Interacting Bose gases in quasi-one dim ensional optical lattices

Abstract.

We study a two-dimensional array of coupled one-dimensional (1D) tubes of interacting bosons. Such systems can be produced by loading ultra-cold atoms in an isotropic optical lattices. We investigate the elects of coupling the tubes via hopping of the bosons (i.e. Josephson coupling). In the absence of a periodic potential along the tubes, or when such potential is incommensurate with the boson density, the system undergoes a transition from an array of incoherent Tom on aga-Luttinger liquids at high tem perature to an anisotropic Bose-Einstein condensate (BEC), at low tem perature. W e determ ine the transition tem perature and long wave-length excitations of the BEC. In addition to the usual gapless (Goldstone) mode found in standard super uids, we also nd a gapped mode associated with uctuations of the amplitude of the order param eter. W hen a commensurate periodic potential is applied along the tubes, they can become 1D M ott insulators. Intertube hopping leads to a decon nem ent quantum phase transition between the 1D M ott insulators and the anisotropic BEC.W e also take into account the nite size of the gas tubes as realized in actual experiments. We m ap out the phase diagram of the quasi-1D lattice and com pare our results with the existing experiments on such systems.

1. Introduction

One dimension (1D) provides fertile grounds for studying the physics of strongly correlated quantum many-body systems. It is a well established theoretical result that, because of the enhanced role of quantum uctuations in low dimensionality, there is no broken continuous symmetry and therefore long range order, even at zero temperature, in a 1D quantum many body system. Instead, in a large class of systems possessing a gapless spectrum, power laws characterize the various correlation functions. This class of systems is known as a Tom onaga-Luttinger liquid (TLL).

O ne of the sim plest exam ples of a TLL is the Lieb-Linigerm odel [1], which describes a system of non-relativistic bosons interacting via a contact (D irac delta-function) potential. This model has been solved exacity using the Bethe ansatz [1], which has provided valuable insights into its them odynam ic properties and excitation spectrum. However, calculation of the asym ptotics of correlation functions is not an easy task using thism ethod, and in this regard it is nicely com plem ented by the harm onic- uid approach introduced by Haldane [2]. The combination of these two methods has allowed us to understand that, as the the interaction is increased, the system exhibits no quantum phase transition. Instead, it smoothly crosses over from a weakly interacting (offen called quasi-condensate [3, 4, 5]) regime, where phase uctuations decay very slow ly, to a strongly interacting regime, the Tonks regime [6]. In the latter, repulsion between the bosons is so strong that it leads to an elective exclusion principle in position space, and makes the system resemble a gas of non-interacting spinless fermions in many properties. Thus it is sometimes stated that the bosons in the Tonks regime \fermionize".

This very simple model solved by Lieb and Liniger in 1963 has recently received a great deal of attention thanks to spectacular advances in con ming quantum degenerate gases of alkali atoms in low dimensional traps [7]. While at the beginning only weakly interacting 1D Bose gases were available [8, 9], the application of a deep optical potential parallel to the 1D axis to arrays of 1D Bose gases has recently allowed the group at ETH (Zurich) [10, 11] to demonstrate a quantum phase transition from a super uid TLL to a 1D M ott insulator, which is the low dimensional analog of the super uid to M ott insulator transition rst demonstrated in the 3D optical lattice by G reiner and cow orkers [12]. Furtherm ore, K inoshita et al. [13] have succeeded in reaching the Tonks regime by creating an array of tightly con ned 1D Bose gases. A di erent path [14, 15] to realize a strongly interacting 1D Bose gases has been followed by Paredes et al. [16], who applied a deep periodic potential to an array of (otherw ise weakly interacting) 1D Bose gases. Thus they were able to dram atically increase the ratio of the interaction to the kinetic energy of the atom s. In both cases [13, 16], the observation of ferm ionization signatures was reported.

In the past, much experimental e ort focusing on low dimensional systems has been spent on studying electronic systems such as spin chains and quasi-1D metals (for a review see [17]). Theoretically at least, electrons in 1D become a TLL (provided there are no gap-opening perturbations) as soon as interactions are taken into account in a non-perturbative way. However, for the electronic system s com parison between theory and experim ent has proved problem atic partly because of material-speci c issues such as the existence of many competing phenom ena at similar energy scales (e.g. in Bechgaard salts [18, 19]) or the always-present disorder in solid state system s [17]. Furtherm ore, one major complication stems from the fact that these materials are indeed three dim ensional (3D), as there is always a sm all am plitude for electrons to hop from chain to chain, whereas C oulom b interactions (often poorly screened because of bad m etallicity) also enhance 3D ordering tendencies. These inter-chain couplings cannot be neglected at low temperatures, which leads to the interesting physics of dimensional crossover: at temperatures high compared to the energy scale determined by these inter-chain couplings, the system e ectively behaves as a collection of isolated 1D chains. However, when the temperature is lowered below this scale, 3D coherence develops between the chains and, at zero tem perature, a complete 3D description of the system is required. Much exciting physics is expected to occur in this crossover from the exotic 1D TLL state to a conventional 3D (but strongly anisotropic) Ferm i liquid, or an ordered 3D phase [17]. Indeed, these phenomena may well have relevance to the pseudogap (and other anom alous) behavior of the quasi-2D high tem perature superconductor m aterials. For instance, one of the many interesting questions that arise in this context is the following: how [19] do the exotic low-energy excitations (bosonic collective modes) of the 1D system transform into the Landau quasi-particles characteristic of Fermi liquids and which resemble more the constituent electrons?

The dimensional crossover phenomena described above has also a counterpart in Bose gases baded in quasi-1D optical lattices. From a theoretical point of view, the fact that bosons can undergo Bose-E instein condensation and, therefore, can be collectively described using a macroscopic quantum eld makes more amenable these systems to a theoretical analysis relying on a mean eld approximation. Such a mean-eld analysis is undertaken in this work: here we treat the intertube hopping via a mean eld approximation, while quantum uctuations within a tube are treated accurately at low energies using the harm onic-uid approach.

From the experimental point of view, the recent availability of gases of ultracold bosonic atoms in optical lattices has revived the interest in understanding the properties of coupled systems of bosons in 1D. Furtherm ore, the already demonstrated high degree of tunability of these systems can provide a clean setup to study the physics of dimensional crossover. Thus, as we show in section 3 of this work, the phenom enology of Bose-E instein condensation in the most anisotropic version of these lattices is very di erent from the one exhibited by Bose gases condensing in the absence of a lattice or even in shallow isotropic optical lattices.

In addition to studying the properties of Bose condensed systems in lattices, some experimental groups have applied a tunable optical potential along the longitudinal direction of an array of electively uncoupled 1D Bose gases. It has been thus possible [10], as mentioned above, to drive a quantum phase transition from the 1D super uid (TLL) state to a 1D M ott insulator. Under these circum stances, the elect

of a small hopping amplitude (i.e.Josephson coupling) between neighboring tubes in the array becomes most interesting: as we show in section 4, for a nite value of the hopping amplitude, the system undergoes a new type of quantum phase transition, known as \decomestic nement" transition, from the 1D M ott insulator to an anisotropic Bose-E instein condensate. Thus the tendency of bosons to develop phase coherence overcom es the localization e ect of the optical potential. As explained in section 6, we believe that some features of this decoment transition may have been observed in the experiments of Ref. [10].

This paper is organized as follows: section 2 de nes our model of a 2D array of 1D tubes of bosons coupled by weak intertube tunneling, and describes the harm onic-uid approach that allows us to derive a low-energy e ective Ham iltonian. Then we discuss separately the phenomenon of Bose-Einstein condensation and the properties of the condensate in an anisotropic lattice (section 3), and the decon nem ent quantum phase transition (section 4). In the form er case, we obtain the zero-tem perature condensate fraction, the condensation temperature, and the excitations of the condensate using the m ean eld approximation and including gaussian uctuations about the m ean eld state. W e also show that som e of the results obtained by these m ethods are recovered from the self-consistent harm onic approximation (section 3.2). These calculations are described in pedagogical detail in Appendix A, Appendix B, and Appendix C. Moreover, in section 3.1.3 we discuss the excitation spectrum of the Bose-condensed phase, and in particular the existence of a gapped mode related to oscillations of the am plitude of the condensate fraction, in the light of a phenom enological G inzburg-Landau theory. D i erences between this theory and the more conventional G ross-P itaevskii theory, where the gapped mode is absent, are exhibited. The transition from the (anisotropic) regime described by the Ginzburg-Landau theory to the one where Gross-Pitaeskii theory holds is also outlined there.

The decon nem ent transition is described in section 4. There we show how the renormalization group can be used to understand the competition between the localization in the optical potential and a small tunneling amplitude between neighboring 1D Bose systems. To assess the nature of the decon nem ent transition, we map (see section 4.2) the mean-eld H am iltonian, at a speci c value of the system's parameters, to a spin-chain model. Finally, section 5 discusses the elect of the nite size of the 1D system that are realized in actual experiments, and how it modiles the phase diagram obtained from the renormalization-group analysis. We argue that, for an array of nite 1D Bose gases, there is a extra energy scale below which the tunneling of atoms between tubes is electively blocked. Finally, in section 6 we present a discussion of the experimental observations and how they com pare with the predictions of our theory. A brief account of som e of our results has appeared elsewhere [20].

2. M odels and Bosonization

In this section we introduce the models for an interacting Bose gas in a quasi-1D optical lattice that we study in the rest of the paper. We also brie y describe the harm onicuid approach (henceforth referred to as \bosonization"), which allows us to obtain a convenient elective low-tem perature description of these models.

2.1. Models of a Bose gas in a quasi-1D optical lattice


In this work we study the low-temperature equilibrium properties of systems recently realized by several experim ental groups [7, 13, 10, 16, 21, 22, 23] which have succeeded in loading ultracold atom ic gases in highly anisotropic (quasi-1D) optical lattices. In the experiments carried out by these groups, a Bose-E instein condensate of ultracold alkali atom s (in particular, ⁸⁷Rb) is placed in a region of space where two pairs of non-coherent and mutually orthogonal counter-propagating lasers intersect. The intensity of the lasers is increased adiabatically, and because of the AC stark e ect, the atom s experience a periodic potential [24] V_2 (y;z) = $V_{0y} \sin^2 (2 \text{ y} =) + V_{0z} \sin^2 (2 \text{ z} =)$, where usually $V_{0y} = V_{0z} = V_{0z}$, with V_{02} / E_0^2 , E_0 being the maximum intensity of the electric eld of a laser whose wavelength is \cdot . The strength of the optical potential, $V_{0?}$, is frequently given in units of the recoil energy, $E_R = h^2 (2M a^2)$, where a = -2 is the period of V_2 (y;z) and M the atom mass z. For V_{02} _{3D}, where _{3D} 4 $h^2a_s \stackrel{3D}{_0} = M$ [25] is the chem ical potential of the BEC (a_s being the swave scattering length of the atom atom interaction potential, and $\frac{3D}{D}$ the mean atom density), the gas atom s are mainly con ned to them inim a of V_2 (x;y), thus form ing long, e ectively 1D, gas tubes as shown in gure 1 (there are additional harm onic potentials along the x;y;z-axes that trap the atom s). Under these conditions, we can project the boson eld operator (x;y;z) onto the lowest (B loch) band of the periodic potential,

where $R = (m_y; m_z) a$, with integers $m_i = M_i=2; :::;+M_i=2$ (i = y;z), is the location of the di erent potential m in in a; W_R (x;y) is the W annier function of the lowest B loch band centered around R. The system just described is called a 2D (square) optical lattice. In typical experiments $M_y = M_z = 10^\circ$, and thus the number of gas tubes is of the order of a few thousand separated half a laser of wave-length, =2' 0:4 m.

In addition, in several of the experiments [10, 22, 16] an extra pair of lasers was applied to de ne a longitudinal periodic potential $V_{jj}(x) = V_{0jj}\sin^2(2 x =) = \frac{1}{2}V_{0jj} + u(x)$, and $u(x) = u_0 \cos(G x)$, where $u_0 = V_{0jj}=2$ and G = 4 = 2 =a. Since, for a commensurate potential, i.e. when the period a matches the mean interparticle distance, the variation of the strength of u(x) is responsible for the transition [2, 26, 17] to a M ott insulating state where the bosons are localized, we shall henceforth refer to z For⁸⁷Rb, $E_R = h = 2^{-2}$, where ' 14:424 m² kHz and is the laser wavelength in m. u (x) as the \M ott potential". In this work we are interested in the extrem e anisotropic case where the strength of this potential $j_{10}j_{10}V_{0j}V_{0j}$. In experiments, this was achieved by increasing V_{0j} so that the motion of the atom selectively becomes conned to a one-dimensional tube, where they undergo only zero-point motion in the transverse directions. This picture is equivalent to the projection onto the lowest B loch band described above. Just like in three dimensional space, the atom is interactions in the tube are still well described by a D irac-delta pseudo-potential, $v_a(x) = g_{1D}$ (x), where the elective coupling g_{1D} has been obtained in Ref. [27]:

The constant C ' 1:4603, and the oscillator length in the transverse direction, $`_{?} = (h=(M !_{?}))^{1=2}$ (where $h!_{?} = E_{R}$ ' $2(V_{0?} = E_{R})^{1=2}$ for deep lattices [12], is the transverse oscillation frequency).

Taking into account the above considerations, we are led to consider the following Hamiltonian:

where $_{R}(x) = \stackrel{Y}{_{R}}(x) _{R}(x)$ is the density operator at point x and lattice site R; the eld operator $_{R}(x)$ obeys $[_{R}(x); \stackrel{Y}{_{R}}(x^{0})] = _{RR^{0}}(x - x)$, and commutes otherwise as corresponds to bosons. The last term in equation (3) describes the hopping of bosons between two neighboring tubes. This term is also known as Josephson coupling. The hopping amplitude [28]:

for $V_{0?} = E_R \cdot W$ e shall assume a very deep transverse potential so that J_{1D} , where $I_{1D} = I_{1D} (0)$ is the chemical potential in each tube, as can be obtained from the exact solution of Lieb and Liniger [1] (or measured experimentally). Since experimentally $I_{1D} < 0.1 \text{ h!}_{?}$ [7], assuming J_{1D} requires at least that $V_{0?} > 10 E_R$. Such limit allow s us to regard the system as an array of weakly coupled 1D interacting B ose gases.

In the experimental systems, the M ott potential u(x), besides the periodic part described above, also contains a slow ly varying harmonic term that connest the atoms longitudinally. A dditionally, there are also harmonic traps in the transverse directions. Thism akes the array, not only nite, but also inhom ogeneous. Whereas we shall discuss nite-size e ects further below (see section 5), it has proven so far intractable in 1D (except for a few limiting cases [29]) to deal with the harmonic connement analytically and only numerical results are available [30, 31, 32, 33, 34, 35]. Thus, with the exception of section 7 where we discuss the experimental consequences of our work, we shall neglect the e ect of the harmonic potential, and treat the system as an array of gas tubes of length L and hard-wallbox (open) boundary conditions [36, 37, 38], each one containing N₀ = $_0$ L bosons (in typical experiments, N₀ ranges from a few tens to a few thousand particles). Thism akes sense, how ever, as much of the interest of this work is focused on computing the phase diagram as well as some of the therm odynam ic properties of the diagram is required to take the therm odynam ic limit L ! 1 at constant density $_0 = N_0 = L$.

Finally, when the axial potential u(x) is made so deep that $ju_0 j = U_{1D}$ (but still $ju_0 j = V_{0?}$), it becomes convenient to perform a further projection of $R_R(x)$ onto the lowest B loch band of the M ott potential u(x). Thus,

where $n_{mR} = b_{mR}^{y} b_{mR}$ is the boson num beroperator at site (m; R). Note that $ju_0 j = V_{0?}$ in plies that $J_x = J$, and therefore we are dealing with a very anisotropic (quasi-1D) version of the Bose-Hubbard model.

2.2. Bosonization and low-energy e ective theory

In order to treat the interactions in a non-perturbative way, it is convenient to rew rite (3) in term s of collective variables that describe phase and density uctuations. The m ethod of bosonization [2, 17, 40, 37] allow s us to obtain such a description. The description is accurate as long as one is interested in the low-tem perature and low-frequency properties of the system. In this subsection we shall brie y outline this m ethod, but we refer the reader to the vast literature on the subject [2, 17, 40, 37] for m ore technical details.

To study the model of equation (3), we use the density-phase representation of the eld operator. To leading order,

The elds $_{R}$ (x) and $_{R}$ (x) describe collective uctuations (phonons) of the phase and the density, respectively x. Since the density and the phase are canonically conjugate variables, it is possible to show [37, 17] that $_{R}$ (x) and $_{R}$ (x) obey the commutation relation: $[_{R}$ (x); $(0_{x^{0} R^{0}}(x^{0})] = i_{RR^{0}}(x - x)$. Furthermore, it is assumed that $(0_{x R}(x))$ is small compared to the equilibrium density $_{0}$. Note that this approach does not assume the existence of a condensate and thus properly takes into account the quantum and thermal uctuations, which are dominant in 1D. Indeed, it is the particle density and not a \condensate" density that appears in the density-phase representation of equations (9,10) (unlike usual mean eld approaches). Furthermore, the terms of equation (10) with m \leq 0 account for the discrete particle nature of the bosons, which is crucial for obtaining a correct description for the transition from the 1D super uid phase to the 1D M ott insulator [2, 26, 17, 41, 42].

Using equations (9) and (10), the Ham iltonian in (3) becomes

The two last term s are related to the M ott potential and the Josephson coupling, respectively. We use the following dimensionless couplings to characterize their strength:

The dimensionless parameter K and the sound velocity v_s depend both on the density, 0, and on the strength of the boson-boson interaction. Indeed, for the Lieb-Liniger model, they depend on a single dimensionless parameter, the gas parameter [1] = M $g_{LD} = h^2_{0}$. Analytical results for these parameters are only available in the small

Therefore, 1 K < +1 for the Lieb-Liniger model, K = +1 corresponding to free bosons and K = 1 to the Tonks limit. For the Lieb-Liniger model, the form ula [37]:

provides a reasonably good interpolation (accurate to within 10% of the exact results) for the non-universal prefactor of the eld operator.

It is worth stressing that in (11) we have retained only terms which can become dom inant at low temperatures. In the language of the remorm alization group (RG) these correspond to marginal or relevant operators. Whenever, for reasons to be given below, any of the terms retained in equation (11) becomes irrelevant in the RG sense, we shall drop it and consider the remaining terms only. We emphasize that the validity of (11) is restricted to energy scales smaller than minfT; $_{1D}$ g, and therefore its analysis will allow us to determ ine the nature of the ground state and low-energy excitations of the system.

Interestingly, the elective Hamiltonian of equation (11) also describes the low energy properties of the anisotropic Bose-Hubbard model of (6). This result can be

derived by a lattice version of the bosonization procedure [17], followed by a passage to the continuum limit. However, the relationship of the elective parameters K, v_s , g_u , and g_J to m icroscopic parameters J_x , J, and U is no longer easy to obtain analytically (except for U small [17] and certain limits in 1D [15]). Thus, in this case K, v_s , g_u , and g_J must be regarded as phenom enological parameters, which must be extracted either from the experiment or from a numerical calculation.

3. Bose-Einstein Condensation

Let us rst discuss the phenom enon of Bose E instein condensation in an isotropic (quasi-1D) optical lattices. This is the phase transition from a normal Bose gas to a Bose-E instein condensate (BEC), which exhibits som e degree of spatial coherence throughout the lattice. Coherence arises thanks to the Josephson term, which couples the 1D interacting Bose gases together. In the absence of the Josephson coupling and the M ott potential (i.e. for J = 0 and u(x) = 0), the system behaves as an array of independent TLL's [2, 17, 40, 37]: the excitations are 1D sound waves (phonons) and, at zero tem perature and for L ! 1, all correlations decay asym ptotically as powerlaws (e.g. phase correlations he^{i_R(x)} e^{i_R(y)} e^{i_R(y)} i _{R:R} ^o j₀x j¹/_{2K} for x $_{0}$ ¹), which in plies the absence of long-range order. However, as soon as the Josephson coupling is turned on, bosons can gain kinetic energy in the transverse directions, and therefore become delocalized in more than one tube. This process helps to build phase coherence throughout the lattice and leads to the form ation of a BEC. Nevertheless, the building of coherence just described can be suppressed by two kinds of phenom ena: one is quantum and thermal uctuations, which prevent the bosons that hop between dierent gas tubes from remaining phase coherent. The other is the existence of a M ott potential that is commensurate with the boson density. For su cient repulsion between the bosons, this leads to the stabilization of a 1D M ott insulator, where bosons become localized. W hereas we shall deal with the latter phenom enon in section 4, we deal with the uctuations in this section.

In this section we have in m ind two di erent experimental situations: one is a 2D optical lattice where the M ott potential is (experimentally) absent. The other is when the M ott potential is irrelevant in the RG sense. The precise conditions for this to hold will be given in section 4 but, by inspection of (11), we can anticipate that one particular such case is when the M ott potential is incom m ensurate with the boson density (i.e. \in 0). Under these circum stances, the cosine term proportional to g_i oscillates rapidly in space and therefore its e ect on the ground state and the long wave-length excitations is averaged out.

3.1. Mean eld theory

To reduce the H am iltonian (3) to a tractable problem, we treat the Josephson coupling in a mean-eld (MF) approximation where the boson eld operator $_{\rm R}$ (x) is replaced

by $_{c} + _{R}(x)$, where $_{c} = h_{R}(x)i$ and $_{R}(x) = _{R}(x) _{c}$. We then neglect the term / $_{R}(x) _{R^{0}}(x)$, which describes the e ect of uctuations about the mean eld state characterized by the order parameter $_{c}$. This approximation decouples the 1D system s at lattice sites $R \in R^{0}$ so that the problem reduces to a single \e ective" 1D system in the presence of a (W eiss) eld proportional to $j_{c}j$. The bosonized form of the Ham iltonian for this system is (we drop the lattice index R):

where z_c is the coordination number of the lattice ($z_c = 4$ for the square lattices realized thus far in the experiments). The phase of the order parameter $_c = \arg_c$ has been eliminated by performing a (global) gauge transformation (x) ! (x) + $_c$, and henceforth we shall take $_c = j_c j$ to be real. We note that, up to the last constant term, H_e^{MF} de nes an exactly solvable model, the sine-G ordon model, of which a great deal is known from the theory of integrable systems as well as from various approximation schemes [40, 17, 43]. The mean-eld H am iltonian must be supplemented by a self-consistency condition, which relates the elective 1D system to the original lattice problem :

Note that the average over the cosine must be computed using the eigenstates of H $_{e}^{MF}$.

3.1.1. Condensate fraction at T = 0: To obtain the condensate fraction at zero tem perature, we rst compute the ground-state energy of H $_{e}^{MF}$ using the following result for the ground state energy density of the sine-G ordon (sG) model [43]:

The dependence of the exponent on the parameter K, which varies continuously with the strength of the interactions between the bosons in the tubes, is a consequence of the fact that the appearance of a BEC at T = 0, as soon as J is made di erent from zero, is a ected by the characteristic 1D quantum uctuations of the TLL's. This behavior is markedly di erent from what can be obtained by a G ross-P itaevskiim eaneld treatment of the system that overlooks the importance of 1D quantum uctuations.

Further below we shall also encounter other instances where the present results strongly deviate from G ross-P itaevskii theory.

To show the electiveness of the uctuations to cause depletion of the BEC, let us estimate the fraction of bosons in the condensate at T = 0 using equation (24). For K = 1 (i.e. the Tonks limit, where phase uctuations are the strongest), we take $a_0 = 1$ and assume that $_{1D} = 0.1 h!_2$ [7]. Therefore, for $V_{02} = 20 E_R$, the hopping amplitude J ' 3 $10^3 _{1D}$, and hence, using equation (24), $_0^{1} C_2^2 = 20\%$. We also note that for weakly interacting bosons, i.e. as K ! + 1, $_c^2 ! _0$, as expected.

In the experim ents of R ef. [10], very sm all coherence fractions were observed. The experimental coherence fraction is de ned as the fraction of the total number of atom s that contributes to the peak around k = 0 in the momentum distribution, as measured by time of ight. The fraction was quantied by thing a gaussian distribution to the peak [10]. We note that such a procedure yields a non-vanishing coherence fraction even for the case of uncoupled 1D tubes, where the momentum distribution exhibits a peak $k^{\frac{1}{4}}$ and a width maxfL; hy=Tq [37, 36]. Thus, identifying with a power-law tail the condensate fraction with the experim ental coherence fraction m ay not be appropriate as there is no condensate in such a 1D limit. Furtherm ore, as we show below, in the anisotropic BEC phase discussed above, this experimental procedure would also pick up a non-condensate contribution to the coherence fraction. Nevertheless, provided heating e ects and them al depletion of the condensate are not too strong, one can regard the experimental coherence fraction as an upper bound to the condensate fraction, and since a strong decrease of the coherence fraction was reported in the experim ents of Ref. [10], our results showing a strong depletion of the condensate are consistent with the experimental ndings.

3.1.2. Condensation temperature: At nite temperatures, them al (besides quantum) uctuations cause depletion of the condensate. Ultimately, at a critical temperature $T = T_c$, the condensate is destroyed by the uctuations. To compute the critical temperature we follow E fetov and Larkin [44] and, taking into account that near T_c the order parameter $_c(T)$ is small, consider a perturbative expansion of the self-consistency condition (18) in powers of $_c$. To lowest order,

The rst one is that, as we turn o the interactions (i.e. for g_{1D} ! 0) so that K can diverge, the chemical potential $_{1D}$ ' g_{1D} 0 ! 0. Therefore since the elective H am iltonian, equation (11), is valid only for energy scales below $_{1D}$, the range of validity of the result is going to lower and lower J in this limit. Indeed one cannot simply let K ! 1 and keep J xed. One would get

In the latter case, we have chosen the zero-point energy (i.e. the bottom of the band) to be zero. In the J ! 0 limit the 1D systems become decoupled and T_c vanishes (i.e. there is no BEC in 1D). Therefore, we expect T_c to be small for small J. It is thus justiled to expand about Q = (0;0) the transverse dispersion ; (Q) ' Ja^2Q^2 . Furtherm ore, (q) = $h^2q^2=2M$, for free bosons, and thus (33) leads to the law $T_c = J^{2=3}$, which is dimension of the excitations in plied by the quadratic part of (11) and (17). Had we insisted in assuming a linear longitudinal dispersion of the bosons (q) = $h_0^2g_1^2$, where v_0 has dimensions of velocity, we would have found that $T_c = J^{1=2}$ as implied by (32). This argument in plicitly assumes that in the weakly interacting limit, the dimense between particles and excitations vanishes. This seem s quite reasonable, as the spectrum of excitations of the non-interacting B ose gas coincides with the single-particle spectrum.

Nevertheless, we can expect equation (30) to provide a good estimate of the condensation temperature as long as $J=_{1D}$ 1. This is of course particularly true in the strongly interacting limit where K 1. The interpolation formula for the prefactor A_B , equation (16), allows to be more quantitative than E fetov and Larkin and to obtain an estimate of T_c for K = 2, for instance. For the Lieb-Linigerm odel this value of K corresponds to ' 3:5 β 7] and to $_{1D} = _F$ ' 0:367. For J ' 3 10° $_{1D}$ (i.e. $V_{0?} = 20E_R$), equation (30) yields $T_c = _{1D}$ ' 0:6 and therefore $T_c = h$ ' 10 kHz or T_c ' 70 nK. We note this temperature seem s to be well above the experimental estimate for the temperature of the cloud, T < 10 3 h!? 10^{2} $_{1D}$ [7]. Thus, we expect the experimentally realized systems to be in the anisotropic BEC phase described in this section, and the optical lattice to exhibit 3D coherence.

3.1.3. Excitations of the BEC phase: Let us next compute the excitation spectrum of the BEC. Due to the existence of coherence between the 1D systems of the array, this turns out to be very di erent from the \norm al" Bose gas (TLL) phase, where the gas tubes are electively decoupled (i.e. $_{\rm c} = 0$) because uctuations destroy the long range order. The most direct way of noting the excitation spectrum is to consider

con gurations where the order parameter varies slow ly with x and R and time. Thus the order parameter becomes a quantum eld, $_{c}(x \mathbb{R};t)$. One then asks what is the e ective Lagragian, or G inzburg-Landau (GL), functional, L_{GL} (x;R;t), that describes the dynamics of $_{c}(x;R;t)$. There are at least two ways of noting this functional: one is to perform a Hubbard-Stratonovich transform ation and to integrate out the original bosons to nd an elective action for the luctuations of the order parameter about a uniform con guration. To gaussian order (random phase approximation, RPA) this is carried out in Appendix A. This method has the advantage of allowing us to make contact with the microscopic theory (the Hamiltonian (11) in our case) and thus to relate the parameters that determ ine the dispersion of the excitation modes to those of the m icroscopic theory. Another m ethod, which we shall follow in this section, is to guess L_{GL} using symmetry principles only. To this end, we rst write $L_{GL} = T$ V, where the kinetic energy term T depends on gradients of $_{c}$ (x;R;t), whereas V depends only on (x; R; x; t). Both T and V are subject to invariance under global G auge transformations: $_{c}(x;R;t) ! e^{i_{0}} _{c}(x;R;t)$.

It is worth comparing these phenom enological results with those of the analysis of gaussian uctuations (RPA + SM A) about the mean-eld state described in Appendix A. One noticeable di erence of these results from those of the GL theory is that the values of v_2 predicted by the RPA + SM A for the longitudinal and G oldstone m odes di er, i.e. $v_2^{(+)} \notin v_2^{(-)}$. This is due to a poor treatment of the Landau-G inburg theory that neglected term s of L_{GL} of order higher than quadratic in the elds $_{\rm c}$ and $_{\rm c}$. These terms represent interactions between the G oldstone and longitudinal eld, as well as self-interactions of the longitudinal eld. On the other hand, the RPA treatment of A ppendix A takes into account some of these interactions and thus yields a correction to the dispersion of the G oldstone and longitudinal m odes, which leads to di erent values of v_2 .

It is interesting to consider the behavior of the system in the limit of strong Josephson coupling where $J > _{1D}$. Under these conditions the motion of the atom s is not mainly conned to 1D and thus they can more easily avoid collisions. Therefore, the e ect of uctuations is expected to be less dramatic and assuming the existence of a 3D condensate is a good starting point. This leads to G ross-P itaevskii (GP) theory, which, assuming a slow ly varying conguration of the order parameter, has the following Lagrangian:

From the above expression, we see that the amplitude $_{c}$ has no dynamics, i.e. there is not term involving ℓ_{tc} that is not a total derivative k. The term $2_{cc}\ell_{tc}$, however, couples the dynamics of the phase $_{c}$ and the amplitude $_{c}$. This is very dimension from the situation with the GL theory encountered above. (q;Q) = $v_{ii}^2 q^2 + v_2^2 Q^2$, vanishes in the long wave-length lim it. This is precisely the Goldstone mode, which corresponds to the one that we have already encountered above when analyzing the excitation spectrum of the GL theory that describes the extremely $_{\rm 1D}$. The presence of the Goldstone mode as the lowest anisotropic limit where J energy excitation in both theories is a direct consequence of the spontaneous symmetry breaking of global gauge invariance. Thus both kinds of super uids are adiabatically connected as J is increased. On the other hand, the latter theory also exhibits a mode, the longitudinal mode, that is gapped for (q; Q) = (0; 0). However, the fate of the longitudinal mode as J increases is not clear from the above discussion. To gain some insight into this issue, let us reconsider the derivation of the GLL agrangian in the light of the previous discussion of GP theory. Apparently, the Lorentz invariance discussed above forbids the existence of a term $hZ_{1} = 0t = 0$. Nevertheless, we have to rem ember the emergence of such an invariance in equation (35) is a consequence of the linear dispersion of the TLL modes of the uncoupled tubes. The dispersion is linear for energies h! 1D, but for J 1D non-linear corrections must be taken into account. These break the e ective Lorentz invariance of (35) and thus a term of the

where $!^2$ (q;Q) are the dispersion of the G oldstone and longitudinal modes for $Z_1 = 0$, which have been found above. We see that for small q and Q there is a solution such that $!^2 = Aq^2 + BQ^2$. Furtherm ore, there is also a gapped mode, for which $^{2}_{+}$ + $(\mathbb{Z}_{1}=\mathbb{Z}_{2})^{2}$ as q and Q) tend towards zero. Thus we see that the gap of !² ! the longitudinal mode depends on the ratio $Z_1 = Z_2$. For $Z_1 = Z_2$, the dispersion of the longitudinalm ode is essentially the sam e as that obtained from the GL theory. However, as $Z_1=Z_2$ grows with J, the gap increases and therefore the exciting the longitudinal m ode becomes m ore costly energetically. At this point is useful to recall that the RPA analysis in Appendix A indicates the existence of a continuum of soliton-antisoliton excitations above a threshold $h! = 2_{s}$. The stability of the longitudinal mode is ensured if $_{+}$ < 2 $_{s}$, which seem s to be the case provided one trusts the single-m ode approximation employed to estimate +. However, as the gap is pushed up towards higher energies by an increasing $Z_1=Z_2$, the longitudinal mode is likely to acquire a large nite lifetime by coupling to this continuum. This will eventually lead to its disappearance from the spectrum.

3.2. Self-consistent harm on ic approxim ation (SCHA)

An alternative approach to obtain the properties of the BEC phase is the selfconsistent H am onic approximation (SCHA) (see e.g.Ref. [17]). The idea behind this approximation is to nd an optimal (in the sense to be specified below) quadratic H am iltonian that approximates the actual H am iltonian of the system. The method is more suitably formulated in the path-integral language, where the role of the H am iltonian is played by the euclidean action. The latter is obtained by performing, in the Lagrangian of equation (35), a W ick rotation to imaginary time, t ! i, and dening the action as $S = \begin{bmatrix} R_L \\ 0 \end{bmatrix} dx \begin{bmatrix} R_h \\ 0 \end{bmatrix} dL_e$ (x; i)=h. However, the SC HA fails to capture the existence of the longitudinal mode. This is because, as described above, the SC HA is tantam ount to expanding the cosine in the Josephson coupling term. Such an approximation neglects the fact that the phase $_{R}$ (x;) is 2 - periodic, and that as a consequence the system supports vortex excitations. On the other hand, this is captured by RPA because it does not disregard the periodic aspect of the phase since the mean- eld state is described by the sine-G ordon model. The latter has soliton, anti-soliton, and breather excitations, which are a direct consequence of the periodicity of $_{R}$.

This is indeed an artifact of the SCHA, which incorrectly captures the second-order character of the transition from the BEC to the \norm al" (TLL) phase.

3.3. Momentum distribution function

Besides the excitation spectrum, the SCHA also allows us to obtain the momentum distribution of the system in the BEC phase. The latter can be measured in a time-of-

ight experiment [25], and it is the Fourier transform of the one-body density matrix:

There are several points that are worth discussion about the results of equations (68) and (72). The rst is that these form are an isotropic generalizations of the result that can be obtained from B ogoliubov theory for a BEC [25]. How ever, for su ciently large q we expect a crossover to the same power-law behavior of a single 1D B ose-gas $jk^{\frac{1}{2k}-1}$ (for T = 0 and L ! 1). This is nothing but a rejection of the dimensional crossover physics: bosons with kinetic energy (k) = $h^2k^2=2M$ J (but such that (k) _{1D} for the bosonization to remain valid) cannot \feel" the BEC and the intertube coherence.

However, they still \feel" the characteristic quantum uctuations of the TLL state. The second observation is related to our discussion of section 3.1.1 on the experimental \coherence fraction": it is clear by thing a gaussian to n (k;K) about zero momentum, one does not only pick a contribution from $j_c(T)f$ but also from the tail of the non-condensate fraction. The presence of a trap (and the inhom ogeneity of the system caused it) should not dram atically modify this conclusion. However, as both contributions are positive, we expect that the experimentally measured coherence fraction is indeed an upper bound for $j_c(T)f$.

4.Decon nem ent

In this section we shall obtain the phase diagram of the system for the case where the M ott potential is relevant. One necessary condition for this is that = 0 and $u_0 \in 0$ so that $g_u \in 0$ in equation (11). As it has been mentioned above, under these conditions, and provided repulsion between the bosons is strong enough so that the parameter K < 2, the system undergoes a transition to a M ott insulating state for J = 0 and arbitrarily small u_0 [2, 26, 17, 41]. In the Mott insulating state bosons are localized about the minim a of the potential. The question thus is what happens as soon as a small Josephson coupling between neighboring tubes is present. The latter favors delocalization of the bosons leading to the appearance of a BEC, and therefore competes with the localization tendencies favored by the M ott potential. The competition between these two opposite tendencies leads to a new quantum phase transition known as decon nement. For sm all values of μ_0 j and J, it can be studied by means of the renormalization group (RG). This is a much better approach than comparing ground state energies of mean-eld theories for each phase, as it takes into account the uctuations, which are entirely disregarded within any mean-eld approximation. However, although the RG approach allows us to estimate the position of the boundaries between the M ott insulating and BEC phases, in the present case it cannot provide any insight into the nature of the decon nem ent transition. For this, we shall rely on the mean-eld approximation and map the mean eld ham iltonian at the special value of K = 1=2 to a spin-chain model.

4.1. Renorm alization G roup calculation

Let us return to the low-energy e ective eld theory de ned by the Hamiltonian in equation (11). Since it is a description valid for low-energies and temperatures, the couplings K, g_{I} , g_{J} , etc. all depend on the cut-o energy scale, which is typically set by the temperature for $= T < _{1D}$. Thus, as the temperature is decreased, the couplings get renorm alized due to virtual transitions to states with energy > = T, which now are excluded from the description. The nature of the ground state is thus determined by the dominant coupling as T = ! 0.

The change ('ow') for the couplings can be described by a set of di erential

equations. For small values of g_J and g_u the RG ow equations can be obtained perturbatively to second order in the couplings. The details of such a calculation are given in Appendix D. The result reads:



where ' In =T. The coupling g_F is generated by the RG and describes an interaction between bosons in neighboring tubes. However, since initially there is not such an interaction (i.e.g_F (0) = 0) and as dg_F =d ' = 0 (g_J²) its e ect on the ow of the other couplings is not very important.

The phase boundary between the BEC and 1D M ott insulator phases can be obtained by studying the asymptotic behavior of the solutions of equations (73) to (76). As the tem perature is lowered, i.e. as `! +1, in the regime $\frac{1}{4}$ K < 2 { the elective couplings g_u (`) and g_J (`) grow as both the M ott potential and the Josephson coupling are relevant perturbations in the RG sense. If g_u (`) grows larger, the localization tendencies of the M ott insulator phase set in, whereas if g_J (`) grows larger, delocalization tendencies of the BEC phase described in section 3 dom inate in the ground state. B oth phases correspond to two di erent strong coupling xed points of the RG. W hen both perturbations are relevant, one has a crossing of the two strong coupling xed points, and since we obtained the above equations assum ing that both g_u and g_J are sm all, the RG is not perturbatively controlled when g_u and g_J grow large. Note that, given this lim itation, we cannot entirely exclude that interm ediate phases m ight exist. W e will come back to that particular point in the next section.

The relative magnitude of the initial (i.e.bare) values of g_J and g_u determines which coupling grows faster to a value of order one, where the above RG equations cease to be valid. The faster growth of one coupling inhibits the other's growth via the renormalization of the parameter K : If g_u (') grows faster, K ows towards 0, leading to the 1D M ott insulator. This rejects the fact that, for large enough g_u , the M ott potential drives the system towards an incompressible phase, where boson number uctuations are strongly suppressed by the localization of the particles. On the other hand, if g_J (') grows faster, K also grows and leads to the 3D BEC phase. A rather crude estimate of the boundary can be obtained by ignoring the renormalization of K. In such a case, dividing (74) by (75), keeping only the leading order terms, and integrating this equation up to the scale `, where both g_J (`) = g_u (`) = g_v (`

In the next section we will see that this power-law is also recovered in the mean-eld treatment of the following section. However, for a more precise estimate of the boundary one needs to integrate numerically the RG – ow equations and take into account the renormalization of K, which can be important especially near K = 2. This is shown in gure 2, where we compare the estimate of (77) with the phase boundary obtained from a numerical integration of the RG equations.

The RG equations also allow to extract the gap of the M ott insulator as well as the soliton energy gap that characterizes the decay of the one-body correlation functions (i.e. the healing length) in the BEC phase. This is achieved by integrating the equations until the fastest grown coupling is of order one. One can then use that, at this scale `, the gap (`) is also of order one, and since gaps renorm alize like energies, i.e. (`) = (`= 0)e `. For example, in the BEC phase, using equation (74), keeping only the leading term, and integrating this equation up to a scale ` log(= _s) where g_J (`) 1 gives $_s$ (J= $_{1D}$)^{1=(2 1=2K)}, which has the same power-law behavior as the one obtained from the mean- eld theory, equation (42). For $\frac{1}{4} < K < 2$, a better

estim ate (num erical) can be obtained by accounting for the renorm alization of K using the full set of RG equations. However, for K > 2, the renorm alization of K is negligible and the previous estim ate of $_{\rm s}$ should be accurate.

A nother instance where it can be necessary to take into account the renorm alization of K is the evaluation of the condensation temperature T_c in the presence of the M ott potential. In particular, for K < 2, although the initial conditions are such that the coupling g_J is the dominant one, K m ay undergo an important renorm alization if g_u is non-zero. The renorm alized value of K could be then used in combination with the RPA form ula, equation (30), for T_c .

4.2. Mean eld theory of the decon nem ent transition

The RG approach explained above does not provide any insight into the nature of the decon nement transition, e.g. it cannot answer questions such as whether the transition is continuous (i.e. second order) or not, or what universality class it belongs to. In order to address, at least partially, some of these issues we will treat again the interchain coupling in a mean eld approximation. We begin by rewriting the mean-eld Ham iltonian of equation (17) in the presence of the M ott potential:

The new mean-eld Ham iltonian is now a double sine-Gordon theory, which is not exactly solvable for general values of the parameter K [46]. However, for $K = \frac{1}{2}$ the solution takes a particularly simple form as one can directly relate it to the results obtained in section 3.1 for the sine-Gordon model. As it has been pointed out above, the regime K < 1 is not physical for models like the Lieb-Liniger model or the 1D Bose-Hubbard model. However, we expect that the solution at this point captures some e of the essential features of the decon nem ent transition for K 1. Indeed in particular in the RG ow nothing special occurs at K = 1 so we can expect the two lim its to be smoothly connected. The key observation behind the solution at K = $\frac{1}{2}$ is that, as shown in Appendix E, at this point (78) is the elective low-energy description of a H eisenberg anti-ferrom agnetic spin chain in the presence of a staggered magnetic eld:

The algebra is essentially very similar to that in section 3.1.1, and we just quote the results here. There exists a critical tunneling J_c , when the condensate fraction $_c ! 0$, i.e. $h_x ! 0$. We nd at K = 1=2,

Thus the condensate fraction grows continuously from zero at the decon nement transition from the M ott Insulator at $J < J_c$ to the 3D anisotropic super uid at $J > J_c$ according to:

where (1=3) has been de ned in (22) and at K = 1=2 the dimensionless ratio = ${}_{0}a_{0}A_{B}$ (1=2). Note that the scaling $J_{c} / u_{0}^{2=3}$ in (86) agrees with that deduced from the RG approach of equation (77) upon setting K = 1=2.

It is instructive to compare this decon nement scenario in 3D with the case where only two 1D systems are coupled together (via the same Josephson coupling term), i.e. a bosonic two-leg ladder, which has been studied in [47]. In both the quasi-1D optical lattice and the ladder, there is the competition between the Josephson coupling that favors super uidity, and the localizing tendency of the commensurate periodic potential on top of which the interacting bosons hop. This is manifested in a very similar structure of the bosonized H am iltonians. For the ladder case, it is convenient use a symmetric and anti-symmetric combination of the elds of the two chains, which leads to slightly di erent forms for the RG equations. Nevertheless, the mentioned competition occurs for the same range of K : 1=4 < K < 2, where, in the ladder case, K characterizes to the correlations of antisymmetric elds. Qualitatively, the critical intertube coupling for the decon nement transition has the same power-law dependence on g_u as in equation (77). However, as the ladder is still electively 1D, the nature of the decon nement transition is expected to be very di erent from the one studied here, where a fully 3D (anisotropic)

BEC results. In Ref. [47], the decon nem ent transition in the ladder was found to be in the Berezinskii-K osterlitz-T houless universality class, at least when (for xed interaction strength U) the intertube hopping is larger than the intratube hopping (note that this lim it has not been studied in this work as it would correspond to coupled 2D system s, with very di erent physics compared to the coupled 1D system s.)

Note that in the entire phase diagram (in the therm odynam ic limit, see qure 2), we have found evidence for the BEC and the 1D Mott insulating phases only. We have not found any evidence (or hints of evidence) for more exotic states such like the sliding Luttinger liquid phase [48, 49, 50] or some kind of supersolid phase. The sliding Luttinger liquid [48, 49, 50] is a perfect insulator in the transverse direction (like our 2D M ott insulator for nite size system s); along the tube direction, the system is still a Tom onaga-Luttinger liquid, but the parameters K and v_s are now functions that depend on the transverse momentum. This state may be stabilized by a strong interaction of the long-wave length part of density uctuations between tubes [49]. We note that, although the RG procedure described above generates such a density-density interaction between the tubes, in the bare Ham iltonian there are no such interactions to start with (atom s in di erent tubes have negligible interactions) and therefore, the coupling g_F is likely to remain small as the RG ow proceeds to low erenergies, at least within weak coupling perturbative RG we use here. Thus it seems unlikely that the system can enter the regime of a sliding Luttinger liquid [49, 50] phase. An even more exotic possibility would be a phase where the tubes are 1D M ott insulators (in the presence of a commensurate periodic potential and strong enough interaction in-tube), while at the same time, there would be coherence between the tubes in the transverse direction. In this scenario, presumably both the couplings q_1 (M ott potential) and J (Josephson coupling) would be relevant. We cannot rule out such a possibility in the strong coupling lim it. However, we have no evidence for it in our weak coupling analysis. Nevertheless, in a quasi-1D system and on physical grounds, it seems hard to imagine a phase where the boson density is kept commensurate within each tube, as required by the existence of the M ott insulator, while at the same time bosons are able to freely hop to establish phase coherence between tubes (but not within tubes!).

As far as the competition between the Josephson coupling and the M ott potential is concerned, mean eld theory is a useful tool (in higher dimensions as well as when the tubes are coupled) for providing insights into which possible phases and what their properties are. However, it is usually inappropriate for predicting the correct critical behavior. For cold atom ic systems, because the systems are nite and of the existence of the harm onic trap that makes the samples inhom ogeneous, it is not very realistic to study critical behavior as the latter is usually strongly perturbed [34]. M ean

eld theory seems thus perfectly adapted to the present study. Let us however more generally comment on the universality at the transition. Because the eld $\cos(2_R)$ is a vortex (instanton) creation operator [17] for the eld _R, the Ham iltonian for each tube R can be faithfully represented by a classical 2D XY Ham iltonian involving J_{x} ; $\cos[_R (x^0; \ ^0) = _R (x; \)]$. It thus becomes apparent that the coupling between the

tubes leads to an anisotropic version of the 3+1 dimensional XY model. The transition will thus be in the universality class of the classical D = d + z = 4 XY model in agreem ent with general considerations on super uid to insulator transitions [39]. In the present case, the transition is tuned by varying the anisotropy of the model J J. For such a transition, the super uid density of the classical model is expected to behave $^{(d+z-2)}$, where for the commensurate M ott insulator to super uid transition z = 1as and, at d = 3, which is the upper critical dimension, the critical exponent = 1=2 is mean-eld-like. One would thus nd that the super uid density behaves as , in agreem ent with our result for K = 1=2 of equation (87), upon identifying the super uid density of the classical XY model with the square BEC fraction of the quantum model, 2 c•

Note that in the absence of the self-consistency condition (18), the mean eld Ham iltonian is equivalent to an XY model in presence of a symmetry breaking eld [51, 52]. It has been recently argued that such a model can have a sequence of two phase transitions [53, 54]. Since in the present case the coe cient of the M ott potential ($\cos(2_R)$) term is small, the system would be in the regime where it undergoes a single phase transition even for the model with the symmetry breaking eld. But, more in portantly, the model that we have studied has to be supplemented by the self-consistency condition, equation (18), which stems from our mean-eld treatment of the original Josephson coupling $\cos(R - R^0)$. This condition will modify the properties of the phase where this coupling is relevant, and for the reasons explained above, should bring back the model in the universality class of the 3 + 1-dimensional XY model.

5. Finite size e ects

A ctual experimental system s consists of nite 2D arrays of nite 1D systems (tubes). The nite size of the sample has some well known consequences in condensed matter physics such as inducing the quantization of the excitation modes and turning phase transitions into more or less sharp crossovers. The latter can be understood using the renormalization-group analysis of section 4.1. The nite size of the tubes introduces a length scale into the problem, namely the size of the tube L, which e ectively cuto s the RG ow at a length scale of the order of L (or, for that matter, the smallest length scale characterizing the size of the properties of one of the therm odynam ic phases discussed above. Furtherm ore, as we show below, the nite size L leads to the appearance of a new phase.

5.1. Finite size tubes and 2D M ott transition

Typically in the experiments [9, 7] a number N₀ of bosons ranging from a few a tens to a few hundreds are conned in a tube of 10 m long. This leads to energy quantization of the sound modes in longitudinal direction, but also to a nite energy cost for adding (or




Figure 3. Zero-tem perature phase diagram of a 2D array of coupled, nite, 1D interacting boson systems. The values on the vertical axis are dened up to a factor of order unity. K is the Luttinger-liquid parameter (see section 2.2 for explanations). The corresponding values of Lieb-Liniger gas parameter = M g=h² ₀ are also displayed. A longitudinal commensurate optical potential of amplitude u_0 (u_0 0.03 $_{1D}$ for K = 1 and u_0 0.02 for K = 2.5) is assumed. The vertical dashed line describes the boundary between the (nite-sized) Tom onaga-Luttinger phase.

rem oving) one atom to the tube. This energy scale is $E_c = h v_s = K L [2, 37]$. The tube can be thus regarded as a small atom ic \quantum dot" with a characteristic \charging energy" E_c . If E_c is su ciently large, it can suppress hopping in an analogous way as the phenom enon of C oulom b blockade suppressing tunneling through electron quantum dots and other m esoscopic system s. In order to know when this will happen E_c must be balanced against the hopping energy E_J . The latter is not just JN₀ as one would naively expect for non-interacting bosons. Interactions and the uctuations that they induce in the longitudinal direction alter the dependence of E_J on N₀ as we show in Appendix F.

Let us consider a system of nite tubes in the BEC phase (i.e. the M ott potential is irrelevant or absent). In the lim it of sm all J (J= $_{1D}$ 1) of interest here, the longitudinal uctuations with wavenum ber q \notin 0 can be integrated out as discussed in Appendix F. The resulting elective H am iltonian is a quantum phase m odel identical to the one used to describe a 2D array of Josephson junctions:

where N_R is the particle number operator of tube at site R, and $_{0R}$ the canonically conjugate phase operator: $[_{0R}; N_{R^{\circ}}] = i_{R;R^{\circ}}$. The renormalized hopping $E_{J} =$ $E_{J}(N_{0})$ ' $JN_{0}^{1-\frac{1}{2K}}$. The model (88) has been extensively studied in the literature (see e.g.Ref. [55] and references therein). It exhibits a quantum phase transition transition between a two-dimensional super uid (2D SF) phase (a BEC at T = 0) and a two-dimensional M ott insulator (2D M I) at a critical value of the ratio $E_J = E_c$. For commensurate lling (integer N₀) using M onte Carlo (MC) van Otterlo et al. [55] found ($E_J = E_C$)_c ' 0:15. Using the form s for E_C and E_J derived above, and assuming that the tubes are described by the Lieb-Lininger model, the MC result reduces to $J_c = {}_{1D}$ ' $0.3N_0^{3=2}$ in the Tonks limit (K = 1) and to $J_c = {}_{1D}$ ' $0.15N_0^{2}$ for weakly interacting bosons (K 1) [20]. A similar result has been more recently obtained in Ref. [56] using the random phase approximation (RPA). Our result, however, includes critical uctuations beyond the RPA as it relies on the num erically exact results from MC simulations. In gure 3 we show the complete zero-temperature phase diagram including the possibility of a phase where the tubes are e ectively decoupled in a 2D M I phase (labeled Decoupled tubes in the diagram). Note that in the 2D M I, only the phase coherence between di erent tubes of the 2D lattice is lost. However, apart from the nite size-gap h y=L, there is not gap for excitations in the longitudinal direction. This makes this phase di erent from the 1D M I described above, where there is a gap (depending very weakly on the size L) for longitudinal excitations. If the M ott potential is applied to the system in this phase, it will cross over to a 1D M ott insulator for a nite, but small value, of the dimensionless strength g_u . This crossover should take place for K < 2 [2, 26, 17, 41] and is thus represented by a vertical dashed line in qure 3.

In the super uid phase, the lattice will also exhibit a crossover as a function of temperature: If the condensation temperature T_c found in section 3.1.2 is larger than the nite-size gap hv_s =L, the gas should behave as a 3D BEC and cross over to a 2D SF for T hv_s =L. However, if T_c hv_s =L the system should behave as a 2D quasi-condensate with no long range phase coherence (and therefore $_c = 0$) at nite temperature. Since hv_s =L $h!_0$, $!_0$ being the longitudinal trapping frequency, and experimentally [7] $!_0$ 0.1 kHz whereas T_c =h 10 kHz, we expect to be in a regime where the BEC is always observed. The presence of harm onic con nem ent means that at least some of the tubes will have a lling deviating from commensurate lling. The critical value of J= $_{1D}$ is reduced relative to the half-lled case, as shown in gure 4.

Finally, let us estimate the typical value of the critical ratio $J_c = _{1D}$. Using the above results and assuming that $_{1D}$ 0:1 h!? [7] and $N_0 = 100$, we conclude that $J_c=h!$? ' 10⁴ for K = 1 whereas $J_c=h!_c$ ' 10⁵ for K 1. The deepest lattices used in the experiments of Refs. [7, 10] had $V_2 = 30 E_R$, which corresponds to $J=h!_2 = 5$ 10⁵. This is of the same order of magnitude as $J_c=h!_2$ for K 1, although a larger number N_0 will further reduce this estimate, and therefore for this lattice the system may be well in the BEC phase (see gure 3). However, in the experiments [7, 10] no coherence was apparently observed between the tubes. The




Figure 4. Phase diagram of a 2D array of nite 1D Bose gases as a function for the local chemical potential and the Josephson coupling J for di erent values of the Luttinger parameter: K = 1 (! + 1, continuous curve), K = 2 (= 3:5, dotted curve), K = 4 (= 0:71, dash-dotted curve).

explanation for this contradiction is that the value of tunneling time h=J must be compared with the duration of the experiment t_{exp} and it turns out that for a lattice depth of $V_{0?} = 30 E_R$ this time is indeed longer than t_{exp} . Therefore, over the duration of the experiment almost no tunneling process occurs and the build-up of intertube coherence can thus hardly take place.

6. C om parison to experim ents

In this section we discuss and summarize our results in connection with the recent experiments on anisotropic optical lattices [21, 7, 10, 22, 16, 13]. The complete phase diagram, taking into account the niteness of the 1D gas tubes, is shown in gure 3. At zero temperature, we predict three phases: an anisotropic BEC, a 1D M ott insulator, and a phase where the gas tubes are decoupled (i.e.phase incoherent), namely a 2D M ott insulator.

However, as mentioned in section 2, the experimental systems are indeed harmonically conned. Unfortunately, so far it has proven very dicult to deal analytically and simultaneously with strong correlations and the harmonic trap. On the other hand, numerical methods can tackle this situation [30, 31, 32, 33, 34, 35]. In the harmonic trap, the cloud becomes inhomogeneous, and thus as demonstrated in a number of numerical simulations [33, 34, 35, 57, 58], for a wide range of system's parameters, several phases can coexist in the same trap. These results have con imed the experim ental observations [12] as well as previous theoretical expectations based on m ean-eld calculations [24]. The num erical simulations have been m ostly restricted to 1D system s [57, 33] and isotropic lattices [34], we expect most of their conclusions to also apply to the anisotropic optical lattices that interest us here. Thus, we also expect coexistence of the phases described above when the system is con ned in a harmonic trap. Q ualitatively, this indeed can be understood using the local density approxim ation, assuming that the trap potential gives rise to a local chemical potential which varies from point to point. Thus, from strong interactions we expect the form ation of dom ains of the 1D M ott insulating phase near the center of the trap, whereas the super uid phase should be located in the outer part of the cloud. If the transverse lattice is very deep (i.e. if $V_{0?}$ is large) there also can be regions where the number of boson per tube is small and the the phase coherence is lost because the charging energy E_{c} becomes locally larger than E_{J} . Nevertheless, con mation of this qualitative picture will require further experimental and numerical investigation, which we hope this work helps to motivate. The coexistence of di erent phases may be revealed by analyzing the visibility of the interference pattern observed in an expansion experiment [59, 58]. Let us nally mention that the existence of the trap can also lead to new and poorly understood phenom ena such as suppression of quantum criticality [34].

Taking into account the above, we only aim at a qualitative description of some experimental observations. Thus, we have shown in 3.1.1 that the strong quantum uctuations characteristic of 1D systems strongly deplete the condensate fraction in the BEC phase that forms for arbitrarily small intertube Josephson coupling. The condensate fraction can be as low as 10% for typical experimental parameters (V_{02} = $20 E_{\rm R}$). We have also argued that the experimentally measured coherence fractions m ay also include some of the non-condensate fraction, and therefore, provided heating e ects of the sample in the measurem ent can be disregarded, the coherence fraction should be an upper bound to the BEC fraction. Quantum and thermal uctuations are also responsible for the power-law behavior of the condensation tem perature with $J = _{1D}$. E stim ates of the latter, when com pared to the experim ental estim ates of the tem perature of the lattice [7] and the nite-size excitation gap means that for $V_{02} = 20E_R$ the system should be in the BEC phase described in section 3 provided the M ott potential is su ciently weak. In this phase, the system exhibits two kinds of low energy modes in the long wave-length limit: a gapless G oldstone mode, and a gapped longitudinal mode. W hereas the form er corresponds to uctuations of the phase of the order parameter, the latter is associated with uctuations of its amplitude, namely the BEC density.


If the strength of the M ott potential is increased, the system (or at least part of it near the center of the trap) should undergo a decon nem ent quantum phase transition (or crossover, given the niteness of the sample) to a 1D M ott insulating phase. This phase is characterized by the existence of a gap in the excitation spectrum which is largely independent of the size of the tube. The hopping between the tubes is suppressed for tem peratures (or energies) below this gap, and it is incoherent above it. For a deeper optical lattices, we predict that hopping between tubes can also be suppressed by the \charging energy" of the (nite-sized) tubes. We also notice that in some experiments the duration time of the experiment is also a limiting factor for the establishment of phase coherence even if hopping is not e ectively suppressed by the charging energy.

Stoferle et al. [10] have studied an optical lattice system for several values of the depth of the transverse optical lattice potential (hence J). By analyzing the width of the momentum peak near k = 0 in the interference pattern after free expansion, they were able to deduce the energy absorption in response to a time-dependent m odulation of the M ott potential. From this analysis, they could tell when the system behaves as a super uid or as a M ott insulator. These experiments were analyzed recently [42, 60, 61, 62] and we will not repeat the conclusions of the analysis here. In the same series of experiments, they also studied the dependence of the width of the m om entum peak near k = 0 in the ground state on the strength of the M ott potential, for several values of $V_{0?}$. For a BEC or a 1D super uid, the inverse of the width is set by a geom etrical factor and it is proportional to the size of the size of the cloud (or, in the 1D case, the therm al length $hv_s=T$, whichever the shortest). For a M ott insulator, however, the inverse of the width is set by the correlation length $c' hv_s= c$, where

c is the M ott gap. Thus, an increase of the width as a function of the M ott potential reveal the opening of a gap in the spectrum of the system [33]. The experimental curves of the width as a function of the M ott potential present uptums around the points where the system should enter the M ott insulating phase in the therm odynam ic limit. Our expectation, based on the phase diagram of gure 3, is that the decon nement phase transition should take place for values of the M ott potential slightly larger than in the pure 1D case (represented by the vertical line at K = 2 in gure 3). It is necessary to recall that, in the Bose-Hubbard m odel (cf. equation (6)) that describes the systems of R ef. [10], the M ott potential controls not only the dimensionless parameter g_u that enters in the RG equations of section 4.1, but also the ratio of the interaction U to the kinetic energy J_x , and therefore the Luttinger parameter K as well. The latter decreases tow ards the Tonks limit (K = 1) with increasing $U=J_x$. The theoretical expectation is in good qualitative agreement with the experimental observation.

The nite extent of trapped cloud (either longitudinally or transversally) limits the minimum momenta of the modes. Thus the energy of the lowest modes in the 3D SF phase can be directly estimated from our results by using the minimum available momentum in (40,41). For instance, for a nite 2D lattice containing M_y M_z tubes (i.e. an atom cloud of size L M_ya M_za) the lowest available momentum is $= (M_i a)$. Putting this value into (40,41) shows that the frequency of the lowest transverse modes decreases with decreasing J. This analysis neglects the possibility of phase coexistence described above, which calls for further investigation of these issues.

We have been not able to calculate the nite temperature excitation spectrum across the dimensional crossover, but it is interesting to speculate what happens to the Tomonaga-Luttinger liquid (TLL) spectrum, especially when the longitudinal momentum q is near 2 $_0$. On general grounds, at temperatures large compared to the dimensional crossover scale T_c , the system should exhibit essentially the 1D

In the long wave-length limit, we nd the system exhibits two kinds of excitations: a gapless (Goldstone) mode, and a gapped longitudinal mode. There is also a continuum of excitations above the longitudinal mode (see discussion at the end of section 3.1.3).

spectrum of a TLL, with its characteristic continuum of (particle-hole) excitations extending roughly between q 0 and q 2 $_0$ [63]. As the temperature or the excitation frequency get below the crossover scale, the low-energy excitations around 2 $_0$ must disappear: being the BEC a 3D super uid, by Landau's criterion, there can be no low energy excitation that contributes to dissipation of super uid motion. The gap about q = 2 $_0$ in the spectrum of the anisotropic BEC phase would be thus rem iniscent of the roton gap in liquid H elium, which m ay be regarded as the rem nant of the crystallization tendency at the momentum of where the roton m inim um occurs [64]. In our case, because of the underlying 1D physics, the roton gap should have a continuum of excitations above it, which is the rem nant of the 1D continuum of excitation in the TLL (see gure 5). This m ay account for the \relatively broad" energy absorption spectrum observed in the \1D to 3D crossover" regime in the experiment of Stoferle et al. [10, 42]

7. Conclusions and discussion

In summary, through a variety of methods, we have arrived at the following picture For the case where the M ott potential is either absent, incommensurate, or generally, irrelevant in the RG, the existence of an arbitrarily weak intertube tunneling immediately turns the 1D arrays into a 3D BEC at zero temperature, albeit with

anisotropic properties. At nite temperature, thermal uctuations cause a phase transition at $T = T_c$ where the 3D coherence (and the BEC) is lost. Since T_c 1D in the quasi-1D optical lattices studied here, for $T_c < T$ 1D the system behaves as a 2D array of phase-incoherent Tom onaga-Luttinger liquids. We have obtained explicit expressions for T_c , the condensate fraction at T = 0, the excitation spectrum, and momentum distribution function, which could be compared to measurements in the experimental systems. In particular, the power-law behaviors of J= found for T_c and condensate fraction are consequences of the strong uctuations that dom inate the properties of the uncoupled 1D systems. In the presence of a relevant (in the RG sense) M ott potential, a nite intertube tunneling (J_c) is required to overcome the bcalization tendencies of the interacting bosons. This process takes place in the form of a decon nement quantum phase transition. Our main result in this case is the phase diagram shown in gure 3 as a function of $J = I_D$ and the parameter K characterizing the interactions in the tube. For the decon nem ent transition, we also nd a power-law dependence of J_c on the strength of the M ott potential u_0 , and a power-law dependence of the condensate fraction near the transition (indeed, these two results are strictly valid for K = 1=2, which is outside the range of values for bosons with short-range interactions, but we speculate that these results are adiabatically connected to the physical (for bosons) regime of K > 1 as we have found no evidence of any quantum 1 in our RG calculation.) Finally, for comparisons phase transitions for 1=2 Κ to experiments, we have looked into trape ects by studying tubes of nite length and described the transition where the system goes from a system of uncoupled 1D Luttinger liquids to the 3D super uid as (renorm alized) J overcom es the \charging energy" of the nite length tube. As discussed in details in the previous section we can compare our predictions with the experiments of Stoferle et al. [10]. Some of our predictions, in particular the large reduction of the coherent fraction is in qualitative agreem ent with the experim ent.

C learly, further experimental and theoretical studies are needed to provide a more thorough and quantitative picture of the dimensional crossover and the decon nement transition. From the theoretical point of view, taking into account the harm onic trap in a more quantitative way would be a step towards a more quantitative description of the experiments. From the experimental point of view, investigation of larger systems with more atoms per tube and more tubes, and in longer experiments that allow to probe smaller values of the Josephson coupling J, would permit a more complete exploration of the phase diagram of the quasi-1D lattices. A lso, most of the current experiments in these lattices have been carried out using rather deep M ott potentials in order to reduce the ratio of kinetic to interaction energy (this is the regime where the Bose-Hubbard model of equation (6) is applicable). However, It would be very interesting to conduct experiments where the interaction energy between the atoms is tuned independently of the longitudinally applied (M ott) potential. Increasing the interaction strength in the absence of M ott potential was recently achieved by K inoshita et al. [13] by con ning the atoms in tighter 1D traps. Under these conditions, and for interaction strength 3:5 2, 41] in 1D, the application of the M ott potential of strength much smaller than the chemical potential _{1D} should su ce to cause localization of the bosons in the 1D M ott insulating phase. To the best of our know ledge, this \weak lattice" M ott insultator has not yet really been realized. In this phase quantum e ects are stronger, and it would be then very interesting to drive the system across the decon nement transition by changing J.
