O rigin of the approxim ate universality of distributions in equilibrium correlated systems

A bstract. { We propose an interpretation of previous experiments and numerical experiments showing that, for a large class of systems, distributions of global quantities are similar to a distribution originally obtained for the magnetization in the 2D -XY model [1]. This approach, developed for the Ising model, is based on previous numerical observations [8]. We obtain an elective action using a perturbative method, which successfully describes the order parameter uctuations near the phase transition. This leads to a direct link between the D-dimensional Ising model and the XY model in the same dimension, which appears to be a generic feature of many equilibrium critical systems and which is at the heart of the above observations.

Following a rst observation by B ram well, Holdsworth and P inton [1], many studies report that the probability density functions (PDF), for spatially or tem porarily averaged quantities in correlated equilibrium [2] and out-of-equilibrium [3{5] systems have a generic asymmetric form similar to the so-called BHP distribution. This distribution (see gure 1(b)) is obtained from the magnetic uctuations in the two-dimensional (2D) XY model of magnetism, in the spin wave approximation, in the zero tem perature limit [6]. This "superuniversality" is clearly incom patible with the notion of universality classes in critical phenomena and its ubiquitous presence in out-of-equilibrium phenomena appears mysterious to say the least. In fact it is easy to nd critical system swhere the distribution is radically diment and in most situations, some deviation from BHP distribution is apparent. Even in the case of the 2D-XY model itself it has been recently established that small temperature-dependent corrections exist [7,9,10]. There are therefore strict physical criteria associated with both the observation of this generic behaviour and with the deviations from it, just as in the case of G aussian uctuations through the application of the central limit theorem. In this paper we expose these criteria through the study of a well known and well controlled equilibrium system, the 2D Ising model, the

aim being to show microscopically how a XY-like behaviour appears in the Ising model. U sing num erical simulations for the 2D Ising model [2,8] we established that there exists a range of tem peratures T (L), or applied eld H (L) close to the critical point $(^{1})$ (T_c(L); H = 0), where L is the system size, where the PDF is similar to the BHP function. At this specic tem perature or eld the magnetization shows intermittent behaviour, where coherent structures appear on interm ediate tim e scales, in analogy with injected power uctuations in enclosed turbulent ow [3,8]. This should be contrasted with the behaviour at the critical point, where the am plitude of the structures and the ensuing interm ittency are cut o by the boundaries of the available phase space. The cross over from approximate superuniversality to universality class dependence is related to this change of regime. We approach the critical point from the ordered phase, making a perturbation expansion about the ordered state. The calculation shows that there is indeed a quantitative similarity between the uctuations for 2D XY and Ising models up to this threshold and this is the origin of generic behaviour in the Ising system . Through this result we are able to make som e precise statem ents about the criteria leading to such generic behaviour in m ore disparate and less well controlled system s. We consider the 2D classical Ising model on a square lattice of size L L described, after the Hubbard-Stratronovitch transform ation, by $N = L^2$ continuous variables i, leading to the partition function Z [11]:

where K is the coupling matrix whose elements are K_{ij} = K (2 $r_{i},r_{j} + r_{j},r_{i+}$), and = K = 1=T. The vectors are the lattice unit vectors \hat{x} and \hat{y} , and is an arbitrary parameter introduced by the Hubbard-Stratonovitch transformation. It is chosen so that all the eigenvalues of K are positive, and the mean-eld critical tem perature $T_{c}^{mf} = 2(D +)$ is usually de ned with = 0. The local spin $_{i}$ is thus mapped onto the local magnetization $m_{i} = \tanh \frac{P_{i}}{j=1}^{N} K_{ij} + H$.

Generalized G insburg criterion for uctuations at large length scale. { The usual criterion used in critical phenom ena to discuss the validity of a perturbative approach to the uctuations is the G insburg criterion. This is de ned such that the ratio of the two-point correlation function, averaged up to the correlation length and the square of the magnetization, averaged on the same scale, be small. For the 2D Ising model it is well known that this ratio is not small compare to unity, and therefore a perturbative approach can not capture the physical behaviour of them odel up to this length scale. In our particular case how every e are interested in the uctuations at a large scale l, not equal to . It is hence natural to de ne a generalized G insburg criterion by the ratio (for D < 4):

Here, G (r) is the two-point correlation function which is roughly equal to $1=r^{D}$ ²⁺ for r < and 0 for r > . Im (r)i is the local magnetization, which scales like ⁼. The second and approximate equality is obtained using the scaling hypothesis and is true independently of

 $^{(^{}l})$ T was de ned in ref. [3] as the tem perature where the kurtosis of the distribution most closely approximates to that for the BHP function. As usual for nite size systems, we de ne the critical tem perature the one corresponding to the maximum value of the susceptibility.

the value of the critical exponents. The traditional G insburg criterion is recovered for l and it is unsatised for all dimension D < 4 (A ' 1). The main result of ref. [8] is that along the locus of temperatures T (L), while the correlation length diverges with L as expected for a critical phenomenon, its amplitude is small compared to L: =L ' 0:03. Therefore we have R_L (T (L)) 1 and we expect that the uctuations at the integral scale l= L could be described, to an excellent approximation, by a perturbative development. Such an approach cannot of course give correct critical exponents but this is consistent with the observation that such behaviour is, to a very good approximation, we are expanding about the zero temperature

xed point, which is Gaussian. The major contribution to the uctuations will come from length scales of the order of the correlation length. From the microscopic scale up to the e ective action stays close to the non-trivial xed point, only to cross over towards the zero temperature xed point for l'L. The calculation approximates the behaviour at this scale with contributions estimated from the zero temperature sink.

To make the perturbative development we denote the \fast", uctuating variables i = i = 0 which we separate from the \slow " variable 0 = i = i = N. Here the term s \fast" and \slow " are taken from the dynamical point of view as we will see in detail below. We take the i to be small. The electric action, expanded to low est order in the i and Fourier transformed can be separated into two parts:

where S_1 is the minimal set of Fourier modes $q = (2 \text{ p=L}; 2 \text{ q=L}) \in (0; 0)$ that, in addition to the operation q = (2 (L p)=L; 2 (L q)=L), Its up the entire Brillouin zone except the zero mode. This prevents us to count twice the quantities $_q$. We also de ne T = tanh [2K (D +)_0 + H] and $K_{qp} = 2K (+ \cos q_x + \cos q_y)$. The total magnetization is then given by m_{tot} 'T 2T (1 T²) $_{q2S_1}K_{q}q_{q}=N$.

Dynam ical approach. { To this low est order, the action (3) looks similar to that of the 2D -XY model with a propagator that is a function of H and $_0$. Setting $_0$ constant would make it truly XY -like, with a massive propagator. However, at zero eld this is not the case as we have here a nite size system. Hence, in dealing with the elective action we have to take into account the fact that there is no rigorous symmetry breaking and that the equilibrium, low temperature magnetization is strictly zero, in zero eld. For this reason we choose a dynam ical approach separating time scales for uctuations about a local free energy minimum from those for a passage from one localminimum to the other. This separation of scales de nes the fast modes and slow modes of evolution. At low temperature, or in nite eld, the slow, or ergodic time scale will be outside the numerical or experimental observation time scale and we expect uctuations around a single minimum. As the critical point is approached, we expect this

separation of scales to be no longer possible with the result that the sym m etry is restored. We can now follow the Langevin dynamics from the action (3). Dening the elds $q^{(1)}$ (resp.

 $_{\rm q}^{(2)}$) as Re($_{\rm q}$) (resp. Im ($_{\rm q}$)), we obtain the following Langevin equations for the fast and slow degrees of freedom :




Fig. 1 { Numerical test of the Langevin dynamics, for = 2:5 and L = 65. (a) The data () are M onte C arlo simulations at T = 1:7 and L = 64. The data () are obtained by Langevin dynamics from equation (4) at $T_{dyn} = T_c^{mf}$ 0:74. The plain curve corresponds to the distribution of the G aussian m odel (L = 64) with mass M = 3:5 10⁻¹ [14]. (b) The plain curve is the BHP distribution [6]. The data () are M onte C arlo simulations for L = 64 system at T (L) = T_c 0:94 [8]. The data () are from the Langevin dynamics (4), at T (L;) = T_c^{mf} 0:95. Inset: examples of m agnetization dynamics.

where the are Gaussian -correlated noise: $h_q^{(\)}(t) q_0^{(\)}(t^0)i = 2$; $_{0q,q^0}(t)$, and $h_0(t)_0(t^0)i = 2$ (t). We have now all the ingredients to compute P (m;), the PDF of the instantaneous magnetization m at time . It is given by, P (m;) = h m $m_{tot}()i_{f_0;q}g$: A spreviously [3,6] we introduce a reduced scaling variable for the magnetization. Here we are interested in uctuations around the typical value of m, m = $lm_{tot}i_{f_q}g$, where the average is performed over all noise except $_0$. Similarly we dene the width of the distribution as $^2 = lm_{tot}^2i_{f_q}g$ m², and the reduced magnetization $_{tot} = (m m) = .$ We stress that m and 2 are not the mean and variance of the instantaneous magnetization, as we have not averaged over the noise $_0$.

At this stage of our derivation, it is useful to num erically check the approxim ations and assumptions made so far, i.e. the perturbation expansion, the Langevin dynamics and the logic of the separation of time scales. In gure 1 (a) we show data generated by integrating num erically equations (4) for a tem perature below the mean-eld critical tem perature, at zero eld. This shows that perturbation theory can indeed capture the rst departure from Gaussian uctuations, as the critical point is approached. In qure 1(b) we compare the PDF obtained from M onte C arb simulations at T (L = 64) = T_c 0:94 [8] with the results of Langevin dynamics at T (L = 65; = 2.5) = T_c^{mf} 0.95. A sone can see the agreem ent is good and the data give an equally good t to the BHP function. Dierences appear in the wings of the distribution. The perturbation scheme overestim ates the value of the PDF, illustrating the lim it of its validity. However, it is clear that, at least in the case where the symmetry is e ectively broken and where our criterion (2) is satis ed, the scheme captures the magnetic uctuations of the Ising m odel to an excellent approxim ation. Our scheme has to be compare with mean-eld treatment of Zheng [13] where a simple approximation or ansatz can also describe most of the features. Here however, the connection with the XY-model is revealed through a separation of the \fast" variables, described by spin waves like excitations, and

\slow " variables, representing the evolution of the global magnetization within the e ective potential minima.

Probability density function of the uctuations. { Using the integral representation of the Dirac function, P(m;) can be written as a path integral over the noise $_0$ and $_q$. As the equations on $_q^{()}$ are linear (4), they can be integrated out if we assume that $_0$ is slow by varying with time. This is true at low temperature: $_0$ is the instantaneous magnetization within them ean-eld approximation, and the uctuations around this value are represented by the $_q^{()}$. The amplitude of the uctuations of the global variable $_0$ in equation (4) are scaled by the factor 1=N coming from S₀, and therefore $_0$ does not, at least at low temperature, venture far from the energy minima. In this case, the quantity G_q, which depends on $_0$, can be considered as constant. That is, we can replace the propagator by its time averaged value during the period .

A fler som e algebra, de ning $g_k = 2 \begin{bmatrix} P \\ q_{2S_1} \end{bmatrix} K_q G_q$ coth $(=G_q)^k = N^k$, one nally obtains

The function $_{X\,Y}$ is the PDF for the 2D-XY model in the spin wave approximation with a massive propagator, $G_q^{-1} - q^2 + M (_0)^2$ [14]. Here $_{X\,Y}$ depends on the temperature as the mass varies with temperature through $_0$. In the limit M ! 0, the temperature dependence disappears and $_{X\,Y}$ becomes precisely the BHP function.

In order to obtain the PDF for m_{tot}, we would have to evaluate the last path integral over $_{0}$. This integral is related to the non linear Langevin equation (4). At T = 0 the dom inant solution of the equation of motion is $_{0}^{(0)}$ (t) = constant, which is a solution of $S_{0} = _{0}$ (u) = 0: the mode $_{0}^{(0)}$ does not have any dynam ics and it a ects the PDF only by imposing a nite m ass M ($_{0}^{(0)}$). Physically this means that the PDF for the Ising model at low temperature should be the same as that obtained for the 2D-XY model with a small magnetic edd. This is exactly what we have observed in gure 1(a). At nite temperature how ever non constant solutions exist: these are the instantons associated with the non-linear Langevin equation (4). Expressing the path integral in (5) over $_{0}$ (t) as a path integral $_{0}^{0}$ [$_{-0}^{0}$ (u) + $S_{0} = _{0}^{0}$ (u)]² du. This leads to

The second order derivative of S_0 , which comes from the Jacobian of the transform ation, is of order N compared with order N² for the other terms and is therefore negligible. To simplify the analysis, we assume periodic boundary conditions, $_0(0) = _0()$, and the rst argument of the exponential in (6) vanishes. The non constant solutions $_0^{(k)}(u)$, k > 1 verify $_{-0}(u)^2 = 2 = V_0$ V_e [$_0(u)$], where $V_0 > 0$ is a constant of motion that depends on the instanton trajectory and $2V_e$ [$_0(u)$] = [$S = _0(u)$]² is an elective inverted potential. From (6) we de ne an elective action S_e whose $_0^{(k)}$ are the classical time dependent solutions:

Generally, we assume that V_0 tends exponentially to zero when is large. For an action with two wells $S_0 = a_0^2 = 2 + \frac{4}{0} = 4$, with a / $\frac{T}{P_0}$ T, we can evaluate this constant. W$ hen is large, V has to be small, and the main contributions from the previous integral come from the end points: V_e ' $2\hat{a}^2 (_0 \quad pa)^2$ for 0 close to 0. It is then easy to show that V_0 / exp ($\frac{1}{2}a$) and it is hence legitim ate to discard this constant for large time . The e ective action S_e can be simplied in this case, and is equal to $S_0^{(k)}$, the sum of the energy barriers crossed by the instanton $\binom{(k)}{0}$ during the time . Finally, the distribution 6) can be put into the following form

where the C_k 's are coe cients related to the Gaussian uctuations around the saddle point solutions $_0^{(k)}$. These instantons restor the system symmetry. Below the critical region they appear only on exponentially large time scales, and can be neglected on the time scale of any observations. Near the critical point they appear more frequently and lead to a phase transition in the nite system. It is extremely challenging to exactly compute the contribution from the instantons [15] and to do so would, in any case, give only an approximate description of the true critical dynamics, so we do not attempt it here. Rather, the nalexpression (7) is su cient for our purposes as it exposes both the origin of generic critical uctuations and of the dependence on universality classes through the generation of instanton like excitations.

Interpretation and generalization. { We have shown that at this level there are two distinct contributions to the PDF for magnetic uctuations in equation (7). The rst is a G aussian action coming directly from the perturbation expansion and as long as quadratic uctuations are present, such a term must appear. The limiting case of zero m ass corresponds BHP distribution. The Ising model universality class does not appear in this term and in this sense it is superuniversal. The uctuations described here are localized around the typical value of the magnetization and are sensitive to the local geometry around this point in phase space, not to the global structure of the phase space related to the universality class. The second term com es from the contribution of instantons that restore phase space symmetry and so is strongly dependent on the universality class. It is the analogue of the corrections com puted exactly for the 2D-XY m odel within the spin wave approximation [9,10]

The existence of a point, or points, in the phase diagram where the PDF of the 2D Ising model is close to the BHP distribution [8] results from a comprom ise between these two terms: to be as close as possible to BHP, we have to reduce the mass in the Gaussian propagators of the rst term. This is exactly what happens as one approaches T_c and the instantaneous value of $_0$ reduces. At the same time the contribution from instantons has to be small, which is not the case at T_c : reducing $_0$ increases the probability of inducing an instanton, taking the system from one local minimum to the other. This occurs just as the correlation length becomes of the order of the system size, hence the instanton contribution being small corresponds exactly to our criterion (2) being satis ed. The temperature T studied in [8] is the point of best comprom ise. The application of a small magnetic eld breaks the symmetry, increasing the

barriers $S_0^{(k)}$. The contribution from instantons is then reduced and one can expect better agreem ent with BHP than in zero eld. This is just what is observed. However, while the agreem ent with BHP can be excellent it is approximate and there will always be corrections to it.

W hat other correlated system s show sim ilar behaviour? The previous analysis suggests that generic behaviour rem iniscent of the D-dimensional Gaussian model should indeed be commonly observed in equilibrium correlated systems in D-dimensions. We show in fact that uctuations of this generic type correspond to perturbative corrections to the central limit theorem and that in this sense such systems should be thought of as being weakly, rather than strongly correlated. It suggests also that one should expect variations. These variations can be large, com ing from non-linear instanton-like objects, taking the distribution far from the generic asymmetric form shown in Fig.1 (b) [8,16], or they can be smaller, coming from the harm onic contribution itself. That is, the BHP function is not a miraculous unique function for all circum stances, rather distributions of the form of the rst term in equation (7) depend weakly on the boundary conditions [6, 17, 18], on the mass [14] and even on the tem perature [9,10]. Of these parameters the strongest dependence is on dimension: we expect that 3D correlated equilibrium systems are related to the 3D Gaussian model, which has weakly asymmetric order parameter uctuations and is not critical [6,19]. Interestingly, out of equilibrium three dimensional systems show results resembling the 2D -XY model [1,2,4], or the closely related G um bel distribution [17] characteristic of a one-dimensional system with long range interactions not those of the 3D-XY model. These results seem to suggest the presence of a dimensional reduction in such systems that remains to be explained.
