## Is tim e continuous?

Conventional time is modelled as the one dimensional continuum  $R^1$  of real numbers. This continuity, however, does not stem from any fundamental principle. On the other hand, natural time is not continuous and its values as well as those of the energy, form countable sets, i.e., with cardinalities either nite or equal to  $0_0$ , where this symbol stands for the trans nite number of natural numbers. For in nitely large number of conventional time an uncountable set. This has a drastically larger cardinality, which in the light of the continuum hypothesis become sequal to  $2^{0_0}$ .

In reviewing the state of physics today, a consensus seems to emerge that we are missing something absolutely fundamental, e.g., [1, 2]. Furthermore, there is a widespread belief that, it is not space but time that in the end poses the greatest challenge to science (e.g., p.18 of [3]). Time, according to Weyl (see p.5 of [4]) for example, is \the primitive form of the stream of consciousness. It is a fact, however, obscure and perplexing to our m inds, that ::: one does not say this is but this is now, yet no m ore" or according to G odel \that m ysterious and seem ingly self-contradictory being which, on the other hand, seems to form the basis of the world's and our own existence." (p.111 of [3]). The challenge seems to stem from the fact that special relativity and quantum mechanics, which are the two great (and successful) theories of twentieth-century physics, are based on entirely di erent ideas, which are not easy to reconcile (In general, the form er theory, according to E instein [5], is an example of \principled theory" in the sense that you start with the principles that underlie the theory and then work down to deduce the facts, while the latter is a \constructive theory" meaning that it describes phenom ena based on som e known facts but an underlying principle to explain the strangeness of the quantum world has not yet been found). In particular, special relativity puts space and time on the same footing, but quantum mechanics treats them very di erently, e.g., see p.858 of Ref.[6]. (In quantum gravity, space is uctuating and time is hard to de ne, e.g., [7]). More precisely, as far as the theory of special relativity is concerned, let us recall the following wording of Einstein [8]:

\Later, H.M inkow ski found a particularly elegant and suggestive expression ......, which reveals a form al relationship between Euclidean geom etry of three dimensions and the space time continuum of physics...... From this it follows that, in respect to its role in the equations of physics, though not with regard to its physical signi cance, time is equivalent to the space co-ordinates (apart from the relations of reality). From this point of view, physics is, as it were, Euclidean geom etry of four dim ensions, or, more correctly, a static in a four-dim ensional Euclidean continuum ."

whereas in quantum mechanics, Von Neumann complains[9]:

F irst of all we must adm it that this objection points at an essential weakness which is, in fact, the chief weakness of quantum mechanics: its non-relativistic character, which distinguishes the time t from the three space coordinates x,y,z, and presupposes an objective simultaneity concept. In fact, while all other quantities (especially those x,y,z, closely connected with t by the Lorentz transform ation) are represented by operators, there corresponds to the time an ordinary number-parameter t, just as in classical mechanics".

Note also that Pauli[10] has earlier shown that there is no operator canonically conjugate to the H am iltonian, if the latter is bounded from below. This means that for m any system s a time operator does not exist. In other words, the introduction of an operator t is basically forbidden and the time must necessarily be considered as an ordinary number (but recall the long standing question that Schrodinger's equation, as well as Einstein's general theory of relativity, is sym m etric under tim e reversal in contrast to the fact that our world is not, e.g., [11]). These observations have led to a quite extensive literature mainly focused on time-energy (as well as on \phase-action") uncertainty relation, proposing a variety of attempts to overcome these obstacles. The discussion of this literature, however, lies beyond the scope of the present paper. W e just sum m arize here that the (conventional) time t is currently modelled as the onedimensional continuum  $R^1$  of the real numbers, e.g., p. 10 of [7] (orp.12 of [4] in which it is stated that  $\backslash :::$  the straight line ::: is how ogeneous and a linear continuum just like tim e"). It is this continuity on which the present paper is focused, in a sense that will be explained below.

It has been recently shown that novel dynam ical features hidden behind time series in complex systems can emerge upon analyzing them in a new time domain, term ed natural time [12, 13, 14, 15, 16, 17] (see also below). It seems that this analysis enables the study of the dynam ical evolution of a complex system and identi es

when the system enters a critical stage. Hence, natural time may play a key role in predicting impending catastrophic events in general. R elevant exam ples of data analysis in this new time dom ain have been presented in a large variety of elds including biology, earth sciences and physics. As a rst example, we mention the analysis of the electrocardiogram swhich m ay herald a cardiac arrest [18, 19]. Secondly, the detection and the analysis of precursory electric signals, term ed Seism ic Electric Signals (e.g., [20, 21, 22, 23, 24]), may lead [12, 13, 16, 17] to the prediction of an impending strong earthquake. A third application of natural time refers to the manifestation of aging and scaling properties in seism ic event correlation [25, 26]. Finally, as a fourth example we mention that the data of the avalanches of the penetration of magnetic ux into thin lms of type II superconductors as well as those of a three dim ensional pile of rice getting progressively closer to the critical state conform to [27] the features suggested, on the basis of natural time, to describe critical dynam ics.




FIG.1: (color online) (a) How a dichotom ous series of electric pulses in conventional time t (upper panel, red) can be read [12, 13] in natural time (lower panel, blue). The sym – bolE stands for the electric eld (not to be confused with  $E_k$  used in the text). (b) The same as in (a), but for a series of seism ic events (e.g. [12, 16, 17]).

In a time series comprising N events, the natural time k = k = N serves as an index for the occurrence of the k-th event [12, 13], and it is smaller than, or equal to, unity (cf. the symbol originates from the ancient G reek o o& (chronos) which means \time"). In natural word time analysis the evolution of the pair of two quantities (  $_{k}$ ;  $E_{k}$ ) is considered, where  $E_{k}$  denotes in general a quantity proportional to the energy of the individual event. For example, to perform the analysis of seism ic events (Fig.1 (b)), we consider the time evolution of the pair  $(k; M_{0_k})$  where  $M_{0_k}$  stands for the seism ic m om ent of the kth event [12, 16, 17], since M  $_{0_k}$  is proportional to the energy emitted in that earthquake (cf. M  $_{0_k}$  di ers essentially from the magnitude M , but they are interconnected). A sanother example, we refer to the analysis of dichotom ous electric signals (Fig.1 (a)) where we consider  $E_k$  as being proportional to the duration of the kth pulse[13, 14, 15]. For the purpose of analysis, the follow ing continuous function (!) was introduced [12, 13]:

where  $p_k = E_k = \sum_{n=1}^{P} E_n$  and ! = 2, and stands for the frequency in natural time, term ed natural frequency. We then compute the power spectrum (!) of (!) as

If we regard  $p_k$  as a probability density function, (!) may be justiled to be treated mathematically as a characteristic function in analogy with the probability theory [28]. Then, the properties of the distribution of  $p_k$  can be estimated by the expansion of this characteristic function for ! 0.

The optim ality of the natural time representation of time series has been recently shown [29] by means of the following procedure: The structure of the time-frequency

representation [30] of the signals was studied by employing the W igner function [31] to compare the natural time representation with the ones, either in conventional time or other possible time reparam etrizations. Signi cantenhancement of the signal was found in the time-frequency space if natural time is used, in marked contrast to other time domains. Since in time series analysis, it is desired to reduce uncertainty and extract signal information as much as possible, the most useful time domain should maximize the information measure, and hence minimize the entropy. This was statistically ascertained in natural time, by investigating a multitude of di erent time domains in several electric signals.

N atural time , from its de nition, is not continuous and takes values which are rational num bers in the range (0,1]. (In these num bers, as the com plex system evolves, the num erators are just the natural num bers (except 0), which denote the order of the appearance of the consecutive events). Hence, one of the fundam ental di erences between (conventional) time and natural time refers to the fact that the form er is based on the idea of continuum, while the latter is not. This paper aim s at raising som e consequences of this di erence, and in particular those that stem from the set theory developed by C antor, having in m ind the follow ing rem ark m ade by Schrödinger (see pp. 62-63 of R ef.[32]):

\W e are fam iliar with the idea of continuum, or we believe ourselves to be. W e are not fam iliar with the enorm ous di culty this concept presents to the m ind, unless we have studied very m odern m athem atics (D irichlet, D edekind,C antor)."

We clarify in advance that we do not tackle here the case (since it is inapplicable to our universe[33]) raised by G odel in 1949 who discovered [34] unexpected solution to the equations of general relativity corresponding to universes in which no universal tem poral ordering is possible (see also R efs.[3, 35] and references therein). This solution acquires its sim plest form (see p.86 in [36]) \with two of the coordinate-line-elements time-like (the other two space-like)". Interestingly, Schrodinger in an early version of R ef.[36], which was published alm ost simultaneously with G odel's work, had also emphasized that \there is no necessity for just three of the four lineelements being space-like, one time-like ::: " (cf. note also that very recently it was suggested [37] that when the universe was small enough to be governed by quantum mechanics, it had four spatial dimensions and no dimension of time.)

W e now recapitulate som e points of the Cantor's set theory that are relevant to our present discussion. A trans nite num ber or trans nite cardinal is the cardinality of some in nite set, where the term cardinality of a set stands for the number of members it contains, e.g., pp. 2-3 of [38]. The set of natural num bers is labeled by N, while the num ber of natural num bers is designated by  $Q_0$ , i.e.,  $Q_0 = N$  j (cf. the cardinality of a set S is labelled '5). In this trans nite num ber, the zero subscript is justi ed by the fact that, as proved by Cantor, no in nite set has a sm aller cardinality than the set of natural num bers. It can be shown that the set of rational num bers designated by Q has the same cardinality as the set of natural num bers, or N = D j (e.g., Theorem 2 in [38]).In other words, the rationals are exactly as num erous as the naturals. Note that a set is countable i its cardinality is either nite or equal to Q o and in particular is term ed denum erable i its cardinality is exactly @ 0. (cf. As usually, for \if and only if "we write simply \i "). A set is uncountable i its cardinality is greater than  $Q_0$ , see also below . Hence, natural tim e takes values (which, as mentioned, are rational numbers) that form in general a countable set; this becom es a denum erable set [39] if the number of events is in nitely large. Further, since in natural time analysis we consider the pairs  $(k; E_k)$ , the values of the quantity  $E_k$  should form a set with cardinality equal to (or smaller than)  $Q_0$ . In other words, the values of the energy also form a countable set, which re ects of course that the energy is not continuous.

The fact that  $\mathbb{N} = \mathbb{D}$  j is an astounding result in view of the following: The rational numbers are dense in the real numbers, which means that between any two rational numbers on the real number line we can not in nitely more rational numbers. In other words, although the set of rational numbers seem s to contain in nities within in-

nities, there are just as m any natural num bers as there are rational numbers. This rejects the following point: Let us assume that we follow a system with some (experimental) accuracy, in which, as mentioned, after an in nite number of events the cardinality of the set of the values of natural time is  $@_0$ . Let us assume that we now repeat the measurement with more sensitive instrumentation (i.e., counting events above an appreciably smaller energy or duration threshold in F igs. 1b and 1a, respectively) and hence between two consecutive events of the form er m easurem ent a considerable number of appreciably sm aller events is monitored. The corresponding cardinality, in contrast to our intuition, is again  $@_0$ . (The inverse, i.e., when the instrum entation becomes less sensitive, may correspond to a \coarse graining" procedure). In others words, when considering the occurrence of innitely large number of consecutive events, the natural time takes values that form a denum erable set and this remains so even upon increasing the accuracy (and hence low ering the uncertainty) of our measurem ent.

W e now turn to the aspects of C antor's set theory related to the real num bers, which as mentioned are associated with the conventional time. It is shown that the num ber of points on a nite line segment is the same as the number of points on an in nite line (e.g., Theorem 13 in [38]). Considering the de nition: The number of real num bers is the same as the num ber of points on an in nite line (or in the jargon, the num erical continuum has the sam e cardinality as the linear continuum ), let \c" designate the cardinality of the continuum -or equivalently the cardinality of the set of real num bers. (Hence  $c = \frac{1}{2}$  j by de nition). It is proven (e.g., Theorem 16 in [38]) that the set of real numbers is uncountable, or  $\Re j > Q_0$ . (Equivalently, this theorem asserts that  $c > Q_0$ ). Hence, the values of conventional time form an uncountable set, in contrast to that of natural time which as mentioned is countable. In order to further inspect this fundam ental di erence, we resort to the continuum hypothesis (CH) -see below - which was form ulated (but not proved) by Cantor. This, after Euclid's parallel postulate, was the rst major conjecture to be proved undecidable by standard m athem atics[39].

We rst clarify that the power set S of a set S, which is the set of all subsets of S, has a cardinality  $j S j = 2^{jS j}$ when S is nite. A coording to C antor's Theorem the cardinality of the power set of an arbitrary set has a greater cardinality than the original arbitrary set, i.e.,  $j S j > \beta j$ (e.g., Theorem 4 in [38]). This theorem is trivial for nite sets, but fundam ental for in nite sets. Hence, for any in nite cardinality, there is a larger in nite cardinality, namely, the cardinality of its power set. From CH, which asserts that there is no cardinal number such that  $Q_0 < < c_r$  it follows that the next largest trans nite cardinalafter  $Q_0$  (labelled  $Q_1$ ) is c, thus  $c = Q_1$ . Since Cantor proved (e.g., Theorem 17 in [38]) that  $Q_1 = 2^{Q_0}$ , CH leads to:  $c = 2^{e_0}$  (thus, this is the num ber of points on an in nite line). Hence, if we assume CH, the cardinality of the set of the values of natural time -when considering in nitely large num ber of events-corresponds to  $Q_0$ , while that of the conventional time is  $2^{Q_0}$ . The values of the form er, as m entioned, are rational num bers, while alm ost all the values of the latter are irrational, because, since 2<sup>@</sup>  $Q_0$ , alm ost all reals are irrational num bers. (On the other hand, without assuming CH we have essentially no idea which trans nite number corresponds to c, and we would know the cardinality of the

naturals, integers, and rationals, but not the cardinality of the reals, e.g., p. 15 of [38]). As for the values of  $E_k$ , they are not necessarily rational, because in general when taking  $\theta_0$  (at the most) out of  $2^{\theta_0}$  values they m ay all be irrational. Hence, even upon gradually in proving the accuracy of our measurements, both sets f  $_k$ g and fE  $_k$ g remain denum erable, the form er consisting of rational num bers only.

Schrodinger, in order to point out the \Intricacy of the continuum ", used an exam ple analogous to the C antor set C (see pp. 138-143 of R ef. [40]). The latter is given by taking the interval [0,1], rem oving the open m iddle third, removing the middle third of each of the two remaining pieces, and continuing this procedure ad in nitum. The cardinality of this set C is no less than that of [0,1]. Since C is a subset of [0,1], its cardinality is also no greater, so it must in fact be equal. In other words, there are as m any points in the C antor set as there are in [0,1], and the Cantor set is uncountable. The same holds for the random Cantor set, which has been suggested as being involved in the geometrical description of the uctuations of the vacuum [41] (cf. m odern physicists hypothesize that what appears to our senses as empty space is in reality a richly dynamical medium [42, 43], which has energy, e.g., [44, 45].). Hence the cardinality of either a Cantor set or a random Cantor set di ers drastically from that of the set of the values of natural time.

We nally comment on the common view that (conventional) time is continuous, keeping in the frame that, as pointed out by Schrodinger (p. 145 of Ref. [46]) \our sense perceptions constitute our sole know ledge about things". In short, it seems that the continuity of time does not \From our experiences on a large scale...... physicists had distilled the one clear-cut dem and that a truly clear and complete description of any physical happening has to ful ll: it ought to inform you precisely of what happens at any point in space at any moment of time ...... We may call this dem and the postulate of continuity of the description". Schrödinger, however, subsequently com mented on this dem and as follows (see p.131 of [40]): \It is this postulate of continuity that appears to be unful llable!....." and furthermore added: \W e m ust not adm it the possibility of continuous observation". If we attempt a generalization of these intuitive remarks, we may say that the concept of natural time is not inconsistent with Schrödinger's point of view.

In sum mary, conventional time is currently assumed continuous, but this does not necessarily result from any fundamental principle. Its values form an uncountable set, almost all of which are irrational numbers. On the other hand, natural time is not continuous, and its values form a countable set consisting of rational numbers only; further, the values of the energy, which are not necessarily rational, also form a countable set. Upon considering an in nitely large number of events, the cardinality of the set of the values of natural time is  $@_0$  (cf. it persists even upon increasing the accuracy of the measurement), thus being drastically smaller than that of conventional time, which equals to  $2^{@_0}$  if we accept the validity of the continuum hypothesis.
