CriticalVelocities for Energy D issipation from Periodic M otions of Impurity in B ose-E instein C ondensates

A phenom enon of energy dissipation in Bose-E instein condensates is studied based on a m icroscopic model for the motion of impurity. Critical velocities for onset of energy dissipation are obtained for periodic motions, such as a dipole-like oscillation and a circular motion. The rst example is similar to a series of M IT group experiments settings where the critical velocity was observed much below the Landau critical velocity. The appearance of the smaller values for the critical velocity is also found in our model, even in the hom ogeneous condensate in the therm odynam ic limit. This suggests that the landau criterion be reexam ined in the absence of quantized vortices in the bulk limit.

I. IN TRODUCTION

In 1941 Landau gave a phenom enological argum ent about the critical velocity in a super uid below which no energy dissipations occur [1]. H is argument was entirely based on a kinem atics and the G alilean invariance. This critical velocity is now known as the Landau criterion, which states that if impurities in a super uid move slower than $v_c = m$ in ! (p)=jp j then there are no excitations created in a super uid. Here ! (p) is the dispersion relation of excitations with the momentum p. This then explains the phenom enon of the super uidity. In a real super uid, however, nite energy dissipations take place even below the Landau critical velocity. This is due to creation of quantized vortices, which was explained later by Feynman [2]. A m icroscopic understanding of the super uidity was initiated by Bogoliubov [3]. He particularly showed that the phenom enon of super uidity can be explained as a consequence of condensation of massive bosons in the ground state. A lthough his model cannot be strictly speaking, applied to the real⁴ H e due to strong interactions between atoms, he succeed to explain the Landau criterion from the st principle. Bogoliubov's weakly interacting massive boson model has been studied extensively in m ore than half century [6].

The celebrated experimental realization of Bose-E instein condensates (BECs) in several alkali vapors have revived theoretical works on BECs as well as experimental works [4, 5]. Particularly, the mean eld approximation of the Bogoliubov model, the Gross-Pitaevskii equation, has been studied extensively [5]. One reason is because this model can be adopted as a realistic model. A nother reason is that the current experimental technics are remarkably well developed and under controlled to provide variety of opportunities to test these theories. Indeed, so far theories have good agreements with experin ental results in m any cases. However, there are still experim ental facts which are left w ithout satisfactory explanation. In this paper we would like to give analytical argum ent to one of those experim ents. They are a series of experim ents done by M IT group [7{9].

These experiment were intended to examine the Landau criterion in BECs. Interestingly, they have found disagreem entwith Landau's argum ent. The essence of these experiments is as follow. The sodium condensate was created in an isotropic harm on ic traps form ing an elongated in one axial direction. A Gaussian laser beam was then used to stir the condensate by moving it back and forth periodically. The critical velocity for creating energy dissipation was observed less ten tim es smaller than the Landau critical velocity. Since a publication of these experim ental results, there appear m any theoretical works to ful 11 this discrepancy. One of the important question is whether this experim ental fact is due to the bulk property of BECs or is originated from other factors, such as creation of vortices [10], the geom etry of the condensate [11], and so on [12]. There is no doubt about the fact that all these factors give rise to the experim ental observations of energy dissipations below the Landau critical velocity. How ever, there still rem ain unclear whether this discrepancy m ay happen in the hom ogeneous system .

In this paper we argue that the appearance of the smaller critical velocity is also part of the bulk properties of the condensates. Hence this elect does occur even in the hom ogeneous system in the therm odynam ic lim it as contrast to the original Landau's argument. To demonstrate it we will evaluate the critical velocity for the energy dissipation in the hom ogeneous BEC in the therm odynam ics lim it at zero temperature. To capture the physics of M IT experiments, we couple the weakly interacting bosons with an external in purity whose trajectory is given by a periodicm otion sim ilar to the actual experiment. We show that this model provides qualitative understandings of the discrepancy observed in laboratories. We also compare the result with other possible periodicm otion, a circularm otion. The result show sthat

the sam e conclusion holds for the case of the circularm otion. A comparison between two cases suggests that the circularm otion has more dissipation than the dipole-like oscillation and the larger critical velocity.

The paper continues as follows. In Sec. II we give a sum mary of our model and its solution within the Bogoliubov approximation. A formula for the energy dissipation due to the motion of impurity in BECs is also given. An idealized case of MIT group experimental settings is studied and the critical velocity is evaluated in Sec. III. In Sec. IV energy dissipation from a circularm otion and its comparison to the result of Sec. III are given. Sec. V gives a sum mary and discussion of our results.

II. THE MODEL AND ITS SOLUTION

A. The model H am iltonian and its diagonalization

The model for motions of classical impurities in the hom ogeneous BEC was proposed and studied in [18{20]. We give a summary of result together with the essence of the model. The total Ham iltonian is the sum of two parts. One is the standard B ogoliubov weakly interacting massive bosons term \hat{H}_B , and the other is the interaction term \hat{H}_I between bosons and a moving impurity which takes into account the local interaction between them :

where M is the mass of the bosons. The coupling constant g between bosons is expressed in term softhe s-wave scattering length $a_s; g = 4 a_s \sim^2 = M$. We assume the repulsive interaction g > 0 and diluteness $na_s^3 = 1$ with n the number density of bosons. The interaction term is

Here is the coupling constant between bosons and the impurity, and $_{c}(x;t)$ is the time dependent distribution of classical impurity. Particularly, we have in m ind an idealized point-like disturbance on the condensate guided along a given trajectory (t), i.e. we will adopt the replacement $_{c}(x;t) = (x (t))$.

In order to estimate the e ects of the impurity in the therm odynamics limit, we expand the eld operators (x;t) in terms of the plane wave basis with periodic boundary conditions in a nite size box $V = L^3$. The limit N and V go to in nity whit a xed density n = N = V will be taken at the end of calculations. We follow Bo-goliubov's treatment to simplify the total Ham iltonian $\hat{H} = \hat{H}_B + \hat{H}_I$ within a number conserving framework of Bogoliubov model [21]. After several steps [20], we

arrived at an approxim ated Ham iltonian :

Here E₀ = gnN =2 gn=2 + n is a constant term , $_k = \tilde{R}^2 k^2 = 2M$ is the free kinetic energy of bosons, and $\gamma_k (t) = d^3x_c (x;t)e^{ik x}$. In this approximation we neglected term s of order of N⁻¹.

Bogoliubov's excitation is created and annihilated by the operators

In terms of Bogoliubov's excitation, the total H am iltonian is expressed as

Here $E_0^0 = E_0 + \frac{X_0}{(\sim !_k \ k} \ gn)=2$ is the ground state energy without in purities (a prime indicates the om ission of the zero mode from the sum mation), and $f_k(t) = n_k(t) \frac{Z}{k} = (N \sim !_k)$. Therefore, the storder in purity e ects are equivalent to decoupled forced harmonic oscillators, which can be solved analytically. Since we are solving the time dependent problem, it is natural to work in the Heisenberg picture. The equations of motions for B ogoliubov's excitation creation and annihilation operators are easily solved as follow s.

where the integral I_k (t) is de ned by

We have chosen the boundary condition such that the system is disturbed by in purity at $t = t_0$.

Now the our system is described by in terms of the dressed Bogoliubov excitation creation and annihilation operators \hat{B}_k^y and \hat{B}_k . They evolve according to the diagonalized H am iltonian \hat{H}^0 :

In the diagonalized H am iltonian, the new ground state energy is de ned by $E_0(t) = E_0^0 + Re(f_k(t)_k(t))$. The energy spectrum ~!_k is that of the gapless excitations <u>characterized</u> by !_k ' kc_s for a small k, where $c_s = gn=M$ is the speed of sound. We remark that the spectrum !_k and the speed of sound c are the same as in the original B ogoliubov m odel w ithout in purities. Hence, the motion of in purities does not a ect either !_k nor c in our model w ithin the above approximation.

B. Hom ogeneous condensate

The hom ogeneous BEC is de ned by the ground state of the H am iltonian (7) without the impurity term. In otherword the vacuum state of the annihilation operators \hat{b}_k . We denote it as peci, and this is to be de ned by

Therefore, we conclude that the dressed Bogoliubov excitation annihilation operator due to impurity does not see the condensate as vacuum :

A lternatively, one can interpret this result as follows. A classical eld describe by $_{\rm k}$ (t) is induced in the hom ogeneous condensate due to the motion of impurity.

C . Energy dissipation due to the motion of im purity

As we have mentioned in Introduction, we are interested in the amount of dissipated energy in condensates due to them otion of impurity. Physically, energy dissipations take place via scattering processes between bosons and impurity. In other words the impurity motion creates excitations in condensates by scattering processes. Excitations in BECs will carry amount of energy equal to their excitation spectra. The amount of dissipated energy is then measured by heat transferred to condensates.

We rst de ne the occupation num ber for the dressed B ogoliubov's excitation with respect to the hom ogeneous condensate. This num ber counts the em itted B ogoliubov's excitations accompanying with the motion of im purity in BEC,

Multiplying by the excitation energy ~!_k gives the dissipated energy E_k (t) for a given m ode k, and the total dissipated energy E (t) is given by sum m ing over all m odes. In our m odel we assume that an impurity is driven by some external forces, in which back reaction is negligible. Therefore, this dissipated energy is equivalent to the amount of energy transferred to the condensate from the external in purity. In the therm odynam ic lim it, the

total energy dissipation due to impurity is evaluated by rather simple form ula :

D. Depletion of the condensate

The depletion of the condensate d(t) due to the quantum uctuation is de ned by the form ula :

U sing the Bogoliubov transformation and the solution obtained before,

Since j_k (t) j^2 has an additional factor 1=N (see eq. (10)), the motion of in purity does not contribute to the depletion of the hom ogeneous condensate in the therm odynam ic limit. The depletion is then given by d = (8=3) na_s^3 which is independent of the impurity effects. Therefore, in the large N limit, the hom ogeneous condensate is stable against an external in purity. In contrast, how ever, these terms in the depletion of condensates is not negligible in real experiments where the

niteness of the number of particles and nite size e ects play in portant roles.

III. M IT GROUP EXPERIMENTS

W e now apply our model to the experim ental settings done by M II group. We consider a point-like in purity which is oscillating along the z-axis with a period 2 =and the oscillation amplitude d. The trajectory is expressed by $(t) = (0;0;d\cos t)$. A lthough this is still an idealized model, we will see that this model gives qualitative explanation for the real experiments. To make the corresponding to the experiments, we also de ne the velocity of the impurity by v = 2d =. In order to ob tain analytical expressions for the energy transferred to the condensate, we further make an assumption that the impurity is oscillating for a su ciently very long time. This assumption seems reasonable if we look the real experimental values. Under this assumption we let the time integral (11) from 1 to +1. Using the plane wave expansion in terms of the Bessel function $J_{\gamma}(x)$,

Here the wave number vector k is written in the spherical coordinates with an angle from the z-axis. Therefore, in the idealized in nite limit, the integral in consideration will take discrete values labeled by the integer `. In this limit an additional care has to be take to evaluate the dissipated energy since we cannot take the square of the D irac delta distributions. To this end we rst evaluate the nite time interval T, then we take the limit T ! 1 in the last step. A fler straightforward but tedious computations, we nd the total dissipated energy per unit time is

The above integrals can be evaluated in term s of the general hypergeom etric function :

where $(a)_n = (a + n) = (a)$ with (x) the Gamma function. The nalexpression for energy dissipation is



Here = ~=(2M c_s) is the healing length of the condensate, and $_0$ is a constant with dimension of energy per unit time; $_0 = 4n \ ^2M \ ^2c_s = (\ ^3)$. The wave number takes the discrete values as a consequence of the D irac delta distribution as

We plot the dissipated energy per unit time as a function of the velocity of in purity v = 2d = . The velocity is in units of the speed of sound c_s , and the energy per unit time is scaled by its value for $v = c_s$. Several curves correspond to various values of the oscillation amplitude d in units of ; d = = 1;10;100, and 1000. Except for the case d = = 1, all curves merge to the same curve. This universal behavior shows that critical velocities are the

characteristics of the motion of impurity itself and are independent of the parameters involved. This statement seems true in general in the bulk lim it of condensates.

We estimate the value for critical velocity v_c by thing the curve with the expression $/v(v\ y)$ for small values of v. This is based on the standard argument that the condensates will experience the drag force from the impurity, which is proportional to $v\ v_c$. The inner product of this force and the velocity of impurity then gives the rate of dissipated energy in the condensates. The estimated value of the critical velocity for the case d= = 100 is found as $v_c=0.34\,c_s$.

IV. ENERGY DISSIPATION FROM A CIRCULAR MOTION

As an another example for periodic motions, we consider a circular motion on the xy-plane, which was studied in details in [20]. The trajectory is specified by two parameters, the radius R and the angular velocity ;

 $(t) = (R \cos t; R \sin t; 0)$: Following the same calculation m ethods carried out for the previous section, the form ula for the dissipated energy per unit time from the

circular motion is

where $_0 = n^{2}M = (2 \sim^{2}R)$, and the discrete wave number k, is given by eq. (25). Note that in the circular motion case, the velocity of the impurity is given by v = R instead.




FIG. 2: The dissipated energy per unit time for the circular motion as a function of the velocity v. The same convention for the units of energy per unit time and the velocity is used as in FIG.1.

W e plot the the dissipated energy per unit time in FIG.2 in the samemanner as FIG.1. The critical velocity for the circularm otion is estimated from the graph as $v_c = 0.43 c_s$. This value is slightly bigger than the case of the dipole oscillation.




FIG.3: The dissipated energy per unit time for two examples for the amplitude d= = 100 and the rotation radius R = = 100. The energy per unit time is in units of $_0 = n^{-2} = (2 \sim ^{-3})$.

For a comparison, we also plot two cases in FIG.3 for the value d= = 100 and R = = 100. The units of the dissipated energy per unit time in FIG.3 is $_0 = n^{-2} = (2 - 3)$. Two curves show the similarity between two cases. Although we cannot make one to one corresponding for the velocities of two cases, the circular motion has more energy dissipation in general.

V. CONCLUSIONS AND OUTLOOK

W e have shown that nite energy dissipation from the periodic motions of impurity can take place even below

the Landau critical velocity in the hom ogeneous BEC. We have found the critical velocities v_c for the dipolelike oscillation and the circular motion as 0:34; c_s and 0:43 c_s respectively. Our result qualitatively agrees with the experimental observations of Ref. [7{9]. The dierences arise from the fact that there are many other factors as pointed out in previous studies [10{12], as well as several simplications in our model and calculations. It is, therefore, necessary to extend to our model to the case for BECs with trapping potentials at nite temperature to see whether our model yields better agreem ent or not.

The result present suggest that the landau criterion be reexam ined even in the absence of quantized vortices for the hom ogeneous system . A sim ple physical argum ent is that the original Landau's argum ent cannot be applied to the case where in purities move under the acceleration. This is because the Galilean invariance fails if there is an acceleration between two coordinates system s. As a related issue, the phenom enon of Cherenkov-like radiation in BECs was studied for an in purity moving with a constant velocity, where the critical velocity for a radiation was found to be exactly same as the Landau critical velocity [16, 19, 20, 25].

In this paper we also evaluate the dissipated energy from the circular motion of impurity. A trajectory of the circular motion in BECs is in principle experimentally realizable in current experimental technics. The studies of impurities under the circular motion in BECs may give us further understanding of the coherent properties of condensates and the phenom enon of super uidities in BECs.
