Spin- op transition in antiferrom agnetic multilayers

A comprehensive theoretical investigation on the eld-driven reorientation transitions in uniaxial multilayers with antiferrom agnetic coupling is presented. It is based on a complete survey of the one-dim ensional solutions for the basic phenom enological (m icrom agnetic) m odel that describes the m agnetic properties of nite stacks m ade from ferrom agnetic layers coupled antiferrom agnetically through spacer layers. The general structure of the phase diagram s is analysed. At a high ratio of uniaxial anisotropy to antiferrom agnetic interlayer exchange, only a succession of collinear m agnetic states is possible. With increasing eld rst-order (m etam agnetic) transitions occur from the antiferrom agnetic ground-state to a set of degenerate ferrin agnetic states and to the saturated ferrom agnetic state. At low anisotropies, a rst-order transition from the antiferrom agnetic groundstate to an inhom ogeneous spin- op state occurs. Between these two regions, transitional magnetic phases occupy the range of interm ediate anisotropies. Detailed and quantitative phase diagram s are given for the basic model of antiferrom agnetic multilayer system s with N = 2 to 16 layers. The connection of the phase diagram s with the spin-reorientation transitions in bulk antiferrom agnets is discussed. The lim its of low an isotropy and large num bers of layers are analysed by two di erent representations of the magnetic energy, namely, in terms of nite chains of staggered vectors and in a general continuum form. It is shown that the phenom ena widely described as \surface spin-op" are driven only by the cut exchange interactions and the non-compensated magnetic moment at the surface layers of a stacked antiferrom agnetic system .

I. IN TRODUCTION

Since the discovery of antiferrom agnetic interlayer exchange¹ and the giant-m agnetoresistance² in m agnetic superlattices, such structures have become important com ponents in m agneto-electronic devices. Research on these coupled multilayer systems is mainly driven by applications in magnetic storage technologies and the em erging spintronics.³ Speci c structures with antiferrom agnetic coupling are now considered as prom ising storage media.⁴ It is clear, that applications necessitate a thorough control and understanding of their magnetic properties. On the other hand, such synthethic antiferrom agnetic structures are ideal experim ental m odels for studies of magnetic states and magnetization processes of antiferrom agnets in con ning geom etries.5,6,7,8 Two ferrom agnetic layers coupled antiferrom agnetically through a spacer, as the sim plest of these system s, show properties which are form ally described by the sam e phenom enological theory as a two-sublattice bulk antiferromagnet. However, the magnetic states, domain structures, and magnetization processes even of such twolayer system s display a bew ildering variability and are far from understood in detail.9 M odern experim entalm ethods now allow imaging of magnetic states and domains in multilayer systems with resolution into the depths of multilayer stacks.^{10,11} Therefore, detailed studies of such structures have becom e feasible.

Theoretical models to describe the magnetic states of nite antiferrom agnetic superlattices have revealed various surface e ects, rich phase diagram s, and com plex magnetization processes. For antiferrom agnetic lay-

ers, there are many other e ects. Surface-induced interactions, exchange couplings of antiferrom agnets to other magnetic systems, in particular exchange bias in antiferrom agnetic-ferrom agnetic bilayer system s¹² add to the multitude of possible magnetic states in antiferrom agnetic layers.¹³ However, the di culty to probe and im age m agnetic structures in antiferrom agnetic m aterials in pedes the progress of our understanding on the antiferrom agnetic side in such layered systems. Hence, the nite antiferrom agnetic superlattices are a suitably sim ple system which may promote a better understanding of surface related e ects in antiferrom agnetic layered system s generally. It is important to stress here, that surface e ects in antiferrom agnets have a di erent nature than in a ferrom agnetic system . The cut exchange bonds at a (partially) uncompensated surface of an antiferrom agnet causes a particular disbalance of m agnetic forces which can never be understood as a sm all surface e ect. In contrast, surface-e ects in ferrom agnets are related to spin-orbit e ects which usually are weak in comparison to the exchange.

A stack ofm agnetic layers with antiferrom agnetic couplings provides the basic m odel for cut exchange bonds at a fully uncom pensated surface. The study of the m agnetic states and transitions for such systems in external elds has a long history. In 1968 M ills proposed that, at the surface of a uniaxial antiferrom agnet, a rstorder transition should occur in elds below the common \bulk" spin- op (SF). This transition from the antiferrom agnetic to a \surface spin- op" state should result in opping a few layers of spins near the surface, i.e. they would turn by nearly 90 degree.¹⁴ Further theoretical in-




FIG.1: (Color online) Sketch of an antiferrom agnetically coupled multilayer corresponding one-dimensional spin chain. The "exchange springs" are cut at the ends of the nite chain.

vestigations have improved the m athem atical analysis of this reorientation e $ect^{15,16,17,18,19}$ how ever, direct experim ental observations at surfaces of crystalline antiferrom agnetic m aterials failed, e.g., for the classical uniaxial antiferrom agnet M nF₂, (see bibliography and discussion in [20]).

As was mentioned above the basic model for two antiferrom agnetically coupled layers is equivalent to the classical mean-eld description of two-sublattice bulk antiferrom agnets.^{21,22} These systems com pose two large groups: antiferrom agnets with weak anisotropy²² and strongly an isotropic uniaxial crystals that are comm only called m etam agnets.²¹ The m etam agnetic phase transition between the antiferrom agnetic and ferrom agnetic phases has been observed and investigated in many antiferrom agnetic bulk system s.²¹ Easy-axis antiferrom agnets with weak anisotropy also compose a large group of magnetically ordered crystals. For bulk antiferromagnets, the spin- op transition has been predicted by $N \in \mathbb{C}^{2^3}$ and later was observed experimentally in CuC b 2H 20.24 In the next fly years, spin op transitions have been discovered and carefully studied in m any classes of antiferrom agnets (see bibliography in Refs. [22,25,26]).

The interest in spin-ops revived with the synthesis of magnetic multilayer stacks with indirect antiferrom agnetic exchange coupling through spacers.⁵ T hese arti cial antiferrom agnetic layers, with few magnetic units as macroscopic spins instead of atomic spins (Fig. 1) o er the possibility to study eld-driven reorientation transitions with unusually low exchange compared to anisotropies.⁶ Experimental investigations in Fe/Cr(211) antiferrom agnetic superlattices⁵ seem ed to con m the scenario of the surface spin-op transition introduced in Refs. [14,15]. The observation was supported by num erical investigation of an elementary m icrom agnetic model.^{5,20} But, investigations on the magnetism of such antiferrom agnetic superlattices and thin m s did not produce a consistent understanding of the

occurrence and nature of \spin- op" transitions or other reorientation transitions in layered antiferrom agnetic structures. Recent experiments dem onstrate complex behaviour and di erent scenarios for the evolution of the states.^{10,11,12,27,28,29,30,31,32,33,34,35,36,37,38,39} m agnetic The problem of the magnetic states in antiferromagnetic superlattices with uniaxial anisotropy is strongly related to the long standing problem of a \surface spin-op" discussed in various papers: 5,6,16,17,18,19,20,40,41,42,43,44,45,46,47,48,49,50,51 Theoretical investigations are mostly based on numerical calculations within a certain model, here called Mills model.40,41,44,45,46,47 Further theoretical works related these nite or sem i-in nite antiferrom agnetic chain m odels to system s like the Frenkel-Kontorova model.43,52 These studies have led to controversial results and generated a long-drawn discussion about the physical nature of the reorientation transform ations in the antiferrom agnetic superlattices.^{13,40,43,44,45,53} Only few attempts have been made to gain a complete understanding of the ground-state structure of the basic one-dimensional models for these superlattices. 43,47,53 Thus, the basic questions, whether, when, and how a surface spin-op occurs, were unresolved.

A full set of solutions for the model under discussion was recently obtained by us.⁵³ These outwardly simple system swith few degrees of freedom own rich phase diagram s because of the competition between internal sti – ness and anisotropy in conjunctions with restricted dimensionality. Present paper presents an extended account and an analysis of the solutions from Refs. [53,54]. We explain the physical mechanism responsible for the formation of the main magnetic states in antiferrom agnetic superlattices. We derive a clear and simple picture of the phenom ena which have been discussed as \surface spin-op". We demonstrate the connections with bulk antiferrom agnetic system s and other classes of magnetic nanostructures.^{55,56}

The structure of the paper is as follows: The phenom enological model and its variants are introduced in Sec. II. The analysis of possible magnetic states in the system starts from two limiting cases of low and high uniaxial an isotropy. The full solution for the generic highly symmetric Mills model in applied elds along the easy axis are presented in Sec. III and the general structure of the phase diagram s are presented. In this section, mainly analytical and num erical examples are employed to explain these solutions. Generalizations are brie y indicated. Them ethods can be extended to solve any other m ore general m odel for an antiferrom agnetic multilayer system. In Sec. IV we exploit the fact that the models for low -anisotropy antiferrom agnetic superlattices can be reduced to equivalent models for a chain of exchange coupled two-sublattice antiferrom agnets. This dim erization transform ation reveals the physical mechanisms ruling the magnetic states and reorientation transitions. Num erical results for the evolution of inhom ogeneous spinop phases, magnetization curves, and phase diagrams

are presented along with this discussion. In particular the lim it of large num bers of layers and the em ergence of the bulk spin-op for such nite systems are discussed. Then, the continuum representation of the generalm odels is presented. This o ers a di erent point of view for the weak anisotropy. This continuum approximation is applicable to any weakly anisotropic system. It allows to derive the structure of the inhom ogeneous spin-op phase for arbitrary m odels, in particular m odel where the m agnetic m om ents at the surfaces are partially com pensated. Hence, the succession of eld-driven phase transitions between the antiferrom agnetic state tow ards the saturated ferrom agnetic state via this spin- op phase can be completely analysed. In Sec.VA the general picture of magnetic states in antiferrom agnetic nanostructures and som e recent experim ental results are discussed in the context of the new results.

II. MODEL

A. The m icrom agnetic energy. M ills m odel

Let us consider a stack of N ferrom agnetic plates in nite in x-and y-directions and with nite thickness along the z-axis. The magnetization of each plate is m_i, and they are antiferrom agnetically coupled through spacers. Replacing this system by a chain of single-dom ain particles with spontaneous magnetization m₀⁽ⁱ⁾ = jm_i; we may describe the magnetic con guration by the variables $s_i = m_i = m_0^{(i)}$, i.e., by the set of unity vectors along the magnetization of the ith layer. We assume that the ferrom agnetic layers have a uniaxial magnetic anisotropy with a common easy axis. The phenom enological energy of this system can be written as

Here, $i = m_0^{(i)} = m_0$ designate deviations of the magnetization in the i-th layer from the average value m_0 . J_i and J_i are constants of bilinear and biquadratic exchange interactions, respectively. The unity vector n points along the uniaxial anisotropy direction; K_i and K_i⁰ are constants of the in-plane and inter-plane uniaxial anisotropy. Finally, e_a (m_i) collects higher-order uniaxial and in-plane m agnetic anisotropy contributions, e.g., intrinsic cubic (m agnetocrystalline) anisotropy in systems like Fe and N i layers.

The functional (1) generalizes similar models considered earlier in a number of studies on magnetic states in antiferrom agnetic multilayers with uniaxial anisotropy^{5,20,40,41,42,43,45,46,47,48,49} In a recent paper on antiferrom agnetic superlattice with higher (tetragonal)

sym m etry, R ef. [55], we have discussed the generalm odel and the justi cation of the approach used for this class of system s. Therefore, the reader is referred to^{55} for a detailed discussion and further references. Eq. (1) com prises the magnetic energies due to the main physical mechanisms, which are present in magnetic multilayers with indirect exchange through spacer layers (see Fig. 1). The ferrom agnetic layers can be considered as hom ogeneously magnetized blocks with constant values of the m agnetic interactions. This assumption relies on the fact that in ferrom agnetic nanolayers the intrinsic (direct) exchange coupling are usually very strong. Thus, they play the dom inating role for the magnetic order within the layers which react also very stiy on all external and induced magnetic forces. Thus, the internal magnetic structure of an individual layer experiences little change under in uence of the induced magnetic forces at the surfaces and interfaces, and the reorientation of other layers in the stack. This hypothesis has been justiled by successful applications of such m odels to describe m agnetization processes in layered ferro-and antiferrom agnetic nanostructures in di erent classes.^{5,11,13,28,57,58,59,60}

A ntiferrom agneticm ultilayers with uniaxialanisotropy and in applied eld along the axis n show the strongest reorientation e ects. Here, we address the overall magnetic properties of such uniaxial systems. Their behaviourm ay be analysed by considering only term swith bilinear exchange J, uniaxial intralayer anisotropy K and an external eld H. The form of the energy in Eq. (1) considers additional terms, which are known to play a role in antiferrom agnetically coupled multilayers. In particular, strong biquadratic exchange has been revealed in a number of antiferrom agnetically coupled multilayers.^{31,59,61,62} In Ref. [55], we have studied the related phenom enological model for multilayers with zero and with four-fold (tetragonal) anisotropies and we have discussed the relevance of biquadratic exchange $(\hat{F} \in 0)$, which plays essentially only a quantitative role for the competition between the various possible magnetic states as long the antiferrom agnetic ground-state remains collinear.

The uniaxial anisotropies may be intrinsic to the magnetic material of the lm or induced by surface e ects. Thus, the uniaxial anisotropies can be strongly changed with respect to bulk systems, and their strengths can be controlled in lm system within wide margins. Combination with intrinsic and induced fourth-order anisotropy, as considered in e_a in Eq. (1), may lead to peculiarities of magnetic properties, see Refs. [28,55], but here we will disregard these contributions. Finally, strong demagnetization e ects in antiferrom agnetic superlattices with perpendicular anisotropy are responsible for com – plex evolution of multidom ain states and speci c magnetization processes.^{7,8,56,63,64} To investigate these e ects the stray- eld energy must be included in Eq. (1), and the corresponding magnetostatic problem has to be solved.

The magnetic superlattices with antiferrom agnetic coupling can be separated into two classes: non-

compensated system swith a net magnetization and those with fully compensated magnetization. In the former case, the net magnetic moment strongly determines their globalm agnetic properties. In many physical aspect their properties are similar to those of bulk ferrim agnets. The main subject of this paper are the multilayers with fully compensated magnetization, i.e., multilayers with even N and equal magnetization in all layers are similar to bulk collinear antiferrom agnets. For simplicity, we assume $_{\rm i}$ = 1 in all layers i = 1:::N . At the end of the paper we also consider e ects in posed by a partial compensation of the magnetization in the endmost layers, i.e., deviations of $_{\rm 1}$ and $_{\rm N}$ from unity.

For the reorientation e ects in the antiferrom agnetically coupled chain (Fig. 1), the e ect due to the cut exchange bonds at the surface dom inates. The last moments in the chain are coupled only to one neighbour while \internal" moments interact with two. Thus, the m om ents at the surface experience a weakened exchange sti ness and are more susceptible to the reorienting inuence of an applied eld. Due to this cut exchange at the surfaces the boundary m om ents oriented against the external eld turn into the eld direction in lower elds than internal moments. The simplied version of the model (1) with equal constants $J_i = J$, $K_i = K$, and $\mathcal{F}_{i} = K_{i}^{0} = e_{a} = 0$ for an applied eld in direction of the easy axes, H kn, describes the e ect of the cut bonds as the sole surface-im posed factor. It allows to investigate this surface e ect separately from other interactions.

U sually the magnetization of the layers is conned to a certain plane. Form any multilayers, this is the lm plane owing to demagnetization. For this case the deviations of m_i from the anisotropy axis can be described by angles i, and the energy (1) in the equal constant model is reduced to the following form

For J > 0 and K > 0, the Eq. (3) describes antiferrom agnetically coupled ferrom agnetic layers with easy-axis anisotropy in an external eld along the anisotropy axis. Energy (3) has been introduced by M ills for a semi-in nite chain (N = 1).¹⁴ Later this model (called here M ills model) has been intensively studied for nite and in nite N 5,6,15,16,17,18,19,20,40,41,42,43,44,45,46,47,48,49,50,51 and has been used as basic ansatz to analyze experimental results in antiferrom agnetically coupled multilayers.^{5,10,39}

B oth the exchange interactions and uniaxialanisotropy in (3) have surface/interface induced nature, their values are very sensitive to m any physical factors such as the structure of the spacers and substrates.^{60,65} H ence, the m aterials parameters m ay vary from layer to layer in the stack. A generalization of the M ills m odel m ay include di ering param eters for each layer

This is a general model for antiferrom agnetic multilayers. Even for a stack of identical nanolayers, the top and bottom layers stillhave a di errent \neighbourhood" than internal layers. To describe these e ects we may introduce a modi ed M ills model with equal materials parameters for all internal layers $J_i = J$ (i = 2;3;...;N 2), $K_i = K$ (i = 2;3;...;N 1) and di errent values for the rst and last layer ($J_1 = J_N$ $_1 = J_s$, $K_1 = K_N = K_s$, $_1 = _N = _s < 1$)

In all these cases, calculations of the m agnetic states for the antiferrom agnetic superlattices can be reduced to the m inim ization of the energy functions $_N$ (1; 2; :::; N). In this paper, we study in detail solutions for the chains with equal constants as described by M ills model (3), and we discuss the generalizations according to Eqs. (4) and (5).

B. General features of the solutions. Relation to bulk antiferrom agnetism

The antiferrom agnetic multilayers with N = 2 are of particular importance for investigations on surface/interface-induced interactions.^{28,31,32,36} In experim ental works they are often referred as \trilayers", we use here the term \two-layer system s". The energy (3) for N = 2 is the same function as the mean-eld m agnetic energy of a bulk two-sublattice antiferrom agnet

We brie y review the reorientation transitions in these two-layers systems to x our notation and term inology. Following a general convention we introduce the linear combinations of the magnetization vectors $s_{1,2} = M$ L,

the total or net m agnetization M and the staggered m agnetization L, that is also called vector of antiferrom agnetic order²². The equations $j_{ij} = 1$ lead to the constraints M² + L² = 1 and (M L) = 0. In a m agnetic eld along the easy axis the vectors H, s_1 and s_2 lie in a xed plane. The m agnitude of the net m agnetization M = j_M jcan be used as an intermal parameter. A fler an independent m inimization with respect to M, the energy and the net m agnetization depend only on the orientation of the staggered vector L and can be expressed as functions of the angle between anisotropy axis n and L




FIG.2: (Color online) The phase diagram of the solutions for a two-layer system includes antiferrom agnetic (AF), spinop (SF) and ferrom agnetic (F) phases. The AF phase is separated from the SF and F phases by the rst-order transition lines (thick). The second-order \spin- ip" line H_F (dashed) separates SF and and F phases. Thin lines indicate stability lim its of the corresponding phases. Inset: in the spin- op eld H = H_{tr} the potential wells switch from (0,) (AF phase) to (=2, =2) (SF phase).

Then, the phase diagram of the antiferrom agnetic twolayer system is given by the potential energy for a system with one variable (7) with the control of materials param eters K = J; H = J. This phase diagram is plotted in Fig.2. The structure of the phase diagram is determined by the following characteristic elds

For K < J a rst-order transition between the antiferrom agnetic (AF) phase with = 0; and the spin-op phase (SF) with = =2 occurs at the spin-op eld H $_{\rm tr}.$ The elds H $_{\rm A\,F}$, H $_{\rm SF}$ are stability lim its of these two competing phases. The dierence H_{AF} H_{SF} gives the width of the m etastability region. B ecause the antiferrom agnetic state has zero m agnetization the m agnetization jump at the rst-order transition, $M = m_0 M_{SF} (H_{tr}) =$ K) exactly in the eld H_{tr} , equals the $m_0 K = (2J)$ magnetization of the spin-op phase. For increasing anisotropy K this magnetization jump M $_{SF}$ (H $_{SF}$) gradually increases from very sm all values M 1 for K J to the saturation value M = 1 which m arks the end point of the rst-order transition line between the AF and SF phase that is reached at $K = J \cdot A$ continuous transition from the SF phase to the ferrom agnetic (F) phase occurs at H_F. This transition leading to an enforced eldpolarized state is usually referred to as spin- ip transition.

For K > J, the SF phase does not arise as a stable state; instead there is a direct rst-order transition between the AF and F phase at $H_1 = J$. Such transitions in antiferrom agnets are known as metam agnetic transition.²¹ For this high anisotropy region, K > J, the critical eld H_F plays the role of the stability limit for the ferrom agnetic phase (Fig. 2). The metam agnetic transition is characterized by a large jump of the magnetization M (H₁) = m₀ and extrem ely broad metastability regions.

For low-anisotropy systems in the region $K \,$ J, the energy (7) can be simplied

In this lim it the m etastable region is restricted to a close vicinity of the spin-op eld: H_{AF} H_{SF} H_{tr} H₀. This sim pli ed potential energy Eq. (9) reveals the physicalmechanism of the spin-op transition. At zero eld the uniaxial anisotropy stabilizes the antiferrom agnetic phase. The potential wells at = 0; corresponding to the two antiferrom agnetic states are stable. An increasing applied eld, H < H tr, gradually reduces the height of the potential barrier between the antiferrom agnetic states. At the threshold spin-op eld H tr the stable potential wells switch into the con gurations = =2, =2 that correspond to the opped states (Fig. 2).

C ontrary to natural antiferrom agnetic crystals which are described only by marginal parts of the K =J scale with either low anisotropy, K =J 1, or very large anisotropy, K 1, antiferrom agnets com posed of magnetic nanolayers can have arbitrary values of K =J. These articial antiferrom agnets cover the whole phase plane in Fig. 2.




FIG.3: (Coloronline) Sketch of the phase diagram for N = 6introduces the main types of the solutions for M ills m odel Eq. (3) with arbitrary even N (A). Due to the cut exchange bonds the opped states are spatially inhom ogeneous and can exist as symmetric inhomogeneous spin-op phase (SF) for low anisotropy, or as asymmetric canted phases (C) for moderate anisotropies. In strongly anisotropic system s (K J) spin con gurations with ipped spins exist These collinear ferrim agnetic (FM) phases exist at interm ediate elds between the antiferrom agnetic and ferrom agnetic states. The spin con quations in panel (B) show for N = 8 the degeneracy of the inhom ogeneous SF state for N = 8 (a) and (b); for N = 6 the evolution of the inhom ogeneous SF in increasing eld (c) to (e) and the two di erent types of FM states, where FM_1 is degenerate (f), (h) and FM_2 (h) is a collinear version of the inhom ogeneous SF state (c)-(e) in an even-odd system .

In nite multilayers with N > 2 the cutting of the exchange bonds at the surfaces (Fig. 1) causes a strong disbalance of the exchange interactions along the chain. This disbalance is the determ ining factor for the appearance of magnetic states in the system. The detailed analysis of the solutions for M ills model will be given

in the next section. Here, we sum marize the physical mechanism ruling the formation of magnetic con gurations in simple terms. In the antiferrom agnetic con guration the moments at one surface always point against an applied eld. These moments can be reversed more easily than the internal m om ents because of the cut exchange. Depending on the relative strength of the exchange and anisotropy, this speci c instability leads to di erent reoriented con gurations. At very strong uniax-J) the exchange coupling between ial an isotropy (K layers becom es negligible. In this case the reorientation of the magnetization in the endmost layer does not in uence m agnetic states in the other layers. In an increasing eld, a collinear spin con guration with an inverted endmost moment is reached. The corresponding ferrim agnetic (FM) phase becomes energetically stable at a eld H_{FM} = J through a discontinuous rst-order transition (Fig. 3).^{53,56} In the opposite case of weak anisotropy, Κ J, the exchange coupling plays the dom inating role. A coordingly the overturn of the endmost moment is spread over the entire stack and creates a spatially inhomogeneous spin con guration (Fig. 3).^{53,55} In Ref. [53] this mode was called inhom ogeneous spin- op phase. In increasing elds, a curious evolution takes place within this spin- op phase, where som e m om ents rotate against the applied eld and change their sense of rotation at higher elds.55 A continuous spin- ip into the saturated state occurs at an \exchange" eld H_E, which depends on the number of layers and on the anisotropy K . In the region of m oderate an isotropy spatially inhom ogeneous asymmetric states exist as transitional phases between the inhomogeneous SF and FM phases. These asymmetric phases arise by canting transitions, i.e., elastic distortions of the collinear FM phases when $K = J \sim 1$. These asymmetric canted (C) phases can be considered as superpositions of ferrim agnetic states and the inhom ogeneous spin-op state (Fig. 3). This means that in these low sym m etry interm ediate C phases all the sym m etries are broken that are broken in the corresponding SF and FM phases. Thus, magnetic states arising in M ills model. com prise antiferrom agnetic, spin-op, and ferrom agnetic phases, which exist in bulk antiferrom agnets, and additional ferrin agnetic and canted con gurations. The latter phases are imposed by the exchange cut. They are speci c to nite antiferrom agnetic layer system s. In particular, the detailed solutions for larger N show series of di erent canted phases. The corresponding phase diagram s include a large num ber of critical points and a tangled net of transition and lability lines (see examples in [47,53,54]). The cut exchange bonds underly this com plexity as the general physical mechanism for the form ation of the various inhom ogeneous magnetic states and their transitions into the simple collinear states in the limiting regions of the phase diagram for and low high anisotropy and for large elds. Therefore, all these phase diagram shave a general topology represented in Fig. 3.

III. PHASE DIAGRAM OF THE SOLUTIONS

In this section we analyse the solutions for M ills m odel (3), derive the regions of their existence, and conditions of the transitions between di erent phases.

A. Spin- op transition and solutions for inhom ogeneous spin- op phases

The expansion of energy (1) with respect to the small parameters $_{2j 1}$ allows to derive analytical solutions for




FIG. 4: (Color online) Evolution of the equilibrium magnetic con gurations $_{\rm i}$ in M ills model for antiferrom agnetic N = 6 layers with nite uniaxial anisotropy, K = 0.01 J (a), K = 0.5 J (b), in magnetic elds applied in direction of the easy axis. For the low anisotropy case only AF, SF, and F states exist (a). The points indicate the spin-op eld H tr and the spin ip eld H $_{\rm F}$. Characteristic elds are H $_{\rm R}$, H $_2$, and H as marked in the plot. The spin con gurations correspond to H = H $_2$ = 1.104 J where the magnetization in the 2th and 5th layer is perpendicular to the applied eld. For intermediate anisotropy (b) canted asymmetric states exist in the eld interval H $_{\rm C1}$ < H < H $_{\rm C2}$. The spin con guration eld H $_{\rm C1}$ = 0.906 J.

the opped states that can be form ulated for arbitrary m odels. As an illustration we write the parameters $_{2j 1}$ for M ills m odel (3), i.e., with equal constants in the even-even case N = 8

The Eqs. (10), (11), and (12) display the generic structure of these solutions which apply also for generalized models with arbitrary parameters. The deviations of the magnetization direction from the directions =2 are small of the order H = J. The corrections due to the anisotropy are of the order (HK)= J^2 . The deviations of the magnetization direction in the di erent layers gradually increase towards the endmost layers i = 1 or i = N, respectively. The dom inating exchange interactions favour antiparallel ordering in the adjacent layers. In the opped con gurations (11), (12) pairs of spins essentially rem ain antiparallel. E.g., for N = 8, the interior pairs s_2 , s_3 and s_6 , s_7 are alm ost antiparallel (Fig. 3 B, panel (a)). This fact may be stated more precisely. A ccording to (11) $j_3 _2 j = j_7 _6 j =$ $(3H K) = J^2$, this m eans the slight deviations from antiparallel arrangement are due to a second order e ect. The exchange coupling in such pairs is stronger than the Zeem an energy of the pair. This causes an interesting e ect, a reverse rotation of the magnetization in a number of layers. In the multilayer with N = 8, the magnetizations s_2 , s_7 undergo such a reverse rotation according to Eqs. (11); for the case N = 10 the corresponding magnetizations are s_2 , s_4 , s_7 , and s_9 , see Eqs. (12).

For even-odd system s, the projections of the m agnetization vectors for the central layers (s_N $_{\rm 22}$, s_N $_{\rm 22+1}$) onto the eld direction are of the order H = J, which is much larger than the corresponding projections of the order (HK)= J^2 in even-even systems (compare solutions for $_{4}$; $_{5}$ in Eqs. (11), $_{5}$; $_{6}$ (12) and spin con gurations in panels (a) and (c) Inset B of Fig. 3, respectively). The solutions i (H) for M ills m odel of a multilayer with N = 6 in Fig. 4 illustrate the general features of the eld induced evolution of the spin- op state. (See also the con gurations in panels (c)-(e) in Inset B of Fig. 3, and the solutions for N = 16 in Ref. [53] and N = 12 in Ref. [54]). An increasing magnetic eld gradually slows down the reverse rotation of the spins with negative projections onto the eld direction. Finally at characteristic elds H $_{\rm R}^{\rm \ (i)}$ the sense of rotation changes. In this point $d_{i}=dH = 0$. A nother set of characteristic elds $H_{2}^{(i)}$ denes the points where the projection of si changes the sign, i.e., $(s_i (H_2^{(i)}))$ H) = 0. In an increasing eld these characteristic elds, H $_{\rm R}^{\rm (i)}$ and then H $_{\rm 2}^{\rm (i)}$, are reached rst for the central layers and at higher elds for those closer to the boundaries. Fig. 4 (a) displays angles $_{i}$ for an example of M ills m odel Eq. (3). with low K 6 0. Finally, for M ills m odel at a particular eld H? the projection

of the magnetization onto the eld direction is equal for all interior layers. This knot point is designated by ?". The value of H[?] is analytically given by

In particular, for K = 0 the knot point is $H^2 = {}^p\overline{}_{6}H_F = 4$, which coincides with the value derived in Ref. [55]. For $H > H^2$ the positive projections of the magnetization onto the direction of the magnetic eld decreases towards the center. The inhom ogeneous spin- op states for isotropic M ills models, K = 0, exist starting from zero eld and have similar features as those for nite anisotropy.⁵⁵

B. Critical lines and multicritical points




FIG.5: (Color online) Phase diagram for M ills model with N = 6 (a). Detail of phase diagram for M ills model with N = 6 (b). Special canted states C_X (sketched con guration) are stable in the hatched area. The point y is a triple point, where FM, SF, and C_X phase coexist. Triangles designate tricritical points, where the SF- C_X transitions change from continuous to rst-order with increasing anisotropy.

In this section we determ ine stability regions of the solutions, conditions of the phase transitions between them and construct the phase diagram s. M ills m odel (3) has three independent control parameters K = J, H = J, and N. Correspondingly a set of (K = J; H = J) phase planes for di erent N provides complete information about the solutions for the m odel (3). As illustration we present the (K = J; H = J) phase diagram for M ills m odel with N = 6 (Fig. 5), which containts all essential features of the generic phase diagram and some complications (Fig. 5(b)), which are absent in the simplest case N = 4 as presented in Ref. [53]. The essential critical points for M illsm odels with N = 4:::16 are given in Table I. Then we proceed to discuss general features of the m odel with arbitrary N.

To determ ine the conditions for the phase transitions between di erent spin con gurations and the stability regions of these phases we may use standard procedures. The equality of the equilibrium energies of the competing phases yields the condition of the rst-order transitions. The stability of the solutions f $_{ig_{i=1},...,N}$ can be checked by writing the energy of the system for sm all arbitrary distortions, $\tilde{}_{i} = _{i} + _{i}$, which yields the expansion

The solutions $_{i}$ are stable, if all eigenvalue of the sym - m etric m atrix $A_{N} = ((A_{ij}))$ are positive. In particular, for the AF phase within M ills model the m atrix A_{N} has a band structure given by $A_{2j \ 1;2j \ 1} = J + K + H$, $A_{2j;2j} = J + K + H$ for j = 1:::N = 2, and $A_{i;i+1} = A_{i+1;i} = J$ for j = 1:::N = 1. All other elements are

The obvious convention D₀ = 1 and D_k = 0 for k < 0 starts the recursion in Eq. (16). Any determ inant D_N includes the determ inant D₂ for a two-layer system D₂ as a multiplier. Thus, within the M illsmodel (3) the lability eld of the AF phase has the same value for arbitrary values of N^{15,43,48,49}. If coincides with that for a bulk antiferrom agnet H_{AF} = $\frac{1}{K} \frac{(2J + K)}{(2J + K)}$ (8).

Note that this simple result for the stability limit of the AF phase holds only for M ills model because of its high symmetry. For general models (see Eq. (17)), $H_{\rm AF}$ is an involved combination of the materials parameters and depends on N . For example, for the modil ed M ills model one derives




FIG. 6: (Color online) Low anisotropy region of the phase diagram for M ills model with N = 6. The magnetic eld is given relative to the stability lim it of the AF phase by H = Η $H_{\,A\,F}$ (K). The canted phase C $_1$ is stable in the darker (blue) area. It is metastable in the brighter (turquoise) areas. Thick black lines give the rst-order spin- op transition from AF to SF and AF to C, respectively. For an isotropies below point only a rst-order spin-op from AF to the symmetric SF-phase exists. At higher anisotropies above the point b, the rst-order transition is from SF to the asymmetric canted C-phase. For K < K < K b, the canted phase exists only as a m etastable state. For $K > K_c$ above the tricritical point c_r the transition from the asymmetric phase C $_{\rm 1}$ to the spin- op phase is rst-order. Line a- -b is the lower stability lim it of the AF-phase, along the line -b-c the continuous transition between C and SF takes place. Lines starting at point are the m etastability \lim its of the canted phase C .

In Fig. 6 the low -anisotropy region is shown by H { K -phase diagram s for N = 6 as representative for the general behaviour. Here, magnetic elds are given relative to H_{AF} , i.e. H H H_{AF} . The stability limit for the antiferrom agnetic phase is always above the lower stability limits of the symmetric and inhom ogeneous SF -phase.

C om paring the equilibrium energies in the AF and SF phase we determ ine the eld for the rst-order transition between these two phases (Fig. 6). In the low-anisotropy limit this rst-order transition line and the two lability elds for the stability limits of the AF and SF phase, respectively, are close to the value H₀ = $\frac{1}{2}$ JH from Eq. (9). The difference between them defining the co-existence region for metastable states is of order H₀ (K = J) H₀.

Near the spin- ip transition from the SF to the F phase, the deviations of s_i from the eld directions are small ($_i$ 1), and form $delEq_i$ (4) the stability matrix in Eq. (15) becomes $_N(\tilde{}_i) = \prod_{i,j=1}^N A_{ij \ i \ j}$ with A_{ij} having a tridiagonal band matrix form where nonzero elements occur only in the main diagonal and the rst side diagonals. In particular, forM illsm $delA_{ii} = H + K = J$, $A_{ij,i \ 1} = A_{i \ 1,i} = J$, and the spin- ip or exchange eld




FIG.7: Hysteresis for M ills model N = 6 and an anisotropy value, where a canting instability of the spin- op phase occurs in the m etastability region K < K < K_b. A resulting m agnetic con guration of the canted C₁-state is show n. Field H_{tr} for the rst-order transition between antiferrom agnetic and spin- op-phase, and upper stability lim it H_{AF} of the antiferrom agnetic phase are indicated.




FIG.8: (Color online) Equilibrium solutions for M ills model with N = 16 and interm ediate anisotropy K = J = 0.5. In increasing eld a series of transition lead from antiferrom agnetic to ferrom agnetic phase via several canted (C_i) and (reentrant) spin- op states. Left panel: m agnetization of the equilibrium states (rst-order transitions are m arked by arrows). R ight panel: spin-con gurations in the canted in spin- op states.

intersects line H_{FM} = 2J. The line H_{FM} is the transition line between the ferror agnetic and ferrin agnetic phases. The value K_f can be derived analytically as solutions of the equation D_N (A_{ij}) = 0 with A_{ii} = K_f J, A_{i;i1} = A_{i1;i} = J (Table I); H_E^(N) (0) = 2J + K_f is the spin-ip eld for zero anisotropy (in point g, Fig. 5). In Ref. [55] the spin-ip elds have been calculated for generalized isotropic m odels including biquadratic exchange.

For systems with larger anisotropies, an asymmetric

canted phase C1 occurs rst as a metastable state for $K < K < K_{b}$, which can be reached by a continuous canting of the spin- op phase. A corresponding hysteresis around the st-order transition between AF and SF-phase is shown in Fig. (7) with an example of the m agnetic con guration C_1 . This canted phase C_1 is derived from elastically distorting the collinear ferrin agnetic state FM₁ with a ferrom agnetically aligned pair at the surface. For even larger an isotropy $K_{b} < K$, the C_1 state becomes a stable phase of the system, which is reached from the AF-state through a rst-order transition. In the H vs. K -phase diagrams, the magnetic elds for the upper and low er stability lim it of the canted phase C₁ meet at the critical point at (K , H) This point also delim its the line for the canting instability of the metastable SF-state. The critical line for the canting instability of the stable SF-state ends in the criticalpoint (K b, H b) on the line of rst-order transitions H_{tr} between either the AF-phase and the SF-phase below K_{b} , or the AF-phase and the C_1 -phase above K_{b} . This point b located at (K $_{\rm b}$, H $_{\rm b}$) designates the lower anisotropy $\lim\, \mathrm{i} t$, where the phase C $_1$ and any asym m etric canted phase is stable for M ills m odels. The topology of the phase diagram s in Fig. 6 for the corner of low anisotropy K < K and elds describes the general behaviour for arbitrary N. From our previous analysis, we have seen that no canted asym m etric phase m ay occur at low anisotropies. The rst canting instability at higher anisotropy will occur into a phase similar to the C1 phase with a opped con guration at the surface. For Mills models with various N we have num erically determ ined the low -anisotropy parts of the phase diagram s and veried this general topology. Coordinates of the two critical points and b for the canting instabilities are collected in Table I. from num erical investigations of M ills m odels with N = 4;6;::;16.

M agnetization curves corresponding to the equilibrium states, where the canted state C_1 is a stable phase are shown in Fig. 7. For anisotropy $K > K_b$ further transitions and critical points occur depending on N . E g., the transition between the C_1 -phase and the spin- op for N = 6 becomes rst-order above a tricritical point c.

C. M etam agnetism of strongly an isotropic system s

At high enough uniaxial anisotropy only collinear phases are stable. For the in nite anisotropy limit, one can describe the model as an antiferrom agnetic chain of classical Ising-spins. In this limit, all collinear states coexist and transitions between them are rst-order. The equilibrium states and their transitions are found from the comparison of their di erent Zeem an and exchange energy. In M ills model (3) only two rst order transitions take place. For increasing elds these are a transition from the antiferrom agnetic (AF) state to a set of degenerate ferrin agnetic (FM) phases at H = J, and the transitions from these FM -phase into the saturated phase

(F) at H = 2J.

Due to the high symmetry of Mills model, it displays a remarkable degeneracy of the FM phase. This degeneracy has important consequences for the structure of the phase diagram at nite anisotropy. Let us denote a ferrom agnetic pair with con guration "". The two di erent antiferrom agnetic dom ains are (AF1)= "# and with reversed spins (AF2)= #". The ferrin agnetic conguration with a ipped spin at the edge can be written $(AF1)^{N=2}$ (F), where exponents denote the number of repetitions for a pair. It is easy to see that all congurations of type FM $_{n} = (AF1)^{N=2 n 1}$ (F) $(AF2)^{n}$ with n = 1;:::;N =2 have the same energy for M ills m odel (Fig. 3 (b) panel (f)-(h)). There are no further ferrimagnetic equilibrium phases for this model. For generalized m odels with di ering m agnetic properties of individual layers the degeneracy of the FM phases will be lifted. Then, the two transitions for M ills model in the lim it of in nite an isotropy will be replaced by sequences ofm etam agnetic transitions between various asymmetric collinear states. The exact sequence will be subject to the set of m aterials param eters for the individual layers.

Towards nite anisotropy, the collinear phases will undergo characteristic instabilities were the competition of Zeem an energy, exchange and anisotropy will cause elastic distortions of these con gurations. The stability lim its for these collinear phases can be calculated from the analytic expressions for zero eigenvalues of their stability matrices A in Eq. (15). These analytic expressions are derived sim ilarly to the expressions for the upper stability $\lim it H_{AF}$ of the AF phase, Eqs. (8), (16), and for the lower stability limit or exchange eld $H_{E}^{(N)}$ of the F phase, Eq. (17). In principle, they can be evaluated with arbitrary precision. But, the stability lim its of the dierent FM phases depend not only on N but also on the particular realization FM 1, i.e., on the location of the F-pair in the chain. For the ferrin agnetic phase of M ills $m \text{ odel w ith } N = 4 \text{ there is only one lability line } H_{FM}$ (K). It can be written in the parametric form




FIG. 9: (Color online) High-anisotropy phase diagram for M ills model and N = 16. The degenerate ferrim agnetic phases are stable in the shaded area. The collinear phases FM $_1$ and FM $_2$ to FM $_4$ are limited by the lability lines (1) and (2-4). The latter are nearly degenerate and not resolved.

This can be understood from the weakened exchange sti ness at the surfaces, i.e. the surface cut, which distinguishes the state FM 1 with an F-pair at the surface from all other realizations F_1 with 1 > 1 (see Fig. 5(b) for the sim plest case N = 6). The generic behaviour of these lines is demonstrated for the case N = 16 in Fig. 9. The lower branch for FM₁ occurs always at higher elds and anisotropies. This is the expected consequence of the surface cut. The FM 1 structure is more easily distorted and plays a special role in the interm ediate an isotropy range. In all phase diagram s, at a certain section of this line a continuous transition between the FM₁ phase and the corresponding C_1 -phase occurs (see Fig. 5(b)). This transition line at low elds and high an isotropies, starts at the critical end-point (K e, H e) on the rst-order line between the AF and FM -phase. In the phase diagram s for N = 6, this section ends at a multicritical point x. For general ${\tt N}$, the other end of the line of continuous transitions between the FM $_1$ and the C $_1$ phase depends on N because at higher elds other canted phases C₁ with 1> 1 m ay intervene. Thus, the series of co-existing collinear states FM 1 at high an isotropy gives rise to series of corresponding canted phases C1 by elastic distortions. These canted phases, how ever, are stable in different regions of the phase diagram tow ards interm ediate anisotropies. Thus, the series of canted phases in increasing elds starts with C $_1$ and, for the highly symmetric M ills m odel, it follows the sequence l = 1; ... (Fig. 8(b)).

For the rst canting transition between the ferrim agnetic state FM $_1$ and the corresponding canted phase C $_1$, along the line for the stability lim it of the FM $_1$ phase, there is a minimum value of anisotropy K . The corresponding critical point coincides with the upper lim it of elds H for the metastability lim it of the canted phase C $_1$. The values of these two characteristic points are

listed in Table I for M ills models N = 4 to 16. There is only a weak dependence on N for the coordinates for the critical points and e. This means, that there is also only a weak shift of the region of stable and m etastable FM -states. Further, the minimum anisotropy values for the stability region of the other collinear phases FM $_1$ with l > 1 are always larger than K . Thus, canted phases may occur in the region rather well circum scribed by the area shown for the simplest phase diagrams for N = 4 and 6. Interestingly, all the stability lines for these collinear phases FM $_1$ l = 1; ::: cross at the point x at $(K_x; H_x) = (4=3J; 2=3J)$ for M ills m odel and arbitrary N . One can show this by a sim ilar recursion for the eigenvalues of their tridiagonal stability m atrices as used by Dantas et al. to calculate H_{AF}.⁴⁹ This point is also visited by the line H AF (K). For all system swith an evenodd num ber of layers N = 6, 10, etc., the point x is a special multicritical point, where the collinear analogue of the symmetric spin- op phase FM [(N 2)=2] becomes degenerate with the inhom ogeneous symmetric SF-state. Thus, the rst-order transition line between the corresponding canted phase C $_{[{\tt N}\ 2)=2]}$ and the SF -phase ends in x as in the phase diagram for N = 6 shown in Fig. 5. This further degeneracy of M ills model yields som e stability and sim plicity of the general features of its phase diagram s.

As a caveat, we nally have to mention additional lowsymmetry phases which cannot be foreseen from the considerations on the stable collinear phases AF, FM₁, and F and their elastic distortions in the phase diagram. Such an intermediate phase C_x appears already in the phase diagram of M ills model for N = 6 in the region between the FM₁ phases and the region of the stable SF-phase. The C_x phase can be derived from an elastic distortion of the collinear phases "#"""", which do not arise as stable states. Sim ilar low-symmetry canted phases also appear in phase diagram s of M ills model for N > 6. For generalized models, the region of stability of these canted low -sym m etry phases will strongly depend on details of the materials parameters of type Eq. (4). Further energy term s and/or disorder in magnetic parameters of the layers can stabilize further phases in the intermediate region of the phase diagram. In the high-anisotropy limit of such generalized models, cascades of m etam agnetic transitions between ferrim agnetic collinear phases exist. From these states various canted phases can be derived in the range of intermediate an isotropies K₁=J₁ $\stackrel{<}{\sim}$ 1. The competition between all these phases will lead to very complicated magnetic phase diagram

IV. REORIENTATION IN WEAKLY ANISOTROPIC MULTILAYERS

A. Surface and volum e interactions

In this section, we re-analyze the magnetic states of an antiferrom agnetic multilayer stack, and their evolution in an applied eld, by analytical methods. In the limit of weak anisotropy, the micromagnetic energy (1) can be represented by a system of interacting dimers and by a continuum form. Thus, we consider the model (1) for weak anisotropies, K_i ; K_j^0 J_i. Further, we only study system s with collinear antiferrom agnetic (zero-eld) ground state. Thus, the strengths of the biquadratic exchange constants is limited to the range, $0 < \mathcal{F}_{i} < J_{i}=2.62$ First, we rewrite the general energy Eq. (1) in this lim it. The resulting expression allows to recognize the main e ects expected in this lim it without explicit calculations. We group the moments of the superlattice into pairs as in a two-sublattice antiferrom agnetic system. Starting from the rst layer we com bine the N m om ents along the antiferrom agnetic chain into N =2 pairs $(s_{2j 1}; s_{2j})$ with j = 1; ::; N = 2. For each of these pairs, we introduce the vectors of net m agnetization M i and the staggered vector L_i

It follows directly from (22) that $M_j = H_j^1 \sin(j)$, where is the angle between the eld H and the easy axis n in the model of Eq. (1).

The independent m inimization with respect to M $_{\rm j}$ is justiled because the exchange interactions dominate the energy and pairs of neighbouring m on ents do not deviate strongly from antiparallel orientation in the limit of weak anisotropy and elds. This establishes the relations Eq. (22) between the components of the net m agnetization and the orientation of the staggered vector. In other words Eq. (22) xeelly connects the net m agnetizations, as auxiliary degrees of freedom, to the vectors l_j and the applied eld. This approach reduces the chain of N m agnetic m on ents s_i into an equivalent system of N =2 unity vectors l_j . Each site of this chain corresponds to a twosublattice antiferrom agnet or a dimer. Substituting (22) into Eq. (20) we obtain the following expression for the energy of these interacting dimers

The minimization with respect to M $_{\rm j}$ according to Eq. (22) and the representation of the energy by the form (23) generalizes simplied dimerization transform ation that have been considered in Refs. [54,67].

The energy of the interacting dim ers Eq. (23) includes rst the sum of their \self"-energies, then an exchange sti ness energy given by the term quadratic with respect to di erences ($_{j+1}$ __j), and a speci c energy contribution ($_j$), de ned in Eq. (27). The term s in ($_j$) arise due to the variation of the magnetic parameters along the chain. The energy ($_j$) can be written in the form of a \Zeem an energy" for the staggered magnetization vectors

The dimensionless coe cients $_j$ are ratios of exchange constants de ned in Eq. (28). The rst two terms in Eq. (29) involve the endmost dimers, i.e., they have the character of a surface energy, which is in posed by the exchange cut. The sum in (29) describes similar \internal" contributions arising due to any variation of the exchange couplings along the antiferrom agnetic chain. This energy contribution disappears in models with equal exchange interactions in internal layers as in the regular and modi ed M ills models Eqs. 3) and (5), respectively.

B. Physicalmechanism of the \surface spin-op" phenomena

The magnetic energy of the low-anisotropy antiferromagnetic multilayers in the form of interacting dimers (23) elucidates the competing forces responsible for the eld-driven reorientation processes. Let us compare energy (23) with that of an isolated dimer. For a localized pair of $s_{2j \ 1}$ and s_{2j} spins (i.e. j-th dimer) a minimization via Eq. (22) yields

W hen the eld reaches the threshold eld H $_{\rm i}$ it causes the spin-op transition. For dimens incorporated into the interacting chain the parameters of the self-energies arem odied due to the exchange coupling and additional anisotropy contributions as seen by com paring Eqs. (23)-(25) with Eqs. (30)-(32). Therefore, within the chain the dimers have dierent threshold elds and they are elastically coupled with neighbouring pairs. Due to the couplings the opping of the individual dimers in their individual threshold elds H ; Eq. (23) are ham pered. Instead the chain only can transform into the opped phase when the opped con gurations are energetically advantageous throughout the whole system . G enerally the differences of the dim er self-energies along the chain causes spatialm odulations of any noncollinearm agnetic states. The inhom ogeneous spin- op and canted phases in M ills model (Fig. 3) exemplify such spin-con gurations.

However, the energy contribution (j) Eq. (21) provides another mechanism of magnetic-eld-induced reorientation in posed by the variation of the exchange interactions along the antiferrom agnetic superlattice, in particular by the exchange cut at its ends. This mechanism is due to the in uence of the linear energy term s (27), which favour a rotation of the staggered vector. As can be seen from the equivalent Eq. (29), an instability of the collinear con guration is caused by the \Zeem an term s" that are linear in the staggered vectors l_i . Generally, the rst term related to the two surfaces will dom inate, and this di erence will favour a rotation of these lj. This enforces an inhom ogeneous spin- op phase above a certain eld. As was shown in the previous section in strong anisotropy system s the exchange cut leads to ips of the m agnetization and a transition into collinear FM phases, which are also inhomogeneous. In low-anisotropy systems, under the dominating in uence of the exchange interactions, the in uence of this \local" defect is spread along the chain and stabilizes a spatially inhom ogeneous structure.

Thus, we have the following important conclusion. There are two di erent mechanisms of the eld-induced reorientation in nite antiferrom agnetic superlattices: (i) O ne of them is connected with a switching of the potential wells in the energy of the uniaxial antiferrom agnetic units. Thism echanims is similar to the usual eld-driven spin reorientation in (low-anisotropy) bulk antiferrom agnets and two-layer systems. Therefore, it is a common spin- op mechanism. (ii) The other mechanism is due to variation of the exchange coupling along the superlattice and, in particular, the exchange cut at the end of the stack. This type of reorientation transition can only exist in nite antiferrom agnetic superlattices and has no analogue in bulk antiferrom agnetism.

The interplay of these twom echanisms rules the form ation and evolution of the magnetic states in the system . Depending on the values of the material parameters dif-

ferent types of m agnetization processes can be realized in the generalm odel (1). In the low -anisotropy system s, ow ing to the dom inance of exchange interactions, it is the second e ect due to the cut exchange at the surfaces that dom inates the eld-driven reorientation transition.

As important cases for applications, we consider in more detail the highly symmetric M ills models Eqs. (3) and (5). Both models are composed of identical internal layers. For the modi ed M ills model Eq. (5) $_{1} = _{N=2} = 2(2J_{s} + J) = (1 + _{s})$, and $_{j} = 4J$ for j = 2; :::; N = 2 1. For the regular M ills model Eq. (3) $_{j} = 4J$ for j = 1; :::; N = 2.  $\frac{T}{P}$ he threshold eld for the endmost dimers is H_S = $\frac{T}{3=2H_0}$ and for internal dimers H_B = $\frac{T}{2H_0}$. Because

the spins in the chains have additional exchange couplings, these thresholds are larger than the threshold eld H_0 for an isolated pair. This reinforcing by exchange sti ness for the bound dimers increases the values of the threshold elds for the coupled chain.

C. Multilayers with large N. Continuum model

The lim it of multilayers with large N and the lim it of in nite antiferrom agnetic systems is best discussed going over to a continuum description. For the regular M ills m odel (3) with arbitrary N the transition into the opped state occurs closely to H tr H_0 given by Eq. (9), su ciently below the dimer threshold elds H $_{\rm S}$ and H $_{\rm B}$ (Fig. 11). This means that this transition is imposed by the exchange cut. These results can be easily understood from the solutions for the spin-con gurations in the opped state Eqs. (10), (11), and (12). The magnetization vectors for all internal layers can be combined into pairs with antiparallel magnetizations. The system e ectively behaves as an isolated dim er consisting only of the endmost spins with energy (4). Correspondingly the opping eld equals the threshold eld H₀ of this isolated pair. This result is common for systems with arbitrary values of N .




FIG.10: (Coloronline) M agnetization curves for M ills m odel with low anisotropy K = J = 0.01 and large N in the vicinity of the \bulk spin- op".

H ow ever, above the critical eld H $_0$ the evolution of the system remarkably changes with increasing N (Fig. 10). The multilayer with low N are characterized by a large magnetization jump at the transition eld and a nearly linear increase of the magnetization up to the ip eld. W ith increasing N the magnetization jump at H $_0$ gradually decreases. Concurrently, a steep section of the magnetization curve is found around elds with values close to H $_B$ (see Eq. (33)). Finally, for N 1 the magnetization curves develop a strong kink around this value.




FIG.11: (Color online) Evolution of con gurations for M ills model with low anisotropy K = J = 0.01 and N = 100 in the vicinity of the \bulk spin- op": (a) local net magnetic moments M_j (b) orientation of local antiferrom agnetic vectors (according to the Eq. (19). Inset shows average magnetization m vs. eld.

The magnetic-eld driven transform ation of the dimer energies in Eq. (33) explains this peculiar behaviour. In the transition eld H $_{\rm tr}$ H_0 the dim er self-energy term s in (33) still favour the antiferrom agnetic m ode (lijn). The threshold elds are exceeded at higher elds $(H > H_S \text{ for endm ost and } H > H_B \text{ for internal dim ers}).$ In superlattices with few layers the endmost and internal dim ers give com parable contributions to the m agnetic energy. The di erence in their internal energies suppresses drastic reorientation e ects at the threshold elds H $_{\rm S}$ and H_B. W ith increasing number of layers the relative energy contribution of the internal dimers for the total energy (20) gradually increases. Then, the magnetic energy of the internal layers plays the dom inant role in the formation of the opped con gurations. Thus, the endmost dimers does not hamper the reorientation e ects in the threshold eld H_B . Below the threshold eld, $H < H_{\rm B}$, the antiferrom agnetic phase with lip corresponds to the minima of the internal dimers and the inhom ogeneous spin- op phase consists of two antiferrom agnetic dom ains with antiparallel orientation of the staggered vectors (Fig. 11). These two regions are sep-

arated by a 180-degree dom ain wall with opped spin congurations in the center (l?n)

For $H > H_B$ the potential wells for the internal dimers switch into (l? n) con guration. A round the eld H_B the center of the domain wall gradually extends and sweeps out the regions with antiferrom agnetic con guration towards the surfaces of the stack. This drastic transform ation between the two con gurations within most of the bulk of the antiferrom agnetic stack causes a prominent anomaly of the magnetization curves near the eld H_B (Fig. 10). Above H_B the net magnetization M_j develops two symmetric maxim a close to the surfaces, which may be observable in experiment.

A sym ptotically with N $!\,1$, the magnetization curve approaches that of the usual spin- op in a bulk uniaxial antiferrom agnet. But, this reorientation occurs within the same magnetic phase, and no phase transition is connected with this process. Rather for any nite value of N the phase transition still occurs between the antiferrom agnetic and inhom ogeneous spin- op phase in the critical eld H $_{\rm tr}$ as a rst-order process. A swasm entioned above for large N this eld-induced phase has the character of a domain wall between two antiferrom agnetic

states. Non-collinear states arise in the central region of the stack, where the sm all total magnetization of the con guration is concentrated. For xed sm all an isotropy the transition is accompanied by a jump of the magnetization at the transition eld H_{tr}. The magnitude of this jum p decreases with the num bers of layers N (Fig. 10). Hence, at rst glance we have a paradox phase diagram for Millsmodel: a drastic eld-driven change of the magnetization is not related to a phase transition, while a real phase transition is noticeable only by a sm all jum p of the m agnetization, that vanishes for large N . How ever, this has a clear physical foundation because the transition at H_{tr} is related to the surface e ect and its visible e ects should vanish for N ! 1, whereas the crossing-over towards the opped con guration in the \bulk" of the multilayer stack should approach a true spin- op transition for N = 1.

A transition into the inhomogeneous spin-op state means that the free boundaries cause an inhom ogeneity far in the interior of the nite system. Close to the boundaries the magnetic con guration resembles that of the two antiferrom agnetic collinear dom ains. This structure is consistent with the properties of sem i-in nite antiferrom agnetic chains described by M icheletti et al.43 In the phase diagram s for these system s (even in the large anisotropy lim it) a highly degenerate phase occurs, where a localized inhom ogeneous con guration is situated at arbitrary distance from the surface.43 For nite antiferromagnetic chains with weak anisotropy, the mutual in uence of both surfaces will determ ine a unique state with 180 degree wall-like con guration in the center. Generally, such a symmetric con guration will be found for antiferrom agnetic layers, when the core of this con guration is wide enough to interact with both surfaces. For the nite systems, the simple structure of the phase diagram, showing only a SF phase with solutions preserving m irror symmetry about the center of the layer in intermediate elds between the AF phase and the saturated F phase, is restricted to low an isotropy system s. At sizeable anisotropy, the asym m etric canting com plicates the phase-diagram .

The energy of the modi ed M ills model Eq. (5) provides a simple way to introduce a continuum form of energy (33). For N 1 and low anisotropy K 1 the energy (20) can be converted to

By solving the Euler equation for the energy functional (40) with the boundary condition 2A (d =d) j= d=2 = 0 W_s (1)=0

one obtains a set of parametrized proles $(;_1)$. The further optimization of the energy with respect to the

parameter 1 yields the equilibrium distribution of the staggered vector within the multilayer of nite thickness. These solutions can generally be written as elliptic functions.

In the lim it of in nite thickness, N ! 1 the boundary values of correspond to the con gurations in antiparallel domains of the antiferrom agnetic phase, 1 (1) = 0, 2(1) = . In this case the variational problem for the functional (40) is equivalent to that of an isolated m agnetic wall with \e ective uniaxial anisotropy" K = (H² $2H_0^2$)=(16A). The corresponding analytical results for the wall parameters have been derived by Landau and Lifshitz⁶⁸. For M ills model this solution has been analysed in¹⁴.

This limiting case of the in nite chain provides a sim – ple physical explanation of the phase transition into the inhom ogeneous spin – op phase. A coording to Eqs. (40), (41) the op of the surface staggered vector (1) = 0 into antiparallel position (1) = yields a gain of surface energy W_s = $(2_s \quad 1)H$. By this process a dom ain wall is generated which requires a positive energy contribution $4^{'}$ AK = H_{B}^{2} H^{2} . The balance between these competing energy contributions is reached at the critical eld

$$H_{tr} = H_0 = \frac{p}{2_s^2} \frac{2_s + 1}{2_s + 1}$$

In particular, for the regular M ills m odel $_{\rm s}$ = 1 and the transition eld in Eq. (42) equals H $_0$. This simple energetics allows to form ulate a clear therm odynam ic reason for the transition into the inhom ogeneous spin- op phase provided by the exchange cut. The anti-aligned m agnetization vector at the non-compensated surface is overturned and reduces the Zeem an energy at the expense of the formation of a planar defect in the center of the superlattice, which has the character of a dom ain w all.

Because the energy gain in the inhom ogeneous spinop phase, W $_{\rm s}$ ($_{\rm s}$) = (2 $_{\rm s}$ 1)H, is proportional to the non-compensated magnetization of the surface layer, this transition into the opped state strongly depends on the net magnetization of the endmost layers. Partial compensation of the surface magnetization is tantam ount to a reduction of the parameter $_{\rm s}$. This reduction decreases W $_{\rm s}$ ($_{\rm s}$), and increases the critical eld H $_{\rm tr}$ (42). For $_{\rm s}$ = 1=2 the energy gain W $_{\rm s}$ ($_{\rm s}$) equals zero and H $_{\rm tr}$ reaches the threshold eld H $_{\rm B}$.

We come to an important conclusion. The exchange cut provides the stabilization of the opped phase only under condition of su ciently strong surface m agnetization. In the regular M ills model the m agnetizations of the layers are assumed to have xed values. The properties of the endm ost layers j = 1 and N are described by the same integral phenom enological parameters as the layers j = 2; :::; N 1 in the \bulk". Only the exchange cut relects the con neminent of this antiferrom agnetic system. In the continuum limit (40) the surface cut is represented by the surface contributions in the energy that describe the eld. The existence of surfaces with eld e ects favour single dom ain states of the individual ferrom agnetic layers in these multilayer stack and at the surfaces. In other system s, variousm echanism s can cause reductions of the non-com pensated m agnetization at the surfaces, such as crystallographic and m agnetic in perfections, form ation of antiferrom agnetic multidom ain states etc. A reduction of the totalm agnetization in the surface layers can strongly reduce the non-com pensated m agnetization of the opped states. For the continuum m odel (40) this occurs for $_{\rm s}$ < 1=2.

The surface energy (41) also includes the rst term that has the conventional form of a (local) antiferrom agnetic unit with a modied threshold eld \mathbb{H}_{S} from Eq. (37). A coording to many experim ental observations, the magnetic parameters $J_{\rm s}$, K $_{\rm s}$ and $_{\rm s}$ can be strongly modi ed by surface-induced interactions, see, e.g., Refs. [60,69]. Correspondingly \mathbb{P}_{S} in (41) can vary in a broad range. Generally, considering models with modi ed magnetic surface properties, the volum e energy (40) and the surface energy (41) m ay favour di erent m agnetic con gurations in certain intervals of applied magnetic eld. This competition can stabilize inhomogeneous phases with continuous rotation of the magnetization vectors along the thickness. The occurrence of such twisted states under pinning (or anchoring) in uence of the surfaces is a rather general e ect in orientable media. In particular, they are known to occur in various classes of liquid crystals as the so-called Freedericksz e ect^{70,71} and in ferromagnetic materials.^{12,72,73} Spiraling in exchange spring m agnets and exchange bias system s also belongs to this class of phenom ena. 73 The phenom enological theory of such states in antiferrom agnetic nanolayers has been developed in Ref. [13]. It was shown that non-collinear twisted phases can arise as solutions for magnetic states under anchoring-e ects at the surfaces. In contrast to inhom ogeneous spin- op states stabilized by the exchange cut the twisted phases arise due to pinning or distortive e ects of surface-induced interactions on the magnetic states. Future analysis of generalized M ills m odels should concentrate on the combined e ects of these surface interactions.

V. DISCUSSION

A. Solving the \surface spin- op" puzzle

The exchange cut is the prim ary driving force that causes the speci c reorientation e ects in antiferrom agnetically ordered multilayers and stabilizes the unique m agnetic states unknown in other classes of m agnetic systems. The pioneering studies by M ills and co-w orkers^{5,14} have introduced the notion of a surface-induced instability in con ned antiferrom agnets¹⁴ and of the novel

reorientation e ects in antiferrom agnetic superlattices⁵. M ills form ulated the basic idea that, in a con ned antiferrom agnet, uncom pensated surface m agnetization causes the instability of the collinear state in the applied magnetic eld quite below the common (bulk) spin-op. This transition from the antiferrom agnetic to a \surface spinop" state should result in opping a few layers of spins near the surface, i.e., they would turn by nearly 90 degree.¹⁴ This picture was in proved and detailed by K effer and Chow,¹⁵, and supplem ented by results of num erical simulations.^{5,6,45,46} It constitutes the recent scenario of a \surface spin-op". According to this picture the opped states are nucleated initially at the surface and in increasing elds this surface state moves into the depth of the sam ple as an antiferrom agnetic dom ain wall.^{15,45} \W hen the external eld exceeds the surface spin-op eld, the surface moment, initially antiparallel to the eld, rotates nearly by 180 . In e ect, a twist is applied to one end of the structure. A domain wall is then set up, in an o center position in the nite structure. [:::] W ith further increase in eld, the wall undergoes a series of discontinuous jumps, as it migrates to the center of the structure. [:::] The dom ain wall becom es centered in the structure, and then with further increase in eld broadens, to open up as a ower to evolve into a bulk spin-op state. The angle between the spins and the external eld is less at and near the surface than in the center of the structure.\6

The detailed investigations of M ills m odel (3) necessitate a considerable revision of the surface spin- op scenario expanded $in^{5,14}$ and some other papers^{6,15,45}. This scenario of the surface spin- op confuses three di erent types of the solutions for M ills m odel (3), see the phase diagram s in Figs. 3 and 5. The \ opping of a few layers of spins near the surface" is inspired by solutions for ferrin agnetic and canted phases in system swith sizeable anisotropy. The picture of the dom ain wall movem ent into the center of the superlattice \in a sequence of discrete hops"45 is related to cascades of phase transitions between canted phases in superlattices with moderate anisotropy (Figs. 8). Finally, the ower-like broadening of the centered dom ain wall poetizes the evolution of the inhom ogeneous spin- op phases in elds higher than H_B (Fig. 10).

Thus, the common scenario of the surface spin- op combines elements that belong to di erent solutions for di erent values of the control parameters (K = J, H = J, N) of the model (3). In R ef.⁵³, it was shown that the equationsminimizing energy (3), as well as general models (1), do not include solutions for surface-con ned (localized) states, which were assumed to occur at a \surface spinop" transition". These models own only well-de ned \volume" phases and transitions between them.

The term surface spin-op" designates the reorientation into the inhom ogeneous spin-op phase at H tr (line a b in Fig.5). Therefore, it is a double m isnom er. This transition does not take place at the surface because it involves the reorientation of all spins along the superlat-

tice, i.e., it has a \volum e" character. And it is not a proper spin- op because it is induced by the exchange cut rather than a switching of the potential wells as in the common spin- ops in bulk antiferrom agnets.

B. Notes on the experim ental observations of surface spin- op phenom ena

The concept of a \surface spin-op" is commonly applied to analyse experim ental results in antiferrom agnetic superlattices^{5,10,11,37}. However, the application of an erroneous concept is dangerous. In particular, quantitative conclusions about m agnetic m aterials param eters from the observed reorientation transitions can lead to wrong results. The lability eld of the antiferrom agnetic states H_{AF} plays the prime role in the common \surface spinop" scenario. Because the surface spin- op was believed to arise as a local surface instability of the collinear phase exactly at the critical eld H_{AF}, this was considered as a transition eld into the surface spin- op state14,15. In reality a (volum e) rst-order transition between the antiferrom agnetic and inhom ogeneous spin- op phases occurs at H_{tr} (e.g., the line a-b in Fig. 5), which is lower than H_{AF} (line a) and larger than another lability eld H_{SF} (line a-). The interval H $_{SF}$ < H < H $_{AF}$ is a metastability region of these competing phases (Fig. 6). In the low -an isotropy lim it the m etastablity region is extrem ely small and these characteristic eld are all close to the value H_0 from Eq. (20). In the lim it of large an isotropy the lability eld H $_{\rm A\,F}$ is much larger than the transition eld between AF and FM phases (Fig. 5).

The \bulk" spin-op eld is also considered as important element of the common scenario. Starting at HAF the expansion of the surface spin- op phase is com pleted in elds exactly equal to the value of the spin- op transition in a \bulk" antiferrom agnet having the sam e values of the magnetic parameters as in model (3). For low-anisotropy systems this eld equals H $_{\rm B}$ and is $\frac{1}{2}$ times larger than the $surface spin - op" H_0$. This eld corresponds to the threshold eld for the internal dim ers as given in Eq. (33). In system swith large num bers of layers N, a strong reorientation of the opped states occurs in the vicinity of this eld. No phase transition is connected with this process, however, it is marked by a noticeable anom aly of the magnetization curve (Fig. 10). Thus, the magnetization curve anomalies are connected with the transition into the opped state at H tr H_0 and with a sm ooth reorientation near H $_{\rm B}$ that does not involve a real transition. The ratio $H_B = H_{tr}$ is about 2. A sim ilar anom aly within the spin- op state is also observed in system s with rather large an isotropy, where the spin- op phase is preceded by one or several canted phases. How ever, a glance at the phase diagram, e.g., Fig. 5 shows that there is no simple quantitative relation between the various reorientation anom alies observable in such multilayer system s with sizeable an isotropy.

Magnetic-eld-induced reorientation transitions were

investigated in high-quality Fe/Cr(211) antiferrom agnetic superlattices^{5,10}. In Ref. [5] m agnetization curves for Fe/Cr (211) superlattices with strong uniaxial anisotropy were measured by a SQUID magnetometer and by longitudinal magneto-optic Kerr e ect. The magnetization curves for both investigated multilayers with even number of layers Cr(100)/Fe(40)/Cr(11)and $Cr(100)/Fe(20)/Cr(11)_{20}$ dem onstrate close correspondence to theoretical results for M ills m odel. A ccording to⁵ the values of the antiferrom agnetic coupling between the layers is JM $_0^2 = 0.275$ erg/cm² and uniaxial anisotropy is K M $_0^2 = 0.06$ erg/cm 2 , The ratio K =J = 0.22 shows that these multilayers belong to the systems at interm ediate an isotropy in the phase diagram that display cascades of canted phases. Indeed, the characteristic anom alies in the eld derivatives of the magnetization reveala series of such reorientation transitions. The asymm etric character of these transitions is dem onstrated by Kerrmeasurements (see Fig. 3 (b) in Ref. [5]). A cascade of canted phases has also been observed in another Fe/Cr system ¹⁰. In this paper a Cr(100)/Fe(14)/Cr(11)₂₀ system has been investigated with JM $_0^2 = 0.405$ erg/cm² and K M $_0^2 = 0.06$ erg/cm². The ratio K = J = 0.15 m eans that this superlattice also evolves in the applied eld via a cascade of canted phases. It should be noted that the rst-order transitions between these di erent magnetic phases allows for phase co-existence in rather wide eld ranges (see Refs. 55,56]). All these processes may involve multidom ain states. In the case of multilayers with effective in-plane anisotropy, the stabilization of dom ain structures will be subject to imperfections. In particular, interface roughness will lead to magnetic charges or leaking dipolar stray elds. The corresponding dom ain structures is determ ined by the defect structure of the multilayer and will have an irregular appearance in general (see, e.g., chap. 5.5.7 in Ref. [9]).

In contrast, m ultilayers with perpendicular anisotropies constitute a novel class of arti cial con ned antiferrom agnets, where well-de ned and regular dom ain structures such as stripes or bubbles can be found. These are layered systems as antiferrom agnetically coupled multilayers [CoPt]/Ru⁷, or Fe-Au superlattices⁷⁴. These strongly an isotropic system s correspond to the right side of the phase diagram s in Figs. 3, 5 and are characterized by a num berm etam agnetic jum ps^{7,56}. Due to strong demagnetization elds the magnetization processes in these superlattices are accompanied by a complex evolution of multidom ain states^{7,8,56,64}. A rti cial layered system s of this kind with a controlled variation of distinct magnetic states in vertical direction can be considered as arti cial m etam agnets⁵⁶.

VI. CONCLUSIONS

In this work, we have provided a complete solution for the basic m icrom agnetic m odel of an antiferrom agnetic

superlattice with ideal non-compensated surfaces under a eld along the easy axis. We have shown how one can system atically enum erate and describe the magnetic phases and their transitions for such structures. The puzzle of the variable appearance of \surface spin- op" phenom ena has been resolved by the re-construction of the phase-diagram s and of the lim iting cases for this m odel. To this end various m ethods had to be introduced that can be used for generalized models. A nalytical tools can be e ciently used for all collinear or highly symmetric phases, and for the case of weak anisotropies. Extensions as given by the models Eqs. (1) { (5), that include further m agnetic coupling term s, additional anisotropies etc., should be made the subject of further work. In particular, the question of competing surface-couplings and partially compensated surfaces in nite antiferrom agnetic stacks should be addressed. In such system s, a com petition between a genuine inhom ogeneous spin- op phase and twisted states takes place.

In system s with interm ediate an isotropies com parable to the indirect interlayer exchange within antiferrom agnetic superlattices, one has to expect very complicated phase-diagram s. Still, such situations can be analysed by the m icrom agnetic m ethods developed here. How ever, it is vital to use clear concepts of magnetic phase transitions and clean de nitions that designate the driving forces behind the varieties of eld-driven reorientation processes in con ned antiferrom agnets. W e em phasize that the notion of a \surface spin- op" is erroneous because the relevant magnetic energy terms that drive both the canting instabilities at surfaces and the transition into the inhom ogeneous spin- op phase are not related to a balance between e ective anisotropies and Zeem an energy in these nite antiferrom agnets. The transitions experienced by the type of nite antiferrom agnets with noncompensated surfaces, as investigated here, are always related to the exchange cut. Finally, for the arti cial antiferrom agnetic system s com posed of m esoscale ferromagnetic units, the rst-order transitions are of crucial importance. The phase-coexistence between states with nite magnetization will give rise to stable dom ain structures and hysteretic behaviour in these system s ow ing to dem agnetization e ects.
