## Role of covalency in the ground state properties of perovskite ruthenates: A rst principle study using local spin density approximations

W e investigate the electronic structure of SrR uO<sub>3</sub> and CaRuO<sub>3</sub> using full potential linearized augmented plane wave method within the local spin density approximations. The ferrom agnetic ground state in SrR uO<sub>3</sub> could exactly be described in these calculations and the calculated spin magnetic moment is found to be close to the experimentally observed values. Interestingly, the spin polarized calculations for CaRuO<sub>3</sub> exhibit large spin moment as observed in the experiments but the magnetic ground state has higher energy than that in the non-magnetic solution. Various calculations for different structural con gurations indicate that Ca-O covalency plays the key role in determining the electronic structure and thereby the magnetic ground state in this system .

## I. IN TRODUCTION

Investigation of the ground state properties of ruthenates has seen an explosive growth in the recent time due to many interesting properties such as superconductivity,<sup>1</sup> non-Ferm i liquid behavior,<sup>2,3</sup> unusualm agnetic ground states<sup>2,3,4,5</sup> etc. observed in these m aterials. SrR uO 3, a perovskite com pound exhibits ferrom agnetic long range order below the Curie Tem perature of about 160 K with a large magnetic moment  $(1.4_{B})$  despite highly extended 4d character of the valence electrons.<sup>4,5</sup> Various band structure calculations based on di erent kinds of approximations reveal ferrom agnetic ground state in SrR uO<sub>3</sub> and the calculated m agnetic m om ents are found to strongly depend on the kind of approxim ations used in the study.<sup>6,7</sup> Interestingly, CaRuO<sub>3</sub>, an isostructural com pound exhibit sim ilarm agnetic m om ent at high tem peratures as that observed in SrR uO<sub>3</sub> but the magnetic ground state is controversial. W hile som e studies predicted an antiferrom agnetic ordering in CaRuO<sub>3</sub>,<sup>7,8,9,10</sup> various other studies suggest absence of long-range order down to the low est tem perature studied.<sup>2,3,5,11</sup> These later investigations predict that the behavior in this compound is in the proximity of quantum criticality, which is manifested in the transport measurem ents exhibiting non-Ferm i liquid behavior.<sup>2,3</sup>




FIG.1: Schem atic diagram of the crystal structure of SrR uO  $_3$  and C aR uO  $_3$ . The thick solid lines show the Ru–O–Ru angles.

B oth SrRuO<sub>3</sub> and CaRuO<sub>3</sub> form in an orthorhom bic perovskite structure (ABO<sub>3</sub> - type). The space group for SrRuO<sub>3</sub> is conventionally de ned as P bnm and that for CaRuO<sub>3</sub> is P nm a, which are essentially the same structure type with a di erence in the de nition of axis system <sup>12,13</sup> The A cation (Sr/Ca) sites help to form the typical building block of this structure. The RuO<sub>6</sub> octahedra in these compounds are connected by corner sharing as shown in Fig. 1. The conduction electrons m oves via this RuO<sub>6</sub> network and hence determ ines various electronic properties. The tilting and buckling of the RuO<sub>6</sub> octahedra as evident in the gure essentially leads to a G dFeO<sub>3</sub> type distortion resulting to the orthorhom bic structure. W hile the structure type is same in both the

com pounds, the extent of distortion is som ewhat di erent resulting to a slightly di erent Ru-O-Ru bond angle in these com pounds. If O (1) represents the apicaloxygen in the RuO<sub>6</sub> octahedra along z-axis in the gure and O (2) represents the oxygens in the basal (xy) plane, there are two O (2) and one O (1) atom s in one form ula unit. The Ru-O-Ru angles in SrRuO<sub>3</sub> are:<sup>13</sup> Ru-O (1)-Ru = 167.6, Ru-O (2)-Ru = 159.7 and those in CaRuO<sub>3</sub> are:<sup>14</sup> Ru-O (1)-Ru = 149.6, Ru-O (2)-Ru = 149.8.

The Ru-O-Ru angle has signi cant in uence in the electronic properties since the electron hopping interaction strength between Ru-sites via oxygens, usually denoted by t is the largest for the angle of 180 and gradually reduces with the deviation of Ru-O-Ru bond angle from 180. Thus, the electron correlation strength, U=W (U = electron-electron C oulom b repulsion strength and t / W = valence band width) is expected to be higher in C aRuO 3 than that in SrRuO 3. It wasbelieved that the di erence in U=W in these two com-

pounds leads to such contrasting ground state properties. However, a recent experimental study shows that U=W is signi cantly weak as expected for a highly extended 4d transition metal oxides and are very similar in both the compounds.<sup>15</sup> Thus, the experimental observation of di erent ground state properties in otherwise these two identical compounds still remains a puzzle despite numerous studies carried out in these and associated other system s as well during last two decades.

Local spin density approximations has offen been found to be successful to capture the magnetic ground state properties of various system s.<sup>16,17,18</sup> In the present study, we investigate the magnetic ground state properties of ruthenates using state-of-the-art full potential linearized augmented plane wave method<sup>19</sup> within the local spin density approximations. The results for SrR uO<sub>3</sub> reveal ferrom agnetic ground state consistent with various experimental results. Interestingly, the ground state energy for the spin polarized solution of CaR uO<sub>3</sub> is higher than that for the non-magnetic solution despite large exchange splitting leading to a large magnetic moment in this system. Calculations for di erent structural con gurations suggest that Ca-O covalency plays the key role in determining the electronic properties in this system.

## II. THEORETICALMETHODS

The electronic band structure calculations were carried out using full potential linearized augmented plane wave (FLAPW) method within the local spin density approximations (LSDA) using w EN2K software.<sup>19</sup> The lattice constants are obtained from the analysis of xray di raction patterns from high quality polycrystalline sam ples<sup>4</sup> and are very similar to those estimated earlier for the samples in both single crystalline and polycrystalline form s.<sup>12,13,14</sup> The estimated lattice parameters corresponding to the axis system shown in Fig. 1 are; a = 5.572 A, b = 5.542 A, c = 7.834 A for  $SrRuO_3$ , and a = 5.519 A, b = 7.665 A, c = 5.364 A for CaRuO<sub>3</sub>. The atom ic positions in SrRuO<sub>3</sub> used in these calculations are; Sr: 4c (x = 0.488(3), y = 1.00(0), 1/4; Ru: 4b (0, 0.5, 0); O (1): 4c (x=-0.000(1), y=0.03(8), 1/4; 0 (2): 8d (x=0.28(5), y=0.22(7), z=-0.03(3)). The atom ic positions in CaRuO<sub>3</sub> are; Ca: 4c (x=0.9465(7), 1/4, z=0.0122(5)); Ru: 4b (0, 0, 0.5); O (1): 4c (x= 0.10248(7), 1/4, z= 0.5899(1)) and O (2): 8d (x = 0.2072(5), y = 0.4513(5), z = 0.2080(8)). It is to note here that the Ru 4d orbitals de ned in the axis system shown in Fig. 1 are di erent from those in the local axis system of R uO  $_6$  octahedra having  $t_{2g}$  and  $e_g$  symmetries. In order to show the partial density of states corresponding to di erent Ru 4d orbitals, we have rotated the axis system by 45 in the xy plane and the results are shown later in the text.

Various bond lengths found in these calculations match well with the experim ental results. Despite di erence in lattice parameters and change in unit cell volume be-




FIG.2: Calculated (a) TDOS, (b) Ru 4d PDOS with  $t_{2g}$  sym – metry, (c) Ru 4d PDOS with  $e_g$  sym metry, (d) O 2p PDOS, and (e) Sr 4d PDOS for the non-magnetic ground state of SrRuO<sub>3</sub>. The large intensity at the Ferm i level suggests a metallic ground state. The states at the Ferm i level have primarily Ru 4d character with O 2p states appearing below -2 eV.

tween CaRuO<sub>3</sub> and SrRuO<sub>3</sub>, average Ru-O bond lengths are very similar in both the cases. The mu n-tin radii ( $R_{M\ T}$ ) for Sr/Ca, Ru and O were set to 1.06 A, 0.85 A and 0.74 A, respectively. The convergence for di erent calculations were achieved considering 512 k points within the rst Brillouin zone. The error bar for the energy convergence was set to < 0.25 m eV per form ula unit. In every case, the charge convergence was achieved to be less than 10 <sup>3</sup> electronic charge.

## III. RESULTS AND DISCUSSIONS

In Fig. 2, we show the density of states (DOS) calculated for the non-magnetic solution of SrR uO<sub>3</sub>. There are four distinct groups of intense features and a at region appear in the total density of states (TDOS) shown in Fig. 2 (a). In order to identify the character of these features, we also plot the partial density of states (PDOS) corresponding to Ru 4d, O 2p and Sr 4d contributions in the eigen states by calculating the projection of the eigen states onto these spin-orbitals. It is clear that Sr 4d contributions appear beyond 4 eV above the Ferm i level, F denoted by 'zero' in the energy axis. O 2p also has -


nite contributions in this energy range suggesting nite mixing between 0 2p and Sr 4d electronic states.

The Ru 4d contributions are shown in two groups. In Fig. 2 (b) and 2 (c), the 4d orbitals de ned in the cartesian coordinate system s correspond to the xyz-axis system rotated by 45 in the xy plane with respect to the axis system shown in Fig. 1. This axis system is very close to the local axis system of the RuO<sub>6</sub> octahedra. The deviations due to the orthorhom bic distortions are clearly manifested by small intensities in the energy range corresponding to other symmetries. The  $d_{xy}$ ,  $d_{yz}$  and  $d_{xz}$ orbitals possess  $t_{2g}$  symmetry and are shown in Fig.2(b). The PDOS corresponding to these orbitals spread over a large energy range of -7 eV to 0.6 eV with a sharp feature between -2 eV to 0.6 eV.O 2p PDOS in Fig 2(d) also exhibit signi cantly large intensities in this energy range. The observation of 0 2p character in the Ru 4d band and vice versa suggests strong hybridization between 0 2p and Ru 4d electronic states. This hybridization between  $t_{2q}$  bands and the symmetry adapted 0 2p bands form s bonding and anti-bonding energy bands, where the overlap of the orbitals are sideways and are known as -bonds. The energy bands between -7 eV to -4.5 eV energies can be assigned as bonding bands and the antibonding bands appear between -2 to 0.6 eV. From the relative intensities of the Ru 4d and 0 2p PDOS, it is evident that the anti-bonding bands possess essentially Ru 4d character and the bonding bands have 0 2p character. The total width of the  $t_{2q}$  band is close to 2.6 eV.

The  $d_{x^2 \ v^2}$  and  $d_{z^2}$  PDOS are shown in Fig. 2(c). The primary contribution appears between 0.9 eV and 5.5 eV with large contributions between - 7.8 eV to -5 eV. Similar to the case of  $t_{2q}$  bands, signi cant 0 2p PDOS also appear in these energy ranges. The mutual contributions between Ru 4d and 0 2p states again indicate large degree of covalency. The electronic states with  $e_g$  symmetry form -bonds (head-on overlap) with the O 2p states. Since, -bonds are signi cantly stronger than the -bonds, it is expected that the separation between bonding and anti-bonding states involving -bonds will be signi cantly larger com pared to that corresponding to -bonds. This is clearly manifested in the electronic density of states in Fig. 2(c), where the energy region between - 7.8 eV and - 5 eV is contributed by bonding bands with dom inant 0 2p character and the anti-bonding states appear above F.

The features in the energy region between -4 eV to -2.2 eV are primarily contributed by 0 2p PDOS, and has negligible contributions from Ru 4d and Sr 4d electronic states. Thus, these intensities are assigned to the 0 2p non-bonding electronic states. Notably, all these characterizations are consistent with various photoem ission results.<sup>15</sup>

In order to investigate the m agnetic properties in this system within the local spin-density approximations, we have calculated the ground state energies for ferrom agnetic arrangement of m on ents of the constituents. Inter-

estingly, the eigen energy for the ferrom agnetic ground state is lower by 1.2 m eV per form ula unit (fu) than the lowest eigen energy for the non-magnetic solution. It is to note here that a small variation in atom ic position leads to a large di erence in energy between the ground state energies corresponding to ferrom agnetic and nonm agnetic solutions. For example, for the atom ic positions from Ref. [12], this energy di erence is about 9 m eV /fu. However, the ferrom agnetic ground state energy in this case is 612 m eV /fu higher than that in the present case. Interestingly, all the structures of SrRuO<sub>3</sub> published in the literature to m y know ledge, the ferrom agnetic ground state energy is observed to be low er than that corresponding to the non-m agnetic solution. W hile these results are clearly consistent with the experim ental observations and various previous results,  $^{6,7}$  it reestablishes that the local spin density approximations are su cient to capture the m agnetic ground state in these materials as also established in 3d and 5d transition m etal oxides.<sup>16,17,18</sup>

The spin magnetic moment centered at Ru-sites is found to be about 0.58  $_{\rm B}$ , which is substantially small compared to the spin only value of 2  $_{\rm B}$  corresponding to four electrons in the t<sub>2g</sub> orbitals in the low spin conguration of Ru<sup>4+</sup>. In addition, there is a large spin polarization of the interstitial electronic states (0.33  $_{\rm B}$ ) about 57% of the Ru-moment). The induced spin moment at the oxygen sites are also found to be signi – cantly large (0.1  $_{\rm B}$  for O (1) and 0.08  $_{\rm B}$  for O (2)). All

these m agnetic m om ents centered at di erent Ru and 0 sites couple ferrom agnetically. Thus, the total spin m agnetic m om ent per form ula unit is found to be about 1.2  $_{\rm B}$  and is very close to the experim ental estimation of 1.4 0.4  $_{\rm B}$  from various m easurem ents on varieties of sam ples in single and polycrystalline form s.<sup>9,20</sup>

Interestingly, the total magnetic moment, although consistent to the experimental estimations, is signi cantly lower than the spin only value for the  $t_{2a}^3 t_{2a}^4$ electronic con guration for  $Ru^{4+}$  ions. This is significantly di erent from 3d transition m etal oxides, where the calculated m agnetic m om ent is often found very close to their spin only value corresponding to the electronic con guration close to the transition metal ions. W hile it has been observed that various other approxim ations, such as generalized gradient approxim ations, inclusion of spin-orbit coupling etc. leads to a larger value of the spin m agnetic m om ent in the ground state, the experim ental observation of sm all saturation m agnetic m om ent even for high quality single crystals suggests that other e ects are in portant for this system . In particular, the orbital m om ent is expected to be negligible for these large 4d orbitals due to the strong crystal eld e ect. The reduction of local moment from the spin only value of 2  $_{\rm B}$ m ay be attributed to the highly extended nature of the 4d orbitals. In addition, a large degree of 0 2p - Ru 4d hybridization is observed in the DOS, which may reduce the magnetic moment further.

The shifts in the DOS due to exchange splitting are shown in Fig. 3, where the down-spin DOS is shown on the same energy scale (x-axis) but the DOS-axis is inverted. The relative shift of the up- and down-spin states provides an estimation of the exchange splitting of the corresponding electronic states. It is evident that there is no shift between up-and down-spin Sr 4d states appearing above 4 eV. The relative shift in the up-and down-spin PDOS corresponding to 0 2p states provides an estimate of the exchange splitting of about 0.25 eV. The exchange splitting in Ru 4d total density of states is close to 0.5 eV and is consistent with the values obtained in previous studies.<sup>6</sup> However, it is found to be som ew hat di erent for the electronic states with di erent symmetries. W hile it is 0.5 eV for  $t_{2g}$  bands, close to 0.4 eVis observed in the case of eq bands. Sm aller splitting in the later cases m ay be attributed to the larger degree of itineracy of the corresponding electronic states. Interestingly, the TDOS at  $_{\rm F}$  for the up-spin states is found to be signi cantly smaller (1.95 states/eV.fu) than that (3.64 states/eV.fu) for the down spin states. The spin polarization can be de ned as

$$P = \frac{(N (_F)_{"} N (_F)_{\#})}{(N (_F)_{"} + N (_F)_{\#})}$$

where N (  $_{\rm F}$  ) denotes the density of state at  $_{\rm F}$ . Thus, P is found to be – 30.2%, which is signi cantly large and negative as observed experimentally.<sup>21</sup>




FIG.4: Calculated (a) TDOS, (b) Ru 4d PDOS with  $t_{2g}$  sym - metry, (c) Ru 4d PDOS with  $e_g$  sym metry, (d) 0 2p PDOS, and (e) Ca 3d PDOS for the non-magnetic ground state of CaRuO<sub>3</sub>. The large intensity at the Fermi level suggests a metallic ground state as that observed in SrRuO<sub>3</sub>. The states at the Fermi level have primarily Ru 4d character with 0 2p states appearing below - 2 eV.

W e now turn to the case of  $C \approx uO_3$ . The calculated DOS for non-m agnetic solutions are shown in Fig.4. The

features below - 2 eV is primarily contributed by the O 2p PDOS as also observed in the case of  $SrRuO_3$  in Fig. 2. The oxygen 2p non-bonding bands appear between -4 eV to -2 eV energy range. By comparing the Ru 4d PDOS and O 2p PDOS, it is evident that the bonding  $t_{2g}$  and  $e_g$  bands with dom inant 0 2p character appears below  $- \ 4 \ \text{eV}$  , where the bonding  $e_{\alpha}$  bands have the lower energies as expected. The anti-bonding  $t_{2\alpha}$  bands possess dom inant Ru 4d character and appear between -1.8 eV to 0.6 eV energies. The anti-bonding eq bands appear between the energy range of 1.5 eV to 5 eV. The  $t_{2q}$  and  $e_q$  bands are separated by a distinct energy gap of about 1 eV. Interestingly, Ca 3d contributions appear above 5 eV, which is signi cantly higher than the energy range corresponding to the Sr 4d contributions. This is unusual since the Sr 4d electronic states are expected to have higher energies com pared to the energies of Ca 3d electronic states. We will discuss this unusual observation later in the text.

It is to note here that the total width of the  $t_{2g}$  band is about 2.4 eV, which is slightly smaller than that observed for SrRuO<sub>3</sub> ( 2.6 eV; a change of 7.5%). How – ever, the width of the individual d-bands are very close to each other ( 2.4 0.1 eV). Thus, the smaller Ru-O-Ru




FIG. 5: Calculated (a) TDOS, (b) Ru 4d PDOS, (c) O 2p PDOS, and (d) Ca 3d PDOS for the ferrom agnetic ground state of CaRuO<sub>3</sub>. The down spin DOS are shown in the same energy scale with inverted DOS axis.

bond angle in CaRuO3 has very little in uence on the width of the  $t_{2q}$  bands. W hile all the d bands with  $t_{2q}$ symmetry are very similar in  $SrRuO_3$ , the  $d_{xy}$  band in CaRuO<sub>3</sub> is slightly shifted to higher energies com pared to the  $d_{yz}$  and  $d_{xz}$  bands. This energy shift may be attributed to the distortion of the RuO 6 octahedra leading to a deviation from octahedral symmetry towards  $D_{4h}$  symmetry. The width of the  $e_q$  band is found to be smaller ( 3.5 eV) in CaRuO<sub>3</sub> than that ( 4.6 eV) in SrRuO<sub>3</sub>. Since,  $e_{\alpha}$  states are coupled with oxygens via bonds, the change in Ru-O-Ru bond angle has the strongest in uence in these bands in comparison to that in the -bonded case corresponding to  $t_{2g}$  bands. How ever, such changes will not have signi cant in uence in the electronic properties of these materials since the ea bands are essentially empty in both the compounds.

In order to probe the m agnetic properties in this system, we calculated the lowest energy eigen states for the ferrom agnetic ordering of the spin moments at various sites. Interestingly, the calculations converges to a ferrom agnetic ground state with large spin moments at different sites and the lowest energy eigenvalue is slightly (4 m eV /fii) higher than that for the non-m agnetic solution. A recent study<sup>7</sup> using fill potential linearized mu n-tin orbital (FPLMTO) calculations within generalized gradient approximations (GGA) and spin-orbit coupling shows that CaRuO<sub>3</sub> exhibit G-type antiferrom agnetic long range order, where all the neighboring

Ru-sites are antiferrom agnetically coupled. However, in the absence of spin-orbit coupling, the ground state is found to be ferrom agnetic. There are strong controversy in the ground state behavior in  $CaRuO_3$ . The recent studies suggest an enhanced param agnetic ground state<sup>5</sup> and/or proximity to the quantum criticality.<sup>2</sup> Slightly higher energy corresponding to the ferrom agnetic ground state com pared to the non-m agnetic/param agnetic solutions in this study suggests that ferrom agnetic ground state in not stable in this system s as also observed in the experimental results.

In the ferrom agnetic solution, the spin m agnetic m oment centered at the mu n-tin spheres corresponding to Ru, O (1), O (2) and interstitial states are found to be 0.49  $_{\rm B}$ , 0.04  $_{\rm B}$ , 0.08  $_{\rm B}$  and 0.25  $_{\rm B}$ , respectively. All the spin magnetic moments at di erent sites couple ferrom agnetically, which leads to a total spin m agnetic moment of about 1 B. This value is again signi cantly smaller than the spin only value of 2  $_{\rm B}$  for Ru<sup>4+</sup> but consistent with the experim entally observed values.4,5 In order to investigate the up- and down spin DOS corresponding to various elements in CaRuO3, we show the calculated DOS in Fig. 5 in the same way as shown in Fig.3 for SrR uO<sub>3</sub>. The exchange splitting in O 2p PDOS is found to be about 0.25 eV. The exchange splitting in both  $t_{2\alpha}$  and  $e_{\alpha}$  bands is close to 0.4 eV, which is slightly smaller than that observed in  $SrRuO_3$ . No exchange splitting is observed for Ca 3d states. The TDOS at  $_{\rm F}$  for the up and down spin states are 1.75 states/eV .fu and 2.22 states/eV fu, respectively. Thus, the spin polarization at  $_{\rm F}$  in this compound is found to be about -11.9% .

From the results presented so far, it is clear that the observation of ferrom agnetism in SrR uO<sub>3</sub> can be explained by band structure e ects. The lowest eigen energies for di erent magnetic arrangements in CaRuO3 suggest a nonm agnetic/param agnetic ground state. In order to investigate the origin of such di erence in CaRuO3 com pared to SrR uO<sub>3</sub>, we calculated the lowest energy eigen states for di erent com binations of crystal structures and their magnetic ground states. As a st step, we calculated the lowest energy solutions for SrRuO<sub>3</sub> in the sam e crystal structure as that of C aR uO 3. Interestingly, the lowest eigen energy for the nonmagnetic solution is 1117.5 m eV /fu higher than the ferrom agnetic ground state energy in its real structure. The low est eigen energy for the ferrom agnetic solutions in this crystal structure is even higher (1118.5 m eV /fu). The total spin m agnetic m om ent is found to be very very sm all (0.14  $_{\rm B}$  ). Change in structure reduces the unit cell volum e by about 6.4% and the average Ru-O-Ru bond angle from 165 to 150 . However, average Ru-O bond lengths are very similar. The large increase in energy indicates that such changes does not lead to a stable state. Interestingly, in the CaRuO<sub>3</sub> structure, the ferrom agnetic ordering leads to an enhancem ent in eigen energies com pared to the nonm agnetic solutions although Sr is present at the A-sites.

We now compare the lowest eigen energies calcu-




FIG.6: Comparison of (a) TDOS, (b) Ru 4d PDOS, (c) O 2p PDOS and (d) Sr 4d PDOS of SrRuO<sub>3</sub> in the real structure (positive DOS axis) and equivalent cubic structure (inverted DOS axis). Results exhibit a close similarity between the two cases as expected in SrRuO<sub>3</sub>. In (d), the dashed lines represent the calculated DOS and the solid lines represented the sam e multiplied by 20.

lated for  $CaRuO_3$  in the crystal structures similar to that of SrRuO<sub>3</sub>. The lowest eigen energy increases by 893.6 m eV /fu com pared to the ground state energy in its original structure in the nonmagnetic/paramagnetic con guration. Interestingly, the ferrom agnetic solution is 869.7 m eV /fu higher in energy, which is 23.9 m eV /fu lower than that in the nonmagnetic con guration. The magnetic moment calculated in this con guration is  $0.66 \text{ }_{\text{B}}, 0.05 \text{ }_{\text{B}}, 0.12 \text{ }_{\text{B}} \text{ and } 0.39 \text{ }_{\text{B}} \text{ for } \text{Ru}, O(1),$ 0 (2) and interstitial states, respectively. The totalm agnetic moment is found to be 1.35  $_{\rm B}$  , which is signi cantly higher than that found even in SrRuO<sub>3</sub>. Thus, in SrR uO<sub>3</sub> structure, the presence of C a at the A-sites also stabilizes ferrom agnetic ground state. Since the change in structure is essentially re ected in the Ru-O-Ru bond angle without much change in Ru-O bond length, it is clear that this change in bond-angle helps to stabilize ferrom agnetic ground state. The A-site potential in the ABO3 structure has negligible in uence in determining the magnetic ordering of the compound.

In order to probe the role of cations in stabilizing the crystal structure, which is manifested by large change in the ground state energies, we compare the calculated results for both  $SrR uO_3$  and  $CaR uO_3$  for their real structure and the equivalent cubic structure keeping the




FIG.7: Com parison of (a) TDOS, (b) Ru 4d PDOS, (c) O 2p PDOS and (d) Ca 3d PDOS of CaRuO<sub>3</sub> in the real structure (positive DOS axis) and equivalent cubic structure (inverted DOS axis). A large shift of the Ca 3d band suggests strong Ca-O covalency. In (d), the dashed lines represent the calculated DOS and the solid lines represented the sam e multiplied by 20.

unit cell volum e identical to that in the real structure. The ground state energy for the nonmagnetic solution of SrRuO<sub>3</sub> is about 45 m eV /fu higher than the ferrom agnetic ground state energy in the real structure. The calculated DOS are shown in Fig.6. It is evident that the DOS for real and cubic structures are sim ilar in term s of energy position and overlap of Ru 4d and Sr 4d electronic states with the 0 2p states etc. Total width of various bands are som ew hat narrow er in the real structure com pared to that in the cubic structure. It is to note here that GdFeO<sub>3</sub> type of distortion appears in SrRuO<sub>3</sub> via the distortion of the RuO 6 octahedra with di erent Ru-0 bond lengths, and Ru-O (1)-Ru bond angle 167.6 and Ru-O (2)-Ru bond angle 159.7 . This leads to a lifting of degeneracy of the  $t_{2g}$  and  $e_g$  bands. How ever, the average Ru-O bond lengths are close to that in the equivalent cubic structure. This is clearly manifested by the closeness of the DOS and PDOS shown in Fig. 6.

In C aR uO<sub>3</sub>, the nonm agnetic ground state energy in the cubic structure is signi cantly large ( 190 m eV /fu) compared to that in the real structure. We compare the calculated DOS corresponding to the real structure of C aRuO<sub>3</sub> and the equivalent cubic structure in Fig. 7. The width of the Ru 4d and O 2p bands are signi cantly larger in the cubic structure due to the Ru-O-Ru bond




FIG.8: (a) Ca 3d PDOS is compared with O 2p PDOS in the cubic structure, where the unit cell volum e is identical to the unit cellvolum e in the real structure. (b) Ca 3d PDOS is compared with O (1) 2p PDOS and O (2) 2p PDOS corresponding to the real structure of CaRuO<sub>3</sub>. The results suggest a strong Ca-O (1) covalency.

angle of 180 and a smaller Ru-O bond length arising from smaller unit cell volume. The most striking e ect is observed in the PDOS of Ca 3d band. In the results corresponding to the cubic structure, Ca 3d band appear in the energy range of 3 - 5.5 eV as expected for Ca 3d electronic states compared to the energies of Sr 4d electronic states shown in Fig. 6. Such lower binding energies leads to a signi cant overlap with the O 2p PDOS appearing at lower energies. Interestingly, the Ca 3d PDOS contributions shift to above 5 eV energies in the real structure with an increase in contribution in the O 2p dom inated region as shown by expanding the low energy part in Fig. 7(d).

In order to investigate the Ca-O covalency and the overlap with di erent oxygens in the structure, we plot Ca 3d PDOS along with corresponding O (1) 2p and O (2) 2pPDOS in Fig. 8. In the cubic structure, Ca 3d PDOS appears between 3 eV and 5.5 eV energies. The contributions at low erenergies (E < F) appears to have di erent intensity distribution with energy compared to that observed for 0 2p PDOS. In the real structure, the Ca 3d band shifts to above 5 eV energies and the contributions below F matches signi cantly well with the PDOS corresponding to 0 (1) 2p electronic states. This reveals a typical scenario of Ca 3d and O (1) 2p hybridization resulting to bonding and antibonding bands. The bands at low er energies represent the bonding electronic states with dom inant 0 2p character and the antibonding levels with large C a 3d character shifts to higher energies.

Thus, the DOS in the real structure reveals a large degree of covalency between Ca-O (1) in the structure, which leads to a shift of O (1) sites towards Ca-sites (G dFeO  $_3$  type of distortion).<sup>22</sup>

Sm aller ionic radius of C  $a^{2+}$  com pared to  $Sr^{2+}$  leads to a reduction in G oldschm idt tolerance factor ( $r_A + r_O$ ) =  $2(r_{R,u} + r_O)$ , where  $r_A$  is the ionic radius of Sr/C a. Such reduction offen results to a distortion in the crystal structure. However, this does not indicate, what kind of distortion is expected. In  $3d^1$  perovskite system s, it is already shown that although there is no change in the tolerance factor between CaVO<sub>3</sub> and LaT iO<sub>3</sub>, a large distortion in the crystal structure is observed.<sup>22</sup> It was shown that the covalency between A -site cations and O -2p states plays the key role in determ ining the distortion in the crystal structure and that the shift of O (1) sites tow ards A -sites leads to a G dFeO<sub>3</sub>-type of distortion in these system s. A sim ilar e ect is also observed here in the electronic structure of these perovskite ruthenates.

In order to understand the magnetic ground state in  $\operatorname{CaRuO}_3$  in the cubic structure, we have calculated the low est eigen energies for the sam e unit cell. Interestingly, in the cubic structure, the ground state is ferrom agnetic, which is about 21 m eV /fu lower in energy than that for non-magnetic solution. The magnetic moment is found to be signi cantly large with total spin contribution of  $1.2_{\rm B}$ . The Ru-O bond length in this condition is about 1.92 A, which is signi cantly smaller than that in the real structure (average bond length = 2 A). It has been observed that application of pressure leads to a decrease in Curie tem perature in SrRuO<sub>3</sub>.<sup>23</sup> This has also been observed in our calculations as well as in the theoretical results published in the past<sup>6</sup> that ferrom agnetic solution becom es less stable with the decrease in unit cell volum e leading to a decrease in Ru-O-Ru bond angle. Thus, the observation of ferrom agnetic ground state in the cubic structure of CaRuO<sub>3</sub> clearly reveals an important role of Ru-O-Ru bond angle in the ground state properties.

In 3d transition m etal (TM ) oxides, it is observed that the TM -O-TM superexchange interaction stabilizes antiferrom agnetic ordering for TM -O-TM bond angles of 180 . This is the origin of antiferrom agnetic behavior observed in alm ost all the 3d transition m etal oxides with insulating ground state. For TM -O -TM bond angle of 90 , a ferrom agnetic ordering is expected since the oxygen 2p orbitals connected to two neighboring TM sites are orthogonal and the holes transferred from TM sites will be parallel due to Hund's rule coupling. Thus, a deviation from 180 is expected to help ferrom agnetic ordering due to Hund's rule e ect.

In addition, the deviation of Ru-O-Ru bond angle from 180 is expected to enhance the local magnetic moment of 4d electronic states due to the decrease in hopping interactions strength. Thus, the destabilization of the long range ferrom agnetic order in C aRuO<sub>3</sub> due to the decrease in Ru-O-Ru angle from 180 is unusual.

It is to note here that in 3d transition m etal oxides, the m agnetic m om ent at the transition m etal site is often

found to be very close to the values corresponding to the ionic con guration<sup>16,17</sup> suggesting signi cantly large bcalized character of the 3d electrons. How ever, 4d orbitals are highly extended com pared to the 3d orbitals and the correlation e ects are found to be signi cantly weak. This is clearly manifested in various magnetic measurements with the estimations of signi cantly smaller magneticm om ent (close to  $1.4_{\rm B}$ ) com pared to the spin-only value of 2  $_{\rm B}$  for Ru<sup>4+</sup>. The extended nature of the 4d electronic states leads to a strong coupling between the local m om ents centered at di erent cites. This is presum ably the origin of large degree of spin polarization in the 0 2p bands ( 17%) and in the interstitial electronic states ( 55%). Such large spin polarization of the valence electronic states has also been observed in elem ental ferrom agnets; 4f m om ents leads to a strong spin polarization in the 5d6s valence electrons of  ${\rm G}\,{\rm d}^{24}$

and these electronic states couple the local m om ents at di erent sites leading to a ferrom agnetic long range order. Such coupling is will be weaker in these nuthenates, when the Ru-O-Ru angle deviates from 180 due to the reduction in hopping interaction strength and hence the reduction in extended nature of the valence electrons. W hile these argum ents provide a qualitative understanding of the m agnetic properties in these interesting class of m aterials, further study is required to probe the details of such interactions in these system s.

In summary, the results in these calculations establishes that A-O covalency in the ARuO<sub>3</sub> structure plays the key role in determining the electronic structure in these systems. The absence of long range order in CaRuO<sub>3</sub> may be attributed to smaller Ru-O-Ru angle appearing due to large Ca-O covalency in this system.
