Self-sim ilarity in Fractal and Non-fractal Networks

Abstract

We study the origin of scale invariance (SI) of the degree distribution in scale-free (SF) networks with a degree exponent under coarse graining. A varying number of vertices belonging to a community or a box in a fractal analysis is grouped into a supernode, where the box mass M follows a power-law distribution, P_m (M) M. The renormalized degree k⁰ of a supernode scales with its box mass M as k⁰ M. The two exponents and can be nontrivial as \Leftrightarrow and < 1. They act as relevant parameters in determining the self-similarity, i.e., the SI of the degree distribution, as follows: The self-similarity appears either when or under the condition = (1)=(1) when > , irrespective of whether the original SF network is fractal or non-fractal. Thus, fractality and self-similarity are disparate notions in SF networks.




FIG.1: (C olor online) (a) The protein interaction network of the budding yeast and (b) its coarsegraining. G roup masses fM g, detected by the box covering, are heterogeneous. The node size in (b) is taken as $p_{\overline{M}}$ for visualization.

I. IN TRODUCTION

K adano 's block spin and coarse-graining (CG) picture is the cornerstone of the renorm alization-group (RG) theory [1]. A system is divided into blocks of equal size and is described in terms of the block variables that represent the average behavior of each block. Scale invariance at the critical point under this CG enables one to evaluate the critical exponents. From a geometric point of view, scale invariance in plies the presence of fractal structures, and their fractal dimensions are associated with the critical exponents [2]. For example, the magnetization and the singular part of the internal energy for the critical Ising model are such scale invariant quantities, which are manifested as the fractal geometric forms of the area of spin dom ains and the length of the spin dom ain interface, respectively.

The fractal dimension d_B of a fractal object is measured by using the box-covering method [3], in which the number of boxes, N_B ('_B), needed to tile the object with boxes of size '_B follows a power law,

This relation is referred to as fractal scaling hereafter. A fractal object is self-sim ilar in the sense that it contains sm aller parts, each of which is sim ilar to the entire object [3].

While the notions of CG and self-sim ilarity are well established when an object is em -

bedded in Euclidean space, it is not clear how to extend and apply them usefully to objects not embedded in Euclidean space. In the form er case, the number of vertices within each box, equivalent to the block size in RG term inology and referred to as the group mass for future discussion, is alm ost uniform, and the fractal objects are self-sim ilar and vice versa. In the latter case, however, the group mass is extremely heterogeneous so that it follows a power-law distribution. This case can happen in scale-free (SF) networks; then, one needs to establish the way of CG and the notion of self-sim ilarity in a new setting, which is a goal of this paper. A SF network [4] is a network whose distribution $P_d(k)$ of degree k, the number of edges connected to a given vertex, follows a power-law form : $P_d(k) = k$ with the degree exponent . The scale invariance of the degree distribution under CG is de ned as the self-sim ilarity in SF networks.

M ost SF networks in the real world contain functional groups or communities within them [5]. In general, the distribution of the group m ass M, the number of vertices within each group follows a power law asymptotically [6, 7]:

W hen such groups are form ed within networks, it would be more natural to take each group as a unit to form a supernode in CG because the vertices within each group are rather hom ogeneous in their characteristics, such as functionality or working division, and are connected densely. In other CG procedures, groups may not necessarily represent functional m odules in bio-networks and communities in social networks; they can be taken arbitrarily in a theoretical perspective, for example, being articially composed or boxes introduced in the fractal analysis [8, 9, 10, 11]. Supernodes are connected if any of their merging vertices in di erent communities are connected. This CG method is di erent from the standard ones in view of extrem ely heterogeneous group masses as shown in Fig. 1. We show below that the exponent plays a central role in determining the self-similarity.

So far, several endeavors to achieve a RG transform ation for SF networks have been carried out. However, their methods remain in the framework of the standard RG method, ignoring the heterogeneity of the group-mass distribution. For example, K im [12, 13] applied CG to a SF network generated on a Euclidean space [14], including long-range edges. Taking advantage of the underlying Euclidean geometry, the number of vertices within each block is uniform and increases in a power law as the block lateral size increases, so that the real-space

RG method can be naturally applied. In Refs. [15] and [16], the decimation method was applied to a few deterministic SF networks, which were constructed recursively starting from each basic structure. Those deterministic models restore their shapes under CG achieved by decimating the vertices with the smallest degree at each stage. We discuss this case in detail later.

In this paper, we perform the CG of SF networks in three di erent ways: (i) random grouping, (ii) box covering in fractal analysis, and (iii) identifying community structure with clustering algorithms. The groups are (i) articially composed, (ii) taken as boxes introduced in the fractal analysis, and (iii) taken as communities embedded within the network, in respective cases. For all cases, the group-mass distribution follows the power law, Eq. (2). We identify the criteria for self-sim ilarity in term softhe exponents in Eq. (2) and which will be introduced below in Eq. (6). Such a self-sim ilarity condition holds for non-fractal, as well as fractal real-world networks.

II. CG BY RANDOM GROUPING




FIG. 2: (Color online) Schematic snapshot of a random SF network with random grouping.




FIG.3: (C olor online) D egree distributions of a renorm alized network of the static m odel for = 3 under CG. The group m asses are preassigned to follow a power law P_m (M) M with = 2(), 3(), and 4(4). The degree distribution of the original network is also drawn (). The dashed and the dotted lines with slopes of 2.1 and 3.0, respectively, are drawn as guidelines.

The model enables us to obtain the renorm alized degree exponent ⁰ analytically by using the generating function technique, showing that, indeed, ⁰ depends on . The model is constructed as follows: (i) W e construct a SF network through the static model of R ef. [17]. We choose the degree exponent = 3 and the mean degree hki = 4. (ii) N individual vertices are grouped random by into N⁰ groups with sizes fM g (= 1;:::;N⁰), following the distribution function in Eq. (2). The exponent is tuned. We consider three cases of : (a) = 2 (<), (b) = 3 (=), and (c) = 4 (>). (iii) We perform the CG by replacing each group with a supernode and connecting them if any of their merging vertices in di errent groups are connected. A renorm alized network is constructed. A schematic snapshot of a constructed network is shown in Fig. 2. Next, the degree distribution P⁰_d(k⁰) k^{0⁰} of the renorm alized network is measured. The result is as follows: ⁰ = = 2 € for = 2 (a), ⁰ = 3 for = 3 (b), and ⁰ = = 3 for = 4 (c), as shown in Fig. 3.

The num erical result is understood analytically as follows: Since the vertices are grouped random ly, every vertex has an equal probability to connect to vertices in other groups per edge, so the total probability is proportional to the degree of each vertex. This leads to the relation $k^0 = \frac{P}{12} k_j$, where is the index of the group. Then, the degree distribution

 $P_{d}^{\ 0}\left(k^{0}\right)$ of the renorm alized network is written as

denoting the K ronecker delta. By using the generating function technique, one can denoting the relation $P_d^0(z) = P_m (P_d(z))$, where $P_d(z)$ is the generating function of $P_d(k)$ and so forth. The $P_d(z)$ is obtained to be




FIG. 4: (Color online) Box-m ass distribution for (a) the W W W and (c) the fractalm odel network of Ref. [20]. D ata are for ${}_{B}^{*} = 2$ () and ${}_{B}^{*} = 5$ (). The solid lines are guidelines with slopes of {2.2 and {1.8, respectively, in both (a) and (c). The degree distributions of the original network (N) and the renorm alized networks with ${}_{B}^{*} = 2$ () and ${}_{B}^{*} = 5$ () for (b) the W W w and (d) the fractalm odel network. The fractalm odel has a system size N 3 10⁵. (c) and (d) are adopted from Ref. [11].

where $hki = \frac{P}{k}kP_{d}(k)$ and a is a constant. The generating function $P_{m}(!)$ is also derived in a similar form to Eq. (4). Then, one can dimmediately that

as long as both and > 2. Thus, self-sim ilarity holds when , and we can con m that the exponent plays a key role in determ ining the exponent ⁰. In the form ulation, the relation $k^0 = \frac{P}{j^2} k_j$ was crucial. W hen the relation no longer holds, the derivation of the degree exponent ⁰ is m ore com plicated. This can happen for fractal and som e non-fractal networks, and also for clustered networks, which we discuss next.

III. CG BY BOX COVERING

Recently, it was discovered [B] that fractal scaling, Eq. (1) holds in some SF networks, such as the world-wide web (W W W), the metabolic network of Escherichia coli, and the

protein interaction network of H om o sapiens. G roups are form ed by covering the networks by boxes that contain nodes whose mutual distances are less than a given box size. The group-m ass distribution follows the power law of Eq. (2), even though the boxes' lateral sizes are xed as $\frac{1}{B}$ for all boxes. Thus, the fractal networks are good objects for our study.

We rst apply a box-covering algorithm to the WWW.Our box-covering algorithm is slightly modilled from the original one introduced by Song et al. §], and the details of the algorithm is presented in Ref. [9]. Both algorithms [8, 9] are identical in spirit and the box size ${}_B$ we use is related linearly to the corresponding one ${}_S$ in Ref. [8]. Next, each box is collapsed into a supernode. Two supernodes are connected if any of their merging vertices in dillerent boxes are connected. The degree distribution $P_d^0(k^0)$ of the renormalized network is exam ined.

The distribution of box m asses is measured and found to follow a power law asymptotically, P_m (M) M Fig. 4 (a)]. The exponent is found to depend on the box size $'_{\rm B}$. For small $'_{B} = 1 \text{ or } 2$, 22 is measured, which is close to . On the other hand, as $'_{B}$ increases, we expect to approach the exponent = = (1), describing the power-law behavior of the cluster-size distribution of the branching tree [18]. We nd that 1:8 for $'_{B} = 5$. This result can be understood as follows: The W W W contains a skeleton [19], a spanning tree based on the betweenness centrality or load, which can represent the original network in the box-covering [20]. For small $_{\rm B}$, the lateral dimension of the box is not large enough to see the asymptotic fractal behavior of the spanning tree, so that the number of vertices in a given box scales similarly to the largest degree within that box. Thus, = . As 'B increases, on the other hand, the asymptotic fractal behavior of the spanning tree becom es dom inant. Thus, the exponent becom es the sam e as the exponent asym ptotically, which was observed in the case of $_{\rm B}$ = 5. The case of \Leftrightarrow was not considered in Ref. [8]. The origin of the self-sim ilarity is nontrivial as we show below.

The CG process involves two steps. The set is the vertex renorm alization, i.e., merging of vertices within a box into a supernode, and the second is the edge renorm alization, merging of multiple edges between a pair of neighboring boxes into a single edge. The second step can yield a nonlinear relationship between the renorm alized degree k^0 and box m ass M $_B$, although the total number of inter-community edges from a given box is linearly proportional to its box m ass [9]. Thus, we propose that there exists a power-law relation between the




FIG. 5: (Color online) P bt of the average renorm alized degree $hk^{0}i$ versus box m ass M_B for (a) the W W W and (b) the fractal m odel network of Ref. [20]. D ata are for box sizes $i_{B} = 2$ (), $i_{B} = 3$ (), and $i_{B} = 5$ (N). The solid lines, guidelines, have slopes of 1.0 (), 0.8 (), and 0.6 (N), respectively, for both (a) and (b). (b) is adopted from Ref. [11].

average renorm alized degree and the box m ass:

The power-law relation Eq. (6) is tested numerically for the WWW, as shown in Fig.5(a). For ${}_{B} = 2$, we estimate 1.0 0:1. Thus, the linear relation holds. For ${}_{B} = 3$ and 5, however, 0:8 0:1 and 0:5 0:1, respectively, in plying the nonlinear relationship, Eq. (6). One may doubt the nonlinear behavior due to the scattered data shown in Fig.5(a). To con m this result, we recall a previous study [1] for the fractal model with = 2:3 introduced by G oh et al. [20], where we can reduce the data noise by taking an ensemble average over network con gurations. We obtained similar results as shown in Fig.5(b). The data for the fractal model are averaged over 10 di erent network con gurations, so the nonlinear relationship could be seen more clearly.

U sing $P_d^0(k^0)dk^0 = P_m(M_B)dM_B$ and $k^0 = M_B$, we obtain the degree exponent of the renormalized network to be ${}^0 = 1 + (1) = :$ In short, we argue that Eq. (5) should be




FIG. 6: (Color online) (a) Box-m ass distribution and (b) average renorm alized degree $hk^{0}i$ versus box m ass M_B of the Internet at the AS level. Here, the lateral box size is taken as '_B = 2 for both. The solid lines, drawn for reference, have slopes of (a) 1:8 and (b) 0:7.

For ${}^{\circ}_{B} = 2$, we found that and 1; therefore, ⁰ . For ${}^{\circ}_{B} = 5$, even though \Leftrightarrow 1, plugging 0:5 0:6 and 1:8 into Eq. (7), we obtain ⁰ 2:3 2:6, which is in reasonable agreement with 2:3. Thus, self-sim ilarity also holds [Fig. 4 (b)]. We recall the previous study for the fractalm odel with = 2:3 [11], nding that the numerical results are the same as those of the WWW, as shown in Figs. 4 (c) and (d).

The self-sim ilarity condition in Eq. (8) is also fulled for some non-fractal networks. The Internet at the autonomous system (AS) level is a prototypical non-fractal SF network. However, it exhibits self-sim ilarity. We obtain 1:8 and the nonlinear relationship in Eq. (6) with 0:7, so that 0 2:1(1) for $_{\rm B}$ = 2, as shown in Fig. 6, satisfying the




FIG. 7: (C olor online) R enormalized degree distributions of real-world, (a) { (c) and (e) { (h), and m odel, (d) and (i), networks under successive CG transformations with a xed box size $'_B = 2$. Symbols represent the original network (), and the renormalized networks after the rst (4) and the second (0) iterations. The networks of (a) { (c) are fractals, and those of (d) { (i) are non-fractals. The networks of (a) { (f) are self-sim ilar while those of (g) { (i) are not.

condition in Eq. (8).

A few determ inistic SF networks have been introduced, which were constructed recursively starting from each basic structure. The pseudofractalm odel [15] introduced by D orogovtsev et al., the geom etric fractalm odel introduced by Jung et al. [16], and the hierarchical m odel [5] are such examples. These m odels restore their shapes under the CG achieved by decimating the vertices with the smallest degree at each stage. Thus, they are self-similar in shape. In those m ethods, the degree distribution is scale invariant under the CG. How – ever, they are not fractal because fractal scaling, Eq.(1), is absent and the fractal dimension cannot be de ned. The three determ inistic m odels , 15, 16] satisfy the self-similarity con– dition in a trivial manner: = and = 1 under the decimation. Here, the group-mass distribution is measured as the distribution of the number of deleted vertices connected to each coarse-grained vertex at each decimation stage. Thus, 0 = , and the models are self-similar, even though they do not follow the fractal scaling, Eq. (1).

We also exam ine the change of the degree distributions under successive CG transformations for the fractal and some non-fractal networks in Fig. 7. We con m that the self-sim ilarity holds even for the non-fractal networks (d) { (f). It is noteworthy that the relation in Eq. (6) is linear for the rst renorm alization, but it becomes nonlinear for the second renorm alization as 0**:**75 and 1:8 for the W W W . It is also interesting to note that the static model with = 2:3 is self-similar in Fig. 7(d) while that with = 3:6 in Fig. 7 (i) is not. That is due to the topological di erence of the SF networks with > 3 and 2 < < 3 [9, 19]. When is small, the edges are compactly concentrated around the hubs while as grows the edges more globally interweave the network. Consequently, when renorm alization is performed on the SF network with 2 < < 3, only the nodes around each hub in the original network are grouped into a supernode in a coarse-grained network, and the supernode again becomes a hub with a corresponding size. On the other hand, > 3, the nodes far from the hubs in the original network have more chances to when be connected to hubs via global edges, and the supernodes in the coarse-grained network become far bigger hubs than those in the original network. The result is more heavily-tailed degree distributions in the coarse-grained networks, as seen in Fig. 7 (i).

IV. CG BY COMMUNITY STRUCTURE

M ost SF networks in the real world contain functional modules or community structures within them, which are organized in a hierarchical manner. W hile the group-mass distributions are known to follow a power law in Eq. (2), for many cases, however, they exhibit a crossover between two distinct power-law behaviors or the power-law behavior appears only in a limited range of mass. A loo, they are sensitive to various clustering algorithms [7]. Thus, it is not easy to not su ciently good examples of clustered networks with appropriate clustering algorithms to test our argum ent.

Here, we choose the algorithm proposed by C lauset et al. [21] and apply it to the condm at coauthorship network [22]. The network data contain 13,861 vertices and 44,619 edges.




FIG.8: (Color online) W hen the coauthorship network is clustered, (a) the box-m ass distribution, (b) the average renormalized degree $hk^{0}i$ versus group mass M, and (c) the degree distribution of the original () and renormalized () networks are plotted. G roups are obtained by using the clustering algorithm of Ref. [21]. The solid lines, drawn for reference, have slopes of (a) 1:6, (b) 0.7, and (c) 1:8.

Unfortunately, the degree distribution of this network is not a power law. Nonetheless, the data are clustered into 175 groups obtained at the point where the modularity becomes maximum in the clustering algorithm. The group-mass distribution is likely to follow the power law in Eq. (2), and the exponent is estimated to be 1:6 0.2 in Fig. 8(a). Next, the CG is carried out; then, the degree distribution of the renormalized network is exam ined. It shows a power-law behavior with exponent 0 1:8 0.2: To check the form ula of Eq. (7), we measure the relationship of Eq. (6) between the renormalized degree and the group mass in Fig. 8(b). The exponent is measured to be 0:7 0:1. We plug the numerical values of and into the formula, and obtain 0 1:9 0:4, which is in reasonable agreement with the measured value 0 1:8 0.2 in Fig. 8(c). The degree distribution of the renormalized network follows the power law. Thus, self-sim ilarity does not hold for this case.

V. DISCUSSION AND CONCLUSIONS

For the fractal networks, Song et al. [8] showed that in the box-covering method, the renorm alized degree k^0 scales as $k^0 = s({}_B)k_m$, where $s({}_B) = {}_B^{d_k}$ with $d_k = d_B = (1)$ and k_m being the largest degree in a given box. This form is not directly applicable to non-fractal networks, but a modil ed form of $k_{max}^0 = (N^0 - N)^{1 = (1)} k_{max}$ can be applied for non-fractal but self-similar SF networks, where $k_{max}^0 = (k_m - k_m)$ is the largest degree in the entire renorm alized (original) network and $N^0(N)$ is the total number of nodes after (before) CG. The above relation can be easily derived by using the scaling of the natural cuto of degree, $k_{max} = N^{1=(-1)}$ and $k_{max}^0 = N^{0=(-1)}$. Thus, for SF networks, it is ore general to form ulate a scaling function in term s of the ratio $N^0 = N$ rather than the length scale 'B.

A lthough, in this paper, we limited the notion of self-similarity to the scale invariance of the degree distribution, one may wonder if other quantities, such as C (k) and $hk_{nn}i(k)$, are scale invariant under the CG.We and that such quantities tend to obey the scale invariance for the WWW in the box-covering method, but the statistics from real-world networks are not su ciently good to support this conclusion. That means, the self-similarity thus de ned does not imply any recursive topological identity nor does it even guarantee that the degree distribution within each group is identical from group to group. On the other hand, the origin of fractality is understood by the power-law relation between the length scale and the

size of the skeleton underlying the original network [9]. In such senses, it seems that the fractality describes an important topological feature of SF networks at a fundamental level while the self-sim ilarity does not. Moreover, the results we obtained till now empirically show that all the fractal networks are self-sim ilar, but the converse is not true. Thus, we conjecture that fractality in plies self-sim ilarity.

In sum mary, we have studied the renorm alization-group transform ation of the degree

distribution, in particular, when the num bers of renorm alized vertices with each block follows a power-law distribution, P_m (M) M. We found that the average renorm alized degree scales with the box m ass as hk⁰i (M_B) M_B. The two exponents and can be nontrivial as 6 and 6 1. They act as relevant parameters and are analogous to the scaling exponents associated with the magnetization and the singular part of the internal energy in the renorm alization group theory. We obtained the degree exponent ⁰ of a rem orm alized network in terms of and . Many non-fractal networks are self-sim ilar. The notions of fractality and self-sim ilarity are disparate in SF networks, which is counterintuitive in view of their equivalence in Euclidean space.
