Red blood cells and other non-spherical capsules in shear ow : oscillatory dynam ics and the tank-treading-to-tum bling transition

Abstract

We consider the motion of red blood cells and other non-spherical microcapsules dilutely suspended in a simple shear ow. Our analysis indicates that depending on the viscosity, membrane elasticity, geometry and shear rate, the particle exhibits either tum bling, tank-treading of the membrane about the viscous interior with periodic oscillations of the orientation angle, or intermittent behavior in which the two modes occur alternately. For red blood cells, we compute the complete phase diagram and identify a novel tank-treading-to-tum bling transition at low shear rates. Observations of such motions coupled with our theoretical fram ework may provide a sensitive means of assessing capsule properties. Hum an red blood cells suspended at low concentrations in steady simple shear ow have been observed to exhibit two types of motion. While cells suspended in a low viscosity media tumble continuously, cells suspended in a uid with su ciently high viscosity exhibit tank-treading' motion [1]. Here, we use the term tank-treading to describe a cell that maintains alm ost constant shape and orientation in the laboratory frame, but whose membrane circulates around the interior much like the motion of a tank tread. Keller and Skalak [2] analyzed the motion of a tank-treading viscous ellipsoid and concluded that the behavior depends on the ratio of the viscosities of the inner and outer uids and was independent of the shear rate. However, it has recently been observed that red blood cells oscillate about a

xed angle while tank-treading and that tum bling can be induced by low ering the shear rate [3]. Furtherm ore, the dynam ics of synthetic m icrocapsules in simple shear ow have been shown to depend not only on the viscosity ratio, but also on the shear rate: at high shear rates, the capsule surface tank-treads about the interior while the orientation oscillates; at low shear rates, the capsule tum bles [4, 5]. These observations are unaccounted for by current theory and motivate the present work. In this letter, we provide a united theoretical fram ework for analyzing the motion of both non-spherical capsules and red blood cells in simple shear ow and attribute the observed shear rate dependent behavior to a periodic variation in the elastic energy during tank-treading.

Here, we model the cell or capsule as an ellipsoid of viscosity ⁰ contained in an elastic membrane and immersed in a uid of viscosity . In the frame of the ellipsoid having axes of length a_i , the surface is at the position $\frac{x_i^2}{a_1^2} = 1$. The external ow unperturbed by the ellipsoid is a simple shear ow of rate _ in the laboratory reference frame (see gure 1a). We assume that material elements in the membrane move along elliptical paths in planes parallel to the x_1 - x_2 plane, with velocity eld as in 2]. Then, the position of each membrane element is dened by a phase angle (t) and the tank-treading frequency is (equation extends the analysis of [2] for a viscous ellipsoid to include the ellipsoid. Our formulation extends the analysis of [2] for a viscous ellipsoid to include the ellipsoid equations unrelated to elastic membrane. Torque balance yields an equation for the rate of change in the orientation of the ellipsoid, , in the laboratory frame 2]

The tank-treading frequency, Q_t , is found by balancing the rate of work done by the external

uid on the ellipsoid with the internal dissipation and the rate of change of the elastic energy stored in the mem brane. The rate of work done by the external uid on the ellipsoid, W_p , and the internal dissipation, D, are [2]

where V is the volume of the ellipsoid and f_i are functions of the ellipsoid geometry dened in the endnote [7].

In a series of recent experiments on red blood cells in a transient shear ow, F ischer $\{$] showed that after relaxation from deformation the rim of a red blood cell is always formed by the same part of the membrane. This shape memory could not be eliminated by continuous deformation for periods up to 4 hours, showing that the elect is not due to visco-elastic relaxation. These results in ply the existence of an elastic energy that has a minimum when the membrane is in static equilibrium. Since an element displaced from the rim can return to either side of the rim depending upon its proximity [6], the elastic energy must pass through two minima during a tank-treading revolution. Similarly, for the case of a polyamide capsule, the unperturbed shape is a slightly non-spherical ellipsoid and we assume that the elastic energy during tank-treading has the same —rotational symmetry as the undeformed shape. C onsequently, we take elastic energy to have the form

F ischer's experiments [6] can also be used to estimate the size of the elastic energy change, E_0 . When the shear ow is stopped, the rate of work done by the external uid W_b vanishes. The slender geometry of the red cell allows us to neglect dissipation in the external uid in this analysis so that the rate of change in the elastic energy (4) balances the internal dissipation (3) so that

The volume of a red blood cell is V 7 $1\sqrt[10]{0}$ m³ and f₁ 15=4. The internal viscosity ⁰ is due to a combination of the cytoplasm viscosity and the membrane viscosity. The dissipation due to the membrane viscosity has been shown experimentally to be between 2 and 4 times the dissipation in the cytoplasm [8, 9], and we choose the value ⁰ = 4 _{interior} =

4 10° Pa scorresponding a membrane dissipation equal to three times the dissipation in the cytoplasm. Fischer's data show the maximum tank-treading frequency to be approximately $0.25s^1$ so that

We can now estimate the amount of strain corresponding to the stored energy E_0 . The properties of the red blood cellmem brane are determined by both the phospholipid bilayer and the adjacent protein network. The high resistance to change in membrane surface area insures that shear (area preserving) deformations dominate. The resistance to shear and the shape memory are most likely due to the underlying protein network [6]. For a membrane of shear modulus $E_s = 6 = 10$ N/m [10] covering a surface S = 1 = 10° m² and undergoing a shear strain u the elastic energy is approximately $E_0 = \frac{E_s u^2 S}{2}$. Equation (5) then yields the characteristic shear strain u = 0.2, a reasonable value.

Equating the rate of work by the external uid 2 with the internal dissipation (3) and the rate of elastic energy storage (4) yields

where = 0 is the viscosity ratio and $U_{e} = \frac{E_{0}}{V_{-}f_{3}}$ is the ratio of the change in the elastic energy to the work done by the external uid during a rotation, i.e., how sti the cell or capsule is relative to the forcing from the external shear ow. Scaling time, t = T = _, yields the dimensionless system of equations for and

The system's behavior is now completely determined by U_e , , and the geometric ratios $a_1=a_2$, $a_1=a_3$. A lthough observations of microcapsules have shown that the capsule geometry oscillates periodically during tank-treading [4, 11], periodic changes in axes length have little impact on solutions of (8).

A simple way to understand the relationship between the tank-treading and oscillation periods is to expand (8) using U_e as a small parameter: $= _0 + U_{e 1}$, $= _0 + U_{e 1}$.

The O (U_e^0) solution recovers the case studied by K eller and Skalak [2], where the tumbling transition is induced via an increase in the viscosity ratio and the steady solution is described by the constant orientation angle $_0$ and the tank-treading frequency $(e_T_0 = !. The O (U_e^1))$ perturbation to this steady state is $_1 = csin(2!T)$, where the constant c and the phase lag between the elastic energy and the orientation angle depend on the specific c parameters of the system . Hence, $=_0 + U_e csin(2!T)$ and the two minim a of the elastic energy in each tank-treading cycle cause the system to oscillate twice about a xed angle in the time it takes a surface element to tank-tread back to its initial position. This elect is illustrated in

gures 1b and 1c and solutions of \$) show that it is also true for large am plitude oscillations. Slightly non-spherical polyam ide m icrocapsules [4, 5] and num erical simulations of slightly non-spherical liquid capsules enclosed by elastic membranes [12] in shear ow have shown oscillations at frequencies twice the tank-treading frequencies.

The transition to tumbling behavior at low shear rates occurs when the uid shear stress acting on the particle is no longer su cient to force the membrane to tank-tread up the elastic energy gradient. The surface velocity decreases and the capsule 'solidies' and begins to tumble. In contrast to the tank-trading-to-tumbling transition for a purely viscous drop described by K eller and Skalak [2], in which there is no dependence on the shear rate, the transition described here depends on the shear rate since $U_e = 1=$. The transition point is a function of the system parameters: $U_{ec}(;\frac{a_1}{a_2};\frac{a_1}{a_3})$. Figure 2 illustrates the tank-treading-to-tum bling transition for the geometric ($a_1=a_2=4$, $a_1=a_3=1$) and elastic ($E_0 = 10^{17}$ J) parameters of a red blood cell in mersed in a viscous uid (= 1.5) being forced at a variable shear rate.

Beyond the critical shear rate the system exhibits type I interm ittent behavior [13, 14], i.e. a series of oscillations followed by a tumble followed by another series of oscillations and so on. This transition is most easily understood by studying the return m ap onto the line = 0 in the - plane modulo . For the initial condition = $_0$, = 0 the trajectory crosses the = 0 line again at F ($_0$), thus de ning the return m ap. Periodic trajectories appear as xed points in the return m ap F ($_0$) = $_0$ and the tank-treading-to-tum bling transition occurs via a saddle-node bifurcation in which an unstable limit cycle and a stable limit cycle coalesce and disappear. Near the bifurcation U_e U_{ec} 1 and we expand the return m ap about , where F ($_0$) $_0$ is sm allest, so that

where and are constants. Taking $_{n}$ to be the angle after n applications of the m ap F, we see that in the vicinity of the construction, where $F(_{0})_{0}$ and $(_{0}_{0})^{2}_{1}$, the system exhibits nearly periodic oscillations and $_{n}$ n (U $_{ec}$). When $(_{n}_{n})^{2}$ (U $_{ec}$) the system has left the construction and interm ittent behavior occurs. Hence, the number of iterations of the m ap prior to the interm ittent behavior scales as

as seen in gure 4. A s U_e is increased further the system enters a regime where the interm ittent behavior consists of a series of tumbles followed by a tank-treading revolution. Finally for U_e > U_{ec} the system fails to exhibit full tank-treading rotations and simply tumbles. In this case, the relevant return m ap is onto the line = 0 in the plane, so that for the initial condition = 0, = 0 the trajectory crosses the = 0 line again at F (0). This transition is also a type I interm ittent transition caused by the coalescence of two lim it cycles. The phase diagram illustrating the di erent regimes is shown for both the capsule and red blood cell geometries in gure 3. The insets in gure 3 show the return m ap in di erent regions and two examples of interm ittent trajectories.

By modifying (4) to include visco-elastic membrane properties, our framework can also account for the shear ow induced oscillations observed for oil drops coated with a viscoelastic protein layer [11, 15]. The details of the behavior discussed in this letter, particularly in and around the intermittent regime, are sensitive to parameter values. Therefore, mechanical characteristics of cells and capsules could potentially be deduced from observations of such behavior.




FIG.1: (a) Schem atic diagram of a tank-treading red blood cell (left) and capsule (right) in m ersed in a uid of viscosity that is being sheared at a rate _. The viscosity of the uid inside the cell or capsule is ⁰ so that the viscosity ratio is = ⁰= . de nes the orientation to the shear ow, V_{tt} is the surface velocity due to tank-treading, and de nes the m em brane orientation to the axes. The red blood cell and capsule are m odeled as ellipsoids of axes a_i . U_e is the dimensionless ratio of the resistance of the elastic m em brane to deform ation to the surface stress applied by the external uid.




FIG. 2: Red blood cell dynamics. For a red blood cell geometry $(a_1=a_2 = 4, a_1=a_3 = 1)$ and elasticity [6] (see text) with a viscosity ratio = 1:5 a novel transition from tank-treading to tum bling is predicted as the shear rate is decreased. For _> _c the mem brane tank treads and the cell orientation oscillates with amplitude and average that depend on _. For _< _c the cell tum bles and the orientation of the mem brane relative to its unperturbed position oscillates. For _c < _< _c the cell exhibits intermittent behavior, with a series of tank-treading revolutions followed by a tum ble or a series of tum bles followed by a revolution. Insets show the dynam ical regimes for _= 2;1:35;0:5.




FIG. 3: Phase diagram for the red blood cell ($a_1=a_2 = 4$, $a_1=a_3 = 1$) and capsule ($a_1=a_2 = a_1=a_3 = 1$:1) geometries. For a given geometry, the system behavior is determined by U_e , the dimensionless ratio of the elastic resistance to tank-treading divided by surface stress from the external ow, and , the ratio of internal to external viscosity. For the red blood cell geometry, the insets (= 1.5; $U_e = 0.6557$; 0.65) show how the return m ap (F ($_0$) gives the value of when the trajectory modulo beginning at $= _0$; = 0 again crosses = 0) changes as the system crosses the boundary between tank-treading and intermittent regions. The stable and unstable xed points of the return m ap coalesce in a saddle-node bifurcation and intermittent behavior ensues. Similarly, for the capsule geometry a return m ap is shown for for = 20; $U_e = 0.6$; 0.37. Both transitions occur for the two geometries investigated.




FIG.4: Type I interm ittency: n is the number of tank-treading oscillations per tumble; U_e U_{ec} is the difference between U_e and its value at the boundary between the tank-treading and the interm ittent regions. The plot is shown for = 1.5 and a red blood cell geometry ($a_1=a_2=4$, $a_1=a_3=1$). The -1/2 slope on a log-log plot is indicative of Type I interm ittency [14] (see text), indicating the coalescence of two limit cycles, which appear as xed points on the return m ap of gure 3.
