Phonon-induced relaxation of a two-state system in solids

W e study phonon-induced relaxation of quantum states of a particle (e.g., electron or proton) in a rigid double-well potential in a solid. Relaxation rate due to Ram an two-phonon processes have been computed. We show that in a two-state lim it, sym metry arguments allow one to express these rates in terms of independently measurable parameters. In general, the two-phonon processes dom inate relaxation at higher temperature. Due to parity e ect in a biased two-state system, their rate can be controlled by the bias.

I. IN TRODUCTION

Relaxation and decoherence in a two state system coupled to environment is a fundamental problem of quantum physics. It was intensively studied in the past; see, e.g., the review of Leggett et al. [1]. In the last years the interest to this problem has been revived by the e ort to build solid state qubits. Recently, symmetry implications have been considered for the problem of a particle in a rigid double-well potential em bedded in a solid [2]. It was dem onstrated that sym m etry argum ents allow one to obtain parameter-free lower bound on the relaxation of quantum oscillations in a rigid double well, caused by the elastic environm ent. One of the argum ents is that the double-wellpotential form ed by the local arrangem ent of atom s in a solid is de ned in the coordinate fram e of that local atom ic environm ent, not in the laboratory fram e. A nother argum ent is that interactions of the tunneling variable with phonons must be invariant with respect to global translations and rotations. W hen these argum ents were taken into account, a simple universal result for the relaxation rate was obtained [2] in term s of m easurable constants of the solid, with no unknown interaction constants.

The above m entioned universal result refers to the low tem perature lim it when the relaxation of a two state system is dominated by the decay of the excited state due to the emission of one phonon. In this paper we extend the method developed in Ref. 2 to the study of two-phonon Raman processes in double-well structures [3, 4, 5, 6, 7, 8]. Such processes can dom inate relaxation at higher tem peratures [9, 10, 11]. We will show that in the tem perature range bounded by the level splitting from below and by the Debye tem perature from above, the rate of the Ram an process for a biased rigid double well is given by a universal expression, very much like the rate of the direct one-phonon process. The R am an rate is proportional to the seventh power of tem perature, while the one-phonon rate is linear on tem perature. Interestingly, how ever, at sm all bias, the R am an rate, unlike the one-phonon rate, is proportional to the square of the bias. Consequently Ram an processes can be switched on and o by controlling the bias. This universal result, which is

a consequence of the parity of quantum states, must have important implications for solid-state qubits at elevated temperatures. Indeed, for an electron in a quantum dot, the rate of a direct one-phonon process is usually sm all. If the rate of a two-phonon process can be made sm all as well, this means that one can eliminate phonons as a signi cant source of relaxation and decoherence of the electron states in solid-state qubits.

II. PARTICLE AND PHONONS

Throughout this paper we shall use units where $\sim = k_B = 1$ unless stated otherwise. In the absence of phonons, the H am iltonian in the laboratory frame is

where r is the radius vector, p is the m om entum, and m is the mass of the particle (e.g., electron). A long-wave phonon described by the displacement eld u (r) translates the rigid double well in space. The H am iltonian of the system (including the free phonon eld) in the laboratory fram e becomes

Here, H_{ph} is the Hamiltonian of the free phonon eld. We intend to obtain a Hamiltonian of the form $H = H_{o} + H_{ph} + H_{e}$ where the last term describes the interaction of phonons with the electron in the double well potential. Using the fact that u is small, one can expand V (r u) in Taylor series to obtain

The st three terms form the interaction-free part of the total H am iltonian. The rest of the terms containing powers of u comprise the electron phonon interaction. It is clear that Eq. (3) requires detailed know ledge of the potential and its derivatives. One can, how ever, obtain Eq. (2) by perform ing a unitary transform ation on Eq. (1) with the help of translation operator $R = e^{ip}$

W orking out the commutators brings one back to Eq. (3). However, the use of Eq. (5) that we are going to employ allows one to obtain parameter-free results solely in terms of the energy levels of our elective two-state system without know ledge of the explicit form of V (r).

We consider the case in which the particle, with good accuracy, is localized near $r=R_{\rm o}$, where $R_{\rm o}$ are the energy m inim a of the left or right wells. W ithout loss of generality we assume that $R_{\rm o}=X_{\rm o}e_x$. The localization length of the state inside each well is sm all compared to the distance between the m inim a of the double-well potential. The bare ground states (when tunneling is neglected) in the left and right wells, that we denote by j $X_{\rm o}i$, are approximately orthonormal,

The tunneling between the wells leads to the hybridization of the states given by orthonorm alwave functions

with $_{\circ}$ being the tunnel splitting in the unbiased double welland "being the energy bias between the wells. Note that the double well also has states, j i, with energies, E, other then E corresponding to j i. The energy splitting

is considered small compared to the distance from E to other E . As we shall see, in this limit the sum mation over all states j i renders result for phonon-induced transitions between j i that is insensitive to the explicit form of the potential.

Below we shall deal with the matrix elements of operators p_{k} , x, and their combinations. O ther components of p and r are irrelevant. Localization of j i allow s one to compute matrix elements of powers of the operator x with the help of the relation

This is a mechanism of elimination of unspecied energy levels E from the problem, leading to a universal result.

III. RAMAN MATRIX ELEMENT

W e are interested in the transition rate between the eigenstates of H $_{\rm o}$ + H $_{\rm ph}$

Here, j i are the tunnel split states of the double well given by Eq. (7). The states j i are the eigenstates of H $_{\rm ph}$ with energies $E_{\rm ph}$; . Our goal is to study R am an scattering processes involving absorption of a phonon of frequency ! $_{\rm k}$ and em ission of a phonon of frequency ! $_{\rm g}$ = ! $_{\rm k}$ + , accompanied by the transition of the particle j + i ! j i; see Figl. The R am an rate can be computed with the help of the Ferm i golden rule in the second order in the interaction. The m atrix elements,




FIG.1: Ram an process on tunnel-split levels in a double-well potential, including virtual transitions to higher levels E [the rst term in Eq. (24) shown].

Here, j is a direct product of the eigenstates of H $_{\rm o}$ with the phonon states $j_{\rm k}$ 1;n_q i in the rst term and $j_{\rm k}$;n_q + 1 i in the second term.

First, we calculate the phonon parts of M $^{(2)}$ and M $^{(1+1)}$ using canonical quantization of the phonon displacements [13]

A common m istake that propagates through literature [14] is summation of rates due to M $^{(2)}$ and M $^{(1+1)}$, instead of adding matrix elements instand then squaring the result and computing the rate. Thism istake is not innocent since M $^{(2)}$ and M $^{(1+1)}$ may cancel leading parts of each other. Taking into account conservation of energy $!_{\rm q}$ = $!_{\rm k}$ + and the relation E = E_+ , one can rewrite this expression as

IV. RAMAN TRANSITION RATE

A coording to the Ferm i golden rule [12] the Ram an rate is given by

V. DOT FRAME CALCULATION

In this section we will check our result by calculating the R am an rate in the fram e of reference of the dot, as it was done for one-phonon processes [2]. In the laboratory fram e the Lagrangian of the particle is

where r^0 is the radius vector of the particle of mass m in the coordinate frame rigidly coupled to the double well. The linear momentum that is canonically conjugated to r^0 is given by

which coincides with Eq. (30) up to an insigni cant phase.

VI. DISCUSSION

W e have dem onstrated that the two-phonon relaxation of the tunnel-split states of a particle in a biased solidstate double-well potential can be expressed in terms of independently measured parameters and without any unknown constants. Two-phonon processes may dom inate relaxation at elevated temperatures (see below). An interesting observation, how ever, is that at a sm allbias the rate of Eq. (41) is proportional to "², while at a large bias it becomes independent of ". This means that one can switch R am an processes on and o by controlling the bias. This result may seem strange at rst, how ever, it is a fundamental consequence of quantum mechanics. The reason for this e ect is parity. If we remove the bias, the potential well will become symmetric. Consequently, the H am iltonian and the parity operator commute which leads to eigenstates of even or odd parity. It is easy to see that the states j i and j_+i at " = 0 have even and odd parity, respectively. Therefore, the matrix elements in Eq. (24) will all vanish.

To nd the range of param eters where two-phonon relaxation becomes in portant, the rate of the R am an processes should be compared with one-phonon transition rate [2] that can be written in the form

Notice that Eqs. (49) and (49) do not contain any unknown interaction parameters. The quantity of interest is the ratio $_2=_1$ which can tell us the importance of the second order process versus the rst order process at various temperatures. If we take T > , the coth (=2T) in Eq. (41) can be replaced by 2T= . The abovem entioned ratio then yields

10 nm embedded in (or deposited on) a solid with Χo 5 g= cm^3 and v_t 10³ m/s, parameter E_t is of order $_{\circ}$ 1 K, R am an processes, 300 K. Then, for, e.g., " according to Eq. (50), will dom inate electron-phonon relaxation above 33 K, while below that tem perature the relaxation will be dom inated by direct processes. The actual phonon rates for an electron are not likely to ex $ceed \ 10^6 \ s^{-1}$ even at T 100 K. For a proton in a molecular double well with X o 0:3 nm in a solid with 5 g/cm^3 and $v_t = 10^3 \text{ m/s}$, one gets E_t 40 K.At " 1 mK, according to Eq. (50), Ram an pro-0 cesses will dom inate proton-phonon relaxation above 1 K, while direct processes will dom inate relaxation in the m illikelvin range.

Finally we should note that since our model is based upon bare quantum states that are well localized in space, it is rigorous for heavy particles, like, e.g., a proton or an interstitial atom, but is less rigorous for such a light particle as an electron. Nevertheless, even for an electron our form ulas should provide a good approximation in the limit of weak tunneling between the wells. Note also that at a large tunnel splitting, the actual rates for a heavy particle like proton, interstitial atom or defect, can become so large that the approximation based upon Ferm i golden rule will no longer apply [16]. Even in this case, how ever, the matrix elements can be expressed in term s of measurable parameters of the quantum well and the solid.
