# X-ray Resonant M agnetic Scattering : Polarisation D ependence in the non-spherical case.

#### Abstract

W e develop a sim ple tensorialcontraction $m$ ethod to obtain analytical form ula for $X$-ray resonant magnetic scattering.W e apply the $m$ ethod considering rst electric dipole-dipole and electric quadrupolequadrupole scattering in the isolated atom approxim ation and com pare the results with previous works. Then we apply the $m$ ethod to derive phenom enological original form ulas which account also for nonspherical system $s$ and for dipole-quadrupole mixing.

1 INTRODUCTION

X -ray m agnetic scattering exhibits huge enhancem ent at resonances corresponding to localized electronic states [1,2]. Because of its coherent nature and dependence on polarisation, $X$-ray resonant $m$ agnetic scattering (XRM S) can be used to determ ine both spatial distribution and orientation ofm atter m agnetisation.

To design experim ents and analyse data, there is a strong need for sim ple analytical form ula which directly relate the experim ental geom etry and sam ple orientation to the $m$ easured scattered intensity.

Simple form ula for RM XS amplitude can be found in the literature w ith the approxim ation ofsphericalatom s[3].

They are com posed of a sum of term $s$, each term being the product of a geom etrical expression, containing polarisations, m ultiplied by a com plex valued function of energy. In a phenom enological analysys, where one is interested in separating the di erent contributions to the spectra, one can take theses com plex valued function as free param eters, under the constraint that dispersion relation are satis ed.

W e derive a sim ple and understandable theoretical fram ew ork w ithin which we recover previous X RM S form ula and then we extend such form ula to non-sphericalsystem s.

## 2 introduction to scattering factors

The interaction betw een $m$ atter and a photon described by a wave vector $k$ and polarisation , is written, discarding elastic $T$ hom son scattering (the $A^{2}(r)$ term in the Schroedinger equation which becom es dom inant oresonance), and discarding also the spin magnetic eld interaction [4], as :

$w$ here $r$ is the electron coordinate, $p$ the kinetic $m o-$ m ent, $\mathrm{a}^{\mathrm{y}}{ }_{\mathrm{k}}$; , $\mathrm{a}_{\mathrm{k}}$; are creation annihilation photon operators, $!=k c$, and $V$ is the space volum e.

The photon-photon resonant scattering is a second order perturbative process whose resonating am plitude per unit of time, for initial $; k$ and nal ${ }^{0} ; k^{0}$ states, is $o b-$ tained from $H_{\text {int }} m$ atrix elem ents as:

A s we are going to describe atom s as sphericalentities plus som e kind of distortion it is interesting to consider the spherical group and how the angular part of the different term s of Eq. 6 decom pose on the irreducible representations of such a group. The scalar product r can be rew ritten as a sum of products of rank 1 spherical harm onics tensors com ponents:

W e see from Eq. 10 that spherical tensorial com ponents of the tensor product $k$ are coupled to sam e rank com ponents of the product $r$ r form a scalar. As the product $r$ r has no antisym $m$ etric com ponent the rank 1 com ponents of the product $k$ do not appear in Eq 10 .

The transform ations expressed by E qs. 9,11 are used to sim plify the scattering factor expression by choosing the angular $m$ om ent quantisation axis in the $m$ ost appropriate way. In the next section we consider a spherical system pertubed by a m agnetic exchange interaction
while in section 4 we consider a non-spherical perturbation term and derive a phenom enological expression for the $m$ agnetic scattering am plitude.

3 derivation of form ula for the spherical case w ith a m agnetic eld perturbation $-$

In the case of a spherical atom perturbed by a magnetic exchange eld the nal scattering am plitude expression does not $m$ ix dipolar w ith quadrupolar tem s because of parity conservation. $W$ e take the angular $m$ om ent quantisation axis ${ }^{\wedge}$, along the magnetic eld. Term shaving di erent quantisation num ber $q \mathrm{w}$ ill not m ix. T he expression for scattering then assum es the follow ing sim ple form
:

In the spherically sym $m$ etric case (no $m$ agnetic eld) the $F_{1 ; q}$ and $F_{2 ; q}$ are independent of $q$. The introduction of a magnetic eld introduces a $q$ dependence in the scattering factors that can be expanded as a polynom ial in the quantisation num ber q :

$w$ here the sym bolC $m$ eans the sum ofallpossible contractions of the two vectors ${ }^{0}$ and $k^{0} w$ th the expression to their right. A contraction is realised by coupling by pairs the 2 N vectors which enter the expression, where 2 N is the sum of the tensors ranks. E ach vectors couple is then contracted, the result being the scalar product, and the N scalar products are m ultiplied together to give the nal result. The contraction of a tensor of de ned rank with itself $m$ ust not be considered.

For dipolar scattering we have therefore

## 4 N on spherical case.

In this section we develop a phenom enological form alism for resonant $m$ agnetic scattering in the non-spherical case. O ur starting point is crystal eld theory where the non sphericity of the atom ic environm ent is represented by a one-particle m ean eld potential which is added to the atom ic H am iltonian. Such an approach, pioneered by the w orks of B equerel [5], B ethe [6], K ram ens 7] and van V leck [8], w as applied to the calculation of x-ray absonption spectra and scattering factors for the rst tim e by van der Laan and T hole[1].

The crystal eld $T$ is given by a supenposition of sphericaltensors :

The tensor T m ust be invariant under all operations of the point sym $m$ etry group of the system [2].

W e treat perturbatively the crystal eld correction to scattering am plitude considering a process, in one-particle approxim ation, w here an electron is prom oted from a closed shell state, denoted by $n_{g} I_{9} \frac{1}{2} ; J_{a} j_{z}$, to the interm ediate states $\operatorname{nn}_{\mathrm{a}} \mathrm{l}_{\mathrm{a}} \mathrm{m} \mathrm{az}$ i $\frac{1}{2}$ and $\dot{n}_{\mathrm{b}} \operatorname{lom}_{\mathrm{bz}}$ i $\frac{1}{2}$ oftwo opens shells $\left(\mathrm{n}_{\mathrm{a}} ; I_{a}\right)$ and $\left(\mathrm{n}_{\mathrm{b}} ; l_{\mathrm{b}}\right)$. T he perturbation T has m atrix elem ents which mix the two shells.

T he electron-photon interaction is represented by the tensors $P^{0}=P\left({ }^{0} ; k^{0}\right)$ for the outgoing photon, and $P$ for the incom ing one.

In this expression the factor $f_{b}(m ;)$, or $f_{a}(m ;)$, contains im plicitely the electron propagator for the spherical atom and accounts also for the orbital occupancies.

Starting from this expression we can arrive at a contracted form which contains, beside polarisation vectors and the $m$ agnetisation axis, the $T$ tensor representing the crystal eld, and the spherical tensors $\mathrm{T}_{\mathrm{m}}^{\mathrm{l}_{\mathrm{g}}}$ representing the core state. $T$ he perturbative process concems interm ediate levels of well de ned angular $m$ om ent $l_{a}$ and $l_{0}$. This im poses a restrictions on the possible contractions : the transition due to a $P$ tensor from the $L=I_{g}$ ground state to the $L=l_{n}$ excited levels implies that exactly $\left(l_{g}+\operatorname{rank}(P) \quad l_{n}\right)=2$ contractions $m$ ust be taken betw een the tensor and the inital ground state. O ur one-particle approxim ation neglects the energy spread of the interm ediate states due to $m$ any-body e ect and is therefore sim ilar to the fast-collision approxim ation em ployed by $M$ arri and C arra for the case of dipole-quadrupole scattering in a m agnetoelectric crystals [9].

A form alderivation of these contraction rules is given in appendix A.

A s an exam ple we give a specialised expression for the $L_{3}$ edge. W e give in table 1 the coe cients $c^{2}\left(j_{z} ;\right)$. It is usefulto notige that for a given $m_{z}=j_{z}$ the sum oftwo coe cients of opposite spin is constant and equal to $4=3$, while the di erence goes from $2=3$ to $2=3 \mathrm{w}$ ith a linear dependence on $\mathrm{m}_{\mathrm{z}}$. This behaviourdoes not depend on the particular edge that $w$ e have considered. In general, for an edge e, we can alw ays w rite : $c^{2}\left(m_{z}+;\right)=l_{e}+2 s_{e} m_{z}$ where $l_{e}$ and $s_{e}$ are constants which depend on the edge. For exam ple, at $L_{3}$, w e have $l_{e}=2=3$ and $s_{e}=1=3$, while at $L_{2} l_{e}=1=3$ and $s_{e}=1=6$.

In the second term we have converted the $\mathrm{m}_{\mathrm{z}}$ quantization num ber into the operator ( $i_{m}$ ) at the left of the corehole orbitals. O nce contracted, the above form ula gives in the general case a com plicated expression.

H ow ever for term swhich are zero and rst order in ( $i_{m}$ ), the sum over corehole orbitals can be sim pli ed in an elegant way.

T he zero order tem s describe anysotropy of the crystal eld. The rst order one describe crystal eld induced corrections to the $m$ agnetic scattering.

C onceming the zero order term S , we notice that such sum looks like a trace. In otherw ords if, in a given contraction diagram, a vector $A$ is contracted $w$ ith the ket ground orbital, and another vector $B$ is contracted $w$ th the sam $e$ bra core onbital the result is equivalent to a contraction of A w th B because the sum runs over a com plete basis of an irreducible supbspace.

C onceming the rst order tem S , ( $\mathrm{i}_{\mathrm{m}}$ ) operates either on the core-hole orbital, or on the interm ediate tensors ( $P, P^{0}$, and crystal eld tensor $T$ ).

The term swhere ( $i_{m}$ ) operates on the interm ediate tensors can be simpli ed as in the zero order case described above.

N ow we consider the term swhere one ( $i_{m}$ ) operates on the core-hole orbital. T he contraction diagram sarising from these term s can be split in two classes.

In the rst class ( $i_{m}$ ) operates on a core-hole vector and the result is contracted w ith another core-hole vector. This class gives zero contribution because ( $i_{m}$ ) is an antisym $m$ etric operator.

The second class is given by the rem aining term s w hich contain the factorv $\left(\left(i_{n} \quad\right) h\right)$, where $v$ is a vector which enters the com position of an interm ediate tensors and $h$ enters the com position of the core-hole tensor. This factor can be rew ritten as ( $\left.\left.i_{m}\right) \mathrm{v}\right) \mathrm{h}$ and once again the sum over the core-hole orbitals disappear from the nal expression.

The general expression for scattering am plitude, up to rst order in ( $i_{m}$ ) is therefore:

$w$ here the $a_{n_{a} ; n_{b}}$ depends linearly on the $f$ electron propagators and the exact linearity coe cients can be found working out the contraction diagram $s$.

For higher order term $s$ this simpli cation is no $m$ ore appliable in the sam e easy w ay. O ne could still w rite contractions where the core-hole tensor disappear but the form ula would be com plicate by the fact that when one rew rites $v \quad\left(\left(i_{n} \quad\right)^{2} h\right)$ as $\left(\left(i_{m} \quad\right)^{2} v\right) \quad h$, the $\left(i_{n} \quad\right)^{2} o p-$ erator cannot be factored out of the tensor com posed by v because

The core orbital disappears from the nal expression because, in our approxim ation, our $\mathrm{L}_{3}$ core state in Eq. 21 is not coupled to the valence orbitals. Such an approxim a-
tion isvalid for the hard $x$-rays dom ain w here the core-hole is deep.

For the sake of sim plicity, in the follow ing, exam ples we lim it ourself to consider only zero and rst order contributions.

### 4.1 Application $M$ agnetic di raction am plitude for

 spiral antiferrom agnetic holm iumW e consider the case of holm ium. The holm ium crystal has a hqp structure where the atom $s$ are em bedded in a locald 3 h sym $m$ etry environm ent.

Taking a cartesian $x ; y ; z$ fram $e w$ ith $x$ along the hqp a axis:

where the rst om itted term of the serie is a rank 4 com ponent. T he signs altemate from one ab plane to the other.

The contribution of the ( $2 z^{2} \quad x^{2} \quad y^{2}$ ), is centrosym $m$ etric. So we consider separately the dipole-dipole and the quadrupole-quadrupole scattering. W ithin the fram ework of our sim plifying assum ption (equation 26) we nd that the dipole-dipole scattering correction is proportional to

$T$ he second term of this expression $m$ erges $w$ th the previously found form for the scattering in the sphericalapproxim ation. But the rst term contains two scalar products w th the z axis and this adds com plexity to the am plitude dependence on experim ental geom etry.

T he quadrupole-quadrupole scattering, discarding those term $s$ that can be m erged w ith the spherical form ulas, has the form :

this term also contains two scalar products w ith the z axis adding com plexity to the am plitude dependence on experim ental geom etry.
$T$ hese term s contribute, in our system, to the am plitude of the $2 n \quad q B$ ragg orders di raction peaks, $n$ and q being the antiferrom agnetic $w$ avevectors. In an experi$m$ ent which $m$ easures several $2 n \quad q B$ ragg order di raction peaks, the incidence angle $m$ ay vary considerably from one order to the others, and therefore we predict that the inclusion of our correction could im prove the $t$.

The scattering factor contribution from the altemating term $\quad\left(x^{2} \quad 3 x y^{2}\right)$ gives di raction peaks at $2 n+1+m q$ orders, $n$ and $m$ being integers and $q$ being the antiferrom agnetic wavevector. To sim plify the follow ing treate$m$ ent, and to give an exam ple of a term contributing to the $2 \mathrm{n}+1+\mathrm{q}$ scattering, we considerm agnetisation in the xy plane and we lim it here to the case where, in equation 26, only the $\mathrm{n}_{\mathrm{a}}=1, \mathrm{n}_{\mathrm{b}}=0$ term is considered. W e apply the contraction rules to form ula 26 where $P^{0}$ and $P$ are and $k$ tensors respectively. In this we get case a

## 5 C onclusions

W e have established a contraction $m$ ethod by which we obtain phenom enologicalanalytical expressions for the scattering factors in term s of scalar and vectors products of the polarisation vectors, of the $m$ agnetisation axis and of the vectors de ning the crystal eld tensor. U sing a perturbative approach we have been able to go beyond the usualSo 2 approxim ation [3] considering sim ultaneaously the $m$ agnetisation and a general crystal eld tensor. O ur m ethod is a viable diagram $m$ atic technique based on contraction betw een vectors. $W$ ith ourm ethod usefiulform ula can be straightforw ardly obtained in term s of the polarisation vectors, the crystal eld vectors and the $m$ agnetisation direction.
occurring at $2 \mathrm{n}+1+\mathrm{mq}$ B ragg orders. O ur work com pletes the H ill \& M CM orrow one[3].

In this expression, when $v=0$ only the term $s$ fully contracted rem ain because if $a_{1} @$ takes down n v=2 factor from the exponent, another $a_{m} @ m$ ust be used to derive this $\mathrm{v}=2$ factor which otherw ise gives zero contribution, and this gives the scalar product $a_{1} \quad$.

The interm ediate sum which appear in equation 22, can be considered as a pro jector $\mathrm{p}_{l_{a}}$ over a tensorial space of de nite rank $l_{a}$. T he pro jection over de nite rank space is obtained through the $j$ and $j$ constraint. $W$ hen applying contraction rules to expressions form ed by tensor of a de ned rank, one $m$ ust bear in $m$ ind that, by de nition, a de ned rank tensor gives zero when contracted w ith itself.
