Phonon B and Structure and Therm al Transport C orrelation in a

Layered D iatom ic C rystal

Abstract

To elucidate the relationship between a crystal's structure, its them al conductivity, and its phonon dispersion characteristics, an analysis is conducted on layered diatom ic Lennard-Jones crystals with various mass ratios. Lattice dynamics theory and molecular dynamics simulations are used to predict the phonon dispersion curves and the therm al conductivity. The layered structure generates directionally dependent therm alconductivities lower than those predicted by density trends alone. The dispersion characteristics are quanti ed using a set of novel band diagram m etrics, which are used to assess the contributions of acoustic phonons and optical phonons to the them al conductivity. The them al conductivity increases as the extent of the acoustic modes increases, and decreases as the extent of the stop bands increases. The sensitivity of the therm al conductivity to the band diagram metrics is highest at low temperatures, where there is less anharm onic scattering, indicating that dispersion plays a more prom inent role in therm al transport in that regime. We propose that the dispersion metrics (i) provide an indirect measure of the relative contributions of dispersion and anham onic scattering to the therm altransport, and (ii) uncouple the standard them al conductivity structure property relation to that of structure-dispersion and dispersion-property relations, providing opportunities for better understanding of the underlying physical mechanisms and a potential tool for material design.

I. IN TRODUCTION

Them al transport in a dielectric crystal is governed by phonon dispersion and phonon scattering.¹ The majority of theoretical studies of them al transport in dielectrics deal with phonon dispersion at a qualitative level. A common treatment is to assume that the contribution of optical phonons to the therm al conductivity is negligible because the associated dispersion branches are often at, implying low phonon group velocities. Theories that quantitatively relate dispersion characteristics to bulk therm al transport properties are limited. One example is the use of phonon dispersion curves to determ ine the phonon group and phase velocities required in the single mode relaxation time formulation of the Boltzmann transport equation (BTE).^{2,3} Even in such a case, the dispersion has traditionally been greatly simplified. The importance of accurately and completely incorporating dispersion into this BTE formulation has recently been investigated for bulk materials^{4,5} and for nanostructures.^{6,7}

D ong et al.⁸ report evidence of the in portant role that phonon dispersion plays in them al transport in their study of gem anium clathrates using molecular dynamics (MD) simulations. In their Fig: 1, they show phonon dispersion curves for a diamond structure, a clathrate cage, and the same cage structure but lled with weakly bonded guest strontium atom s that behave as \rattlers." W hile the range of frequencies accessed by the vibrational m odes in these three structures is comparable, the dispersion characteristics are quite different. The large unit cell of the clathrate cage signi cantly reduces the frequency range of the acoustic phonons, the carriers generally assumed to be most responsible for therm al transport. There is an accompanying factor of ten reduction in the thermal conductivity. In the lled cage, the encapsulated guest atom s have a natural frequency that cuts directly through the middle of what would be the acoustic phonon branches, and the value of the thermal conductivity is reduced by a further factor of ten. Experimental studies on lled cage-like structures have found similar results, i.e., that rattler atom s can reduce the thermal conductivity.^{9,10}

C onsidering phonon dispersion is also in portant in studying therm altransport in superlattices (SLs).^{11,12,13,14} U sing an inelastic phonon B oltzm ann approach to m odel anharm onic three-phonon scattering processes, B roido and R einecke¹¹ studied the therm al conductivity of a m odel two-m ass SL w ith a diam ond structure, and how it depends on the m ass ratio and

the layer thickness. A sthem ass ratio is increased, the dispersion curves atten, which tends to lower the therm al conductivity. At the same time, the increase in mass ratio reduces the cross section for Um klapp scattering, which tends to increase the therm al conductivity. The relative in portance of these two mechanisms is found to be a function of the layer thickness. U sing a kinetic theory model, Simkin and Mahan¹² found that as the layer thickness in a model SL is reduced, the therm al conductivity decreases due to an increase in ballistic scattering stemming from the rise in interface density. It was shown in the same study that as the layer thickness is further reduced to values su ciently smaller than the phonon mean free path, the therm al conductivity increases. This transition, which predicts a minimum SL therm al conductivity, was attributed to a shift from phonon transport best described by a particle theory to one that follows a wave theory. Thisminimum SL therm al conductivity has also been measured in experiments^{15,16,17} and predicted in MD simulations.¹³ The need for a wave treatment of phonons indicates that interference mechanisms a ect the phonon transport.

A part from the above mentioned e orts, few investigations have attempted to rigorously establish a connection between dispersion characteristics, which include the size and location of frequency bands (and stop bands), and them all transport properties. In this work we explore the three-way relationship in a crystal between: (i) the unit cell structure, (ii) the associated dispersion characteristics, and (iii) the bulk them all transport behavior using lattice dynamics calculations and M D simulations, as shown in Fig:1. The dispersion characteristics are quantiled using a new set of frequency band diagram metrics. As a starting point, we narrow our attention to a diatom ic Lennard-Jones (LJ) crystal that corresponds to a monolayer SL. The atom ic species are only dilerentiated by their masses. By modeling a simple system, phenomiena can be observed that might not be discernable in more complex structures. The overall them e of the investigation, however, is intended for dielectric crystals in general and the analysis tools developed are not limited to SLs.

The insights gained in this study could lead to the developm ent of a system atic technique for the atom ic-level design of materials with desired therm all transport properties. This capability could facilitate the introduction of novel, yet realizable, materials with very high, or low, therm all conductivities. Examples of applications include therm coelectric materials with high gure-of-merit, microelectronic devices enjoying enhanced cooling characteristics, and e cient therm all insulators for chemical processing.




FIG.1: Schem atic of the relationships between atom ic structure, dispersion characteristics, and them al conductivity. Shown are both the tools available for moving between these blocks (solid lines), and the links we are seeking to establish (dashed lines). Link A is discussed in Section III, link B in Section IV C, link C in Section V A, and link C in Section V B. In this investigation, we restrict our discussion of the lattice dynam ics to the phonon m ode frequencies.

W ebegin by presenting the diatom ic crystal structure and basic inform ation pertaining to the M D simulations. Phonon dispersion relations are then determ ined using lattice dynam – ics calculations and analyzed for di erent m ass ratios at various tem peratures. The band diagram m etrics are introduced and discussed. W e then use M D simulations and the G reen-K ubo (G K) m ethod to predict the therm al conductivities of these structures. D iscussion is presented with regards to the m agnitude of the therm al conductivity, its directional and tem perature dependencies, and relation to the unit cell. W e then explore the relationship between the therm al conductivity and the associated dispersion band structure. W e perform our study of the relationship between atom ic structure, phonon band structure, and therm al transport by considering m odel system s described by the LJ potential,

Here, $_{ij}$ is the potential energy associated with a pair of particles (i and j) separated by a distance r_{ij} , the potential well depth is $_{LJ}$, and the equilibrium pair separation is 2^{1-6} $_{LJ}$. The LJ potential is commonly used in investigations of thermal transport in bulk and composite system s.^{5,13,14,18,19,20,21,22,23} D in ensional quantities have been scaled for argon, for which $_{LJ}$ and $_{LJ}$ have values of 1:67 10²¹ J and 3:4 10¹⁰ m.²⁴ The argon m ass scale, m $_{LJ}$, is 6:63 10²⁶ kg (the m ass of one atom). Quantities reported in dimensionless LJ units are indicated by the superscript *.

The structure we consider is a simple-cubic crystal with a four-atom basis (unit cell) and lattice parameter a, as shown in Fig: 2. If the four atom sA-D are identical, the conventional unit-cell representation of the face-centered cubic (fcc) crystal structure is obtained. By taking two of the atom s in the basis (A, B) to have one mass, m_1 , and the other two (C, D) to have a di erent mass, m_2 , a crystal with alternating layers of atom s in the [010] direction [which we will refer to as the cross-plane (CP) direction] is created. We will refer to the [00] and [001] directions as the in-plane (IP) directions. This structure is a monolayer SL. The value of m_2 is xed at m_{LJ} , and the mass ratio R_m is de ned as

The symbolm will be used to denote the dimensionless mass of the atom s in a monatom ic system. It has a value of unity, unless noted. By varying only the atom ic masses, the LJ potential can be applied to this system without any modi cation. We primarily consider R_m values of 1 (the monatom ic unit cell), 2, 5, and 10. We note that this variation in atom ic masses is in the same spirit as the work of Broido and Reinecke¹¹ and Che et al.²⁵ who considered two-mass diamond systems. Their approach was dierent, though, in that they varied the mass ratio while keeping the density constant.

The MD simulations are performed in dimensionless LJ units. All results can be scaled to dimensional values using the parameters $_{LJ}$, $_{LJ}$, and m_{LJ} , and the Boltzm ann constant,




FIG.2: The four-atom unit-cell of the layered diatom ic crystal. If the four atom s are equivalent, the crystal structure is face centered cubic. If A and B have a di erent m ass than C and D, the crystal structure is simple cubic. The arrangement chosen leads to planes with a thickness of one atom ic layer stacked in the [010] (cross-plane) direction. (C olor online)

 k_B , which is part of the temperature scale, $_{\rm LJ}=k_B$. From dimensional analysis, it can be shown that the therm al conductivity of the $1=R_m\,$ system, $k_{1=R_m}$, is related to that of the $R_m\,$ system, k_{R_m} , through

Thus, one dimensionless simulation can be used to generate data for both the R_m system and the 1= R_m system . Where helpful, data corresponding to mass ratios of 0.5, 0.2, and 0.1 will be presented.

The purpose of the MD simulations is (i) to obtain the zero-pressure lattice parameter as a function of temperature (used in later simulations and for lattice dynamics calculations), and (ii) to predict the therm alconductivity. Because the functional form of the LJ potential is kept the same (we consider only di erent masses), the zero-pressure unit cell parameters remain unchanged from those for a single mass system.⁵

All reported MD results are generated from simulations run in the NVE (constant mass, volum e and energy) ensemble at zero pressure with a time step of 4.285 fs. The simulation cell contains 512 atoms (eight unit cells in the cross-plane direction, and four in the in-plane directions) and periodic boundary conditions are imposed in all three directions. This system size was found to be su cient to obtain computational dom ain-independent

them al conductivities. The MD procedures have been described in detail elsewhere.^{5,22,26} W e consider tem peratures, T, between 10 K and 80 K in 10 K increments. The melting tem – perature of the monatom ic system is 87 K. The data presented in the therm al conductivity analysis for a given parameter set (R_m , T, and the crystallographic direction) are obtained by averaging over ve independent simulations so as to get a representative sampling of phase space. In each of the ve simulations, information is obtained over one million time steps, after an equilibration period of ve hundred thousand time steps.

III. PHONON DISPERSION

The frequency (phonon) space characteristics of a solid phase can be determined with lattice dynamics calculations,²⁷ in which the real space coordinates (the positions) are transformed into the normal mode coordinates (the phonon modes). Each normal mode has a frequency, !, wave vector, , and polarization vector, e (which describes the mode shape). The available wave vectors are obtained from the crystal structure, and the frequencies and polarization vectors are found by solving the eigenvalue equation²⁷

where D () is the dynam ical matrix for the unit cell and the parameter identies the polarization for a given wave vector. The lattice dynamics methods used are reviewed in the Appendix.

The predictions of harmonic lattice dynamics calculations from Eq: (4) at zerotem perature are exact, and can be found using the equilibrium atom ic positions and the interatom ic potential. As the tem perature rises, the system will move away from the zerotem perature minimum of the potential energy surface. The lattice dynamics are a ected in two ways. First, the solid will either expand or contract. This e ect can be accounted for by using the nite-tem perature lattice constant in the harmonic lattice dynamics form ulation (the quasi-harmonic approximation).²⁷ Second, the motions of the atom s will lead to anharmonic interactions. These e ects cannot be easily accounted for in the form al lattice dynamics theory due to the di culty in incorporating third order (and higher) derivatives of the interatom ic potential. In an MD simulation, it is possible, with considerable e ort, to capture the true anharmonic lattice dynamics.⁵ For the purposes of this investigation,

however, we restrict the analysis to the quasi-harm onic formulation. Further discussion of this choice will follow where appropriate.

We now consider the relationship between the mass ratio R_m and the dispersion characteristics (A in Fig:1) by plotting a set of dispersion curves in Figs: 3 (a), 3 (b), and 3 (c). The plots in Fig:3 are of dimensionless frequency, $! = ! = (L_J = m_{LJ} \frac{2}{L_J})^{1=2}$, versus dimensionless wave number, de ned as = (2 = a). The zero-temperature phonon dispersion curves for the monatom ic ($R_m = 1$) unit cell in the [100] direction are shown in Fig: 3 (a). As this system has cubic isotropy, the dispersion characteristics are the same for the [010] and [001] directions. For the monatom ic crystal, the true B rillouin zone extends to a value of unity in the [100] direction and is a truncated octahedron. Here, to be consistent with the plots for the layered structure (where the B rillouin zone extends to a value of 0.5 and is cubic), the branches have been folded over at their m idpoints.

The zero-tem perature dispersion curves for the in-plane and cross-plane directions for the $R_m = 10$ unit cell are shown in Figs: 3 (b) and 3 (c). The anisotropy of the crystal structure is rejected in the directional dependence of the plotted dispersion curves. At non-unity m assistics, stop bands (band gaps) in the frequency spectra are evident, and grow as R_m is increased. A stop band in the in-plane direction opens when the m assistio is 1.17 and in the cross-plane direction when the m assistio is 1.62. The stop bands in Figs: 3 (b) and 3 (c) are shaded gray.

The dispersion curves plotted correspond to a crystal of in nite size, and are thus continuous. Due to the nite size of the simulation cell, only the modes at values of 0, 0.25 and 0.5 will be present in the MD simulations for the in-plane directions, and at values of 0, 0.125, 0.25, 0.375, and 0.5 for the cross-plane direction.

The maximum frequencies of the acoustic and optical branches at zero-temperature are plotted in Fig: 4(a) for R_m values between 0.1 and 10. The data for the in-plane and cross-plane directions are indistinguishable. Maximum frequency values for the monatom ic system are taken at values of 0.5 and 1 for the acoustic and optical branches. As the mass ratio is increased from unity, the maximum optical frequency decreases slightly and the maximum acoustic frequency decreases. As R_m is reduced below unity, the maximum optical frequency increases and them aximum acoustic frequency is essentially constant. The maximum optical frequency increases for small R_m because the lighter mass can oscillate at higher frequencies. These trends are qualitatively consistent with those predicted for a




FIG. 3: (a) Phonon dispersion curves for the monatom ic crystal. The dispersion characteristics are the same in the [100], [010], and [001] directions. A llbranches correspond to acoustic phonons, and have been folded over at = 0.5. Phonological persion curves for $R_m = 10$: (b) in-plane and (c) cross-plane directions. The maximum acoustic and optical frequencies are noted, and the stop




FIG. 4: (a) Maximum frequencies of the acoustic and optical branches plotted against the mass ratio R_m at zero temperature. The data in the in-plane and cross-plane directions are indistinguishable. (b) B reakdown of the frequency spectrum into the acoustic and optical pass bands (p_{ac} and p_{op}) and the stop bands, s_{all} . The p_{ac} curves for the two directions are indistinguishable. The data have been t with sm oothed curves to highlight the trends.

one-dimensional diatom ic system .28

The LJ system expands as its temperature is raised, causing the phonon frequencies to decrease. At a temperature of 80 K, the quasi-harmonic dispersion calculations for the monatom ic system give a maximum dimensionless frequency, $!_{opmax}$, of 16.6, compared to the zero-temperature maximum of 26.9. The temperature dependence of the maximum frequency is close to linear, and a similar percentage decrease is found for the non-unity mass ratios. The full anharmonic dispersion analysis for the monatom ic system at a temperature

of 80 K gives a maximum dimensionless frequency of 21.2.⁵ The discrepancy between the quasi-harm onic and anharm onic dispersion curves increases with increasing temperature and wave vectorm agnitude. For the majority of the data considered here, the expected di erence is less than 10%, which we take to be satisfactory in lieu of calculating the full anharm onic dispersion characteristics.

In later analysis, we will investigate the relationship between them alconductivity and the dispersion curves. To facilitate this analysis, we introduce three m etrics for the dispersion curves: p_{ac} , p_{op} , and s_{all} . The idea of param eterizing the frequency band structure has previously been applied in the area of elastodynam ics.²⁹ The rst of the m etrics, p_{ac} , is de ned as the fraction of the frequency spectrum taken up by the acoustic branches, i.e., $p_{ac} = !_{acm ax} = !_{opm ax}$. This is the acoustic phonon pass band. Sim ilarly, p_{op} represents the portion of the spectrum taken up by the optical branches [the optical-phonon pass band (s)]. We calculate p_{op} as $P_{i} p_{op}^{i}$, where the sum m ation is over the optical phonon bands, as shown in Figs: 3 (b) and 3 (c). The rest of the spectrum ism ade up of stop bands, whose contribution is given by $s_{all} = P_{i} s^{i}$, as shown in Figs: 3 (b) and 3 (c). Thus,

These three quantities are plotted as a function of the mass ratio for both the in-plane and cross-plane directions at zero temperature in Fig: 4(b). As the mass ratio increases, the acoustic phonons take up less of the spectrum (the results are essentially identical in the two directions), while the extent of the stop bands increases (more so in the cross-plane direction). The optical-phonon extent initially increases in both directions. This increase continues for the in-plane direction, but a decrease is found for the cross-plane direction, consistent with its larger stop band extent. The temperature dependence of p_{ac} , p_{op} , and s_{all} is small (1% change between temperatures of 0 K and 80 K).

IV. THERMAL CONDUCTIVITY

In this section we address the relationship between atom ic structure and therm al conductivity (B in Fig: 1), with m inim al consideration of the phonon dispersion.

A. Green-Kubomethod

The net ow of heat in the MD system, given by the heat current vector S, uctuates about zero at equilibrium. In the GK m ethod, the therm alconductivity is related to how long it takes for these uctuations to dissipate. For the layered crystal under consideration, the therm alconductivity w illbe an isotropic (di erent in the in-plane and cross-plane directions) and for a direction l w ill given by³⁰

where t is time and $hS_1(t)S_1(0)i$ is the heat current autocorrelation function (HCACF) for the direction 1. The heat current vector for a pair potential is given by³⁰

where E_i , r_i , and v_i are the energy, position vector, and velocity vector of particle i, and r_{ij} and F_{ij} are the inter-particle separation vector and force vector between particles i and j.

The most signi cant challenge in the implementation of the GK method is the specication of the integral in Eq: (6), which may not converge due to noise in the data. Such an event may be a result of not obtaining a proper sampling of the system's phase space, even when averaging over a number of long, independent simulations, as we have done here. Thus, it is not always possible to directly specify the therm al conductivity. As such, we also consider noting the therm al conductivity by thing the HCACF to a set of algebraic functions.

It has been show $n^{22,31}$ that the therm al conductivities of the monatom ic LJ fcc crystal and a fam ily of complex silica structures can be decomposed into contributions from short and long time-scale interactions by thing the HCACF to a function of the form

Here, the subscripts sh and lg refer to short-range and long-range, the A and B parameters are constants, and denotes a time constant. The summation in the optical phonon term corresponds to the peaks in the Fourier transform of the HCACF,³¹ where $!_{oprij1}$ is the

frequency of the jth peak in the lth direction. This term is used when appropriate (i.e., for crystals with more than one atom in the unit cell). Substituting Eq: (8) into Eq: (6),

Further details on the decomposition can be found elsewhere.^{22,31} In this investigation, a t of Eq: (8) was possible for all cases except the cross-plane direction for (i) $R_m = 5$ (T 60K) and (ii) $R_m = 10$ (T 40K). In these cases, the peak in the spectrum of the HCACF broadens to the point where it is no longer well represented by an exponentially decaying cosine function in the time coordinate.³² The agreem ent between the t therm al conductivity and that speci ed directly from the integral is generally within 10%. W hen available, the t values are reported.

B. Heat current autocorrelation function

The time dependence of the HCACF (norm alized by its zero-time value), and its integral (the therm al conductivity, norm alized by its converged value), are plotted for four cases at a tem perature of 20 K in Figs: 5(a), 5(b), 5(c), and 5(d).

The data in Fig: 5(a) correspond to the monatom ic system. The HCACF decays monotonically (sm all oscillations can be attributed to the periodic boundary conditions²⁶), and is well t by the sum of two decaying exponentials [the rst two terms in Eq: (8)]. Such behavior is found at all tem peratures considered for the monatom ic system.

The data in Figs: 5(b), 5(c), and 5(d) correspond to the cross-plane direction for R_m values of 2, 5, and 10. Signi cant oscillations in the HCACF are present, and grow as the mass ratio is increased. This is the e ect of the optical phonon modes.³¹ The HCACF can be t by Eq: (8), with one term taken in the optical summation (this is justified by the HCACF spectra shown later). The integrals in Figs: 5(c) and 5(d) converge at a longer time than shown in the plot. This result indicates that while the oscillations in the HCACF dom inate its magnitude, the contribution of the $k_{ac;lg}$ term to the thermal conductivity is signified at a xed temperature. For a xed mass ratio, increasing the temperature leads to a HCACF that decays faster. Fewer periods are captured in the decay,




FIG. 5: The HCACF and its integral (whose converged value is the therm al conductivity) for $R_m = (a) 1$, (b) 2, (c) 5, and (d) 10 at a tem perature of 20 K. The data for the latter three cases corresponds to the cross-plane direction. The HCACF is scaled against the zero time value, while the therm al conductivity is scaled against its converged long-time value. (C olor online)

which makes it harder to extract the oscillation frequency. Results for the in-plane direction are qualitatively similar.

In Fig: 6(a), the Fourier transform (FT) of the norm alized HCACF is plotted for m ass ratios of 2, 5, and 10 in the in-plane and cross-plane directions at a temperature of 20 K.Each of the spectra have a non-zero zero-frequency intercept, and a strong, single peak. This is in contrast to the FT of them onatom ic system, which decays monotonically from the zero-frequency value.²² The peaks fall within the range of the optical phonons, and the peak frequency is best found through the HCACF decom position. As the m ass ratio increases, the location of the peak frequency in each of the directions decreases, which is consistent with the trends in the dispersion curves plotted in Fig: 4 (a).

In Fig: 6 (b), the FT of the norm alized HCACF for a mass ratio of 5 in the cross-plane direction is plotted at temperatures of 20 K, 40 K, 60 K, and 80 K. As the temperature increases, the peak frequency decreases, consistent with the discussion of the e ects of temperature on phonon frequencies in Section III. The peak also broadens considerably and itsm agnitude decreases; the behavior is better described as broad-band excitation. It is this behavior that leads to the failure of the tting procedure under certain conditions. This broadening is not as signi cant for a mass ratio of 2. The origin of the peaks will be further discussed in Section V A.

C. Predictions

The them alconductivities predicted for the $R_m = 2$ system are plotted in Fig:7(a) along with the data for the monatom ic unit cell. A lso included in the plot are the predictions for a monatom ic cell with all atom s having a mass of 1.5 (i.e., $R_m = 1, m = 1.5$, giving the same density as the $R_m = 2$ system). These results are obtained by scaling the data from the $(R_m = 1, m = 1)$ system. While increasing the density lowers the therm alconductivity, the presence of the di erent masses has a more pronounced e ect for both the in-plane and cross-plane directions, with the form er being lower than the latter. The therm alconductivities for all cases considered in the cross-plane direction are plotted in Fig: 7(b). The data in Figs: 7(a) and 7(b) are twith power law functions to guide the eye. Due to the classical nature of the simulations, all the curves will go to in nity at zero tem perature (unlike experimental data, which peaks and then goes to zero at zero tem perature).




FIG. 6: HCACF frequency spectrum for (a) T = 20 K, mass ratios of 2, 5, and 10 in both the in-plane and cross-plane directions and (b) mass ratio of 5, cross-plane direction, for tem peratures of 20 K, 40 K, 60 K, and 80 K. (C olor online)

By considering the LJ therm alconductivity scale, $k_B = {2 \atop LJ} (L_J = m_{LJ})^{1=2}$, it can be deduced that the therm al conductivity of a monatom ic system where each atom has mass m is proportional to (m) $^{1=2}$. We will denote the k / (m) $^{1=2}$ behavior as the density trend. In Figs: 8 (a) and 8 (b), the therm al conductivities for mass ratios between 0.1 and 10 in both directions at temperatures of 10 K, 40 K, and 70 K are plotted as a function of the average




FIG. 7: (a) Therm al conductivity plotted as a function of tem perature for m ass ratios of 1 and 2. (b) Therm al conductivity in the cross-plane direction plotted as a function of tem perature for m ass ratios of 1, 2, 5, and 10. The data in both (a) and (b) are twith power-law functions to guide the eye.

dimensionless atom ic mass in the unit cell, m, given by

which is proportional to the system density. Also plotted for each data series in Figs: 8(a) and 8(b) is the therm al conductivity that would exist in an equivalent monatom ic crystal where all atom s have mass m (i.e., m = m). These are the solid lines in the plots,




FIG.8: Therm al conductivity at temperatures of 10 K, 40 K, and 70 K in the (a) in-plane and (b) cross-plane directions plotted as a function of the average atom ic mass in the system. Also plotted is the therm al conductivity of the equivalent monatom ic systems where each atom has a mass m (solid line). The dashed lines correspond to k / (m) $^{1=2}$, and are t to the data by visual inspection.

obtained by scaling the $(R_m = 1, m = 1)$ data point. The dashed lines in Figs: 8(a) and 8(b) correspond to k / (m) $^{1=2}$, and have been placed by eye to highlight trends. From these two plots, the relationships between the elects of temperature (i.e., anharm onicity and scattering), density, and the mass ratio become apparent.

In the in-plane direction [Fig: 8(a)], the therm al conductivity data converge towards the same density monatom ic system curve as the temperature is increased. At the high temperatures, the mass di erence plays no appreciable role, and the therm al conductivity only depends on density. At the lowest temperature, 10 K, the therm al conductivity data do not approach the monatom ic value, but do show the density-predicted trend at the large and sm all mass ratios. This di erence between the low and high temperature behaviors is due to the di erence in the degree of scattering. At high temperatures, the anharm onic e ects are strong and tend to override the structural e ects.

In the cross-plane direction, the data is never close to the sam e-density m onatom ic system, other than at $R_m = 1$. At the two low tem peratures, the data follow the density trend closely, but with values lower than the monatom ic system (this is a structural e ect). At the high tem perature, 70 K, there is an increase towards and decrease away from the $R_m = 1$ therm al conductivity value for increasing m ass ratio. Here, we hypothesize that the e ect of the increasing density is o set by the decrease in phonon scattering in the cross-plane direction as the two m asses in the system approach the sam e value.

The general trends in the in-plane and cross-plane directions are di erent: in the in-plane direction, higher temperature leads to the density trend and apparent structure independence, while in the cross-plane direction, the density trend is found at lower temperatures where structural e ects are in portant. W hile this di erence is most likely a result of the anisotropic nature of the system, the underlying reasons are not yet clear. Qualitatively, a therm al conductivity following the density trend suggests strong contributions from phonon m odes in which the atom s in the unit cellm ove cooperatively { a characteristic of the acoustic phonon m odes. In general, from these results we see that having a polyatom ic structure introduces additional decreases in therm al conductivity beyond that predicted by density trends.

V. CORRELATION BETWEEN PHONON BAND STRUCTURE AND THER-MALCONDUCTIVITY

In this section, we address the link between them al conductivity and phonon dispersion (C and C in Fig: 1), without explicit consideration of the atom ic structure.

A. Dispersion and HCACF

W hile peaks in the spectrum of the HCACF have been observed,^{8,25,31} no comprehensive explanation has been given for their origin. It has been hypothesized that they corresponded to optical phonons,^{31,33} due to their frequencies lying in that region of the phonon spectrum. Such a result is shown in Fig: 9(a), where the quasi-harm onic phonon dispersion curves for the in-plane direction are shown on top of the HCACF spectra for the in-plane and cross-




FIG.9: (a) In-plane and (b) cross-plane dispersion curves superim posed on the respective HCACFspectra for $R_m = 2$, T = 20 K. C om parison of the peaks in the HCACF to the associated frequencies in the quasi-harm onic dispersion curves for (c) $R_m = 2$ and (d) $R_m = 5$ in the in-plane and crossplane directions, plotted as a function of tem perature. (C olor online)

plane directions for $R_m = 2$ and a tem perature of 20 K. In Fig: 9(b), the location of the peak [as found in the decom position of the HCACF with Eq: (8)] is plotted as discrete data points as a function of tem perature for the in-plane and cross-plane directions in the $R_m = 2$ system. The corresponding data for $R_m = 5$ are plotted in Fig: 9(c).

By overlaying the dispersion curves and the HCACF spectra for both directions for a range of tem peratures and m ass ratios, we nd that the peak in the in-plane spectrum is coincident with one of the dispersion branches at zero wave-vector (i.e., the gam m a point {

the center of the B rillouin zone). The associated quasi-harm onic frequency is denoted by $!_2$ in Fig: 9(a), and is plotted as a continuous line in Figs: 9(b) and 9(c). A similar coincidence exists for the cross-plane peak, which is consistently near the gamma point frequency $!_1$, also shown in Fig: 9(a). These frequencies are also plotted in Figs: 9(b) and 9(c). The link between HCACF peaks and gamma-point frequencies has also been found in LJ SL structures with longer period lengths.³⁴

The agreement between the HCACF peaks and the dispersion frequencies is very good, especially for the in-plane peak. The data for $R_m = 10$ shows a similar agreement as for $R_m = 5$. The speci cation of the peak from the HCACF decomposition becomes discult at high temperatures, particularly in the cross-plane direction [this can be seen in Fig: 6(b)]. Quasi-harm onic theory will lead to an under-prediction of the dispersion curve frequencies, which seems to be the case for the cross-plane peak.

From these results, it is clear that speci c optical phonon modes generate the peaks in HCACF. W hile these modes do not make a signi cant contribution to the thermal conductivity, as will be discussed in Section VB, we interpret the appearance of peaks in the HCACF as an indication that they are partly responsible for the increased phonon scattering (and lower thermal conductivity) in the diatom ic system.

B. D ispersion and therm al conductivity

A seen in Figs: 7 (a) and 7 (b), the them al conductivities in the in-plane and cross-plane directions are lower than the monatom ic value. The deviation from the monatom ic value increases as the mass ratio increases. In the limit of an in nite mass ratio, the therm al conductivity will go to zero. This limit, and the overall behavior, can be partly understood from the trends in the dispersion curves. A sthem ass ratio increases, the dispersion branches get atter (see Fig: 3). The phonon group velocities (related to the slope of the dispersion curves) will get correspondingly smaller until they reach a value of zero when the branches are completely at, leading to zero therm al conductivity.

It is often assumed, although in most cases not properly justied, that acoustic phonons are the primary energy carriers in a dielectric crystal. Optical phonons are assumed to have a small contribution because of their supposed lower group velocities. Yet from a visual inspection of the dispersion curves in Fig: 3, one can see that there is not a signi cant

di erence in the slopes of the acoustic and optical branches. Based on the results of the therm al conductivity decomposition by Eq: (9) (not presented in detail here), the acoustic modes are responsible for most of the therm al conductivity. For a mass ratio of 2 in the cross-plane direction, the acoustic contribution ranges between 99.98% at a temperature of 10 K to 99.79% at a temperature of 80 K. For a mass ratio of 10 in the cross-plane direction, the acoustic contribution ranges between 98.84% at a temperature of 10 K to 85.08% at a temperature of 80 K. Thus, the dispersion trends alone cannot completely explain the observed behavior, and changes in the phonon scattering behavior must be considered.

In Figs: 10 (a) and 10 (b), the therm alconductivities for all cases considered in this study are plotted as a function of the dispersion metrics p_{ac} , p_{op} , and s_{tot} introduced in Section III and plotted in Fig: 4 (b). These quantities represent the fraction of the frequency spectrum taken up by the acoustic phonon modes, the optical phonon modes, and the stop bands. A lltherm alconductivities are scaled by the corresponding $R_m = 1$ value at the sam e tem perature.

From these plots, a number of general trends can be discerned. First, in both the in-plane and cross-plane directions, as the relative extent of the acoustic phonon m odes increases, the therm alconductivity increases. As discussed, the acoustic modes are most responsible for the them al conductivity. A larger frequency extent will lead to larger acoustic phonon group velocities, and a higher therm al conductivity. As the extent of the stop bands increases, the therm al conductivity decreases in both directions. In a stop band, there is no phonon wave propagation and hence no means for therm altransport. The optical phonon e ect is di erent in the two directions, consistent with the behavior of p_{op} seen in Fig: 4(b). Initially, in both directions, an increase in pop leads to a decrease in the therm al conductivity. The e ect of the optical branches is similar to the e ect of the stop bands: an accompanying decrease in the extent of the acoustic phonon m odes. This trend continues for the in-plane direction, but the cross-plane direction shows a di erent behavior, with a decrease in p_{op} as the therm al conductivity decreases. This change of behavior motivates further research on the role of the optical modes, but at least indicates that considering only one of p_{ac} , p_{op} , or stot is not su cient, and that all must be considered to completely understand the behavior of a given system .

These results can also shed light on the competition between dispersion characteristics and anham onic scattering in a ecting them al conductivity. In a ham onic system energy




FIG. 10: Therm al conductivity at all tem peratures and m ass ratios considered, scaled by the appropriate $R_m = 1$ value, plotted against the phonon dispersion m etrics p_{ac} , p_{op} , and s_{tot} . To best see the trends, sm ooth curves through each of the data sets are plotted. (C oldronline)

transport can be completely described by the dispersion curves, as there are no mode interactions. A sanharm onicity is introduced to such a system (e.g., by increasing the tem perature), the dispersion curves will no longer be su cient to predict the transport as the modes will interact. From F igs: 10 (a) and 10 (b), we see that as the tem perature increases, the therm al conductivity is less sensitive to changes in the dispersion metrics (i.e., the magnitude of the slopes of the curves decrease), consistent with the above discussion The analysis in this study suggests that a spectral perspective to them al transport, quanti ed by dispersion metrics such as those proposed, provides the following benets: (i) it enables a quantitative analysis (e.g., by evaluating the slopes of the them al conductivity versus dispersion metrics curves) of the relative contributions of dispersion and anham onic scattering mechanisms to them al transport, and (ii) it uncouples the structure-property relation (as discussed in Section IV) to that of structure-dispersion and dispersion-property relations, providing a simpli ed analysis fram ework that could be taken advantage of in design studies.

VI. CONCLUSIONS

We have studied a layered diatom ic Lennard-Jones crystal with varying mass ratio in order to establish a temperature-dependent three-way correlation between (i) the unit cell structure and inter-atom ic potential, (ii) the associated phonon dispersion curves, and (iii) the bulk therm al conductivity (see Fig: 1). The dispersion curves were obtained using lattice dynam ics calculations, and their characteristics were quanti ed using a set of novel band diagram metrics. The therm al conductivity was predicted using molecular dynam ics sim ulations and the G reen-K ubo method.

As shown in Fig: 7, the therm al conductivity of the layered material is less than that of a corresponding monatom ic system, and is directionally dependent. To understand the therm al conductivity trends, one must consider the elects of density and crystal structure, with consideration to both the dispersion and the anharm onic scattering characteristics (see Fig: 8).

The HCACF for each material was t to an algebraic function, allowing for the roles of acoustic and optical phonons to be distinguished. The peaks in the FT of the HCACF were found to coincide with frequencies obtained from the dispersion calculations, con rm ing that these peaks are generated by optical phonons (see Fig: 9).

The dispersion curves metrics introduced in Section III, and plotted in Fig: 4, describe the frequency extent of the acoustic and optical phonon modes and that of the stop bands. As shown in Fig: 10, the therm al conductivity increases with increasing p_{ac} , and decreases with increasing s_{tot} . The dependence on p_{op} varies depending on the mass ratio and the crystallographic direction, a behavior that motivates further investigation.

The rate of change of the therm al conductivity versus the dispersion metrics (see Fig: 10) decreases with increasing temperature, consistent with the increasing role of anharmonic scattering on therm al transport at higher temperature. These relations provide an indirect measure of the relative contributions of dispersion and anharmonic scattering to therm al transport. Moreover, the dispersion metrics allow for the uncoupling of the traditional therm al conductivity structure-property relation to that of structure-dispersion and dispersion-property relations. This decomposition facilitates further elucidation of the underlying physics of therm al transport, and could be used as an elective tool for material design.

APPENDIX A:LATTICE DYNAM ICS CALCULATIONS

In this appendix, we outline the analytical procedure used to investigate the lattice dynam ics. The formulation is based on that presented by $D \operatorname{ove}^{27}$ and M aradudin.³⁵

D eterm ining phonon mode frequencies and polarization vectors using lattice dynamics is greatly simplied under the harmonic approximation. In this approximation, a Taylor series expansion of the system potential energy about its minimum value is truncated after the second-order term. This approach leads to harmonic equations of motion that can be solved analytically for simple system s_r^{28} but are most easily solved numerically.

G iven an interatom ic potential and the equilibrium positions of the atom s in a crystal with an n-atom unit cell, the analysis proceeds as follows:

Here, the summation is over all unit cells and (alpha or equals 1 for x, etc.). For example, in a unit cell of four atoms denoted by A, B, C and D (like that shown in Fig: 2), the summation in Eq: (A 6) for $(j = 1; j^0 = 2)$ would be over pairings between atom A in the 0-th unit cell and atom B in all unit cells, including 0.

The dynam ical matrix is Hermitian and therefore has real eigenvalues and orthogonal eigenvectors. The square roots of the eigenvalues of D () are the phonon mode frequencies !(;), and the eigenvectors of D () give the phonon polarization vectors e(;). The polarization vectors (also known as the mode shapes) are normalized such that

In general, the elements of e(;) are complex and describe the relative amplitude and phase di erence of the displacements of the atom s in the unit cell.

D ispersion curves can be generated by calculating the phonon mode frequencies for a range of wave vectors in a particular direction. For example, the dispersion curve presented in Fig: 3 (b) was generated using 100 evenly spaced wave vectors in the in-plane direction with wave numbers ranging from 0 to =a where a is the lattice constant. The dispersion curve has 3 acoustic branches and 3n 3 optical branches. The dispersion shown in Fig: 3 (c) has only 8 branches because the transverse branches in this direction are degenerate.

The procedure outlined here gives results that are exact at zero tem perature. For higher tem peratures, the zero-pressure lattice positions should be used (i.e. the quasi-harm onic approximation).²⁷ The anharm onic contributions to the lattice dynamics analysis can be included using molecular dynamics simulations.⁵
