Interactions and phase transitions on graphene's honeycom b lattice

The low-energy theory of interacting electrons on graphene's two-dimensional honeycom b lattice is derived and discussed. In particular, the Hubbard model in the large-N limit is shown to have a sem im etal – antiferrom agnetic insulator quantum critical point in the universality class of the G ross-N eveu model. The same equivalence is conjectured to hold in the physical case N = 2, and its consequences for various physical quantities are exam ined. The elects of the long-range C oulom b interaction and of the magnetic eld are discussed.

A graphite m onolayer, or graphene, em erged recently as the new frontier in physics of electronic systems with reduced dimensionality [1]. Such two-dimensional, or quasi-two-dimensional systems have led to some of the most startling discoveries in the condensed matter physics in the recent past, the quantum Halle ects and the metal-insulator transitions in silicon-MOSFETS and G a-A sheterostructures, and the high-tem perature superconductivity in cuprates being prime examples. W hat m akes graphene qualitatively new is its sem i-m etallic nature with low -energy quasiparticles behaving as 'relativistic' D irac spinors over a good portion of the conducting band. The spinor structure is a general consequence of the bipartite nature of the honeycom b lattice [2]. Indeed, recently observed quantization rules for the H all conductivity [3] may be understood as a direct consequence of the D irac nature of its low energy spectrum [4], [5].

The relativistic spectrum and the concomitant linearly vanishing density of states at the Ferm i level, sim ilarly as in the superconducting state of cuprates, provide graphene's quasiparticles with an additional protection against the e ects of interactions. Nevertheless, a suf-

ciently strong repulsion is expected to turn the sem im etallic state into a gapped insulator, possibly breaking the translational and/or the rotational symmetry in the process. W ithin the simplest interacting theory de ned by the Hubbard model there is convincing num erical evidence for the quantum phase transition at a large Hubbard U into an antiferrom agnet (AF) [6]. On the other hand, the long-range Coulomb interaction remains unscreened in the sem i-m etal (SM) [7], and has been argued to favor the charge-density-wave (CDW) at strong coupling [8]. The competition between di erent instabilities, the universality class, or even the order, of the SM insulator transition, and the interplay of interactions with the Landau quantization in the external magnetic eld present som e of the basic open problem s. A lthough graphene in its natural state may not be near a criticalpoint [9], one can conceive mechanical deform ations that would pull it deeper into the strong-coupling regime [10]. Finally, the outcome of the competition between di erent interactions should have consequences for the selection of the ground state in the magnetic eld, even at weak coupling [11].

In the present com m unication som e of these issues are addressed by considering the half-lled Hubbard m odel

on a honeycomb lattice, complemented with the additional long-range C oulom b interaction between electrons. The analysis is based on a useful decom position of Hubbard's on-site interaction on a bipartite lattice into a sum of squares of average and staggered densities, and average and staggered magnetizations. The long-range part of the Coulom b interaction m ay be represented by a massless scalar gauge eld, whereas its main e ect on the lattice scale is to provide the repulsion between nearestneighbors. W hen prepared like this, in the continuum lim it such an extended Hubbard model on a honeycom b lattice maps onto a 2 + 1-dimensional eld theory of Dirac fermions, with nine di erent couplings. Its apparent complexity notwithstanding, when generalized to a large number of ferm ion $\mbox{ avors } N$, the theory adm its a simple SM - AF critical point of the G ross-N eveu variety [12]. Coulom b interaction is marginally irrelevant at the critical point. Assuming that the equivalence with the G ross-N eveu m odel persists down to the physical case of N = 2, I infer the values of the critical exponents in the original Hubbard model. A more general phase diagram, and the implications of these results for graphene are discussed.

The extended H ubbard m odel will be de ned by the H am iltonian H = H $_0$ + H $_1$ where

The sites \overline{A} denote one triangular sublattice of the hexagonal lattice, generated by linear combinations of the basis vectors $a_1 = \langle \overline{3}; 1 \rangle$ (a=2), $a_2 = \langle 0;a \rangle$. The second sublattice is then at $\overline{B} = \overline{A} + \overline{b}$, with the vector \overline{b} being either $\overline{b}_1 = (1 = \overline{3}; 1)$ (a=2), $\overline{b}_2 = (1 = \overline{3}; 1)$ (a=2), or $\overline{b}_3 = (a = \overline{3}; 0)$. a is the lattice spacing. Neutralizing background is assumed, as usual.

The doubly degenerate spectrum of H $_0$ at E (K) =

where it was convenient to rotate the reference frame so that $q_x = q \ K = K$ and $q_y = (K p q) \ K = K^2$, and set $h = k_B = v_F = 1$, where $v_F = ta \ 3=2$ is the Ferm i velocity. Choosing $_0 = I_2$ _ z implies $_1 = _z$ y and $_2 = I_2$ _ x, with I_2 as the 2 2 unit matrix, and ~ as the Paulim atrices. 1=a is the ultraviolet cuto over which the linear approximation for the dispersion holds. The sum mation convention is adopted hereafter, but only over repeated space-time indices. Besides the Yelativistic' invariance, L_0 also exhibits a global invariance under the U (4), generated by fI_2 ;~g fI; 3; 5; 35g, where I is the 4 4 unit matrix, $_3 = _x y$, $_5 = _y y$, and $_{35} = i_{3}$ 5. This is similar to the emergent thiral' symmetry of a d-wave superconductor [13].

Generalizing slightly Hamman's decomposition, the rst term in H $_1$ can also be rewritten exactly as

where $n(A);m(A) = u_{+}^{Y}(A)u_{+}(A)$ $u^{Y}(A)u_{-}(A)$, are the particle number and the magnetization at the sites A. Variables at the second sublattice are analogously de ned in term s of v(B).




FIG.1: The large-N ow diagram in the attractive plane $e = g_d = g_f = g_x = 0.A$, B, C, and G are the AF, bicritical, CDW, and the Gaussian xed points, respectively. A and C are in the Gross-N eveu universality class. The extended H ubbard m odel in Eq. (2) de nes the (dashed) line of initial conditions $g_c = (U \ V)=4U_c$ and $g_a = U=4U_c$, with V as a xed nearest-neighbor repulsion. Inset: the resulting phase diagram.

The notation is now in place to write the low-energy theory of the extended H ubbard m odel. In the continuum lim it (a ! 0) the Lagrangian becomes

The short-range couplings are g_{d} = $2g_1 e^2 = 4K = (U + V)a^2 = 8, g_c = 2g_f = (U V)a^2 = 8,$ $g_f = g_a = 2g_f = 2g_f = Ua^2 = 8.d$ and c couplings correspond to the rst (average density) and the second (staggered density), whereas f and a couplings represent the third (m agnetization) and the fourth (staggered m agnetization) terms in Eq. (5). The Coulomb interaction is represented by: 1) the intra-unit-cell, nearest-neighbor repulsion V = $e^{2^{r}}$ $\overline{3}$ = (a), and the 2K Fourier component $e^2 = 2K$, and 2) its long-range part, which is recovered upon Gaussian integration over the scalar gaugeeld a₀. jr jshould be understood as jej in Fourier space [14]. W hereas such a separation would be exact for an in nitely long-ranged interaction, it is only an approximation for the Coulomb interaction.

The usual power counting in plies that all short-range interactions in L are irrelevant, and that the charge e is a marginal coupling at the non-interacting xed point $g_x = g_x = e = 0$. Any critical point would therefore have to lie in the strong-coupling regime. To exert some control over it we may deform the Lagrangian from two to N avors of the D irac elds as follows:

with $C_{c;a} = 4$, $C_{d;f} = 0$, and with the couplings rescaled as g = ! g. To the leading order in 1=N -functions for di erent interactions thus do not m ix [15]. Since the model when N = 1 is exactly solvable by the saddlepoint method, the leading order -functions may also be understood as guaranteing that the solution is cuto independent [15]. Non-analyticity of the inverse gauge- eld propagator and the gauge invariance of L also dictate that

with z as the dynamical exponent, exactly [14]. Relativistic invariance of L is broken when $e \in 0$, and consequently $z \in 1$ at nite length scales. Similarly to the bosonic case,

and the charge is marginally irrelevant to the order in 1=N [7], [16].

Besides the trivial fully attractive xed point, the large-N -functions in Eqs. (13)-(15) exhibit two critical points in the attractive plane $e^2 = g_f = g_d = g_x = 0$: 1) at $g_a = 1=4$, $g_c = 0$ and 2) $g_c = 1=4$, $g_a = 0$. There is also a bicritical point at $g_a = g_c = 1=4$, which directs the ows towards one of the two critical points (Fig. 1). The critical points are related by the sym m etry under a change of sign of for 'down' components with = N = 2 + 1; ::: N accompanied by the exchange of g_a and g_c . The transition is either to A = hi€ 0, which corresponds to an AF with a nite staggered magnetization, or to a C D W , with the nite staggered density C = hi € 0. The same, of course, follows from the explicit solution of the model at N = 1. The ow of gf towards the origin also agrees with the saddle-point equations, which do not show a ferrom agnetic critical point at N = 1, whereas the irrelevance of $g_d \sin p \ln p$ m eans that the chem ical potential vanishes.

Eqs. (14), however, appear to exhibit additional critical points at $g_x = 1=2$. These, however, would occur within the AF or the CDW, and are artifacts of our procedure which checks only the stability of the sem im etal. It is easy to see from the explicit solution that the existing gap prevents such an additional transition. All g_x are therefore irrelevant.

The transition in the pure, e = 0, repulsive Hubbard model with $q_a < 0$ and $q_c > 0$ in the large-N lim it is controlled therefore by the critical point A. Recalling that 1=a, and $ta^{1} = 3=2 = 1$ by $q_a = U a^2 = (8), w \pm h$ our convention, one nds that this corresponds to the critical value of U_c=t 5:5, certainly fortuitously close to the values found in num erical calculations [6]. Above the critical interaction the system develops a gap, at the same time becoming insulating and antiferrom agnetic. At the critical line $g_c = g_f = g_d = g_x = e^2 = 0$, upon the change of sign of -m atrices for down' components the Lagrangian becomes identical to the much studied G ross-N eveu m odel in 2+1 dim ensions [12]. Evidently, the G ross-N eveu critical point has only one unstable direction to the order 1=N. Since the actual expansion parameter is 4N, I expect this feature to survive even for N = 2. This leads to the conjecture that the SM -AF transition in the Hubbard model is continuous and described by the N = 2 G ross-N even critical point, at which

with the ferm ion's anom alous dimension = $(2=(3 \ ^2N)) + 0 \ (1=N^2) \ [17]$. The order parameter's correlation function at the critical point also decays as:

where is the standard anom alous dimension, and = $16=(3^{2}N) + O(1=N^{2})$. The correlation length di-1 verges at the critical point with the exponent = 1 + $8=(3 \ ^{2}N) + 0 \ (1=N^{2})$, and the usual scaling laws are expected to be satis ed. The critical exponents have been computed to the order $1=N^2$ (with known even to the order $1=N^{3}$) [17], as well as being determ ined by M onte Carlo calculations, the -expansion [18], and the exact renorm alization group [19]. In sum mary, for N = 2one nds = 0:038 0:006, = 0:97 0:07, and = 0**:**770 0:016 [19].

The presence of gapless ferm ions on the sem im etallic side places the G ross-N even phase transition outside the usual G inzburg-Landau-W ilson paradigm, as evidenced by the large anom alous dimension , for example. In fact, the G ross-N even model probably de nes the sim – plest such a universality class. Its distinct characteristic is the ferm ion's anom alous dimension , which governs the disappearance of quasiparticles as the transition is approached on the sem im etallic side. Scaling dictates that the residue of the quasiparticle pole behaves as

so that a very small would make it appear discontinuous at U = U_c.

In the AF, the eight generators that anticom m ute with z = 0 become broken; these are $(I_2; z) = (3; 5)$ and (x; y) = (I; 35). Among these only (x; y) = I, which generate the usual spin rotations, correspond to the exact symmetry at U = 0, whereas the rest emerge as generators of approximate symmetries only at low energies. In the insulating phase the G oldstone bosons which correspond to the emerging generators are gapped, due to the irrelevant terms excluded from L [20]. The low-energy spectrum in the insulator consists therefore only of the usualm agnons.

The long-range nature of C oulom b interaction is found to be irrelevant at a large N . On the scale of lattice spacing, how ever, C oulom b interaction leaves its imprint on the initial value of the coupling g_c , as indicated right below Eq. (11), for example [21]. In general, if the nearestneighbor repulsion V is made su ciently strong so that the line of initial conditions in Fig. 1 reaches left of the point C, there is an additional sem im etal - CDW transition. Identifying V with $\hat{e}=a$ gives an alternative m echanism to that of ref. 8 for the CDW form ation. The two lines of continuous transitions m erge above a certain V, when the line of initial conditions com es left of the point B. The direct transition between the AF and the CDW is discontinuous. It seems natural, how ever, to assume that in reality U > V, which would suggest a single, continuous, antiferrom agnetic transition.

For graphene, t 2:5eV, U 5 12eV,U=V 2 [10], so that the system is probably on the SM side of the transition. The external magnetic eld, how ever, changes the density of states into a series of delta-functions, so that the transition can now in principle take place even at an in nitesim alcoupling [11]. In them agnetic eld the $1=\frac{1}{2}$, where ow of the couplings should be cuto at a is the magnetic length. If the large-N picture Ŀ presented here holds for N = 2, in the the pure, e = 0, Hubbard model, at a su ciently low eld all couplings would become negligible compared to ga. This would suggest that the magnetic eld, at least with the Zeem an term neglected and the long-range component of the interaction screened by a metallic substrate, for example, should 'catalyze' the antiferrom agnetic order at a weak U.
