N on Ferm i liquid behavior in transport across carbon nanotube quantum dots

A low energy-theory for non-linear transport in nite-size single-wall carbon nanotubes, based on a microscopic model for the interacting p_z electrons and successive bosonization, is presented. Due to the multiple degeneracy of the energy spectrum diagonalas wellas o -diagonal (coherences) elements of the reduced density matrix contribute to the nonlinear transport. A four-electron periodicity with a characteristic ratio between adjacent peaks, as well as nonlinear transport features, in quantitative agreement with recent experiments, are predicted.

Since their recent discovery single-wall carbon nanotubes (SW NTs), cf. e.g. [1], have attracted a lot of experimental and theoretical attention. In particular, as suggested in the sem inal works [2, 3], due to the peculiar one-dim ensional character of their electronic bands, m etallic SW NTs are expected to exhibit Luttinger liquid behavior at low energies, re ected in power-law dependence of various quantities and spin-charge separation. Later experimental observations have provided a con rmation of the theory [4, 5]. As typical of interacting electron systems in reduced dimension, SW NTs weakly coupled to leads exhibit Coulom b blockade at low tem peratures [6] with characteristic even-odd [7] or four-fold periodicity [8, 9, 10]. In [9] not only the ground state, but also several excited states could be seen in stability diagram sofclosed SW NT quantum dots. Such two-fold and four-fold character can be qualitatively understood from sym m etry argum ents related to the two-fold band degeneracy of SW NTs and the inclusion of the spin degree of freedom . So far, a quantitative description has relied on density functional theory calculations [11] or on a mean

eld description of the Coulom b blockade [12]. In particular, the position of the spectral lines in the stability diagram measured in [9] was found to be in quantitative agreement with the predictions in [12]. However, a mean eld description may be not justi ed for one-dimensional systems. For example, to describe the spectral lines of

the sample with four-fold periodicity (sample C) in [9], a quite peculiar choice of the mean eld parameters was made, and a quantum dot length three times shorter than the measured SW NT length was assumed. Moreover, to date no quantitative calculation of the nonlinear current across a SW NT dot has been provided.

In this Letter we investigate spectral as well as dynam ical properties of electrons in metallic SW NT quantum dots at low energies. We start from a microscopic description of metallic SW NT s and include C oulom b interaction e ects, beyond mean-eld, by using bosonization techniques [2, 3], yielding the spectrum and eigenfunctions of the isolated nite length SW NT.Due to the many-fold degeneracies of the spectrum, the current-voltage characteristics is obtained by solving equations of motion for the reduced density matrix (RDM) including o -diagonal elements. A nalytical results for the conductance are provided, which account for the dierent heights of the conductance peaks in [9]. Moreover, we can quantitatively reproduce all the spectral lines seen in sample C in [9] by solely using the two ground state addition energies provided in that work. The derived level spacing is in agreement with the measured SW NT length.

To start with, we consider the total H am iltonian

where H is the interacting SW NT Ham iltonian (cf. Eq. (5) below) and H_{s=d} describe the isolated metallic source and drain contacts as a therm al reservoir of non-interacting quasi-particles. Upon absorbing terms proportional to external source and drain voltages $V_{s=d}$, they read (l = s;d) H₁ = ${}_{q}$ "q;lc^Y_{q1}cq₁, where c^Y_{q1} creates a quasi-particle with spin and energy "q;l = "q eV_{s=d} in lead s=d. The transfer of electrons between the leads and the SW NT is taken into account by

where ^Y and ^Y₁(\mathbf{r}) = ^P_{q q}(\mathbf{r}) $c_{q 1}^{y}$ are electron creation operators in the SW NT and in lead 1, respectively, and T₁(\mathbf{r}) describes the transparency of the tunneling contact 1. Finally, H_{gate} = $_{g}N_{c}$ accounts for a gate voltage capacitively coupled to the SW NT, with N_c counting the total electron number in the SW NT.

SW NT Ham iltonian. In the following the focus is on am - chair SW NTs at low energies. Then, if periodic boundary conditions are applied, only the gapless energy subbands nearby the Ferm ipoints $F = K_0 = K_0 e_x$ with e_x along the nanotube axis, are relevant [2, 3]. To each Ferm i point two di erent branches r = R = L are associated to the B both waves $r_{R=L,F}$; $(r) = e^{i \times r} r_{R=L,F}$ (r), where measures the distance from the Ferm i points

Upon inserting 6) into (5), integration over the coordinates perpendicular to the tube axis yields the interacting H am iltonian expressed in terms of 1D operators and an elective 1D interaction $V_{eff}(x;x^0)$. Using standard bosonization techniques [2, 3] H can now be diagonalized when keeping only forward scattering processes associated to $V_{eff}(x;x^0)$. It reads




FIG.1: Energy spectrum of a SW NT with open boundary conditions (right) described in terms of left (Γ) and right (R) branches. It is constructed from suitable combinations of travelling waves whose spectrum is shown on the left side.

where the st line is the ferm ionic contribution and represents the energy cost, due to Pauli's principle and the Coulom b interaction, of adding new electrons to the system. Specically, $N_r =$ c^y_r c_r ; is the operator that counts the number of electrons in the (r)-branch, $_{\rm r}$ N $_{\rm r}$ yields the total electron number, and N $_{\rm c}$ = "_0 = $\sim v_F \frac{1}{T_c}$ is the free-particle level spacing (see Fig. 1). W hen are coherences needed? Eqs. (10) with (12) show that coherences (in the energy basis) enter the evaluation of the current. In the low bias and temperature regime $k_B T$; $eV \coloneqq e(V_s V_d)$ "0, however, where only ground states contribute to the current, because of hN; $0 j_{r}^{y} r jN^{0}; 0i = (1=2L)_{N^{0};N}$, only diagonal elem ents of the RDM contribute. Hence, due to the "unpolarized" character of the leads, the commonly used m aster equation (CME) with population's dynamics only is valid. At larger biases coherences should be included [14]. In the following we focus on the case 0, relevant

to explain the experim ental results for sam ple C in [9].

Low bias regime (CM E is valid). At low bias the current can be obtained by looking to transitions between ground states with N and N + 1 particles and energies E_{N}^{0} ; E_{N+1}^{0} . Then, the matrix element ($_{r}$)_{N⁰N} is non zero only if N⁰ = N q, with q_{r} the unit vector, and

Here $C_{N,N} \circ is$ the number of ground states with N ⁰ particles whose con gurations N⁰ di er from the fermionic con guration of a given ground state with N electrons only by a unit vector. With N = 4m;4m + 1;4m + 2;4m + 3 one nds $C_{N,N+1} = 4;3;2;1$ and $C_{N+1;N} = 1;2;3;4$, respectively. We also notice that all ground states with N particles are populated with equal probability P_N (t) = $d_N |_{N,N}$ (t), where d_N is the degeneracy of the ground states with particle number N. It holds $d_N = d_{N+1} = C_{N+1;N} = C_{N;N+1}$. The corresponding CM E for P_N (t) can now be easily solved and the current evaluated in analytic form . W e nd




FIG.2: a) Conductance vs. electrochem ical potential in the linear regime eV $k_B T = "_0$. Despite asymmetric contacts, the two central peaks and the two outer peaks have equal height. b) Current in the regime $"_0 = jeV_1j$ kT. A symmetry elects become visible. Four-electron periodicity is still observed. Parameters are $E_c = 9.5 \text{ meV}$; $k_B T = 0.10 \text{ meV}$, $"_0 = 2.9 \text{ meV}$, $_s = 5 \text{ d} = 4.9 = 1^{10} \text{ s}^{-1}$.

This expression can be further simplified in the regime $jeV j kT "_0$ where the linear conductance $G_{N,N+1}$ is obtained by linearizing f in V, and by evaluating the remaining quantities in (16) at zero bias. The conductance trace exhibits four-electron periodicity (Fig. 2a), with two equal in height central peaks for the transitions N = 4m + 1! N + 1, N = 4m + 2! N + 1, and two

sm aller peaks for N = 4m ! N + 1, N = 4m + 3! N + 1 also equal in height. The relative height between central and outer peaks is $G_{4m+1;4m+2}^{max} = G_{4m;4m+1}^{max} = 27 = (10 + \frac{p}{6})$ 1:36, independent of the ratio s = d.

In the bias regine " $_0$ jeV₁ E j kT is f = 1. If e.g. eV_s E < 0 and eV_d E > 0; such that tunneling is preferable rom source to drain, we nd $I_{N,N+1} = eC_{N,N+1}C_{N+1,N} s d=({}_{s}C_{N,N+1} + {}_{d}C_{N+1,N})$: In this regine, the nonlinear conductance will still exhibit four-electron periodicity, Fig. 2b. For s = d one stillexpects two equal central peaks and two sm aller outer peaks with ratio 3=2. If $s \in d$ this latter symmetry is lost. If we invert the sign of the bias voltage, the current is obtained by exchanging s with d.




FIG.3: a) Current in a bias voltage – electrochem ical potential plane for the sym m etric contacts case. b) D i erence plot of the current with and without coherences. Here $k_B T = 0.01$ m eV and $"_0 = "_{c+q} = 0.21$. O ther parameters are as in Fig. 2a.

High bias regime. In the bias regime $eV > "_0$ states with bosonic as well as ferm ionic excitations contribute to transport. An analytical treatment is not possible, except to de ne the position of the various excitation lines. The resonance condition for tunneling in/out of lead 1 is as usually given by $eV_1 + E$ = 0, where Ε (E_{N 1} E_N): Besides the resonance condition, also the overlap integral between initial and nal state determ ines the rates, and hence the "active" resonance lines contributing to the current. F ig 3a shows the current in a bias voltage-electrochem ical potential plane for the symmetric case s = d. By choosing the addition energies provided in [9] $_1 = E_c = 9.5 \text{ meV}$ and $_2$ = 13:4 m eV, we can reproduce all the excitation lines from sample C in [9]. Moreover, we nd a level spacing $"_0 = 2.9 \text{ meV}$, which well agrees with the estim ated length for sam ple C of 750 nm . W e com pare with the mean eld parameters: to t the data, an unusually large exchange interaction J = 2:9 m eV as well as a band J had to be assumed in [9] (in our theory shift " is "o J 0). This yields a level spacing three times Finally, the e ect of the coherences induced by the bosonic excitations is shown in Fig. 3b, where a di erence plot for the current with and without coherences is shown. Though the coherences do not qualitatively change the current, they do have a quantitative in uence in a region of interm ediate bias V. A further indication for non-Fermi liquid behavior could lie in negative di erential (NDC) features originating from spin-charge separation, as predicted for a spinful Luttinger liquid quantum dot [15]. A symmetric contacts are a necessary requirement. We checked these predictions as possible explanation of the NDC seen in [9]. We con result (also for non-relaxed bosons) NDC coccurs. However, very large asymmetries must be assumed. Moreover, in contrast to the experiments, all the NDC lines have the same slope.

To conclude, we discussed linear and nonlinear transport in SW NT quantum dots using a bosonization approach. Our results are in quantitative agreement with experimental notings in [9]. Further work to explain the nature of the NDC seen in [9] is needed.
