Derivation of hydrodynam ics for the gapless mode in the BEC-BCS crossover from the exact one-loop e ective action

W e show that many hydrodynam ical properties of the BEC/BCS crossover in the presence of a Feshbach resonance at T = 0 can be derived easily from the derivative expansion of the (exact) fully renormalized one-loop e ective action. In particular, we calculate the velocity of sound throughout the BCS and BEC regimes and derive the generalized super uid continuity equations for the composite two - uid system.

As the strength of ferm ionic pairing increases in cold alkali atoms there is a continuous evolution from the BCS-like behavior of C ooper pairs to B ose-E instein C ondensation (BEC) of m olecules. This crossover phenom enon becomes controllable experimentally [1] when the atom s interact through a Feshbach resonance [2, 3, 4, 5, 6, 7]. In both regimes, condensation is a consequence of global U (1) symmetry breaking with a concomitant gapless G oldstone m ode (the phonon).

A lthough the s-wave scattering length diverges at the crossover, the speed of sound changes sm oothly, as do the hydrodynam ical properties of the condensate. The m ain result of this letter is to show that, at T = 0, all of these can be determ ined straightforwardly from the derivative expansion of the exact, fully renorm alized one-loop e ective action, in the spirit of [7], sidestepping the m ore com – plicated derivations based on a fullm ulti-channel analysis (e.g. see [4]).

Consider a condensate comprising a mixture of fermionic atoms and molecular bosons. The fermions

(x), with spin = (";#), undergo self-interaction through an swave BCS-type term. In addition, two ferm ions can be bound into a molecular boson (x) through a Feshbach resonance e ect. To exemplify our method, we take the Lagrangian density to be [2, 3] (U > 0, g xed)

Them assofthe bosons is twice that of the ferm ions, M = 2m. The kinetic energy of the ferm ions is $k = k^2 = 2m$

and the kinetic energy of the bosons is $k^2 = 2M +$, where

is the threshold energy of the Feshbach resonance. To demonstrate the method we restrict ourselves to a narrow resonance approximation [2, 3] where quantum loop e ects from themolecular boson can be safely ignored [7], although this is often an idealization. The elective fourferm ion interaction is determined by the value of , which is controllable by an external magnetic eld. On tuning the eld, the condensate can be varied in form from BCS C ooper pairs to BEC molecules as the scattering length changes sign.

On introducing the auxiliary eld $(x) = U_{\#}(x) \cdot (x)$, a Hubbard-Stratonovich transform ation leads to an elective Lagrangian density, to which the ferm ionic contribution is $y(x)G^{-1}(x)$, where (x) is the Nam bu spinor, $y(x) = (\frac{y}{n}; \frac{x}{n})$, and G^{-1} is the inverse Nam bu G reen function

The combined condensate of the theory is (x), given in terms of the biferm ion and molecular condensates and as ~(x) = (x) (x): The gapless mode of the theory is encoded in α the phases of (x) and (x) for which we write (x) = $j(x)je^{i}(x);(x) =$ j(x)jė^(x): The amplitude and phase of $(x) = j'(x) j e^{i \cdot (x)}$ can be determined from those of (x) and (x) by its de nition above. We now perform a U (1) gauge transform ation on the ferm ion $(x) = e^{i - (x)^2}$ (x). Integrating out eld (x) leads to a non-local elective action S_e [;;;]. The action possesses a U (1) invariance under the phase change ! + and ! + (or ~ ! ~ +). This symmetry is spontaneously broken when and respectively acquire the non-vanishing constant values 0 and 0 determined by the gap equations obtained

from extrem izing the e ective action. In these, $j^{\circ}_{0}j = j_{0}j + j_{0}j$ satis es

Since the microscopic theory under consideration is G alilean invariant, any elective theory derived from it must respect this symmetry [8]. Consider the dynam-ics of the phonon carried in the angular variables. To preserve G alilean invariance at each step, the variations in the condensate magnitudes can be written as $j j = j_{0} j + j j$; $j j = j_{0} j + j j$, 10, 11]. We assume that terms in j j, j j, and $()^{2}$ are of the same order in their de ning equation, although and are large variables. with jjde ned by $j^{j} = j^{0} j^{j} + j^{j} [9]$. G_{0}^{1} is the free inverse N am bu G reen function with the same form as G^{1} in Eq.(2), except that (x) is replaced by $j^{0} j$. S_e [; ;;] then permits the derivative expansion

the rst two terms of which are no more than the expansion of iTrLn (G¹). For our purposes it is sufcient to truncate the sum in n at second order, to yield an action $S_e^{(2)}[jj;; ~]$ after eliminating in favor of ~, and in terms of ~, on using (~) (j_0j=j~j)(). D is gram matically, this am ounts to taking account of ferm ionic one-loop e ects in the e ective action.

The action of the gapless phonon mode is that part of the quadratic contribution to $S_e^{(2)}$ in which the derivatives of j jand \tilde{j} jare om itted. A fter straightforward manipulations this takes the form

This lends itself to a very simple mechanical picture of a coupled 'wheel' and 'axle'. The radius of the wheel is j~jand that of the axle is j g j measured from the gap values j~₀ jand j g ₀ j with angles of displacement ~, , respectively. There is slippage between the wheel and axle with an elastic restoring force $^2 = (2g=U)j_0jj_0^{-1}j_0$. The ferm ion number density at n = 1 is

A further straightforward eigenvalue calculation gives the long wavelength dispersion relation for the phonon as $!^2 = v^2 \tilde{k}^2 + 0 \ (k^4)$, where

Note that v is independent of the slippage strength 60.

In fact, is UV-singular, as are U_{eff} ; U and g from the gap equations (3) and (4). Renorm alization is in plem ented by de ning the renorm alized coupling U_e in terms of the s-wave scattering length a_s as

In turn, we now de ne a renorm alized threshold energy through

The outcome of this renormalization is that S_{phonon} of (7) and the gap equation for the condensate (4) are rendered UV nite term by term by replacing the unrenormalized




FIG. 1: The behavior of the sound velocity v throughout BEC and BCS regimes as a function of the threshold energy .We choose U = 7:54 $_{\rm F}$ =k $_{\rm F}^3$ and g = 4:62 $_{\rm F}$ =k $_{\rm F}^{3=2}$ as an example [12]. The dotted line is obtained with the approximate solution of the sound velocity, Eq.(15) for the BEC regime and Eq.(14) for the BCS regime. The lower inset shows how the scattering length $a_{\rm s}$ varies from BEC to BCS as the threshold energy increases, while the upper inset reveals the evolution of the ferm ion density $_{0}^{\rm F}$ (solid line) and the molecule density $_{0}^{\rm B}$ (dotted line).

U;U_e ;g; ; by their renorm alized counterparts. Henceforth we drop the overbars for sim plicity, and understand all quantities in (9) as renorm alized. Necessarily, the renorm alization prescription we propose above makes not only the gap equations free of UV-divergence, but also the sound velocity. Thus, combining the renorm alized equations (4) and (11) with the number equation (8) allow sus to study the behavior of the condensate numerically when the threshold energy varies so that the scattering length goes from $a_s ! 0^+$, the deep BEC regime, to $a_s ! 0$, that of deep BCS, through a BCS/BEC crossover. This is shown in the inset in Fig.(1) [6, 12]. Solving rst for the chemical potential as a function of the threshold energy , the sound velocity θ) can be computed, as depicted in the main Fig.(1), in agreement with [13].

To understand the num erical behavior shown in Fig.(1) we evaluate v^2 analytically in both deep BCS and BEC regimes. In the deep BCS regime, there is considerable simplication as all momentum integrals are dom - inated by the k modes near the Fermi surface. In this limit, j_0j_0 , where few molecules are present, and

0, the ignorable amplitude-phase coupling due to the particle-hole symmetry near the Fermi surface. We obtain A = B N, leading to

W ith the total ferm ion density $_0 = k_F^3 = 3^2$ and N N₀ = m k_F = 2², the ferm ion density of states at the Ferm i surface, the sound velocity is given by v² ' v_F²=3. This is the result we obtain from conventionalBCS theory with no Feshbach resonance (e.g. see [9]), for which g = 0 and j₀ j = 0.

On the other hand, in the deep BEC limit U

 $g^2=j$ 2 j, which gives rise to j 2 j 2 b $_0=k_F$ a_s , as obtained from U_e . To maintain this relation for small a_s , U cannot be too large. From Eqs. (10), the sound velocity v^2 can be approximated as

in this deep BEC regime as a result of A = B N. We nd that j₀ j increases as goes increasingly negative, while the combined condensate j_0° jdecreases to keep the number of fermions xed. As a result $j_0^{\circ} f' g^2 j_0 f'$ $(g^2=2)_0$ for largely negative (i.e. $a_s ! 0^+$) when all fermions are in the form of molecules as seen in the inset in Fig.(1). Thus, the behavior of v^2 , which is found to approach zero at sm all a_s , is now determ ined by how the chem ical potential increases negatively as a_s deceases.

In the central region, the behavior is sm ooth across the 'unitarity lim it' at $j_{a_s}j!$ 1 when =2. In this case, the gap and num ber equations are reduced to involving only one parameter g in the one-channel form ulation of Ref.[14]. If g is large, 'universal behavior' is found where $v^2 \qquad 0.2 v_F^2$. Nevertheless, the renormalization of the molecular boson is expected to contribute sizable corrections to the sound velocity obtained above in such a strongly coupled regime [15].

M ore generally, the BEC/BCS system perm its a hydrodynam ic interpretation as a two-component super uid. The crucial ingredient is the Galilean invariance of the derivative expansion. It is not dicult to rederive the relevant angular parts of $S_e^{(2)}$ from S_{phonon} . We restore Galilean invariance by the substitutions

for both phase angles.

Taking the variation of $S_e^{(2)}$ with respect to the condensate phase \sim leads to a single mean-eld equation of motion which can be rewritten in terms of the explicit ferm ion number density $_F$:

describing a coupled two-component super uid, where $= F_{\rm F} + F_{\rm B}$ and $j = j_{\rm F} + j_{\rm B}$. The behaviour of the mean explicit and molecular ferm ion number densities $F_{\rm F}^0$ and $F_{\rm B}^0$ as varies is given in the inset of Fig1.

Our earlier de nitions give $^{2}(_{\sim}) / j_{0} j j_{0} j ($

), showing that the coupling between the super uid components is due to the di erence in the phase of the ferm ionic pairs and the molecular eld . It vanishes in both the deep BCS and BEC regimes, when jojand j_0 j tend to zero respectively. Further, with Fand <u>j</u>ir j $j_B j$ in the deep BCS regime and _F в j_B j in the deep BEC regime, the system and <u>j</u>; j is described by a single uid in each case. Away from these extrem es the situation gets m ore com plicated, w ith the coupling strongest in the transition regime, but still tractable for vortices with phase coupling = ,whose properties will be pursued elsew here.

Finally, we brie y consider G ross-P itaevskii (GP) equations in the BEC regime. (For the BCS regime the results of [9] can be simply extended to $g \in 0$). The relationship of super uid equations to GP equations is well established, in principle. To each (; j) pair there is allocated a complex GP (or non-linear Shroedinger) eld . In our case the G ross-P itaevskii elds underlying (17) and (19) are $_{\rm F} = \frac{P}{_{\rm F}} e^{i} = 2$ and $_{\rm B} = = \frac{P}{_{\rm B}} e^{i} = 2$. A lthough, in general, $_{\rm F}$ has the phase of the combined condensate, but the magnitude due to the explicit ferm ion density only, it happens that, in the BEC regime,

That is, now $_{\rm F}$ / ~ , linking its phase to the condensate density.

Furtherm ore, S_{phonon} is all that is needed to extract the coupling constant of two-body interactions between the condensate. The form of this two-body interaction is

From the second term we can read o \sim directly from S_{phonon} as $\sim = (2=U) = 8j_0 j^2$. Again in the BEC regime, we nd

Let us rewrite $\sim (\sim^{\gamma} \sim)^2$ as a GP self-interaction j $_{\rm F}$ ⁴, using the renorm alization of (22). On using (24)

we nd a weakly repulsive interaction = 2 ja j-M, where $a_{\sim} = 2a_s$ and M = 2m, as follows from the strongcoupling B ogoliubov-de G ennes equations [16].

The extension of our approach to non-zero tem perature is straightforward, in principle, and will be considered elsewhere. It has yet to be seen whether, in general, the e ect of Landau dam ping can be interpreted as a norm al uid component in addition to the coupled super uids of (21), as happens for pure BCS theory [17].
