Anomalous Hall E ect in non-commutative mechanics

A bstract

The anom alous velocity term in the sem iclassicalm odel of a B loch electron deviates the trajectory from the conventional one. When the Berry curvature (alias noncommutative parameter) is a monopole in momentum space, as found recently in some ferromagnetic crystals while observing the anomalous Halle ect, we get a transverse shift, similar to that in the optical Halle ect.

1 Introduction

The Anom alous Hall E ect (AHE), characterized by the absence of a magnetic eld, is observed in some ferrom agnetic crystals. While this has been well established experimentally, its explanation is still controversial. One, put forward by Karplus and Luttinger [1] fly years ago, suggests that the e ect is due to an anom alous current.

M any years later, it has been argued [2] that the sem iclassical dynam ics of a Bloch electron in a crystal should involve a Berry curvature term,

In the nth band the equations of motion read, in an electromagnetic eld,

$$k = eE + e\underline{r} \quad B (r); \tag{2}$$

where $r=(x^i)$ and $k=(k_j)$ denote the electron's intracell position and quasim om entum, respectively; $_n(k)$ is the band energy. The relation (1) exhibits an anom alous velocity term, k-, which is the mechanical counterpart of the anom alous current.

The model is distinguished by the non-commutativity of the position coordinates: in the absence of a magnetic eld, $fx^i; x^j g = {}^{ijn}$ $_n$ [3, 4]. In the free noncommutative model in 3 space dimensions, can only be momentum-dependent such that θ_{k_i} $^i = 0$ [3].

A rem arkable discovery concerns the AHE in the metallic ferrom agnet $SrRuO_3$. Fang et al. [5] found in fact that the experimental data are consistent with taking the form of a monopole in momentum space,

 $k \in 0$. (3) is, furtherm ore, the only possibility consistent with rotational sym m etry [3].

Here we propose to study the AHE in the sem iclassical fram ework (as advocated in [6]), with non-commutative parameter (3). For B = 0 and a constant electric eld, E = const. and assuming a parabolic prole $_n$ (k) = k^2 =2, eqn. (2), k= eE, is integrated as k(t) = eE t + k_0 : The velocity relation (1) becomes in turn

where $b=k_0$ [\hats" denote vectors normalized to unit length]. The component of k_0 parallel to E has no interest; we can assume therefore that k_0 is perpendicular to the electric eld. Writing $r(t)=x(t)k_0+y(t)k_0+z(t)k$, eqn. 


Figure 1: The anomalous velocity term deviates the trajectory form the plane.

becomes a half-integer upon quantization, = N = 2, and hence (6) is indeed $N = k_0$. The constant $k_0 \in 0$, the minimal possible value of momentum, plays the role of an impact parameter. Let us observe that while (6) does not depend on the eld E or the electric charge e, the limit eE! 0 is singular. For eE = 0, the motion is uniform along a straight line.

The transverse shift is rem in iscent of the recently discovered optical Hall e ect [7] and can also be derived, just like in the optical case, using the angular momentum. The free expression [3], J=r k k; is plainly broken by the electric eld to its component parallel to E,

 $= \frac{eE t}{k_0^2 + e^2E^2t^2};$ (7)

whose conservation yields once again the shift (6).

How can the same argument work for a Bloch electron and for light? The answer relies, for both problems, on having the same $\mbox{k-m}$ onopole" contribution, \mbox{k} in the angular momentum.

Our model is plainly not realistic: what we described is, rather, the deviation of a freely falling non-commutative particle from the classical parabola found by Galileo. Particles in a metalare not free, though, and their uniform acceleration in the direction of Eshould be damped by somemechanism. It is nevertheless remarkable that we obtain qualitative information from such a toy model.
