# T im e-convolution less master equation for $m$ esoscop ic electron-phonon system $s$

#### Abstract

The tim e-convolutionless $m$ aster equation for the electronic populations is derived for a generic electron-phonon $H$ am iltonian. The equation can be used in the regim es where the golden rule approach is not applicable. T he equation is applied to study the electronic relaxation in several models w th the nite num ber norm alm odes. For such $m$ esoscopic system $s$ the relaxation behavior di ens substantially from the sim ple exponential relaxation. In particular, the equation show $s$ the appearance of the recurrence phenom ena on a tim e-scale determ ined by the slow est $m$ ode of the system. T he form al results are quite general and can be used for a w ide range of physical system s . N um erical results are presented for a two level system coupled to a 0 hm ic and super-o hm ic baths, as well as for a a m odel of charge-transfer dynam ics betw een sem iconducting organ ic polym ers.


## I. IN TRODUCTION

The P aulim aster equation and the $R$ ed eld equation have long been applied to ${ }^{1} y$ of relaxation dynam ics in electronic system : T hese equation were originally derived using sem l-neuristic argum ents. H w w ever, w it ${ }^{1}$ vent of projection operator techniques in 1960's it becam e clear that such $m$ aster equations could be ootained from form ally exact generalized $m$ aster equations through a series ofw ellde ned approxim ations. Such approxim ations are usually justi ed when the system of interest is coupled to a them ostat w ith a large num ber of degrees of freedom. In this lim it, the resultant transition probabilities in the $P$ aulim aster equation are identical to se obtained by the less rigorous golden rule approach
$T$ he case when the them ostat is $m$ esoscopic (i.e. $w$ ith a nite num ber ofm odes) is less well studied. In general, for this case the tim e independent transition probabilities of the golden rule type $m$ ay not be well de ned since the kemels of the generalized $m$ aster equations do not van ish in the lim itt! 1 . O urgoalin this paper is to develop a the convolutionless generalized $m$ aster equation suitable for a m esoscopic electron-phonon system using the fact that this equation becom es form ally exact for arbitrary system sizes. In contrast to the derivation of the Pauli $m$ aster equation, the only approxim ation that we w illuse is that of weak coupling. A s a result we will arrive at a $m$ aster equation $w$ ith tim e dependent rate coe cients.

[^0]II. HAM ILTONIANAND THE IN IT IAL STATE

A wide class of the electron-phonon system s can be described by the follow ing $H$ am iltonian ( $h=1$ )

Here jni's denote electronic states with vertical energies $n, a_{i}^{y}$ and $a_{i}$ are the creation and annihilation operators for the norm alm ode iw th frequency $!_{i}$, and $g_{n m}$ i are the coupling param eters of the electron-phonon interaction which we take to be linear in the phonon norm alm ode displacem ent coordinate.

W e can separate $H$ into a part that is diagonalw ith respect to the electron ic degrees of freedom,

where the prim e at the sum $m$ ation sign indicates that the term $\mathrm{s} w$ th $\mathrm{n}=\mathrm{m}$ are excluded. This separation is useful for the follow ing tw o reasons. First, in $m$ any system $s$ only o -diagonalcoe cients $\mathrm{gnm}_{\mathrm{n}}$ are sm all com pared to $g_{n n i} . H$ ence, $V$ can be treated as a perturbation. Second, form any cases of interest, the initialdensity $m$ atrix com $m$ utes with $\mathrm{H}_{0}$. In this case, the separation gives sim pler form $s$ of the $m$ aster equations.

For further analysis it is convenient to diagonalize $\mathrm{H}_{0}$ w th respect to the norm al m ode degrees of freedom. T his is achieved w ith the unitary operator

T he sim ilar unitary transform ations replied to the electron-phonon H am iltonians before As can be seen from Eq in the transform ed picture the electronic transitions from state jin to jn i are accom panied not only by the creation or annihilation of a single phonon of m ode $i$ but also by the displacem ents of all the nom al m odes.

Let us take for the initial density $m$ atrix

$T$ he qualitative behavior of the probabilities $P_{n}(t)$ depends on the evnlicit form of the time dependent rates $\mathrm{W}_{\mathrm{m}} \mathrm{n}(\mathrm{t})$ in Eq , D epending on a particular system, certain simpli cations of $\mathrm{Wm}_{\mathrm{m}}(\mathrm{t})$ are possible. In particular, for large system s we can expect the integrand in

IV. RELAXATION IN MODEL ELECTRON PHONON SYSTEMS

In what follow S , we exam ine the solution of the $P$ auli equation for a num horofm odel system susing the correlation functions (Eq de ned above. W e take two exam ples, one in consisting of a tw o state electronic system coupled to a single acoustic phonon branch w ith O hm ic and super- hm ic couplings. The other taken from our recent w ork in describing secondary exciton form ation at the dom ain boundary in organic polym er sem iconductor hetero junctions. W e also, then com pare the results obtain using the present $m$ ethod to those obtained using M arcus' form ulation of the rate-constant.

## A. O hm ic vs. Super-O hm ic C oupling

As our rst example we consider a system with two electronic levels coupled to N norm alm odes w ith frequencies $!_{i}=A \sin (i=2 N) w$ ith $i 2[1 ; N]$ that model the acoustic phonon branch. W e w ill choose the coupling coe cients in the follow ing form $g_{12 i}=g_{21 i}=g_{11 i}=$
$\left(!{ }_{i}\right)^{\mathrm{p}}$ and $g_{22 i}=\left(!_{i}\right)^{\mathrm{p}}$, where and p are param $e^{-}$ ters. $W$ e w ill consider the cases of $p=1=2$ and $p=0$ that correspond approxim ately to the O hm ic and superO hm ic baths in the golden rule approach to relaxation.

Taking the initial state to be prepared in the higherlying electronic state, electronic population of the higher electronic state as a function of tim $e$ is show $n$ on $F$ ig

It can be seen that the relaxation does not follow a sim ple exponential decay. This behavior can be understood by looking at the explicit form of the rate coe cients $W$. ( $t$ ) and $W_{21}(t)$ as functions of tim $e$ as show $n$ on $F i g$ For the super-0 hm ic case. O nly after the rate coe cientsioecom e nearly constant in tim e does exponential relaxation occur. For the chosen param eter values, substantial nonexponential relaxation occurs before that tim e. N ote the for the chosen param eters the com plete electronic relaxation occurs before the onset of any possible recurrence phenom ena due to the nite num ber ofm odes. Such recurrences will occur at the tim e scale of the order of 2
divided by the sm allest norm alm ode frequency. It can also be seen on Fig. 2 that coe cients $W 12$ ( t ) and $\mathrm{W}_{21}$ ( t ) can acquire negative values. This is in contrast to the golden rule approach where the coe cients are alw ays positive and tim e independent. Because of the tim e dependence of coe cients $\mathrm{W}_{12}(\mathrm{t})$ and $\mathrm{W}_{21}$ ( t ) and their ap proxim ate nature the tim e-convolution less $m$ aster equation is not guaranteed to preserve the positivity of probabilities. Fig. 2 also show s the electronic relaxation for the Ohm ic m odel obtained by applying the golden rule to the $H$ am iltonian when coe cients $g_{n n i}$ are treated on the sam e basis as $g_{n m}$ ( $n \in m$ ). No reliable golden rule results can be obtained for the super-0 hm ic case because of the relatively sm all num ber of $m$ odes in the $m$ odel.

## B. Exciton regeneration at a sem iconductor interface

As another exam ple we consider the electronic relaxation in the conjugated $p$ rojunctions previously investigated in Ref . by a di erent approach. H ere we consider the decay or an excitonic state into a charge-separated state at the interface between two sem iconducting polym er phases (TFB) and (F 8B T). Such $m$ aterials have been extensively studied for theirpotential in tovoltaics At the phase boundary, the ma -

terial form s a type-II sem iconductor hetero junction with the o -set betw een the valence bands of the tw o $m$ aterials being only slightly $m$ ore than the binding energy of an exciton placed on either the TFB or F8BT polym er. As a result, an exciton on the F8BT side will dissociate to form a charge-separated (exciplex) state at the interface.

O rdinarily, such type II system sare best suited for photovoltaic rather than LED applications H ow ever, LED s fabricated from phase-segregated $50: 50$ blends of T FB F 8B T give rem arkably e cient electrolum inescence e ciency due to secondary exciton form ation due the back-reaction

as therm alequilbrium betw een the excitonic and chargetransfer states is established. T his is evidenced by longtim e em ission, blue-shifted relative to the em ission from the exciplex, accounting for nearly $90 \%$ of the integrated photo-em ission.

H ere, as above, as consider only tw o low est electronic levels corresponding to

As was shown in Ref. for such system $s$ there are tw o groups of pnonon $m$ odes that are coupled strongly to the electronic degrees of freedom as evidenced by their presence as vibronic features in the vibronic em ission spectra, nam ely: low frequency torsionalm odes along the backbones of the polym er and higher frequency $C=C$ stretching $m$ odes. The nom alm odes $w$ thin each group have about the sam e frequencies and form tw o sepfor speci c details regarding the param eteri-
zation of the $m$ odel.

A s before, we consider the initial state as being prepared in the X T istate corresponding to photoexcitation of the F8BT polym er. The results for the higher electronic bryel population obtained by num erically solving Eq. are shown on $F$ ig The tim e dependonce of coe clents $W_{12}(t)$ and $W_{21}(t)$ is show $n$ on $F$ ig A s in the previous exam ple the electronic relaxation does not follow a sim ple exponentialpattem. Them ain di erence betw een this $m$ odel and the previous exam ple is that the electronic relaxation tim $e$ is of the sam e order as the recurrence tim e for 000 cients $W 12$ ( $t$ ) and $W_{21}(t)$. A s can be seen from $F$ ig
cients has the form of approxim ately constant regions abruptly changed at regular recurrence intervals. This type of tim e dependence $m$ akes the electronic relaxation look like a series of exponentialrelaxationsw ith changing rates. A s in the previous exam ple, coe cientsW 12 ( t ) and $\mathrm{W}_{21}(\mathrm{t})$ can becom e negative as the relaxation proceeds tow ards the equilibrium population.
$N$ ote also, that the because the relaxation does not obey a simple exponential rate law, the in itial decay slightly \overshoots" the nal equilibrium population. $T$ his is $m$ ost evident in the highest tem perature case considered here ( $T=340 \mathrm{~K}$ ). Since the X T i is also the em issive state, photo-em ission (not inchuded herein) depletes this population on a nanosecond tim e scale (radiative lifetim e). Population back-transfer from the $\mathbb{X}$ Ti to $m$ aintain a them alequilibrium population then leads to the continuous replenishm ent of the em issive species such that nearly all of the CT population contributes to lary (regenerated) excitonic states

It is of interest to com pare the relaxation dynam ics in TFBF8BT hetero junction obtained through the application of the tim e-convolutionless $m$ aster equation $w$ ith other approaches. As an exam ple we will consider the M arcus-type approach which is wid-..................... tron transfer in chem ical system $s$ Because of the coordinate dependency or the coupling, som e
care $m$ ust be taken in deriving the M arcus rates and we give details of this in the appendix. The results for the relaxation dynam ics using these rates applied to TFBF8BT heterojunction for three di erent tem peratures are show $n$ in $F$ ig It can be seen that apart from a $m$ ore com plicated tim e aependence them aster equation approach gives faster relaxation when com pared to the $M$ arcus-type picture. The discrepancy betw een the two approaches can be explained by the fact that the $M$ arcus approxim ation is assum ed to be valid when $k T \quad h!i$ for all the norm alm odes. In the case of the TFB F8BT heterojunction this condition is not satis ed for the higher frequency m odes.
V. CONCLUSION S

W e derived the explicit form of the tim econvolutionless $m$ aster equation for the electronic populations in the electron-phonon system s. W e applied it to study the electronic relaxation in the tw o-levelelectronic system scoupled to the Ohm ic and super- Ohm ic baths, as well as in the realistic con jugated polym er heterojunction. The time evolution of the electronic populations is, in general, $m$ ore complex then the one obtained with the Paulim aster equation and depends on the explicit form of the tim e dependent coe cient. $T$ he tim econvolutionless $m$ aster equation can account for the appearance of recurrence e ects in sm aller electron-phonon system s.
