# Quantum Dynamics of Spin W ave Propagation Through Domain W alls

Through numerical solution of the time-dependent Schrodinger equation, we demonstrate that m agnetic chains with uniaxial anisotropy support stable structures, separating ferrom agnetic domains of opposite m agnetization. These structures, domain walls in a quantum system, are shown to remain stable if they interact with a spin wave. We not that a domain wall transmits the longitudinal component of the spin excitations only. Our results suggests that continuous, classical spin m odels described by LLG equation cannot be used to describe spin wave-domain wall interaction in microscopic m agnetic system s.

KEYW ORDS: quantum spin model, nanom agnetic, dom ain wall, Schrodinger equation

### 1. Introduction

Wave propagation in one-dimensional magnets through a magnetic domain wall (DW) is an interesting topic in quantum many-body physics. A DW separates two regions with opposite magnetization. The DW in m esoscopic wire can be considered to be self-assembled stable nanostructures which is treated as a kind of soliton in a continuous medium. Such structure can be created or annihilated by some external action. The manipulation of DW in stripes has already been proposed as a way of storing information or even performing logic functions, and to o er new types of electronics devices<sup>1</sup> in which the DW motion carries the inform ation along a magnetic wire of submicrom eter width, with DW velocities up to thousand kilom eters per second.<sup>2)</sup> Recently, a direct observation of the pendulum dynamics of a DW has been reported.<sup>3)</sup> The DW as a topological particle has a very small but nite mass of 6:6 10<sup>23</sup>kg.<sup>3,4)</sup>

The structure of DW s and also wave propagation in one-dimensional classical spin system s has been studied in Refs.<sup>5,6</sup> Recently, the interaction between DW s and spin waves has attracted a lot of interest. Hertel et al showed that the DW induced phase shift of spin waves in the Landau-Lifshitz-G ilbert (LLG) m odelofthin, narrow strips, is a characteristic property of such system s.<sup>8</sup> The value of the phase shift of spin waves passing through a DW was found to be proportional to the angle by which them agnetization of DW rotates in the lm plane.<sup>8</sup> This e ect m ight be used as a concept for a new generation of nonvolatile mem ory storage and logical devices.<sup>8</sup>

On the other hand, recent progress in synthesizing materials containing ferrom agnetic chains<sup>9(12)</sup> opens new possibilities to study the interaction between a spin wave and a DW in a microscopic spin chain. Furthermore, quantum spin models provide a playground to investigate how quantum information can be transferred in quantum spin networks.<sup>13(15)</sup> But, in contrast to the nanoscale phenomena mentioned earlier, on the atom ic




Fig. 1. Left pictures (a,b,c,d): Spin con gurations at time t= = 0; R ight pictures (e,f,g): D ynam ically stable spin con gurations for the H eisenberg-Ising m odel ( = 2), at time t= = 100. (e): Ferrom agnetic state of the spin chain; (f): State containing a DW at the center of the chain; (g): State containing two DW s. R ight picture (h): Spin con guration at time t= = 100 for the H eisenberg m odel ( = 1), illustrating the instability of the initial dom ain wall state (d).

level, the spin dynamics is purely quantum mechanical and in such strongly quantum uctuating system sitm ust be described by the time-dependent Schrodinger equation (TDSE). Then, it is of considerable interest to com pare the properties of spin wave propagation through a magnetic dom ain boundary in a single spin chain with the dynamics obtained in mesoscopic system, in which the magnetization is regarded as a classical, continuous variable. In the nanoscale regime, the DW is de ned as the boundary of regions with opposite magnetization. On the atom ic level, a DW may be de ned as a structure that is dynamically stable under quantum mechanicalmotion, the existence of which has to be con rm ed.

#### 2. Dynam ically Stable Dom ain W alls

In this paper, we study the stability of DW s and the e ects of DW s on the spin wave propagation in a chain

of N sites on which we place S = 1=2 spins. We solve the TD SE to compute the time-evolution of the magnetization at each lattice site. The Ham iltonian of the spin chain is given by<sup>16)</sup>

where the exchange integrals J > 0 and J determ ine the strength of the interaction between the x, y and z components of spin 1=2 operators  $S_n = (S_n^x; S_n^y; S_n^z)$ . We solve the TD SE by the Chebyshev polynom ial algorithm which is known to yield extrem ely accurate solutions of the TD SE, independent of the time step used.<sup>17(20)</sup> W e display the results at time intervals of = =5J. W e present results for system s containing N = 26 spins only. W e checked that simulations for N = 20 spins (data not shown) yield qualitatively sim ilar results. In our num erical work, we use units such that ~ = 1 and J = 1.

First, we study the stability of DW s. The left panel of Fig. 1 shows the spin con gurations that we take as the initial state (t= = 0) in the simulation. All the results shown in this Letter have been obtained using open boundary conditions. We let the system evolve in time according to the Ham iltonian Eq.(1) for a long time (t= = 100) and nd that the motion generates a dynam ically stable state with DW (s) (see Fig.1(fg)). The DW is de ned as the boundary between regions of di erent m agnetization but it is not trivial that these boundaries exists in the presence of strong quantum uctuations.<sup>7)</sup> Figure 1 (e,f,g) shows the dynam ically stable spin congurations obtained by starting from the corresponding con guration (a,b,c).

W hether or not quantum uctuations destroy the DW (s) depends on the value of the anisotropy .For the m odel Eq.(1), it is well know<sup>16)</sup> that quantum uctuations destroy the long range order of the ground state if  $1 < \langle 1 (XY - like) \text{ or } = 1$  (Heisenberg antiferrom agnet).For 1 (Ising-like) the ground state exhibits long range order. This property is rejected in the stability of con gurations that contain one or more DW s, except for = 1.0 ur num erical simulations show that con gurations with a DW are dynam ically stable if > 1.For com parison, in Fig. 1 we include the case

= 1, where the initial DW structure (Fig. 1(d)) is destroyed (Fig. 1(h)). Not suprisingly, the destructive e ect of quantum uctuations can be suppressed by increasing . Having studied systems with di erent values of , we found that = 2 is representative for the quantitative behavior of the anisotropic system s. Therefore, in this paper, we present results for = 2 only. We also checked the e ect of the boundary condition. We found alm ost the same stable DW structures in the case of periodic boundary conditions (results not shown).

## 3. Spin W ave P ropagation

We use the con guration at t = 100 as the initial con guration to study the spin wave dynam ics. We generate a spin wave excitation by rotating the left most spin S<sub>1</sub> in Fig. 1 (e,f,g). For reference, we also consider the dynam ics of the ferrom agnet (see Fig. 1 (a,e)). This




Fig. 2. (color online) Time evolution of the magnetization  $hS_n^z$  (t)i of the Ising-like spin chain with = 2. The initial con guration (t= = 0) of each panel (a,b,c) is shown in Fig.1(a,b,c), respectively. At the time t= = 100, the rst spin (n = 1) is ipped, generating a longitudinal spin wave.




Fig. 3. (color online) T in e evolution of the transverse component  $hS_n^{\times}$  (t)i of the magnetization, for the same cases as those shown in Fig.2 except that the rst spin is rotated by =2 about the y-axis (instead of ip) at the time t= = 100.

case without DW can be analyzed analytically, so that it also gives check of precision of num erical calculation. A ctually, we found very sm all di erence between the analytical results and num erical ones.

In Fig.2(a) we show the time evolution of  $fhS_n^z$  (t) ig for n = 1; ::: N after ipping  $S_1$ , in the case of the uniform




Fig. 4. (color online) Time evolution of the magnetization  $S_N^z$  (t) . (a) spin wave generated by ipping the rst spin  $S_1$ ; (b) spin wave generated by rotating the rst spin  $S_1$  by =2 about the y-axis. Solid (black) line: N o DW, corresponding to the spin con guration Fig.1(e); D ashed (red) line: one DW, corresponding to the spin con guration Fig.1(f). Because  $S_N^z$  (t) is negative in this case, we plot the absolute value to facilitate the com parison; D otted (blue) line: two DW s, corresponding to the spin con guration Fig.1(g). Com parison of (a) and (b) shows that the time sat which the  $S_N^z$  (t) reaches one of the minim a does not depend on m ethod by which the spin wave is generated.

chain. The time evolution of  $fhS_n^z$  (t)ig for n = 1;:::Nin the chain with one DW at n = 13;14 is depicted in Fig. 2(b), and Fig. 2(c) shows the results for the chain with one DW at n = 10;11 and another DW at n = 17;18. Hence, we demonstrate that even in the presence of a spin wave, the DW structure remain stable. In the model Eq.(1), the magnetization in the z-direction is a conserved quantity. Hence, by ipping one or more spins we change the total magnetization of the initial state. The expectation value of the transverse spin com – ponents is identically zero  $(hS_n^x (t)i = hS_n^y (t)i = 0$  for n = 1;:::N, for all t > 0.

From Fig.2, we can deduce how the spin wave is scattered by the DW (s). The triangular pattern in Fig.2 (a) m erely results from the re ection of the spin ip excitation by the other edge of the chain. The triangular pattern is also present in Fig.2 (b), but the presence of the DW causes  $hS_n^z$  (t) i to change sign if n > N = 2. Fig. 2 (b) also dem onstrates that the DW itself is extrem ely robust, even in system s with one spin ipped. A sim ilar behavior is observed for the case of two DW s (see Fig. 2 (c)), indicating that the change of sign at the DW is generic.

The slope of the line in Fig. 2 from the point (n = 1;t= = 100) that connects spin 1 and spin N is directly related to the velocity of the excitation.W e can estimate the time of the excitation to propagate from site n to site m by analyzing the in nitely long chain. Starting from an initial state in which we ip the spin at site n, the




Fig. 5. (color online) T in e evolution of  $S_N^{\times}$  (t) of the same system as in Fig. 3, plotted on two di erent scales. Solid (black) line: N o D W, corresponding to the spin con guration Fig. 1(e); D ashed (red) line: O ne D W, corresponding to the spin con guration Fig. 1(f). D otted (blue) line: Two D W s, corresponding to the spin con guration Fig. 1(g).

magnetization at site m is given by

where jn i denotes the ferror agnet state with a ipped spin at sitem and  $J_m$  (x) is the Bessel function of the rst kind of order m. Although Eq. (3) is valid for the in nite chain only, we may expect that it provides a qualitatively correct description of the wave propagation in the nite system . Our numerical calculations (results not shown) demonstrate that for N 16, the time for the excitation to travel from n = 1 to m = 26 agrees within 2% with the rst minimum of Eq. (3).

A lthough it is clear that the longitudinal motion of the spin that results from the spin ip can easily propagate through the DW structures, quantum uctuations reduce the amplitude of the excitation and for t= > 250it becomes di cult to follow the excitation in Fig. 2 (b,c). A smentioned earlier, we could increase to reduce the quantum uctuations but this does not change the qualitative features that we are interested in.

Next, we study the propagation of the transverse com – ponents, that is the x or y com ponents of the expectation values of the spins. At t= = 100, we excite the system by rotating the rst spin in Fig. 1 (e,f,g) by =2 about the y-axis. A fler this rotation, the m agnetization of spin  $S_1$  is parallel to the x-axis. Starting from this con guration, the tim e evolution will cause the rst spin to rotate about the z-axis (due to the presence of the neighboring spin that is pointing in the z-direction). This then gener-

ates spin waves that contain both longitudinal fhS<sub>n</sub><sup>z</sup> (t) ig and transverse (fhS<sub>n</sub><sup>x</sup> (t) ig, fhS<sub>n</sub><sup>y</sup> (t) ig) components.

The space-time diagram of  $hS_n^z$  (t)i boks very similar as Fig. 2 and therefore we do not show it. Now, we investigate the propagation of the transverse spin waves by considering one of the two components (the actual choice is irrelevant). In Fig. 3, we present results for the time evolution of  $hS_n^x$  (t)i for n = 1 to N. In the Ising-like H eisenberg chain w ithout a DW, the transverse spin waves propagate in the same manner as the longitudinal waves. (com pare Fig. 2 (a) and Fig. 3 (a)). How ever, from Fig. 3 (b,c) it is clear that the transverse waves do not propagate through the DW structure but are re ected instead.

For a more quantitative study of the interaction of DW (s) and spin waves in quantum spin chains, we analyze in detail, the time evolution of the right-most spin. In Fig. 4 we plot  $hS_N^z$  (t) i as a function of time for the six cases depicted in Figs. 2 (Fig. 4(a)) and 3 (Fig. 4(b)).

From Fig. 4, we conclude that the propagation of longitudinal spin waves in the two cases is essentially the same, except for the amplitude. Rotating the rst spin by =2 (instead of in the case of the spin ip) about the x or y axis generates waves of which the amplitude of the longitudinal component at the site N is half of that of the spin- ip case. Using Eq. (3) and the fact that J<sub>25</sub> (x) has a rst maximum at x 27:4, we nd that hS<sup>z</sup><sub>26</sub> (t) i has a minimum at t= 144. This value is in agreem ent with the time at which the num erical solution for the N = 26 chain exhibits a rst dip (see black (solid)) line in Fig. 4(a)). A rst conclusion from this analysis is that the qualitative aspects of the interaction of the longitudinal spin wave excitation and the DW (s) does not depend on the transverse components of the spin wave.

Fig.4 also clearly shows that the presence of a DW increases the speed at which the excitation travels through the DW. C om paring the curves for the system without DW, one DW, and two DW s, we conclude that the solid curve lags behind with respect to the dashed curve, and the dashed curve lags behind with respect to the dotted curve. Thus, the longitudinal component of the spin wave excitation is shifted forward as it passes a DW.

Fig.5 shows the time evolution of  $\mathrm{K}_{\mathrm{N}}^{\times}$  (t) i. In contrast to the longitudinal component (see Fig.4), them aximum amplitude of the transverse signals strongly depend on the presence of DW (s) in the system (note the di erence in scale between Fig.5(a) and Fig.5(b)). Thus, in the quantum system, the rejection of the transverse spin wave excitation is signilicantly larger than the rejection of the longitudinal component.

#### 4. D iscussion and Summary

Finally, we point out the di erence between the continuous model for mesoscale magnetic systems and the present lattice model. In the form er, DW s exist as rotation of the spins according to a soliton structure, while in the microscopic quantum system, there is no structure in the transverse spin component and a DW is dened as a dynamically stable structure of the longitudinal components. We found that such DW s exists for 1 they are unstable. W e also > 1 whereas for studied spin wave propagation and found that the longitudinal components of the spin wave speed up when they cross a DW . The transverse components of the spin wave are alm ost totally re ected by the DW , but this characteristic feature of the microscopic quantum chain is not found in m esoscopic m agnetic system, where the transverse components crosse a DW without re ection and with a phase shift of  $=2.^{8}$  It should be noted that the system described by the LLG equation is fundam entally dierent from the system that we consider in this Letter. The form er treats the magnetic system in the meso-

ter. The form er treats the magnetic system in the mesoscopic regime as a classical, continuous medium, whereas the present study treats the magnetic system as a microscopic, quantum mechanical system. Which of these two approaches is the most suitable description obviously depends on the speci c material. The change of behavior from mesoscopic to microscopic may become important as bottom -up chemical synthesis is providing new ways for further down-sizing of the magnets.
