# Inclusion of phonon exchange in a nuclear $m$ atrix elem ent

#### Abstract

Phonon exchange with nuclei in the course of fusion reactions that occur in a solid have not been analyzed previously. This problem has becom e of interest in connection w ith claim s of observations of anom alies in $m$ etal deuterides. If the strong force interaction were dependent only on position (and not spin or isospin), then the coupling with phonons can be developed directly. Since a nuclear interaction can change the lattice constituents, the initial and nal state lattices can be di erent, and we must include this in the form ulation. For m ore realistic strong force m odels w ith spin and isospin dependence, we can use correlated nuclear wavefunctions which are $m$ ade up of products of space, spin and isospin com ponents. In this case, the spin and isospin algebra can be done analytically, producing channel-dependent potentials that are only space dependent. The form ulation that results can be used for quantitative estim ates of phonon exchange.

## I. INTRODUCTION

Few claim s have resulted in as much controversy as the claim of the observation of an excess heat e ect of nuclear origin in $m$ etal deuterides $m$ ade by $F$ leischm ann, $P$ ons, and H aw kins in 1989․ R eview s of work on this problem were conducted by the Departm ent of Energy (in the U nited States) in 1989² and in $2004 \frac{3}{}{ }^{2}$ The conclusions of the 1989 review were very negative. The 2004 review was quite di erent in how it was carried out, what $m$ aterial was reviewed, and in the results. O $n$ the speci c question of the existence of an excess pow er e ect, which was the central issue of the review material presented to D oE, $\boldsymbol{r}^{4}$ there w ere $m$ ore positive com $m$ ents than negative com $m$ ents volunteered from the review ens. $\frac{5}{-}$ $T$ his is signi cant, as D oE did not charge the review ers to consider this question speci cally. A $m$ ong $m$ any other com $m$ ents that w ere $m$ ade, several of the review ers suggested that m ore work on this problem be subm itted to $m$ ainstream juumals.

O ur interest in this paper is not focused on the question of the existence of an excess heat e ect, although this issue has motivated our investigations. W e are interested instead in theoretical issues which $m$ ust be better understood in order for theory to be m ore relevant to the problem. Form ost physicists, the theoretical problem w as adequately addressed by H uizenga, w ho argued that three \m iracles" w ere required for a theoretical explanation $\frac{6}{}$

The rst $\backslash m$ iracle" involves the question ofreaction rate. T he excess heate ect im plies reaction rates on the order of $10^{12} \mathrm{sec}{ }^{1}$, tens of orders of $m$ agnitude larger than the fastest fusion rates possible in molecular $\mathrm{D}_{2}$ or HD.

The second \m iracle" concems the branching ratio. $F$ leischm ann initially speculated that ${ }^{4} \mathrm{He}$ was being m ade from two deuterons. Such a result is seem ingly m iraculous as the branching ratio for this reaction channel is lower by about seven orders of $m$ agnitude than the prim ary $n+{ }^{3} \mathrm{He}$ and $\mathrm{p}+\mathrm{t}$ reaction channels.

The third $\backslash m$ iracle" involves the requirem ent that the reaction energy be expressed through channels not involving energetic reaction products.

If one believes that these issues are insum ountable, then one w ould require that any claim of excess heat of nuclear origin m ust be accom panied by m easurable energetic reaction products. This view was adopted by H uizenga, and by the 1989 ERAB Panel. This view is also w idely held am ong the physics com m unity at this tim e.

## A. M otivation

H ow ever, other views are possible. F leischm ann's initial speculation w as that a new physical process was involved, one that behaves di erently from what is described in the textbooks. It seems that if we are trying to understand whether an excess heat e ect
can exist, we should be asking whether there can be interactions between nuclei and a condensed $m$ atter environm ent. For exam ple, suppose that phonons are exchanged in the course of a nuclear reaction that occurs in a lattice. Could this phonon exchange result in a modi cation of the selection rules? A nd if phonon exchange occurs, would that not constilute a new channel into which reaction energy m ight go? N uclear physics relies heavily on the notion of an equivalent vacuum reaction in order to understand quantitatively fusion reactions. H uizenga's three $\backslash m$ iracles" re ect such a view. Forexam ple, the second $\backslash m$ iracle" is essentially a statem ent ofenergy, linearm om entum, and angularm om entum conservation, all of which are conserved in vacuum. Is it obvious that conservation law s in a condensed $m$ atter environm ent alw ays produce the sam e reaction pathw ays $w$ ith the sam e branching ratios; and, if so, can this be proven? In the case of the third $\backslash m$ iracle," the reaction energy $m$ ust be expressed as an energetic product in vacuum , since no other kinds of channels exist. But is it obvious that this $m$ ust also be the case in a condensed $m$ atter environm ent, where low energy channels do exist? O nce again, can this be proven? In any event, all of these questions ought to be capable of being addressed by theory.

The current lack ofsuch a theory in them ainstream literature is underscored in com $m$ ents m ade by som e reviewers in the 2004 D oE review. For exam ple, a review er w ith expertise in $m$ etal deuterides and phonons w rote: \To create a coupling between nuclear interaction and phonons at such a low energy region (nam ely, the electrom agnetic interaction) is beyond one's im agination at the $m$ om ent." A nother review er w ith expertise in nuclear theory w rote: \I am convinced that sim ple order-ofm agnitude estim ates of this kind could quidkly rule out any of the exotic $m$ echanism s proposed..." This review er argues that the $m$ atrix elem ent for the em ission of a large num ber of phonons would scale as $(k R)^{2 L}$, where $k$ is the phonon wavenumber. A side from the fact that the em ission of a large num ber of phonons in a single process was not put forth as a proposed reaction $m$ echanism in the review, the use (or m isuse) by this reviewer of a phonon wavenum ber in this way underscores the need for a relevant theory. We nd ourselves then in a position where a better understanding of phonon exchange in fusion reactions is required for a sensible discussion of these and related issues. Thism otivates us to consider in thism anuscript how to calculate phonon exchange in perhaps the sim plest application; that of an interaction $m$ atrix elem ent. Phonon exchange due to recoil in neutron capture reactions was analyzed by Lamb $\frac{7}{r}$ and this analysis has been used subsequently for phonon exchange in gam $m$ a reactions. In the M ossbauer e ect, an anom alous zero-phonon exchange e ect occurs if the recoil is su ciently gentle. 8 In our $m$ atrix elem ents recoil is involved im plicitly, and phonon exchange due to the local change in lattice structure w ill appear explicitly.

## B . Excitation transfer schem e

In the follow ing sections of this $m$ anuscript, we develop a form ulation suitable for including phonon exchange in nuclear reaction $m$ atrix elem ents. O nce arm ed w ith this tool, we are in a position to develop calculations relevant to candidate reaction schem es that involve phonon exchange (of which quite a few have been proposed over the years). Our current interest is focused on a particular schem e in which coupling occurs betw een nuclei at di erent sites as a result ofphonon exchange with a com $m$ on phonon $m$ ode. In this schem $e, t w o$ deuterons fuse locally w ith the reaction energy transferred elsew here through a second-order o -resonant excitation transfer e ect. The system atics of this e ect in the idealized case of two-level system s coupled to a com $m$ on oscillator is discussed in a recent analysis. $\frac{9}{9}$ In essence, the reaction energy is transferred to excited states in host lattioe nuclei through an initial slow excitation transfer step, and then subsequent rapid excitation transfer occurs am ong these nuclei. The reaction energy is transferred to the phonon $m$ ode in this schem e a few phonons at a tim e in a very large num ber of fast excitation transfer reactions. T he schem e seem s to be closely related to experim ent, and the reaction rate predicted appears to be consistent $w$ ith experim ent to $w$ ithin uncertainties in the deuteron-deuteron screening. The evaluation of this schem e requires the ability to evaluate phonon exchange in fusion reactions as discussed in the present $m$ anuscript.

H uizenga's argum ents are based ultim ately on fundam ental notions relevant to vacuum reactions, local energy and $m$ om entum conservation, and the use of Golden $\mathrm{R} u$ le reaction rate estim ates, as discussed above. In this new excitation transfer schem e, the energy of the coupled system is conserved, but local energy is transferred elsew here. In addition, the associated reaction dynam ics do not follow sim ple G olden R ule predictions. H uizenga's argum ents sim ply do not apply to this kind of schem e.

## C. O verview of the paper

This paper is organized as follows. In section II we discuss the basic lattioe-nuclear coupling (assum ing a sim pli ed nuclear potential model that depends only on position), and argue that it is very sim ilar to the m ore fam iliar electron-phonon and neutron-phonon couplings. H ow ever, realistic nuclear potentials depend on spin, isospin, and parity. In Section III we show that for realistic nuclear potentials, by rst doing the spin and isospin algebra analytically, the ideas developed in Section II are relevant. In Section IV , using the H am ada-Johnston nuclear potential, we explicitly carry out the program outlined in Section III for one particular $m$ atrix elem ent relevant to a deuteron-deuteron fusion reaction. This particular interaction is chosen because it is one of the sim plest realistic nuclear potentials. In Section V we extend this vacuum result to include the lattioe. W e nd in Section V I an explicit expression for one of the integrals that appears in the interaction $m$ atrix elem ent in
term s ofphonon coordinates. This result is closely related to the discussion in Section II. A sum $m$ ary and conclusions is given in Section VII.

A though the essential issues involved in phonon exchange can be seen w ith the sim pli ed position-dependent potential, we need to work w ith nuclear wavefunctions that depend on spin and isospin when using a m ore realistic nuclear potentialm odel. The construction of these general four-body correlated nuclear wavefunction requires the use of certain aspects of representation theory, and $m$ ay be unfam iliar to som e of the readers. A s a result, we have included $m$ aterial in a set of appendices that provide further discussion of the wavefiunction construction and usage in $m$ atrix elem ent calculations.

## II. P H O N O N INTERACTIONS

W e are interested in the basic issue of phonon exchange in association with nuclear reactions in a lattice. The form ulation that follow $s$ in subsequent sections is com plicated, and it $m$ akes sense to review phonon exchange in $m$ ore fam iliar circum stances. In condensed $m$ atter physics, phonon exchange is of interest in the study ofelectron scattering and neutron scattering. In both cases, phonon exchange com es about through a form ulation in which the center ofm ass coordinates of the nuclei are taken to be phonon operators.
A. Phonon exchange associated with electronic transitions

For exam ple, electron-phonon interactions can be developed ultim ately starting from the C oulom b interaction written in the form 10

$w$ here the $\mathrm{x}_{\mathrm{k}}$ are the electron coordinates, and the $\mathrm{Z}_{\mathrm{j}}$ are the e ective charges on the ions. $T$ he $\hat{R}_{j}$ are the nuclear center ofm ass coordinates, which are dynam ical, and which we think of in term $s$ of lattice operators ( $\mathrm{f}_{n}$ )

In this way of thinking about the problem, we could de ne a phonon interaction by integrating over electronic coordinates

In the event that the electronic transition results in a change in the local force constants, the initial and nal state lattice $m$ ay di er enough that this should be re ected in the $m$ atrix elem ent.

A sim ilar approach can be used in the case of neutron scattering. In the case of a sim ple position-dependent interaction

In these equations $r_{n}$ is the neutron coordinate. $W$ ith a know ledge of the phonon interaction, we can analyze phonon exchange using $M_{\text {fi }} m$ atrix elem ents as calculated above.

## C. Phonon exchange in a sim pli ed $m$ odel for nuclear reactions

W e might choose to work w ith an approxim ate position-dependent nuclear interaction $m$ odel that is a function of spatial coordinates alone

where and refer to nucleon (neutron and proton) coordinates. T he interaction matrix elem ent in this case can be w rilten as
where the integration here is taken over individual nucleon coordinates. A nuclear reaction $m$ ay result in the in itial lattice being di erent than the nal lattice. For exam ple, if two deuterons reacted to form ${ }^{3} \mathrm{H}$ e+ n , the initial lattioe would contain the two deuterons while the nal lattige would have ${ }^{3} \mathrm{He}$ and a possibly free neutron. W e note that in a norm al version of this reaction, the nal state products would yo as energetic nuclear products; we consider this possibility to be included w thin the form ulation under discussion.

H ow ever, this description does not yet $m$ ake clear the situation $w$ ith respect to phonon exchange. For this, we need to rew rite the integral in term $s$ of phonon coordinates rather than in term s of nucleon coordinates. To m ake progress, we can express individual nucleon coordinates that are associated w ith nuclei in term $s$ of the nuclear center ofm ass coordinates R and relative intemal nuclear coordinates

Since a nuclear reaction $m$ ay result in a change in nucleibetween the initial states and the nalstates, the set of center ofm ass coordinatesm ay be di erent. C onsequently, the nuclear interaction $m$ atrix elem ent can be w rilten form ally as


W e integrate over all initial and nal state center of m ass and intemal coordinates, and require that the individual nucleon coordinates be the sam e in the initial and nal states.

O nœ we have a description in term s of the nuclear œenter of $m$ ass coordinates, we can rew rite the integrations in term sofphonon coordinates. To sim plify things, wem ight assum e product states of the form

D ue to the change in the lattice structure, the phonon $m$ ode structure can be altered. 11,12 $T$ he associated $m$ atrix elem ent w ritten in term $s$ of initial state and nal state coordinates [equation (15)] is com m on in papers on Franck-C ondon factors in polyatom ic m olecules. ${ }^{\frac{13}{}}$

Phonon exchange in electron and neutron scattering can be im plem ented using the local nuclear center of $m$ ass operators as phonon operators. This leads to a straightforward description of $m$ atrix elem ents that include phonon exchange, as well as the developm ent of phonon exchange operators. In the case of a nuclear reaction, we can de ne a nuclear interaction $m$ atrix elem ent sim ply enough under the assum ption of a position-dependent potential as long as we work with nucleon coordinates. However, when the integral is rew ritten in term s ofphonon $m$ ode am plitudes, the resulting expression ism ore com plicated. The underlying ideas and approach are very sim ilar. The im portant $m$ essage here is that a nuclear interaction $m$ atrix elem ent expressed in term $s$ of the nucleons of the lattice is com pletely straightforw ard, and it is only the bookkeeping associated w ith the assem bly of nucleons into nuclei, and nuclei into phonons, that adds som e com plication to the problem .

There are basic di erenœes between the new problem and the well known electron and neutron scattering problem swhich deserve to be noted.

The energy scales in the case of nuclear reactions are not $m$ atched; typical nuclear reaction energies are on M eV scale, whereas the maxim um phonon energies are typically 100 meV or less.

A nuclear reaction involving a change in the nucleon content of the product nuclei w ill likely produce phonon exchange, if for no other reason than the fact that such reactions will produce a change in the structure of the lattice.
III. FORMALCALCULATION W ITH A REALISTIC POTENTIAL

Forquantitative results, wew illneed to use a realistic nuclear potential. In atom ic physics and solid state physics, we are fam iliar w ith wavefunctions that have both spin and space dependence. Nuclear wavefunctions have in addition isospin dependence. In the isospin schem e, a nucleon can be in an isospin down state j\#i in which case it is a neutron, or it can be in an isospin up state $j$ " $i$ in which case it is a proton. It was recognized early on in nuclear physics that the nucleon-nucleon potential is of short range in space, and depends explicitly on both spin and isospin. O ver the past 60 years, increasingly accurate nuclear potentialm odels have been developed. Early m odels w ere based in part on eld theoretical $m$ odels for the one-pion exchange, and in part on few param eter em pirical models that were $t$ to scattering data. In recent years, the $m$ ost accurate nuclear potential models have been constructed from a diagram $m$ atic analysis of an e ective eld theory. 14,15 For the purposes of the present paper, wew illadopt an early potentialm odel (the H am ada-Johnston


## A. H am ada-Johnston potential

The H am ada-Johnston potentialbetw een nucleon 1 and nucleon 2 appears in the literature w rilten as

$T$ his potential is $m$ ade up of four basic term $s$ : a central potential $V_{C}$; a tensor interaction $\mathrm{V}_{\mathrm{T}} \mathrm{S}_{12}$; a spin-orbit term $\mathrm{V}_{\mathrm{LS}}(\mathrm{L}: S)$; and a generalized centripetal potential term $\mathrm{V}_{\mathrm{LL}} \mathrm{L}_{12}$. These are discussed further in Appendix A. The central and tensor term s have isospin dependence, whereas the spin-orbit and generalized centripetalterm sdo not. A s an exam ple, we consider the tensor term in m ore detail (which we use as an exam ple in A ppendix D) . Explicitly it is given by

where $a_{T}$ and $b_{T}$ are param eters which have been $t$ separately for singlet-triplet spin and even-odd parity (angular mom entum ) channels. H ence, $Y_{T}$ has an additional im plicit dependence on spin and parity: $\mathrm{Y}_{\mathrm{T}}=\mathrm{Y}_{\mathrm{T}}$ where can be even-triplet (et), even-singlet (es), odd-triplet (ot) or odd-singlet (os) .

## B. W avefunctions

Because realistic nuclear potentials have explicit dependences on spin and isospin, one requires nuclear wavefunctions that have well de ned spin and isospin dependences. In the nuclear physics literature, there are a variety of approaches to this problem, ranging from determ inantalwavefunctions built up from single nucleon orbitals to $m$ ore com plicated correlated w avefiunctions. For the developm ent of the results in this paper, we w illadopt a basic construction of correlated w avefunctions in term s ofproducts ofspatial, spin-dependent, and isospin-dependent pieces, each of which is determ ined by group theory.

A $s$ is custom ary in nuclear physics, we choose our wavefunctions to satisfy the generalized P auli exclusion principle, which requires that the totalw avefunction (including space, spin and isospin parts) has to be antisym $m$ etric w ith respect to nucleon exchange. A group theoretical construction of the antisym $m$ etric wavefunctions is possible by summ ing over products of $m$ any-particle spatial functions, spin functions, and isospin functions, each of which belong to appropriate representations of the sym $m$ etric group, $S$ (4). 17 In the case of the spin and isospin fiunctions, the sym $m$ etric group representations correspond to eigenfunctions of total spin and isospin, as a consequence of the Schur-W eyl duality $\frac{18}{\underline{\underline{1}}, 19} \mathrm{H}$ ence the antisym $m$ etric wavefunctions have well-de ned totalspin and isospin. This is discussed in A ppendix B.

In general, such correlated wavefiunctions can be w ritten in the form

where $s_{j}(f)$ are the spin functions, $t_{j}(f)$ are the isospin functions, and ${ }_{j}(f r g)$ are the spatial functions; all of which belong to certain representations of the sym $m$ etric group as indicated above. The $C_{j}$ are products of the $C$ lebsch-G ordan coe cients of $S$ (4).

## C. Form alm atrix elem ent calculation

$G$ iven the discussion above, the basic calculation of an interaction $m$ atrix elem ent is straightforward. We begin with initial and nal states de ned as

W e then form ally calculate the $m$ atrix elem ent to give

In this way we can reduce the spin and isospin dependent nuclearm atrix elem ent into a set of sim pler m atrix elem ents, each one of which involves a position-dependent potential.
IV. BASIC VACUUM MATRIX ELEMENTCALCULATION

B efore attem pting a calculation of a speci c interaction $m$ atrix elem ent in the lattice case, it is appropriate to rst exam ine the sim pler equivalent calculation in the vacuum case. For this speci c calculation, we w ill select a four-body problem in which there are tw o deuterons in the initialstate, and in which the nalstate contains a three nucleon body ( ${ }^{3} \mathrm{H}$ e ort) and a one nucleon body ( $n$ or $p$ ).

## A. Vacuum nuclear wavefunctions

The speci c matrix elem ent that we select for our exam ple involves a quintet ( $\mathrm{S}=$ 2; $\mathrm{M}_{\mathrm{S}}=1$ ) initial state i w th two deuterons (the deuterons each have spin 1), and a singlet ( $\mathrm{S}=0 ; \mathrm{M}_{\mathrm{s}}=0$ ) nal state which is a linear com bination of ${ }^{3} \mathrm{H}+\mathrm{p}$ and ${ }^{3} \mathrm{He}+$ $n$. The reason for this is that a linear combination of states $w$ ith di erent total isospin ( $T=0$ and $T=1$ ) are required to resolve a single proton or neutron in the nal state channel. For simplicity, we have adopted initial and nal state wavefiunctions with total isospin $T=0$. As we discussed brie y above, nuclear wavefunctions can be constructed from linear com binations of products of basis vectors of representations of the sym $m$ etric group. For the case of four-body wavefiunctions, we have indexed the speci c basis vectors in term s of their associated Yam anouchi sym bol in A ppendix B. W e have also listed the results of a system atic construction of all such four-body wavefunctions with total isospin zero in A ppendix C.

The initial state is constructed according to

W e have selected these states in particular due to the close correspondence betw een the physical states discussed below, and the group theoretical Yam anouchi basis states for these channels. In the case of other channels, a linear superposition of $Y$ am anouchibasis states $m$ ay be required.

## B. M atrix elem ent in term s of $Y$ am anouchibasis functions

Them atrix elem ent can be evaluated using the approach discussed above. W e rst express the $m$ atrix elem ents in term $s$ of $V_{H J}(1 ; 2)$, since the $Y$ am anouchibasis fiunctions are either sym $m$ etric or antisym $m$ etric under $1 \$ 2 . W$ e w rite


U sing the initial and nalstates in the form listed above, we obtain four di erent contributions to the m atrix elem ent

T he details of this calculation for the tensor term are w orked out in A ppendix D. T he generalized centripetal term can be w orked out in a com pletely analogous way. $T$ he net result is that

W e have already noted that the Yam anouchibasis is naturally purely sym $m$ etric or antisym m etric under the exchange $1 \$ 2$ ( $T$ his is further discussed in Appendix D). As a consequence, the calculation of the $m$ anyłoody $m$ atrix elem ent leads to the sim plest algebraic result when speci ed in term $s$ of 12 term $s$. Interactions between all particles are represented, since the 10 and 5 representations include perm utations of the particle num bering. Hence, the use of a position-dependent interaction potential given in term S of $\mathrm{r}_{12}$ is appropriate, and implies the use of $r_{12}$ as a favored relative coordinate to use in the evaluation of the spatialm atrix elem ent.

## C. Physicalw avefunctions

The group theoreticalm achinery that we used in the evaluation above results in a com pact expression given in term $s$ of spatial Yam anouchibasis functions. As such, they have certain sym $m$ etries $w$ ith respect to particle interchange. These $m$ ust be im plem ented in the construction of the spatialw avefiunctions. T his can be accom plished by using an appropriate supenposition of perm utations of $w$ avefunctions $w$ ith no particular sym $m$ etry.

For exam ple, suppose we begin w ith an unsym m etrized \physical" wavefunction for the two deuteron initial state

Let us now consider exactly the sam e physical process taking place inside the lattioe. W e are interested in the calculation of the interaction $m$ atrix elem ent $w$ ith $w$ avefunctions that contain both nuclear and lattioe coordinates. Perhaps the sim plest way to approach the problem is to $m$ ake use of the vacuum results from the last section, but expand the de nition of the initial and nal states to include the lattice.

## A. W avefunctions for lattice and nuclei

W e now augm ent the de nition of the physicalwavefunctions to include the lattioe coordinates. For exam ple, in the new physical initial state wavefunction, we include the center ofm ass coordinates of the other nuclei to obtain

The other nuclei in the lattice are spectators in the sense that they do not participate in nucleon rearrangem ent associated w th the reaction. C onsequently, the appearance of the associated degrees of freedom into the lattice channel separation factor is an appropriate generalization of the generalized channel separation factor from the vacuum case. W e still require the nucleons that participate in the reaction to be described by a wavefunction that is totally antisym $m$ etric under the exchange of nucleons. The vacuum form ulation that we discussed above accom plished this in the absence of spectator nuclei. There seem s to be no reason that we cannot adopt precisely the sam e kind of form ulation here (this is discussed in A ppendix F). Hence, we form the appropriate Yam anouchi spatial basis function for the initial state $m$ ade up of the sam e supenposition of physical states that are augm ented $w$ ith spectator coordinates. W e can take advantage of the sam e group theoretical construction to evaluate the $m$ atrix elem ent when spectator nuclei are present, since we only required total antisym $m$ etrization on the four nucleons involved in the local strong force interaction. C onsequently, we $m$ ay write

We see in this result a very strong connection between the vacuum result and the lattice result. In general we can system atically extend vacuum calculations to the lattice case through the addition of the lattice nuclear center of $m$ ass coordinates as spectator degrees of freedom .

## C. M atrix elem ent in term sof physical w avefunctions

W e have $m$ ade use of representations of the sym $m$ etric group in order to construct nuclear wavefunctions and to evaluate the interaction $m$ atrix elem ent. In the case of the spatial wavefunctions, these basis functions are $m$ ade up of several di erent perm utations of the physical wavefunction. If we $m$ ake use of these expansions, we can recast the interaction $m$ atrix elem ent in term $s$ of $m$ atrix elem ents involving physical wavefunctions. This will in general produce a large num ber of term $s$.

In the speci c case of the tensorm atrix elem ent that we have been using as an exam ple, we obtain twenty four term $s$ in total. W e may w rite

A prim ary goal of this paper is to develop an expression for one of the integrals that appear in the $m$ atrix elem ent explicitly in term $s$ of phonon coordinates, sim ilar to what we discussed in Section II.W e begin by de ning the integral I according to

## B. D euteron-deuteron separation

W hen the tw o deuterons are close enough for strong force interactions to take place, then the C oulomb repulsion is su ciently strong that this interaction dom inates over the foraes from other atom s. A though we can use a phonon description in this case, it would not be the m ost natural, and the C oulom b foroes w ould require the presence of very high-order phonon operators. Hence, it $m$ ay be m ore convenient to adopt the point of view that the
tw O deuterons appear to the lattioe as an equivalent ${ }^{4} \mathrm{H}$ e nucleus when they are a few ferm is apart. T he separation between them $m$ ay best be handled then as part of the $m$ icroscopic nuclear problem. In this case, we m ay write

$N$ ote that in casting the $m$ atrix elem ent in this way we are not assum ing that the $m$ icroscopic ${ }^{4} \mathrm{H}$ e nuclear wavefunction is the sam e as the m icroscopic nuclear w avefiunction for tw o deuterons. Instead, we recognize in these expressions that there is little di erence from the point of view of the rest of the lattioe between two deuterons localized on the ferm i scale (w hich the rest of the lattice sees as a charge 2 and $m$ ass 4 obj ject), and a ${ }^{4} \mathrm{H}$ e nucleus (which the rest of the lattice also sees as a charge 2 and $m$ ass 4 ob ject). D ue to the C oulom b repulsion betw een the two deuterons when they are close, the associated relative wavefunction is far into a tunneling regim $\mathrm{e} . \mathrm{W}$ e have the choioe to describe this tunneling in term s of deuteron coordinates as phonon operators, which is com plicated, or else to describe this tunneling via a relative nuclear coordinate based on a ${ }^{4} \mathrm{H}$ e center ofm ass coordinate, which is much simpler. The form al problem is not changed $w$ ith this replacem ent, although the approxim ations used in the evaluation of the resulting expressions could be di erent.

## C. Transform ation to phonon coordinates

$W$ e are now in a position to $m$ ake the transform ation to phonon coordinates. In the intitial state, a nuclear center ofm ass coordinates can be expressed in term s of phonon coordinates in general according to

The generalized lattice w avefiunctions include an explicit dependence on phonon coordinates, as well as an explicit dependence on a m icroscopic nuclear degree of freedom. In the initial state, this extra degree of freedom is the deuteron-deuteron separation; in the nal state it is the position of the neutron. Im plicit in this description is an assum ption that the lattioe center of $m$ ass is preserved, which is an additional assum ption here that is consistent $w$ ith our focus on phonon exchange (we do not $m$ ean to im ply here that no coupling is possible $w$ ith the lattice center of $m$ ass coordinate). $W$ ith this notation, we $m$ ay $w$ rite

Equations (57) and (58) are the prim ary results that we nd in the particular integral involved in the speci c deuteron-deuteron $m$ atrix elem ent considered as our exam ple. Sim ilar results can be readily obtained for other integrals appearing in this $m$ atrix elem ent, and also for other $m$ atrix elem ents as well.

V II. C O N C LU S IO N S

The analysis presented in this paper is m otivated by claim s of excess power production in experim ents involving $m$ etal deuterides that have been reported over the years since the originalclaim off leischm ann and $P$ ons in 1989. T he existence of such an e ect im plies new physicalm echanism $s$, in particularm echanism swhidh lead to a coupling betw een condensed $m$ atter degrees of freedom and nuclear degrees of freedom. There has been confusion and con jecture about how energy or angular $m$ om entum exchange with the lattice works, and no relevant form ulation or calculations have been reported in the $m$ ainstream literature. In recent years, our focus has been on a particular schem e involving excitation transfer, idealized $m$ odels for $w$ hich are discussed in detail in a recent $m$ anuscript 9 T he form ulation discussed in this paper leads to form ulas that can be used for a quantitative evaluation of this model, and other models that have been proposed which also involve coupling w ith phonons.

The nuclear part of the calculation requires spin and isospin degrees of freedom in addition to the spatialdegrees of freedom. W e developed nuclear w avefunctions based on Yam anouchi basis functions for each degree of freedom individually, which allows us to integrate out the spin and isospin degrees of freedom separately in a convenient way. This leads to a straightforw ard expansion of the interaction matrix elem ent in term s of a sum of spatial integrals which contain di erent perm utations of particle num bering.

T he lattice part of the problem com es into the calculation initially as spectator degrees of freedom in the generalized channel separation factor. In essence, the $m$ icroscopic part of the calculation at this level is com pletely equivalent to the vacuum calculation, since the spectator nucleiare not involved locally in the strong force interaction. T he lattioe does com e into the problem in a m ore fundam ental way when we replace the nuclear center of $m$ ass degrees of freedom $w$ th phonon coordinates. Since the reacting nuclei in this form ulation are taken to be part of the lattige in both initial and nal states, the lattioe is changed as a result of the reaction. W e chose a description in which both the initial and nal state product nuclei are assum ed to be included in the associated lattioe de nitions. This leads to integrals which contain both initial state and nalstate lattige wavefiunctions, where the lattioe structure is di erent in the two cases.

W e m ake use of the H am ada-Johnston potential as our m odel nuclear potential in this paper. It is one of the sim plest isospin-preserving nuclear potentials to give reasonable results. T he $H$ am ada-Johnston potential betw een nucleon 1 and nucleon 2 can be w rilten as

The sym $m$ etric group $S(n)$, the group of perm utations of $n$ ob jects, plays an im portant role in our calculation. It does so, in three im portant ways

C lebsch-G ordan coe cients are used to construct the antisym $m$ etric wavefunctions.
Schur-W eylduality lets us build wavefunctions with a well-de ned spin (and isospin) and which also transform as Yam anouchibasis vectors under $S$ (4).

Induction coe cients of S (4) are utilized to construct Yam anouchibasis vectors for the spatial part.

In quantum mechanics, we are fam iliar $w$ ith the transform ation properties of the spherical harm onics. In the case of $Y_{m}$ 's the labels the irreducible representation of $S O$ (3) and $m$ labels the basis vector. Sim ilarly for the sym $m$ etric group, we get two labels: the Young diagram $s$ and the $Y$ am anouchisym bols 20,21 , where the Y oung diagram $s$ label the irreducible representation of $S(4)$ and the $Y$ am anouchi sym bols label the basis vectors. The index schem e we use for the Yam anouchisymbols is de ned in Table

## 3. Induction C oe cients

In the previous subsection we explicitly constructed the spin/isospin Yam anouchi wavefunctions using angular $m$ om entum addition. We still have to construct the spatial Ya$m$ anouchi wavefunctions. O ne way to do it to use induction coe cients of the sym m etric group, which are tabulated and discussed in Chen et al. ${ }^{23}$. The relevant form ula for our purposes is

$W$ e have calculated a com plete set of such $Y$ am anouchi $m$ atrix elem ents for the $T=0$ case. There are too $m$ any cases to be presented here. $W$ e therefore focus on a speci c exam ple by calculating the tensor force $m$ atrix elem ent of $1_{1}\left(M_{s}=0\right)$ and ${ }_{6}\left(M_{s}=1\right)$. The $m$ ain issue $w$ ith all these caloulations is that the param eters in $m$ ost of the nuclear potentials are $t$ separately to spin singlet-triplet and even-odd spatial parity (for exam ple, in the H am ada-Johnston potential the $y$ functions are param eterized by a and b param eters, which depend on the spin and parity). Them ost convenient way ofdealing with these issues is to use pro jection operators to separate the various parity and spin channels. H ow ever we can, w ithout the use of pro jection operators, directly exploit the properties of the interaction and the wavefunctions to evaluate these $m$ atrix elem ents.

From the explicit form of $V_{T}(1 ; 2) S_{12}$, we can see that it is sym $m$ etric under the exchange 1 \$ 2, individually for spin, isospin and space parts. If we look at the explicit form of the spin wavefiunctions in Appendix B we can see that since particles 1 and 2 couple to form a triplet, $s_{5}, s_{7}, s_{8}$ and $s_{10}$ are even under $1 \$ 2$. Sim ilarly since particles 1 and 2 couple to form a singlet, $s_{6}$ and $s_{9}$ are odd under $1 \$ 2$. The sam e applies to the isospin wavefunctions. Being even or odd under the exchange 1 \$ 2 in this case has nothing to do w ith angular mom entum algebra, but is a property of the Yam anouchi symbol. In A ppendix D we saw that it was straightforw ard to calculate the $m$ atrix elem ent of the tensor force in term $s$ of the Yam anouchi basis. This is in general true for all nuclear interactions. Perhaps the sim plest way of carrying out realistic physical calculations is to express initial and nalstate wavefunctions in term s of the Yam anouchibasis. Then we can use the $Y$ am anouchibasis $m$ atrix elem ent results to calculate the nuclear $m$ atrix elem ents w ith physical initial and nalstates.

For an isospin preserving, $T=0$ reaction, in which two deuterons interact to form a three-nucleon body and a one nucleon body the relevant states are:

2;2: O ne initial $2+2$ state of two deuterons in a quintet spin 2 state. W e should in general consider the deuterons to be in a singlet or triplet as well. H ow ever, we are focusing on a single exam ple here. In this enum eration of states, we suppress the various $M_{s}$ values.

3;1: Two nal3 + 1 states (since these can be singlets or triplets). These are a linear superpositions of the ${ }^{3} \mathrm{H}+\mathrm{p}$ and ${ }^{3} \mathrm{H} e+\mathrm{n}$ states.

## 1. Physical w avefunctions

Thew avefunctions discussed above are form aly am anouchiob jectsw hich are very general. W e need to focus on speci cwavefunctions for the di erent m ass $4(T=0)$ channels in order to proceed. For sim plicity, we adopt a wavefiunction for two deuterons that are in a quintet (spin 2) state. In this case, we can use

Som e of these term \(s\) are am enable to a simple intenpretation in term \(s\) of stripping reactions. O thers can be considered as higher-order exchange term s . H ow ever, in nuclear reactions, it is not necessary that higher order exchange term s are necessarily less im portant than sim ple direct or exchange interactions. H ence, in any realistic com putation we will need to sum over all of these term \(s\).
