## M agnetic fullerenes inside single-wall carbon nanotubes

 $C_{59}N$  magnetic fullerenes were formed inside single-wall carbon nanotubes by vacuum annealing functionalized  $C_{59}N$  molecules encapsulated inside the tubes. A hindered, anisotropic rotation of  $C_{59}N$  was deduced from the temperature dependence of the electron spin resonance spectra near room temperature. Shortening of spin-lattice relaxation time,  $T_1$ , of  $C_{59}N$  indicates a reversible charge transfer toward the host nanotubes above 350 K. Bound  $C_{59}N$ - $C_{60}$  heterodimers are formed at lower temperatures when  $C_{60}$  is co-encapsulated with the functionalized  $C_{59}N$ . In the 10–300 K range,  $T_1$  of the heterodimer shows a relaxation dominated by the conduction electrons on the nanotubes.

Single-wallcarbon nanotubes (SW CNTs) [1,2] exhibit a variety of unusual physical phenom ena related to their one-dimensional and strongly correlated electronic properties. These include excitonic e ects [3, 4], superconductivity [5], the Tom onaga-Luttinger liquid state [6], and the Peierls transition [7]. Magnetic resonance is a powerfulm ethod to study strong correlations in low dim ensional system s. How ever, for SW CNTs both nuclear magnetic resonance (NMR) and electron spin resonance (ESR) are severely limited by NMR active <sup>13</sup>C nuclei and ESR active electron spins in residual magnetic catalytic particles and other carbon phases. Synthesis of <sup>13</sup>C isotope engineered SW CNTs solved the problem for NMR [8, 9]. To enable ESR spectroscopy of SW CNTs, a local probe, speci cally attached to SW CNTs, is required. The N@C<sub>60</sub> [10] and C<sub>59</sub>N [11] m agnetic fullerenes are ideal candidates for such studies. In fullerene doped SW CNTs, fullerenes occupy preferentially the interior of the tubes and form "peapods" (C 60 @ SW CNT) [12]. Fullerenes adhesing to the outside can be rem oved [13] in contrast to e.g. lling with iron [14]. ESR on encapsulated magnetic fullerenes could yield inform ation on the electronic state of the tubes and it could also enable to study the fullerene rotational dynam ics in a con ned environm ent. In addition, magnetic fullerene peapods could exploit the combination of the SW CNT strength and the magnetic moment of molecules in magnetic scanning probe tips and they could enable a bottom -up design for magnetic storage devices or for building elements of quantum com puters [15].

Typical spin concentrations in  $(N \& C_{60} \& C_{60}) \& SW \ CN T$ are low, 1 spin/tube, and the N spins are insensitive to SW CNT properties [16]. The C<sub>59</sub>N m onom er radical is a better local probe candidate as the unpaired electron is on the cage. C<sub>59</sub>N can be chem ically prepared but it form s spinless dim ers (C<sub>59</sub>N)<sub>2</sub> or m onom er adducts [11]. The magnetic  $C_{59}N$  monomer radical can be stabilized as  $C_{59}N$   $\mathcal{L}_{60}$ , a dilute solid solution of  $C_{59}N$  in  $C_{60}$  [17].

Here, we report on the rst ESR study of SW CNT properties and peapod rotational dynam ics using a paramagnetic local probe:  $C_{59}N$  m onom er radicals encapsulated inside SW CNTs. SW CNTs were rst lled with chem ically inert  $C_{59}N$  derivatives. A heat treatment in vacuum removes the side-group and the monom er radical is left behind. The rotation of encapsulated  $C_{59}N$  is hindered and anisotropic in contrast to the isotropic rotation in  $C_{59}N$  C<sub>60</sub>. In samples with co-encapsulated  $C_{60}$  and  $C_{59}N$ , bound  $C_{59}N$ -C<sub>60</sub> heterodim ers are form ed during the heat treatment. The electron spin-relaxation tim e of the heterodim er is dom inated by the conduction electrons of the SW CNTs and follows the K orringa law.

SW CNTs were lled with air stable C<sub>59</sub>N derivatives (4-Hydroxy-3,5-dim ethyl-phenyl-hydroazafullerene,  $C_{59}N$  -der in the following) and  $C_{59}N$  -der  $C_{60}$  in concentrations of 1:10. The mean value of the SW CNT diam eter distribution, as determ ined from Ram an studies [18], d = 1.40 nm is optimal for fullerene encapsulation. A m ixture of dissolved fullerenes and SW CNTs were sonicated in toluene and ltered, which results in a high degree of encapsulation as shown by transmission electron m icroscopy and R am an spectroscopy in R ef. [19]. The peapods were mixed with ESR silent SnO<sub>2</sub> to separate the conducting SW CNT pieces and were annealed in dynamic vacuum at 600 C for 15 minutes to remove the side-group. The air-sensitive materials were sealed under He in quartz tubes. ESR was studied on a Bruker Elexsys spectrom eter at 9 GHz in the 10-600 K tem perature range with spin-sensitivity calibrated by  $CuSO_4$  5(H2O).




FIG. 1: ESR spectra of a)  $C_{59}N \& SW CNT$ , b)  $C_{59}N \& C_{60} \& SW CNT$ , and c) crystalline  $C_{59}N \& C_{60}$  at 300 K.1, 2, and 3 denote the <sup>14</sup>N hyper ne triplet lines with nuclear state of I = 1, 0, and -1, respectively. A sterisk in a) shows a weak in purity signal. A rrows in b) and c) indicate the  $C_{59}N - C_{60}$  heterodim er. Fit in b) shows the deconvolution of the ESR signal into the <sup>14</sup>N triplet of m onom er  $C_{59}N$  and the  $C_{59}N - C_{60}$  heterodim er com ponents.

Fig. 1 shows the room temperature ESR spectra of  $C_{59}N \otimes SW \ CNT$  (sample A) and  $C_{59}N \otimes CNT$  (sample B) and for comparison the spectrum of crys-

talline  $C_{59}N \mathfrak{L}_{60}$  (sample C) from Ref. [17]. This latter spectrum was previously assigned to the superposition of rotating C<sub>59</sub>N monomers and bound C<sub>59</sub>N-C<sub>60</sub> heterodim ers [20]. The large spin density at the <sup>14</sup>N nucleus of the rotating C<sub>59</sub>N molecule results in an ESR triplet signal and the C 59N -C 60 heterodim er has a singlet signal (arrow in Fig. 1c) as the spin density resides on the C  $_{60}$ molecule.<sup>14</sup>N triplet structures are observed in the peapod sam ples (A and B) with identical hyper ne coupling as in the crystalline sample (C) and are thus identi ed as the ESR signals of rotating C 59N m onom er radicals encapsulated inside SW CNTs. The additional component (arrow in Fig. 1b) observed for sample B, which contains co-encapsulated C  $_{60}$ , is identi ed as C  $_{59}$ N -C  $_{60}$  heterodimers encapsulated inside SW CNTs since this signal has the sam e q-factor as in the crystalline m aterial. This singlet line is absent in sample A which does not contain C<sub>60</sub>. For both peapod sam ples a broader line with HW HM of H 0:6 m T is also observed. The broader com ponent appears also on heat treatm ent of reference sam ples without encapsulated C 59N -der and is identi ed as a side-product. A nnealing at 600 C is optimal: lower tem peratures result in smaller C 59N signals and higher

tem peratures increase the broad in purity signal without increasing the  $C_{59}N$  intensity.

Deconvolution of the ESR signal (Fig. 1b) and the intensity calibration against the CuSO  $_4$  5 (H2O) spin standard allows to measure the amount of  $C_{59}N$  related (C  $_{59}$ N m onom er and C  $_{59}$ N -C  $_{60}$  heterodim er) spins in the sam ple. The am ount of encapsulated fullerenes is known [8], thus the ratio, r, of observed C<sub>59</sub>N related spins and encapsulated C 59N -der can be determ ined. W e obtained r = 2.5(6) % and r = 12(3) % for the A and B sam ples, respectively. The observed ESR signal of C<sub>59</sub>N can be reduced due to various reasons: i) dim erization of C 59N rst neighbors into ESR silent (C 59N)2, ii) incomplete transform ation of C  $_{59}{\rm N}$  -der into C  $_{59}{\rm N}$  , iii) dipolar elds of near neighbor C<sub>59</sub>N pairs: only those C<sub>59</sub>N related spins are observed which have no neighbors with dipole elds larger than the ESR line-width, 0.07 m T. The likely origin of the smaller r value for sample A is dim erization. For sample B, however, a statistical calculation of the dipolar elds gives r = 9% in agreement with the experim entalvalue. For the calculation, the fullerene lattice constant inside the tubes [21], the three dim ensional arrangem ent of the SW CNTs into bundles [22], the random orientation of the bundles, and the concentration of C<sub>59</sub>N was taken into account. As a result, the data for sam ple B supports that most C 59N -der is transform ed to C<sub>59</sub>N monomer radicals.




FIG. 2: Line-widths of the <sup>14</sup>N triplet components in crystalline  $C_{59}N C_{60}$  (open symbols) and  $(C_{59}N, C_{59}N C_{60})$  (0 SW CNT (full symbols) samples below 350 K (a) and above 290 K (b). Stars show the data for the tem perature range where the line-widths of the three components are equal. Solid lines are guides to the eye.

The tem perature dependence of the line-widths of the  $^{14}$ N triplet is identical for the two peapod samples, A and B, and is shown together with the data on C  $_{59}$ N  $\mathfrak{L}$   $_{60}$ in Fig. 2 using the labeling given in Fig. 1a. The line-0.04 m T larger for the peapod than for widths are the crystalline m aterial. This excess line-w idth is sim ilar to that of (N @ C 60 C 60) @ SW CNT and is related to the stray magnetic eld of magnetic catalytic particles in the nanotube sam ple [16]. The three C<sub>59</sub>N triplet lines are broadened unequally at lower tem peratures for both the peapod and crystalline m aterials. The details of the low tem perature broadening are di erent for the two kinds ofm aterials: for encapsulated C 59N, the unequality persists to higher tem peratures and the three lines broaden di erently, whereas for the crystalline  $C_{59}N \gtrsim C_{60}$  line 1 broadens signi cantly and lines 2 and 3 broaden equally but less.

The unequal broadening of <sup>14</sup>N triplet lines with decreasing temperature is well known for NO spin labels and is explained by an incomplete motional narrowing of the anisotropic hyper ne and g-factor anisotropy [23]. For crystalline  $C_{59}N \mathfrak{L}_{60}$ , molecular rotation becomes rapid enough immediately above the 261 K structural phase transition to result in motionally narrowed lines [17]. In contrast, the line-width data of encapsulated  $C_{59}N$  indicates a hindered rotation. The line-width in the hindered molecular rotation regime is:

where M  $_{T}$  is the nuclear state of the <sup>14</sup>N hyper ne lines and the param eters A, B, and C depend on the hyper ne and g-tensor components, on the  $R_x$ ,  $R_y$ , and  $R_z$  molecular rotational rates around each axis, and on the ESR frequency [23]. For crystalline  $C_{59}N \colon C_{60}$  at 9 GHz the isotropic rotation of the molecule (i.e.  $R_x = R_y = R_z$ ) combined with the hyper ne and g-tensors results in C and thus in an equal broadening for lines 2 B  $(M_I = 0)$  and 3  $(M_I =$ 1) [17, 20]. The unequality of the line-widths for encapsulated C 59N indicates an anisotropic rotation, i.e.  $R_x \in R_y \in R_z$  as the hyper ne and g-tensor com ponents are expected to be identical for the peapod and crystalline materials. The anisotropic rotation is suggested to originate from the anisotropic environm ent inside the nanotubes.

A bove 300 K the triplet line-widths rapidly grow with tem perature (Fig. 2b) and the signal intensity decreases faster than the Curie-law but no new lines appear. The broadening and the loss of signal intensity is fully reversible with tem perature cycling. The broadening is rem iniscent of that observed above 600 K in the crystalline material, which was interpreted as a spin-lattice life-time shortening due to delocalization of the electron from  $C_{59}N$  over the  $C_{60}$  matrix [20]. Based on the analogous behavior, we suggest that reversible charge transfer from  $C_{59}N$  tow and the nanotubes takes place above




FIG.3: Concentration of C<sub>59</sub>N-C<sub>60</sub> bound heterodimers in C<sub>59</sub>N C<sub>60</sub>@SW CNT.Solid curve is a twith parameters explained in the text. D ashed curve shows the same quantity for crystalline C<sub>59</sub>N C<sub>60</sub> above the 261 K phase transition. Note the much higher heterodimer concentration for the peapod material. Inset shows the temperature evolution of the spectra.

350 K. The signi cantly lower temperature of the charge transfer indicates a larger overlap of the extra electron of C<sub>59</sub>N to the SW CNTs compared to its overlap with the C<sub>60</sub> conduction band in the crystalline material. In C<sub>59</sub>N C<sub>60</sub> the broadening is accompanied by the emergence of the ESR signal of the delocalized electrons. The intrinsic ESR signal of SW CNTs is not observable [24, 25], which explains the absence of a signal corresponding to charge transferred electrons on the tubes.

The coexistence of bound  $C_{59}N - C_{60}$  heterodim ers and rotating  $C_{59}N$  m olecules was understood for  $C_{59}N \ C_{60}$  as a them al equilibrium between the ground state heterodim er and the rotating m onom ers [20]. The inset in Fig. 3 shows a similar behavior for  $C_{59}N \ C_{60}$ @ SW CNT: the heterodim er dom inates the low tem perature spectrum and vanishes at higher tem peratures, how ever the relative intensity of the heterodim er ism uch larger in this m aterial. The heterodim er signal intensity norm alized by the total (heterodim er+ triplet) intensity gives the heterodim er concentration and is shown in Fig. 3. Similarly to crystalline  $C_{59}N \ C_{60}$ , the heterodim er concentration can be tted with:

$$\frac{I_{C_{59}N \ C_{60}}}{I_{total}} = \frac{1}{1 + e^{(E_a = T + S)}}$$

where  $E_a$  is the binding energy of the heterodimer and S is the entropy di erence between the rotating m onom er and the static heterodimer states. A twith Eq. 2 for the peapod material is shown in Fig. 3 as a solid curve and gives  $E_a$  (peapod) = 2800 (200) K and




FIG.4:a) Temperature dependence of the ESR line-width for the heterodim er signal. b) The hom ogeneous contribution to the line-width with a linear t (solid line). The corresponding  $T_1$  values are shown on the right axis.

S (peapod) = 9(1). This compares to the results for the crystalline m aterial with  $E_a$  (cryst) = 2400 (600) K and S (cryst) = 11(2) [20]. The higher heterodimer concentrations for the peapod m aterial is caused by the larger  $E_a$  and sm aller S values. The latter is explained by the limited rotational freedom of encapsulated  $C_{59}N$ .

Similar to NMR spectroscopy, the ESR spin-lattice relaxation time, T1, of the localized heterodimer spins yields inform ation on the electronic structure of the host SW CNT material [26].  $T_1$  can be measured by timeresolved ESR measurements or in continuous wave ESR spectroscopy from the line-width, H, by separating the hom ogeneous, relaxation related line-width from the inhom ogeneous one. In Fig. 4a, we show H for the heterodim er signal as determ ined from ts with derivative Lorentzian lines. Clearly, H has a tem perature dependent component in addition to a H  $_0 = 0.089(2)$ m T residual line-width, which is obtained by averaging the line-widths below 50 K. The line-shape of the heterodim er signal does not change with tem perature, which indicates a uniform, hom ogeneous broadening in addition to the inhom ogeneous residual width.

To obtain the hom ogeneous line-width, H  $_{\rm H\,om}$ , we subtracted H  $_0$  from the line-width data: H  $_{\rm H\,om}$  =  $\frac{1}{\rm H} \frac{2}{0}$  H  $_0^2$ . Fig. 4b shows H  $_{\rm H\,om}$  and 1=T<sub>1</sub> =  $_{\rm e}$  H  $_{\rm H\,om}$ , where  $_{\rm e}$ =2 = 28.0 GHz/T is the electron gyrom agnetic ratio. 1=T<sub>1</sub> as a function of T is linear, with (T<sub>1</sub>T) <sup>1</sup> = 4.2(2) 1<sup>t</sup>(sK) <sup>1</sup> (t shown in Fig. 4b), which suggests that K orringa relaxation, i.e. the interaction with conduction electrons [26] gives the relaxation of the heterodim er. An electric coupling constant (averaged for tube chiralities), A, of localized spins and conduction electrons is 11 m eV as determined from the

Korringa relation [26]:

where  $\overline{n} (E_F) = 0.014$  states/eV /atom is the DOS at the Ferm i level for a d 1.4 nm m etallic tube in the tight-binding approximation [22]. The above discussed uniform ity of the hom ogeneous broadening suggests that the heterodimer spins do not sense separate m etallic and sem iconducting tubes as it would be expected based on the geometry of tubes alone [22]. This can be explained by charge transfer in the SW CNTs bundles, which shifts the Ferm i level and renders all tubes m etallic.

In sum m ary, we observed  $C_{59}N$  m onom er radicals encapsulated in SW CNTs. The nanotube cage hinders and m akes the m olecular rotation anisotropic. We nd a low activation energy for charge transfer to the tubes. At low tem peratures, bound  $C_{59}N$ - $C_{60}$  heterodim ers are observed when m ixtures of the two fullerenes are encapsulated. E lectron spin-relaxation of the heterodim er shows an overall m etallic behavior of the tubes. The m aterial is a step toward the realization of con ned linear spinchains, which m ight nd application in e.g. quantum inform ation processing.
