Quantum chaos and uctuations in isolated nuclear spin systems

U sing numerical simulations we investigate dynamical quantum chaos in isolated nuclear spin systems. We determ ine the structure of quantum states, investigate the validity of the Curie law for magnetic susceptibility and nd the spectrum of magnetic noise. The spectrum is the same for positive and negative temperatures. The study is motivated by recent interest in condensedmatter experiments for searches of fundamental parity- and time-reversal-invariance violations. In these experiments nuclear spins are cooled down to microkelvin temperatures and are completely decoupled from their surroundings. A limitation on statistical sensitivity of the experiments arises from the magnetic noise.

Introduction. M uch of the present know ledge about violations of the fundam ental sym m etries P (invariance under spatial inversion) and T (invariance w ith respect to tim e reversal) comes from experiments m easuring P - and T -violating perm anent electric dipole m om ents (EDM 's) of atom s, m olecules and the neutron, see, for example, Ref. [1]. M ost EDM experiments measure precession of the angular momentum of the system in an applied electric eld analogous to the Larm or precession in an applied magnetic eld.

In addition to such precession experiments, there are EDM searches of another kind [2, 3], which have drawn recent renewed attention [4, 5, 6, 7, 8, 9, 10]. The idea of these experiments is the following. Suppose that we have som e condensed m atter sam plew ith uncom pensated spins. If an electric eld is applied to the sample, it interacts with the associated (P – and T –violating) EDM 's, leading to a slight orientation of the spins in the direction of the electric eld. This orientation, in turn, is measured by measuring the induced magnetization of the sample. In this work we concentrate on e ects related to nuclear spins in insulators with fully compensated electron spins [7, 9]. The EDM energy shift under discussion is about 10 $^{\rm 24}$ 10²⁸eV per nuclear spin. For comparison a similar shift is created by a magnetic 10^{20} T.So the e ect is tiny and lim eld B 10 16 itation to statistical sensitivity com es from the fact that 10^{23} , inspite of being large is the number of spins, n still nite [9]. Basically the lim itation com es from a kind ofm agnetic shot noise. In the EDM experiments the nuclear spins must be cooled down at least to 100 K and optim ally down to 10 100nK. At low tem peratures the spins are completely decoupled from the crystal lattice, so there is no contact with any heat bath. This motivates the problem considered in the present work: magnetic noise of an isolated nuclear spin system . An important point is that the total spin of all nuclei is not conserved because magnetic dipole-dipole interaction depends on relative orientation of nuclei.

Concerning previous work we rst of all refer to the 1959 paper by Hebel and Slichter [11] where the physical

m eaning of tem perature for an isolated spin system has been discussed. This work assumed the validity of a statistical approach for the isolated quantum system. This is what now adays is called dynamical quantum chaos. The problem of the onset of dynamical quantum chaos has been addressed much later. Level statistics in a spin system with a mobile ferm ion has been investigated by M ontam baux et al in 1993 [12]. The criterion for onset of quantum chaos in spin glass shards with H eisenberg interaction in a random externalm agnetic eld has been derived by G eorgeot and Shepelyansky in 1998 [13]. There have been also num erical studies of level statistics in XYZ spin chains with and without a random m agnetic eld that dem onstrated non-W igner behavior in the absence of m agnetic eld [14].

M odel. To be speci c, we consider the Lead T itanate ferroelectric suggested for EDM experiments in Refs. [7, 15]. The interaction between the nuclei is governed by the magnetic dipole-dipole interaction, the strength of which falls o as $1=r^3$, $J = {}^2$ ($3n n = r^3$. Therefore in the paramagnetic phase that we are interested in it is su cient to only include nearest-neighbour interactions. The dom inating contribution to the dipole-dipole interaction is from the 207 Pb isotope which has a natural abundance of 22.1% and are distributed random ly through the lattice. As a consequence the interaction is anisotropic and random in strength. Therefore we adopt a model H am iltonian of the form,

where J^{k1} is the interaction between spins S = 1=2 on nearest sites k and l on a lattice and B is a uniform external magnetic eld. The interaction J^{k1} is represented by random num bers uniform ly distributed between $[-J_rJ]$. The typical value of J is J 10¹² eV 10nK []. For the sake of simplicity unless otherwise is stated we take a usual square lattice with periodic boundary conditions. W e will consider the case when the tensor J has only diagonal components, = , and the case when it has both diagonal and o diagonal components. The latter case corresponds to real dipole-dipole interaction. We diagonalize the H am iltonian (1) num erically exactly and we need to know all eigenstates and all eigenenergies, so the size of them atrix is 2^n where n is the num ber of spins. Therefore, practically we are able to consider only relatively sm all clusters with n= 8,10,12. For a su ciently large lattice all results are expected to be self-averaged. However, we consider relatively sm all clusters, therefore, to im prove statistics we average results over 100 random realizations of J^{k1} . We do not consider an odd num ber of spins to avoid K ram ers degeneracy of spectra that cannot be im portant in the therm odynam ic lim it.

Structure of chaotic eigenstates. Sm all m agnetic eld. At zero magnetic eld the Hamiltonian (1) is invariant under time reversal (I-reversal). This im plies that the eigenfunctions of the H am iltonian are split in two sectors of dierent time-parity: in the rst sector they stay the same (+) and in the second one they change sign (-) under the action of all the spins being ipped. Therefore the expectation value of magnetization that is a T-odd operator vanishes for any state, $hi\beta_z ji = 0$. Because of random J, chaos is established in each of these two sectors but the sectors do not interact. Anderson localization of single particle states in a random potential is a well known e ect. In principle a spatial localization of many-body quantum states is also possible, while it is known that interaction tends to destroy Anderson 10calization [16]. Spatial localization would imply Poisson level statistics (the distribution of level spacing between closest levels), P_P (s) = exp(s), within a sector with a given T-parity in a su ciently large system . On the other hand the W igner-Dyson distribution $P_{W,D}$ (s) = $s^2=4$) within a given sector indicates a full $\frac{s}{2}$ exp (chaotization including delocalization. To characterise to what degree the statistics of levels are W igner or Ppisson, following Ref. $[L_{3}]$ we use the parameter $\begin{bmatrix} \Gamma_{s_0} \\ 0 \end{bmatrix} \mathbb{P}$ (s) $\mathbb{P}_{W D}$ (s)]ds $\begin{bmatrix} \Gamma_{s_0} \\ 0 \end{bmatrix} \mathbb{P}_{P}$ (s) $\mathbb{P}_{W D}$ (s)]ds , where P (s) are the statistics measured in num ericals in ulations and $s_0 = 0.4729$ is the intersection point of P_P (s) and $P_{W\ D}$. Localization $e\ ects\ are\ always\ enhanced\ in$ the 1D case. Therefore to investigate the localization seenario we studied level statistics within a given T-parity sector for the Hamiltonian (1) on a 1D ring at B = 0. W e found that = 0:18;0:051;0:035 for n= 8, 10 and 12 respectively. So, we do not observe any deviation from the W igner-D yson distribution within the accessable system size. Thus, we come to a conclusion that there is no spatial localization of quantum states in the random spin system . This conclusion is similar to that of Ref. [16] for m obile interacting particles.

The combined statistics of levels including both sectors at B = 0 is given by the sum of two W igner distributions, giving an intermediate statistics with 0.5, see Figl. A very small critical magnetic eld is needed to mix the sectors and hence to lead to a single W igner distribution. The critical magnetic eld B_{cl} is given by the condition that mixing of two nearest states from di erent sectors is of the order of unity

Here j_{+} i and j_{-} i are opposite T-parity eigenstates of the Hamiltonian (1) at zero magnetic edd. The level spacing is roughly equal to E J^{-} $n=2^{n}$, where the factor P_{-} comes from the total width of the spectrum that is discussed below. To estimate a typigal mixing matrix element in (2) we use the sum rule p_{-} j_{-} j_{-}




FIG.1: as a function of the magnetic eld: solid line n = 8, dashed line n = 10, dotted line n = 12.

To con m this analytical estimate we present in Fig. 1 the value of calculated numerically for dierent magnetic elds. As we already mentioned at zero magnetic eld 0.5 indicating intermediate statistics, and at large eld ! 0 indicating the W igner-D yson distribution. Taking the value = 0.25 as a crossover point we nd $B_c(n + 2)=B_c(n)$ 0.5 in good agreement with Eq. (3). Thus the value of the rst critical eld B_{c1} drops

down exponentially with number of spins. For the EDM experiment we are interested in large system s, n 10^{23} . So in this situation B_{c1} = 0:N ote that Eq. (3) is not a criterion for onset of quantum chaos. This is the criterion for a crossover from a two component chaotic distribution or in other words the criterion for destruction of T-parity. This is quite similar to the dynam ical enhancement of spatial parity violation in nuclei [17].

<u>\Strong" magnetic eld</u>. In a strong uniform magnetic eld stationary states can be classi ed by total spin projection on the direction of the eld, S_z . This regime is realized when the level spacing B is larger than the matrix element between directly coupled states that is of the order of J, see e.g. [13]. Thus the

crossover to the strong magnetic eld regime happens when $B > B_{c2}$ J 10^{7} T (the num erical value corresponds to Lead Titanate). In the strong eld regime due to random exchange interaction J the states with a given value of Sz are com pletely m ixed up and their energies, according to our calculations, are spread within the 0.3 nJ. Note that \conservation" of band of width total S_z does not m ean that the z-projection of a particular spin is conserved. Every particular spin uctuates very strongly. Thus the energy spectrum consists of successive bands, separated by B, the width of the band is about 0.3 nJ. There is the W igner-D yson statistics of levels within a given band. W hen n $(B = J)^2$ the bands overlap and this leads to Poisson level statistics.

The above discussion of the structure of quantum states is valid in the case when the tensor J in H am iltonian (1) has both diagonal and o diagonal components. In the case without o diagonal components there is a hidden integral of motion. The H am iltonian acting on a basis state with a particular S_z only changes S_z by 0; 2, therefore S_z (mod2) is conserved. This means that eigenfunctions can be expanded in a basis with either even or odd S_z components. Then the above considerations are valid separately for S_z -even and for S_z -odd sectors. It is possible that the non-W igner behaviour observed in Ref.[14] is due to the hidden integral of motion.

Tem perature, average energy and m agnetic susceptibility. The textbook analysis of a spin system based on assum ing the validity of the Boltzm ann distribution gives the following well known relations [18]




FIG.2: a. M agnetization $hi\beta_z$ jii averaged over energy bins E = 0.5J. The magnetic eld B = 0.1J. Solid, dashed, and dotted lines correspond to clusters of size n = 8;10;12 respectively.

Here is the magnetic susceptibility, E (T) is the average energy at a given tem perature (we set the Boltzm ann constant equal to unity), \overline{E}_{i} is the average energy of stationary states and E_i^2 is the average energy squared. \overline{E}_i and E_{i}^{2} are independent of tem perature. First we want to check the validity of Eq.(4) for the isolated dynam ical system (1). In this case Eq.(4) in essence de nes an e ective tem perature, see the discussion in Ref.[11]. To give a precise meaning to Eq. (4) one has to consider m any energy levels inside a bin around som e given energy E. Then, according to (4) the susceptibility averaged over these levels is related to the energy E . W e have checked num erically that for the Ham iltonian (1) 0 and \overline{E}_{i}^{2} $0:13J^2n$. Hence, according to (4) Εi $1:94E = \hat{J}$. This agrees well with results of num er-

ical simulations with H am iltonian (1) shown in Fig. 2a. This gure represents values of the level magnetization $hi\beta_z$ jii calculated in the eld B = 0:1J, averaged over bins of width E = 0:5J, and averaged over random

J . Deviation from linear dependence at large positive and negative energy is the nite size e ect: Eqs. (4) m ake sense only if the average energy is smaller than the \band

Let us stress that tem perature here is just a param eter that samples a set of energy levels around the average energy that according to (4) is $E = 0:13nJ^2 = T$. O ne can also check that the energy \window " around the average energy is $E_{\rm rm \ s} =$ 0:13nJ. Note that the Boltzmann sampling does not imply a validity of the equilibrium Boltzmann distribution. For example we can use Boltzm ann sam pling in a system without interaction that never com es to an equilibrium. The value of TM = B calculated for di erent cluster sizes, tem peratures (positive and negative) and m agnetic elds and averaged over ranis presented in Fig. 2b. For high tem peratures, dom J T = 3J, the results agree perfectly with the Curie law. Unexceptedly it agrees even at $B < B_{c1}$. For low er tem peratures, jI j J the results deviate from Curie's law as one should expect. To complete the analysis we have also calculated the dispersion of the susceptibility and found = h^2 i h^2 0:01 <u>n=</u>T. that

M agnetic susceptibility at nonzero frequency, uctuations. There are no temporal uctuations in an isolated system in a given quantum state. The uctuations come from the fact that a large system cannot be prepared in a xed quantum state. We always deal with a density matrix that represents a combination of a large number of quantum states around some average energy. In this section we consider only the Boltzm ann sampling: the average energy is $E_p = 0.13nJ^2 = T$ and the energy \window " is $E_{\rm rm \ s} = 0.13nJ$. In this case we can use the standard form ula for the imaginary part of the magnetic susceptibility [18]




FIG. 3: TIm = n versus !. Solid line, analytic. Numerical results for n = 12 at T = 3 and T = 1 are shown by dashed and dotted lines respectively.

Here $!_{ij} = (E_i \quad E_j) = h$. First we perform direct num er-

ical simulations using this formula and quantum states generated by the Hamiltonian (1) at B = 0.1J [19] For simplicity we consider the case when the tensor J has only diagonal components. Results of simulations

for cluster n = 12 are shown in Fig. 3. The plots for n = 8;10 are very sim ilar. The result unam biguously in-

dicates a Gaussian line shape, $\text{Im} [] \frac{n}{4T}^{p-1} e^{\frac{1}{2}^{2}};$ 0:85=J. Assuming the Gaussian shape we with can also calculate analytically using a method usually applied in NMR studies [20]. Here hkli represents a pair of nearest sites. Since we have perform ed num erical simulations without o diagonal components of J , the right hand side of Eq. (6) is $n2^{n-1}J^2=3$ and hence $M_2 = 2=3J^2$. On the other hand for the Gaussian line shape $M_2 = p1=(2^{-2})$. Hence the analytical calculation gives the $= 1^{n-2}(2^{-2})$. Hence the analytical calculation gives the $= 1^{n-2}(2^{-2})$. The Gaussian curve with this value of the relaxation time is shown in Fig. 3 by solid line. It is in good agreem ent with results of direct num erical simulations. The real part of the susceptibility can be easily found using K ram ers-K ronig relations (see, for example, Ref. [18])

As soon as Im [] is known then using the uctuation dissipation theorem one can nd magnetic noise, i.e. the spectral density (M²)_! of the square of the deviation of the magnetization from its average value [9], V^2 (M²)_! = h coth (h!=2T)Im [(!)]. V is volume of the sample. A very interesting point is that at ! T the

noise is independent of tem perature and moreover it is the same for positive and negative tem perature. W hat is usually called the uctuation dissipation theorem in the case of negative tem perature becomes the uctuation radiation theorem because Im [(!)] changes sign.

W e have investigated the structure of chaotic quantum states in a spin lattice system with random interactions. W e also checked the validity of the C urie law form agnetic susceptibility and nd the spectrum of m agnetic noise. The tem perature independent noise lim its the statistical sensitivity of experiments on parity and time-reversalinvariance violations.
