# Qubit feedback and control with kicked quantum nondem olition measurements: A quantum Bayesian analysis

The inform ational approach to continuous quantum measurement is derived from POVM form alism for a mesoscopic scattering detector measuring a charge qubit. Quantum Bayesian equations for the qubit density matrix are derived, and cast into the form of a stochastic conform almap. Measurement statistics are derived for kicked quantum nondemolition measurements, combined with conditional unitary operations. These results are applied to derive a feedback protocol to produce an arbitrary pure state after a weak measurement, as well as to investigate how an initially mixed state becomes puried with and without feedback.

I. IN TRODUCTION

Quantum measurement is usually taught in textbooks as an instantaneous process. However, in nature, all processes take a nite time. Physical projective measurem ent (or wave-function collapse) must therefore happen over some time period, and is often a sequence of weak measurements, run for a su ciently long time. Weak quantum measurements are characterized by an intrinsic uncertainty about the state of the measured system . In the parlance of detector physics, this is equivalent to the statem ent that the signal cannot be con dently distinquished from the noise without a su ciently long integration time. At some intermediate time, the eigenstates of the measurem ent operator can only be assigned a value with some con dence, determined with the probability of a given realization of the detector output (sim ilarly to classical Bayesian inference).

In solid state system s, the typically weak coupling constant between the quantum system and measuring apparatus in ply that weak measurem ents with long measurement times are the norm. While this is often frustrating to experim entalists who wish to preform projective measurement for quantum computation purposes, we view this situation as an opportunity to discover and im plement ideas in quantum measurement that are qualitatively di erent from standard projective measurement. A though m any results in this paper are abstract and apply to m any di erent physical system s and detectors, the results will be discussed in terms of solid state physics. Quantum detection in mesoscopic structures began with the \controlled dephasing" experim ents of R ef. 1 and related theoretical works,  $^2$  which has continued to be an active area of research.<sup>3</sup> The particular mesoscopic structure we shall focus on presently is a quantum point contact (QPC) detector measuring a double quantum dot charge qubit (DD), a system that has been extensively investigated, both theoretically<sup>4</sup> and experim entally.<sup>5</sup>

A generic problem that arises if one is interested in

making a projective measurement, made out of many weak measurements, is that the dynamics from the Hamiltonian evolution combines in a nontrivial way with the measurement dynamics. The way around this problem is with quantum nondemolition (QND) measurements.<sup>6</sup> The QND scheme employed in this paper is that of kicked QND measurem ents  $^{7,8,9,10,11,12}$  on a qubit. This idea was discussed for the QPC in Ref. 9, and was inspired by a similar rotating QND scheme of Ref. 13. By turning the detector on and o in a time scale much faster than the R abioscillation period, the detector gives a little information about the quantum state. The qubit is then allowed to make a full Rabioscillation before the next weak measurement, so the measured observable is static in time from the perspective of the measurement device, e ectively turning o Ham iltonian evolution. In this fashion, the information contained in the qubit is teased out over many measurements, or detector kicks. Kicked QND measurements have many advantages that recommend them as a technique of choice both for theoretical treatm ent, as well as for experim ental im plem entation:

> Theoretically, the kicked m easurem entsm ay be described with a non-unitary quantum m ap. Them ap is discrete in the tim e index, but the m easurem ents are weak, not projective. The quantum m ap form alism allows for a technically simple treatm ent of the combined H am iltonian and m easurem entinduced dynam ics in a globalm anner, in contrast to continuous m easurem ent analysis using conditional di erential Langevin equations.

> The kicking mechanism is convenient, in that it allows the measurement strengths to be fully tunable by adding more kicks, as well as the easy inclusion of unitary operations by simply waiting a fraction of a Rabiperiod.

> Kicked QND measurements may be implemented in experiments with several advantages. The kicks

m ay be accomplished with a pulse generator on a QPC measuring a DD, and the waiting time between kicks gives external decision circuitry the needed time to process the data in order to do real-time feedback. Also, the pump variation introduced in Ref. 11 rem oves the uninteresting background signal of the measurement, and just gives the bare output signal as either positive or negative pumped current.

The purpose of this paper is two-fold. The rst topic is form al: To start with the well-known POVM approach to generalized measurements, and derive the quantum Bayesian form alism from it, starting with a scattering detector. The detector physics allows a natural translation of the abstract POVM form alism into physical processes, and the quantum Bayesian form alism is recovered in the weak coupling lim it. A fler discussing kicked-QND measurements, we show how both kicked measurements and unitary operations may be recast in terms of conform alm aps, and demonstrate a close parallel with the mathematics of the special theory of relativity.

The second topic is physical: the form al results are applied to make predictions using conditional operations with real-time feedback: (1) We derive an algorithm to determ inistically produce an arbitrary pure state after a (random) weak measurement using feedback. (2) We investigate the puri cation process under measurement and generalize Jacobs' qubit feedback protocol to speed up puri cation with feedback.<sup>14</sup>

The paper is organized as follows. In Sec. II, we derive the quantum Bayesian form alism from POVM sapplied to a m esoscopic scattering detector in the weak coupling lim it. Kicked QND measurements are reviewed in Sec. III, in the context of the quantum Bayesian form alism. In Sec. IV we introduce a stereographic projection representation, and rewrite the measurem ent dynam ics as a stochastic conform alm apping. A close analogy to special relativity is also discussed. Sec. V combines kicked m easurem ents with unitary operations, and calculates m easurem ent statistics. Sec. V I introduces conditional phase shifts in order to determ inistically produce the same quantum state after a measurement. In Sec. VII, we investigate the puri cation process of any initially mixed density matrix under kicked measurement. Sec. V III contains our conclusions.

## II. DERIVATION OF THE QUANTUM BAYESIAN FORMALISM FROM POVM

The form alism used in this paper is called the quantum B ayesian approach<sup>15</sup> because it may be considered as a generalization of classical B ayesian inference. An analogous approach to quantum measurement that is better known in the quantum information community has been given the unfortunate name of positive operator-valued measure (POVM) formalism.<sup>16,17</sup> In this section,

the quantum Bayesian form alism for a solid state system is derived from POVM s.

Consider a bipartite system composed of A and B, where the states of B are expressed in the orthonormal basis  ${\rm D}$   $i_{\rm B}$ , and the states of A are expressed in the orthonorm albasis  ${\rm jj}i_{\rm A}$ . A unitary transformation that entangles the states in A with the states in B is given by

where we consider an initial state j  $i_A$  in A, described by a density operator  $_A$ , an initial state j $bi_B$  in B, and have introduced the measurement operators M  $_Q$  that are indexed by the states in B, and operate in A. The normalization of the states gives the completeness relation,  $_Q$  M  $_Q^{y}$  M  $_Q$  = 1. Now make a projective measurement on B alone, and nd the result Q. Any measurement of this kind may be described as a POVM in A. The probability of nding the result Q, called P (Q), is given by

while the outcom e of this measurem ent prepares a new density operator of A, conditioned on the outcom e Q, and is given by

This de nes a mapping  ${}^0_A = \$({}_A)$  from density operators to density operators, known as a super-operator, which is not unitary in general.

W hile the above results are standard generalizations of projective m easurem ent on A, the abstract form ulation obscures how to practically apply the POVM to a specic physical system . We now consider such a system in the solid-state: the quantum point contact (QPC), measuring the state of a double quantum dot (DD), in order to see how the POVM translates into physical language. The Coulomb interaction between the DD and QPC alters the transport properties of the QPC, and can thus be used to detect which quantum dot the DD electron occupies. The QPC is described with the help of a scattering m atrix  $S_{i}$  that depends on the physical state of the DD. Following Averin and Sukhorukov,  $1^{18}$  the unitary evolution of the total state during the scattering process is comprised of the state of an individual electron (system B) incident from the left electrode,  $in i_B$ , and the state of the DD (system A), jli<sub>A</sub> + j2i<sub>A</sub>, evolving as

where  $J_{L}$ ;  $R_{i_B}$  represent scattering states of the QPC that have either been relected or transmitted, and the transmission and relection amplitudes  $t_i$  and  $r_i$  are elements

of the scattering m atrix S<sub>j</sub>:

The state of the \logical" qubit of the DD, is now entangled with the \ancilla" qubit of the left/right position of the QPC electron, and this comprises the bipartite system. Using the evolved state (4), we can now read o the measurem ent operators, M  $_{\rm Q}$ , of this unitary operation in the ( $\rm Di_A$ ; Ji<sub>A</sub>) basis,

and easily verify that M  $_{\rm L}^{\rm y}$ M  $_{\rm L}$  + M  $_{\rm R}^{\rm y}$ M  $_{\rm R}$  = 1 from probability conservation. Counting the electron in the collector of the QPC gives a random outcom e, Q = 1 if the electron is counted, or Q = 0 if the electron is not counted, and m akes a projective m easurem ent on the B part of the H ilbert space. Equation (2) gives the probability of counting the electron (or not),

where  $_{ij}$  are the elements of the DD density matrix in the jl;2i basis,  $T_j = \frac{1}{2}j^2$ ,  $R_j = \frac{1}{2}j^2$ , and  $T_j + R_j = 1$ . The density matrix of the DD qubit may be updated, given the outcome of the measurement with Eq. (3). If Q = 1, so an electron is counted, then

where =  $\operatorname{Arg}(\underline{t}_{2})$ ; while if Q = 0, so an electron is not counted, or equivalently, a hole is counted, then

where =  $A \operatorname{rg}(r_1 r_2)$ .

The results (8,9) have a natural interpretation as a quantum Bayes form ula: The diagonal density matrix elements are interpreted as classical probabilities, and are updated according to the classical Bayes form ula, while the o -diagonal elements have a more exotic rule.<sup>15</sup> Note that if the initial DD qubit state is pure, it remains pure after the measurement. This is because while the entanglement enlarged the electrice H ilbert space which would lead to decoherence if the entangled information went undetected, the measurement of the QPC electron collapses the 2-particle state back down to a different pure DD state.

It is instructive to contrast the POVM procedure with the wellknown \decoherence" approach to quantum measurement in this most simple case. The decoherence approach corresponds to explicitly averaging the elements of the density matrix over all possible outcomes of the detector. In this case, the two possible outcomes of the measurement (8,9) are used to obtain

for the diagonal elements ( $_{22} = 1$   $_{11}$ ), and

for the o -diagonal elements ( $_{21} = _{12}$ ), in agreement with Averin and Sukhorukov.<sup>18,19</sup> The new o -diagonal matrix elements are reduced because  $j_1t_2 + r_1r_2j = 1$ , resulting in e ective decoherence, while the diagonal matrix elements are preserved. The predictive advantage of the quantum Bayesian approach comes from not averaging over them easurement results, but rather conditioning the quantum density matrix on the result obtained in a particular physical realization.




FIG.1: W eak entangling of a logical qubit with m any ancilla qubits, followed by projective m easurem ent on the ancilla qubits can be m apped onto the m easurem ent of a quantum double dot by the transport electrons of a quantum point contact. Two given m easurem ent realizations are shown, depending on whether the logical qubit state is either jli or jDi. The random ancilla result 1 is m apped onto m easuring an electron in the current collector (denoted with a lled circle), while the random ancilla result 0 is m apped onto not m easuring an electron in the current collector, or equivalently, m easuring a hole (denoted with an empty circle). The fact that the states jli and j2i of the logical qubit alters the probability of projecting the ancillas to 0 or 1, allows a weak POVM m easurem ent on the logical qubit.

The above POVM analysis is not di cult to extend to M \ancilla" qubits, or QPC electrons. The basis 12 i is now spanned by M qubits, each being projected to either 0 or 1. Rather than nd the probability of obtaining a given sequence of 0s and 1s in the output, it happens that it is su cient to nd the probability of just obtaining  $_{i=1}^{M} Q_{i}$ , given M attempts, where the total charge n = $Q_i = (0;1)$ . In other words, sequence does not matter, only the total number of counted electrons. This mapping is illustrated in Fig. 1, where the ancilla outcom e 1 or 0, is mapped respectively into either counting an electron, or not counting an electron in the current stream . The generalization of the quantum Bayesian rules (7-9) for M ancilla qubits is done by replacing the success probabilities  $T_{i}$ , and the failure probabilities  $R_{i} = 1$ T<sub>i</sub> by the probability P (m; M jj) to measure m electrons in M attempts, under the condition that the qubit is in state iji,

which is the binom ial distribution.

W hile this is su cient for the diagonal matrix elements, the o -diagonal matrix elements get a di erent phase shift after each electron is measured. The total phase shift is (m; M) = M + m ( ), which is determ inistic if = . The symmetric quantum point contact has the property that  $= 0_{\ell}^{2,4}$  so this sim plication will be made in the rest of the paper. For m any electrons M , the current is determ ined by m =M . The physically relevant weak-coupling (weakly responding) lim it corresponds to  $(T_1)$  $T_2$ )=( $T_1 + T_2$ ) 1. Appealing to the central lim it theorem , we treat the detector shot noise in the Gaussian approximation with little lost information.<sup>20</sup> The QPC detector is e cient, in the sense that no inform ation about the DD qubit is lost in the noisy current output.<sup>4,15</sup> This is analogous to saying in the logical language that no ancilla qubit was left unprojected, and that the unitary operations did not hide any qubit information in the phase of the ancilla qubits that is destroyed after projection in the left/right basis.

One manifestation of an e cient detector in the dephasing approach, is that the measurement rate coincides with the measurem ent-induced dephasing rate.4,15 Ref. 18 related the measurement rate to one of the Renyi entropies, or the statistical overlap  $O_{1;2}$  =  $_{m}$  [P (m ; M j1)P (m ; M j2)]<sup>1=2</sup>, and showed that for the symmetric QPC it coincides with the reduction of the o -diagonal matrix elements. It is one feature of the quantum Bayesian approach that this particularm easure com es out in a natural way. To see this, we rst note a general property of the density m atrix,  $j_{12}j$ 11 22/ that simply comes from the density matrix eigenvalues being bounded between zero and one. Next, we consider an initially pure state  $(j_{12} j = p_{11 22})$  and notice that the elements of the density matrix after a measurement, <sup>0</sup>, obey the relation

The above relation is valid for every given m easurement outcome, so it is also valid after averaging over the distribution of results, hO (m) i =  $_{m} P$  (m; M)O (m), where O is any observable, and P (m; M) =  $_{11}P$  (m; M jl) +  $_{22}P$  (m; M j2). Using the classical Bayes rule for the diagonal elements, taking O =  $j_{12}^{0} = _{12}j$  and the fact that jO ij hjD ji, we obtain the generalized e ciency relation

Notice this relation is quite general, as no particular update rule for the o -diagonal matrix element has been invoked. Therefore, a detector reaching the upper bound (14) can naturally be called ideal, or 100% e cient. (For the appropriate de nition of e ciency for an asymmetric detector see, e.g., Refs. 15,21.) Thus far, we have focused only on the dynam ics of the m easurem ent process, and have neglected the H am iltonian evolution of the DD qubit. This evolution rotates the quantum state, and continually changes the elective m easurem ent basis, which typically nuins the desired continuous m easurem ent. The way to get around this bothersom e detail is with QND m easurem ents, the subject of the next section.

#### III. KICKED QND MEASUREMENTS

The unifying them e behind allQND schemes is to couple the m easurem ent apparatus to the qubit with an operator that is an approxim ate constant of motion of the measured quantum system  $^{6}$  In this way, the detector only m easures the state in the desired xed basis, and the internal quantum dynamics that would otherwise spoil the desired m easurem ent is circum vented. The speci c scheme we employ in this paper is that of kicked QND m easurem ents, introduced by V.B raginsky et  $al^7$  and K. Thome et al.<sup>8</sup> for the ham onic oscillator. In Ref. 9, this idea is introduced for two-state systems by making an analogy to a cat playing with a string that moves in a circle. In the kicked QND mode, the cat sits in one spot waiting for the string to come to it, and only then bats at it. The motion in a circle com es from the simple Hamiltonian evolution of a two-state system. If <sub>z</sub>=2+  $_{\rm x}$ =2 is the qubit H am iltonian, where H = is the tunnel coupling energy, and is the energy asym m etry, then unitary evolution for a time t is given by

where  $E = \frac{P}{2} + \frac{2}{2}$ , and  $\sim = 1$  throughout the paper. From the perspective of the qubit, the measurement ap-




FIG. 2: (color online). (A fier R ef. 11). V isualization of the kicked QND m easurem ent scheme. A voltage pulse is applied to the quantum point contact on a time scale v q, followed by a quiet period of zero voltage bias, lasting for a R abi oscillation period q, followed by another pulse, and so on. The up/down variation is depicted, where the kicks come every half period, and the sign of the voltage pulse alternates with every kick. In this scheme, qubit read-out is by sim – ply m easuring the sign of the current, and corresponds to an elementary quantum pump.

paratus only measures at approximately discrete points in time. In this reduced problem, by choosing the waiting time between kicks to be  $_q = 2 = E$  (or some integer multiple n thereof), the unitary evolution (15) becomes  $U ! (1)^n$ . The operator we want to measure is then static in time, and is thus a QND measurement. (The evolution is also simple if n is a half-integer, especially if = 0). However, from the point of view of the detector,

the on/o pulse lasts much longer than any detector time e scale, so many electrons pass through the QPC. If  $_0$  is the time scale of the QPC electron correlation,  $_V$  the time scale of the pulse duration, and  $_q$  is the Rabioscillation period, then the considered time scale ordering is  $_0 \quad v \quad q^{22}$ .

A pump variation on kicked QND measurements was given by Buttiker and the authors in Ref. 11, where instead of giving the sam e kick every R abi oscillation, the experimentalist gives a sequence of voltage kicks to the QPC with a pulse generator, alternating in sign, every half oscillation period (see Fig. 2). In this scenario, we have shown that if = 0, qubit readout is accom plished by pum ping current: the kicks provide one AC current source, and the dynam ics of the qubit provides another (intrinsically quantum mechanical) AC current source, that nevertheless causes a net D C current ow in the QPC.<sup>23,24</sup> There are two limiting cases the system is driven into: E ither the qubit oscillations are of the same phase with the pump oscillations, pumping positive current, or the qubit oscillations are of opposite phase with the qubit oscillations, pum ping negative current.

To characterize the result of each measurement kick, the parameters of the measurement process with an ideal QPC detector are specified by the currents,  $I_1$  and  $I_2$ , produced by the detector when the qubit is in state jli or j2i, and the detector shot noise power  $S_1 = eI(1 - T)$  (where T is the transparency)<sup>26</sup>. The typical integration time needed to distinguish the qubit

signal from the background noise is the measurement time  $T_M = 4S_I = (I_1 \quad \underline{\flat})^2$ . Shifted, dimensionless variables may be introduced by dening the current origin at  $I_0 = (I_1 + I_2) = 2$ , and scaling the current per pulse as I  $\underline{\flat} = x (I_1 \quad \underline{\flat}) = 2$ , so  $I_{1,2}$  are mapped onto x = 1. The weak static coupling (per pulse) between QPC and DD implies that the kick duration  $_V$  is less than the measurement time  $T_M$ . We take x to be normally distributed with variance  $D = T_M = _V$ . The typical number of kicks needed to distinguish the two states is D , where we assume D 1.

The measurement result I after N kicks is

and we seek the conditional probability distribution P (I;N j) of measuring the dimensionless current I, starting with a given density operator prepared before the rst kick. The functions P (I;N jj) are dened as classical probability distributions of the current with mean I = 1 (if j = 1) and variance  $^2$  = D =N, the G aussian equivalent of (12),

and the notation  $P_j(x_n)$  is adopted for the j = 1;2 distributions of the nth kick. The probability density of m easuring the result  $x_n$  after one kick is determ ined by the state of the qubit just before the m easurem ent, and is given by the analog of (7),

The density matrix of the qubit is updated based on the information obtained from the measurement that just occurred. This is done with the quantum Bayesian update rules,<sup>15</sup> that de ness a non-unitary quantum map directly analogous to Eqs. (8,9),

This quantum map is a probabilistic, non-unitary relative of the unitary maps studied in kicked quantum chaos.<sup>27,28</sup> The advantage of QND m easurement in the Bayesian approach is seen by using Eqs. (19) to express the conditional probability density P ( $x_n$ ) in terms of the result of the preceding kick  $x_{n-1}$ . It follows from (18,19) that

This recursive relation helps in the calculation of the (unconditional) probability distribution P (I;N j) of nding current I, starting with the density matrix , after N kicks, given by Each application of (20) generates a denom inator that cancels the probability density in mediately preceding it in (21). Making N iterations of (20) gives

where 11; 22 are the diagonal matrix elements of the original density matrix, and the N G aussians compose to form one G aussian with a variance N times smaller. As N is increased, the two qubit states can be distinguished with greater statistical condence, and eventually the distributions limit to delta-functions, giving either I = 1 with probability 11, or I = 1 with probability 22. A one-sigm a condence is obtained when N = D, as previously stated.

It is worthwhile to point out several features of the above QND m easurem ent. First, N weak m easurem ents sim ply compose to make an N-times stronger measurement. Second, the QND measurement output only involves the diagonal density matrix elements. It is for this reason that the output of a quantum nondem olition measurement is equivalent to noisy classical measurement, where the detected \classicalprobabilities" are given by the diagonal density matrix elements in the preferred measurement basis. In spite of the classical nature of the detector output, the qubit state prepared after the N measurements can be deduced from the outcom e of the random variable I. To characterize the postmeasurement density matrix, we note another recursion relation from (19),

This result may be composed N times, and the update of the o -diagonal matrix element (19) follows from (23). Using the de nition I = (1=N)  $\prod_{n=1}^{N} x_i$ , the measurement of a given random current I prepares a new density matrix of the DD,




FIG. 3: (color online). (A fter Ref. 11). The conditional evolution of all initial pure states, represented on the B loch sphere, under continuous QND m easurement by an e cient detector. From (a-e), the rapidity of the m easurement is = N I=D = (1; 5;0;5;1) respectively. As the detector obtains more information about the quantum state, we can with greater statistical certainty distinguish the postmeasurement quantum state, so the B loch sphere is more and more red (jli) or blue (jli), depending on the value of the rapidity measured. The conditional evolution of several representative states is also indicated with black arrows. The view-point is parallel to the equator of the B loch sphere, so jli! North pole, and jli! South pole.

where = IN =D is the rescaled measurement result, named the rapidity of the measurement, for reasons given in the Sec. IV. The conditional quantum dynamics of Eq. (24) is illustrated in Fig. 3, for all pure states, and the density matrix is parameterized as =  $(1 + \frac{1}{2}X_{i}) = 2$ ,

so (X;Y;Z) give coordinates on the Bloch sphere. The X and Y behavior follows from Z, which is in turn conditioned on the detector output I, so the sphere is colored according to the conditional evolution of Z,

If the rapidity is positive, then states are \attracted" toward the North pole, while if the rapidity is nega-

tive, then states are \attracted" toward the South pole. As the rapidity grows increasingly positive or negative, we become more condent which state the qubit has continuously collapsed to, but this also depends on the initial state. The conditional evolution of several representative states is indicated with black arrows.

W hile the whole point of the kicked QND proposalwas to e ectively turn o the qubit unitary evolution while the continuous measurement is taking place, a much more interesting situation arises when continuous (nonunitary) measurements are combined with controlled unitary rotations. The kicked measurement set-up provides a simple way of generating a single-qubit rotation: waiting. Rather than spacing the pulses by a full Rabi oscillation as previously described, we choose to wait some fraction r of a Rabi oscillation,  $t_{wait} = r_q$ , that de nes a phase shift = 2 r. A single-qubit unitary operation (expressed in the z-eigenbasis),

m ay be executed by choosing r, such that  $a = \cos(=2)$ i(=E) sin(=2), and b= i(=E) sin(=2), by using the H am iltonian evolution of the qubit, Eq. (15). Varying r, any point m ay be reached on a circle on the B both sphere, which is xed by and . In order to reach any pure state (up to an overall phase) by H am iltonian evolution starting with a pure state, the qubit asymmetry should also be varied between the kicks with gate voltages.

# IV. POVM MEASUREMENT AS A STOCHASTIC CONFORMALMAP

Before considering speci c examples of weak measurement, combined with unitary operations, we rst reformulate the above set of weak measurements (18,19), and unitary operations (26) in an important special case: where the initial state is pure, the detector is e cient (as considered in this paper), so the post-measurement state is also pure. The initial arbitrary DD state is de ned as j i = jli + j2i, with density matrix elements  $_{11} = j f$ ,  $_{12} =$ ,  $_{21} = _{12}$ ,  $_{22} = j f = 1$   $_{11}$ . Represented as coordinates on the B loch sphere, (X;Y;Z), both measurements and unitary operations leave the state on the surface, X<sup>2</sup> + Y<sup>2</sup> + Z<sup>2</sup> = 1.

Now make a stereographic projection of the Bloch sphere onto the complex plane, with the complex variable , de ned as

The South pole of the B loch sphere is identified as the origin of the plane, while the N orth pole is identified as 1 on the plane. Translating the unitary operation (26) on the qubit into an operation on the complex variable , we not the conform alm apping,

known as a M obius transform ation. The group algebra of unitary rotationsm aps onto the group algebra of conform alM obius transform ations. R eference 29 points out that this property can be used to dem onstrate operator product identities for one qubit.

Translating the non-unitary Bayesian update equations for the density matrix (19), as an operation on the complex coordinate , we nd the following stochastic conform alm apping:

This conform alm apping is simply a random scale transform ation with two xed points: one at 0 (the South pole, state j2i) and the other at 1 (the North pole, state j1i). The random variable x is chosen from the probability distribution (18), which translates to

Thus, any sequence of weak m easurements, combined with unitary operations can be translated into repeated conform alm apping. We note that after an arbitrary sequence of weak m easurements and unitary operations, the de nition = =, together with the normalization of the state,  $j \ j^2 + j \ j^2 = 1$ , im mediately allows the wavefunction to be read o (up to an overall phase). The inclusion of asymmetric m easurements, where the phase shift in Eq. (9) is kept for a broader class of scattering matrices may also be easily included. This phase shift has the e ect of twisting the B both sphere proportionally to the value of current measured, which is equivalent to including phases in the scale factor,

where  $_1$ ;  $_2$  correspond to the continuous limit of the total acquired phase shift (m;M) = M + m (), described in Sec. II. The mapping (31) is obviously still conform al.

If we momentarily let x be a determ inistic variable, then the set of M obius mappings form a group, and the set of determ inistic scale transform ations form a di erent group. A natural question that arises is what (if any) group is described by the composition of (28), with (29)? Am usingly, the answer is provided by the special theory of relativity. Consider a relativistic four-vector (X;Y;Z;T). As is wellknown, any element of the Lorentz group m ay be produced by making a spatial rotation, followed by a boost in the (say) Z direction, followed by another spatial rotation. The boost from (X;Y;Z;T) to (X °;Y °;Z °;T °) in the Z direction may be described as a hyperbolic rotation

where the rapidity is introduced in term softhe velocity parameter v, the physical velocity measured in units of the speed of light, c = 1.

To connect this to spinor form alism, we follow the discussion in Penrose and R indler,<sup>30</sup> and de ne a Herm itian coordinate operator,

To extend the analysis to N boosts with rapidities  $_{i}$ , the mapping simply composes the N scalings, to produce a boost with rapidity  $= \sum_{i=1}^{N} _{i=1}$ . This conformal mapping is identical with (29), the analogous quantum m easurement composition, if = N I=D, the quantum m easurement parameter, is identiced with the rapidity of the boost. Furthermore, any spatial rotation of the sphere may be interpreted as a unitary operation on the B boch sphere, which projects to the M obius mapping (up to an overall phase). Thus, the group described by the composition of (28), with (29) is the (restricted) Lorentz group.

The di erence with the relativity analogy com es when we recall that =  $_{i}x_{i}=D$  is a random variable. The distribution of this random variable (30), explicitly depends on the \space-time" coordinates , and thus breaks the Lorentz invariance by introducing a preferred reference frame, the Z-axis, with Z = 1 as the attracting xed points. From the quantum measurement point of view, this is a consequence of choosing to measure along

the Z -axis. Therefore, for pure states, the mapping (29, 30) may be viewed as a stochastic Lorentz sem igroup.

#### V. COM BINED W EAK M EASUREM ENTS AND UN ITARY OPERATIONS

A fler having separately described weak measurement and unitary operations, we now combine them . Consider an experiment, where N<sub>1</sub> kicks are made, followed by a single qubit unitary operation U (produced by inserting a dislocation into the pulse sequence), followed by N<sub>2</sub> kicks. The measurement results I<sub>1</sub> and I<sub>2</sub> are dened as

We seek the normalized probability distribution  $P(I_1; N_1; I_2; N_2)$  of nding current  $I_1$  after  $N_1$  kicks, and  $I_2$  after  $N_2$  subsequent kicks. This distribution may also be interpreted as joint counting statistics.

The analysis from Sec.III indicates that after the rst N<sub>1</sub> kicks, them easured current I<sub>1</sub> willoccur with a probability given by (22), and prepares a post-m easurem ent density m atrix <sup>0</sup>, given by (24), described with the rapidity of the m easurem ent = I<sub>1</sub>N<sub>1</sub>=D. The subsequent unitary operation U (26), (characterized by a phase ) rotates the post-m easurem ent density m atrix,

The following set of N<sub>2</sub> kicks start with the density matrix (37), and continue to measure in the z-basis as before. Equation (22) may be applied again with the modie ed initial density matrix (37) to deduce the (unconditional) probability distribution of nding result I<sub>1</sub> after N<sub>1</sub> kicks, and result I<sub>2</sub> after N<sub>2</sub> kicks,

and the natural Hamiltonian dynamics performs the unitary operation (15,26). One interesting feature of the result (38,39) is that the outcome of the rst N $_1$ 

m easurements,  $I_1$ , appears in the expression involving the variables of the second set of kicks. This immediately implies that the distribution does not factorize, P  $(I_1; N_1; I_2; N_2) \in P_1 (I_1; N_1)P_2 (I_2; N_2)$ . The e ect comes from the rst set of measurements preparing a given density matrix of the DD, which a ects the results of the next set of measurements. From the distribution (38), the average current in each interval, as well as the correlation between the two may be calculated:

A lso, as N<sub>1</sub>; N<sub>2</sub> are taken to in nity in (38,39), the distribution P<sub>PM</sub> (I<sub>1</sub>; I<sub>2</sub>) from making simple projective measurements on the DD is recovered,

Reference 11 applied these results to violate a Bell inequality in time.

# VI. CONDITIONAL PHASE SHIFTS AND FEEDBACK PROTOCOLS

In the preceding Section, the phase shift was chosen beforehand, independently of the result  $I_1$ . We can now use the information gained in the rst N<sub>1</sub> measurements, and make a conditional phase shift, pending the outcome of the random variable  $I_1$ . This is essentially a feedback protocol that the experimentalist can choose to execute, de ned by a function  $(I_1)$ , so a di erent phase shift is assigned to every possible random outcom e of the continuous m easured current.

K icked QND m easurement provides a realistic mechanism for implementing general qubit feedback protocols. The reason for this is two-fold: First, as seen in the previous section, any combination of weak measurements and unitary operationsmay be accomplished with a sequence of voltage pulses to the detector. Second, the feedback circuitry must take the result obtained from the measurement, execute logical operations, and command the experimental apparatus to do something it otherwise would not have done (like make a given phase shift). The intrinsic waiting time between the kicks provides the needed time delay for all of the above to take place.

We now explicitly nd the feedback protocol  $(I_1)$  to take a given pure state to any desired pure state after a weak measurement. As the simplest case, consider any pure state on the Z Y great circle of the Bloch sphere (X = 0; Y<sup>2</sup> + Z<sup>2</sup> = 1), and a symmetric qubit, = 0. Both Ham iltonian evolution, and weak measurem ents (according to (24)) do not take these states out of Y great circle. Therefore, know ing the outcom e the Z I<sub>1</sub>, a conditional phase shift m ay be applied to determ inistically prepare any quantum state on the Z Y great circle of the Bloch sphere. For de niteness, we choose to shift to the state jli. This choice has the advantage that after the N $_2$  D m easurem ents, the current will be  $I_2 = 1$  determ inistically. The parametrization (Y;Z) = (sin; cos) of the initial state is chosen, so that if no measurement is made, the shift to the North pole may be done with a phase shift = . The result (39) is applied by setting  $11^{\text{new}} = 1$ , and solving for as a function of the rapidity , to nd

This answer interpolates between two extreme strategies:<sup>31</sup> (1) If no measurement is made, just make the desired phase shift, = . (2) If a projective measurement is made, either do nothing if  $I_1 = 1$ , or ip the state by applying the phase shift = if  $I_1 = 1$ . The asymptotic limits in the later case may be obtained by expanding the inverse tangent to obtain

The above real-time feedback proposal is experimentally promising in the kicked scheme. However, it demands fast time resolution and feedback circuitry. An experimentally simpler proposal to verify the above protocol is to make many realizations of weak measurement, phase shift, weak measurement, where the phase shift is chosen randomly in each realization. After the run is nished, the data record may be reviewed, and all instances of phase shifts where condition (45) is approximately satis ed are post-selected. In this data subset, the prediction is that the following set of N  $_2$  D kicks will determ inistically nd I $_2$  = 1.

## VII. PURIFICATION OF INITIALLY MIXED DENSITY MATRICES BY WEAK MEASUREMENT

Under repeated weak QND measurements, eventually all states collapse to either ili or ili, including mixed initial states. However, the states jli and jli are both pure, and therefore if the initial state ism ixed, a puri cation occurs during the measurem ent process.<sup>32</sup> This phenomenon is especially counter-intuitive from the point of view of the dephasing approach to quantum measurement. Jacobs has shown that the average puri cation in a given time can be increased by the use of continuous feedback.<sup>14</sup> Jacobs' protocol is som ew hat counterintuitive for the qubit: always use Ham iltonian evolution to rotate the state to Z = 0, i.e. perpendicular to the m easurem ent axis. The purpose of this section is (1) To show how this idea can be easily implemented for our set-up, (2) To dem onstrate that the \equatorial plane" protocol (i.e. Z = 0) is also optim all for kicked QND m easurem ents which have a continuous output of tunable m easurem ent strength, and (3) To generalize Jacobs' nofeedback puri cation solution to any initial density matrix.

It is well known that any unitary operation preserves the purity (or entropy) of the state. It is interesting to note from (19), that during weak m easurem ent there is a di erent preserved physical quantity, that we name the murity. For the qubit, the purity P and the murity M are de ned as

If the purity P = 1, then the murity M = 1, re ecting the statement made in Sec. II that if the initial state is pure, the post-measurement state is also pure. We note that P may be expressed in terms of M and Z by  $P = M (1 Z^2) + Z^2$ . After one kick, the change in the purity, P, (or puri cation) is given by

Several observations are in order: First, if P = 1, the puri cation P is automatically 0, while the rst (determ inistic) factor is maximal if P = 0. Second, if x = 0,

the second (random) factor is zero, so there is no puri cation, which corresponds to no gained information. Finally, the rst factor is between [0;1], while the second factor could be negative or positive, in plying that either puri cation or further mixing is possible in a given run.

The average puridation is given by averaging (49) over the distribution of x, given in Eq. (18), to yield

It is straightforward to check that 0 f 1, so there is nonnegative average puri cation for all density matrices.<sup>33</sup> Changing variables to = x=D, it is also straightforward to check asymptotic limits. Taking D ! 0, the projective limit, f(0;Z) = 0 is recovered, so h P i = 1 P, in plying that the nal state is pure with unit probability. The opposite limit, D ! 1, corresponds to an vanishingly weak measurement, so f(1;Z) = 1, or h P i = 0, giving no puri cation.

The results (50,51) allow us to nd the optimum average puri cation strategy for one kick. The best strategy on average is to rotate the density matrix to where the puri cation (50) is maximum. These point(s) may be found by maximizing h P i on the B loch ball, under the constraint that D and P are xed. The P constraint sim – ply relects the fact that unitary operations do not alter the purity. This problem is equivalent to minimizing f with respect to Z, by solving df=dZ = 0, which leads to the equation

The solution is immediate because at the point Z = 0, the integrand is odd, so the integral is zero. The fact that f is minimized at Z = 0 is seen by noting that the integrand of  $d^2 f = dZ^2 (Z = 0)$  is nonnegative. Therefore, the average puri cation is maximized by applying a phase shift after the rst measurement that rotates the qubit to the equatorial plane of the B loch ball before the measurement. This result is in agreement with Jacobs, who considered puri cation from a two-outcome POVM of variable strength (and also the stochastic Schrödinger equation lim it).<sup>14</sup> O ur approach is from the complimentary perspective of a continuous outcom e measurement of variable strength.

Results (50,51) have a simpler form in the large D limit, for very weak measurements. The average purication h P i and the noise in the puri cation, h(P)  $^{2}$  i, are given to leading order in D  $^{1}$  as

In order to compare puri cation with and without feedback, we rst consider Jacobs' feedback protocol Z = 0 at every tim e step. Equation (53) in plies that for this feedback protocol the puri cation noise vanishes. Therefore, the dynam ical puri cation is described by the determ inistic rate equation dP = dN = (1 P) = D. Solving the equation with initial condition  $P_0$  yields<sup>14</sup>

yielding an approach to purity with rate (2D)  $^1$ , half as fast as the feedback case, in agreem ent with Jacobs. The result (56) generalizes Jacobs' no-feedback puri cation result to arbitrary initial states. Before concluding, we point out that W isem an and Ralph have recently show n that the advantage of feedback for puri cation depends on how the question is form ulated.<sup>35</sup> If instead of asking about the average puri cation for a xed time, we ask about the average time taken to reach a given purity, then the no feedback case is actually better.

#### VIII. CONCLUSIONS

The quantum Bayesian approach to the problem of quantum measurement has been derived from POVM form alism, applied to a mesoscopic scattering detector. By considering an elementary scattering event, measurement operators associated with the successful or failed detection of the electron in the current collector can be identied. We recover the quantum Bayesian form alism in the continuous current approximation.

K icked QND m easurements have been analyzed within the quantum Bayesian formalism. We derive a quantum map representation that, while discrete in the time index, describes a sequence of weak m easurem ents. Unitary operations (easily in plem ented by waiting a fraction of a R abiperiod), together with kicked m easurem ents, can be represented as a sequence of conform alm appings, where the unitary m aps are determ inistic, and the kicked m easurem ent m aps are stochastic. A close analogy exists between these quantum m aps and the Lorentz transform ations of special relativity.

We have calculated the measurement statistics associated with combined weak measurements, and unitary operations. These results are applied to nd the feedback protocol that deterministically takes a given pure state to any other desired pure state after a weak measurement, using conditional phase shifts.

Next, we have investigated the process of puri cation of m ixed density m atrices under kicked QND m easurem ent. The concept of \m urity" (the physical quantity that is preserved under m easurem ent) has been introduced, and applied to calculate the change in the state's purity associated with a m easurem ent. Puri cation with and without feedback has also been investigated.

W e stress that kicked QND m easurements provides an experimentally viable way of implementing ideas in quantum feedback: Any combination of weak measurements and unitary operations can be accomplished by applying a sequence of voltage pulses to the detector, and the intrinsic quiet time between kicks allows the necessary processing time for feedback to occur.
