# Chiral sym metry restoration in (2+1)-dimensional QED with a Maxwell-Chern-Simons term at nite temperature

We study the role played by a Chem-Sim ons contribution to the action in the QED $_3$  form ulation of a two-dimensionalH eisenberg model of quantum spin systems with a strictly xed site occupation at nite temperature. We show how this contribution a ects the screening of the potential which acts between spinons and contributes to the restoration of chiral symmetry in the spinon sector. The constant which characterizes the Chem-Simons term can be related to the critical temperature  $T_c$  above which the dynamical mass goes to zero.

#### I. INTRODUCTION

Q uantum E lectrodynam ics Q E D  $_{(2+1)}$  is a common fram ework aim ed to describe strongly correlated systems such as quantum spin systems in 2 space and 1 time dimension, as well as related specic phenomena like high- $T_c$  superconductivity  $^{1,2,3,4}$ . Indeed, a gauge eld formulation of the antiferrom agnetic H eisenberg model in d=2 dimensions leads to a Q E D  $_3$  action for spinons, see f. i. G haem i and Senthil  $^2$ , M orinari  $^3$  and also  $^6$ .

W e consider the -ux state approach introduced by A eck and M arston  $^{7,8}$ . The site-occupation of the system by a single particle is enforced by m eans of a procedure which was suggested by Popov and Fedotov<sup>5,6,9</sup>.

Here we concentrate on the behaviour of the spinon mass at nite temperature which is dynamically generated by an U (1) gauge eld when the action contains a Chem-Sim ons (CS) term. Solving the Schwinger-Dyson equation for the spinon eld we show below how the critical temperature  $T_{\rm c}$  (above which the dynamical mass vanishes) is a ected by the CS term.

The outline of the paper is as follows. The  $\,$  rst section sketches the main steps of the QED  $_3\,$  formulation of the 2dH eisenberg model. Section III introduces the CS term and justimes its presence. In section IV we show and comment the chiral symmetry restoration of the spinoneld in the presence of this term.

# II. FROM THE HEISENBERG INTERACTION TO THE -FLUX DIRAC ACTION

Heisenberg quantum spin Hamiltonians of the type

with antiferrom agnet coupling  $fJ_{ij}g < 0$  can be mapped onto Fock space by means of the transformation  $S_i^+ = f_{i,"}^y f_{i,"}$ ,  $S_i^- = f_{i,"}^y f_{i,"}$  and  $S_i^z = \frac{1}{2} (f_{i,"}^y f_{i,"} f_{i,"} - f_{i,"}^y f_{i,"})$ 

where  $ff_{i,}^{y}$ ;  $f_{i,}$  g are anticommuting ferm ion operators which create and annihilate spinons with = 1=2. The projection onto Fock space is exact when the number of ferm ions per lattice site veriles  $f_{i,}^{y} f_{i,} = 1.$ 

This can be enforced by using the Popov and Fedotov procedure  $^{5,6,9}$  which introduces the imaginary chemical potential = i =2 at temperature  $^{1}$  adding the term N to the expression given by (1)

In 2d space the Heisenberg Ham iltonian given by Eq.(1) can be written in terms of composite non-local operators fD  $_{ij}$ g ("di usons") $^{5,13}$  de ned as

where  $\sim$  is a lattice vector  $fa_1$ ;  $a_2g$  in the O'x and O'y directions the H am iltonian takes the form

where i and j are nearest neighbour sites.

The number operator products  $\mathrm{fn}_i\mathrm{n}_j\mathrm{g}$  in Eq.(2) are quartic in terms of creation and annihilation operators in Fock space. In principle the formal treatment of these terms requires the introduction of a Hubbard-Stratonovich (HS) transformation. One can however




FIG. 1: Plaquette ( ) on a two dimensional spin lattice.  $e_x$  and  $e_y$  are the unit vectors along the directions  $\mathscr{O}x$  and  $\mathscr{O}y$  starting from site 1 on the lattice

show that the presence of this term has no in uence on the results obtained from the partition function. Indeed both  $\operatorname{fn}_i g$  and  $\operatorname{fn}_i n_j g$  lead to constant contributions under the exact site-occupation constraint and hence are of no importance for the physics described by the H am iltonian (2). As a consequence we leave them out from the beginning.

U sing a H S transform ation in order to reduce the  $\,$  rst term in Eq. (2) from quartic to quadratic order in the ferm ion operators  $f^{\,y}$  and f the H eisenberg H am iltonian reads

where f  $_{ij}$ g are the HS auxiliary elds. At this point no approximation has been made and Eq.(3) is exact.

The elds  $_{ij}$  can be chosen as complex quantities  $_{ij}=j$  je  $^{i}$   $_{ij}$ . This param etrization introduces gauge elds  $_{ij}$  which are de ned on the square plaquette shown in gure 1 and can be decomposed into a mean eld part and a uctuation contribution  $_{ij}={}^{m}_{ij}+{}^{l}_{ij}$ . The amplitude j j too may contain a mean-eld and a uctuating contribution. In the following we assume that at low energy the essential quantum uctuation contributions are generated by the gauge eld  $_{ij}$  and neglect the amplitude uctuations in the sequel.

In order to implement the SU(2) invariance in (1) at the level of the mean-eld Hamiltonian (3) we follow  $^{7,8,14,15,16}$  and introduce the con quration




FIG. 2: The contour representation of the energy spectrum  $!\binom{PFP}{()\kappa_i} + = 2 \frac{p \cos^2(k_x) + \cos^2(k_y)}{\cos^2(k_x) + \cos^2(k_y)}$  for  $k_x$  and  $k_y$  belonging to  $\frac{1}{2};\frac{1}{2}$  and showing the presence of the nodal points ( $\frac{1}{2};\frac{1}{2}$ ) where the energy is equal to zero.

Then the total ux through the fundamental plaquette is such that  $^{m f} = which$  guarantees the SU (2) sym m etry<sup>17</sup>.

We are interested in the low energy behaviour of the quantum spin system described by (4) in the neighbourhood of the nodal points  $k_x = \frac{1}{2}; k_y = \frac{1}{2}$  where the energy gap  $\binom{p + p}{(+), k}$   $\binom{p + p}{(-), k}$  vanishes. Fig 2 shows the contour plot of the energy spectrum  $\binom{p + p}{(-), k}$  and locates the nodal points. We linearize the energies in the neighbourhood of these points.

Following $^{2,3,6}$  the spin liquid Hamiltonian (4) at low energy can be described in term soffour-component Dirac spinons in the continuum limit. The Dirac action of this

spin liquid in (2+1) dimensions including the phase uctuations  $_{ij}$  around the -uxmean eldphase  $_{ij}^{m\ f}$  has been derived in  $^6$  and reads

The rst term in (5) originates from the U (1) sym metry transform ation !  $e^{ig}$  which generates a gauge eld a = @ . The constant g in (5) is the coupling strength between the gauge eld a and the D irac spinons . The rst term corresponds to the \M axwell" term  $\frac{1}{4}$ f f of the gauge eld a where f = @ a @ a , is the parameter of the Faddeev-Popov gauge xing term (@ a ) $^{218}$ , the K ronecker , =  $^{2}$  +  $^{2}$  the Laplacian in Euclidean space-time. # III. M AXW ELL-CHERN-SIM ONS ACTION AT FINITE TEMPERATURE

### A. Justi cation and im plem entation

As shown by M arston<sup>17</sup>, only gauge con gurations of the ux states belonging to  $Z_2$  symmetry ( ) are allowed. Hence the ux through the plaquette is restricted to =  $^{m f}$  + = f0; g. In order to rem ove \forbidden" U (1) gauge con gurations of the antiferrom agnet H eisenberg model ( $\frac{1}{2}$ ) a CS term should be included in the QED  $_3$  action in order to x the total ux

through a plaquette. This leads to the M axwell-Chem-Sim ons (MCS) action in Euclidean space

introduces a new constant . We show below that this constant can be xed to a de nite value.

From the above action (6), the equation of motion of the gauge eld in M inkowskian space

leads to a relation between a magnetic eld and the CS coe cient  $^{19,20}$ . If B =  $@_1a_2$   $@_2a_1$  is chosen to be constant in such a way that the whole system experiences an hom ogeneous magnetic eld the equation of motion (8) of the gauge eld becomes

The gauge eld a is related to the phase (r) of the spinon at site r through the gauge transform ation  $f_r$ ; !  $e^{ig}$  (r)  $f_r$ ; which keeps the H eisenberg H am iltonian (3) invariant. From the de nition of one gets  $f_r$ !  $f_r$  . It is clear that (r) is the phase at the lattice site r and that a (r) = @ (r). Hence the magnetic eld B is then directly related to the ux through the plaquette shown in gure 1

The present analysis may suggest that the application of a real magnetic eld to the spin system could allow to detect the presence of spinons through the Quantum Hall E ect $^{21}$ . We leave this point for further investigations.

#### B. The photon propagator at nite tem perature

In this subsection we construct the dressed photon propagator of QED  $_3$  with an MCS term at nite temperature in order to gain information about the interaction between spinons and the implication of the CS term on the dynamical mass generation.

Integrating (6) over the ferm ion elds  $_R$ , the partition function of the spin system Z [;a] = D (;a)e  $^{S_E}$  with the action  $S_E$  given by (6) leads to the pure gauge partition function

the rhs. of equation (15) is independent of the gauge eld fag. It can be removed from the series since we focus our attention on pure gauge eld terms. The rst term proportional to the gauge eld n=1 in the sum vanishes since tr=0. Keeping only second order terms in order to stay with gaussian contributions to the uctuations one gets the pure gauge action

The second term in equation (16) has been worked out  $in^6$ . The whole action can be put into the form

#### IV. \CHIRAL" SYM M ETRY RESTORATION

The coupling of the gauge eld a to the spinon eld generates a mass for this eld  $^6$ . Chiral sym metry in four dimensions requires fermions to be massless. In this space a mass term m changes sign under chiral transform ations generated by means of the Dirac matrix  $_5$ . Hence fermions must be massless in order to keep the action invariant. In three dimensions no real  $_5$  matrix can be dened. However embedding the (2+1)-dimensional space into a four dimensional space two types of \chiral" sym metries can be dened from  $_3$  and  $_5^{11,22,23}$  where  $_3$  and  $_5$  are 4 4 matrices

where  $f_{i}$ ; i = 1; 2; 3g are the Pauli m atrices and D irac matrices verify + = 2 in Euclidean space.

Appelquist et al. $^{11,12}$  showed that at zero tem perature the originally massless ferm ion acquire a dynamical mass when the number N (= 1) of ferm ion avors is

lower than the critical value N  $_{\rm C}$  = 32=  $^2$ . Later M aris<sup>24</sup> con m ed this result with N  $_{\rm C}$  ' 3:3. Since we consider only spin-1=2 system s, N = 2 and hence N < N  $_{\rm C}$ .

At zero temperature the dynamical m<sub>h</sub>ass term is renormalized by the CS term  $\frac{m~(~6~0)}{m~(~=~0)}=~e^{-\frac{4N}{N_{\rm c}}:\frac{2}{(~=16)^2}}$  and even the critical value N  $_{\rm c}$  is a ected as Ne  $_{\rm c}=$  N  $_{\rm c}$  1+ (16 = ) $^2$  as shown by H ong and Park  $^{10}$ .

Here we concentrate on the impact of the CS term on the dynam icalm ass generation and show that chiral symmetry can be restored at nite temperature. An explanation of the mechanism behind this symmetry restoration will also be given.

## A. E ective potential at nite tem perature

In the present theory mass is generated in two dierent ways. First, as shown earlier, the massless photon

induces a mass for the spinon through the coupling of the two elds  $^6$ . Second, the CS coe cient gives a mass to the "photon" (gauge eld a ), m  $_{\rm M}$  CS = . This can be seen from the pure gauge equation of motion for the dual eld  $^6$   $^1_2$ " f  $^{19}$

The m assive photon induces the same e ect (dynamical mass generation) at zero temperature  $^{10}$ .

We show now how the photon mass (the CS coe - cient) a ects the e ective potential at nite temperature between two spinons.

The static e ective potential between spinons with opposite charge g is given by

which shows that the stronger the shorter the correlation length . Hence variations of a ects the correlation length between spinons. Moreover the variation of

the ux through the square plaquette also a ects the correlation length since the CS coe cient is related to the ux through equation (9). If the ux through the plaquette increases the correlation length also increases, the larger the shorter the interaction between spinons.

#### B. Dynam icalm ass generation

W e show how the CS term a ects the \chiral" restoring transition tem perature of the dynam icalm assignmentation. The Schwinger-D yson equation for the spinon propagator at nite tem perature reads

The second term in (20) is the ferm ion self-energy , (G  $^1 = G^{(0)}$  ). Performing the trace over the matrices in equation (20) leads to a self-consistent equation for the self-energy

If the main contribution comes from the longitudinal part  $_{00}$  (0;  $\overset{\mathbf{p}}{}$ ) of the photon propagator (22) goes over to




FIG. 3: Dependence of the dynam ical mass m (T) on the tem perature. Full line: = 0. Long dashed line: = =  $5:10^3$ . Dashed line: = =  $7:10^3$ . All curve are obtained with = =  $10^5$ .

Perform ing the sum mation over the modi ed ferm ion M atsubara frequencies  $e_{\rm F}$ ;  $_{\rm n}$  =  $\frac{2}{}$  (n + 1=4) $^{5,6}$  the self-consistent equation takes the form

As de ned above =  $g^2N$  with N = 2 since we have implemented the Popov-Fedotov procedure<sup>5,6</sup>. Here is the UV cuto and can be identied as the inverse spin lattice spacing. Equation (24) can be solved numerically.




FIG. 4: Chiral sym m etry transition tem perature  $\frac{T_c}{r}$  depending on the CS coe cient -. Here - =  $10^5$ .

Figure 3 shows the dependence of the dynam icalm ass on the tem perature for di erent value of = . This m ass which is di erent from zero for low tem perature T vanishes at some tem perature  $T_c$  which depends on . As = increases the chiral symmetry transition tem perature  $T_c$  decreases following the relation  $\frac{T_c \, (\, 6 \, 0)}{T_c \, (\, = \, 0)} =$  e  $^{a \, (\, = \, ) \, \frac{2}{2}}$  where a ( = ) is a coe cient depending on = . The behaviour for a xed is shown in Figure 4.

One can understand the mechanism of chiral sym metry restoration as follows. The photon (gauge eld) gives a m ass to the ferm ions (spinons) through a dynam icalm ass generation m echanism. W hen the temperature increases this mechanism is lowered by uctuations, the ferm ions gain in m obility (the dynam icalm assm (;) decreases). This is similar to the situation in plasmas. When the tem perature is high enough the charged particles com posing the plasm a are considered as free particles. Below som e tem perature these charged particles are screened thus their mass is renormalized and gets larger than in the high tem perature plasm a. The CS m ass contributes also to the photon m ass, the interaction V (R; ) between ferm ions is weakened as increases for a xed length R, the correlation length gets weaker and thus the screening e ect gets weaker. Finally the chiral sym metry restoring tem perature decreases with increasing the screening e ect is smaller and thus ferm ions gain mobility, their mass term is renormalized to a smaller value. At zero tem perature the dynam icalm ass decreases as

increases like  $\frac{m\ (\ 6\ 0)}{m\ (\ =\ 0)}=e^{-\frac{4N}{N}\frac{2}{c\ (\ =\ 16)^2}\,20}$ , thus proving that the screening e ect is lower as the photon mass increases and reduces the dynam ical mass of the spinon.

Going back to the Heisenberg model and looking for consequences of this chiral symmetry restoration on the energy spectrum of spinons, one can see that when the CS coe cient diers from zero the gauge eld a gets a gap due to the mass term . As goes to 1 the spinon energy gap m (;) decreases leaving a gapless spinon spectrum for a transition temperature  $T_{\text{c}}$  going to zero.

For xed = the know ledge of T  $_{\rm c}$  xes (Fig. 4) and consequently the generated m ass m (; ) (Fig. 3).

#### V. CONCLUSIONS

The low energy spectrum of the Heisenberg model describing a two dimensional antiferrom agnet quantum spin system with an SU (2) symmetry has been mapped onto a (2+1)-dimensional quantum electrodynamics action with a U (1) gauge eld symmetry  $^6$ . In this framework

we showed that the addition of a Chern-Sim ons term to the M axwell term in the pure gauge eld theory of the QED $_3$  at nite temperature a ects the spinon energy spectrum through a chiral symmetry restoration transition. The chiral symmetry transition temperature  $T_c$  above which the dynamical spinon mass is equal to zero follows the relation  $\frac{T_c\,(\,6\,0)}{T_c\,(\,-\,0)}=\,e^{-a\,(\,-\,)\,\frac{2}{2}}$  where a ( = ) is a coe cient depending on = and the UV cuto .

The e ective potential between two spinons with opposite charge g at nite temperature shows that the Chem-Sim ons term controls also the screening of this interaction through the photon mass which is identified with the Chem-Sim ons coecient. The correlation length decreases showing that the screening elect gets weaker as increases.

The value of can be controlled by xing the ux through a plaquette going around neighbouring spin lattice sites. The gap in the spinon spectrum shrinks to zero with increasing for a xed temperature.

Hence the Maxwell-Chem-Simons term at nite temperature which is aimed to x the correct U (1) gauge conguration provides an interesting way to control the chiral symmetry restoration temperature and the elective potential between spinons. The present study has been done in the framework of a non-compact theory. One may ask how it will be in uenced by the presence of instantons in a compact description of the gauge led. This point related to the connement/deconnement problem is still under discussion 25,26,27,28.

#### VI. APPENDIX

One may believe that a system at nite temperature breaks Lorentz invariance since the frame described by the heat bath already selects out a specic Lorentz frame. However this is not true and one can formulate the statistical mechanics in a Lorentz covariant form  $^{29}$ .

We consider a system in 2 space and 1 timed in ension. Denote the proper 3-velocity unof the heat bath. In the rest frame of the heat bath the three velocity has the form u=(1;0;0) and the inverse temperature characterizes the thermal property of the heat bath.

Given the 3-velocity vector  $\mathbf{u}$  one can decompose any three vector into parallel and orthogonal components with respect to the proper velocity of the heat bath, the velocity  $\mathbf{u}$ . In particular the parallel and transverse components of the three momentum  $\mathbf{q}$  with respect to  $\mathbf{u}$  read

are orthogonal to q

Sim ilarly one can decompose any vector and tensor into components which is parallel and transverse to a given momentum vector  ${\bf q}$
