Separation of suspended particles by arrays of obstacles in micro uidic devices

Abstract

The stochastic transport of suspended particles through a periodic pattern of obstacles in m icro uidic devices is investigated by m eans of the Fokker-P lanck equation. A sym m etric arrays of obstacles have been shown to induce the continuous separation of DNA m olecules of di erent length. The analysis presented here of the asymptotic distribution of particles in a unit cell of these systems shows that separation is only possible in the presence of a driving force with a nonvanishing norm al component at the surface of the solid obstacles. In addition, vector separation, in which di erent species move, in average, in di erent directions within the device, is driven by di erences on the force acting on the various particles and not by di erences in the di usion coe cient. M onte-C arb simulations perform ed for di erent particles and force elds agree with the num erical solutions of the Fokker-P lanck equation in the periodic system.




FIG.1: Schematic view of a micro uidic device for the continuous- ow separation of suspended particles, equivalent to the one proposed in Ref. [11] and in plemented experimentally in Refs. [3, 8]. The gray rectangles are solid obstacles. A suspended particle, represented by a small sphere is transported through the sieving medium by an external eld F(x). We show the unit cell used in this work, with dimensions L_x and L_y in x and y directions respectively. We also show, on the right, the primitive cell of this 2D periodic system in dotted lines.

In recent years di erent separation strategies have been explored for the developm ent of integrated micro uidic devices that could provide rapid and e cient fractionation of particles in solution. Particularly interesting are novel methods that take advantage of the intrinsic Brownian motion of small particles suspended in solution, and the dependence of the magnitude of the therm alm otion on the size of the particles, to fractionate the initial suspension as it is transported through the micro uidic device. Following the pioneering work by Austin and Volkmuth [1], several experiments and theoretical investigations have shown the possibility to rectify the Brownian motion of suspended macromolecules (DNA in particular) by driving them through an asymmetric course of micrometer-scale obstacles [2, 3, 4, 5] (see Fig. 1 for a schematic representation of the microdevice). These novel methods have the additional advantage that separation occurs in a direction di erent (norm al) to the average motion of the suspended particles, thus allowing for continuous fractionation, in contrast to traditional separation techniques for biological macrom olecules such as electrophoresis [6]. How ever, the original explanation which assumes di erences in the di usivity of the suspended particles as the underlying mechanism leading to the observed separation [2, 3, 7] has been recently challenged by experim ental observations and theoretical considerations [8, 9]. Here we investigate the transport of suspended particles in spatially periodic system s by m eans of the Fokker-P lanck equation, as well as direct M onte-C arlo simulations, and discuss the necessary conditions for separation to occur. In particular, we dem onstrate that, in the absence of a driving force with a norm al component to the solid obstacles at the uid-solid interface, the asymptotic concentration of particles is uniform and no lateral separation is possible. We also show that in the presence of a norm al force at the surface of the obstacles, which induces a non-uniform concentration of particles, the vector separation of particles, in which di erent species migrate at di erent angles within the microdevice, is driven by di erences on the force acting on the particles and not by di erences on their mobility or di usion coe cient.

The stochastic transport of suspended particles through an array of obstacles in the presence of an external force can be described by the Fokker-P lanck equation for the probability density P (x;t),

where x = (x; y) is the position vector in the 2D m icrodevice, $k_{\rm B}$ is the Boltzm ann constant,

T is the tem perature, F (x) is the force acting on the suspended particles, which we have assumed to be time-independent, and is the friction coe cient [10]. The di usion coe - cient is given by the well known E instein relation $D = k_B T =$, and for a hydrodynam ic drag (friction) on a spherical particle of radius a suspended in a viscous uid of viscosity and m oving at low Reynolds numbers we arrive at the Stokes-E instein relation $D = k_B T = 6$ a.

In general we are interested in computing the probability density ux describing the migration of the suspended particles relative to the xed sieve,

and, in particular, to seek to determ ine whether the direction in which particles m igrate is dierent for dierent species, leading to vector separation [12, 13]. In a periodic array of obstacles, such as the one shown in Fig. 1, it is convenient to introduce the reduced probability density and ux [14],

where $k = (k_x; k_y)$ identi es the speci c cell within the periodic system and I_x , L_y are the unit cell dim ensions (see Fig. 1). The previous sum s are expected to be convergent based on the norm alization condition for P(x;t). Note that we have assumed an array extending to in nity in both x and y directions, or equivalently we are neglecting nite size e ects on the behavior of the transported species. Then, given the linearity of the Fokker-P lanck equation, the convergence of the previous sum s, and the invariance under discrete translations in the periodic system, $(x_0; y_0) = (x + k_x L_x; y + k_y L_y)$, it is clear that P'(x; t) is also a solution to the Fokker-Planck equation. In particular, P satis es Eq. (1) with periodic boundary (and initial) conditions. It is clear that the suspended particles move between di erent cells but, due to the invariance of the system, it is as if a particle leaving a given cell was in fact returned at the equivalent point in the opposite face of the same cell, leading to the mentioned periodic boundary conditions in both P'(x;t) and J(x;t). In addition, for transit times that are long enough so that the system reaches its asymptotic state, we are interested in the long time behavior of the system, governed by the steady-state solution of the Fokker-P lanck equation. Note that only the reduced probability reaches a steady state, whereas the global probability density function has no meaningful asymptotic state [14]. G iven an initial distribution of particles at the inlet of the micro uidic device, the steady state is reached for transit times longer than the characteristic di usive time required for a single particle to explore the primitive unit cell. That is, when the transit time for a particle m oving through N cells, c N L=u, where u is the average velocity of the particle and L is the dimension of the unit cell, is larger than the di usive time required to explore the cell, $L^2=D$, where D is the di usion coe cient. The previous condition is satis ed for small D gbbalPeclet numbers, Pe = uL=ND 1. In previous experimental works the condition of steady state distribution, i.e. sm all Pe, is typically reached after the suspended particles are transported through a relatively small number of cells. In Ref. [3], for example, the authors observe lateral separation for 48.5 kbp DNA molecules with Pe 9=N (u 1 m; 0:64 m²=s; L D 6 m) but no lateral separation for 411 bp DNA molecules with 12 m²=s and L 1 m =s, D 6 m). In both cases, the steady state is Рe 0:5=N (u in fact reached after the DNA molecules are transported through a few cells, compared to the total number of cells in the device, N 1000.

In the presence of di erent species, such as suspended particles or DNA molecules of di erent size, and assuming that the dilute approximation in which particle-particle inter-

actions are neglected is valid, we can describe the dynam ics of the di erent particles by independently solving the steady state solution of the Fokker-Planck equation with periodic boundary conditions for each of the species present in the system. In addition, for impermeable obstacles, the probability density has to satisfy the zero-ux boundary condition at the surface of the solid obstacles. The governing equations then read,

where @s is the surface of the obstacles and n is the local norm alto the solid surface. Once we obtain the steady state solutions, $P^{1}(x)$ and $J^{1}(x)$, we can compute the average migration velocity (as well as its orientation), by computing the total probability ux across the boundaries of the unit cell, that is,

and the analogous equation for $hU_{y}i$.

Let us now consider two cases, classied according to the properties of the force eld, that are relevant to the separation of particles in micro uidic devices. Case I: A solenoidal force eld with no force norm alto the solid obstacles. This is probably the most com m on situation in experiments. For example, if one uses electrophoretic driving forces with obstacles that are in permeable to the ionic solution then the electric eld outside the Debye double-layer (which is typically only a few nanom eters thick) will be parallel to the solid surfaces as the ions carried by the electric eld move around the obstacles. This is also the case for hydrodynam ic convection in pressure driven ow s. In fact, in order to describe the motion of an advected particle we can replace F = by the local uid velocity v, and again the norm al component vanishes at the surface of the impermeable obstacles. Unfortunately, the steady state in these cases is a uniform concentration of particles in the unit cell, independent of the details of the forcing eld or the physical properties of the suspended species (N ote that the force eld satis es r F = 0). This is due to the fact that, since there is no force towards the obstacles at the solid surface, there is no concentration gradient developing at the interfaces. Therefore, the average velocity will be co-linear with the coarse-grained global force applied on the system and no vector separation is possible,




FIG.2: Contour plots for the steady-state reduced probability density function $P^{-1}(x)$ inside a unit cell of the micro uidic device shown in Fig.1. The force is spatially uniform and oriented at 45, $F_x = F_y$. The di erence between the two plots is the magnitude of the boal Pecket number, $Pe = F = k_B T$: a) Pe = 1:12 and b) Pe = 5:58.

If the magnitude of the force divided by the mobility of the particles, F =, is di erent for di erent species, then the particles would move at di erent absolute velocities, but they will still move in the same direction (relative orientation within the device). Case II: Force penetration into the solid obstacles. In Fig. 2 we show the steady-state solution of the probability density for a spatially uniform force oriented at 45 ($F_x = F_y$). It is clear that concentration gradients develop close to the solid obstacles, which increase with the magnitude of the external force F. It is possible, in fact, to render Eqs. (5) and (6) nondimensional using the local Pecket number, $Pe = (U')=D = F'=(k_B T)$, where 'is a characteristic length scale for the obstacles. Figure 2 presents results for two dimensional using the local Pecket number, $Pe = (U')=D = F'=(k_B T)$, where 'is a characteristic length scale for the obstacles. Figure 2 presents results for two dimensional using the local Pecket numbers, Pe = 1 and Pe = 5, where we used '= d (see Fig. 1). These Pecket numbers are representative of some of the recent experiments on the transport of DNA molecules in microdevices. For example, in Ref. [8] the authors report good separation for local Pecket numbers in the range 2:1 < Pe < 5:1 and in Ref. [3] the authors observe the best separation perform ance for Pe = 35. On the other hand, the asymptotic solution in the limit of high Pecket numbers is singular, with high concentration gradients present in a thin boundary layer of thickness ($k_B T$)=F_x. In this limit, the assumption of point-particles will no longer be valid for ' a.




FIG. 3: Probability distribution function at the two perpendicular lines, X and Y, in the unit cell (see Fig. 1). The force is spatially uniform and oriented at 45, and the Peclet number is Pe = 5.58. The solid line corresponds to the solution to Eqs. (5) and (6) presented in Fig. 2b. The open and solid points correspond to M onte-C arlo simulations for two types of particles, which only di er on their m obility, and thus their di usion coe cient, by a factor of 10.

The migration velocity will in general depend on the specic force eld acting on the particles, but we can, however, obtain som e interesting results by considering the properties of the steady state solution to Eqs. (5) and (6). First of all, for a given force eld F(x), the steady-state probability density function, \mathbb{P}^1 , is independent of the mobility of the particles and, therefore, independent of their di usivity. As a consequence, if we have species A and B with mobilities 1^{1} and 1^{1} their average migration velocities will be proportional to each other, $hU_A i = (B_B = A)hU_B i$, and there will be no vector separation in this case. In order to test this result, we compare the solution to Eqs (5) and (6) with M onte-C arlo simulations for the motion of suspended particles. We simulated the motion of two species of particles which experience the same force eld but have di erent di usivities, e.g. the case of equally charged particles of di erent size driven by an external electric eld. First, we simulated the motion under an electric eld that does not penetrate the obstacles and obtained, as expected, a uniform distribution of particles. Then, we simulated the motion under the action of a spatially uniform force and, in Fig. 3, we compare the steady-state solution presented in Fig. 2 with the simulation results. It is clear that the simulations results agree well with the steady state solution to the Fokker-P lanck equations with periodic boundary conditions. We can also see that the asymptotic distribution of the two dierent types of particles is the same, independent of the value of their mobility. Then, particles with an order of magnitude di erent di usivities willm igrate in the sam e average direction. Fortunately, in the case of DNA molecules, although the electrophoretic velocity is independent of size, the electric force acting on DNA molecules of di erent length is not the same (0:3e = A is the e ective

charge per length of the DNA molecule [1, 7, 15]). Therefore, it could be possible to achieve vector separation by creating an electric eld with a non-vanishing norm alcom ponent at the solid surfaces using, for example, permeable obstacles. In the previous analysis, how ever, we neglected the hydrodynam ic interactions between the suspended particles and the solid obstacles, which would lead to a position-dependent mobility [16]. Then, for large enough particles compared to the characteristic size of the obstacles, there might be separation induced by the di erence in permeability of particles of di erent size [12, 13].

We showed that the stochastic transport of particles through periodic patterns of obstacles can be described by the asymptotic steady-state solution of the Fokker-P lanck equation applied to a unit cell with periodic boundary conditions and appropriate condition at the surface of the solid obstacles. We demonstrated that, in order to obtain vector separation of particles, a non-vanishing driving force norm alto the obstacles is required at the uid-solid interface. We also showed that the underlying cause driving separation is the di erence in the force experienced by di erent species and not the di erences in the di usion coe cient. These results could provide guidance for future developments in the design of micro uidic devices, such as the use of permeable obstacles in combination with electrophoretic forcing of the particles. In addition, the num erical solution of the Fokker-Planck equation in di erent geom etries could then be used to optim ize the design of such m icrodevices. It is interesting to note that an analogous form alism to the one used here has been developed to study transport in periodic porous media (discontinuous system s) and a nice and thorough discussion can be found in chapter 4 of Ref. [17]. There, the authors show that the use of such m ethod goes beyond the study of particle m igration and also allows the direct com putation of the dispersion coe cient, responsible for the broadening of an injected band of suspended particles, an important parameter a ecting the resolution in separation devices. F inally, we mention that we are currently considering the e ect of transient dynam ics before steady state is reached, which could lead to perm anent separation in short devices.
