A mean-eld theory for strongly disordered non-frustrated antiferrom agnets

M otivated by in purity-induced magnetic ordering phenomena in spin-gap materials like T.CuC.L, we develop a mean-eld theory for strongly disordered antiferromagnets, designed to capture the broad distribution of coupling constants in the elective model for the impurity degrees of freedom. Based on our results, we argue that in the presence of random magnetic couplings the conventional rst-order spin-op transition of an anisotropic antiferromagnet is split into two transitions at low temperatures, associated with separate order parameters along and perpendicular to the eld axis. We demonstrate the existence of either a bicritical point or a critical endpoint in the temperature eld phase diagram, with the consequence that signatures of the spin-op are more pronounced at elevated temperature.

I. INTRODUCTION

The interplay of magnetism and disorder is a fascinating eld of research in condensed matter physics. Various non-trivial low-tem perature phases, like spin glasses, Bose glasses, random singlet phases etc., and associated phase transitions have been studied in both theory and experiment. A particularly interesting manifestation of quantum e ects is in purity-induced magnetism in quantum paramagnets: The starting point is a Mott insulator with a nite spin gap which separates elementary spin excitations from the spin singlet ground state; exam ples are SrCu₂O₃, CuGeO₃, PbN ½V₂O₈, $SrCu_2$ (BO₃)₂, KCuCl₂, or TCuCl₃. As demonstrated in recent experiments, 18 non-magnetic impurities, replacing magnetic ions in such quantum paramagnets, can induce e ective magnetic moments. These impurity-induced mom ents reveal them selves in a Curie-like behavior of the uniform susceptibility, / C = T, at intermediate temperatures. Remarkably, in the presence of three-dimensional couplings these induced moments can order at su ciently low temperatures, thus changing the spin-gapped param agnetic ground state of the pure compound into an magnetically long-range ordered state upon doping.

On the theoretical side, the appearance of e ective moments upon doping vacancies into the spin system is well understood in principle. It occurs in systems with conned spinons, i.e., elementary S=1 excitations; for spin 1=2 systems it is best visualized in terms of broken singlet bonds where one spin is replaced by a vacancy. The liberated spin 1=2 is conned to the vacancy at low energies, resulting in an elective spin 1=2 moment. Since 1=2 excitations, i.e., deconned spinons, no moments are generated by introducing vacancies.) This theoretical picture has been supported by various numerical studies, in particular on spin chain and ladder systems. 1=20 excitations and ladder systems.

A number of theoretical works also addressed in purity-induced antiferrom agnetic ordering. On the one hand, numerical simulations on nite-size systems of spin gap magnets containing in purities studied signatures of magnetic ordering. $^{14\{17}$ On the other hand, analytical approaches typically start from an elective spin-1=2 model involving the

im purity-induced m om ents S_i only:

where the interaction J_{ij} between two inpurity moments depends on their distance r_{ij} as J_{ij} / exp (r_{ij} =), where

is the magnetic correlation length of the host material. Due to the random locations of the impurities the system shows a broad distribution of coupling values $J_{\rm ij}$. Furthermore, on bipartite lattices the sign of Jij will alternate as function of the M anhattan distance between i and j. This in plies that classically allbonds can be satis edwith a Neeltype arrangement of the e ective moments. In other words, Eq. (1) de nes a strongly disordered non-frustrated quantum magnet. Real-space renormalization group studies^{20,21} indicate that the ground state of the model (1) with quantum spins 1/2 shows long-range order for any concentration of impurity moments; this is supported by numerical simulations of vacancy-doped quantum paramagnets with con ned spinons, which display magnetic order up to the percolation threshold. 14{17 Thus, although the systems under consideration are long-range-ordered antiferrom agnets, their properties can be expected to be strongly dierent from that of antiferrom agnets without quenched disorder, due to the broadly distributed J_{ij} .

The purpose of this paper is to introduce a generalized mean-eld theory, which takes into account the broad distribution of coupling constants in Eq. (1). The central idea is to param eterize the spins according to their coupling strength to the environment, i.e., by their sum of coupling constants to all other spins, J, see Eq. (2) below. For each J a separate m ean-eld param eter will be introduced, leading to integral equations replacing the standard self-consistency relations. Although such a mean-eld theory misses certain aspects of disorder physics, like localization phenomena, we will demonstrate that it captures various distinct properties of magnets described by Eq. (1). For instance, the overall behavior of the order parameter as function of temperature is signi cantly dierent from non-disordered magnets and from conventionalmean-eld theory. In particular, we discuss the physics in an external eld the presence of a m agnetic anisotropy, relevant form ost realm aterials. Here,

a spin- op transition is expected to occur for elds parallel to the easy axis, which indeed has been observed in T Σu_1 $_x$ M g_x C l_z . We argue that strong disorder leads to an interesting temperature evolution of the spin- op physics: at low temperature the transition is generically split into two (with at least one of them being continuous), whereas at elevated temperature a single rst-order transition is restored.

The bulk of the paper is organized as follows: In Sec. II we describe our generalized mean—eld theory, together with the num erical procedure to solve the mean—eld equations. Sec. III discusses the sym metries and possible phases of the model in the presence of a eld parallel to the easy axis, and presents temperature {eld phase diagrams obtained from the mean—eld theory. In Sec. IV we take a closer book at the phase transitions, in particular at the spin—op transition. A comparison to experiments and available numerical results for vacancy-doped magnets is given in Sec. V. A brief outbook concludes the paper.

II. MEAN-FIELD THEORY

A. Param eterization

In standard mean—eld theory, the many-body problem is reduced to one single-spin problem in an elective eld. Following this idea in the presence of disorder requires to consider distinct elective elds for all spins. Physicswise, we expect spins to behave dierently if they have dierent couplings to their environment; spins in a similar environment may behave in a similar fashion. This is the basis for the main simplication of our mean—eld theory: We will parameterize the spins by the coupling sum J, de ned as

Thus we replace the spin variables S_i by S(J). The factor (1^{j^i} $^{j+1}$ accounts for the sublattice structure of the bipartite lattice, with (i j) being the M anhattan distance, and the second identity follows from the alternating sign of the coupling J_{ij} . With this de nition, J_i is the magnitude of the elective eld on spin i in a perfectly ordered antiferrom agnetic state.

For a description of the magnetic interactions in terms of the coupling sum , we introduce a probability distribution $P \ (J)$ according to

where we have included an external eld B.

For an antiferrom agnet on a bipartite lattice dierent mean ells are required for the two sublattices A and B, which can become inequivalent in the presence of symmetry breaking and a nite eld. Using $P_A (J) = P_B (J) = P (J) = 2$, the elective eld becomes

In general, two angles are needed to specify the orientation of a spin. In the following, we will exclusively consider situations where H has a U (1) symmetry of rotations about the z axis (see Sec. III). Then we can describe the orientation of a spin just by one angle, ', between spin and z axis; the angle in the xy plane can be xed to zero, positive (negative) values of ' on the A (B) sublattice account for the staggered in-plane order. Hence, the expectation value of a spin can be written in the following way:

The single-spin problem of Eq. (8) can be readily solved, yielding the mean-eld equations:

The amplitude equation (12b) has been written for a spin with two states s, appropriate for quantum spins s=1=2 { this will be used in the numerical calculations. For continuous classical spins the tanh () needs to be replaced by a Brilbuin function as usual.

In the case of P (J) = $(J - J_0)$ and f $(J_1; J_2) = J_0$ the mean-eld equations (9,12) reduce to the self-consistency equation of the familiar W eiss mean-eld theory, with $J_0 = zJ$ for a Hamiltonian with a nearest-neighbor coupling strength J and a coordination number of z.

B. Magnetic anisotropy

In this paper we consider the form ally simplest source of magnetic anisotropy, namely an anisotropic exchange interaction of easy-axis type (the behavior in the presence of a D shyaloshinski-M oriya interaction is expected to be similar). Thus, in the Ham iltonian we perform the replacement

with an anisotropy constant < 1; we keep the coupling to the external eld as B S.We note that in the context of impurity-induced magnetism, e.g., in T LuCl some complications arise (which we will ignore here): The anisotropy of the elective interaction will depend on the external eld and the interaction itself; furthermore the form of the eld coupling will be modified, leading to an anisotropic gitensor.

The anisotropy according to Eq. (13) requires the follow-ing replacement in the mean-eld equations (12):

where m $^{\rm xy}$ and m $^{\rm z}$ denote the components perpendicular and parallel to the easy axis.

C. Choice of input param eters

The described mean-eld theory requires the coupling distribution P (J), Eq. (3), and the interaction function f $(J_1;J_2)$, Eq. (4), as input. Both functions are given by the underlying microscopic model. We have numerically determined P (J) and f $(J_1;J_2)$ for an elective model of impurity-induced order in quantum paramagnets, Eq. (1), as described in the Appendix.

For the actual mean-eld calculations we found it more convenient to use plausible model (i.e. tting) functions instead. However, a di-culty arises here: P (J) and f ($J_1;J_2$) cannot be chosen independently, because the normalization




FIG. 1: M odel functions for the coupling-sum distribution P (J) obtained from di erent generating functions g (J₁;J₂): a) Lognorm al-like distribution from Eq. (18), with the parameters $_2$ = 0:699, $_L$ = 0:171, $_L$ = 1:3, and J_{m ax} = 4:317. b) G auss-like distribution from Eq. (19), with the parameters $_1$ = 0.59, $_L$ = 0:193, and J_{m ax} = 1:929. In both cases, dJP (J) = 1.

conditions (5) cannot be easily full led while preserving the symmetry w.r.t. J_1 \$ J_2 . We have therefore resorted to the following construction. From an arbitrary symmetric \generating" function $g(J_1;J_2)$ we de ne the functions P(J) and $f(J_1;J_2)$ according to:

all normalization conditions are ful led.

As detailed in the Appendix, in vacancy-doped magnets the function P(J) will be peaked at a value which increases with in purity concentration, and it will be increasingly asymmetric at low concentrations, with a tail to higher J. Thus, among others, we have employed the following generating functions $g(J_1;J_2)$.

generates a Lognorm al-like distribution P (J) which captures the coupling distribution for a small in purity concentration. In contrast,




FIG. 2: (color online) Angle con gurations '(J) occurring in the ordered phases of the antiferrom agnet with eld parallel to the easy axis, with blue/red (dark/gray) showing ' $_{\rm A}$ /' $_{\rm B}$. a) Ising phase, b) mixed phase, c) canted phase. The evolution from a) to c) represents the behavior at low temperatures upon increasing the eld, see Figs. 3,4 below .

leads to a Gauss-like distribution P (J), corresponding to higher in purity concentrations. The $_{\rm i}$ and $_{\rm i}$ are free param eters. Exam ples for the resulting P (J) are shown in Fig. 1; here and in the following the J values are scaled such that the mean value of J is unity. In Fig. 8 below we show P (J) results of the numerical simulations for comparison.

To model an easy-axis situation, we have chosen the anisotropy parameter = 0.9.

III. PHASE DIAGRAM S

A. Sym m etries and phases

We will restrict our attention to magnetic elds parallel to the easy axis in which case interesting spin- op physics arises. Then, the symmetry of the antiferrom agnetic Hamiltonian (10) in the presence of a eld is U (1) Z_2 (whereas for B = 0 we have U (1) Z_2 Z_2 which becomes SU (2) Z_2 in the absence of exchange anisotropy). Here we have assumed a unit cell size of 2 sites, and the Z_2 symmetry corresponds to the exchange of the two sublattices.

The possible phases are easily enumerated: (i) An Ising phase, where spins on the A (B) sublattice point preferrentially up (down). This breaks the $\rm Z_2$ symmetry, but leaves the U (1) rotations about the z axis intact. (ii) A canted phase, where the spins order spontaneously perpendicular to the eld, and have a nite component in the eld direction (equal for both sublattices) as well. $\rm Z_2$ and U (1) are broken, but a combination of sublattice exchange and $\rm 180^\circ$ rotation is an intact $\rm Z_2$ symmetry. (iii) A mixed phase where $\rm Z_2$ and U (1) are fully broken. (iv) A disordered phase with no symmetry breaking. For non-zero eld the spins point in the eld direction only.

The order parameters are the components of the staggered magnetization parallel and perpendicular to the direction of the applied magnetic eld, M $_{\rm stagg;z}$ and M $_{\rm stagg;xy}$. Further, the ordered phases (i){ (iii) can be nicely characterized by the angles ' , Eq. (11). W ithout quenched disorder, i.e., for P (J) = (J J_0), we have (i) Ising: $'_{\rm A}$ = 0, $'_{\rm B}$ = ; (ii) canted: 0 < $'_{\rm B}$ = $'_{\rm A}$ < ; (iii) mixed: $'_{\rm A}$ < 0, $'_{\rm B}$ > 0, $J_{\rm A}$ j \in $J_{\rm B}$ j. In the disordered case with broad P (J), the angles become functions of J , with examples for $'_{\rm A}$; (J) shown in Fig. 2.




FIG. 3: Temperature { eld phase diagram of a disordered easy-axis antiferrom agnet, obtained from the present meaneld theory, for the Lognom al-like distribution of coupling constants P (J) as shown in Fig. 1a. The calculation was done for spins with eigenvalues s, hence the axes are scaled by appropriate powers of s. First-order transitions (thick lines) were determined from crossing points of the free energy, whereas second-order transitions were obtained from extrapolations of the order parameters. BP is a bi-critical point. Magnetization data along the dotted gray lines will be shown in Figs. 5, 7 below.

B. Num erical iteration of the mean-eld equations

For given functions P (J) and f (J1;J2) and xed values of applied m agnetic eld B, tem perature T, and anisotropy constant one can iterate the mean-eld equations (9,12), using a linear discretization for the J values. The initial distributions for the angles $\prime_{A,B}$ (J) and amplitudes $\mathfrak{fS}_{A,B}$ ij could be chosen random in principle; we found it more convenient to employ distributions corresponding to perfect Ising or XY order instead. The mean elds are calculated from Eq. (9); new amplitudes are obtained from Eq. (12b). Some care is required with the angle equation (12a) in the case of an Ising initial conguration: in addition to Eq. (12a) we used an update scheme where spins on the sublattice B ipping from $\prime_B=$ to $\prime_B=0$ are set to $\prime_B==2$ by hand in order to mix the symmetry breakings.

These dierent initial conditions and dierent update schemes lead to potentially dierent xed-point distributions after convergence is reached. These correspond to dierent local minima in the free-energy landscape; comparison of the free energies then yields the stable phase.

C. Phase diagrams from mean-eld theory




FIG. 4: Tem perature $\{$ eld phase diagram as in Fig. 3, but for the G auss-like distribution P (J) shown in Fig. 1b. (CE is a critical endpoint.)

In Figs. 3, 4 we show representative phase diagram s for the disordered easy-axis antiferrom agnet with a longitudinal eld, obtained from solving the mean-eld equations (9,12). At zero eld, the Ising order, present at low temperatures T, is destroyed at a continuous transition to a param ag-




FIG. 5: (color online) Magnetization curves for the Lognorm al-like distribution P (J), Fig. 1a, at a) $T=s^2=0.435$ and b) $T=s^2=2.177$. The red (dashed) part indicates the jump at the rst-order transition.




FIG. 6: (color online) A s Fig. 5, but for the G auss-like distribution P (J), Fig. 1b, at a) $T=s^2=0$ and b) $T=s^2=0$:675.

netic phase. Applying a eld to the Ising phase drives various transitions, resulting in a canted phase at intermediate elds and nally a eld-polarized (disordered) phase at large eld. The main di erence to the text-book antiferrom agnet is the presence of a mixed phase. The conventional rst-order spin- op transition is split into two transitions at bw T: At some small eld, there is a continuous transition from the Ising to a mixed phase, where an in-plane staggered magnetization M stagg;xy perpendicular to the eld develops. Only at a larger eld, the Ising orderm easured by M stagg;z is destroyed, leading to a spin- op transition into a canted phase, see Figs. 5, 6. The origin of this behavior lies in the broadly distributed couplings: A liready for small elds, weakly coupled spins with J B cannot sustain the zero-eld Ising order and ip in the eld direction, while for strongly coupled spins (J B) Ising order is favored. At low T, spins with J B reach their lowest-energy state by canting { this results in an overall mixed phase and can be nicely seen in Fig. 2b. (However, at elevated temperatures the in-plane mean-eld from these spins alone is not sucient to establish a mixed phase.) At the spin-op transition (m ixed! canted at low T, Ising! canted at higher T), the spins with the largest couplings loose their Ising order. The evolution of the angle distributions ' $_{\rm A\;;B}$ (J) with increasing eld at low T is shown in Fig. 2.

Note that the part of the phase transition line between Ising and mixed phases at small T and B (dashed) is dicult to extract numerically for a linear discretization of J. However, by a comparison of energies it is easy to prove that at T = 0, B > 0 the Ising phase is always unstable towards the mixed phase for distributions P (J) which are non-zero for arbitrarily small J.

The two phase diagrams in Figs. 3, 4 di er in the extensions of the mixed phase, and in the character of the phase transition line between mixed and canted phase (see below). Clearly, the deviations from the textbook spin-op behavior of non-disordered antiferrom agnets are most pronounced for broad distributions P (J).

Both the N eel tem perature $T_{\rm N}~$ and the critical ~ eld B $_{\rm C}~$ where long-range order is destroyed, scale with the m ean value of the exchange constant (which is set to unity in our calculations). Similarly, the ~ op ~ eld B ~ op scales as (1 ~) $^{1=2}$ times the mean exchange. Furtherm ore, an asymmetric distribution P (J) as the one in Fig. 1a leads to a larger $T_{\rm N}$, B $_{\rm C}$, B ~ op compared to a symmetric one with the samemean J, the reason being that the scales are primarily determined by the spins with large J.

IV. PHASE TRANSITIONS AND CRITICAL PROPERTIES

A. M agnetizations and critical exponents

The Figs. 5, 6 show curves for the staggered m agnetizations (M $_{\rm stagg;xy}$ and M $_{\rm stagg;z}$) as well as the total m agnetization M , along the gray dotted lines in the phase diagram s in Figs. 3, 4. The role of M $_{\rm stagg;xy}$ and M $_{\rm stagg;z}$ as order param eters can be clearly seen.




FIG. 7: Staggered m agnetization for a) the Lognorm al-like distribution P (J), Fig. 1a, at B = s = 0.209, and b) the G ausslike distribution P (J), Fig. 1b, at B = s = 0.189.

Fig. 7 shows the total staggered magnetization vs. temperature for both coupling-sum distributions. The transition to the disordered phase at high T (or B) is always continuous. The corresponding order-parameter exponent , de ned through M $_{\rm stagg}$ / (T $_{\rm c}$ T) , should be 1=2 in conventional mean—eld theory. Interestingly, Fig. 7a shows an overall behavior very different from this standard square—root law . This is again due to the broadly distributed

couplings: Close to $T_{\rm c}$ the magnetization is electively only carried by a small fraction of the spins with large J { note that the distribution P (J) corresponding to Fig. 7a has a pronounced tail at larger J. We note that asymptotically close to the phase transition standard mean—eld behavior is restored within the present approach, with exponent $=\,1\text{=}2$.

B. Spin- op transition

In a non-disordered easy-axis antiferrom agnet, a rst-order spin-op transition from an Ising to a canted phase occurs upon increasing the eld, leading to a jump in the total magnetization.

In the present situation with quenched disorder, a mixed phase with both M $_{\rm stagg;xy}$ and M $_{\rm stagg;z}$ non-zero occurs at bw temperatures. The spin- op transition splits; for small disorder (a narrow distribution P (J)) the mixed! canted

transition remains of rst order, but becomes second-order at larger disorder, whereas the Ising! mixed transition is always continuous. As the mixed phase only exists at low T, the conventional rst-order spin-op transition is restored at elevated temperatures. This has the remarkable consequence that the jump in the magnetization is most pronounced at intermediate T, namely at the position of the critical end point or the bicritical point, respectively (see Figs. 5, 6). In general, the magnetization jump is larger in situations with less disorder because the collective spin op is carried by a larger fraction of spins here.

V. RELATION TO VACANCY-DOPED MAGNETS

In the previous sections, we have described a general mean-eld theory for disordered non-frustrated antiferromagnets. We now discuss the applicability to impurity-induced magnetic order in quantum paramagnets.

A. Experim ents

The low-energy physics of M g-doped T LuC & m ay be expected to be well-described by a Hamiltonian of the form (1), provided that the impurity concentration is small. Magnetization m easurem ents have indicated the presence of a spin-op transition at 1.8 K for elds parallel to the easy axis [2,0,1] at a eld of approxim ately 0.35 T, signi cantly below the eld corresponding to the bulk gap, 6T. Interestingly, the spin-op eld seem s to be almost independent of the impurity concentration (in the measured range of 0.8 { 2.5%). Our theory does not o er an easy explanation for that: As discussed above, the spin-op eld B op is roughly proportional to the mean exchange (for xed anisotropy parameter), which would result in a concentration dependence of B $_{\rm op}$. W ithin the e ective model (1), it is hard to envision a mechanism leading to a concentration-independent op eld, therefore we speculate that correlations between the im purities beyond this e ective model play a role here. We also consider it possible that B $_{\mathrm{op}}$ will actually decrease for in purity concentrations smaller than the ones measured. In this context we note that the experim ents of Ref. 22 m apped out the phase diagram for T LuC & doped with 1% Mg and showed the zero-eld in purity-induced ordered phase to be continuously connected to the high-eld bulk ordered phase. Together with recent theoretical studies 16,23, this suggests that the impurity and bulk energy scales are not well separated there, i.e., the impurity concentration is too high to allow for a description using the e ective model (1).

Further magnetization measurements on Mg-doped T LuCl would also be interesting regarding the temperature dependence of the spin- op physics: Our theory predicts interesting behavior for very low temperatures, where the spin- op transition should split. This requires measurements down to e.g. 1/10th of the ordering temperature $T_{\rm N}$; the experiments of Ref. 7 have T & $T_{\rm N}$ =2.

B. Num erical results from Quantum M onte Carlo simulations

Num erical sim ulations using Quantum Monte Carlo techniques can go beyond the e ective model (1) and study the full system, i.e., quantum param agnet plus vacancies. Those calculations have been reported in Refs. 14{17, but all were restricted to the spin-isotropic situation. These sim ulations mapped out the complete phase diagram, with distinct low - eld and high- eld ordered phases. Am ong the interesting aspects are the occurrence of Bose glass phases near the bulk eld-ordered phase 16, and of a quantum disordered phase at intermediate elds where in purity-induced transverse order is destroyed and the in purity m om ents appear to form a random-singlet-like phase¹⁷. Clearly, these properties rely on the one hand on the quantum nature of the impurity-induced spin-1=2 m oments and on the other hand on localization e ects, both not captured by ourm eaneld approach. Quantum Monte Carb calculations for the spin-anisotropic case studied by uswould be interesting, but m ay be dicult due to the small energy scales involved in the spin-op physics.

VI. CONCLUSIONS

We have proposed a mean—eld theory for strongly disordered magnets, which takes into account the broad distribution of energy scales in the system. Parameterizing the spins by their sum of coupling constants, equivalent to the exchange eld in a perfectly ordered state, yields a continuous set of mean—eld equations. We have applied the form alism to a model for in purity-induced order in spin-gap quantum magnets, and derived detailed phase diagrams as function of temperature and external eld. We have shown that the conventional rst-order spin—op transition generically splits at low temperatures, leaving room for a mixed phase with both transverse and longitudinal order.

We envision our approach of continuous mean elds to be applicable to a number of interesting problems involving strong disorder, like magnetic ordering in dilute magnetic semiconductors²⁴, charge ordering in the presence of strong pinning, or electronic models treated within modications of dynamical mean-eld theory (DMFT)²⁵.




FIG. 8: Numerical results for the coupling-sum distribution P (J), in a host magnet with a correlation length of 7.9 lattice spacings, at impurity concentrations of a) 0.1% and b) 1%. (The energy unit for the vertical axis is J_k of the bilayer model; note that the rather large values of J arise from the inaccurate short-range behavior of Eq. (A 3).)

APPENDIX A: COUPLING CONSTANTS FOR IM PURITY-INDUCED MOMENTS IN PARAMAGNETS

Our mean-eld theory requires the know ledge of the distribution of the coupling-constant sum s, P (J), and the interaction function f ($J_1;J_2$). We have numerically determined these functions from an elective H am iltonian for the impurity-induced moments of the form (1).

The elective interaction between two inpurity spins $(s_{i;j})$, coupled to two dilement spins $(S_{i;j})$ of a bulk system according to

can be determ ined in perturbation theory in K . In lowest order and in the static approximation, it is given by the !=0 bulk susceptibility:

For vacancy-induced m om ents, K can be approximated by a bulk exchange coupling.

To be speci c, consider a bulk system consisting of dimers on a d-dimensional hypercubic lattice, with intra-dimer (inter-dimer) coupling J_2 (J_k). Using a bond-operator formalism in the linearized (harmonic) approximation 26 , we not for the elective coupling in the long-distance limit:

where r denotes the distance between the impurity spins, (1\sc f accounts the alternating sign of the interaction, and = 0 (1) for spins i; j on the same (on di erent) sites of the dimer pairs. Note that the asymptotic behavior r $^{(d-1)=2}\exp(-r=-)$ is generic, whereas the concrete value of and the prefactor in (A3) depend on the level of approximation used; in our case $^2=J_k=(J_2-2dJ_k)$. For the purpose of our numerical simulation, we will employ Eq. (A3) with K = J_k for all distances r { this will overestimate couplings at small r. The sign of J_e- leads to a non-frustrated system on a bipartite lattice.

The simulation is done by random by placing in purities on sites of a bilayer square lattice (i.e. d = 2), calculating P (J)

and f ($J_1;J_2$), Eqs. (3,4), from the e ective coupling constants (A3), and averaging the result over several in purity con gurations. The bilayer system is assumed to be in its quantum disordered phase, close to the magnetic ordering transition. In the linearized bond-operator approach, the phase transition takes place at $J_k=J_2=1=4$; we choose in the following $J_k=J_2=0.249$, corresponding to a correlation

length of 7:9. Fig. 8 shows the resulting P J) for two di erent in purity concentrations: In the low-concentration lim it, the distribution is strongly asymmetric, with a tail to high energies. (Note that in this lim it analytical results are available as well, see e.g. Ref. 23.)
