Frequency dispersion of photon-assisted shot noise in mesoscopic conductors

We calculate the low-frequency current noise for AC biased mesoscopic chaotic cavities and diusive wires. Contrary to what happens for the adm ittance, the frequency dispersion is not dom inated by the electric response time (the "RC" time of the circuit), but by the time that electrons need to diuse through the structure (dwell time or diusion time). Frequency dispersion of noise stems from uctuations of the Fermi distribution function that preserve charge neutrality. Our predictions can be veried with present experimental technology.

Charge neutrality in m esoscopic devices is enforced by Coulomb interaction on a time scale ($_{\rm RC}$) given by the product of the resistance and the capacitance scales. The typical time (D) for non interacting electron motion is instead xed by either the dwell or di usion time, depending on the transparency of the interfaces between the system and the electrodes. The typical physically realized situation is RC D: electrons, which would norm ally slow ly di use, are pushed to run by the electric elds that they are generating them selves by piling up charge. The consequence is that the typical response time of the device is $1 = \frac{1}{RC} + \frac{1}{D} = \frac{1}{RC}$. This has been shown for the frequency dependence of both the adm ittance [1, 2] and the noise [3, 4, 5, 6] in mesoscopic chaotic cavities and di usive wires. The inverse of the di usion tim e appears instead as the relevant energy scale for the voltage or tem perature dependence for both the conductance and the noise in superconducting/norm almetals hybrid systems [7, 8, 9, 10]. Indeed, in this case the energy dependence is due to interference of electronic waves that does not induce charge accumulation in the system s. To our know ledge, in norm alm etallic structures a dispersion on the inverse di usion tim e scale has been predicted so far only for the third m om ent of current uctuations [5] and for the nite frequency therm al noise response to an oscillating heating power [11]. An alternative, and less investigated possibility, is to study the low frequency current noise as a function of the frequency of an externalAC bias. The noise for a quantum point contact was calculated a decade ago [12] and later m easured [13, 14]. Since the quantum point contact is very short, electron di usion does not introduce any additional time scale in the problem and the resulting frequency dispersion is simply linear [12]. More recently, the noise for an AC biased chaotic cavity was considered [15, 16] in the lim it of small elds eV=h 1 (V is the amplitude of the AC bias and e is the electron change). The authors of Ref. [15] found that the noise disperse only on the scale, that is the combination of the di usion and the electric




FIG.1: Schem atic of the system . A chaotic cavity connected to the electrodes through arbitrary coherent connectors characterized by a set of transparencies $fT_n g$.

response time. This should be contrasted with the result of Ref. [17] where the noise in a di usive wire was studied when the conductor was biased by a short voltage pulse. E ven if the dispersion of the noise is not considered in that paper, the authors ind that the ratio of the di usion time to the time duration of the pulse may a ect the observed noise. This indicate that a dispersion of the noise on the external frequency could be present.

In this paper we derive analytical expressions for the photon-assisted noise in chaotic cavities [Eq. (13) in the following] and numerical results for di usive wires. We show that the noise depends on the AC frequency on the di usion time scale. We take into account the C oulomb response that guarantees charge neutrality over times longer than $_{RC}$. Within our calculation, the admittance has no structure at $1 = _{D}$, while the derivative of the noise with respect to the frequency shows a clearm aximum.

We start by considering a chaotic cavity (see Fig. 1) connected to two metallic leads through two barriers characterized by a set of transparencies $fT_n^k g$ where k takes the value 1 or 2. We de ne the conductances $G_k = G_Q_n^k T_n^k$, the total conductance $G = G_1G_2 = (G_1 + G_2)$, and a dwell time $_D = 2 hG_Q = (G_1 + G_2)$, where is

the level spacing of the cavity and $G_0 = e^2 = (2 \text{ h})$. We assume that the dwell time is much shorter that the inelastic time. We also assume that $G = G_1 + G_2$ Go so that we can use sem iclassical theory to describe transport and neglect Coulom b blockade e ects. The cavity is coupled capacitively to the leads through the capacitances C_k and to a gate through C_q . O ne can then de ne the typical electric response time as $_{RC} = C = G$ where $C = C_1 + C_2 + C_q$. If linear dimension of the cavity L are much larger than the Ferm is avelength $_{\rm F}$, the ratio $=E_{c}$ (_F =L)^{d 1} 1 where $E_{c} = e^{2}=C$ RC = Dis the Coulomb energy and d = 2 or 3 is the dimension of the cavity. Three di erent tim e dependent voltage biases are applied to the gate and the two contacts (V_q , V_1 , and V₂), clearly the current depends only on two voltage di erences, we keep the three voltages to sim plify the notation. The cavity resistance is negligible with respect to the contact resistances so that we can assume a uniform electric potential inside.

We begin by considering a very simple model of charge transport, where di usion and electric drift are described classically. The charge Q in the cavity is related to the electric potential V of the cavity itself by the relation $Q = \sum_{k} C_k (V - V_k)$, where k = 1, 2, and g. The equation of motion for Q is then

where $I_k = G_k (V = V_k)$. The equation can be conveniently solved in terms of V (!), the Fourier transform of the cavity potential:

where we de ned $_{k} = G_{k}=G$ for k = 1 or 2, and $_{g} = 0$. When $_{RC}$ $_{D}$, the response time $= _{RC} _{D} = (_{RC} + _{D})$ is simply given by $_{RC}$. The adm ittance has a similar frequency dependence. For $_{RC} _{D}$ and ! 1 one thus nds the very simple result

and $I_1(!) = \underbrace{1}_{2}(!) = G_{1-2}(V = V_1)$: charge neutrality is perfectly enforced for low frequency drive. As it follows from Eq. (1), only I_k is nite, since Q and \mathcal{C}_tQ vanish in this limit. In the following we will consider this experimentally relevant low driving-frequency limit $_{RC}$ 1, which will enable us to use the ! $1 = _{RC}$ response for V (!).

Let us now consider the noise. We use the sem iclassical description of non-equilibrium transport provided by the time dependent U sadel equations [18, 19]:

where D is the di usion coe cient in the cavity and the K eldysh G reen's function satis es the norm alization condition:

Since the conductance is controlled by the contacts, $G(t_1;t_2)$ is uniform in the cavity. Eq. (3) can then be integrated on the volume of the cavity, and relate G to the current through the interfaces [20]. The equation for G takes then the form of a charge conservation equation: X

where the voltage in the cavity is given by the electroneutrality condition (2) and

are the spectral currents that relate the G reen's function of the electrodes G_k to the G reen function of the cavity [21]. The form of G_k is given by the equilibrium solution for m etallic leads of Eq. (5), explicitly, in presence of a time dependent potential, one has:

In order to calculate the noise we need to modify the G reen's function of the electrodes by introducing two counting elds [20, 22]:

where $_{x}$ is a Pauli matrix. Solving Eq. (5) together with Eq. (2) gives the value of G from which, using Eq. (6) one can derive the counting eld dependent current: $I_{k}(t; _{1}; _{2}) = G_{k} Trf_{x} I_{k}(t;t) g=2$. Derivatives with respect to $_{1}$ _ 2 give all the moments of current uctuations. We assume that the potential di erence between the two leads is harmonically oscillating at frequency . Then the time average over the period 2 = of $I_{k}(t)$ and $i \notin I_{k}(t) = \Re(1 - 2)$ gives the DC current and the low frequency noise, respectively.

Let us rst discuss brie y the current. For vanishing $_{k}$, G has the form given by Eq. (7) and it depends on a single function: F (t_1 ; t_2). It is convenient to change gauge by de ning F (t_1 ; t_2) = $e^{i (t_1)}$ F (t_1 ; t_2) $e^{i (t_2)}$ where h ℓ_t (t) = eV (t), and introducing new time variables t = t_2 $\frac{1}{2}$ and t_4 = ($t_1 + t_2$)=2. F (t_4 ;t) is

a periodic function of t_{+} : $F'(t_{+};t_{-}) = \frac{P}{n} e^{in t_{+}} F_{n}(t_{-})$ and its explicit expression in terms of the Fourier com – ponent of $F'^{(k)}$ comes from the solution of the equation of motion (5):

Here $F_n^{(k)}(t) = F_{eq}(t)J_n(2A_k \sin(t=2)), J_n$ are Bessel functions, $A_k = e(V_k^{\circ} V^{\circ}) = (h)$, and V° are the am – plitudes of the AC eld: $V_k(t) = V_k^{\circ} \sin(t)$. In order to m ake a connection with the classical description given by Eq. (1) we relate F' to the charge on the cavity:

Usadel equations (5) for t ! 0 reduces then to the continuity equation (1) for the total charge. Note that when the voltage time dependence (2) is enforced, Q vanishes identically, as it can be veri ed by calculating the limitt ! 0 in Eq. (9). On the other hand, the energy distribution function, $F'(t_{+};") = dt F'(t_{+};t_{+})e^{i''t_{+}=h}$ varies periodically in time, and its dependence on the AC driving frequency, , is on the scale of the inverse di usion time \int_{D}^{1} . When an electron enters the cavity, after a very short tim e $_{\rm RC}$, the charge rearranges to keep the cavity neutral, the distribution function, instead, will relax on a much longer time given by $_{\rm D}$. Since zerofrequency noise probes the electronic distribution function, it should depend on the frequency on the same scale.

To obtain the noise, it is su cient to expand the G reen's function up to rst order in $: G = G_0 + G_1 i(_1$

 $_{2})=2 + :::,$ and substitute this expression into Eq. (5) [9, 10]. The term G_{o} is given by Eq. (7) with F given by Eq. (9). Note that in principle also V (!) could depend on $_{k}$. By going back to the K eldysh action form ulation we veri ed that the corrections are of order higher than one in $_{k}$, they thus do not contribute to the calculation of the noise. In order to full the norm alization condition (4) we use the parametrization for G_{1} proposed in Ref. [23]:

By dening = $_1$ $_2$ and choosing $_1$ = $_2$, $_2$ = $_1$ we obtain W 0 = 0 and the kinetic equation for W :

where $_{k} = G_{Q} = G_{k} \stackrel{P}{}_{n} T_{n}^{(k)} (1 T_{n}^{(k)})$ are the Fano factors of the two junctions and with we indicate time convolution. To obtain the low frequency noise we need




FIG. 2: Frequency dependence of a di erential photonassisted shot noise in the sym m etric chaotic cavity (G₁ = G₂) under xed ux A = $e(V_1^0 V_2^\circ)=(h)$. The magnitude of dS=d is normalized to its value at = 0. Curve (1) A = 1:0, (2) A = 2:0, (3) A = 3:0, (4) A = 4:0, (5) A = 5:0. For sym m etric cavity the curves appears to be independent of the transm ission distribution of the contacts.

W averaged over one period, the n = 0 Fourier com ponent of Eq. (12) thus su ces for our purpose. Substituting the expression for W into the current de nition and evaluating the traces we obtain:

where $J(A_1;A_2) = J_{n+1}(A_1)J_1(A_1)J_{r-n}(A_2)J_r(A_2)$, $F_1 = (_1 + _1 _2 F) = 2, F_2 = (_2 + _2 _1 F) = 2, F =$ 1 + 2 + 1 + 2 + 2 + 2 + 3, and the amplitudes are $A_1 = -1A$, and $A_2 =$ $_{2}A$, with $A = (V_{1}^{\circ} V_{2}^{\circ})=h$. Expression (13) is one of the main results of this paper. For D 1 it reduces to Lesovik-Levitov result [12] with the e ective Fano factor, F, appearing at the place of the quantum point contact Fano factor. For small A we recover the result of R ef. [16]: at A^2 order there is no dispersion. For all other cases a frequency dispersion is present, as it can be seen from Fig. 2, where dS=d is shown as a function of for sm all tem perature T h . In particular, we nd that dS=d displays a weak maximum for 1= _D rem in iscent of the reentrant behavior in superconductors.

The driving frequency dependence of the photonassisted noise may also be generated by electron di usion in disordered metals. To illustrate this point we consider a one-dimensional di usive wire of length L and dimensionless conductance $g = G = G_Q$ 1. We employ the same procedure used for a chaotic cavity, with the important di erence that we have to take into account the spatial dependence of G in the wire described by Eq. (3). The condition (2) is substituted by the neutrality condition on the potential along the wire: eV $(z;t) = eV^{\circ} \sin(t) (L = z)=L$, with 0 < z < L. We assume now that contact resistance is negligible, thus Eq. (3) is complemented by continuous boundary conditions for G at the ends of the wire. (The electronic energy distribution function for this problem has been discussed in Ref. [24].)

To accomplish this program technically we switch to the energy representation of Eq. (3). Since the driving is periodic we can single out the t+ dependence for any $_{n}$ A_n (t) e^{in ot} . In the energy operator A: A $(t_1; t_2) =$ domain this in plies that $A(1; 2) = \prod_{n} A_n (2; 2) = \prod_{n} A_n (1) 2$ (1 $_2$ + nh), where A_n^c (nh =2) is the Fourier transform of A_n (t). It is thus convenient to de ne = E + kh, such that k in an integer, and h = 2 < E < h = 2. One can then represents A in matrix form : A_{nm} (E) = \mathcal{R}_{m-n} (E + n). In this way the time convolution between two operators becomes a simple matrix product. In the matrix representation the distribution function entering Eq. (7) for the right lead (z = L) takes a diagonal form : $F_R (E)_{nm} = m \operatorname{sign} (E + n)$. For the left lead at zero tem perature it reads instead:

where $A = eV^{\circ} = h$. In practical calculations it is enough to restrict the matrix size to jnj 3A.

We solve Eq. (3) by representing the wire as a chain of N 1 1 chaotic cavities (where G is uniform) with N identical barriers between them [9, 25]. This leads to a nite di erence version of the U sadel equation:

where $_{Th} = hD = L^2$ is the Thouless energy of the wire. The operators and V^k have matrix representations ($_{h,m} = E + n$ and V^k_{nm} (E) = ieV° (N k) ($_{n,m} = 1 - n_{,m+1}$)=(2N). Eq. (14) can be solved by iteration [9]. Then photon-assisted shot noise can be obtained by evaluating the -dependent current I_k () = gN Tr [G_k;G_{k+1}]_K =8 at any one of the N barriers.




FIG. 3: Frequency dependence of the di erential photonnoise for a di usive wire for given values of $A = eV^{\circ}=h$. Here $_{Th} = hD = L^2$ and the num erical calculation has been performed with 10 nodes. The magnitude of dS=d is normalized to its value at = 0. Curve (1) A = 1.0, (2) A = 2.0, (3) A = 3.0, (4) A = 4.0.

Results for the di erential noise dS=d versus AC frequency are shown in Fig. 3. We nd that di usion due to impurities induces on the photon-assisted noise a sim – ilar frequency dependence as the transm ission through a chaotic cavity. Again a weak maximum is present with the main di erence that the energy scale is set by the Thouless energy instead of the dwell time.

In conclusion, we have shown that the frequency dispersion of the photon assisted noise can be used to probe directly di usion times in mesoscopic conductors. Our predictions can be veried by an experiment analogous to that described, for instance, in R ef. [14], where a chaotic cavity or a di usive wire should be substituted to the

quantum point contact. By carefully choosing the transparencies of the cavity or the length of the w ire, one can m atch the T houless energy ($h = _D$) with the range of frequencies that have been already investigated. A T houless energy of 10 eV, that is typically realized in m esoscopic conductors, corresponds to =2 = 2.4 G H z which is a frequency readily accessible in experiments.
