F in ite tem perature properties of the triangular lattice t-J m odel, applications to N $a_x C \circ O_2$

We present a nite tem perature (T) study of the t-J model on the two-dimensional triangular lattice for the negative hopping t, as relevant for the electron-doped N $a_x CoO_2$ (NCO). To understand several aspects of this system, we study the T-dependent chem ical potential, speci c heat, m agnetic susceptibility, and the dynamic Hall-coe cient across the entire doping range. We show system atically, how this simplest model for strongly correlated electrons describes a crossover as function of doping (x) from a Pauli-like weakly spin-correlated m etal close to the band-lim it (density n = 2) to the Curie-W eiss m etallic phase (1.5 < n < 1.75) with pronounced anti-ferrom agnetic (AFM) correlations at low tem peratures and Curie-W eiss type behavior in the high-tem perature regine. Upon further reduction of the doping, a new energy scale, dom inated by spin-interactions (J) emerges (apparent both in speci c heat and susceptibility) and we identify an e ective interaction $J_{eff}(x)$, valid across the entire doping range. This is distinct from Anderson's form ula^1 , as we choose here t < 0, hence the opposite sign of the usual N agaoka-ferrom agnetic situation. This expression includes the subtle e ect of weak kinetic AFM² - as encountered in the in nitely correlated situation (U = 1). By explicit computation of the K ubo-form ulae, we address the question of practical relevance of the high-frequency expression for the H all \cos cient R_H³. We hope to clarify som e open questions concerning the applicability of the t-J m odel to real experim ental situations through this study.

I. IN TRODUCTION

Since the discovery of superconductivity in H20intercalated NCO crystals⁴ this com pound has drawn signi cant attention. In addition, NCO displays a variety of rem arkable therm oelectric e ects, such as an unusually large and magnetic eld dependent therm opower⁵ and a T-linear Hall-coe cient ^{3,6}. While som e of its properties are similar to those seen in high-T_c materials there are some distinctive di erences. Both the cobaltates and the cuprates become superconducting in the vicinity of the Mott-insulating state, however, while this is achieved through hole-doping in the cuprates, NCO requires electron-doping x between x = 1=4 and $x = 1=3^7$. W hile for both com pounds the role of electron transport in two-dimensional planes - separated by thick insulating layers - appears to be crucial, the sites for the localized electron wavefunctions are organized in planar square lattices (Cu-ions) in the cuprates and in a triangular lattice (Co-atom s) in NCO. The most striking di erences how ever, are the sign of the hopping, which is inferred to be positive in the cuprates and negative in NCO, and its absolute value, which is believed to be an order of m agnitude sm aller in NCO⁸. W hile the experim ental results indicate a rich blend of phases - stem m ing perhaps from structural rearrangements with x - it is rst necessary to system atically probe the scope of a single m odel. for strongly correlated system s - namely the t-J m odel - in the case of this electronically frustrated triangular lattice.

In the half-lled band, where strong interactions lead to the spin- $\frac{1}{2}$ Heisenberg-antiferrom agnet (HAF), the square geometry facilitates anti-ferrom agnetism (AFM) through its bipartite nature, while the tendency towards

AFM in the cobaltate system is weaker. How ever, extensive num erical com putations⁹ indicate N eel long-ranged order even in the triangular lattice. Away from halflling, projected hopping on the square lattice system (t > 0) obeys the Nagaoka mechanism¹⁰. This results in a competition between the ferrom agnetic (FM) kinetic operator and AFM potential energy for nite values of J. Conversely, in the current case of the triangular lattice with a negative hopping t < 0, AFM tendencies are supported - rather than weakened - by the electronically frustrated kinetic energy operator. By further reducing the t-J model - taking J = 0 - we explicitly isolate thee ect of electronic frustration which leads to kinetic Antiferrom agnetism $(kA)^2$, an e ect triggered only by the motion of holes in an AFM spin-background, even away from the special case of doping 1=L, with L the number of sites.

This paper has two main objectives: Firstly, we want to supplement the arguments made in ref. 11, where the Curie-W eiss phase in the doping range x > 0.5 was addressed. Secondly, we will discuss the nite temperature t-J m odel starting from the N agaoka-regim e and then extend into nite dopings. The structure is as follows: In section II we describe our model and the exact diagonalization technique, which we utilize for our com putations. Section III presents the results for the static properties chem ical potential, speci c heat and entropy as well as the spin susceptibility. We then investigate the dynam ic Hall-coe cient R $_{\rm H}$ (!) and compare its dcand high-frequency behavior. Lastly, we draw a connection between the Hall-coe cient and the diam agnetic susceptibility. For all properties, we study system atically the dependence on tem perature, doping, and interaction strength. In Section IV we conclude and sum marize our results.

Beginning at a doping of only a single hole in the innitely correlated system, we track the e ect of kA into the interm ediate doping regime. The specic heat develops a low-tem perature peak indicative of e ective spininteractions, generated by a dressed hole in an AFM -spin background. The same e ect is manifest in the susceptibility results where we present an x- and J-dependent e ective interaction, with a smallbut nite AFM value in the case of J = 0.W e proceed by an explicit computation of the frequency-dependent Hall-coe cient. The results show weak frequency-dependence of R_H and encourage the applicability of its high-frequency lim it R_H to practical situations. W hile sm all in m agnitude com pared to the spin-susceptibility, we show through an identity in term s of derivatives - suggested by our num erical results -that the diam agnetic susceptibility alonem ay be closely connected to the tem perature dependent Hall-coe cient.

II. MODELAND EXACT DIAGONALIZATION

As a model for hole doped strongly interacting M ottinsulators, the t-J H am iltonian can be applied to the experimental situation of electron-doped NCO after an electron-hole transform ation¹², making use of the sym metry of the Hubbard model in respect to the M ottinsulator. The replacement rules are t ! t, = jl nj = x and q ! q, where is now hole-doping away from half-lling and n is the electron density per site. This leads to the t-J m odel

where C_i^v (\hat{c}_i) creates (annihilates) an electron of spin , \hat{S}_i is the three-com ponent spin-operator, $\hat{\pi}_i$ is the num – ber operator and i speci es the lattice site. \hat{P}_G denotes the Gutzwiller projector and the sum mation is over all nearest neighbor pairs < i; j > .

In the following, whenever doping x is mentioned this refers to electron doping in the NCO system and holedoping in the model H am iltonian. To compute the com plete spectrum - as required for therm odynamic properties - we employ the canonical ensemble exact diagonalization technique for sm all clusters. The computational dem and limits the analysis to quite sm all systems and nite size e ects are challenging to overcom e. Nonetheless, careful comparison between several systems of di erent geom etry enables us to extract the stable behavior and som ewhat isolate nite size e ects. Conversely, nite size e ects can help identify the favored eigenstate of a system.




FIG.1: (color on-line) Sm all numbers along arrows (red) denote Peierls phases in units of the ux through a single plaquette, phases on Icosahedron (c) not shown for clarity. D otted parallelograms (black) specify boundaries of nite clusters ((a) and (b)). All sites on corners of parallelogram s are equivalent and translations along bounding vectors T_1 and T_2 tile in nite lattice; shaded region in (b) forbidden for ladder. Note: di erent coordinate system s are used for torus and ladder. For ladder-system we use the Landau gauge with A / y%, (a) represents only one choice (denoted Torus a) for 12 sites. Another (denoted Torus b) results from ladder (b) by connecting all corners through T_1 and T_2 (not shown). Torus c is simple 3 4 cluster (not shown).

W e have employed several toroidal and ladder geom etries with L = 9, 12, and 18 sites, as well as the highly sym m etric icosahedralgeom etry. The icosahedron -a 12sited P latonic solid with 20 equilateral triangular faces – shares the property of geom etric frustration with the innite system while the e ect of the reduced coordination num ber (z= 5) appears to have only a sm all, quantitative e ect on the computational results (Fig. 1 (c)). O ur 12site torus clusters are depicted in Fig. 1 (a)-(b). A third 12-site cluster is the sim ple 4 3-cluster (called Torus c, not pictured).

W hile the num erical e ort of exact com putations for translationally invariant systems can be signi cantly reduced by exploiting space group symmetries of the H am iltonian, these symmetries are broken upon the introduction of a magnetic eld, as relevant for the evaluation of the H all coe cient. A magnetic eld is introduced by the usual Peierls substitution which modi es the hopping t between sites i and j by

where A is the magnetic vector potential and $_0$ the ux quantum . We depend the ux threading a triangular pla- $\frac{2}{M}$ A ds. In nite systems, the value of quette as the sm allest non-zero m agnetic eld is limited to values =1 where 1 is the length of a periodic loop in the system . Through a particular gauge we can achieve l equal to the number of triangular faces in the cluster, this guarantees the equality of the ux values through all plaquettes. An example is given in Fig. 1(a). A sim ilar strategy has been followed in the case of the square lattice quantum Halle ect^{13} . We complement the computations on periodic system swith ladder system s, which enable an in nitesimal ux to be chosen due to open boundary conditions in one of the spatial dimensions (Fig. 1(b)) and the Landau-gauge is adequate. In the case of the icosahedron (Fig. 1 (c)) the magnetic eld is applied through a (ctitious) magnetic monopole in its center, creating equalmagnetic uxes through all triangular plaquettes.

III. RESULTS

A. Chem ical Potential

The chem ical potential is evaluated as a derivative of the free energy F with respect to the particle number N ,

The derivative has to be taken as a discrete di erence of F (N). To take this derivative num erically, we use the central di erence form ula. Hence it is suitable to de ne




FIG.2: (color on-line) Chem ical potential (T) for all accessible dopings on Torus b: x = 2=12 = 0.16 to 10=12 = 0.83 for J = 0(a), $J = 0.4 \pm 0$ (b) and U = 0 (c). D ata for U = 0 computed for in nite non-interacting system, comparison with (a)-(c) shows relatively weak e ect of interactions in the doping range x > 0.8.(d) Squares are experimental data for (T) = (T) (0) from ref. 15. Shaded area is a comparison with our data for U = 0 for t = 100 K to t = 300 K.

In Fig. 2(a)-(b) we present (T) at several J and dopings x. At low temperatures (T) shows degenerate Ferm ibehavior $(/ T^2)^{14}$. In the strong-correlation regime (J = 0 and J = 0.4);) the ground state (g.s.) internal energy has a maximum at intermediate dopings x 0.5 due to the competition of increasing number of mobile particles and reduction of the available vacancies upon decrease of doping and, hence, the low temperature chemical potential changes sign here. In the high-temperature regime the doping-dependence of the H ilbert-space dimension determines the limit of

with $g(x) = (1 \ x) \log (2x=(1 \ x)) + \log (1=x)$ essentially the natural logarithm of the dimension of the Hilbert-space. In the projected t-J model, g(x) peaks at x = 1=3. For x < 1=3 the slope at large T becomes negative. In Fig. 2 the comparison of (T) for di erent interactions shows that the impact of projected ferm ions near half-lling is to force a negative slope of

for x > 0 which occurs in the non-interacting system only for x < 0. This is an example of the qualitative difference between a strongly-interacting Ferm i-system and its non-interacting counterpart.

At larger x > 0:7 the e ect of strong interactions is gradually lost and the temperature-dependence resem – bles that of the non-interacting Ferm i-system (Fig. 2(c)). For low temperatures well below the linear range of , – nite J > 0 generally increases the value of the chem ical potential with a stronger increase for x near the M ott-insulator. The high-temperature behavior is independent of J.

In Fig. 2(d) we compare the results with direct experimental measurements of the T-dependent chemical potential¹⁵ at x 0.83. Since our results in this doping range are rather insensitive to the value of U, we compare with our U = 0 results. Here, (T) was obtained directly from the tight-binding density of states by the implicit equation $\text{hni} = 2 \frac{1}{1} f(\textbf{;})$ ()d with xed hni = 1 + x, where f denotes the Ferm i-Dirac distribution function and is the non-interacting density of states. This t con rm s the notion of NCO as a system with an unusually small Ferm i tem perature scale. In Fig. 2(d) we show as a shaded region the values t = 100

K to t = 300 K, photoem ission results⁸ point to a value of jj 10m eV 118 K, hence jjhere is more than an order of m agnitude sm aller than in the cuprate-superconductors. In the following, when m aking contact with experiments, we take t = 100 K for simplicity.

B. Speci c H eat, Entropy




FIG.3: (color on-line) Speci c heat per site as function of T for varying x (computed on 18 site (x 0.72) and 12 site cluster (x < 0.72), (a) J = 0, (b) J = 0.4 j. Dotted lines show C_v (T) for non-interacting ferm ions and solid line for exact results. Note: scale changes in plots of di erent dopings, long tem perature exponential behavior at large x due to nite-system induced gap in energy spectrum. Results for x = 0.72 appeared in ref. 11

In Fig. 3(a)-(b) we present the speci c heat per site




FIG. 4: (color on-line) $C_{\nu}\left(\Gamma\right)$ at x = 1=L for several sets of boundary conditions, peak in speci c heat is system-independent property.

with hE i the therm odynam ic expectation value of the internal energy. We isst concentrate on the case of J = 0, corresponding to an in nite on-site interaction. Near the band insulator (x 1) the tem perature-dependence resembles that of non-interacting ferm ions, computed at xed particle density by isst determ ining (T) and then the T -derivative of the internal energy. When the doping is reduced, the m ain energy scale -m anifest in a peak of $C_v(T)$ at tem peratures, away from the tight-binding peak. Even at our low est doping x = 1=L the peak-feature persists (called kA-peak). This feature is magni ed in Fig. 4 for several di erent system s.

Numerical work on the g.s. of the problem of a single hole in an AFM spin-background² suggests this system to exhibit a weak e ective AFM interaction J_{eff} / 1=L due to the projected kinetic energy term only. While for one hole this excitation decays in the therm odynam ic

lim it, J_{eff} nonetheless induces a N elordered AFM g.s. and low energy excitations sim ilar to those observed in the HAF⁹.




FIG. 5: (color on-line) Entropy per site for three di erent dopings at J = 0 (x = 1=12 = 0.08, x = 5=12 = 0.42, x = 13=18 = 0.72), horizontal lines indicate high-tem perature lim it s(T ! 1) = $k_B \log (g(x)) = N$, x = 0.08 corresponds to Fig. 4. Exponential increase at low T for interm ediate x due to nite system -size gap .

The validity of our computations for the case of a single hole is underscored by the entropy. In Fig. 5, the tem – perature dependence of the entropy shows that the low – energy features observed in the speci cheat are necessary for the entropy to obtain its (known) high-tem perature lim it. For $T=\pm j$ 0:075 half the entropy is recovered (s(T)=s(1) = 0:5), indicative of entropy-enhancement due to electronic frustration¹⁶. For interm ediate dopings, the entropy reaches half its maximum at $T=\pm j$ 0:75 and for dopings x 0:7 - relevant to the Curie-W eiss phase of NCO - we nd $T=\pm j$ 0:78.

W ithin a high-temperature expansion¹⁶ a numerical argument was given for an S-shaped low temperature behavior of the entropy for the case of x = 0.2 and x = 0.4. O ur computations at small dopings rather suggests T for low T as applicable to a metal from Fermi-liquid arguments. It is remarkable here that C_v (T) relects these low energy excitations, notably even for larger dopings than the one applicable to the N agaoka-situation.

We now distinguish the e ect of J > 0 (Fig. 3(b)). This scenario has been investigated by several authors for the case of the hole doped square lattice and the HAF^{17,18}. For the situation of a single hole J > 0 shifts the kA-peak to larger temperatures $T_m = J=t$. In Fig. 8(b) we present the peak positions as function of doping and J. We nd T_m (x; J) to increase monotonically both with x and J and the slope as function of J for xed x to decrease for larger values of x. Extrapolating these results at a given value of J to x = 0 we obtain roughly

 $T_m \ (x=0) \ J.$ Our result should be distinguished from investigations on the t>0 square lattice 17 , where $T_m \ was found to follow the opposite trend decreasing slightly with x at sm all dopings, along with a rapid suppression of the peak. This supports the notion of electronic frustration contributing to AFM correlations in the present study in opposition to competing AFM exchange coupling and the FM N agaoka-mechanism in the case of <math display="inline">t>0$, capable of quick ly elim inating the low-energy spin excitations.

An experimentally interesting quantity related to the specic heat is dened by $C_v(T)$ T or = ds=dT corresponding to the low energy electronic part of the specic heat. When extracting this quantity from our numerical results, we neglect the contributions at very low T arising purely from the nite system induced gap in the spectrum (scaling as exp(=T) where is the gap between the g.s. and the rst excited state).

For the large doping case x = 0.7 we found¹¹ 45 (5) mJ=molK² ($_0$ 33 mJ=molK² for noninteracting tight-binding electrons), indicating a significant many-body enhancement. Experimental results¹⁹ indicate 26 mJ=molK². On the other hand, in the low-doping regime the linear increase with T is only observed in a very small temperature range and this range is possibly better classified as a non-Fermi-Hquid regime. Roughly, (x) = 0(x) 1 for x & 0. The increase in

with decreased doping is also demonstrated clearly by the low T slope of s(T) in Fig. 5.

C. Spin Susceptibility

To gain further insight into the role of spin- uctuations and to address the existence of the experimentally observed Curie-W eissphase of NCO²⁰, we compute the spin susceptibility (T) as function of temperature from the G ibbs free energy G (T;M), here $M = \sum_{i} S_{i}^{z}$ is the total m agnetization. This quantity follows from the Helm holtz free energy F (T;H) through a Legendre-transform ation G (T;M) = F (T;M) $H \frac{\theta}{\theta H} = F (T;H) + M H . H$ is the externally applied magnetic eld.

can then be evaluated numerically, by constraining the canonical ensemble to the sector of minimal β_z^{tot} ; and those sectors where S_z^{tot} is raised (lowered) by ~.




FIG.6: (color on-line) Spin susceptibility per site (T) for all accessible dopings x on 12-site torus. Dependence on $J=j_{2}j_{3}=(0, 0.1, 0.2, 0.3, 0.4, 0.5)$, indicated by arrow, blue dotted line shows bare-susceptibility for non-interacting ferm ions of density n = 1 + x and black dotted line indicates susceptibility of isolated spin $\frac{1}{2}$ ferm ions of density n = 1. Plots for x 0.58 appeared in ref. 11.

For low temperatures, near the band-lim it (x = 1)we identify weakly tem perature-dependent, Pauli-like behavior of , rem iniscent of the experim entally observed spin density wave (SDW)-phase (Fig. 6). When x is lowered past x = 0.75 we nd¹¹ a crossover to a Curie-W eiss like behaviorw ith appreciable renorm alizations of the g.s. susceptibility compared to its bare value, m irroring the experimental ndings. This behavior can roughly be understood by picturing electrons distributed on an empty lattice: Initially, the many-body eigenstate enables the electrons to move around without interacting directly with their neighbors, yielding a susceptibility that is Jdependent only to second-order. W hen the density is increased (n > 0:25 or equivalently n < 1:75), electrons are forced to interact through the exchange-coupling directly and hence yield a strongly J-dependent m agnetic susceptibility. The emergence of the Curie-Weiss phase is further supported by the strong magnetic eld suppression of the Heikes-Mott term in the therm opower within the t-J m odel, an e ect due to spin-entropy⁵ as was dem onstrated in ref. 11.

For tem peratures larger than a certain crossover tem – perature (which we call T), for all dopings, (T) can be described through the Curie-W eiss form




FIG.7: (color on-line) (a)-(c) Inverse susceptibility vs. temperature for dopings x = 1=12 = 0.08 (bottom), x = 2=12 = 0.16 (center), and x = 3=12 = 0.25 (top) for Torus a, b and c (l to r). Solid vertical arrows show increase in J, dotted (blue) line shows example for t to extract W eiss-temperature (x;J) and e ective moment p_f . Dotted vertical arrows indicate temperature T ; Note: comparison of the three system s allows isolation of nite size e ects, most visible for x = 0.16. (d) E ective magnetic moment p_{ff} . (e) W eiss-temperature vs doping x for J = 0 :::05. Letters in angled brackets correspond to experimental data from [a] V iciu²¹ et al., [b] G avilano²² et al., [c] Sales²³ et al., [d] Takeuchf²⁴ et al., [e] M otohashi¹⁹ et al., and [f] E ective moment of isolated spin $\frac{1}{2}$ -particles on half- lied lattice. (f) M agni cation of vs. x for J = 0 for several clusters.

with the W eisstem perature and the e ective m agnetic m om ent p_{eff} , V $% (\mathbf{r})$ is the volume of the crystal and L the num ber of sites. For all accessible system sizes - in particular Torus a,b,c (Fig. 1) - we compute (T) to extract , p_{eff} and T , the parameters characterizing the magnetic properties at a given doping and interaction strength. To determ ine and peff we t the hightem perature part of our computations for (I) to the function f(T) = a = (T)b) (com pare Fig. 7(a)). In Fig. 7(a)-(c) we present the inverse susceptibility at several di erent dopings near the Mott-insulating phase. The results for and p_{eff} are shown in Fig. 7(d)-(f). For 0, remains negative indicating AFM corallx and J relations. shows a linear increase when the doping is increased or the interaction is decreased. In short, as mentioned in ref. 11, can be collapsed into the form (x;J) = cJ_{ff} (x) where

with c = 4.0, $c^0 = 0.01425$ and $c^{00} = 0.9175$. In contrast to the relation given by Anderson et al.¹ in the case of the t > 0 square lattice, in our situation of t < 0 even at J = 0 there is a slightly negative intercept suggesting AFM spin-interactions in the low temperature regime of the electronically frustrated U = 1 Hubbard model, indicative of kinetic Antiferrom agnetism (kA).

On the other hand, once J > 0 is allowed, this intercept grows strongly and expresses dom inant AFM correlations (Fig. 7(e)). We compare these results with experiments for various dopings (x > 1=2) of NCO. Am ong others, the cases of $x = 0.75^{19,23,24}$, $x = 0.7^{22}$, x = 0.6 and $x = 0.9^{25}$, various x in the three-layer system ²¹ and $x = 0.55^{26}$ were experimentally investigated. The comparison with experiment proves di cult due to the large number of structural phases²¹, the role played by the Na-ions in the crystal and the large quantitative and qualitative di erence between powder and single crystal sam ples²³. How ever, the W eiss-tem perature appears to lie between 100 K and 200 K near x = 0.7 (varying considerably with H jp and H jp²³) and was measured to be sm aller at larger dopings²¹. Hence, at least for x > 0.5,

the t-J m odel description yields reasonable experim ental agreem ent.

The elective magnetic moment p_{eff} in units of B has a value close to that obtained for localized spin $\frac{1}{2}$ particles at half-lling $_{1=2} = g \frac{p}{s(s+1)} = \frac{p}{3}$ and decays linearly for x ! 1.

The inverse susceptibility shows a minimum at a temperature T which becomes more pronounced with increasing J. At low temperatures the system prefers antiferrom agnetic order which is strengthened by J > 0. Thermal spin uctuations break this order and when T is increased to values of order J a sm all perturbative B - eld is su cient to align spins antiparallel to the eld. Hence, the susceptibility is largest at this temperature. W hen T is further increased, the ability of the eld to ip spins is weakened by therm al uctuations, consequently, (T) decreases. The behavior of this peak as function of hole doping away from the M ott-insulator has already been investigated within a high-temperature expansion¹⁶.

D ue to the small size of the systems available to our study, it is dicult to con m the results for the doping dependence¹⁶. Here, we study the behavior as function




FIG. 8: (color on-line) (a) AFM -param agnetic crossovertem perature as function of J for several dopings on 12-site tonus clusters a, b, c. (b) Evolution of T_m as function of J, values averaged over three 12-site clusters a, b, c.

of J, considering several dopings near half-lling and several system geom etries (Fig. 8(a)). The gure indicates that T =j.j roughly scales as J=j.j hence, the scale at which the system undergoes a transition from an AFM – ordered to a param agnetic state is set by the interaction strength. As was shown for the case of J = 0 and t > 0 in the hole doped system², a single hole favors AFM N eel order and num erical results⁹ indicate that the triangular lattice H eisenberg m odel also favors N eel order – at least in the g.s. and the elementary excitations –hence it is not surprising that a nite J > 0 em phasizes this tendency. This is in opposition to the case of t < 0 where the kinetic energy term favors ferrom agnetism and competes with the H eisenberg-interaction preferring AFM .

D. HallCoe cient

Experimentally, NCO has been shown to exhibit unusual therm coelectric properties, resulting from strong electron correlations. W ang et al.⁶ m easured the dc-H all coe cient as function of temperature at several dopings showing unexpected temperature dependence with an oscillatory behavior below 200 K and a rapid linear increase for temperatures above 200 K.

M uch theoretical has been work invested into the study of R_H on square lattices^{3,12,27,28,29,30,31,32,33,34,35,36,37,38,39} both for properties and for nite temperatures. g.s. For the triangular lattice, it was possible to predict the high-tem perature behavior within a high-tem perature expansion of the t-J-m $odel^{3,12}$ in its high-frequency lim it. Several authors have also attempted to describe this behavior through Boltzm ann transport theory^{36,37} within the relaxation time approximation, where $R_{\rm H}$ is

expressed as an integral over the Ferm i-surface curvature

and the relaxation time $_k$ is taken to be isotropic. For large dopings -x 0:7 - where the hole-like Ferm i-surface of NCO approximates a circle, this leads to the same high-temperature linear coe cient as the t-J-high-temperature expansion, however, the behavior completely diverges in the dense regime (x < 0:7), possibly due to the m isleading replacement of the interacting Ferm i-surface by its non-interacting counterpart. A lso, at low temperatures - where the relaxation time is anisotropic - the oscillatory behavior seen in experiments is not reproduced.

To shed some light on the low-temperature and strongly-correlated behavior, we start from the high-frequency $\lim_{t \to 0} \frac{1}{2} \operatorname{for } R_H$ (T;!):

Here, e is the electron charge, J_x (J_y) are the currents in x (y)-directions, v is the unit cell volume, and $_{x,x}$ is the diagonal part of the stress tensor. To ensure the e ect of strong correlations within this limit, it is necessary to force the hierarchy t < ! U. We enable this by projecting out double occupancy using the G utzw iller projector, hence the t-J m odel is the appropriate description.

O ur plan is as follows: we show the connection of this high-frequency lim it – not measurable in experiments – to the dc or low-frequency behavior. Then we evaluate the dependence on the parameters T, J and x for several systems. Hence, for the rst part we compare $R_{\rm H}$ with the expression derived from the Kubo formulae for the electrical conductivities

with the 'th energy eigenvalue off and Z the canonical partition function. In terms of this expression the Hall coe cient is given by

As a transport object R_H is a demanding quantity to study on nite clusters. The e ect of boundary conditions and their nite size implications are di cult to eliminate. We introduce a small magnetic eld through the Peierls substitution (Eq. 2) which impacts only on the orbital motion of the electrons and does not couple to the spin. Studying R_H on toroidal and spherical geometries reduces the nite size e ects on the transport, how ever, these periodic systems constrain the smallest accessible ux $_0$ to =L. For L = 12 this is already a considerable ux. An alternative are ladder systems such as in Fig. 1(b) where the lim it $_0$! 0 is possible. How - ever, ladders have additional nite size e ects in pacting on the transport quantities.




FIG.9: (color on-line) R_H (!;T) on 12-site torus at several frequencies for several dopings and J = 0.

For several dopings (x = 0.08, 0.67, 0.75, 0.83) we com – pute R_H (!) as a function of temperature both on the torus and the icosahedron. To take into account the – nite size of the system, a broadening of the energy equal

to the mean level spacing of the current matrix elements was employed, this requires 3 tj. In Fig.9 we show R_H as function of temperature at three di erent frequencies. Comparing ! = 0 to ! = 1 we nd that the dc-limit is qualitatively the same as the high-frequency limit, how ever, the overall temperature-dependence is scaled by a renorm alization factor s $R_{\rm H}$ (T;! = 0)= $R_{\rm H}$ (T;1) where s is only weakly temperature dependent. For the torus, s was found to be 0.83 (0:78) at x = 0.83 (x = 0.75). At x = 0.083 the many-body renorm alization is stronger.




FIG.10: (color on-line) $R_{\rm H}$ (!) at several tem peratures and dopings as function of frequency on 12-site Torus a for J = 0. Tem peratures in all plots T=tj=(0:5;1;2;4).

Conversely, in Fig. 10 we show the frequency-dependence of $R_{\rm H}$ at several tem peratures and di erent dopings. Sim ilar to the work done by G rayson et al. 40 on the H all angle, nite frequency experiments may be helpful to con m the weak frequency-dependence seen in our computations: W ith <code>tj</code> 10m eV results in the frequency range ! 3<code>tj</code> 30m eV could be compared to our theoretical results and hence lend experimental support for the usefulness of the high-frequency lim it³ of $R_{\rm H}$.

W e have computed two additional quantities related to the dc-lim it as checks of the validity of the dccom putations. Zotos et al.²⁹ derived an expression for the g.s. expectation value, R $_{\rm H}$ (T = 0) = $\frac{1}{\rm jej\,dn}$ log D (n) with D the charge sti ness D = $\frac{d^2 hE i_0}{d^2}$, hE i₀ the g.s. energy a constant ux inducing a persistent current⁴¹. In and this fashion, we evaluated the doping dependence of the g.s. and found $R_{\rm H}^{\,0} > 0$ in the experimental regime near 0:7 and a divergence R_{H}^{0} ! 1 as the Mott-lim it х is approached¹¹. The second check refers back to the basic de nition of the dc-Hall-coe cient R_H = $E_v = (B j_x)$ and computing this directly on a ladder system . This computation showed no change of sign for x 0:7 as function of T and a qualitatively similar behavior to the ! = 1 result.

Encouraged by the notion of weak frequencydependence, we studied $R_H = R_H (! = 1)$. We have studied several 12 site tori, several doping values on an 18 site torus, the icosahedron and several ladders.

The g.s. $R_{\rm H}$ (x) shows a D rude drop-o near the band insulator and a saddle point around x = 0.5 as was reported by the authors in ref. 11. W hen the strongcorrelation regim e near the M ott-insulator is approached (x < 1=2), the slope again increases and for 1 hole (x = 0.083) $R_{\rm H}^0$ changes sign.




FIG.11: (color on-line) (left) R $_{\rm H}$ (T) for several x and J for Torus b. (right) C $_{\rm v}$ (T) for several x and J on same Torus.

The high tem perature behavior con m s the prediction from the high-tem perature series expansion^{3,12}. The interesting tem perature range is for T < 2 ± j where the experimental data shows an oscillatory behavior and analytical results are not available (Fig. 11). Our com – putations show a distinct m inimum in R_H (T) which appears near T = ± j in the Curie-W eiss regime (x 0:7) and continuously m oves to smaller tem peratures as the doping is decreased. For the smallest dopings accessible (x = 1=L) this m inimum appears near T = 0.2 ± j while the behavior becom es linear at higher T in all cases. In the Curie-W eiss regim e som e system s also show a weak maximum close to $T = 0.25 \pm j$. These results point towards the existence of two distinct energy scales. The pronounced minimum appears to be correlated with the peak in the electronic speci c heat (Fig. 11), which also occurs around $T = \pm j$ in the band limit, and gradually shifts towards sm aller tem peratures with decreased doping.

To strengthen this point it is useful to include the dependence on J. As reported for the specic heat, the e ect of J is to move the peak in speci c heat to larger tem peratures. This behavior is mirrored by R_{H} . In Fig. 11 we show $R_{\rm H}$ (T) for several dopings and J.Atx = 0:75 the peak of C_v (T) shifts from T = 1:3 t to T = 1:5 t j while the minimum in R_H (T) moves from T = 0:75 t j to T = 1:1 j. At x = 0:67 the behavior around T = 1 j is similar, however an additional peak in the specic heat em erges at T < 0:5 tj. A qualitatively sim ilar feature is seen in other clusters, how ever, its magnitude is dependent on the system geometry. Hence, we do not attempt to extract quantitative inform ation in the T-range below T = 0.5 j. Nonetheless, it is important to note that with decreasing doping a second energy scale - caused by spin interactions - becom es dom inant. At sm all doping x = 0.16 and x = 0.08 the speci c heat becomes strongly J-dependent and the main peak in the specic heat as discussed in the sst section - increases signi cantly with J. The variations in $R_{\,\rm H}$ (T) with J are also more pronounced.




FIG. 12: (color on-line) C om parison of 12-site Torus b and icosahedron with experim ent³⁶ at x = 0.31 and x = 0.71, we take t = 100 K, in the lower plot our num erical results are scaled to m atch the slope of the linear part at T > 200 K in the experim ental results.

100 K we compare our results to the Assuming t experimentally available data⁶ at x = 0.31 and x = 0.71, this was done in ref. 11 for x = 0.71. In Fig. 12 the comparison at x = 0.31 shows good agreement for the slope at high T and reproduces the tem perature scale for the minimum near 25 K. For x = 0.71 the temperature scale for the minimum near 100 K is seen both in experim ent and theory. The slope of the high tem perature lim it diers by a factor of 4 and was adjusted in the plot for better com parison. A lso, the theory does not show the change of sign as function of tem perature. How ever, the oscillatory behavior below T = 100 K and the onset of the linear increase for T > 200 K agrees well with experim ent. Hence, the exact tem perature dependence of R_H remains a challenging task - both on the theoretical and experim ental side.

E. D iam agnetic Susceptibility

Lastly, we study the orbital susceptibility per site

It is useful to employ ladder systems as shown in Fig. 1(b). Dening t = $\sim^2 = 2m l^2$ we have




FIG.13: (color on-line) (a) $_{\rm d}$ (T) and unitless Hall-coe cient $r_{\rm H}$ and their derivatives on a 12-site ladder at x = 0.83. (b) C om parison of num erical results for x = 0.83 for $R_{\rm H}$ (T) (obtained on an 18-site torus) with the integral of Eqtn. (6) ($_{\rm d}$ (T) obtained on a 12-site ladder system) for two di erent values of J. A ppeared partly in ref. 11.

where f is the dimensionless F = t and $_B$ is the Bohrmagneton. In Fig. 13(a) we present the diamagnetic susceptibility and its rst two derivatives with respect to T.For free electrons in an in nite system, d corresponds to electrons moving in circular orbits with radii inversely proportional to the magnetic eld. R_H measures the polarization induced in a system with a stationary current and perpendicular magnetic eld. It is hence reasonable to ask for a connection between these two quantities. Our num erics suggest the relation

where c(x) is a function depending on doping x.

In Fig. 13(b) we display our numerical result for R_H (T) at a doping relevant to the experimental situation⁶ compared to the result obtained from integrating Eqtn. (6) and choosing the two integration constants

IV. CONCLUSION

In sum m ary, we have presented a system atic study of the entire doping regime for the triangular lattice t-J m odel with electronic frustration (t < 0 for n > 1). We have identi ed low energy excitations, stem m ing purely from kinetic processes (J = 0) of in nitely correlated spin $\frac{1}{2}$ ferm ions. These are manifest in a peak structure in the speci cheat emerging at very low T near the M ottinsulator, how ever persisting for interm ediate dopings. The e ect of electronic frustration is further supported by entropy-enhancement in the underdoped regime with a low entropy recovery temperature.

We have studied both the diam agnetic and spinsusceptibility. For the spin susceptibility we extract a relation for elective spin-interactions (x;J) valid for all dopings. This stands in contrast to Anderson's form ula for FM t> 0, since in our case AFM is supported rather than suppressed by doping. In the experimentally relevant doping range of x > 0.5 we over an explanation for the crossoverbetween the Curie-W eiss and SDW metallic phases, as observed in experiments⁷. For the diam agnetic susceptibility d a connection is obtained between d and the tem perature dependent H all coe cient.

The dynam ic Hall coe cient reveals a weak frequencydependence and a qualitatively similar dc and highfrequency behavior, with stronger renorm alizations close to the Mott-limit. This strengthens the practical relevance of the high-frequency limit³ $R_{\rm H}$. The tem perature-dependence con m sthe linear slope at high tem peratures³ and reproduces the experimentally observed m in im um near T = 100 K at x = 0:71.

In conclusion, the t-J m odel is applicable to NCO for x > 0.5 and shows that the interface of strong correlations and m etallic behavior indeed describes the experimental situation here. For x < 0.5 the frustrated t-J m odel leads to subtle e ects of strong correlations, even in the case of J = 0. Our results show, that for the proper description of experimentally observed normal state properties⁷ there - such as the charge-ordered insu-
