O scillatory multiband dynamics of free particles: The ubiquity of zitterbewegung e ects

In the D irac theory for the motion of free relativistic electrons, highly oscillatory components appear in the time evolution of physical observables such as position, velocity, and spin angular momentum. This elect is known as zitterbewegung. We present a theoretical analysis of rather dierent Ham iltonians with gapped and/or spin-split energy spectrum (including the Rashba, Luttinger, and Kane Ham iltonians) that exhibit analogs of zitterbewegung as a common feature. We not that the amplitude of oscillations of the Heisenberg velocity operator v(t) generally equals the uncertainty for a simultaneous measurement of two linearly independent components of v. It is also shown that many features of zitterbewegung are shared by the simple and well-known Landau Ham iltonian describing the dynamics of two-dimensional (2D) electron systems in the presence of a magnetic eld perpendicular to the plane. Finally, we also discuss the oscillatory dynamics of 2D electrons arising from the interplay of Rashba spin splitting and a perpendicular magnetic eld.

I. INTRODUCTION AND OVERVIEW

The Dirac equation 1,2,3 was derived to obtain a relativistic generalization of Schrodinger's approach to quantum physics that describes the dynamics of singleelectron quantum states. While it served as an important stepping stone towards a more complete description of quantum -electrodynam ic e ects, D irac theory has occasionally been regarded with some suspicion. In particular, the e ect of zitterbewequng showed that solutions of the Dirac equation exhibit peculiarities that are inconsistent with classical intuition in a more fundamental way than nonrelativistic quantum physics. The zitterbewegung is an oscillatory dynamics of observables induced by the Dirac equation, with a frequency of the order of $2m c^2 = h$, where m is the electron mass, c is the speed of light and h is the Planck constant. The am plitude of oscillations in a particle's position is of the order of the Compton wave length. Subsequently, zitterbewequng attracted som e interest as a possible way to understand the intrinsic magnetic moment of the electron. 5,6 Later, on the level of fundam ental physics, the advent of quantum eld theory obviated the need to discuss relativistic quantum theory in terms of a rst-quantized, Schrodinger-type theory. Present interest in the Dirac equation ranges from hadronic physics over lattice gauge theory8 to recent e orts9 to incorporate relativistic effects into quantum -chem istry calculations.

A Dirac-like dynamics causing analogs of zitterbewegung was also predicted for electrons moving in crystalline solids, 10,11 in particular for narrow-gap sem iconductors, ¹² carbon nanotubes, ¹³ graphene sheets, ¹⁴ tunnel-coupled electron-hole bilayers¹⁵ and superconductors. 16 All these systems are characterized by having the relevant electron excitations grouped into two bands separated by a nonzero energy gap so that their energy spectrum is similar to the spectrum of the Dirac Hamiltonian. A recent study¹⁷ of two-dim ensional (2D) electron system s in inversion-asym m etric sem iconductor heterostructures showed the presence of an oscillatory motion analogous to zitterbewequng arising from spin splitting of the energy levels. The spin splitting corresponds to an energy gap that vanishes for momentum p! 0. A similar situation occurs for electronic excitations in the bulk of an ideal graphene sheet. 14

These ndings indicate the need to understand zitter-bewegung-like e ects on a more general level. In Ref. 18, the authors presented a general form ula for the Heisenberg position operator r(t) in systems that can be described by e ective 2 2 Ham iltonians. In the present work, we have investigated the oscillatory dynamics of Heisenberg observables such as position r(t), velocity v(t) = dr=dt, orbital angular momentum L(t), and spin S(t) in a variety of qualitatively dierent models that describe the motion of free (quasi-)particles. Besides the Dirac Ham iltonian, we have studied three Ham iltonian

ans frequently used in sem iconductor physics to describe the dynam ics of (quasi-free) B loch electrons in the vicinity of the fundam ental gap, the Rashba, 20 Luttinger, 21 and Kane²² Ham iltonians. A number of striking features em erge quite generally in all these models, thus illustrating rem arkable sim ilarities between time evolutions generated by rather dierent Hamiltonians. We suggest that these com m on features can be used to extend the concept of zitterbew equing to a broader class of quantum Ham iltonians for free (quasi-)particles. Our analysis shows that this generalized notion of zitterbewegung is manifested, in addition to the oscillatory unitary time evolution of observables, also by uncertainty relations characterizing the m easurem ent of such observables. These two aspects tum out to be closely related. In particular, they can be described, for each of the models considered here, by the same set of parameters. Also, we identify the typical scales (lengths, velocities, and frequencies) that characterize zitterbewegung-like oscillatory motion. We em phasize that this extended notion of zitterbew equing is entirely based on quantum mechanical concepts. In an alternative, sem iclassical approach one would identify a zitterbewegung relative to a suitable classical dynamics as, e.g., in Ref. 23. In some cases the conclusions will be dierent from those obtained within the present approach. The most general aspects of our study can be sum m arized as follows:

(i) An oscillatory motion occurs in the time evolution of free (quasi-) particles when the energy spectrum of the corresponding Hamiltonian H is characterized by one or several energy gaps. Besides the Dirac model, an important example are Bloch electrons in solids, 10,11 whose quantum dynamics are described by elective free-particle Hamiltonians that incorporate the electron the periodic lattice potential.

(ii) In the case of two-band models (e.g., the D irac, R ashba, and Luttinger models), zitterbewegung-like effects are generally characterized by an amplitude operator F and a frequency operator ? (p). These two quantities enter the expression for the velocity operator in the H eisenberg picture, which can be decomposed as v(t) = v(t) + v(t), where the mean part is

Here, h! (p) is related to the energy dierence between states having the same momentum p, but belonging to dierent subspaces (i.e., energy bands) of the Hamiltonian. The operator F, which anticom mutes with! (p), determines the magnitude of oscillations in the velocity components but also enters the expression for the mean part. We can integrate Eq. (1) to get the Heisenberg position operator that can be decomposed in the same way,

Sim ilarly, we get the time derivative of v (t),

The operators F and ! (p) govern also the oscillations in the Heisenberg time evolution of the orbital angular momentum operator L (t), and the spin operators S (t). In system s with more than two bands (K ane and Landau-Rashbam odels), more than one characteristic frequency and amplitude operator can appear.

(iii) For each model describing an oscillatory multiband dynam ics of free particles, the components of the velocity operator v (t) do not commute. This can be written as an uncertainty relation that takes the form (apart from a prefactor of order one)

where \forall is the amplitude of the oscillatory motion, see Eq. (1b). The uncertainty relations (4) are an integral part of our analysis. 24

(iv) The velocity operator v (t) does not com m ute w ith the H am iltonian. A lthough we discuss the m otion of free (quasi-)particles, the components of v (t) are not constants of the m otion, see Eq. (3). On the other hand, m om entum p is always a constant of the m otion. This implies that none of the m odels discussed here provides a simple relation between m om entum p and velocity v.

(v) The counterintuitive properties of r(t) and v(t) arise because r(t) m ixes di erent subspaces H $_{\rm j}$ that are associated with the di erent bands in the energy spectrum of H . Thus we can interpret zitterbewegung-like phenom ena as an interference e ect. In the case of two-band m odels, one can replace r by the part r that leaves the subspaces H $\,$ associated with the $\,$ ' and $\,$ ' bands separately invariant,

where P are projection operators onto these subspaces. The result coincides with the mean part r(t) of r(t) introduced in Eq. (2a), i.e., zitterbewegung-like e ects are removed by the projection (5). This result can be understood from a dierent perspective by analyzing the amplitude operator F. We get

i.e., F m aps states associated with the ' band onto states associated with the ' band and vice versa. An alternative de nition of r(t) is obtained by applying the inverse unitary transform ation to r(t) that m akes H diagonal. The same techniques can also be applied to v(t)

to obtain v (t) given in Eq. (1a). The components of v (t) commute; hence they can be measured simultaneously [unlike Eq. (4)]. They also commute with the Hamiltonian so that they are constants of the motion.

(vi) In every case considered, zitterbewegung-like phenom ena are manifested also by oscillations of the orbital angularm om entum L (t) and spin S (t). At the same time, the total angular momentum J does not oscillate as a function of time. As expected for a model of a free particle, J is a constant of the motion, i.e., it commutes with the H amiltonian. From a dierent perspective, this implies that the oscillations of L (t) = r(t) p and S (t) must cancel each other, which is possible only if the oscillations of r(t) and S (t) have a common origin. For the Rashba H amiltonian, the oscillatory motion of $S_{\rm Z}$ (t) corresponds to the well-known and experimentally observed 25 spin precession in the elective magnetic eld of the Rashba term.

The following Sections II(V are devoted to a detailed discussion of zitterbewegung e ects arising in systems whose time evolution is governed by the Dirac,3 Rashba, 20 Luttinger, 21 and Kane 22 Hamiltonians. Rem arkable form al sim ilarities between the oscillatory behavior of observables in these models are established, as outlined above. Next we show in Sec. VI that the familiar Landau model of 2D electrons subject to a perpendicular magnetic eld26 exhibits essentially all the features attributed to the extended notion of zitterbewegung in previous sections. We nish our case studies in Sec. V II by investigating the quantum oscillatory dynam ics of 2D electrons arising from the interplay of Rashba spin splitting and a perpendicular magnetic eld. 27 Conclusions and a sum mary of open questions are presented in Sec. V III. For easy reference, we provide a number of relevant basic form ulae in the Appendix.

II. DIRAC HAM ILTONIAN

Our discussion of zitterbewegung for the Dirac Hamiltonian follows, for the most part, Ref. 3. We include this section with an overview of the ect's salient features to provide a reference frame and notation for our following discussion of solid-state analogies.

The D irac H am iltonian H $_{\rm D}$ describes a free relativistic electron or positron. It can be written in the form

and is the vector of Pauli spin matrices. (Here we assume magnetic eld B = 0. See Ref. 28 for the generalization to nite B.) The energy eigenvalues of H $_{\rm D}$ are E (p) = $_{\rm D}$, where

Note that H $_{\rm D}^{2}=_{\rm D}^{2}$. In the Schrödinger picture, the velocity operator reads

so that the components of v have the two discrete eigenvalues c. In the Heisenberg picture, we get Eq. (1) with

It turns out³ that orbital angularm omentum L = r p and spin S, which is dened as

show the phenomenon of zitterbewegung, too. For the orbital angular momentum, we have

The time evolution of spin in the Heisenberg picture reads

Thus it follows from Eqs. (13a) and (13b) that the total angular momentum J = L + S does not oscillate as a function of time,

We can estimate the magnitude of zitterbewegung by evaluating the square of \forall (t) (Ref. 4). This yields

i.e., v^2 varies between $3c^2$ in the nonrelativistic lim it and $2c^2$ in the relativistic lim it. (Note that, although $v^2>c^2$, no measurable velocity exceeds c.) On the other hand, the components of the velocity operator v do not commute. Equations (10) and (12) in ply that

where ^-D = h=(m c) is the C om pton wave length. Thus both the magnitude and the uncertainty of the zitterbewegung are given by c^2 (Ref. 24). We can also estimate the spatial amplitude of the zitterbewegung using the decomposition r(t) = r(t) + r(t), see Eq. (2). We get for the oscillating part

i.e., in the nonrelativistic lim it, the amplitude of zitterbewegung is approximately $^{\text{-}}_{\text{D}}$, and it is given by the de Broglie wave length $^{\text{-}}_{\text{B}}$ = h=p in the relativistic lim it.

It is well-known³ that zitterbewegung is caused by a coupling between the states with positive energies (\particles", subspace H $_+$) and negative energies (\antiparticles", subspace H). Thus one can elim inate the oscillations of r(t) by projecting r on H as in Eq. (5) and the result coincides with Eq. (2a). The components r_j of r do not commute:

is the spin operator analogous to Eq. (1a) that does not m ix the subspaces of positive and negative energy states. D iagonalizing Eq. (17a) yields the uncertainty relation for j \in k

The tim e derivative v of the m ean position operator r is the velocity operator one would expect based on the correspondence principle and classical relativistic kinematics. Its components v_j , v_k commute, $[\![v_j]\!];v_k]=0$. Furtherm ore, v commutes with H $_D$, i.e., it is a constant of the motion .

Equation (5) is motivated by the requirement that it leaves the subspaces H separately invariant. However, this requirement is not sudient for a unique denition of a relativistic position operator. The Dirac equation becomes diagonal in the Foldy-Wouthuysen (FW) representation. If we require the mean position operator to be diagonal in this representation, it can be obtained in the standard representation via an inverse FW transform:

This operator is often called the New ton-W igner position operator. In contrast with the position operator r in Eq. (5), the components of $r_{\scriptscriptstyle N\,W}$ do commute. We see that $r_{\scriptscriptstyle N\,W}$ (t) shares with r(t) from Eq. (5) that the time derivative v (t) is given by Eq. (1a), i.e., it does not show any zitterbewegung because it is a constant of the motion.

G eneral requirem ents for any position observable describing the localization of a particle or wave packet are discussed in Ref. 3. In this context, the operator r in Eq. (5) appears inappropriate because its components do not commute. The optimal choice for a position observable is the operator r_{NW} . However, general arguments prohibit the possibility of strict spatial localization for a one-particle state (see, e.g., Refs. 3,32,33). This imposes restrictions on the utility of any position operator in relativistic systems.

III. RASHBA (AND PAULI) HAM ILTONIAN

An intriguing example of zitterbewegung-like dynamics exhibited by a non-D irac-like H am iltonian has been found 17 in the R ashbam odel. This model describes 2D electrons in semiconductor heterostructures with spin-orbit coupling present, using the electrone H am iltonian (we assume here B = 0, see Sec. V II for the case B $\stackrel{\leftarrow}{\bullet}$ 0)

Here

is the Rashba term with Rashba coe cient (Ref. 20), and e_z denotes the unit vector in the direction perpendicular to the 2D plane. (Note that H $_{\rm R}^2$ = $^2p^2$, similar

to the D irac H am iltonian.) The H am iltonian (19) is also equivalent to the Pauli H am iltonian 2 for a 2D system . The energy eigenvalues of H are

The time-dependent position operator r(t) in the Rashbam odelwas discussed previously in Ref.17. Evaluated in close analogy to the D irac case, it is again possible to decompose r(t) into a mean part r(t) and an oscillating part r(t). The result is of the form shown in Eq. (2), where F and r(t) are now

Explicit evaluation shows that r(t) oscillates with the frequency ! $_R = 2$ p=h, which is equal to the precession frequency of a spin moving in the elective magnetic eld of the Rashba term [see Eq. (24b) below]. The oscillation becomes arbitrarily slow for p! 0. We not for the oscillating part of r(t)

i.e., the magnitude of the oscillations is of the order of the de Broglie wave length $^{-}_{\rm B}$ and independent of the Rashba coe cient . Note that $^{-}_{\rm B}$ diverges in the lim it p! 0.

We obtain the mean part r(t) by projecting on the subspaces of H associated with the spin-split bands, as in Eq. (5). We not the same r(t) by applying an inverse FW transform ation, similar to Eq. (18). For the Rashba model, the last term in Eq. (2a) corresponds to a spatial separation of up and down spin contributions in a wave packet by $^{\rm -B}$ (independent of the Rashba coe cient), which was noticed in previous numerical work. 34 The general validity of Eq. (2a) for two-band models in plies the existence of similar displacements for the Dirac and Luttinger cases. See also Ref. 18. The components x and y of the mean position operator room mute, similar

The velocity operator and its derivative are given by Eqs. (1) and (3), respectively, using expressions (21). The oscillatory part of v satisfies

analogous to Eqs. (15). In Eq. (23c) we replaced the matrix-valued RHS of Eq. (23b) by the eigenvalues of

this matrix. Thus similar to the D irac case, both the magnitude of the oscillations in v(t) and the minimum uncertainty are given by the same parameter. The components of the mean part of the velocity operator commute, $[v_x(t); v_y(t)] = 0$. They also commute with H $_R$, i.e., they are constants of the motion.

The time dependence of orbital angular momentum $\,L_z$, spin component $\,S_z$, and total angular momentum $\,J_z=\,L_z+\,S_z$ can be straightforwardly discussed. We get

The form al structure of these equations is analogous to the D irac-case counterparts shown in Eqs. (13). Equation (24b) represents the well-known spin precession in the elective magnetic eld of the Rashbaterm, which has been observed experimentally. The total angular momentum component perpendicular to the plane does not depend on time, as expected from $[J_z\,;H]=0.0$ by biously Eqs. (24) require that the spin precession is caused by the elective in-plane magnetic eld of a spin-orbit coupling term such as the Rashbaterm. We see here clearly the difference between spin precession caused by spin-orbit coupling and spin precession caused by the Zeem an term in the presence of an external in-plane magnetic eld. In the latter case J_z is not a constant of motion.

IV. LUTTINGER HAM ILTONIAN

The upperm ost valence band $\ ^v_8$ of comm on sem iconductors like Ge and GaAs is well-characterized by the Luttinger Ham iltonian 21

The upper sign corresponds to the so-called light-hole (LH) states with spin-z component M = 1=2, and the lower sign corresponds to the heavy-hole (HH) states with M = 3=2. The momentum-dependent energy gap between HH and LH states is

The position operator is of the form shown in Eq. (2) with F and ! (p) given by

Thus r(t) oscillates with the frequency $!_{\rm L}$, which has been noticed in previous numerical work. ³⁶ Similar to the Rashba Hamiltonian, these oscillations become arbitrarily slow for p! 0. The squared amplitude of the oscillations of r(t) is ${\rm r}^2$ (t) = $(3=2)^{-2}_{\rm B}$, independent of the Luttinger parameter. It diverges for p! 0.

W e obtain the mean position operator r, de ned in Eq. (5), using projection operators that project onto HH and LH states. The result coincides with Eq. (2a). The components of r do not commute,

This uncertainty is of the order of (or less than) the de Broglie wave length. The uncertainty is the largest for those components r_i that are perpendicular to p.

U sing Eqs. (28), the velocity operator can be written in the form shown in Eq. (1). For its oscillating part, we not v^2 (t) = 6^2 (p=m) 2 . The components of v do not commute,

and cyclic perm utations thereof, i.e., the uncertainty is approxim ately lim ited by 3 2 (p=m) $^2=\frac{3}{4}\left(!\right|_L$ ^-_B) 2 . Thus again, the magnitude of the oscillations of v (t) and the minimum uncertainty are characterized by the same combination of parameters. The velocity v (t) is not a conserved quantity but satis es Eq. (3). However, the mean velocity operator is again given by Eq. (la). Its components commute and are constants of the motion.

The time dependence of orbital angular momentum L, spin S, and total angular momentum J=L+S turns out to be given by Eqs. (13). Note that the time dependence of S (t) in the Luttinger model corresponds to a spin precession in the absence of any external or e ective magnetic eld. The Again, the total angular momentum does not depend on time, which rejects the fact that [J;H]=0.

We rem ark that a similar analysis as presented in this Section also applies to models that neglect the spin degree of freedom. An example is the 3 $\,$ 3 Shockley H amiltonian that describes spinless holes in the upperm ost valence band $\,^{\, V}_{\, \, 0}$ of semiconductors like Si. 39,40 Indeed, this

is consistent with the fact that zitterbewegung for the D irac case can be studied already in a model with only one spatial dimension, where the D irac H am iltonian H $_{\rm D}$ becomes a 2 $\,$ 2 m atrix that rejects the occurence of both signs of the energy in the spectrum of H $_{\rm D}$; but this H am iltonian does not describe the spin degree of freedom 29 A spin with spin-orbit coupling is not a necessary condition for the oscillatory behavior of r(t) and v(t) to occur. The most basic ingredient required for zitterbewegung-like e ects are several bands separated by a (usually momentum -dependent) gap. Of then the splitting of these bands can be described by an ejective spin-orbit coupling 35,41

V. KANE HAM ILTONIAN

The K ane H am iltonian 22 is an elective H am iltonian that captures the important physics of electrons and holes in narrow-gap semiconductors like InSb. We restrict ourselves to the 6 $^{\circ}$ 6 K ane model which includes the lowest conduction band $^{\circ}$ and the uppermost valence band $^{\circ}$ (3D, B = 0), neglecting the split-o valence band $^{\circ}$, because that model perm its a fully analytical solution. Then we have

Here E $_{\rm g}$ is the fundam ental energy gap, and P denotes K ane's m om entum matrix element. The vector T of 2 4 matrices is de ned in Ref. 42. The energy eigenvalues of H $_{\rm K}$ are (each twofold degenerate)




FIG. 1: Energy spectrum E $_{;0}$ (p) of the 6 $_{6}$ K ane m odel. Here, E $_{g}$ denotes the fundam ental gap. Each band E (p) is twofold degenerate.

i.e., the K ane H am iltonian combines the gapped spectrum of the D irac H am iltonian with the gapless spectrum of the Luttinger H am iltonian. (Indeed, the Luttinger H am iltonian corresponds to the lim iting case E $_{\rm g}$! 1 of the K ane m odel.) The energy spectrum E $_{;0}$ (p) is shown in Fig. 1.

Results similar to those discussed below can also be derived perturbatively for the full 8 8 K ane H am iltonian that includes the split-o valence band $^{\rm Y}_7$. We also remark that a simplied 4 4 K ane H am iltonian, which includes only the conduction band $^{\rm C}_6$ and the valence band $^{\rm Y}_7$, is strictly equivalent to the D irac H am iltonian. Recently, zitterbewegung was studied for a simplied version of the K ane model where the H H band [with dispersion E $_0$ (p) = E_g=2] and the split-o band $^{\rm Y}_7$ were neglected. In this limit, the K ane H am iltonian becomes similar to the D irac H am iltonian. Our analysis below shows that qualitatively new aspects arise when the H H band is taken into account.

Sim ilar to the D irac equation, the velocity operator v in the K ane m odel has a discrete spectrum . Each component of v has eigenvalues $2=3\,\mathrm{P}$ and 0, which correspond to (pure) electron, LH, and HH states. In general, for a wave packet containing a superposition of electron, LH, and HH states we have a nite probability to measure each of these discrete values. The components of the velocity v do not commute. We get

Note that Eq. (34a) implies that the minimum uncertainty depends on the dominant character of the wave function. The lower bound $P^2=6$ requires a LH state. For an electron state, the minimum uncertainty is $P^2=3$, whereas for a HH state it is $P^2=2$.

We omit here the lengthy expressions for r(t) and v(t). It follows from Eq. (33a) that the oscillating parts r(t) and v(t) of r(t) and v(t) depend on the frequencies

Unlike in the models discussed above, \mathbf{r}^2 (t) and \mathbf{v}^2 (t) in the K ane model are not diagonal in spin space. Hence

these quantities depend explicitly on time, oscillating with the frequencies given in Eqs. (35). However, we can estimate the magnitude of these quantities by neglecting the oscillatory terms and diagonalizing the resulting matrices. We get the following twofold-degenerate eigenvalues for \mathbf{r}^2 (t)

A Taylor expansion shows that for small mean velocities (\nonrelativistic lim it") we thus have two characteristic length scales for the oscillatory motion, the de Broglie wave length $^{\rm -}_{\rm B}$ and an elective Compton wave length $^{\rm 12}$

We have $^{\rm r}_{\rm K}$ ' 7 A in GaAs and $^{\rm r}_{\rm K}$ ' 40 A in InSb which should be compared with $^{\rm r}_{\rm D}$ = 3:9 $^{\rm r}$ 10 3 A.N ote that, in the nonrelativistic limit, the de Broglie wave length becomes a fourfold degenerate eigenvalue of ${\bf r}^2$ (t), i.e., it characterizes the oscillatory motion of electron, HH, and LH states. For large mean velocities (\relativistic limit"), the de Broglie wave length is the only length scale characterizing r(t). Similarly, we get for ${\bf v}^2$ (t)

O rbital angular m om entum L=r p and spin S also oscillate as a function of time. Similar to the D irac and Luttinger cases, these oscillations arise even though free particles are considered with no external or e ective magnetic eld present. However, the total angular momentum J=L+S does not oscillate as a function of time which, as always, rejects the fact that $[J;H_K]=0$.

VI. LANDAU HAM ILTONIAN

There are several remarkable similarities between the spin-dependent Hamiltonians discussed above and the well-known and rather simple case of the Landau Hamiltonian 26 describing the cyclotron motion of 2D electrons in the presence of a magnetic eld B $_{\rm Z}>0$ perpendicular to the 2D plane. The Landau Hamiltonian is given by

which should be compared with Eqs. (15) and (23). Obviously, in plications arising from this uncertainty relation become relevant only for su ciently large magnetic elds when $_{\rm c}$ becomes comparable to $_{\rm c}$.

The velocity V (t) is not a conserved quantity, which rejects the eject of the Lorentz force. We have

because, on average, the particle is at rest for B $_z$ θ 0. This also implies $[v_x; v_y] = 0$.

Our analysis indicates that the dynam ical properties of the Landau model bear strong resemblances to those exhibited by models showing zitterbewegung-like motion.

VII. LANDAU-RASHBA HAM ILTONIAN

An interesting example combining two types of oscillatory motion can be found by considering the interplay between 2D cyclotron motion (Sec.VI) and Rashba spin splitting (Sec.III). The Hamiltonian for that situation reads

(19b) and (41). For the following calculation we replace the components $p_{\rm x}$ and $p_{\rm y}$ of the kinetic momentum by creation and annihilation operation operators for Landau levels, $a^{\rm y}$ and a, defined in the usualway,

(56a) are rem in iscent of the oscillatory motion in the Rashba case for $B_z = 0$, where the amplitude of the oscillations is inversely proportional to the de Broglie wave length and independent of , see Eq. (22). Here these terms contribute to a spin-dependent renormalization of the cyclotron radius. We also note that R (t) = C, so that Eq. (45) remains valid in the presence of H $_{\mbox{\scriptsize R}}$.

(Note that [H $_{\rm cR}^{(1)}$; H $_{\rm cR}^{(2)}$] = 0.) This problem has been solved for the Jaynes-C um m ings model. 45,47 Translating into our situation, we get for the tim e-dependent position operator

VIII. CONCLUSIONS AND OUTLOOK

We studied a variety of qualitatively dierent model Ham iltonians for quasi-free electrons that exhibit zitterbewegung-like oscillatory motion. A number of features can be identied that are widely shared as discussed in Sec. I. Here we nally point out open questions.

For the D irac H am iltonian, the am plitude of the zitterbewegung of r (t) is given by the C om pton wavelength in the nonrelativistic lim it and by the de B roglie wave length in the relativistic lim it. For those H am iltonians having a gap that vanishes for p ! 0, the length scale of oscillations in r (t) is always given by the de B roglie wavelength $^{-}_{\rm B} = h = p$, independent of the magnitude of spin-orbit coupling. It is surprising that the am plitude of the oscillations of r (t) diverges in the nonrelativistic lim it p ! 0.

The most interesting but also, at least in our present work, a largely open aspect is the experim ental observability of zitterbew equng-like e ects. Certainly, any measurement of the oscillatory motion must obey the fundam ental uncertainty relations [Eq. (4)] discussed in our work. Furtherm ore, we have already comm ented on the intim ate relation between oscillations in position and spin space. However, while spin precession due to spin-orbit coupling can be observed experim entally, 25 it is often arqued that the zitterbewegung of r(t) \is not an observable motion, for any attempt to determine the position of the electron to better than a Compton wavelength must defeat its purpose by the creation of electron-positron pairs" (Ref. 5). We note that the same argument can be applied to Bloch electrons in solids where electron-hole pairs can be created.16
