## Shear ow induced isotropic to nem atic transition in a suspension of active laments

A bstract. { We study the elects of externally applied shear ow on a model of suspensions of motors and laments, via the equations of active hydrodynamics [PRL 89 (2002) 058101; 92 (2004) 118101]. In the absence of shear, the orientationally ordered phase of both polar and apolar active particles is always unstable at zero-wavenum ber. An imposed steady shear large enough to overcome the active stresses stabilises both apolar and moving polar phases. Our work is relevant to in vitro studies of active laments, the reorientation of endothelial cells subject to shear ow and shear-induced motility of attached cells.

The collective behaviour of suspensions of active particles  $(^{1})$  is fundam entally di erent from that of their passive counterparts, as highlighted by recent studies on hydrodynamic instabilities [1,2], rheology [3] and steady state patterns [4{6]ofactive particle system s. Recent experim ental studies on m odel system s such as m otor- lam ent extracts [7,8] and suspensions of sw im m ing bacteria [9{11] or sperm atocytes [12] have also reported strong departures from equilibrium behaviour.

O ne surprising prediction [1] is that, unlike in passive suspensions, long-range uniaxial orientational order in active Stokesian  $\binom{2}{}$  suspensions of polar particles is always destroyed by a hydrodynam ic instability. This is because the ow generated by a small, long-wavelength splay or bend deform ation in posed on an oriented con guration always acts instantaneously (in the Stokesian regim e) to further increase the deform ation [1,13].

If only this instability could be controlled, we would have an orientationally ordered phase of active particles with rather unusual rheological properties [13]. We already noted two dram atic rheological consequences [2,3]: (i) the orientationally ordered phase is characterised by a nonzero steady-state average of the deviatoric stress { a kind of yield stress { and (ii) on approaching the orientationally ordered state from the isotropic uid, a suspension of active contractile elements exhibits solid-like behaviour without translational arrest. However to obtain this novelm aterial we would rst need to stabilize this orientationally ordered phase.

In this paper we ask whether an imposed shear ow can suppress this instability of active Stokesian suspensions. We address this question by constructing a set of coarse-grained equations for the hydrodynam ics of the active particle suspensions. We consider apolar (nem atic) as well as polar order, keeping in m ind that the latter correspond to phases with a nonzero drift velocity of the active particles. Here is a sum mary of our results, valid in both 2 and 3 dimensions. (i) The instability obtained in [1] occurs for apolar ordered suspensions as well; (ii) Im posed shear larger than a critical strain rate  $_{\rm c}$  stabilises the orientationally ordered phase yielding a stability diagram (Fig.4) controlled by two variables, a ow alignment parameter and the the ratio of the shear to active stress. The drift velocity of the vector-ordered phase depends on \_ and . Possible experimental tests and some com plications regarding boundary conditions and back- ow are discussed at the end of the paper. We now turn to the details of our calculations.

(A) Hydrodynam ic equations : The hydrodynam ic variables for a suspension of active particles [1,3] are the total momentum density q = u of the particles + uid, where u is the hydrodynamic velocity eld and the density, the concentration c(r;t) of active particles, and the orientational order parameter eld. For polar system s, the order parameter is the polarisation vector p (r;t) of the force dipoles associated with the active particles. A ctive system s being out of therm al equilibrium, a local polarisation always in plies a local average drift velocity of the active particle relative to the uid. We thus take p to be the velocity eld of the active particles relative to the uid. A polar nem atic orientational order is characterised by a traceless symmetric tensor Q S (pp  $p^2$  (1=d)I), where p is now the director and S is the scalar nem atic order param eter [14]. We focus on the polar case, and indicate di erences where appropriate for the apolar case. M om entum conservation in the Stokesian lim it m eans a + r + d is the sum of contributions from = 0, where the total stress tensor r activity, order-param eter gradients and viscous dissipation, and overall incom pressibility of the suspension means r = 0, r = 0, the mean density.

The equations for the active polar order parameter p read

In (1), the nst three terms on the left are the material derivative of p (co-moving and co-rotating with the suspension) and the square brackets (as well as the term on the right) contain symmetry-allowed polar contributions [15] (of which the  $_1$  term alone [2] is active), nuled out in apolar nem atohydrodynamics, whether passive [14,16] or active [1]. The rst term on the right, together with the r u term on the left, lead to ow-alignment [14]. The relaxation dynamics is contained in the order-parameter molecular eld  $h = c(r;t) p j^2 p + K r^2 p$  which favours a xed length for p and assigns an elastic cost to inhom ogeneities in the one-Frank-constant approximation.

Conservation of active particles states




Fig.1 { Suspension of active vector ordered particles subject to an imposed velocity along the  $\hat{x}$ -axis,  $u_0 = -y\hat{x}$  with a gradient along the  $\hat{y}$ -axis. The shear alignment angle and the angle between the wavevector q and the ordering direction are also shown.

The reactive stress from order-param eter gradients is

where is a generalised pressure; and the viscous stress is  $d = \frac{1}{2} r u + (r u)^T$  A, where the bare shear viscosity of the suspension.

To determ ine the active stress, we make use of the fact that the simplest active particle, on long timescales, is a permanent force dipole [1,3]. To leading order the deviatoric part of the stress coming from activity is given by

where d is the spatial dimension, and the magnitude and sign of W characterise the nature of the elementary force dipoles [1,3].

Here we use this hydrodynam ic description to study the elect of shear ow on the ordering and stability of active particle suspensions.

(B) Shear ow : We impose a planar shear ow (Fig.1) along the  $\hat{x}$ -axis, with a velocity gradient along  $\hat{y}$ , giving rise to an imposed velocity eld  $u_0 = -y\hat{x}$ .

The instability of the orientationally ordered phase [1] and its stabilisation due to shear is most simply seen in two dimensions (d = 2); we therefore present detailed calculations in d = 2, and merely state results in d = 3.

We look for hom ogeneous steady states of (1), (2); the steady state concentration is a uniform  $c(r;t) = c_0$ . The amplitude and phase of the steady state active vector order parameter

are, respectively,

The ow alignment parameter can take values between 1 and 1, corresponding to =4. Note that while  $p_0$  increases with shear rate, the phase is independent of it.

(C) Stability of orientational order: To determ ine the stability of this hom ogeneous steady state, we set  $p(r;t) = p_0 (\cos ; \sin ) + p(r;t), u(r;t) = u_0 + u(r;t)$  and  $c(r;t) = q_0 + c(r;t)$ , where the perturbations are assumed small. It is convenient to decompose p and u paralleland perpendicular to the ordering direction  $p_0$ , e.g.,  $p = (p_k; p_2)$ , and to elim inate the \massive" eld  $p_k$  in favour of the remaining variables yielding, after a spatial fourier transform,

Fluctuations in the hydrodynamic velocity eld, u = 0, to linear order are governed by the Stokes equation. Imposing incompressibility and eliminating the pressure, eliminating  $p_{jj}$  in favour of the remaining elds as above, and fourier-transforming in space, we nd  $q_k = q_k \cos s + q_y \sin s$  to obtain,

We are now in a position to compute the full uctuation spectrum. While we have analysed the linear stability of the orientationally ordered phase in the basis spanned by u, p and c, we not that the origin of instability and its recovery by the shear ow can be understood even in the absence of the concentration equation. Thus, to make the subsequent analysis m ore transparent, we drop the concentration uctuation terms at the outset.

Following [1], we express the uctuation spectrum in terms of the splay uctuation =  $r_2 p_2$ , the in-plane expansion rate =  $r_2 q_2$ , and the angle made by q with the ordering direction:




Fig.2 { The growth rates (q = 0) versus 2 (angle between perturbing and the ordering direction), for either sign of activity W. Inset shows the induced ow lines arising from active rods subject to a ow.

This implies that the splay uctuations q have a growth rate




Fig. 3 { D ispersion curves versus q, for corresponding to maximum growth rate. The horizontal line corresponding to a frequency  $\frac{p}{2}$  1 1  $\frac{1}{4}$  denes the scale q beyond which uctuations are stabilised. As \_ increases towards \_c, the stabilisation scale goes to zero as  $(_ _c)^{1=2}$ .

First recall the generic instability when  $\_= 0$ : the oriented phase is always unstable, either to splay or to bend uctuations, depending on the sign of W [1]. This can be seen even at q = 0, where the growth rate  $_+(0) > 0$  for  $_{=}4 > ~ > ~ =4$  when W > 0, and  $_{=}(0) > 0$  for  $_{=}4 > ~ > ~ =4$  when W > 0, and  $_{=}(0) > 0$  for  $_{=}4 > ~ > ~ 3 = 4$ , when W < 0 (Fig. 2). The dispersion curve is shown in Fig.3 : uctuations with wavenumber  $q < q_0 / \frac{1}{2}$  grow in time; this sets the scale over which orientational order can be stabilised. Note that both the polar phase, as noted by [1], and the apolar nem atic as well, are generically unstable in the absence of shear. This is clear, since the polar term s containing f ig and in (1), do not appear in the grow th rate equation (3).

The imposed shear ow represented by a horizontal line \_ = const. in Fig.3, cuts this dispersion curve at q (\_), suggesting that uctuations whose scale is smaller than 1=q are the rst to be stabilised by the shear ow. Our estimate of q is qualitative : the crossover from -dom inated to \_-dom inated at nonzero q cannot strictly be evaluated in our treatment, since we dropped the  $q_k @q_y$  terms on the grounds that they wouldn't matter at q = 0 where the instability is fastest. As \_ is increased, q (\_) decreases, till at \_= \_c, this cuto scale m oves to zero, as  $q = (_ __c)^{1=2}$ . At this shear rate \_c, the oriented phase is completely stabilised by the shear ow. This de nes a stability boundary as a function of and W.




Fig. 4 { Stability diagram in the plane of A ctive Pecket number P  $e_a$  and ow-alignment parameter .

The stability phase diagram is best represented by de ning a dimensionless active Peclet number,  $Pe_a = 2 = j_V j_0$ , as the ratio of the imposed shear rate to the typical shear-rate produced around the active particles. As one crosses from the unstable to the stable region in the plane of  $Pe_a$  and ow-alignment parameter (Fig.4) the orientational order parameter sets in at the value given by Eq. (6), which in e ect gives a discontinuous transition since the

order parameter in the hydrodynamically unstable region is zero. For polar active particles, the shear-stabilized oriented phase has a nonzero drift of the particles with respect to the solvent.

Note that the critical shear rate required to stabilise the oriented phase  $\__c$  is larger for positive W than negative. This is consistent with our earlier observation [3], that the ow induced by the active stresslets, oppose the imposed ow when W > 0 and enhance it when W < 0.

(D) Shear ow induced stabilisation in d = 3: The calculation of the stability diagram is m one tedious in d = 3; how ever since the spirit is the same, we merely quote results and point out di erences. To start with, we note that  $p_0$ , the steady state orientational conformation in the presence of the shear ow  $u_0 = _y x$  is the same as (6), i.e., it still lies in the plane of the imposed velocity and its gradient (the xy plane). We then decompose the uctuations

in an appropriate orthonorm albasis, viz.,  $p = (p_k; p_2; p_z)$ , where  $p_k = p_1, p_2 = p_2$ 

 $p (2(p_0))$  and  $p_z = p (2)$  (similarly for g). A substitution we ignore concentration uctuations. Once again,  $p_k$  is massive, and we rewrite the order parameter uctuations in term softhe

in-plane splay  $_{?} = r_{?} p_{?}$  and  $_{z} = r_{z} p_{z}$ . Similarly invoking incompressibility, we rewrite the momentum uctuations as the in-plane expansion rate  $_{?} = r_{?} g_{?}$  and  $_{z} = r_{z} g_{z}$ . E liminating the momentum uctuations via force-balance, we not that the resulting linearised dynamical equations for  $_{?}$  and  $_{z}$  give rise to an eigenvalue spectrum qualitatively resem – bling (3). Thus even in d = 3, one may de ne a stability phase diagram in the Pe<sub>a</sub> plane; a large enough shear rate stabilises an orientationally ordered phase.

Note that the vector-ordered phase has a non-zero drift velocity  $v_d$ , with a magnitude proportional to  $c_0 p_0$  (6). This macroscopic particle current will result in a counter solvent ow of the same magnitude.

Experimental realisations in a planar shear ow geometry will necessarily have to contend with nite boundaries; it is therefore important to specify boundary conditions for the active order parameter p. This is especially important in the polar case, since the local polarisation implies a local average drift velocity of the active particle relative to the uid. A ssum ing the active particles cannot penetrate the walls, p m ust be tangent to the con ning walls (the hom ogeneous boundary conditions of liquid crystal physics). In plane C ouette ow, how ever, this is at odds with the ow-alignment requirement of pointing at an angle to the suspension velocity as in Eq. (6). This con ict must be resolved by a boundary layer in p at the walls. The case of wall-norm al (hom eotropic [14]) alignment will be discussed elsew here.

In conclusion we have shown how to stabilise the orientationally ordered phase of an active particle suspension by in posing a uniform shear ow. We have determ ined the nonequilibrium phase diagram in the plane of \active Peclet number" and ow-alignment parameter. This sets the stage for a study of the unusual rheological features of this shear-stabilised oriented phase of active matter [13]. In a forthcoming submission we will use this framework to study the dynamics of reorientation of endothelial cells subject to shear ow [17].
