### Super uid Suppression in d-W ave Superconductors due to D isordered M agnetism

The in uence of static magnetic correlations on the temperature-dependent super uid density  $_{\rm s}$  (T) is calculated for d-wave superconductors. In self-consistent calculations, it inerant holes form income mensurate spin density waves (SDW) which coexist with superconductivity. In the clean limit, the density of states is gapped, and  $_{\rm s}$  (T  $_{\rm Tc}$ ) is exponentially activated. In inhom ogeneously-doped cases, the SDW are disordered and both the density of states and  $_{\rm s}$  (T) obtain form sindistinguishable from those in dirty but pure d-wave superconductors, in accordance with experiments. We conclude that the observed collapse of  $_{\rm s}$  at x  $_{\rm 0.35}$  in underdoped YBacCu<sub>3</sub>O  $_{\rm 6+x}$  m ay plausibly be attributed to the coexistence of SDW and superconductivity.

## I. IN TRODUCTION

High tem perature superconductors (HTS) are an ideal class of materials with which to study electronic correlations in superconductivity because the correlations can be tuned from weak to strong via chemical doping. A consequence of strong-correlation physics is that the BCS theory of conventional superconductors fails to describe HTS.Uem ura dem onstrated that, unlike in BCS theory where the super uid density s and critical tem perature T<sub>c</sub> are independent, HTS exhibit an approxim at scaling  $_{\rm s}$  /  ${\rm T_c}^1$ . The physical origin of the Uem ura relation is not known conclusively but is consistent with strongcorrelation m odels<sup>2,3,4</sup> in which the quasiparticle spectral weight, and consequently s, are proportional to the hole concentration p, where p is measured relative to the M ott insulator phase. However, these models fail to explain both the collapse of superconductivity at a nonzero dop-0:05 and the breakdown of the Uemura relation ing p<sub>c</sub> near  $p_c$ , shown by recent experiments in YBa<sub>2</sub>Cu<sub>3</sub>O<sub>6+x</sub> (YBCO)<sup>5,6</sup>.

A number of authors  $^{7,8}$  have suggested that  $T_{\rm c}$  is governed by phase uctuations, possibly in combination with quasiparticle excitations<sup>9</sup>, and in particular that the rapid collapse of  $_{\rm s}$  and  $T_{\rm c}$  at  $p_{\rm c}$  can be thus explained<sup>10</sup>. In this work, we exam ine a completely different mechanism : the suppression of super uidity by the form ation of static magnetic moments. This is motivated by a substantial body of experim ental evidence for the presence of quasistatic magnetism in underdoped HTS.<sup>11,12,13,14,15,16,17,18,19</sup> There have been previous suggestions that some form of competing order is important in the underdoped  $HTS_{r}^{20,21,22,23}$  and in particular there have been num erous studies of the competition between d-wave superconductivity and commensurate antiferrom agnetism .<sup>24,25,26,27,28</sup> These are generally di cult to reconcile with super uid density measurements largely because the competing order introduces an identi able energy scale. Calculations show that this energy scale appears in the tem perature dependence of the super uid density  $2^{9,30,31}$  but such an energy scale has not been observed experim entally<sup>31</sup>. Indeed, recent m icrow ave conductivity m easurem ents<sup>6</sup> of the super uid

 $_{\rm s}$  (T ), in high quality single depletion,  $_{s}(T)$ <sub>s</sub> (0) crystals of YBCO nd  $_{\rm s}$  (T) / T with a crossover to  $_{\rm s}$  (T) / T<sup>2</sup> when T T<sub>c</sub>. The linear T-dependence is expected in a single-phase d-wave superconductor and the low-T crossover to T<sup>2</sup> behavior has been attributed to residual in purity scattering. It is therefore not a priori clear that the experim entally observed m agnetic m oments have any signi cant e ect on the electronic spectrum. Here, we show that a phase of coexisting spin density wave (SDW) and d-wave superconducting (dSC) order can, provided the SDW is disordered, have a spectrum indistinguishable from that of a dirty dSC .W e conclude that the rapid collapse of super uid density near  $p_c$  could indeed be due to magnetism .

Our approach is sem i-phenom enological. We construct a mean-eld model in which the model param eters are assumed to have been dressed by electron interactions. The approach is motivated by a variety of calculations, 2,3,24,32,33,34 mostly for the t-J model, in which mean-eld theories are developed for which the parameters are functions of p. In the simplest G utzw iller approximation for the t-J m  $odel_{r}^{34}$  for example, the renormalized kinetic energy operator  $\hat{T}$ is related to the bare kinetic energy operator  $\hat{T}_0$  by  $\hat{T} = \hat{T}_0 2p = (1 + p)$ : O ther results are found in other approximations,<sup>2,3,24,32,33</sup> but all show the same qualitative result that  $\hat{T}$  is reduced as one approaches the M ott insulating phase. In dynam icalm ean- eld theory calculations, this derives from a self-energy which renorm alizes both the quasiparticle spectral weight and e ective m ass.<sup>35</sup> W e remark that the e ective interactions are also expected to depend on the doping, generally increasing as p is reduced. This is ignored in our calculations since it will have a quantitative but not qualitative e ect on the outcom e. The essential physics in the current discussion is that, near the magnetic phase boundary a small change in the mean-eld parameters produces a much larger change in the magnetic state. The progression from pure dSC to pure magnetic order depends only on the general trend that the ratio of kinetic to interaction energies decreases as p decreases.

In section II we introduce the model and describe the phase diagram. The most signi cant result of this section is that it is possible to have substantial incom mensurate m agnetic m om ents coexist with the superconductivity, with very little suppression of the pair am plitude. This is in contrast with the m ore widely studied case of com – m ensurate m agnetic order, which suppresses superconductivity rapidly.<sup>24,25,26,27,28</sup> In section III, we calculate both the density of states and the super uid density for the incom m ensurate phases. As m entioned previously, we nd the supprising result that when the m agnetic m om ents are disordered, the spectrum is indistinguishable from that of a dirty d-w ave superconductor. W e conclude brie y in section IV.

### II. MODEL AND PHASE DIAGRAM

The HTS consist of conducting two-dimensional CuO<sub>2</sub> layers that are weakly coupled along the perpendicular direction. We model the lower Hubbard band of a single two-dimensional layer with an extended Hubbard model, treated at a mean-ekd level. Our numerical calculations have found that the results are only weakly dependent on the lling p but depend sensitively on the quasiparticle bandwidth and Ferm i surface curvature. As discussed above, we assume that doping e ects occur indirectly through a parameter w (p) which renorm alizes the quasiparticle dispersion. For sim plicity, and since the detailed relationship between w and p is not established, we will treat w as the independent parameter, and keep all other parameters xed.

C alculations are for an N -site two-dimensional tightbinding lattice with periodic boundary conditions and lattice constant  $a_0 = 1$ , sim ilar to one used previously to study the local density of states in underdoped HTS<sup>36</sup>. The Ham iltonian is




FIG.1: (Coloronline) Phase diagram as a function of kinetic energy renorm alization. Open symbols are for the hom ogeneously doped calculations, closed triangle and + symbol are for inhom ogeneously doped calculations. Inset: Ferm i surface and CSDW nesting vector.

where tij are the hopping matrix elements of the tightbinding band, i and j are site-indices, is the electron spin, and — . We take  $t_{ij} = t_0$  for i = j and  $t_{ij} = t_n, n = 1; \dots; 3$ , for nth nearest-neighbor sites i and j. Taking  $ft_0$ ;:::; $t_3g = f1:7$ ; 1;0:45; 0:1g gives the Ferm i surface shown in Fig. 1. The local electronic  $h\hat{n}_i$  i, where  $\hat{n}_i = c_i^y c_i$ , is determined density n<sub>i</sub> self-consistently and the hole density is  $p_i = 1 \quad n_i$ . The m agnetic order parameter is then m  $_{i} = (n_{i^{"}} n_{i^{\#}})=2$ , and the staggered m om ent is  $m_i^Q = (1)^{\kappa_i + \gamma_i} m_i$  where  $r_i =$ (x<sub>i</sub>;y<sub>i</sub>) is the coordinate of site i. The nearest neighbor pairing term  $_{ij} = \frac{J}{2} h f_{ij} i$ , with  $f_{ij} = (c_{j\#} c_{i"} g_{"} c_{i\#}) = 2$ is also determined self-consistently and has pure dSC symmetry,  $ij = \frac{1}{4}$  ( 1)<sup>y<sub>j</sub> y<sub>i</sub>, in the nonmangetic phase.</sup>

To allow for inhom ogeneous doping we add dopantim purity and Coulom b interaction term s, also treated at the mean- eld level:

with  $n_i = \int_{-\infty}^{-\infty}$  $n_{\rm i}$  , Z the impurity charge, R  $_{\rm v}$  the locations of the N  $_{\rm I}\,$  impurities, and V (r) =  $e^2e^{-r=}$  =  $a_0$  a weakly-screened C oulom b interaction, with  $e^2 = a_0 = 1.5$ =  $20a_0$ . In the cuprate HTS, donor impurities and typically sit a few A above the CuO<sub>2</sub> layers, so we random ly choose values of  $R_{i} = (x_{i}; y_{i}; d)$  with  $d = a_{0}$ . The total hole doping is  $p = Z N_I = N$ . We study a homogeneously doped case with  $N_{T} = N$  and  $Z = p_{I}$  and an inhom ogeneously doped case at the same lling with  $N_{I} = N = 4$  and Z = 4p. The resulting in purity potential is sm oother than one expects in m any underdoped HTS but is reasonable for underdoped YBCO where approxim ately 35% of chain oxygen sites are lled. It is assumed that strong-correlation renorm alizations of V, J and U are included in plicitly and rem ain constant over the narrow doping range explored here; for a given p, we choose J and U such that w = 1 corresponds to a pure dSC phase close to the magnetic phase boundary. We then follow the magnetic phase diagram, Fig. 1, as w is reduced. The results depend sensitively on the Ferm isurface shape (ie. on t<sub>2</sub> and t<sub>3</sub>), but depend only weakly on p which is therefore chosen for com putational convenience. W e have studied the parameter sets (p;U;J) = (0:05;3:4;1:8) and (p;U;J) = (0:35;3:2;1:5). The two agree sem iquantitatively where we have been able to com pare; how ever, it is di cult to obtain converged solutions for p = 0.05when w is small, and we have chosen to present results for p = 0.35 where a full set of results is available.

The calculations proceed as follows. The H am iltonian, written  $\hat{H} = c^{y}Hc$  with  $c^{y} = [c_{1}^{y} ::::c_{N}^{y} :c_{1\#} ::::c_{N\#}]$  and H a H erm itian matrix, is diagonalized numerically giving the unitary matrix U of eigenvectors and eigenvalues  $E_{n}$ .




FIG.2: (Color online) Typical self-consistent solutions. The staggered magnetization is shown for the CSDW phase at w = 0.85 (a,b) and the DSDW phase at w = 0.8 (c,d) with hom ogeneous (a,c) and and inhom ogeneous (b,d) doping; The magnetization (e) and dSC gap (f) are shown for w = 0.78 with inhom ogeneous doping. Inhom ogeneous results are for a single dopant con guration.

are iterated until the largest di erence between successive values of  $_{ij}$  and  $n_i$  is less than 10<sup>4</sup>. At convergence, the total energy is typically varying in the tenth signi cant gure. Convergence is di cult to obtain: rst, the charge density oscillates wildly in simple-iteration schemes because of the Coulomb interaction and, second, them agneticm on ent con guration may fail to converge because the energy near self-consistency depends only weakly on it. A signi cant e ort has been m ade to address both these issues. First, we have generated our initial guess for the local charge density using a self-consistent Thom as Ferm i calculation. In order not to bias the outcom e of the calculation we have used 8-16 random ly seeded initial magnetic moment con gurations for each parameter set, from which the lowest

energy self-consistent solution is retained. Second, we have adopted a Thom as Ferm i-Pulay iteration scheme, $^{37}$  which controls the iteration instability in most cases. Results shown here have all converged.

The phase diagram is shown in Fig. 1. For large w, there is a pure dSC phase. As w is reduced, there is a second order transition into a coexisting phase of dSC and checkerboard SDW (CSDW) order at w 0:95, followed by a rst order transition into a phase of coexisting dSC and diagonalSDW (DSDW) order at w 0:81; both phases are illustrated in Fig. 2. Superconductivity is destroyed at w 0:76. From Fig.2, one sees that doping-induced inhom ogeneity disorders the SDW and has a signi cante ect on the phase diagram in the dSC + D SDW phase: a typical solution for w = 0.78, shown in Fig. 2 (e,f), consists of an inhom ogeneous mixture of pure SDW and dSC + SDW order, with superconductivity preferentially form ing in hole-rich regions. The spatially-averaged varies considerably between dopant con qurations, as seen in Fig.1, but within superconducting domains, the local order parameter is consis-0:5; the destruction of superconductivity tently j<sub>ii</sub>j occurs inhom ogeneously.

W e can understand the origin of magnetic order in the CSDW phase; the Fourier transform m (q) of m<sub>i</sub> has a set of four peaks at ( ) and the inset to Fig.1 ; ) taken from the data shows that the vector ( ; in Fig.2(a) connects nodal points on the Ferm is  $urface^{38}$ . The CSDW, therefore, nests portions of the Ferm i surface where the pairing energy is small, and consequently m in im izes competition between magnetic and dSC order. This explains why is roughly constant throughout the dSC+CSDW phase (c.f. Fig. 1), and why the transition to the dSC + D SDW phase appears to occur only when the magnetic energy scale M Umax(jn, j) is greater than . It appears, then, as if C SD W ordering is stabilized by superconductivity. An analysis of m (q) for the DSDW, in contrast, does not reveal any nesting of high-sym m etry points, and collapses rapidly in the dSC + D SDW phase.




FIG.3: (Color online) Phase diagram for com mensurate order. Here, U = 3.6 while other parameters are as given in the text.

These results are in striking contrast to what one nds for the case of commensurate magnetic or-We show, in Fig. 3 the results of calculader. tions for the antiferrom agnetic moment  $m_z$  and the dSC order parameter determined self-consistently in the homogeneous limit. F igure 3 shows that the dSC and antiferrom agnetic order parameters are generally incompatible, with only a small coexistence region. More extensive studies of the phase diagram with commensurate order by K yung<sup>26</sup> show that the size of the coexistence region depends on the model parameters, but that the antiferrom agnetic and dSC order always suppress one another. By contrast, the CSDW order has very little e ect on the dSC phase.

# III. DENSITY OF STATES AND SUPERFLUID DENSITY

Because of the nodal nesting, the density of states  $(\mbox{DOS})$




FIG. 4: (Color online) Density of states. N (!) is shown for hom ogeneous (top row) and inhom ogeneous (bottom row) doping. Inhom ogeneous results are for a single dopant con guration, except for w = 0.78 which is averaged over 5 con gurations. The single-particle gap and subgap resonance at ! 0 are indicated.

develops a gap of width in the dSC+CSDW phase, as shown in Fig. 4. In contrast, the dSC+DSDW phase retains the characteristic d-waveDOS,N (!) / j! jat low !, but develops a resonance at !<sub>0</sub> which in m any cases dominates the spectrum. In both cases, these qualitative di erences from the pure dSC DOS are rejected in  $_{\rm s}$  (T).

The super uid density is related to the magnetic penetration depth (T) measured in experiments by  $_{s}(T) = mc^{2}=4 e^{2} (T)$ . In linear-response theory,  $^{2}(T) = (4 e^{2}=c^{2}) hK^{dia}(T) K^{param}(T) i = _{x,y} w ith$

where M and ~ are the inverse elective mass tensor and current vertex respectively, written in the basis of eigenstates of the H am iltonian. On a tight-binding lattice, M<sup>1</sup>l<sub>ij</sub> =  $t_{ij}$ ~  $\underline{r}_{j}r_{ij}$  ~ and [  $l_{ij}$  = i~  $\underline{r}_{j}t_{ij}$  with ~ and ~ the unit vectors  $\hat{x}$  or  $\hat{y}$  and  $r_{ij}$  =  $r_i$   $r_j$ . The calculations are restricted to low T where we can use the T = 0 values for  $_{ij}$  and  $n_i$ ; the T-dependence of  $_s$  (T) is due to therm all pair breaking, as has been argued in Ref. [2]. We discuss this assumption below.




FIG.5: (Coloronline) Super uid density.  $_{\rm s}$  (T) is plotted for hom ogeneous (a) and inhom ogeneous (b) doping. Dierent curves for w = 0:78 in (b) correspond to dierent random lygenerated im purity potentials. Inset: low -T behavior of  $_{\rm s}$  (T) for hom ogeneous (solid) and inhom ogeneous (dashed) doping. Results in (b) are con guration-averaged over 2-4 sam ples, except for w = 0:78 where results are shown for each con guration.

We focus rst on hom ogeneous doping, Fig.5(a). The super uid density at T = 0 is a strong function of w, especially in the dSC+DSDW phase;  $_{\rm S}(0)$  is reduced to 10% of its initial value with only small changes in the coherence peak energy in the DOS. While this is consistent with experiments, the T-dependence of  $_{\rm S}(T)$  is

not. In the dSC+CSDW phase,  $_{\rm s}$  (T) is exponentially activated:  $_{\rm s}$  (T) / exp(T=), where is the single-particle gap shown in Fig.4. In the dSC+DSDW phase,  $_{\rm s}$  (T) is linear in T, but also has an exponential contribution from the resonance at !<sub>0</sub>, also shown in Fig.4. In m ost cases we have studied the exponential contribution is dom inant.

The inhom ogeneously-doped calculations are qualitatively di erent. The electronic potential produced by doping is itself weakly scattering and has little direct effect on nodal quasiparticles<sup>39</sup>; however, it disorders the SDW , and indirectly does have a signi cante ect on the low -! DOS. As seen in Fig. 4, characteristic features of the di erent SDW phases are washed out and N (!) universally obtains a dirty-d-wave form . This is one of the main results of this work. Not surprisingly,  $_{\rm s}$  (T) also obtains the dirty dSC form ; as shown in Fig. 5 (b) and in the gure inset,  $_{\rm s}({\rm T})$  /  ${\rm T}^2$  for T  $T_{c}$ , and is linear in T at larger T. In general, <sub>s</sub>(T) varies weakly between disorder con gurations. The notable exception is near the superconducting phase boundary (ie. w = 0.78) where  $_{\rm s}$  (0) depends strongly on disorder con guration, although  $_{\rm s}$  (T) remains quadratic in T. In macroscopic samples, this will be re ected as a sensitivity to both sample quality and doping. The remarkable aspect of Fig. 5(b) is that, even for a magnetic energy scale Μ 2 (at which point  $_{s}(0)$  is near zero),  $_{s}(T)$  has the appearance of a dirty but pure dSC, as seen in experiments. This constitutes our main nding.

The mechanism by which the super uid density is depleted is quite interesting. The diamagnetic response, K  $^{dia}$ , is almost independent of both w and the magnetic

m om ent: how ever, the param agnetic response at T = 0, K <sup>para</sup> (0), is a strong function of the magnetic m om ent. T his is rem iniscent of the response to disorder in d-wave superconductors where C ooper pair breaking by in purity scattering m anifests as a nonzero K <sup>para</sup> (0). In this case, how ever, the broken C ooper pairs are also apparent as a

nite residual density of states at the Ferm i level. A disorder level su cient to cause a 90% reduction in  $_{\rm s}$  (0), as we have found here, would produce a residual density of states comparable to that of the norm al state. The fact that such a residual density of states is not observed in our case illustrates that the SDW correlations are not simply breaking C ooper pairs.

R ather, it is the fact that C ooper pairs in the magnetic phase do not have a well-de ned charge-current which is responsible for the suppression of  $_{\rm s}$  (0). In the commensurate (four-band) case, the current operator is

with  $v_x = 0$  k=0kx and 0 the Paulim atrix. This matrix is not diagonal in the basis of Bogoliubov quasiparticles (ie.  $\sim_x (k)$ ) is not diagonal), meaning that the current is not conserved. Physically, this is because the Bogoliubov quasiparticles are form ed from mixtures of states with crystal momenta k and k + Q. Then, because  $\sim_x (k)$  has nonzero o -diagonal matrix elements, there is a nonzero interband contribution in Eq. (11) which reduces the overall super uid density. We stress that this mechanism is distinct from either pair-breaking or quasiparticle renorm alization (ie. strong-correlation) mechanism s for reducing the super uid density.

We nish with a comment on the relationship between  $T_c$  and s(0). An estimate of  $T_c$  as the temperature at which a straight line, tted to the region T > 0:1 in Fig. 5(b), crosses the T-axis yields  $T_c$ 0:36, for all w. This is surprising, as it indicates that even for strongly inhom ogeneous cases  $T_c$  is determined by the maximum, rather than average, . It also suggests that two physical processes neglected in our calculations, phase uctuations and glassy SDW dynamics, may play an important role at higher T. In particular, phase uctuations are expected to be pronounced at sm all w where the superconductivity is spatially inhom ogeneous. G lassy spin dynam ics, provided they remain slow on electronic time scales, behave as quenched disordering of the SDW , and should not change our results qualitatively. An interesting question, outside the scope of this work, is how the SDW dynamics a ect  $_{s}$  (T) at higher doping, where a gap in the spin-wave spectrum begins to appear. In summary, it seems likely that, as suggested in Ref. $, T_c$ is ultimately determined by a combination of phase and quasiparticle excitations.

#### IV. CONCLUSIONS

In conclusion, we have shown that incommensurate magnetic correlations which nest the nodal points of the Ferm isurface may coexist with d-wave superconductivity with essentially no suppression of the superconducting order. Furtherm ore, the form ation of quasistatic moments is a plausible explanation for the rapid suppression of super uid density near p in YBCO.We in that, provided the spin density waves are disordered, both the single-particle spectrum and  $_{\rm s}$  (T) are indistinguishable
