Multiple time-scale approach for a system of Brownian particles in a non-uniform temperature eld.

The Sm oluchowsky equation for a system of interacting Brownian particles in a temperature gradient is derived from the K ramers equation by means of a multiple time-scale method. The interparticle interactions are assumed to be represented by a mean-eld description. We present num erical results that compare well with the theoretical prediction together with an extensive discussion on the prescription of the Langevin equation in overdam ped system s.

I. IN TRODUCTION

The erratic motion of tiny particles suspended in a uid of lighter particles is a known phenomenon, going under the name of Brownian motion, of fundamental interest in Statistical Mechanics^{1,2,3}. A classical method to study this physical process is the Langevin equation, where the in uence of the solvent particles on the heavier particles is modeled by two force terms. One term represents a viscous force, with friction coe cient , the other a stochastic force, whose intensity depends on the tem perature of the solvent. A lternatively, the description of the dynamics of a system of Brownian particles in an external eld may rest upon the Fokker-Planck equation (FPE) for the probability density of the particles. The two levels of description, namely, a) the K lein-K ramers equation⁴, which considers the evolution of the probability density of position and velocity, and b) the Sm oluchowski equation⁵, for the probability distribution of position only, have deserved a great deal of attention. The passage from the rst description to the second one is well understood for the case of ideal non-interacting particles in mersed in a heat bath at constant temperature. In fact, as shown by W ilem ski and T itulaer⁶, the derivation of the Sm oluchow ski equation from the K ram ers-K lein equation, can be performed by means of a perturbation expansion in terms of the inverse of the friction coe cient, . O n the other side, one can derive the Sm oluchow ski equation more directly after taking the overdam ped lim it

! 1 in the Langevin equation and neglecting the inertial acceleration term. Physically speaking, this procedure corresponds to the fact that the velocities of the particles therm alize rapidly, so that only the probability distribution of positions of the particles m atters.

Them al gradients, besides causing a heat ow, can induce a mass ow in systems such as colloids. The phenom enon is term ed therm odi usion, therm ophoresis or Ludwig-Soret e ect^{7,8,9,10,11,12,13} and is relevant because it represents a tool to manipulate and concentrate molecules in solution. Them ophoresis, in fact, typically enhances the concentration in colder regions. Recently, it has been employed to form two dimensional colloidal crystals using 2 m polystyrene beads. Such a method leads to applications in micro limiton, particle accumulation and molecular detection on surfaces¹⁴. Nevertheless, in spite of its technological interest, not many studies provide a derivation of the governing equation for the concentration eld in the presence of a temperature gradient externally imposed. A problem arises when one considers the ! 1 limit: the resulting stochastic equation contains a multiplicative noise term (the temperature is space-dependent). This in turn means that the associated FPE depends on the particular prescription used to derive it, i.e. one encounters the so called Ito-Stratonovich dilem ma. To solve it, M atsuo and Sasa¹⁵ recently obtained the Sm oluchow ski equation from a perturbation expansion in powers of the inverse of . Two important messages arise from their work: rst, the underdamped dynamics is free from the Ito-Stratonovich dilem ma, and, second, their perturbation scheme is unbounded in time and one needs a renorm alization treatm ent to make it convergent.

The main objective of this work is to present a system atic and convergent derivation of the Sm oluchow skiequation for a system of interacting B rownian particles in a temperature gradient. The interaction is of mean-eld type, so that our starting point, the K ramers equation, can be written down in close form for the one-particle distribution function. We employ a multiple time-scale method which has been designed to deal with non-uniform ities in system s with more than a time scale. The approach is quite appropriate for our objectives, since in the large friction lim it there is a very clear time-scale separation in the system : in a very short period the velocities of the particles relax to their thermal equilibrium value, whereas on a much longer time scale also the positions of the particles assume con gurations compatible with their steady state distribution. In this regard, the multiple time-scale method has been used to perform the passage from the K ramers to the Sm oluchow skiequation for an ideal gas at constant temperature as an expansion in powers of the small parameter 1 , providing a uniform ly valid result^{16,17}. More recently, the case of interacting hard-core particles in isotherm all systems has also been studied within this framework¹⁸.

A nother in portant part of this work is the discussion about the Ito versus Stratonovich description of the system. This is based on num erical results of the Langevin dynam ics.

The plan of this paper is the follow ing: in section II we present the full Langevin equation, its overdam ped lim it, and the corresponding K ram ers and Sm oluchowski descriptions of the system. In section III the derivation of the Sm oluchowski equation with the multiple time-scale method is presented. In section IV we present the numerical results, with some discussion on the di erent Ito-Stratonovich prescriptions, and in section V we give our conclusions.

II. M ICROSCOPIC MODEL.SMOLUCHOW SKIAND KRAMERS EQUATIONS.

Let us consider a system of N interacting B rownian particles of mass m in an external force eld. For the sake of simplicity, let us assume only one spatial dimension. The system is also under the in uence of an external non-uniform temperature eld so that the dynamics of the particles is given by:

for i = 1;:::;N, and where is the friction coecient, T is a non-uniform heat-bath temperature, f_{ext} is an external force, f_{int} is the interaction force between pair of particles, and $_i$ (t) is a G aussian white noise with zero average and correlation

h i indicates the average over a statistical ensemble of realizations, and \underline{k} is the Boltzm ann constant. To study the dynam ics of the system we consider the single particle probability distribution function, P (x_i ; v_i ;t), of the position and velocity variables. Its evolution is given by the Fokker-P lanck equation¹ also known as K ram ers equation:

Here $f_m(x)$ is the molecular eld which takes the form

being U (jx x^0) the pair potential energy (i.e. $f_{int}(x_i x_j) = \frac{@U(x_i x_j)}{@x_i}$), and (x) = $R^{R} dvP(x;v;t)$. It is very in portant to realize under what conditions on the interparticle interactions one can write down eq. (3) (see¹⁸). Note that with no approximations the K ram ers-FPE for interacting particles for the one-particle distribution function, P(x;v;t), depends on the two-particle distribution $P_2(x;v;x^0;v^0;t)$. The main hypothesis done in Eq. (3) is that whenever U (x x⁰) is a smooth function of particle separation one may assume a mean-eld approximation for the two-particle distribution $P_2(x;v;x^0;v^0;t)$. In the following we shallde nef = $f_{ext} + f_m$.

Since the temperature T (x) in Eq. (3) multiplies a derivative with respect to v, one realizes that the K ram ers equation is free from the so called Ito-Stratonovich dilem m a. On the contrary, when one considers the overdam ped lim \pm , ! 1, in Eq. (1) one obtains the following Langevin equation:

which leads to di erent equations for the distribution of the spatial position (the so-called Sm oluchowski equation) depending on the prescription adopted to integrate the stochastic evolution. In fact, the corresponding FPE for Ito and Stratonovich conventions, the two rules usually applied, are respectively:

The aim of this work is to derive a Sm oluchow ski equation for the system using the multiple time-scale method, via an expansion in the inverse of the friction coe cient. Our starting point is the K ram ers equation, Eq. (3). At this stage it is convenient to introduce the following dimensionless variables:

being $v_{T_0} = \frac{p}{k_B T_0 = m}$ the therm alvelocity at the reference tem perature T_0 (which can be taken equal to 1), and l is a typical length scale of the system, for example the elective radius of the particles. The non-dimensional K ram ers equation for P(X;V;) denoting, T(X) = T(x), is:

In the following we shall skip the tildes in our notation. The (non-dimensional) K ram ers equation, Eq. (10), is our de nitive starting point and in the next section we proceed to present the set of eigenfunctions that will be used in the subsequent section when we make use of the multiple time-scale approach.

III. METHOD OF SOLUTION

Standard solutions of Eq. (10) go through an expansion in a basis set of eigenfunctions. First, it is convenient to separate the spatial dependence from the velocity dependence of the probability distribution. We rew rite Eq. (10) as:

We will expand P in term softhe eigenfunctions H (X;V) of L_{FP} ¹⁵ which are related to the Herm ite polynom ials:

We now express the solutions to Eq. (11) as a linear combination of products of the type (X;)H(X; V) and after some algebra obtain:

where the prime denotes derivation with respect to the argument. Equating the coecients of the same basis functions, H, we obtain an in nite hierarchy of equations relating the various moments (X;). Such a hierarchy can be truncated by the multiple scale method, as shown hereafter.

A. Multiple tim e-scale analysis

In the multiple time-scale analysis one determ ines the tem poral evolution of the distribution function P (X;V;) in the regime 1 < < 1 by m eans of a perturbative m ethod.

In order to construct the solution one replaces the single physical time scale, , by a series of auxiliary time scales (0; 1; ::; n) which are related to the original variable by the relations n = n. A loo the original time-dependent function, P(X;V;), is replaced by an auxiliary function, $P_a(X;V;_0;_1;::)$, depending on the n, which are treated as independent variables. Once the equations corresponding to the various orders have been determ ined, one returns to the original time variable and to the original distribution.

We begin by replacing the time derivative with respect to by a sum of partial derivatives:

Each term $P_a^{(s)}$ is then projected over the eigenfunctions H ,

At this stage one substitutes the time derivative (16) and expressions (17)-(18) into Eq. (10), and identifying terms ¹ in the equations one obtains a hierarchy of relations between the amplitudes ^(s). The of the sam e order in advantage of the method over the naive perturbation theory is that secular divergences can be eliminated at each order of perturbation theory and thus uniform convergence is achieved.

The most important function in all this expansion is $_{0}^{(0)}$. Its physical meaning becomes clear if one integrates over V the auxiliary density probability function $P_a(X;V;_0;_1;_2;...)$. Assuming, as in the standard expansion, that $\binom{0}{0} = 0$ for 1 one sees that $\binom{0}{0}$ is the spatial density probability function. We shall consider the partial derivative, (0, 0), and obtain the evolution equation for (0, 0) to order i. For the sake of completeness we brie y show how the method works. To order ⁰ one nds:

By iterating the method we obtain the correction of order 1 to the evolution equation of $^{(0)}_{0}$, which reads

F inally, we recover the original time variable, , and obtain the most important result of this work, that is, the evolution equation for the spatial probability density:

W ith O (1=2) we mean terms of or 1=2 and superior. The rst comment that arises from Eq. (26) is that it is of the Ito type if one uses this prescription for the overdam ped Langevin equation. However, here we did not use any prescription for the Langevin equation, and Eq. (26) was derived from an expansion of the K ram ers equation. M oreover, the generalization of Eq. (26) to arbitrary spatial dimensions is straightforward.

U sing a more usual notation for the spatial density probability function, and following the line of reasoning of M arconi and Tarazona¹⁹, one could write the following governing equation

where D (x) = $k_B T (x)=m$ and F_{ni} is the excess over the ideal gas contribution to the free energy²⁰. The second term renorm alizes the elective di usion constant of the particles and may become important at higher concentrations.

In the next section we proceed to check num erically our results and to enter in a possible discussion about the Ito-Stratonovich dilem m a.

IV. NUMERICAL RESULTS

This section is devoted to num erically check our analytical results. The way to proceed is to compare the results of num erical simulations of a system of N particles following the dynamics given by Eqs. (1) or rather Eq. (5). We shall compare these with the analytical solution, if available, of the corresponding density equation: Eq. (26) for the rst case, or the Sm oluchow ski in the Ito and Stratonovich prescriptions, Eqs. (6-7), for the second case.

In order to obtain a simple analytical solution of the density equation we assume a vanishing external force and m olecular eld, F = 0, particles have m assone, the system is one-dimensional and particles positions restrict to the interval [0;1]. We also assume that the temperature eld has a linear spatial dependence T (X) = $T_0 + T_1X$, with T_0 and T_1 positive constants. Finally, we impose zero ux boundary conditions of the system at the extrem es of the spatial interval, i.e., there are in nite walls at these extrem es where the particles rebound and cannot scape from the system .

The equation for the probability density that we have derived from the K ram ers equation with the multiscale approach in an expansion in , Eq. (26), is now (for aesthetic reasons we denote in the following $\binom{0}{0}$ (X;) = (X;))

where J is the ux. The boundary conditions read J(0) = J(L) = 0. The stationary solution is given by:

where we have used the norm alization condition $\begin{bmatrix} R_L \\ 0 \end{bmatrix} dX \quad ^{s}(X) = N$.

On the other side, in the overdam ped lim it one has to distinguish between the two prescriptions. In this paper we discuss the two more standard: Ito and Stratonovich. The Ito-Sm oluchow ski equation is also given by Eq. (28) and the stationary solution is obviously given by Eq. (29). A very important di erence here is that it has not been derived as an expansion of inverse powers of , and thus it is exact and no higher order corrections should appear. In the




FIG.1: (color online) P lot of the stationary density of particles for di erent values of . The particle dynam ics correspond to the Langevin equation Eq. (1), and the density of particles has been computed by making a coarse-graining in the particle positions. W ith the solid black line we plot the analytical solution Eq.29, that ts well for large values. The other parameters used in the simulation are dt = 0:0001 and the cell size for the coarse-graining dx = 1=1000.

Stratonovich prescription the density equation, which is also exact and not an approximation to order 1, is given by:

Now we show the numerical results for the Langevin particle dynam ics. We begin with the underdam ped dynam ics, and consider 2000 particles evolving according to Eq. (1). We take $T_0 = 0.1$ and $T_1 = 10$ and all our measurements are performed when the system is stationary. A verage values are obtained by sampling 200 di erent realizations. A stationary density of particles is de ned at every spatial point by counting the number of particles in every cell of size dx = 1=1000. The time step used is dt = 0.0001. For di erent values of the results are shown in Fig. 1. One can see that for large values of the comparison with the analytical result, Eq. (29), is excellent. O byiously, the sm aller the value of the larger the corrections that we are neglecting and the agreement worsens.




FIG. 2: (color online) Coarse-grained density eld obtained from the overdam ped Langevin dynamics Eq. 5. Left panel corresponds to the Ito interpretation of this equation, and right to the Stratonovich one. We take dierent values of the parameter as indicated in the legend box. W ith the solid line we plot the stationary density solutions as given by Eqs. 29 and 30, for Ito and Stratonovich respectively. The rest of the parameters used in the simulation are dt = 0.0001 and the cell size to make the coarse-graining of the position of the particles is dx = 1=1000.

In Fig. 2 we show the results obtained from the simulations of the overdam ped dynam ics, Eq. (5), where we have also coarse-grained the distribution of particles to compute a density of particles. Interpreting it like Ito the results are in perfect agreement with the Ito-Sm oluchow ski stationary solution, Eq.(29). This is shown in the left panel of the gure for dierent values of . When it is understood in the Stratonovich calculus, for which we have to add a new term $\frac{T^{\circ}(X)}{2m}$ in the rh.s. of Eq. (5) to make the numerical simulation, again the results coincide with the stationary density solution in the Stratonovich calculus, Eq. (31), as shown in the right panel of Fig. 2 for various values . A very in portant dierence encountered in these results with respect to those in Fig. 1 is their independence with respect to the value of : for any of its values the agreement with the stationary density is always excellent. In fact, one can realize that once the lim it has been performed, the value of only renormalizes the time scale of the problem.

V. CONCLUSIONS

In the present paper, we have derived the form of the governing equation for the probability density of interacting B row nian particles in the case of an inhom ogeneous medium, whose tem perature varies in space. The interparticle interactions have been treated in a mean-eld fram ework. We have show n, using the K lein-K ram ers equation associated to the fully inertial stochastic dynam ics, that, to leading order, one obtains a Sm oluchow skiequation for the particle distribution which has the same form as the equation obtained by applying the Ito prescription to the overdam ped dynam ics.
