C om puter sim ulation of fatique under diam etrical com pression

We study the fatigue fracture of disordered materials by means of computer simulations of a discrete element model. We extend a two-dimensional fracture model to capture the microscopic mechanisms relevant for fatigue, and we simulate the diametric compression of a disc shape specimen under a constant external force. The model allows to follow the development of the fracture process on the macro- and micro-level varying the relative in uence of the mechanisms of damage accumulation over the load history and healing of microcracks. As a specic example we consider recent experimental results on the fatigue fracture of asphalt. Our numerical simulations show that for intermediate applied loads the lifetime of the specimen presents a power law behavior. Under the ect of healing, more prominent for small loads compared to the tensile strength of the material, the lifetime of the sample increases and a fatigue limit emerges below which no macroscopic failure occurs. The numerical results are in a good qualitative agreement with the experimental indings.

I. INTRODUCTION

Understanding the fatigue dam age process of disordered materials is obviously important in many areas. The time scales related to the failure process, the relevant dam age mechanisms, and scaling laws associated with this phenomenon have been widely studied both experimentally and theoretically [1, 2, 3, 4]. Universal laws have been found in the fracture process related to both system sizes and geometry [5, 6], and in particular dam age accumulation has been shown to play an important role in the form ation and development of cracks with fractal structure [7].

This phenomenon is also important in practical applications, in particular when dealing with asphalt mixtures subject to trackled layer failure in pavement of the main causes for asphalt layer failure in pavement structures, among moisture damage and thermal cracking. Most of the knowledge about fatigue failure of asphalt mixtures relies, however, on experimental observations [8, 9, 10, 11, 12, 13]. Material modeling to improve structural design is becoming an important tool to overcome this mode of material distress.

Recently, fatigue life tests have been carried out to study the perform ance of asphalt m ixtures [14], by m easuring the accumulation of deformation with time for cylindrical discs under diametrical compression applied periodically with a constant amplitude. Experiments revealed that the fatigue process has three dierent regimes depending on the external bad amplitude: when falls close to the tensile strength of the material a rapid failure occurs, while for low bad values a so-called fatigue limit emerges below which the material does not suer macroscopic breaking. In the intermediate load regime the lifetime of the speciment $t_{\rm f}$ has a power law dependence on the bad, also called the Basquin law of fatigue [15]. Dierent models have been developed to

obtain a theoretical understanding of the fatigue performance of asphalt specimens [16, 17, 18]. Besides dam age accumulation, experimental research has shown the im portance of the healing process to the lifetime of asphalt m ixtures [9, 10, 11, 13, 19]. The healing mechanism is related to the recovery of microcracks due to the viscoelastic nature of the binder material in polymeric mixtures, resulting in an extended lifetime. Theoretical approaches turned out to have di culties in capturing all the mechanisms involved in the fatigue process, such as dam age growth, relaxation due to viscoelasticity and healing [10, 16, 17, 20, 21]. Although, these models agree well with the results of the experiments, taking into account the stochastic nature of the fracture process and the cumulative e ect of the load history, they fail to describe explicitly the processes of dam age, fracture and failure of the solid. A more complete understanding of the failure process due to dam age accumulation in the Brazilian test con quration may bene t from detailed com puter simulations confronted with the experiments, as already was successfully performed in many fracture processes [22, 23, 24, 25, 26, 27, 28, 29, 30].

In this paper we enhance a 2D discrete element model of the fracture of disordered materials in order to capture the relevant microscopic mechanisms of fatigue. In the model convex polygons symbolizing grains of the material are coupled by breakable beams, which can suer stretching and bending deformation [1, 2, 22, 24, 25, 31, 32, 33, 34, 35, 36]. The beams of the model can represent the polymeric binder of asphalt between aggregates. Similarly to former studies, breaking of a beam can be caused by stretching and bending captured by the von Mises-type breaking criterion [22, 24, 25, 35]. Additionally, we introduce an ageing mechanism, i.e. intact beams undergo a damage accumulation process which can again give rise to breaking. The accumulation process introduces memory over the loading history of the system.




FIG. 1: (Color online) Geometrical layout of the model. A disk shaped sample is subjected to diam etrical compression. The disk is composed of convex polygons connected by elastic beams (magnied image).

Damage recovery leading to healing is implemented in the model by limiting the range of memory which contributes to the amount of damage of bers. We study in details the time evolution of the system and demonstrate that the model provides a good quantitative description of the experimental ndings, where damage accumulation and healing proved to be essential.

II. M O D E L

Our model is an extension of a realistic discrete elem ent model of disordered materials which has been successfully applied to study various aspects of fracture and fragm entation phenom ena [22, 24, 25, 35]. The material is assumed to be composed of a large number of mesoscopic elements that interact elastically with each other. In our model the mesoscopic elements are convex polygons random ly generated using a Voronoi construction [37].

The mesoscopic elements are elastic and unbreakable bodies, all with the same physical properties. Deformations are represented in the model by the possible overlap of the elements when pressed against each other. Between overlapping polygons we introduce a repulsive force which is proportional to the element's bulk Young modulus Y and the overlapping area, and has a direction perpendicular to the contact line [25, 37].

Cohesion between the elements is introduced in the model by the inclusion of beams between neighboring polygons, see Fig. 1. The use of beam s, as opposed to simple springs, takes into account tension and bending deform ations, which are especially important in the com-

plex multi-axis stress eld regime present in the geometries used experim entally. This model also resolves the local torques and shear forces which naturally arise when dealing with materials with complex micro-structures, where grains or aggregates are embedded in a matrix m aterial. Beam s have been particularly used in the literature to prevent an unphysical failure of the system under shear [35], which happens when using central force elements. A detailed description of the beam model is given elsewhere [25, 31, 37]. Brie y, the centers of mass of neighboring elements are connected by beams which can su er stretching and bending deformation, and hence, exert an elastic force and torque on the polygons when stretched or bent [1, 2, 22, 24, 31, 32, 33, 34, 35, 36].

In the model beam s can break according to speci ed rules in order to explicitly model damage, fracture and failure of the solid [25, 37]. The imposed breaking rule must take into account both the imm ediate breaking of the beams by stretching and bending, as well as the accum ulation of dam age and the healing mechanism. In order to achieve these conditions for each beam, at time t, we evaluate the quantities p(t) and q(t) de ned by

where "= l=1₀ is the longitudinal deform ation of the beam , and $_{\rm i}$ and $_{\rm j}$ are the rotation angles at the ends of beam s between sites i and j, respectively. Equation (1a) has the form of the von M ises plasticity criterion describing the mechanical strength of beams with respect to stretching and bending deform ation. The rst part of Eq. (1a) refers to the breaking of the beam through stretching and the second through bending, with "th and th being the threshold values for elongation and bending, respectively. Equation (1b) refers to the long term memory, and accounts for the accumulation of damage and the healing m echanism. The rate of damage accumulation is assumed to have the form $c(t) = f_0 p(t)$, i.e. the dam age accumulated until time t is obtained as an integral over the loading history of elements $c(t) = \int_0^{1/t} p(t^0) dt^0$. In our model healing is captured such that microcracks

nucleated in beam s can recover, a process which lim its the total am ount of dam age. We describe this elect by introducing a nite range of memory over which the load experienced by beam s has a contribution to the damage. For polymeric materials the dynamics of long chain molecules typically lead to an exponential form of the healing term. In Eq. (1b) the parameter f_0 is a memory factor and is the time range of the memory over which the loading history of the specimen contributes to the accumulation of damage [7], and therefore a parameter that controls the healing mechanism. The breaking condition Eqs. (1a) and (1b) are evaluated at each iteration time step and those beams for which q(t) 1 are considered to be broken, i.e., are removed from the simulation.

For sim plicity, all the beam s have the same threshold values " $_{\text{th}}$ and $_{\text{th}}$, and disorder is introduced in the model solely through the mesh generation [22, 23, 24, 25, 37, 38]. The globalm aterial properties can be tuned by adjusting geometrical and microscopic physical param eters of the model. The random ness of the Voronoi tessellation and the average size of the mesoscopic elements, which de ne the average length and width of the beam s are geom etrical param eters that, together with the Young modulus of polygons Y and that of the beam s E determ ine the macroscopic response of the modelmaterial [22, 23, 24, 25, 37, 39]. The time evolution of the system is calculated by num erically solving the equations ofm otion for the translation and rotation of all elements using a sixth-order predictor-corrector algorithm . The breaking rule is evaluated at each iteration step. The breaking of beam s is irreversible, which means that it is excluded from the force calculations for all following time steps. Table I sum marizes the parameter values used in the simulations.

Since usually the fracturing of materials is highly dependent on the structural environm ent in which it is studied, one needs to reproduce the experim ental geom etry as accurately as possible. Starting from the Voronoi construction of a square, one cuts a disk-shaped specimen by rem oving those polygons outside the disk region and reshaping those at the border. The loading conditions for the numerical specimen are shown in Fig. 1. This specim en is loaded in diametral compression by nondeform able platens, which are modeled by introducing two new polygons with the same physical properties of the loaded material. The load platens are cut with the sam e curvature of the disk. The ratio between the width of the load platen b and the diam eter of the disk D is b=D = 0.125, as in the experiments of Ref. [14]. In the simulations presented in this paper each disk specimen is com posed of 5070 m esoscopic elem ents.




FIG. 2: (Color online) Fracture of a disk-shaped solid subjected to a constant diam etric load. Snapshots of the evolving dam age. Simulations were carried out with the parameter values: = $_{\rm C}$ = 0.8, f₀ = 100, and = 1300. For further parameters see Table I.

III. RESULTS AND DISCUSSION

A . Fracture developm ent

In the num erical experiments the sample is loaded with a constant external stress. In order to avoid undesirable large elastic waves, the load applied to the opposite platens is slowly increased from zero. When the load reaches the value, the numerical sample is allowed to equilibrate during thousands of time steps including a small damping between the grains and friction according to Coulomb's friction law [25, 37]. Only after equilibration the breaking rules are applied to the beams. With this slow loading and long equilibration time, the vibrations of the sample are drastically reduced compared to the case when a constant load is applied instantaneously to the platens. The parameter values used in the simulations are summarized in Table I.

First we carried out computer \sin ulations in order to determ ine the quasi-static strength $_{\text{C}}$ of the model solid at the given parameters. Then the damage and fracture of the disc was studied varying the external load below $_{\text{C}}$. In order to understand the failure process we studied




FIG. 3: (Color online) Fraction of broken beam s due to im mediate breaking (squares) and memory accumulation (circles) as a function of , for $f_0=100$, = 500, together with the total fraction of broken beam s (diam onds). The insets show the nal fracture pattern for = 0.2 (left) and = 0.8 (right).

in details the evolution of the crack pattern during the simulations. Figure 2 presents snapshots of the evolving system for a disk of diameter 20 cm (approximately 80 polygons) and = c = 0.8. In the initial stage of fracture, shown in Fig. 2(a), a number of cracks appears in the regions situated near the border of the platens contacts. Because of the nite width of the platens, the stress eld induced in the sample is not purely unjaxial tensile stress along the load direction as one might expect [40], so the cracks do not initiate from the middle of the specimen. In fact, the cracks in itiate from the border and coalesce to form wedges, as shown in Figure 2(b). The wedges extend up to approximately 0.25D, exhibiting a series of parallel vertical cracks, characteristic of com pressive tests [25]. As time evolves the wedges penetrate the specimen (see Fig. 2(c)) originating a fracture in the center of the specimen, in a narrow region between the load platens. This mechanism leads to the sudden and catastrophic failure of the specimen (as shown in Figure 2 (d)). This failure behavior agrees qualitatively well with previous experim ental observations [14, 26].

It is important to emphasize that without the time dependent dam age accumulation, the system would not have macroscopic failure under a load c. After < som e cracking events the disc would attain equilibrium resulting in an in nite lifetime. However, according to the failure criterion Eq. (1b), intact elem ents accum ulate dam age which results in beam breaking after a nite time even under a constant local load. These beam breakings due to damage accumulation give rise to load redistribution and stress enhancem ents on intact elements triggering additional breakings. In this way, if healing is neglected, or analogously ! 1 is set in Eq. (1b), the system would fail after a nite time at any small load value. One can conclude from Eq. (1b) that the main




FIG. 4: (Color online) Final fracture pattern with $f_0=1$ (a) and $f_0=100$ (b) obtained by computer simulations at the same load = $_{\rm c}=0.8$ and $!\ 1$. At the higher value of the memory factor f_0 more dispersed cracking occurs (b), while for low f_0 correlated crack growth can be obtained due to the dominance of immediate breaking.

role of the mem ory factor f_0 is to control the relevant time scale of the system , i.e. the lifetime of the specimen t_f has a dependence t_f $1=f_0$.

In order to analyze the importance of the accumulation of dam age in the fracture process, we have investigated the nal fractions of the beam s that have been broken during the course of the sim ulations due to the im m ediate breaking rule (rst term in Eq. 1b)) and those that have been broken due to dam age accumulation (second term in Eq. (1b)) for di erent applied loads. Figure 3 shows the fractions of the broken beams due to the di erent breaking modes as a function of the applied load. For low load values dam age dom inates the failure of beam s, while im m ediate breaking plays only a m inor role. As the external load is increased, the fraction of broken beam s due to dam age accumulation decreases monotonically, while that due to im mediate breaking increases and saturates. 0:65 c the im m ediate breaking m ode becom es dom inant. It is interesting to note that the total fraction of broken elements is a decreasing function of the load, implying that correlated crack growth dominates when

One of the most in portant features of our modeling approach is that it accounts for the inhom ogeneous stress eld in the specimen and provides also information on the microstructure and spatial distribution of damage. The ageing of beams is less sensitive to the details of the stress eld in the specimen. That is why when damage accumulation dominates the breaking of beams microcracks are more dispersed in the stripe of the specimen between the loading platens. The insets of Fig. 3 show the nal fracture pattern corresponding to = 0.2 c and = 0.8 c. For = 0.2 (left), where the elect of fatigue is more important, we observe more disordered cracks, while for = 0.8, where the immediate breaking process




FIG.5:Deform ation " of the disk as a function of time t for f_0 = 100 and = 1 varying the external load . Macroscopic failure is preceded by an acceleration of the deformation. The vertical dashed line indicates the lifetime $t_{\rm f}$ of the system. Note that $t_{\rm f}$ decreases with increasing .

is m ore important, longer cracks can be identied due to crack growth.

In our model the importance of damage accumulation for the beam breaking is controlled by the memory factor f_0 with respect to the immediate failure of elements. Figure 4 dem onstrates crack patterns obtained at the sam e load without healing ! 1 varying the value of f_0 . It can be observed that for large values of f_0 , even at a relatively high load = $_{c}$ = 0.85, a large amount of distributed cracking occurs in the specimen. Correlated crack growth can only be observed for low f_0 (see Fig. 4a) where im mediate breaking has dominance. These crack patterns are very sim ilar to those originated due to mem ory e ects in thermal fuse networks [41]. The e ect of increasing the memory factor for resembles the elect of decreasing the applied load, in the sense that increasing fo has the same e ect of enlarging the lifetime of the sample, as can be inferred from Eq. (1b).

B. M acroscopic tim e evolution

On the macroscopic level the time evolution of the system is characterized by the overall deform ation " of the disk and the lifetime $t_{\rm f}$ of the specimen. The total deformation of the specimen, ", is obtained directly from the simulation by monitoring the position of the loading platens. Figure 5 shows the behavior of " as a function of time for dierent values of with respect to the tensile strength $_{\rm c}$ of the simulated specimen. Due to accumulation of damage, "increases monotonically until catastrophic failure of the material occurs. Some uctuations can be seen in "before it starts increasing rapidly, due to the natural randomness of the beam breaking. The lifetime $t_{\rm f}$ of the specimen is dened as the time at which the deformation "diverges. It can be observed




FIG. 6: Fit of the experim ental results of Ref. [14]. Using the parameter values $f_0 = 100$ and = 1300 a good quality agreement is obtained with the experiments.


that, by increasing , the lifetime $t_{\rm f}$ rapidly decreases and actually goes to zero as the external load approaches the tensile strength of the m aterial $_{\rm c}.$

For the purpose of thing the experimental results, the most important parameters of the model that can be tuned are the two threshold values "th and th for the stretching and bending deformation of the beams, as well as the memory factor f_0 and the range of memory . As we have pointed out, f_0 only sets the time scale of the system, while the other three parameters have a strong e ect on the qualitative form of "(t) and $\frac{r}{k}$ ().

In the experiments of Ref. [14] the asphalt specimen was subjected to periodic loading with a constant amplitude monitoring the maximum deformation as a function of the number of loading cycles and the number of cycles to failure. In our model a constant load or a periodic load with a constant amplitude would have the same effect, hence, we directly compare the simulation results to the experimental ndings.

Figure 6 shows a tofthe experimental results of Ref. [14] to the simulations, obtained by relating time to number of cycles and an appropriate choice of geometrical and physical parameters for the mesoscopic elements and beams. We see that the simulation and the experimental curves show excellent agreement.




FIG. 7: Lifetime as a function of the load $\,$ for dierent breaking thresholds. In (a) the stretching threshold is kept xed " $_{\rm th}$ = 0.03 and we vary the bending angle threshold $_{\rm th}$, while in (b) $_{\rm th}$ = 15° and the lifetime is calculated for dierent values of " $_{\rm th}$.

In order to exam ine the consequences of the predom—inance of stretching or bending breaking m odes we perform ed a number of simulations with dierent threshold values. The dependence of the lifetime on the external applied load is shown in Figure 7, for =1 and different values of "the and the The simulations show that for external loads $\cdot \cdot \cdot$ for all curves the lifetime decreases rapidly and approaches the immediate failure of the specimen. For intermediate values of applied load, $\cdot \cdot \cdot \cdot \cdot \cdot$ the specimen with the

where the value of the exponent can be controlled by the breaking param eters "th; th. We can see in Fig. 7a that for a xed value of "th = 0.03 the Basquin exponent varies from = 1.1 0.1 for th = 3° (bending breaking mode dominance) to = 1.6 0.1 as we increase that 0.20°, hence increasing the in uence of the stretching breaking mode. O briously, the value of calso increases with increasing the inverse one of the breaking modes gets completely suppressed. Similarly in Fig. 7b, with a xed value of the 15° the Basquin exponent varies from = 1.4 0.1 for "th = 0.04 to = 1.8 0.1 for "th = 0.01, in which case there is a clear predominance of the




FIG. 8: Lifetime as a function of the load = c. The square lled symbols correspond to experimental results, the open circles correspond to = 1, and the , + and symbols to = 21150, 16450 and 11750, respectively.

stretching breaking mode.

In order to obtain the measured value = 2:0 0:1 the breaking parameters had to be set such that the stretching mode of Eq. (1a) dominates the breaking, i.e. $"_{th} = 0.01$ and $_{th} = 20^{\circ}$ were used which implies that the bending mode has only a minor role in breaking. The uptum of the curves of tf for sm all loads in Fig. 8 indicates the em ergence of the fatigue $\lim_{n\to\infty} i t_n$ in the system below which < 1 the specimen only su erspartial failure and has an in nite lifetime. Figure 8 also illustrates that the value of 1 is determ ined by the range of mem ory , since healing has only a dom inating e ect on the time evolution of the system when is comparable to the lifetime of the specimen measured without healing (! 1). Hence, it follows from the Basquin law, Eq2, that the fatique lim it 1 scales with as 1 quantitative agreem ent between simulations and experim ent obtained for = 21150 indicates that the stretching breaking mechanism is more important for this particular m aterial. This is reasonable since the polymer binding in asphalt can not sustain torsion.

IV. CONCLUSIONS

We carried out a computational study of the fatigue failure of disordered materials occurring under a constant external load. A two-dimensional discrete element model was extended to capture microscopic failure mechanisms relevant for the process of fatigue. As a specie cexample, we considered experiments on asphalt where damage recovery in the form of healing is known to play a crucial role for the long term performance of the material.

The breaking of beam s is caused by two mechanisms:

immediate breaking occurs when the failure thresholds of stretching and bending are exceeded. Intact beam s undergo a dam age accum ulation process which is lim ited by the nite range of memory (healing). The relevant param eters of the model to the experim ental results are the breaking thresholds of stretching "th and bending th and the range of memory . We carried out a large am ount of computer simulations to study the time evolution of the system at the macro-and micro-level. We dem onstrated that at the micro-level failure of beam s due to damage is responsible for the di use crack pattern, while correlated crack growth is obtained when im mediate breaking has dom inance. The model provides a good quantitative agreem ent with previous experimental ndings on the fatigue failure of asphalt, i.e. varying only three param eters "th, th, and of the model we could reproduce the deform ation-time diagram and the Basquinlaw of asphalt obtained in experiments. Very interestingly we found that the value of the Basquin exponent of

the model is controlled by the relative importance of the stretching and bending modes in beam breaking. The fatigue $\lim_{t\to\infty} it_t$ is obtained as a threshold value of the external bad below which the specimen does not suer macroscopic failure and has an in nite lifetime. In the fram ework of our model it_t is solely determined by the range memory over which local bads contribute to the total accumulated damage in the system.
