D iscrete Sym m etries and $\frac{1}{3}$ -Q uantum Vortices in C ondensates of F = 2 C old A tom s

In this Letter we study discrete symmetries of mean eld manifolds of condensates of F = 2 cold atom s, and various unconventional quantum vortices. D iscrete quaternion symmetries result in two species of spin defects that can only appear in integer vortices while cyclic symmetries are found to result in a phase shift of 2 =3 (or 4 =3) and therefore 1=3- (or 2=3-) quantum vortices in condensates. We also brie y discuss 1=3-quantum vortices in condensates of trin ers.

O ne of the most striking features of a super uid is the existence of quantized vortices. This is a consequence of the requirem ent that the quantum mechanical wavefunction of any physical state be single-valued. In a standard single component bosonic condensate, this requirement results in the quantization of circulation: the line-integral of the super uid velocity along a path linking a vortex takes discrete values: dr $y = n \frac{2 h}{m}$, with n an integer. Here, $\frac{2 h}{m}$ is the fundamental quantum of circulation. The quantization of circulation has been observed in super uid liquid Helium by V inen [1], and recently in B ose-E instein condensates of cold atoms [2]; the presence of quantized vortices usually results in discrete values in the energy splitting of collective modes that have been studied in experiments.

The existence of quantized vortices in a condensate is also tied to the topology of the vacuum manifold. In a single component condensate, the vacuum manifold is the set of all distinct phases that the condensate can have. This set is identical to the unit circle S¹. As one moves in a closed path around a quantized vortex, the phase must traverse S¹ an integer number of times [3, 4, 5, 6]. For condensates with more than one component, vortices can have circulation quantized as fractions of the basic unit $\frac{2 h}{m}$; this is achieved when a change of phase is combined with a rotation of spin or orbital orientation. A most recent example are the half-quantum vortices in condensates of sodium atom s[7]; half vortices were also discussed in the context of super uid ³H e[4].

C old atom s in optical traps and lattices are a prom ising venue where exotic condensates and vortices could be realized in nature. Spin correlated states of spin F = 1cold atom s have already been explored experim entally [8] and theoretically [9, 10, 11]. M ore recently, the scattering lengths of spin F = 2 cold atom s have also been investigated [12] and various possible condensates have been pointed out [13, 14]. In this letter we shall exam ine the possible appearance of unconventional vortices in the latter condensates. In a previous study of their possible insulating phases [15], we found a convenient param etrization of the F = 2 wave-function as a tensor where

; take the values x;y;z. Being the wave-function of an atom, the entries of this matrix are complex functions. To be a state with F = 2, it must be symmetric,

= , and traceless, tr = $_{xx} + _{yy} + _{zz} = 0$. This leaves ve independent complex entries. These entries are linear combinations of the ve components of the atom wave-function $_{m_F}$ with $m_F = 2;1;0; 1; 2$ the z-component of the spin. In Ref. [15], we related the Landau-G inzburg free energy functional of the condensate to recently measured scattering lengths for atom s. By including a derivative term, in the long-wavelength lim it we have

m is the elective mass of atom s in optical lattices, M is the average number of atom s per site and $_0$ the average particle density. The coe cients b_L and c_L can be estim ated from the two-atom interaction strengths in channels with various spins[15]; b_L or c_L is proportional to b = (a₄ a₂)=7 or c = (a₀ a₄)=5 2 (a₂ a₄)=7 and a_{0;2;4} are two-body s-wave scattering lengths in F = 0;2;4 channels respectively. For ground states we consider uniform condensates. The -dependence of the energy of condensates is identical to that of M ott states obtained earlier in R ef.[15]; m inimization of this energy subject to a constraint of tr = 1=2 was previously carried out.

W hen all scattering lengths are equal, A(;) = 0and the H am iltonian is SU (5) symmetric. The mean eld manifold is U(1) SU (5). SU (5) is simply connected and its fundamental group is trivial. Only integer vortices are allowed in this case. Restoring the spin-dependent scattering turns on the potential and, as shown below, results in multiply connected mean eld manifolds and exotic vortices. Here we investigate various discrete symmetries of the manifolds for cyclic and nem atic phases.

W hen $b_L > 0$, and $c_L > 0$, the energy is minimized by a ground state satisfying tr² = 0 = [;]. The real and imaginary parts of commute with each other and we can nd a coordinate frame where is diagonal. A solution which obeys tr = 0 as well as tr = $\frac{1}{2}$ is

The full set of degenerate solutions can be obtained by applying symmetry transformations: SO (3) rotations, im plemented by 3 3 orthogonal matrices R and multiplication by a U (1) phase, e^i , to the solution $_+$. An arbitrary solution can be written as $e^i R _+ R ^1$.

The set of all solutions is equal to the group of all such sym m etry transform ations factored by the subgroup which leaves _ invariant. A swe shallexplain below, this subgroup is the tetrahedral group, T. The vacuum m anifold is therefore the set of right cosets $M = \frac{SO(3) U(1)}{T}$ [16]. The tetrahedral group, T, is the subgroup of SO(3) U(1) which leaves _ in eq. (2) invariant. This group contains the identity, and three diagonal SO(3) m atrices (called the K lein 4-group)

The remaining elements of T implement cyclic permutations of the diagonal elements of $_+$ as well as multiplication by phases. The the elements of SO (3) which permute the diagonal elements of $_+$ are

Indeed, $_{+} = !C _{+}C^{1}$, where ! was introduced in Eq. (2). The elements 1;C;C² form a cyclic subgroup of SO (3), C₃. We emphasize that the transform ation of $_{+}$ involves a U (1) phase of $\frac{2}{3}$ as well as a cyclic rotation represented by C. We will denote this combination of transform ations as C. The full tetrahedral group T has the 12 elements T = f1;I_x;I_y;I_z, C;I_xC;I_yC;I_zC, C²;I_xC²;I_yC²;I_zC²g.

The rst step in classifying vortices is to identify the hom otopy group $_1$ (M) [17]. Since SO (3) is not simply connected, to understand the topology of the manifold M we shall lift SO (3) to SU (2). An element of SU (2) is a 2 2 unitary matrix. The set of 2 2 unitary matrices is characterized by the four realEuler parameters (e0;e) through the relation $Q = e_0 + ie \sim ; \sim$ are the usual Pauli matrices. Q is unitary when $e_0^2 + e = 1$; the Euler parameters live on the unit three-sphere S^3 , which is simply connected. The matrix Q is the well-known quaternion representation of a rotation [18]. The 3 3 rotation matrix R 2 SO (3) which corresponds to Q 2 SU (2) is R $=\frac{1}{2}$ Tr Q Q^Y. This is a two-to one m apping since both Q and Q are m apped to the same R. The inverse, R ! (Q; Q) is the 'lift' of R to SU (2).

W e also need to lift the tetrahedral group T to T , the binary tetrahedral group which is a subgroup of SU (2)

and contains 24 elem ents. For this, we must identify the pair of SU (2) matrices which correspond to each of the 12 elem ents of T. The elem ents of T are the simple rotations (examples are shown in Fig.2) that lift as: 1 ! 1, $I_{x,y;z}$! $i_{x,y;z}$, C ! $= \frac{1}{2}(1 + i_x + i_y + i_z)$. We further denote a rotation combined with a phase shift of 2 =3 as ~. The group elements of T which are lifts of T are therefore,

Eq.(5) represents the quaternion subgroup Q.

The vacuum manifold derived above is isomorphic to

To nd the hom otopy classes of closed paths in M , we must rst understand how they are related to paths in the product of space of SU (2) U (1). As we have discussed above, SU (2) is equivalent to a three-sphere S³, and U (1) to a circle S¹, so that we could equivalently think of paths on the product space S³ S¹. Each point of S³ S¹ corresponds to an element in the group SU (2) U (1). Factoring by T is simply making an identication on S³ S¹, each point is to be identied with 23 other points which are obtained from the corresponding group element by operation of the non-trivial elements of T.




FIG.1: (color online) Schem atic of the mean eld manifold of cyclic condensates. The unit circle is oriented horizontally with phase angles (de ned after Eq2) around it shown explicitly. Each cross section at a given angle stands for a threesphere. Examples of 24 four identi ed points in the product space S^3 S^1 are shown explicitly as stars, with eight points at = 0 or 2 (or elem ents in Eq5), eight points at = 2 = 3 (or elem ents in Eq.6), and the eight points at = 4 = 3 (or elem ents in Eq.7). The red path ending at phase 2 is for an integer vortex with a spin defect inserted; the red dashed one is for a plain integer vortex w ithout spin defects. The short (long) blue path ending at 2 = 3 (4 = 3) is for a 1=3 (2=3)quantum vortex. The green path at phase = 0 corresponds to a spin defect and the winding along S^1 is trivial.

Consider a path on S^3 S^1 . In order to be a closed path on M it must either end at the point on S^3 S^1 at which it began, or it must end at one of 23 points that are identied with it. As shown in Fig. 1, there are three types of paths (which all begin at the identity):

Type A : Paths that traverse S^1 n (n is an integer) times and end with one of the eight elements in Eq.(5);

Type B: Paths that traverse $S^1 n + \frac{1}{3}$ times and end with one of eight elements in Eq.(6);

Type C: Paths that traverse $S^1 n + \frac{2}{3}$ times and end with one of eight elements in Eq.(7).

Thus each path is characterized with two variables: the winding number around S¹ and an element in T . 1 (M) = f(n;1); (n; 1); (n;i); (n; i); $(n + \frac{1}{3}; \sim); (n + \frac{1}{3}; \sim); (n + \frac{1}{3}; i); (n + \frac{1}{3}; \sim); (n + \frac{2}{3}; \sim^2); (n + \frac{2}{3}; \sim^2); (n + \frac{2}{3}; i); (n + \frac$

So far, we have computed the hom otopy group $_1 M$) for loops with a base-point. However, distinct vortices are identied with free hom otopy classes, which coincide with conjugacy classes of the based hom otopy group [4, 5]. For an element g_i of a group, the conjugacy class is the set of all distinct elements in the set $g_a gg_a^{-1}$ as g_a sweeps over the group. In our case, the classes are 1) f(n;1)g; 2) f(n; 1)g; 3) f(n; i); (n; i)g, =

x;y;z;4) f(n+ $\frac{1}{3}$;~); (n+ $\frac{1}{3}$; i ~)g;5) f(n+ $\frac{1}{3}$; ~); (n+ $\frac{1}{3}$;i ~)g; 6) f(n + $\frac{2}{3}$;~²); (n + $\frac{2}{3}$; i ~²)g; 7) f(n + $\frac{2}{3}$; ~²); (n + $\frac{2}{3}$; i ~²)g. A logether there are only seven distinct classes and thus seven types of linear defects.




FIG.2: Spin rotations in integer vortices, 1=3-quantum vortices and 2=3-quantum vortices. (a) the orientation of three basis vectors $\hat{x}\hat{y}\hat{z}$ at azim uthal angle = 0. (b-e) the orientation of the triad $\hat{x}\hat{y}\hat{z}$ at angle = 2 in four con gurations of integer vortices: (0; i x) (b), (0; i y) (c), (0; i z) (d), (0; 1) (e); the arrow in (e) represents a 360° rotation around the z axis. (f.g) the orientation of the triad $\hat{x}\hat{y}\hat{z}$ at angle = 2 in two 1=3 quantum vortices: (1=3; i z ~) (f), (1=3; i y ~) (g); (h,i) the orientation of the triad $\hat{x}\hat{y}\hat{z}$ at angle = 2 in two 2=3 quantum vortices: (2=3; i z ~²) (h), (2=3; i x ~²) (i).

If n = 0, a Type-A path corresponds to a pure spin vortex. Such a path might begin at the origin (identity) and end at one of i_x , i_y , i_z or 1. These correspond to, respectively, 180° rotations around one of the three axes $\hat{x};\hat{y};\hat{z}$ or a rotation around the \hat{z} -axis by 360° (see (b-e) in Fig. (2)). However, paths which end at i_x , i_y , i_z are freely hom otopic to each other and all represent the same spin defect. So there are two di ertypes of spin vortices (speci ed by classes): (0; 1) and (0; i), = x, y or z.

O n the other hand when n is a nonzero integer, a type-A path corresponds to an integer vortex. Three conjugacy classes involving integer n represent three distinct species of integer vortices: a conventional integer vortex with no spin structure, an integer vortex with a spin defect of (0; 1) inserted and an integer vortex with a spin defect of (0; i a) inserted. The last two types are unique to condensates of F = 2 atom s.

A long Type-B or Type-C paths, a phase shift of 2 = 3 or 4 = 3 is generated under the action of the element \sim_c or \sim_c^2 . In these cases, the spin rotation leads to a 1=3quantum vortex or a 2=3-quantum vortex. Furthermore, there are only two topologically distinct species of each of 1=3- or 2=3-vortices. The two distinct 1=3-quantum

vortices are represented by either paths that end with elements ~, i ~ or paths that end with ~, i ~. The 1=3 and 2=3-quantum vortices necessarily contain topologically non-trivial spin con gurations which dier in structure from those in integer vortices.

We now are going to exam ine spatially slow ly varying matrix (r) and focus on spin vortices and 1=3-quantum vortices. All linear defects are oriented along the z-direction; the center of a defect is at the origin of cylindrical coordinates (;;z). The super uid velocity in the condensate is $v_s = 2$ Im tr r h=m. Far away from the center, the wavefunction of a pure spin vortex is specied by the rotation, (= +1;) = R() + R^T(). To minimize the energy in Eq.(1), we nd that the rotation matrix satis es the equation

A solution can be expressed as R () = $\exp(in Lf())$, where f() is a linear function of . A lternatively

Here L is a matrix vector, L = i, is the antisymmetric tensor. n is a unit vector with three com –

ponents n , = x;y;z. For a con guration that is speci ed by the boundary condition: R (0) = 1;R (2) = I_z , we nd the following solution

The super uid velocity is zero. W hen going around this vortex, the local triad of three orthogonal basis vectors $\dot{\chi}\dot{\chi}$ m akes a 180 rotation around \dot{z} -axis (see Fig.(2d)).

In a 1=3-quantum vortex, the boundary condition is R (= 0) = 1, R (= 2) = $\rm I_zC$; at any , () = $e^{i~=3}R$ () $_+\,R^{\rm T}$ (). The solution which satis es Eq.(9) and boundary conditions is

One gan calculate the circulation integral and con m that dr $y = \frac{1}{3}\frac{2}{m}\frac{h}{m}$. A 1=3-quantum vortex is always superimposed with a spin defect and is a unique com – posite excitation in coherent condensates. When going around this vortex, e ectively the local triad $\hat{x}\hat{y}\hat{z}$ is permuted cyclically: $\hat{x}\hat{y}\hat{z}$! $\hat{y}\hat{z}\hat{x}$; this is accompanied by a 180° rotation around the \hat{y} axis (see Fig.(2f)). The stability can be studied by examining the core structure. Similar discussions were presented for half-vortices [19].

W hen $b_L > \frac{c_L}{4}$ and $c_L < 0$, satis estr² = 1=2; =

which corresponds to biaxial nem atics [15]. A real solution is again invariant under the subgroup in Eq.(3); the submanifold should be isomorphic to M $_{n} = \frac{S^{3}}{Q} S^{1}$, Q is the quaternion group introduced before[20]. There are quaternion spin defects but no 1=3-quantum vortices in this case. The quaternion vortices are analogous to disclinations in cholesteric liquid crystals [4, 5, 6, 21].

In conclusion, we have studied discrete symmetries in condensates of $F = 2 \mod a \mod s$ and investigated 1=3quantum vortices and pure spin defects. It is worth remarking that 1=3-quantum vortices are also natural topological excitations in condensates of singlets of three atom s (an analogue of C ooper pairs in a two-body channel) or condensates of trimers. Rotationally invariant M ott states of trimers were pointed out by the authors recently [15]. If a trimer condensate does exist in optical lattices (say created by removing atoms from a trimer M ott state), there will then be simple 1=3-quantum vortices that are featureless in the spin subspace. Note that 1=3-quantum vortices in a cyclic phase on the other hand have very rich spin structure as discussed above. The one-third circulation quantum can be studied by observing fractionalized values in the energy splitting of collective modes in experiments similar to those in Ref.[1, 2].
