Abstract.

A generalm ethod is proposed for calculating a fully k-dependent, continuous, and causal spectral function A (k; E) within the recently introduced nonlocal version of the coherent-potential approxim ation (N LCPA). The m ethod involves the combination of both periodic and anti-periodic solutions to the associated cluster problem and also leads to correct bulk quantities for sm all cluster sizes. W e illustrate the m ethod by investigating the Ferm isurface of a two-dim ensional alloy. D ram atically, we nd a sm eared electronic topological transition not predicted by the conventional CPA.

1. Introduction

The coherent-potential approximation (CPA) [1] is a successful and widely used theory of dealing with disordered solids. However, the CPA does have a serious limitation in that it is only a single-site mean-eld theory of disorder and hence unable to treat multi-site correlations in the ensemble of disorder con qurations. However, this long-standing problem has recently been addressed by the development of the nonlocal coherent-potential approximation (NLCPA) [2], a cluster mean-eld theory which provides system atic corrections to the CPA. It was introduced as the static version of the dynam ical cluster approximation (DCA) [3, 4] used to describe shortrange correlations in strongly-correlated electron systems, and has been in plemented both for model Hamiltonians [2, 5, 6] and within st-principles density functional theory [7, 8, 9]. Notably, in contrast to earlier cluster theories [10] and supercell calculations, the NLCPA preserves the full translational sym m etry of the underlying lattice. Signi cantly, this highly desirable attribute means the NLCPA could be used to study nonlocal e ects on spectral properties of disordered system s. Indeed, the spectral function A_B (k; E) for m etallic alloys is of general interest because its peaks de ne the Fermi surface. For an ordered system these peaks are delta functions, how ever for a substitutionally disordered alloy they have $\,$ nite heights and widths $^{-1}$, where is the coherence length at the Fermi energy E_F . The shapes of such Fermi surfaces can be determined from two-dimensional Angular Correlation of (Positron) Annihilation Radiation (2D-ACAR) experiments [11], and, since they drive various ordering processes [12] and are subject to observable topological changes [13, 14], their theoretical description is an important area in alloy physics. One of the main

objectives of this paper is to introduce a method for calculating the spectral function within the NLCPA and to demonstrate its use by explicit calculations for the Ferm i surface of a tight-binding model alloy.

Recall that for such a tight-binding model alloy, the con gurational average over all possible disorder con gurations is represented by a translationally-invariant e ective medium characterized by the exact self energy (k). By mapping to a selfconsistent single-site in purity problem, the conventional CPA neglects correlations beyond a single site and hence yields a single-site self-energy that has no dependence on momentum k. The idea of the NLCPA is to system atically restore this neglected k-dependence by replacing the conventional single-site in purity with an ensemble of in purity cluster con gurations, thus providing system atic corrections to the CPA as the cluster size increases. Unlike previous cluster theories, the NLCPA preserves translational-invariance by in posing B om-von K arm an (periodic) boundary conditions on the cluster. How ever, a consequence of this is that the resulting e ective medium is characterized by a self-energy (K) which is a step function in k-space, with the number of steps centred at the points K equal to the number of sites in the cluster. This naturally leads to a spectral function with discontinuities at the jumps, which in turn leads for exam ple to an unphysical Ferm i surface.

Furtherm ore, it has recently been explicitly shown [6] that the NLCPA results are di erent if anti-periodic [4, 6] B om-von K arm an boundary conditions are im posed on the same cluster instead of the conventional periodic boundary conditions. The periodic and anti-periodic results only become equivalent as the cluster size N_c is increased to some critical value which depends on the model in question. In fact, below this critical value of N_c it has been explicitly shown that the periodic and anti-periodic solutions on their own are unphysical due to the discontinuities, i.e. not su cient to yield a meaningful density of states [6].

In this paper we introduce a new method for in plementing the NLCPA which resolves all the issues above. It involves the combination of both periodic and antiperiodic solutions to the NLCPA and should be used for cluster sizes sm aller than the critical value. It yields a fully k-dependent, continuous, and causal spectral function A (k; E), together with a meaningful density of states.

The outline of this paper is as follows. First, we brie y sum marise the idea of the NLCPA in section 2.1. Then, in section 2.2 the concept of periodic and anti-periodic Bom-von K am an boundary conditions is described in detail, and the key idea of the new method for implementing the NLCPA is introduced. The strict criteria that the new method must satisfy are outlined in 2.3, and the formalism is detailed in section 2.4. To test the validity of the new method, section 3.1 describes an application to a simple 1D tight-binding model in order to compare with known results. Following this, we apply the method to a 2D tight-binding model in section 3.2 and investigate the Ferm i surface. Finally we conclude in section 4.

2. Form alism

2.1. Brief sum mary of the NLCPA

Consider a general tight-binding model binary alloy dened by a hopping amplitude W_{ij} and site energies V_A and V_B . In terms of the site occupation numbers $_i$ which take on values of 0 and 1 depending on whether the site is occupied by an A-atom or

a B -atom, the usual G reen's function G ii (E) satis es the equation

where $V_i = {}_iV_A + (1 {}_i)V_B$ and E is the energy. We are interested in the average of G_{ij} (E) over all possible disorder congurations f_{ig}. Here it is useful to introduce the concept of an elective medium, and rewrite the average G reen's function in terms of the exact self-energy is which is translationally-invariant. In essence it replaces the substitutional disorder at each lattice site. By applying a Fourier transform to such translationally-invariant quantities we obtain

where a is the lattice constant and W(k), (k) are the hopping and exact self-energy respectively in reciprocal space. In the interests of clarity, the energy dependence of all G reen's functions on energy will be implicitly de ned as in (2) for the remainder of this paper.

In the single-site CPA the self-energy is k-independent and the purpose of the NLCPA is to system atically restore this neglected k-dependence. As explained in [2, 6] the idea is to coarse-grain the function (k) over a set of N_c tiles which divide up the Brillouin zone of the underlying lattice. If these tiles are centred at a set of N_c points fK_ng then this results in a function (K_n) which is a step function in k-space. The NLCPA is able to determ ine the function (K_n) by mapping to a self-consistent embedded cluster problem, where the cluster of N_c sites has Bom-von K arm an (periodic) boundary conditions in posed. This means the real-space cluster sites fR_1g and corresponding cluster m on enta fK_ng are related by the Fourier transform

where $n = 1; ::: N_c$. This relation is key to constructing an algorithm to determ ine the medium (see [2] for full details). A fler convergence of the algorithm, the NLCPA approximation to the exact average G reen's function (2) is given by

where (K_n) takes its appropriate value within each reciprocal-space tile n. C learly the e ect of coarse-graining the self-energy has been to reduce its range in real space (although physics on a longer length scale is treated at the m ean-eld level), how ever translational invariance is always preserved.

Unfortunately, as mentioned in the introduction, the fact that (K_n) takes its appropriate value within each reciprocal-space tile in (4) means that discontinuities have been introduced at the tile boundaries, leading for example to an unphysical Ferm i surface.

2.2. Idea of the new method

In order to remove the discontinuities in $\overline{G}(k)$ described above, an idea would be simply to interpolate the self-energy (K_n) to a smooth function (k) in such a way as to preserve the number of states. However, the problem with such an approach is that new information (e.g. structure in the DOS) would be inferred. A second problem is that of preserving causality. For example previous attempts have been made (within

the DCA) [15] to interpolate the self-energy via schem es such as the maximum entropy method (MEM). However, although the MEM is guaranteed to be causal, it can only be used to add a nite number of points to a data distribution, after which it adds spurious structure. One must use a secondary interpolation to ll in the gaps left by the MEM e.g. A kim a spline as used in the DCA [15]. However such spline interpolations are well known to overshoot the interpolation in some circum stances [16], and particulary when the data set used for the interpolation is rapidly varying the spline may violate causality. To overcom e this, more data points are required and hence a bigger cluster size, but one is still not ensured a causal interpolation for all cases. Furtherm ore, in the case of rst-principles alloy calculations [7, 8, 9] we are particularly interested in large deviations from the CPA in k-space where the self-energy will vary rapidly since only sm all clusters are computationally viable at the present tim e.

In this paper a di erent approach to the problem is introduced. First recall that in previous NLCPA calculations to date, periodic Born-von K am an boundary conditions have been applied to the cluster. This essentially means reducing the size of a conventional lattice with Born-von K arm an boundary conditions to contain only a cluster of N_c sites, so that the edges of the cluster map round to the other end in each dimension e.g.

for the cluster G reen's function, where L_1 is the length of the cluster along direction i. Since the lattice constant is unchanged, the boundaries of the BZ will remain the same, however it will now contain only N_c evenly spaced k points referred to as the set of cluster momenta fK_ng. Thus the conventional lattice Fourier transform used in the N_c! 1 limit reduces to the cluster Fourier transform given by (3). However, as mentioned in the introduction, for a given cluster there are another set of cluster momenta fK_ng satisfying (3) corresponding to anti-periodic [4, 6] B om-von K arm an boundary conditions so that quantities such as the cluster G reen's function at the edges of the cluster m ap back to minus the value at the other end i.e.

As an example, the periodic and anti-periodic set of cluster m om enta for a 2D square lattice with N_c = 4 are shown in gure 1, labelled as fK $_{n}^{P}$ g and fK $_{n}^{AP}$ g respectively. Permutations of periodic and anti-periodic conditions along each axis are also possible, for example periodic along the x-axis and anti-periodic along the y-axis and vice-versa. These are shown in gure 1 for the same example and are labelled as fK $_{n}^{P_{x}AP_{y}}$ g and fK $_{n}^{P_{y}AP_{x}}$ g respectively.

Next, recall that it has recently been explicitly shown [6] that for a given cluster the NLCPA results change with respect to the choice of $fK_n g$. Any theory with a choice of boundary condition must be invariant in its predictions of bulk properties [17] and hence at present the NLCPA can only be perceived as a unique theory above som e critical value of N_c, which depends on the model in question. Moreover, below this critical value of N_c it has been explicitly shown that the periodic and anti-periodic DOS results on their own are not meaningfuldue to the discontinuities [6]. The main idea of the method introduced in this paper is to appropriately combine the results obtained with the various boundary conditions to give a unique and meaningful result for any given cluster.

First note that, signi cantly, the set of K $_n$ points associated with each boundary condition is shifted compared to the others so that no overlap occurs. This can be




Figure 1. (colour online) Shown (left) are the sets of cluster momenta fK_n^Pg (denoted by asterisk) and $fK_n^{AP}g$ (denoted by circles) centred at their corresponding tiles. Shown (right) are the sets $fK_n^{P_XAP_Y}g$ (denoted by plus) and $fK_n^{P_YAP_X}g$ (denoted by trangles) centred at their corresponding tiles. Note that is situated at (0;0), X is situated at (0; $\frac{1}{a}$) and ($\frac{1}{a}$;0), and M is situated at ($\frac{1}{a}$; $\frac{1}{a}$).

clearly seen in gure 1 for the 2D square lattice example. Next, let us label the G meen's function (given by (4)) obtained using a particular boundary condition by $\overline{G}_{i}(k)$ and its corresponding set of cluster momenta by $fK_{n}g_{i}$, where $i = P;AP;P_{x}AP_{y}P_{z}$: etc. Note that on account of the coarse-graining procedure outlined in section 2.1, by construction $\overline{G}_{i}(k)$ is a better approximation to the exact result in the region of reciprocal space close to each of the points $fK_{n}g_{i}$ (in fact other $\overline{G}_{j}(k)$ with $j\overline{6}$ i have discontinuities at $fK_{n}g_{i}$). This suggests that one should construct a new G meen's function $\overline{G}_{M}(k)$ which follows each $\overline{G}_{i}(k)$ close to each of its corresponding set of cluster momenta $fK_{n}g_{i}$ only, sm oothly joining up with the other $\overline{G}_{i}(k)$ close to their set of $fK_{n}g_{i}$. Such a combined solution $\overline{G}_{M}(k)$. Furtherm ore, the problem of discontinuities is autom atically rem oved since no solution would be followed where it has a discontinuity.

In addition to yielding a new mixed G reen's function \overline{G}_M (k) which is fully k-dependent with no discontinuities, observe that the method e ectively increases the number of tiles dividing up the BZ. This leads to a better sampling of the BZ and is thus expected to yield meaningful bulk quantities such as density of states. The strict criteria that the method must satisfy are outlined in the next section.

2.3. Form alism : Introduction of continuous k-dependence

In section 2.2 it was proposed that a new unique solution (G reen's function) may be constructed by combining solutions associated with the dimension of $fK_n g$. We propose the following criteria that the combined solution \overline{G}_M (k) must obey:

- (i) Follow the individual solutions through their associated K $_{\rm n}$ -points (hence yielding a meaningful D O S).
- (ii) Be based on a well founded mathematical principle such as the variational principle.

- (iii) Y ield a spectral function A_B (k) with no discontinuities.
- (iv) Be causal everywhere in k-space.
- (v) Conserve the total num ber of electron states $\ensuremath{\mathbb{N}}$.
- (vi) Retain the point-group symmetry of the lattice.

Here we propose that a generalm ixed solution \overline{G}_M (k) satisfying all the above criteriam ay be written in the form

where $_{i}(k)$ is the mixing parameter of the solution $\overline{G}_{i}(k)$ de ned by (4), with i = P; AP:: etc. This mixing parameter is generally k-dependent with range

For example, for the case of a 2D square lattice the new Green's function may be written as

where each $_{i}(k)$ is to be determ ined. The new G reen's function $\overline{G}_{M}(k)$ will obviously yield a new set of bulk properties and a unique DOS with its own Ferm i energy E_{F} . The spectral function can then be de ned in term s of $\overline{G}_{M}(k)$ by

Using \overline{G}_{M} (k), a new self-energy $_{M}$ (k) may also be de ned from Dyson's equation

In Appendix A it is shown that \overline{G}_{M} (k) satis as criteria (iv) and (v) above for any set of mixing parameters $_{i}(k)$ satisfying (8) and (9). Next, in section 2.4 it is shown generally how to choose a speci c set of $_{i}(k)$ so that the remaining criteria are satis ed.

2.4. Form alism : Choice of (k)

Given the functional requirements described in section 2.3 that the $_i(k)$ must satisfy, one may narrow down a choice of suitable functions. First, $\overline{G}_{M}(k)$ must follow each $\overline{G}_{i}(k)$ as close as possible to its associated set of cluster momenta fK $_{n}g_{i}$. As explained in section 2.2 and is clear from gure 1, this enables one to remove all discontinuities since no solution will be followed at its corresponding tile boundary where the discontinuities occur. Speci cally, $\overline{G}_{i}(k)$ must be a function that is equal to 1 in the tile centres fK $_{n}g_{i}$ and so each $_{i}(k)$ must be a function that is equal to 1 in the tile centres fK $_{n}g_{i}$ and so one has a value of $_{i}(k) = 0$ on the tile boundaries. Thus the discontinuities in $\overline{G}_{i}(k)$ are removed by cancellation with $_{i}(k)$. $\overline{G}_{i}(k)$ must also be a periodic function in k-space with the same periodicity as fK $_{n}g_{i}$. Therefore $_{i}(k)$ should be expandable in a Fourier series made up of terms

from (3). We also want to base our choice on a mathematical principle that gives a unique solution.

Generally for this system we can de ne a potential that is proportional to the density of states $(D \cap S)$

For example if a power of the system energy E^n is used as the proportionality factor one can immediately see that the moments (e.g. band energy) will be directly a ected by the choice of $_i(k)$. Hence, the choice of $_i(k)$ cannot be considered arbitrary, one must aim to minimize through $_i(k)$. At any point in k-space there will be an associated potential

between \overline{G}_{M} (k) and \overline{G}_{i} (k). Each _i (k) has well de ned lim its, since at its K n-points it should be at a minimum, where the NLCPA coarse-grained \overline{G}_{i} (K n) are considered best. A loo it will be a maximum on the tile boundary where \overline{G}_{i} (K n) is unde ned and is at its worst. From section 2.3, _i (k) is independent of the value \overline{G}_{i} (k), and hence our mixing potential (14) will have the same proportionality factor for each _i (k) which we can denote by the value . The total potential of _i (k) is hence given by

Notice that (k) at the K_n points will be solely attributed to the associated $\overline{G_i}(k)$ at that point and vice versa on its tile boundary and we have assumed no functional form for $_i(k)$. W ith the boundary conditions on how each $_i(k)$ must behave well de ned we seek to minimize (15). To solve this problem one must notice that (15) can be mapped directly to the potential of a static membrane [18] described by the general solution of the wave equation u(k), related to $_i(k)$ by

since $1=2r u(k) \pm u(k)$ to a rst order is proportional to that of a potential stored in a static membrane [18]. Hence the sum of $_i(k)$ is equal to the di erential surface area of the membrane m apped out by u(k). We wish to minimize the total potential

 i_{i} (k) while treating all i_{i} (k) equally. M in in ization of (16) gives the well known Euler (Laplace) equation describing wave motion

that is solved generally for a membrane of the same dimensions as the tile for the problem i.e.we only allow waves that can propagate according the boundary conditions of $_{\rm i}$ (k).

Example: 2D square lattice As an example, for the 2D square lattice u has the general form

where the origin is de ned at the -point in the rst Brillouin Zone, L_x and L_y are the lengths of the cluster (principle vectors) along the x and y directions respectively, and A is a complex constant. Substituting (18) into (16) gives

where i (k) can now be determ ined by comparison of (19) and (9) to yield


Each $_{i}(k)$ can be seen to uphold their respective boundary conditions given in section 2.3. Each solution to $\overline{G}_{i}(k)$ is thus treated equally while removing all discontinues and minimizing the potential (k), and that of given the restrictions on $_{i}(k)$.

Note that each $_{i}(k)$ smoothly varies between a value of 1 at fK $_{n}g_{i}$ and 0 at the associated tile boundary and has the sam e periodicity as the tiling. A lso, because the sum over $_{i}(k)$ in (9) is always satis ed even at the tile boundaries one can see that all discontinuities are rem oved because the solution remains continuous and bounded (lies in the range between the smallest and largest solutions of $\overline{G}_{i}(k)$ given by (8)). At the k-points where there are no fK $_{n}g_{i}$ the method will take a mix of $\overline{G}_{i}(k)$ with weights corresponding to the locality of their fK $_{n}g_{i}$ points. It is also worth mentioning the limiting cases of N $_{c}$ = 1 and N $_{c}$! 1 . When N $_{c}$ = 1 all $\overline{G}_{i}(k)$ will equal the same CPA value. This is because there will only be one tile (which encom passes the whole B rillouin Zone) where $_{i}(k)$ always satis es (9), thus $\overline{G}_{M}(k)$ will also equal the CPA value. When N $_{c}$ approaches in nity all $\overline{G}_{i}(k)$ will approach the exact solution for $\overline{G}(k)$ given by (2) hence so must $\overline{G}_{M}(k)$ because (9) bounds them within the range of $\overline{G}_{i}(k)$. A lso note that (18) can be extended to 3-dimensions with the inclusion of a k_{z} term of the same form of the other dimensions, where all mathem atical properties of $_{i}(k)$ shown for the 2D case will hold.

3. Results

3.1. Validity of the new method

The ideal test case for the validity of the new method is the simple 1D tightbinding model investigated in [6]. This is because in 1D the exact result can be obtained numerically. Also, uctuations are much more significant in 1D and so detailed structure is expected in the DOS which can be accurately compared with

both the exact result and other cluster theories such as the embedded cluster method (ECM) [19] and molecular coherent-potential approximation (MCPA) [10]. Indeed, in the absence of chemical short-range order the NLCPA results should be very similar to those of the ECM and MCPA since the elects of self-consistency are less signil cant in the random case. Note that in 1D there are only two NLCPA boundary conditions that are possible (periodic and anti-periodic) and the new mixed G reen's function is given by the simple expression

Figure 3 in [6] shows the exact DOS plot for a random A 50 B 50 alloy of constituent site energies $V_A = +2.0$ and $V_B = -2.0$ (or written more concisely $V_1 = -2$) with hopping parameter W = 1.0, together with the conventional CPA result. Figure 2 in this manuscript shows results for the sam e model obtained using the ECM, MCPA (averaged over all cluster sites) and the NLCPA for cluster sizes $N_c = 2;4;6$. The NLCPA anti-periodic N $_{\rm c}$ = 2 result is the same as the CPA here due to symmetry. First note the large di erence between the periodic and anti-periodic NLCPA results for these sm all cluster sizes. Signi cantly, both the periodic and anti-periodic results only resemble the ECM and MCPA over particular and di erent energy regions. Indeed, troughs are present at certain energies which are not seen in either the ECM or M C PA results or the exact result given in gure 3 of [6]. These unphysical features are caused by the discontinuities in the Green's function. On the other hand, the new mixed NLCPA result reassuringly looks remarkably similar to both the ECM and MCPA results for all cluster sizes, with unphysical features rem oved and troughs and peaks in the DOS which can be associated with specic cluster disorder con gurations. Note that allNLCPA results become increasingly similar as the cluster size increases and eventually converge to the same result at the critical cluster size of N $_{\rm c}$ = 12 [6].

3.2. Ferm i surface of a two-dim ensional model alloy

In the 2D case of the NLCPA (and DCA) for system swith G reen's functions of the form (4), spectral features are unphysical for sm all cluster sizes due to the coarse graining procedure. By having only a small num ber of tiles any large discrepancy in the selfenergy will result in a large discontinuity at the tile boundaries and hence a B loch spectral function that remains essentially coarse grained in each tile. Furtherm ore, this behaviour will be most evident near energies that represent constituent ordered and clustered alloy states. Bulk quantities may as a result display features that overcom pensate for short range correlations. For example in the DCA the stable d-wave state observed for N_c = 4 in the doped repulsive 2D H ubbard m odel [20] was later argued to be unfounded in comparison to exact results [21]. The reason for this is that the $N_{c} = 4$ periodic case exaggerates cluster induced d-wave behaviour by the coarse graining procedure. Hence the DCA using periodic boundary conditions can only be deem ed to correctly predict such features for large cluster sizes [22]. It is very important from an alloy point of view to improve upon the results available from small periodic clusters, since a rst principles treatment of large clusters would require an unrealistic amount of computational power (at the present time N $_{\rm c}$ < 4 cluster sizes have been investigated [8, 9]). In this section we again backup the validity of our method with a DOS comparison, then investigate some of the new interesting Ferm i surface physics possible with the new in plementation of the NLCPA. Also note




Figure 3. (colour online) (top) Split-band N_c = 4 (W = 0.25;V_i = 1) density of states (DOS) using periodic (P), antiperiodic (AP), antiperiodic along x-axis (P_yAP_x), anti-periodic along y-axis(P_xAP_y), and mixed (M) solutions, calculated from their respective G meen's functions. Where the DOS for (P_yAP_x) and (P_xAP_y) are the same by symmetry. To demonstrate the bounding of the mixed G meen's function in k-space, cross-sections of A_B (k) at E = 1 are also plotted along the high symmetry axis X (centre) and M (bottom). The mixed solution A_B (k) can be seen to remove discontinuities introduced by artefacts of the original NLCPA coarse graining procedure at tile boundaries e.g =2a. Any antefacts of the original coarse of the separate $\overline{G}_{i}(k)$.





Figure 4. (colouronline) A_B (k) at E = 1:02 and $N_c = 4$ (W = $0.25; V_i = 1$), plotted for the CPA (top-left) and NLCPA-M ixed (top-right) in k-space. Also shown is the plot zoom ed in to the rst quadrant of the Brillouin zone for CPA (bottom -left) and NLCPA-m ixed (bottom -right) and the anisotropic di erence A_B^{CPA} (k) A_B^M (k) (bottom -centre). The colour scale for A_B (k) represents white as peaks going through yellow and red to troughs as black. The colour scale for the anisotropic di erence A_B^{CPA} (k) A_B^M (k) represents positive peaks as yellow going through red and blue to negative peaks as black.

that we have used the concise convention of labelling the V_A and V_B atom ic potential parameters by $V_i \quad V_A$ since we only use atom ic potentials symmetric about E = 0 i.e. $V_B = \quad V_A$.

For this simple alloy model we investigate the rst available cluster after $N_c = 1$ (CPA) i.e. $N_c = 4$ with a nearest neighbour hopping interaction W = 0.25 and cluster principle vectors $L_y = L_x = 2a$. We maintain the same disorder and constituent alloy concentrations as in the previous section for the 1d model i.e. a random $A_{50}B_{50}$ alloy. The 4-site cluster is the ideal test case since the di erence between $\overline{G}_i(k)$ should be large and so any improvement given by $\overline{G}_M(k)$ over $\overline{G}_P(k)$ should be clear. The interaction W has been given the same value as previous work [2] in order to compare with the DOS calculated there for the periodic $N_c = 32$ case. For this lattice all solutions for $\overline{G}_i(k)$ can be considered almost indistinguishable from each other at $N_c = 32$ [2, 4], and hence [2] provides a reliable guide to what the exact DOS should be. We rst exam ine the DOS (gure 3) for the case of $V_i = 1$ where the band has split and the nonlocal e ects should be large, where we will denote the periodic DOS

by $D \cap S_P$ etc. A some might expect we see that $D \cap S_P$ shows large uctuations around $D \circ S_{CPA}$ (the same as $D \circ S_{AP}$ by symmetry) that are unrealistic when compared to previous work [2]. Particulary the extra peak form ation is much stronger, and results in the DOS being far too low at the troughs between peaks with 2 extra sem i-bands being form ed near the main band gap. Indeed in the literature, for the N_c = 32 case there is never such a large drop below the DOS $_{CPA}$. Looking now at the new mixed result $D \circ S_M$ one sees that the large oscillations associated with $D \circ S_P$ are no longer present but the structure is much more like that of the N $_{\rm c}$ = 32 case. Of note is how the large troughs of DOS_P are lied in: the DOS can be seen to lim the band gap, as well as the central peak becom ing prom inent over the adjacent structure. In sum m ary we see there is a shifted and heightened peak at E 1:02 and a second peak em erging at E 0:79, that overall corresponds to a clear in provem ent over all N_c = 4 solutions separately as well as the CPA. This is more strong evidence that the mixing of NLCPA solutions is physical for this model when carried out using the method described in this paper.

The structure of DOS_M is a consequence of how A_B^M (k) behaves in k-space as shown in gure 3. By following each solution according to the weighting function $_i(k)$ the new solution \overline{G}_M (k) removes discontinuities at all tile boundaries (irrespective of cluster size) giving a smooth representation of the Bloch spectral function. In gure 3 cross-sections of the spectral function A_B^M (k) for an example energy show how the new solution is bound and how it is an improvement. Where discontinuities are present, the solution switches and uses a supposition of the ones that remain analytic. For example A_B^M (k) at the -point must be equal to the periodic solution A_B^P (k) since all other solutions have a tile boundary at that point, and so their associated $f_i(k)g = 0$.

A comparison can be made for the new spectral function A_B^M (k) taking the Ferm i energy at $E_F = 1.02$ (corresponding to the main DOS peak of the mixed solution) with the CPA spectral function for the same energy value, as shown in gure 4. Again, som e quite rem arkable features are apparent, m ost notably the topological change induced by a kink halfway along the X X direction (not possible in the CPA) giving rise to a transition from a circular-like surface to a diam ond-like surface centred on the -point, and vice versa for the surface centred on the M -point. This is quite dram atic since a Ferm i surface (de ned spectral function peaks) taken at this energy would now have a whole new set of nesting vectors such as the vector along X. Moreover, these 'rounding' and 'squaring' features of Ferm i surfaces Х not seen in the CPA calculations have been observed experimentally. For example, the work of W ikinson et al [11] gives a clear example for $Cu_{1,x}Pd_x$ where the diam ond-like Ferm i surface on the (100) plane predicted by the KKR-CPA is actually found experim entally to be rounded. Furtherm ore, sm earing and the associated width of peaks regains a k-dependence that produces so-called hotspots' along the Х directions as shown by dark patches in the di erence between the CPA and mixed NLCPA. This e ectively produces necking in the surface at the X -point in the direction Х м.

In the nalset of results shown in gure 5 we exam ine the Ferm i surface for the half-led band with $E_F = 0$. This is the same for all $N_c = 4$ NLCPA solutions and the CPA by symmetry. A Ferm i surface is only visible at this energy when there is nite DOS and so we exam ine the properties where there is a breakdown of V intual Crystal (VCA) behaviour to a two-band system. This is achieved by increasing the value of the atom ic potentials V_i from zero. In the CPA one sees a transition from a band with a central peak in the DOS, associated with a van Hove singularity at E_F ,

to two peaks close to V_i that represent the inclusion of states from both constituent metals [19]. However, although this was a great breakthrough at the time of the discovery of the CPA, no such behaviour is observed in k-space. Sitting in the overlap of metal bands one would expect the Ferm i level to cross electron states from both m etals and hence produce a m ore com plicated Ferm i surface. How ever, because the CPA has no k-dependence in the correction to the VCA only emerges through an increased smearing $\frac{1}{1}$ / Imf (E_F = 0)g. There is no topological change in this system since R ef (E $_{\rm F} = 0$)g = 0. This is because the alloy potentials are equidistant from zero and so neither constituent has a preferential weighting. The CPA Fermi surface is the same as the VCA Ferm i surface at this energy and alloy concentration i.e. a straight line joining X -points. W ith the inclusion ofk-dependence in the NLCPA a transition to a more complicated form should be possible. However, associated with such a transition (near a van Hove singularity) are very large uctuations in the correction to k-space between coarse grained tiles that are not identical. Hence, the standard (periodic) solution to the NLCPA does not produce a physical result in this regime. However, dram atically, we can now start to investigate such phenom ena using the new mixed solution to the NLCPA. Results are plotted in gure 5 for increasing V_i and show how a topological transition occurs at V_i 0:39 from a CPA-like Ferm i surface. The Ferm i surface splits by introducing new circular surfaces around M and -points and also new necking features around the X -points, in contrast to the CPA which only displays increased smearing. This is very in portant because of the new nesting vectors introduced [13, 14]. The emergence of this necking around X -points is very similar to that observed in recent work for the shape-m em ory alloy N i32A l68 [23]. Com parison of rst-principles KKR-CPA calculations and experiment show the KKR-CPA does not predict a necking feature in the Ferm i surface at the X -points of the Brillouin zone. The KKR-CPA retains a at surface associated with a van Hove singularity; the topological discrepancy is argued to be the result of the Ferm i level being close to a van H ove singularity in the DOS.AsVi is increased further the surface around M becomes prominent and may be associated with states on the band edges of the pure A and B m etal states em erging ie clustering of A's or B's, and it is believed X -point features are associated with ordered alloy states. These points will be further investigated in future work based on this paper [24] which will also incorporate chem ical short-range order (which can be introduced by weighting the cluster probabilities) and concentration dependence $A_x B_{1,x}$.

4. Conclusions

This paper has presented a method for calculating the spectral function within the NLCPA. The method is general and can be applied to any (allowed) cluster for any lattice in any dimension, and the obtained spectral function is fully k-dependent, continuous, and causal. Furthermore, we believe the method to be the correct implementation of the NLCPA for cluster sizes below the critical cluster size (see introduction) since it yields meaningful results for bulk properties such as the DOS and converges system atically as the cluster size increases.

As an illustrative example, we have applied the method to a 2D tight-binding model alloy. Dramatically, a topological transition is clearly observed in the Ferm i surface as the difference in core potentials is varied in the split-band regime. Furthermore, Ferm isurface splitting has been observed producing new nesting features previously not observed in the conventional CPA. This occurs even in the absence of chem ical short-range order (SRO) which could be straightforwardly included by appropriately weighting the ensemble of cluster probabilities.

Clearly, it would be bene cial to apply the method within rst-principles calculations. Indeed, a derivation and in plementation of the spectral function has recently been given within the rst-principles KKR-NLCPA multiple-scattering theory in [25]. However, only the periodic set of cluster momenta fK ng are used and no attempt is made to remove the discontinuities. It is our intention to combine the method in this paper with the form alism of [25], and investigate the elects of SRO on Ferm i surface features of systems such as CuP d [11].

Finally, note that the one electron spectral function of correlated electron systems also have nite widths. Moreover, they can be measured in angle-resolved photoem ission experiments (ARPES). As they are due to dynamical uctuations related to the many-electron system they can be described by the DCA. Indeed, the DCA has recently been used to interpret such experiments [15]. The method proposed here for calculating the spectral function in the NLCPA can be directly transferred to the analogous calculation in the DCA and thus it may be useful in this context as well as in the study of random alloys.

Appendix A. Proof: causality and conservation of states

It is straightforward to see that the new mixed G reen's function \overline{G}_{M} (k) is always causal. Provided the set of mixing parameters satisfy (8) and (9), it follows immediately from (7) that \overline{G}_{M} (k) will always be bound between the individual solutions \overline{G}_{i} (k) in k-space. Since these individual solutions have an imaginary part that is positive de nite and hence are causal [2], this implies that \overline{G}_{M} (k) must also have an imaginary part which is positive de nite and hence is causal.

In order to prove that the m ixing scheme preserves the total number of electron states N, we introduce $_{i}(k)$ as as a coarse grained quantity in k-space $_{i}(k) = _{i}(K)$, where fK g are an arbitrary set of k-points within the BZ that are each centred on a coarse grained tile. If we also de ne M $_{c}$ as the total number of tiles (independent of N $_{c}$), we have a step function 0 $_{i}(K)$ 1 that has M $_{c}$ possible values. For M $_{c} = 1$ we have the sim plest form of averaging with $_{i}(k)$ having no k-dependence, equivalent to a weighted average over the DOS. For M $_{c} > 1$ coarse grained k-dependence is introduced to the mixing of $\overline{G}_{i}(k)$, and M $_{c}$! 1 representing the introduction of com plete k-dependent mixing. We wish to show that conservation of electron states applies to all values of M $_{c}$. To do this we integrate (7) over the coarse grained $_{i}(k)$

where the small k-dependence has been integrated out, leaving a new coarse grained version of \overline{G}_{M} (k), \overline{G}_{M} (K). Integrating (A 1) over all energies 1 E 1, we

obtain

where N_M (K $_n$) and N_i (K $_n$) are the total num ber of electron states for the m ixed and i-th NLCPA solutions respectively for the tile centred at K \cdot . Note that this requires

(K) to be energy-independent to keep N_M in terms of N_i i.e. we do not want to infer any new self-consistency condition on N_M to conserve N apart from the NLCPA. Since each solution satis es the conservation laws separately and electron states are evenly distributed across the B rillouin zone, we have N_i(K_n) = N=M_c for each i. Now (A 2) becomes

Provided (8) and (9) are satisfied so that \overline{G}_{M} (k) is bounded between the individual solutions at every point in k-space, we have for any M_{c} , $N_{M} = N$. In particular we are free to use the M_{c} ! 1 limit to introduce fully k-dependent mixing of \overline{G}_{i} (k).
