# D epletion e ects and loop form ation in self-avoiding polym ers

#### Abstract

Langevin dynam ics is em ployed to study the looping kinetics of self-avoiding polym ers both in ideal and crow ded solutions. A rich kinetics results from the com petition of two crow ding-induced $e$ ects: the depletion attraction and the enhanced viscous friction. For short chains, the enhanced friction slow $s$ dow $n$ looping, while, for longer chains, the depletion attraction renders it $m$ ore frequent and persistent. W e discuss the possible relevance of the ndings for chrom atin looping in living cells.

The kinetics and therm odynam ics of the folding of a exible polym eric_chain_into a loop are central issues in
 classic problem has been fuelled by the introduction of novelm anipulation techniques ['క్ర-1] that provide unprecedented insight into the $m$ echanics and exibility of various biopolym ers. In particular, it hasbeen show $n$ that, in the cell nucleus, DNA regions separated by several m's on the genetic $m$ ap can nevertheless be in $m$ olecular contact [1] $\left[\begin{array}{l}1 \\ 1\end{array}\right]$. Is such looping generated by active $m$ echanism $s$ (e.g. m olecular $m$ otors), or $m$ erely by passive them odynam ic mechanism s (e.g., di usion)? Som e light can be shed on these issues by com paring experim ental observations with the statistics and dynam ics of looping predicted by general polym er $m$ odels. T he system atic application of this strategy has so far been hindered by the dependence of cyclization dynam ics on $m$ any time scales even for the sim plest phantom polym erm odels [i]

Here, we go beyond the treatm ent of phantom chains and focus on the im pact of steric e ects. W e not only consider the polym er self avoidance $\left[\begin{array}{l}1 \\ 1\end{array}, \bar{\prime}, \overline{1} 1\right]$ but also incorporate exchuded volum e interactions of the chain with a surrounding crow ded environm ent, treated as a collection of sm all m onodisperse globular particles ( m icrospheres) which induce an entropic attraction on larger ob jects in solution 期]. To date, the investigation of this intriguing depletion e ect, has been mainly studied in poly-
 crow ding a ects the behaviour of a single self-avoiding polym er thus represents a novel and im portant topic in m acrom olecular physics. It also has im $m$ ediate im plications in cell and system s biology, as cells are so crow ded w ith globular proteins and RNA s [1d, 1 show that crowding a ects the occurrence and persistence of loops in self-avoiding polym ers in diverse ways, according to the length of the polym er chain and the size of the constitutive $m$ onom ers. Besides uncovering new physics, our results $m$ ay be relevant to the understanding of chrom atin looping in vivo. Speci cally, we w illdiscuss w hether and to what extent the depletion attraction $m$ ay explain existing observations in cell.biology that active polym erases, attached to chrom atin, cluster
into supram olecular \factories". of up to m size during transcription and replication [ $\left.{ }_{[1 / 3}{ }^{-1}\right]$.

A traditional string-and-beads $m$ odel will be used to describe polym er chains. W e consider tw o sim ple cases: a plain self-avoiding string of N equally-sized spherical beads of radii $\mathrm{R}_{\mathrm{i}=1 ;::: ; \mathrm{N}}=12.5 \mathrm{~nm}$, and one w th larger beads at the ends. This sphere size was chosen to relate our polym er to an eukaryotic chrom atin ber, whose e ective diam eter and persistence length are both 25 nm [ $\left.]_{1}^{-1}\right]$. The case of larger end beads is instead $m$ otivated by the study of chrom atin loops w ith an attached genom e-grabbing $m$ achinery (a large transcription or a replication complex which locally increases the e ective ber diam eter! [ $[13]$ ). The potentialenergy, when the centres of beads $i$ and $j$ are at a distance $d_{i ; j}$, is

where 1 and 2 are respectively 0.24 and 70 units of therm al energy, $\boldsymbol{B}^{T}, a=4 \mathrm{~nm}{ }^{1}$, and $d_{i, j}^{0}=R_{i}+R_{j}$ is the contact distance ofbeads $i$. The rst term in eqn. (II) en forces the hard-core repulsion for contacting pairs, while the second provides an attraction betw een consecutive beads on the chain. Interplay betw een the two term $s$ produces a self-avoiding FENE chain []'] where, at tem perature $\mathrm{T}=300 \mathrm{~K}$, the distance betw een consecutive beads uctuates by about 0.5 nm around 25 nm . The m icrospheres have radius $\mathrm{r}=2: 5 \mathrm{~nm}$ and occupy a fraction $=0: 15$ of the total available volum e. T hese values conservatively re ect the crow ding of the cellular environm ent $m$ ostly due to RNA and proteins $[13$ id. Because the value of considered here is $m$ oderate (see $F$ ig ${ }_{1}^{1}$ we can resort to the approxim ate A sakura-O osaw a (A O ) treatm ent $[\underline{[ } \overline{1}]$, which does not require to sim ulating explicitly the dynam ics ofm icrospheres. M ore precisely, in addition to the term of eqn. ([11) , the polym er is sub ject to the follow ing e ective interaction potential:

step function ensures that the AO depletion interaction vanishes at distances $>d^{0}+2 r\left[{ }_{[10}^{1}\right]$. A s r is su ciently sm aller than the radii of the chain beads it is legitim ate to disregard in $(\underline{Z})$ three- and $m$ any-body interactions. The evolution of the system, carried out for various $N$, sizes of end spheres and values of w as described by overdam ped Langevin dynam ics

where runs over the $C$ artesian com ponents, $x_{i}$ is the position of the ith bead and the stochastic white noise term obeys the uctuation-dissipation condition: $h i=0$, $h_{i}(t){ }_{j}\left(t^{0}\right) i=2 ; i ; j \quad\left(t ; t^{0}\right) k_{B} T \quad i$. The friction term i was obtained from the Stokes $£$ instein [1] [1] relationship: ${ }_{i}=6(1+2: 5) R_{i}$ where $=5 \mathrm{cP}$ [ [1] Langevin equation was integrated num erically by $m$ eans of a predictor-corrector schem e [1] [] and a tim e step of 15 ps. The viability ofeqn. (3'1) w as ascertained by a prelim inary successfulcom parison of various dynam ic and equilibrium properties w ith those produced by underdam ped dynam ics (w th $m$ asses deduced from typical densities of biopolym ers, $=1: 35 \mathrm{~g} / \mathrm{cm}^{3}\left[\bar{l}_{-1}^{\prime}\right]$ ).

The dynam ical evolution was followed starting from random ized non self-intersecting con gurations of chains with 3 N 30 beads. W hen investigating how looping dynam ics is a ected by the size of the contacting spheres,
we set $N=10$ and varied the radius of the end spheres, $R_{1}=R_{N}$, w thin 12.5 and 43.75 nm . The form ation of loops $w$ as detected by $m$ onitoring the end-to-end distance, $\mathrm{d}_{1 ; \mathrm{N}}$ and com paring it to the range of the depletion attraction, $d_{1 ; N}<\left(d_{1 ; N}^{0}+2 r\right)$. To have a well-de ned com parison term, the sam e criterion for loop form ation was adopted in the absence of crow ding e ects/agents (i.e. $=0$ ). Typical evolutions of the end-to-end dis-
 analysed to highlight how depletion interactions a ect the looping kinetics and the chains equilibrium structural properties. For the latter issue several geom etrical descriptors w ere considered: the radius of gyration, virial coe cients and the distribution of localchiralities
 $m$ alised bond vector joining residues $i$ and $i+1$. For looped con gurations we also calculated the writhe and crossing num ber, averaged over hundreds of random ly oriented two-dim ensional projections [1]d]. C onceming the looping dynam ics we instead characterize the evolution of the system in term sof the $m$ ean rst looping tim e (MFLT) and the mean- rst unlooping time (MFUT), which we establish through the follow ing novel procedure apt for num erical im plem entation. For very long, and hence them alised, tra jectories the M F LT is obtainable by picking at random unlooped conform ations and $m$ easuring the time to the rst looping event. $C$ on $g u-$ rations in a speci c \unlooped tim e interval" ofduration $u$ $w$ ill be picked $w$ ith weight equal to $u$ and their average rst looping time will be $u=2$. The MFLT can thus be expressed in term s of the average duration of unlooping intervals and its second $m$ om ent: $M F L T=\frac{1}{2} \frac{h_{u}^{2} i}{h_{u} i}$. An analogous form ula holds for the MFUT. The average values of MFUT and MFLT (we have veri ed that the rst twom om ents of looping and unlooping intervals are nite) and their uncertainties were calculated over 10 independent tra jectories having $m$ axim um duration ranging from 0.1 s for $\mathrm{N}=3$ to 10 s for $\mathrm{N}=30$.

We rst discuss the structuraldi erences of the generated con gurations. The short-range depletion attraction produces a reduction of the e ective size of the polym er. For the largest $N$ considered, where $m$ ost conform ations are unlooped, the radius of gyration decreases by 10\% when goes from 0 to 0.15. T he depletion attraction also im pacts on the chain structuralorganization. Indeed, the geom etrical com plexity of looped chains is enhanced by crow ding and the average crossing num ber increases w ith
( $F$ ig. ${ }^{\prime \prime} 11 \mathrm{c}$ ). This is akin to what occurs in random rings upon compacti cation [ilp]. At variance $w$ th this case, the developm ent of a striking trim odal character of the chirality distribution indicates the em ergence of a peculiar structural organization (see Fig. ${ }_{1}^{1} 1 \mathbf{1}$ d). T hough the chiral biases are local, and hence do not lead to longrange structural order, they provide qualitative support to the recent suggestion of Snir and K am ien that deple-

tion $e$ ects $m$ ay be su cient to drive the form ation of optim al helices in thick biopolym ens $\left.[1] 1,1,1 \underline{1}_{2}^{\prime}\right]$.

W e next tum to the analysis of the looping kinetics and discuss the behaviour of the M FUT. In the presence of $m$ icrospheres, the two contacting ends are sub ject to the depletion attraction and it $m$ ay be anticipated that the MFUT is larger than for $=0$. This expectation, qualitatively peroeivable from $F$ ig. 1 quanti ed in Fig. Ina which portrays a parallel trend of unlooping timeasa function ofN for $=0$ and $=0: 15$. $M$ oderate crow ding is enough to increase the tim e the ends spend together (form ing a loop) by a factor of 3 .

The behaviour of the M FLT ( $F$ ig. inc and d) is m ore intriguing and harder to anticipate, ow ing to two opposing tendencies. On one hand, as we saw earlier the depletion attraction reduces the e ective polym er size and hence favours looping. O $n$ the other, crow ding augm ents thee ective viscosity of the m edium, thereby slow ing the di usive encounter ofterm inalbeads. $M$ ore precisely, the Stokes $£$ instein form ula gives a $38 \%$ increase of friction coe cient when $=0: 15$ com pared to $=0$. The resulting balance betw een the two opposing e ects can be established by considering the asym ptotic expression for relaxation tim es in R ouse chains w ith excluded volume. $T$ he slow est relaxation tim e in such chains (assim ilated to
 is the scaling exponent for self-avoiding polym ers and $b$ is the e ective size of the chain $m$ onom ers estim ated

by calculating the second virialcoe cient accounting for the depletion attraction of of eqn. $\overline{\overline{2}}\left[\begin{array}{l}{[1]} \\ \hline 1\end{array}\right]$. Indeed, the data collected within the explored range of $N$, appear well com patible w th this asym ptotic relationship (see Fig. $\bar{n} 1 \mathbf{c}(\mathrm{c})$. The R ouse scaling form ula can hence be used to quantify how the crow ding-induced changes in and b ultim ately a ect the M FLT for large N. For the speci c case considered here, $=0: 15$, one nds that the M FLT is decreased by about $17 \%$ com pared to the $=0$ case. $T$ his crude asym ptotic estim ate is in fair agreem ent $w$ ith the sim ulation results for $N=15-30$ which indicate that, when $=0: 15$, crow ding decreases the M FLT by $10 \%$ or more. It is interesting to consider, within the previous approxim ate analysis, how the M FLT depends on
. This inform ation, obtained from the known functional dependence on of the friction and second virial coe cients, is shown in Fig. ${ }_{131}^{13}$ which portrays an intriguing non-m onotonic dependence: for sm all crow ding < 0:1, the di usive slow ing dom inates, while larger facilitate looping via depletion-induced crum pling of the chain.

W e nally discuss the dependence of looping on the size of the term inalbeads. W e considered chains of $\mathrm{N}=10$ beads where $R_{1}=R_{N}$ were varied betw een 12.5 and 43.75 nm . We found that the increase in end spheres size had $m$ inore ect on the MFLT which, for $=0: 15$, changed by less than $10 \%$ over the explored range ofterm inalradii. The near constancy of the M FLT is notew orthy since the change of $R_{1}=R_{N}$ from 12.5 to 43.75 nm im plies a tw o-fold increase of probability that term inal spheres contact intemal ones. In contrast, the M FUT is greatly a ected by changes in term inal radii. As ir lustrated in F ig. into for $=0: 15$ it increases approxi$m$ ately exponentially as a function of $R_{1}$ and $R_{N}$. This behaviour would be expected if the term inalbead exited the depletion well (w hose depth increases linearly with $\mathrm{R}_{1}=\mathrm{R}_{\mathrm{N}}$ ) according to sim ple A rrhenius kinetics. H ow ever, the increase in MFUT also re ects the decreased di usivity of term inalbeads as a result of the linear increase in $R$ of the friction coe cient, . This second $e$ ect, dom inated by the form er in the presence of crow ding, is readily visible in the curve pertaining to $=0$ in Fig. points $w$ ith a linear relationship in $R_{1}=R_{N}$ ( $w$ ith relative ${ }^{2}$ equal to 1.5 ), which would be appropriate if the di usion coe cient of the term inal spheres w ere the only
factor slow ing unlooping. By carrying out sim ulations for selected values of it was found that increasing enhances the $m$ agnitude of these e ects. For exam ple, with
$=0: 3$, which m ay also be appropriate for crow ding in nucleoplasm []3], the MFLT is 3 tim es sm aller, and the MFUT (w ith $R_{1}=R_{N}=25 \mathrm{~nm}$ ) 9 times longer than $w$ ith $=0: 15$.

W e now discuss the possible biological im plications of our results. A s m entioned previously, a large num ber of active DNA (and RNA) polym erases can attach to speCi c segm ents of a chrom atin ber thus increasing its local thickness. E xperim ental observations have shown that these scattered groups of polym erases eventually chuster into replication (or transcription) factories thus looping the intervening genom e. In the case oftranscription factories in eukaryotes, these structures contain 10 orm ore polym erases and having size ranging from 100 nm up to m [13]. Is there a simple physical $m$ echanism leading to their establishm ent? O ur study suggests that the form ation and persistence of these loops can be aided by cellular crow ding. F irst, using a conservative estim ate of $=0: 15$, we nd that the depletion self-interaction of the ber therm odynam ically facilitates looping (see e.g. Fig. ( $\overline{1}_{11}^{\prime}$ ). For exam ple, analysis of end-to-end distances in equilibrium show s that bridging the two ends of a 750-nm ber, which would contain 75 kilobases ofD NA [14], costs m ore than $8 k_{B} T$ in the $a b-$ sence of crow ding agents, but less than $7 \mathrm{k}_{\mathrm{B}} \mathrm{T}$ in their presence. We nd crowding dim inishes the looping cost by $1-2 k_{B} T$ for all lengths sim ulated. A 11 , or $m$ ost, of this looping cost $m$ ay be overcom e by the extra depletion attraction betw een the thicker ends of the loop, to which the transcription m achinery is attached, consistently $w$ ith recent theoretical predictions [13] $]$. Second, the results off ig. . $\overline{1}$ d dem onstrate that crow ding can also aid looping dynam ically by facilitating the di usive encounter of the ends. This intriguing result is supported by theoretical argum ents sum $m$ arised in $F$ ig. N్NT, which suggest the e ect is robust. Furthem ore, crow ding stabilizes loops once the two ends have $m$ et. The fact that theM FUT has an approxim ately exponentialdependence on the height of the depletion well ( $F$ ig. . $\overline{2}$ the role that crow ding has for the form ation of replication/transcription factories. V ia eqn. (ᄌㅍ) we estim ate the unlooping tim e of e.g. two transcription com plexes of radius $\mathrm{R} \quad 40 \mathrm{~nm}$ w th $0: 3$ can easily exceed $0.1 \mathrm{~s}\{$ a m acroscopic tim e-scale, the experim entally $m$ easured persistence tim e of factories. In living cells the life-tim e of such aggregates is probably longer because, besides other physical-chem ical factors, $m$ any com plexes $m$ ay com e together (rather than the tw o considered here) and interactions of one large bead w ith tw o orm ore others cooperatively increases the stabilization due to the depletion attraction $[\overline{[ }] \underline{Z}]$ ].

In conclusion, we have considered various kinetic and therm odynam ic aspects of polym er looping in a crow ded
$m$ edium . The process of loop form ation is controlled by two opposing e ects. On one hand looping is entropically aided in crow ded $m$ edia by the depletion e ect. O n the other, the enhanced friction of the $m$ edium hinders the di usive encounter of the chain ends. The balance of the twoe ects is found to depend both on the length of the polym er chain and on the size of the contacting ends. Speci cm odelparam eters have been used to show quantitatively that crow ding-enhanced looping form ation/persistence $m$ ay be actually exploited in living cells to prom ote the contact of actively replicated/transcribed
 T he approach outlined here dem onstrates the viability of com putational and analytical approaches to investigate the noveland stim ulating problem of crow dinge ects on a single polym er. It w ould be interesting to confront theory and experim ents on looping and unlooping tim es obtained from single $m$ olecules experim ents $w$ th and $w$ ithout crow ding agents.
