E ects of density im balance on the BCS-BEC crossover in sem iconductor electron-hole bilayers

We not only identify the crossover in the phase diagram from the BCS limit of overlapping pairs to the BEC limit of non-overlapping tightly-bound pairs but also, by varying the electron and hole densities independently, we can analyze a number of phases that occur mainly in the crossover region. With dierent electron and hole electron are diagram is asymmetric with respect to excess electron or hole densities. We propose as the criterion for the onset of super uidity, the jump of the electron and hole chemical potentials when their densities cross.

There is a growing interest in the physics of the BCS-BEC crossover, owing to the recent experimental advances with trapped Fermi atom s. With the use of Fano-Feshbach resonances, this crossover has been observed with fermionic ⁶Li and ⁴⁰K atom s [1] which become composite bosons in the BEC limit. Although trapped atom s represent an ideal testing ground for a fundamental understanding of the BCS-BEC crossover, technological applications exploiting the occurrence of condensates will most probably rely on semiconductor systems. In these systems, excitons made up of electrons and holes play the role of composite bosons.

Excitonic systems were, in fact, the rst to be considered for the BCS-BEC crossover. In bulk materials, originalwork on exciton condensation was done by Keldysh and co-workers [2]. Extension of this to the BCS-BEC crossover was proposed by Nozieres and Com te [3]. However, in bulk materials fast electron-hole recombination hinders the detection of BEC. Proposals have accordingly been made to condense excitons with spatially separated electrons and holes [4, 5]. Particularly promising are bilayer quantum -well systems separated by a distance d, with conduction-band electrons in one well and valenceband holes in the adjacent well [6, 7, 8, 9]. Recently, developm ents for the detection of excitonic BEC in coupled quantum wells has been reported [10, 11, 12]. Technological advances with electron-hole bilayers [13] make it now possible to contact separately the layers of electrons and holes in GaAs, separated by an AlGaAs barrier of thickness das smallas 15 nm.

In this paper, we consider the BCS-BEC crossover in electron-hole bilayers when the densities of the electrons and holes are varied independently of each other. The effect of the density in balance resembles that of a magnetic eld in a superconductor (disregarding orbital e ects) rst considered by Samma [14]. This analogy was also noted in Ref. [15], where the in uence of an isospin asymmetry in nuclearmatterwas considered for the BCS-BEC crossover. The species of system we shall consider as an ex-

am ple is G aA s-A lG aA s.

Recent experiments with population in balance in ultracold trapped Ferm i atoms [16] have stimulated a considerable amount of theoretical work on two-component Ferm i systems with density in balance [17, 18]. Emphasis has been placed on the possible occurrence of exotic phases in addition to the ordinary BCS pairing [17, 19, 20]. However, in these systems the presence of a trap and their charge neutrality inhibit the occurrence of the exotic phases, and so far only phase separation between a super uid core with equally matched populations and an outer normal phase has been detected.

E lectron-hole bilayers may o er a better opportunity of observing such exotic phases because the C oulom b repulsion within each layer acts to suppress phase separation [21]. In addition, we not that the dierent electron and hole e ective m asses in G aAs, m $_{\rm e}$ and m $_{\rm h}$, and also the non-local nature of the electron-hole attraction both favor the occurrence of exotic phases. These include the Sam a phase with one or two Ferm i surfaces and nite population imbalance, and the Fulde-Ferrel-Larkin-Ovchinnikov (FFLO) phase [22], as well as the ordinary BCS pairing with equal populations. The relative extension of these phases is quite asymmetric between an imbalance with more holes and an imbalance with more electrons. We also not that in the super uid phase the separate electron and hole chem ical potentials display a jump when reversing the population imbalance from more electrons to more holes, while in the normal phase no jum p occurs. D etection of this jum p could thus serve to identify super uid character in a system.

The electron-hole bilayer system is described by the grand-canonical H am iltonian:

Here, k, k^0 , and q are two-dimensional wave vectors in

the layers, is the quantization volume (surface area), (c_k) are the creation (destruction) operators for electrons (e) and holes (h) distinguished by = (e;h), the are the band dispersions with chemical pofor electrons and holes, $k_e = k^2 = (2m_e) + E_a$ and $_h(k) = k^2 = (2m_h)$. The sem iconductor band gap E_{q} can be reabsorbed in the electron chem ical potential. Explicit spin quantum numbers are om itted.

We have carried out our calculations in the zerotem perature lim it, where a mean-eld description of the BCS-BEC crossover is appropriate even in two dimensions [23]. We use an unscreened electron-hole attractive potential as in Ref. [7], $V_k^{eh} = 2 e^2 \exp(k t) = (k t)$ where $k = k_i$ e is the electron charge, and " the background dielectric constant. The gap in the superuid phase makes screening less e ective, so introducing screening should only cause small quantitative changes.

In the present calculation we neglect the intra-layer Coulomb repulsions V $^{\rm ee}$ and V $^{\rm hh}$. In the absence of density imbalance, V^{ee} and V^{hh} can be readily included in a mean-eld treatment [7], but when the densities are im balanced, including V $^{\rm ee}$ and V $^{\rm hh}$ in the m ean $\,$ eld requires a detailed know ledge of how overall charge neutrality is attained. This is in order to avoid divergence of the Hartree term. This depends on the specic engineering con guration of the device, and therefore in the interests of generality we drop V ee and V hh here. W hen the densities are equal we can compare with Ref. [7], and we have veri ed that om itting V $^{\rm ee}$ and V $^{\rm hh}$ reduces the size of the gap by an amount no larger than 30 % . As a separate issue, and as we have already noted, intra-layer repulsion should stabilize the system against phase separation. For this reason, we exclude the possibility of phase separation from our discussion of the phase diagram.

The relevant mean-eld equations to be solved for the variables e, h, and the (s-wave) gap function k are:

where $f(E) = (p \frac{E}{2})$ is the Ferm i function at zero tem – perature, $E_k =$ $\frac{2}{k} + \frac{2}{k}$ with $k = (\frac{e}{k} + \frac{h}{k}) = 2$, and k)=2. In addition, $_{k}$ w $\sharp h$ $_{k}$ = ($_{k}^{e}$ $v_k^2 = 1$ $u_k^2 = (1 k = E_k) = 2$. Throughout, we express lengths in units of the e ective Bohr radius a, and energies in units of the e ective Rydberg Ry [24]. In two dimensions the average interparticle spacing is $r_s = [(n_e + n_h) = 2]^{1=2}$.

Figure 1 (a) shows the wave-vector dependence of k for equal densities, layer separation d = 1, and several values of r_s . These values of r_s and a layer sepa-




FIG. 1: (a) W ave-vector dependence of the gap function for = 0, d = 1, and several values of r_s ; (b) M axim um value max = maxf kgvs for d = 1 and several values of r_s .

ration of d = 1 are already experimentally attainable. The wave-vector position $k_{\text{m ax}}$ of the peak in the gap function is seen to evolve from a nite value in the BCS regime (small r_s) toward zero in the BEC regime (large r_s), while the corresponding value m_{ax} of the gap function attains its maximum for intermediate values of rs. This is a generic feature of the density-induced BCS-BEC crossover [25].

We have veried for several values of the distance 4 that the optim all value of r_s at which m_{ax} attains its largest value is located close to the value of r_s where the average chem ical potential = $(_e + _h)=2$ crosses zero. Ford = 1 this occurs near r_s = 3. This nding is in line with results for the BCS-BEC crossover with a contact potential in three dim ensions, namely, that super uid properties are more robust in the region located between the Fano-Feshbach resonance and the vanishing of the chemical potential [26]. The narrow region lying between the optim al value of $r_{\rm s}$ and the value corresponding to = 0 thus identies the middle of the crossover region between the BCS and BEC regimes for the electron-hole bilayer.

Thee ect of the density im balance $(n_e n_h) = (n_e +$ $n_h)$ on $_{\text{max}}$ is shown in Fig.1(b). We see that the density im balance acts to reduce the magnitude of the energy gap and that it has dierent e ects on the two sides of the crossover. In the BCS regime, the mismatch of the Ferm isurfaces for electrons and holes strongly a ects the




FIG. 2: Zero-tem perature phase diagram for d = 1, showing the stability domains of the di erent phases: Normal (N), Sarma (S1 and S2), and FFLO. The dashed line corresponds to the curve = 0, and the dash-dotted line separates the S1 and S2 phase. Note the logarithm ic scale for $r_{\rm S}$.

super uid properties of the system . The super uid properties are lost when the Ferm ienergies m ism atch becomes large compared with the value of $_{\rm m\,ax}$ for equal densities. For $r_{\rm s}$ small this occurs for a small value of . In the BEC regime, the super uid properties are less sensitive to density imbalance, whose maine ect is then to reduce the number of electron-hole pairs.

Figure 2 shows the zero-tem perature phase diagram for d=1. We can identify various phases using $_{\rm k}$, determined from Eq.(2), and the super uid (m ass) density $_{\rm S}$. Within mean-eld theory and in the zero-tem perature limit, $_{\rm S}$ is given by:

Here, k_j is the j-th zero of $E_k = 0$ w ith = (+;). For positive (negative) density in balance only E_k^+ (E_k) has zeros, while no zero occurs for = 0.]

The normal phase (N) corresponds to the trivial solution k = 0. The Sam a phases corresponds to nonvanishing k when 6 0 and positive super uid density s. The S1 and S2 denote the Sam a phases for one and two Ferm i surfaces, respectively. There will be one zero of E_k (j = 1) for the S1 phase (one Ferm i surface), and two zeros (j = 1;2) for the S2 phase (two Ferm i surfaces). Som etim es, the Sam a S2 phase is called the \breached-pair" phase after Ref. [19]. A negative value of s in Eq. (5) indicates that the Sam a phase is unstable toward a phase with a spontaneously generated superuid current, which we associate [27, 28] with the FFLO phase. We have veried that the Sam a phase, whenever it exists, is always lower in energy with respect to the normal phase. We recall in this respect that our calculation is at xed density in balance, while the original Sam a calculation was at xed chem ical potentials.)

The most prominent feature of Fig. 2 is the marked dependence of the phase diagram on the sign of [29]. In particular, while the boundary of the normal phase does not depend appreciably on the sign of , the region of stability of the Sarma phase with respect to the FFLO phase depends dramatically on the sign. For <0, the phase diagram is dominated by the FFLO phase, with the Sarma (S1) phase being connect to the extreme BEC region, while for >0, the FFLO phase is compressed into the region of small $\rm r_{\rm s}$.

Such an asymmetry can be understood in terms of the relevant dispersion \boldsymbol{E}_k^+ (\boldsymbol{E}_k^-) for positive (negative) . Due to the mass dierence, the term 2_k^- which is added (subtracted) to \boldsymbol{E}_k^- makes the dispersion \boldsymbol{E}_k^+ (\boldsymbol{E}_k^-) steeper (atter) with respect to the case of equal masses. As it is clear from the last term in Eq. (5), a atter dispersion will make the super uid density more negative, thus replacing the Sarma phase with the FFLO phase. The opposite occurs for positive , when the relevant dispersion becomes steeper.

In this part of the phase diagram there is some room even for the S2 Sarm a phase. So far, this phase was found in the literature to be very fragile, being invariably replaced by phase separation or by the development of a FFLO phase [19, 27, 30]. Here, the concurrence of several favorable factors, the mass dierence, the wave-vector dependence of the gap, and the intralayer Coulomb repulsion, all serve to stabilize the S2 Sarm a phase in an appreciable region of the phase diagram.

W e note that the largest number of phases occurs for interm ediate values of $r_{\rm s}$ (say, $r_{\rm s}=1.5-3$), corresponding to the sm ooth crossover region between the BCS and BEC limit for =0. For non-zero , several transition lines can be crossed in this region by varying or $r_{\rm s}$. This is thus the most fertile region to be explored experimentally, also because we recall in the same region $_{\rm max}$ is largest and the super uidity most robust.




FIG.3: Zero-tem perature electron ($_{\rm e}$) and hole ($_{\rm h}$) chem icalpotentials vs for d = 1 and $r_{\rm s}$ = 3. The average chem ical potential is also shown.

In this respect, the behavior of the separate chem ical potentials $_{\rm e}$ and $_{\rm h}$ vs can serve to reveal the appearance of a nite value for the gap . This is because $_{\rm e}$ and $_{\rm h}$ must show a jump across $_{\rm e}$ 0 in order to sustain a nite density in balance in the super uid phase. This behavior is shown in Fig. 3 for d = 1 and $r_{\rm s}$ = 3, when $_{\rm e}$ (= 0 +) $_{\rm e}$ (= 0) ' 2 $_{\rm max}$. The possible instability toward the FFLO phase we discussed above should not a ect the occurrence of this jump. Physical quantities obtained for the Sam a and the FFLO phases should, in fact, merge continuously when approaches zero, owing to the corresponding vanishing of the modulation wave vector associated with the FFLO phase [28].

It is useful to discuss the sensitivity of our results to the parameters used in the calculations. Increasing the distance d will shift the location of the intermediate region where most phases are seen, to larger values of $r_{\rm s}$ (for d = 2, e.g., the shift is about a 30%), but it does not alter the shape of the phase diagram . Reducing the mass

di erence has the e ect of contracting the FFLO phase for negative and expanding it for positive. This is as expected from the arguments discussed above. However, even for equal masses the phase diagram changes only quantitatively, allowing even in this case some space for the S2 Sam a phase. Finite temperature assists in stabilizing the Sam a phases with respect to the FFLO: the super uid density is, in fact, quite sensitive to temperature in the presence of density in balance. We have found, however, that tem peratures below 1 K do not appreciably alter the phase diagram in the most interesting intermediate r_s region. Finally, a reduction of the FFLO phase due to the intra-layer C oulom b repulsion m ay occur but this reduction should be limited to the region of large rs, where the spatial modulation of the gap parameter is expected to be accompanied by a density modulation.

In conclusion, we have shown that electron-hole bilayers are promising candidates for revealing a variety of super uid phases while traversing the BCS-BEC crossover. Exotic phases such as the FFLO and the S2 Sam a phases which have been so far elusive to experimental detection, should be notably robust in electron-hole bilayer systems.
