E lectrophoretic separation of large DNAs using steric con nem ent

Abstract

W e report an alternative m ethod for electrophoretic separation of large DNAs using steric con nem ent between solid walls, w ithout gelor obstacles. The change of electrophoretic m obility vs con nem ent thickness is investigated using uorescence video m icroscopy. We observe separation at sm all con nem ent thicknesses followed by a transition to the bulk behaviour (no separation) at a thickness of about 4 m (a few radii of gyration for the studied DNA chains). We present tentative explanations of our original observations.

1 Introduction

Capillary electrophoresis in polymer solutions has become an alternative method of gelelectrophoresis for DNA separation (review in [1]). Simultaneously, there has been a stimulating development of new methods using new geometries. For instance, separation of DNA adsorbed on a at surface [2] exploits the dependence of the adsorption-desorption kinetics on chain length; microlithography has been used to create topological defects and entropic trapping [3]. Is it possible to nd a simpler way of separation? Could the sole geometrical con nem ent be su cient? Two groups have worked in this direction. Roeraade et al. [4] have separated a mixture of H indIII-digested

-DNA fragments, using capillaries with diameters of order of two radii of gyration (R_g) of the largest fragment. Ikietal. [5] have used 20 m-diameter capillaries. Both groups have explained the separation using electrostatics. Roeraade has considered that the smallest molecules are repelled towards the capillary center since walls and DNA are both negatively charged. He has calculated that capillaries with small inner diameter (< 1 m) led with low ionic strength solution lead to an electro-osmotic ow (EOF) with a Poiseuille prole: the smallest molecules experience the fastest stream lines and are eluted rst. Iki has considered that the smallest molecules have a smaller mobility in the vicinity of the wall because of the screening by the surface counter-ions; with the EOF in the opposite direction of the electrophoretic force, the smaller the molecule, the higher velocity in the capillary.

The present paper reports experim ents perform ed in di erent conditions (higher ionic strength than [4], tighter con nem ent and much lower electric elds) that exhibit totally di erent behaviours.

2 M aterials and m ethods

C on nem ent is achieved using a hom e-built cell (Fig. 1). Two glass plates (m icroscopy slides) are separated by the DNA solution and connected to two reservoirs, hosting Pt electrodes to apply an electric eld (using an ISO – TECH power supply). The glass plates are washed with 1 % RBS solution (an alkaline powerful industrial detergent from Roth-Sochiel) in a sonication bath (B ranson 1200) for 10 m in, and then thoroughly rinsed with ultra pure water (M illipore M illiQ). The con nem ent gap is led with a solution 36 pm ol 1^l for -DNA (48.5 kbp from B iolabs) or 11 pm ol 1^l for T2-DNA (164 kbp from

Sigm a) in 10² m ol ¹ TBE bu er solution pH 8:3. Both concentrations correspond to the same mass concentration, 1:2 g m l¹ (dilute regime). The DNA s' radii of gyration are estimated from the Benoit-D oty relation [6]: R_g ' $L_{c}l_{p}=3$ (with L_c the contour length and l_p the persistence length [7]). This gives $R_g = 0.56$ m for -DNA ($L_c = 16.5$ m and $l_p = 50$ nm) and $R_g = 1.13$ m for T2-DNA ($L_c = 55.8$ m and $l_p = 50$ nm). The DNA molecules have been labeled with a uorescent dye (YOYO-1, Molecular P robes): 1 dye per 50 base-pairs. This very smalldye content ensures that the characteristics of DNA (charge, persistence length etc.) remains unaltered. The images are taken at 25 fram esper second during 8 seconds using a silicon intensi ed target (SIT) cam era (H am am atsu) tted to a microscope (Leica). No electric eld is applied during the rst two seconds to estimate the possible convection in the sample. Five eld values (from ' 2 to 8 V cm¹) have been used and the electrophoretic mobility is derived from the slope of the linear variation of velocity with applied eld.

The image analysis is performed as follows. In a rst set of experiments, using solutions containing only one individual species (either -DNA or T2-DNA), we have derived the velocities of the chains from the correlation of successive frames. In a second set of experiments we have investigated mixtures of both DNA s: we have determined the position [8] and the size of the molecules [9] to derive the 2D histogram of velocity vs radius and the mean velocity of each population.

The con nem ent thickness is determined from the electrical resistance of the con ned liquid lm. The measurement of the current gives a constant and reproducible value 30 m in after tightening the plates, indicating mechanical equilibrium. The calibration is done using spacers of 0.5 and 2 m (monodisperse polystyrene beads) and also gives the conductivity C of the solution. Indeed the resistance R of the lm is related to the thickness e by the relation $R = \frac{1}{C} \frac{L}{el}$ where L is the length of the plate along the direction of the electric eld, 1 is the width of the plate norm al to this eld. We obtain a conductivity of 1:9 0.2 m S cm⁻¹ in fairly good agreement with the 2.2 m S cm⁻¹ value measured with a conductimeter (F isher scientic C A ccum et A R 20) at room temperature. We set the gap thickness by tightening uniform by the two plates together. The accuracy of the thickness measurement is around 10 % and the thickness is uniform within 0:1 m. The excess of solution leaving the gap on the side of the plates during tightening is carefully removed to avoid any shortcut for the electric current. The evaporation of the solvent

is negligible because of the area of solvent exposed to air is very small. Finally, the variations of the thickness explored by DNA molecules during an experiment of 8 s are also considered as negligible.

3 Results

Fig. 2 represents the measured mobility as a function of the con nem ent thickness e (rst set of experiments). A rst and striking feature is that -values are positive: negatively charged DNAs move towards the cathode in the same direction as the electric eld E. This behaviour is caused by the presence of an electro-osmotic ow (EOF): glass plates are negatively charged at pH = 8:3 and their positively charged counter-ions, dragged by the electric eld E, induces a plug ow of the solution with velocity v_{EOF} towards the negative electrode. This can be characterized by an electro-osmotic mobility $_{EOF} > 0$ de ned by $v_{EOF} = _{EOF} E \cdot W$ hen this mobility is larger than the intrinsic (and negative) electrophoretic mobility of DNA, the electrice mobility is positive.

We distinguish two regimes for (e). In a rst regime, for small thicknesses (e < 4 m), increases with a large dependence on chain length. Although T2-DNA is longer, it has a larger mobility than -DNA: for instance, for e = 2 m, T2-DNAs move more than twice faster than -DNAs. EOF reverses the order of elution; this e ect has been already observed by Barron [10] during DNA electrophoresis in very dilute polymer solutions using uncoated capillary glass tubes.

In a second regime, for thicknesses larger than 4 m, is constant and equal to + $(1 \quad 0.3)10^{4}$ cm² V¹ s¹ and neither depends on chain length nor con nem ent thickness.

The rst and second regime are separated by a transition region with an important reduction of the mobility.

In the second set of experiments, we have measured the mobilities in a 50-50 m ixture of the original T2-DNA and -DNA solutions. The weight concentration is thus still 12 g m l¹, but since -DNAs are 3 times shorter than T2-DNAs, the solution contains an average T2/ chain ratio of 1:3. Fig. 3 represents the 2D histogram of the velocity vsm easured radius for di erent con nem ent thicknesses, showing two well-de ned populations, with the expected 1:3 ratio. Note that the two clusters are centered on about 1:3 m and about 1:6 m instead of the calculated R gs (0:56 m and 1:13 m). Decon-

volution of the measured radii using the form alism of point spread function leads to (resp.) 0.6 and 1:1 m, in excellent agreement with the calculated values. The mean velocities of the two populations have been extracted from the centers of mass of each population.

M obility values are summed up in table 1. In the mixture, the overall behaviour is identical to the one described for the mst set of experiments (two regimes for the mobility and T2-DNA faster than -DNA). Both -DNA and T2-DNA go faster when mixed. This observation is due to the procedure of the determination of the mobilities in the mixture which leads to a larger uncertainty: we need to distinguish two populations and then calculate the mobility of each population rather than measure the mean mobility of the assembly of molecules seen on the images. We also observe that the smaller () DNA chains move signi cantly faster in mixture than in pure solutions, maybe entrained by the larger (T_2) chains.

Finally, in order to prove that EOF indeed reverses the order of elution, we have coated the glass plates with poly (N, N, -dim ethylacrylam ide) (PDMA), a neutral polymer, in order to eliminate the EOF. We let the polymer adsorb on the glass surfaces by incubating the glass plates overnight in a PDMA solution (1% w/w in water) [10], then rinsed with distilled water. With the PDMA coating, we observe that the DNAs move towards the anode (negative mobilities on g. 3E) which means that the EOF as been removed by the coating. As expected, the absolute amplitudes of the two DNA mobilities are reversed: -DNA moves faster than T2-DNA with mobilities of + (3:1 0:2)10⁴ cm² V¹ s¹ and + (2:2 0:2)10⁴ cm² V¹ s¹ respectively.

4 D iscussion

The experim ents perform ed in capillaries and reported by R oeraade et al. [4] and by Iki et al. [5] also shown a separation but with di erent features and interpretations as m entioned in the introduction. But let us notice that our experim ental conditions are signi cantly di erent:

we have used a con nem ent between two plates and not in a capillary tube;

the diam eters of the capillaries in 4] and [5] are always larger than the largest chain fragments. A nyway, on decreasing the con nem ent (in our second regime), we never observe the behaviours described by R oeraade and Iki;

they have used high electric elds $(170 \text{ to } 200 \text{ V} \text{ cm}^1)$ which may lead to Joule heating, resulting in radial convection in the capillary. Such an e ect is not present in our experiments (maximum eld ' 8 V cm¹);

in the case of R oeraade's work, it was observed that a good separation is obtained only at low ionic strength (salt concentration close to 50 M).

All these di erences explain that we observe original behaviours and we have thus to nd di erent m igration mechanisms. In the following, we present simple models combining the electric force applied on the DNA and the friction of them olecule on the solvent and on the walls to explain the observed behaviours.

In the second regime, the elective mobility remains constant (= + (1 0:3)10⁴ cm² V¹ s¹) and does not depend on the DNA length: this is characteristic of a bulk regime (no separation) with an overall displacement of the solvent by the EOF. This yields:

where $_{e} < 0$ is the intrinsic mobility of the DNAs (in bulk solution and without EOF) and is mass independent (free draining conditions). $_{EOF}$ is related to the zeta potential $_{S}$ (< 0) of the glass surface by $_{S}$ = ($_{EOF}$)=($_{0}$ r) with $_{0}$ the vacuum permittivity, $_{r}$ and the dielectric constant and viscosity of the solution. U sing $_{e}$ = 410 4 cm² V¹ \pm [11, 12] (for a similar ionic strength), we nd $_{EOF}$ = + (5 0:3)10 4 cm² V¹ \pm , in agreement with the values reported in [10, 11, 12] (+ 5:6 10 4 cm² V¹ \pm) in similar conditions. This allows a determination of the zeta potential of the glass plates: $_{S}$ ' 70 mV (with = 10 3 N m² s_{r0} = 8:810 12 C² N¹ m² and $_{r}$ = 80), in good agreement with reported values [13].

On increasing the con nem ent (decreasing the gap e between plates), we observe an important increase of the mobility. Assuming that the EOF is constant (since e is much larger than the D ebye length 1' 2 nm), this can be achieved solely by a decrease of the electric force acting on DNAs. This may be realized likely through a local screening of the DNA charges within the proxim al layers of the glass plates but we have no model to discuss quantitatively this possibility.

In the rst regime, the mobility increases with the gap thickness e and decreases with the chain length N, and our set-up separates DNA sofdi erent length. We present a tentative theoretical model to describe the dependence of the elective mobility on the con nem ent thickness e and the chain length (num ber of m onom ers N).

Using the results of [14], the elective mobility of the con ned DNA is given by:

N₁a is the friction coe cient of the N₁ sliding monomers (of size a) on the cell walls and is the friction coe cient of the remaining N N₁ monomers in the gap between the two walls. In absence of speci c adsorption, N₁ = N a=e [15] and then 1 N a²=e; inside the gap, the DNA chain behaves as an impermeable coil [14] and is proportional to N¹⁼² (gaussian ideal chain) or to N³⁼⁴a⁵⁼⁴e¹⁼⁴ (taking into account monomers excluded volum e). Eq. 2 then does predict an increase of the mobility with thickness e but fails to describe the N dependence.

A ssum ing N₁ N¹⁼², as suggested in [2] for uncon ned DNA, we can satisfactorily describe the experimental data if we consider that the chain inside the gap behaves as a free draining coil (ie N) but Eq. 2 then fails to describe the thickness dependence. We have experimentally addressed the possibility of strong DNA adsorption that could give special N₁ dependence on N. U sing AFM (atom ic force microscopy), we have determined that the maximum roughness of the glass plates is about 2 nm: plate surfaces are smooth at the scale of the inter-plate gap size and DNA separation cannot be attributed to chain trapping on surface defects. Furtherm ore we have not observed J or U DNA shapes, characteristic of such trapping [16]. M oreover, scanning the sam ples in the z-direction with an opticalmicroscope does not reveal any particular DNA adsorption on the glass plates.

5 Conclusion

We have investigated the mobility of DNA chains conned between two solid walls. The EOF reverses the order of elution of the DNA chains. We have shown that steric connement constitutes a simple and fast technique for separation of large DNA, without gel or pulsed eld, using weak electric elds. The interpretation of the underlying mechanism s is still opened.




Figure 1: Schem atic representation of the m easurem ent cell (the distance d between electrodes is 8 cm)




Figure 2: M obilities of () and T2 () DNA vs con nem ent thickness e. The vertical dashed line represents the transition between the two regimes. The horizontal dashed line is a eye guide of the constant mobility in the second regime.




Figure 3: Norm alized 2D histogram of the mobility of molecules vs their radius. Con nement thicknesses are (m): (A) 2.3, (B) 1.2, (C) 5, (D) 8 and (E) 3 with PDMA coating. Electric voltage is 60 V.B in sizes are (units m and 10 4 cm 2 V¹ \pm): (A) 0.04 and 0.05, (B) 0.04 and 0.03, (C) 0.06 and 0.08, (D) 0.02 and 0.03 and (E) 0.03 and 0.08. The mobilities are de ned as positive if the molecules move to the positive electrode. Notice the negative sign of the mobility when using PDMA coating which indicates that molecules go in the opposite direction compared to the situation with EOF.
