# A nom alous relaxation in binary m ixtures: a dynam ic facilitation picture

A bstract. Recent computational investigations in polymeric and non-polymeric binary mixtures have reported anom abus relaxation features when both components exhibit very di erent mobilities. A nom abus relaxation is characterized by sublinear power law behaviour for mean squared displacements, logarithm ic decay in dynamic correlators, and a striking concave-to-convex crossover in the latters by tuning the relevant control parameter, in analogy with predictions of the M ode C oupling T heory for state points close to higher-order transitions. We present M onte C arb simulations on a coarse-grained m odel for relaxation in binary mixtures. The liquid structure is substituted by a three-dimensional array of cells. A spin variable is assigned to each cell, representing unexcited and excited local states of a mobility eld. Changes in local mobility (spin ip) are permitted according to kinetic constraints determined by the mobilities of the neighbouring cells. We introduce two types of cells (\fast" and \slow ") with very di erent rates for spin ip. This coarse-grained m odel qualitatively reproduces the mentioned anom alous relaxation features observed for real binary mixtures.

#### 1. Introduction

B inary m ixtures of sm all and large particles with su ciently large size disparity, at low orm oderate concentrations of the sm all particles, exhibit a large separation in the time scales for both components. Recent computational investigations in polymeric and nonpolymeric m ixtures of soft spheres [1, 2, 3] in such conditions have reported anom alous relaxation features at intermediate intervals of more than three time decades between the short-time ballistic and long-time di usive regimes. These anom alous features are: i) sublinear power law behaviour for mean squared displacements, with decreasing exponent by decreasing temperature, ii) logarithm is relaxation in dynamic correlators, iii) concave-to-convex crossover in dynamic correlators by tuning the relevant control parameter. These results exhibit striking analogies with predictions of the M ode Coupling Theory (MCT) for state points close to higher-order MCT transitions [4, 5, 6], which arise in regions of the control parameter space where competition between dimensing matching is arrest takes place. For the fast component in binary matching we have suggested a competition between conment and bulk-like caging [1, 2, 3], respectively induced by the host matrix formed by the slow component, and by the surrounding particles belonging to the fast component. This view is supported by the observed non-trivial analogies [3] with a recent MCT theory for matrix for mediation features in short-ranged attractive colloids are also observed. For these latter systems a higher-order MCT transition has been derived as the result of a competition between steric repulsion and reversible bond formation for dynamic arrest [6, 9, 10, 11].

K inetically constrained models [12, 13] are used as coarse-grained pictures for relaxation in supercooled liquids. In these models, the liquid structure is substituted by an array of cells. The cell size roughly corresponds to a density correlation length. A spin variable is assigned to each cell, with values 0 or 1 denoting respectively unexcited and excited local states in a mobility eld. Changes in local mobility (spin ips) for a given cell are permitted according to kinetic constraints determined by the mobilities of the neighbouring cells. Propagation of mobility, which yields structural relaxation, occurs via dynamic facilitation: microscopic regions become temporarily mobile only if neighbouring regions are mobile. K inetically constrained models provide in a simple way an important feature exhibited by glass-form ing liquids: the growing of dynamic correlation lengths by decreasing temperature, leading to dynamic heterogeneity [14, 15, 16, 17].

Some of the anomalous dynamic features exhibited by short-ranged attractive colloids, and associated with a higher-order point within the framework of MCT, as logarithm ic relaxation or reentrant behaviour of the di usivity [6], have been recently reproduced by a simple model based on dynamic facilitation [18]. Motivated by this fact and by the mentioned dynamic analogies with binary mixtures, we investigate a simple kinetically constrained model aim ed to reproduce qualitative relaxation features for such mixtures. In Section 2 we introduce the model and give computational details. Simulation results are presented and discussed in Section 3.

## 2. M odel and C om putational D etails

We have carried out M onte C arb (MC) simulations on a variation [19] (see below) of the north-or-east-or-front (NEF) m odel recently investigated by Berthier and G arrahan [17]. In these three-dimensional model directionality in the kinetic constraints is in posed to m in ic fragile liquid behaviour [17]. Spin ip of a given cell is only permitted if there is at least one excited neighbouring cell in the north-or-east-or-front direction. M ore speci cally, if the cell is denoted by its position vector  $\mathbf{i} = (\mathbf{i}_x, \mathbf{i}_y, \mathbf{i}_z)$ , spin ip is permitted according to the follow ing rules:

i) At least one of the neighbouring cells in the north  $(i_x, i_y, i_z+1)$ , or east  $(i_x, i_y+1, i_z)$ , or front  $(i_x + 1, i_y, i_z)$  direction is excited, i.e., it has spin 1.

ii) If i) is fullled, spin ip is accepted according to the Metropolis rule [20]. Hence, 1 ! 0 is always accepted, while 0 ! 1 is accepted with a thermal probability  $[1 + \exp(1=T)]^{-1}$ , where T is the temperature.

In the present work we investigate a binary mixture of cells with the same population of excitations,  $[1 + \exp(1=T)]^{-1}$ , but di erent rates for excitation,  $\exp(E=T)[1 + \exp(1=T)]^{-1}$ , and decay,  $\exp(E=T)$ , of the cell mobility. This choice fulls detailed balance. We use the activation energies E = 0 and 3 for the di erent components, which are respectively denoted as \fast" and \slow " cells. Hence, spin

ip rules for the fast component are the same as in the original NEF model, aim ed to reproduce bulk-like dynam ics. The probability of spin ip for the slow cells is decreased by a factor exp(3=T) as compared to that of the fast cells, providing a large time scale separation for relaxation of both components (see below).

The m ixture composition,  $x_f$ , is de ned as the fraction of fast cells. We investigate a wide range of composition and temperature as control parameters. A square box of side N = 50 cells is used. Periodic boundary conditions are implemented. Slow and fast cells are random by distributed according to the selected value of  $x_f$ . T in e is given in M C steps. W ithin each M C step a total of N<sup>3</sup> trials (one trial for each cell) is performed. The conguration of the mobility eld at times t and t+1 is de ned as that respectively before and after the N<sup>3</sup> trials.

## 3. Results and Discussion

We have evaluated the mean squared displacement according to the de nition given in Ref. [21]. A \probe molecule" placed in a given cell i at time t is permitted to perform a jump = (x; y; z), with 2 f 1;0;1g, to an adjacent cell j = i+ provided that both i and j are instantaneously (i.e., at the same time t) in an excited state. O therw ise the jump is not permitted. If in the form er case there are several candidates between the adjacent cells, one of them is random ly selected. The mean squared displacement is computed from an average over the trajectories of di erent (non-interacting) probes initially placed in di erent cells. In the case of the binary m ixture investigated in this work, only jum ps between cells of a sam e com ponent (\fast" ! \fast" or \slow "! \slow ") are permitted. In this way the motion of a probe initially placed in a cell of a given component remains coupled to the mobility eld of that component. Fig. 1 shows, at a xed composition  $x_{f} = 0.33$ , results for the mean squared displacement computed according to this procedure. The short-time ballistic regin e exhibited by real system s is obviously absent due to the coarse-grained character of the model. A large time scale separation is induced between both components at low tem peratures. In analogy with the behaviour displayed by binary mixtures with large size disparity [1, 2, 3], an interm ediate sublinear power law behaviour is observed for the fast component, and the corresponding exponent decreases by decreasing temperature.

The latter takes a value of about 0.6 at the lowest investigated temperature.

W e have also computed the mean persistence function P (t) =  $_{i}p(i;t)=N^{3}, where$ p(i;t) is the persistence function of the cell i at time t. The latter takes the value 1 ip has occurred for that cell in the interval [0,t]. If one or more spin if no spin jps have occurred, it takes the value 0. A coording to the picture of dynam ic facilitation, the decay of P (t) is a signature of structural relaxation [17]. Fig. 2 shows the tem perature dependence of P (t) at composition  $x_f = 0.33$ . The st decay usually observed for any correlator in real systems corresponding to the transient regime at m icroscopic times is again absent due to coarse-graining. As for the mean squared displacement, the introduction of very di erent rates for cell spin ip yields very di erent relaxation times for fast and slow cells. W hile slow cells display standard relaxation, fast cells exhibit rather di erent relaxation features. In full analogy with results for dynamic correlators of the fast component in binary mixtures [1, 2, 3], P (t) shows a concaveto-convex crossover by decreasing tem perature. At an interm ediate tem perature, pure logarithm ic relaxation is observed over a time interval of near three decades. This behaviour is also observed by xing tem perature and varying the mixture composition (see Fig. 3).

It is worthy of remark that the features displayed in Figs. 2 and 3 are not speci c of P (t). Qualitatively analogous results are exhibited by other dynamic correlators, as intermediate scattering functions. An example is displayed in Fig. 4 for the incoherent correlator  $F_s(q;t)$ . Following the denition given in Ref. [22] the latter is computed, for a wavevector q, as  $F_s(q;t) = hexp[iq (r(t) r(0))]i$ , where r is the position of a probe molecule. The latter is permitted to jump between adjacent cells according to the same rules in posed for the evaluation of the mean squared displacement of each component

(see above). The brackets denote average over initial locations of the probe. As in the case of the m ean persistence function,  $F_s(q;t)$  exhibits a concave-to-convex crossover by decreasing tem perature, and a logarithm ic decay at some intermediate state point.

In sum m ary, the highly non-trivial anom alous relaxation features recently reported for binary m ixtures with a large time scale separation between both components can be qualitatively reproduced by a simple kinetically constrained m odel. The fact that recent work within this approach [18] also reproduces unusual relaxation features for shortranged attractive colloids suggests that dynam ic facilitation is a relevant ingredient for

relaxation in system s with several competing mechanism s for dynam ic arrest. Results reported here provide a new step to extend the picture of dynam ic facilitation, which had been used basically for describing bulk-like relaxation, to more complex situations.
