Static and dynam ic properties of a particle-based algorithm for non-ideal uids and binary m ixtures

A recently introduced particle-based model for uid dynamics with elective excluded volume interactions is analyzed in detail. The interactions are modeled by means of stochastic multiparticle collisions which are biased and depend on local velocities and densities. Momentum and energy are exactly conserved locally. The isotropy and relaxation to equilibrium are analyzed and measured. It is shown how a discrete-time projection operator technique can be used to obtain G reen-K ubo relations for the transport coel cients. Because of a large viscosity no long-time tails in the velocity auto-correlation and stress correlation functions were seen. Strongly reduced self-dilusion due to caging and an order/disorder transition is found at high collision frequency, where clouds consisting of at least four particles form a cubic phase. These structures were analyzed by measuring the pair-correlation function above and below the transition. Finally, the algorithm is extended to binary mixtures which phase-separate above a critical collision rate. PACS number(s): 47.11.+ j.05.40.+ j.02.70 N s

I. IN TRODUCTION

The e cient modeling of the hydrodynam ics of complex liquids such as colloidal suspensions and microemulsions is a challenging task due to the interplay between ow and therm odynam ic properties and the importance of therm al noise. The desire to simplify the description of the solvent degrees of freedom led to the development of mesoscale simulation methods, which are essentially novel ways of solving the equations of uctuating hydrodynam ics.

In particular, a recently introduced simulation technique of this type | offen called Stochastic R otation D ynam ics m ethod (SRD) [1] or Multi-Particle C ollision D ynam ics [2]| is a very promising tool for such a coarse-grained description of a uctuating uid [3, 4]. The m ethod is based on so-called uid particles with continuous positions and velocities, which follow simple dynam ic rules of stream ing and collision. In this sense, SRD is closer to the m icroscopic reality than conventional N avier-Stokes solvers. On the one hand, this gives rise to unlimited numerical stability, on the other hand there are certain restrictions on the transport coe cients which depend on the details of the dynam ics. For instance, the viscosity cannot be chosen to be arbitrarily sm all or large at reasonable com putational e ciency. D ue to the simplicity of the SRD -rules, m any analytical calculations could be perform ed [5, 6] which are very hard to do for other particle-based m ethods. So far, SRD has been used to study sedim entation [7, 8], colloids and polymers in ow [9, 10], vesicle dynam ics [11], reacting ow [12], and m icroem ulsions [13].

The uid particles of the original SRD m ethod have an ideal gas equation of state. Hence, they are very compressible and the speed of sound, c_s , is low. In order to have negligible compressibility elects as in real liquids the M ach num ber has to be kept sm all, which means that there are limits for the low speed in the simulation. Recently, we showed how SRD can be modiled to achieve a larger speed of sound and a larger viscosity [14, 15] which makes simulations of dense gases and liquids more elecient and realistic. This was done in a therm odynamically consistent way by introducing generalized excluded volume interactions among the luid particles. That means, the kinetic energy is still locally conserved and no complications such as temperature drifts are encountered. This was a liquid of a liquid-gas phase transition.

W hile (to our know ledge) this has been the rst SRD model with a non-ideal equation of state, there have been several attem pts to generalize other particle methods to non-ideal uids. The rst one is described by A lexander et al, [17], and is based on a modi cation of the original D irect Sim ulation M onte C arb (D SM C) or B ird's algorithm [18]. It is called the C onsistent B oltzm ann algorithm (CBA) [17, 19]. The authors labeled the original D SM C algorithm as \inconsistent" in the sense that it has the transport properties of a hard-sphere gas, but obeys an ideal gas equation of state; CBA has the correct hard-sphere equation of state. How ever, back-scattering events connected with structural e ects are absent in the model [17], leading to too high self-di usion at higher densities. Furtherm ore, the sound speed determ ined from the equal-time density uctuations are not in agreement with the value obtained directly from the equation of state. A s seen from Fig. 2 and 3 in [17], the analytical expressions from Enskog-theory for the transport coe cients are signi cantly low er than the simulation results.

A nother particle method very close to DSMC explicitly aimed to solve the Enskog equation is given in Refs. [20, 21]. The method correctly reproduced the transport properties of the Enskog gas, but has the unpleasant feature of conserving momentum and energy only in a statistical sense and not in a single collision. To overcome these de ciencies a modi cation of the DSMC method was proposed to solve the Enskog-equation by Frezzotti [22]. The main idea is the same as in [21]: due to the nite size of a particle, binary collisons do not just take place between particles of the same cell, but also particles from adjacent cells can participate, but now energy and momentum are conserved in every collision.

The original SRD m ethod has a similiar issue as D SM C: The transport properties can be tuned to that of an interacting gas, while the equation of state remains ideal. Hence, a generalization which leads to a tunable equation of state is highly desirable. This also allows us to observe phase transitions and critical phenom ena, and the m ethod can be easily extended to multi-com ponent system s. Furtherm ore, it was shown that the generalized SRD is \m ore consistent" than CBA since independent measurem ents of the density uctuations, the pressure and the speed of sound are consistent with each other and agree with theory [14].

In CBA, excluded volume e ects are modeled by introducing an additional displacement of the particles away from each other after every binary collision. This displacement is in addition to the free streaming displacement, v_i , given by the time step and the actual velocity v_i of particle i. The idea behind this is that particles of nite size collide earlier than point-like particles, and hence would be further apart after time . It is likely that this enhanced particle relocation leads to an additional di usive term in the continuity equation for the density, which could be

the reason for them odynam ically inconsistent density uctuations. As discussed in [15] one has to be careful with respect to them odynam ic consistency; often it is not obvious why a certain algorithm fails to produce the correct therm al uctuations. Therefore, in generalizing SRD we followed a di erent strategy than A lexander et al. [17]: O ur m ain idea is to coarse-grain the collisions between hard-spheres. This leads to additional e ects such as caging and crystallization, and therm odynam ically consistent uctuations can be obtained.

Instead of costly binary collisions, which is the core of any D SM C -code, in agine two clouds of particles containing M₁ and M₂ particles, and having center of mass velocities u₁, u₂ respectively. The volume of the clouds is assumed to be equal and constant. On average, the momentum transfer between these clouds will be high if they are very dense and move at high speed into each other. Hence, the average interaction between these clouds depends on the sign and size of u u₁ u₂, and on the product of the particle numbers M₁M₂. In our model, clouds are dened by the particles in a particular cell of a cubic grid. Two adjacent cells; which we will call a double-cell, will be picked at random and all the particles will undergo a collective collision which conserves energy and momentum in the double cell with a collision probability proportional to (u)f(u; M₁M₂). It turns out that the equation of state can be tuned by the choice of the function f.

K eeping the underlying lattice as a simple means to determ ine collision partners allows us to utilize the projection operator formalism worked out for original SRD. This formalism was used to obtain transport coe cients via G reen-K ubo relations [6]. Very accurate analytical expressions were found even for low particle density and at low tem peratures [4, 23] where the mean-free path is much smaller than the cell size. Both regimes are usually avoided in D SM C, mainly because no good agreement between Enskog-theory and numerics can be obtained.

II. MODEL

Consider a set on N point-particles with continuous positions r_i and velocities v_i , i = 1::N. The particle m ass is set equal to one. The discrete dynam ics with time step consists of a stream ing and a collision step. In the stream ing step, particles are advected freely with their corresponding velocities, $r_i(t +) = r_i(t) + v_i(t)$. As in original SRD, [1, 3] a cubic grid with lattice constant a is im posed on the system, which is used to organize multi-particle collisions. In the current m odel, another grid with twice the mesh size of the original grid is introduced which groups four original cells into one supercell (see F ig. 1). For simplicity, we restricted ourselves to two dimensions, but everything can be easily extended to more dimensions. Each supercell is indexed by the index of the small cell in its lower left corner. The origin of the grid is chosen such that the indices of the supercells are always odd. The position of a cell relative to its supercell is now uniquely determined by whether the components of its index vector ($_x$; $_y$) are even or odd. For instance, the cell in the lower right has an even x-index, $_x$, but an odd y-index, $_y$.

A sproposed in [1] in order to avoid anom alies, all particles are shifted by the same random vector with components in the interval [a;a] before the collision step (note this is a larger interval than in original SRD because of the bigger size of the supercells). Particles are then shifted back by the same am ount after the collision.

To initiate a collision, two cells in every supercell are random ly selected. These two cells form what we will call a double cell. The probabilities for the possible double cells have to be determ ined in a way which is as e cient as possible, i.e. leads to a large non-ideal part in the equation of state, and furtherm ore should lead to a model which is isotropic at least at the N avier-Stokes level. A s will be discussed later, the cubic anisotropy of the underlying grid will show up at the B unnett and higher levels, eventually leading to a cubic phase at very high collision frequency.




FIG.1: Collision rules. Three distinct collisions are considered: (a) horizontally along $_1$, (b) vertically along $_2$, (c) diagonally and o -diagonally along $_3$ and $_4$. w and w_d are the probabilities of choosing collisions (a), (b), and (c), respectively.

For e ciency, we always pick two double cells in every supercell as possible candidates for momentum exchange. This way, every particle in the entire system has a chance to be included in a collision. As pictured in Fig. 1 three distinct choices are made in every supercell: a) horizontal collisions: The two top cells with equal y-coordinate form one double cell, and the two lower cells form another double cell. b) vertical collisions: The two left cells with equal x-coordinate form one double cell, and the two right cells form another double cell. c) diagonal and o -diagonal collisions: The cell from the upper left and the one from the lower right form a double cell, while the remaining two cells form the second double cell.

Note, that the diagonal collisions are essential to obtain an equilibration between the kinetic energies in the x and y-direction. Because of x-y symmetry, the probabilities for choice a) and b) must be equal, and will be denoted by w. The probability for choice c) is given by $w_d = 1$ 2w. The ratio $w = w_d$ has to be determined such that the model becomes as isotropic as possible. One way to x this ratio is based on the relaxation of the velocity distribution, and will be discussed in the next section.

A. Collision rules

Fig. 1 shows the three choices for double cells. We de ne unit vectors j, j = 1:4, which connect the center of the selected cells. For the two possible double cells aligned with the \hat{x} -direction one has $_1 = \hat{x}$ and for the vertical choices one has $_2 = \hat{y}$. The diagonal and o -diagonal choices are described by $_3 = (\hat{x} + \hat{y}) = \frac{p}{2}$ and $_4 = (\hat{x} + \hat{y}) = \frac{p}{2}$, respectively. In every cell the mean particle velocity is de ned by

where the sum runs over all particles contained in a given cell, n is the cell index.

Now, the projection of the difference of the mean velocities in the selected cells on j is calculated, u = j ($u u_2$). If u < 0, no collision will be performed. For positive u a collision will occur with an acceptance probability which depends on u and the actual particle numbers in the two cells M₁ and M₂. In order to enable analytical calculations and for rst tests, the following total acceptance probability was chosen:

where A is some parameter to tune the equation of state. In the limit of A ! 1 this gives $p_A = (u)$, which maximizes the collision frequency, leads to a large non-ideal part of the pressure, and thus to a large speed of sound (the more collisions the faster sound can travel). Unfortunately, as will be shown in a later section, in this limit, the pressure has a non-analytic dependence on density and temperature, which leads to certain therm odynamic inconsistencies. More details about this limit can be found in Ref. [15]. Another, computationally simpler choice than Eq. (2) would be the rst term of an expansion of the hyperbolic tangent for small A : $p_A = m in (1; (u))$, but the cusp at $p_A = 1$ m akes accurate analytical calculations of the equation of state di cult. This procedure represents a coarse-grained version of the collisions in a real gas. There, mostly binary collisions occur, and they are only possible if the particles approach each other, i.e. if w = -12 ($v = v_2$) > 0. v_1 is the velocity of the particles, 12 is the vector connecting their center of mass. In SRD the generalization of this can be seen as if two clouds of particles coming from the two cells are colliding. The total momentum transfer of this scattering should be much larger if the two clouds approach each other on average, i.e. at u > 0, compared to u < 0. Furthermore, the elective cross section of the scattering should increase with the particle density in the clouds. This is described by the dependency of the function on the particle num bers. In this model there is large exibility about how to choose this function with the restriction that it should be symmetric against the interchanging of the two cells.

Once it is decided to perform a collision, the explicit form of the momentum transfer between the two cells is needed. In close analogy to the hard-sphere liquid, the collision should keep the total momentum and total kinetic energy of the double cell invariant, and it should mainly transfer the component of the momentum, which is parallel to the connecting vector j. In the following, this component will be called the parallelor longitudinalm om entum, as opposed to the perpendicular or transverse momentum. There are many di erent rules which full lithese conditions. For instance, a stochastic rotation of the relative velocities of all particles in the double cells similiar to the rotation rules in SRD for ideal gases, could be used. Our goal here is to obtain a large speed of sound. Therefore, we use a collision rule which leads to the maximum transfer of the parallel momentum, and does not change the transverse momentum. The rule is quite simple, it exchanges the parallel component of the mean velocities of the two cells (parallel to $_j$), which is equivalent to a \re ection" of the relative velocities:

u^{jj} is the parallel component of the mean velocity of the particles of both cells in a double cell. W ritten in Cartesian coordinates this amounts to:

a) Horizontal double cells (characterized by 1):

where $u = (M_1u_1 + M_2u_2) = (M_1 + M_2)$ is the mean velocity of the double cell, u_1 , u_2 are the mean velocities of the cells form ing the double cell. One easily veri as that these rules conserve momentum and energy in the double cell.

B. Collision probabilities and isotropy

The ratio $w = w_d$ describes how often collision cells in the vertical and horizontal direction, a) and b) are chosen compared to diagonal cell pairs, case c) in Fig. 1. We determ ined this ratio by requiring that the relaxation of the velocity distribution functions of the particles is isotropic and does not depend on the orientation of the underlying grid.

Instead of analyzing the tem poral evolution of the entire distribution function, we will restrict ourselves to its low est moments. A ssum ing molecular chaos for the moment, i.e. that velocities of di erent particles are uncorrelated at

equaltimes, it is su cient to consider the following three moments of a single particle i: hv_{ix}^2 i, hv_{iy}^2 i, and $hv_{ix}v_{iy}$ i. For simplicity we will om it the particle label i from now on. We assume a hom ogeneous, but non-equilibrium inital state and study the temporal evolution of these moments to their corresponding values given by the M axwell-B oltzm ann distribution. We denote the vector of second moments as follows:

For simplicity only the limit A ! 1 in Eq. (2) will be discussed in the following. This means, on average every second collision attempt is accepted (since the probability to have a positive velocity di erence u is 1=2). Using the collision rules, Eq. (3), we obtain the following relaxation in one time step:

Here, n is the actual, uctuating number of particles in a given double cell. Now we consider a rotation of the coordinate system by an arbitrary angle, i.e.

with $c = \cos$ and $s = \sin$. This results in a transformation of the relaxation matrix from R to $\tilde{R} = 0 \text{ R O}^{-1}$ with a matrix

O ne of the three eigenvalues of R is always one due to the conservation of total energy, i.e. $hv_x^2 i + hv_y^2 i = const = 2k_B T = m$. The other two eigenvalues are given by

Requiring isotropy amounts to $\mathcal{R} = \mathbb{R}$, which is possible only if $_1 = _2$, since the rotation of the coordinate system will mix these two modes. This condition can be fulled for arbitrary n only if $w_d = 1=2$ and w = 1=4. Inserting these values we indeed nd that the relaxation matrix is invariant under coordinate rotations: $\mathcal{R} = \mathbb{R}$. Another way to see this is that the requirement of $\mathcal{R} = \mathbb{R}$ is equivalent to dem and that \mathbb{R} and \mathbb{O} commute: $[\mathcal{R};\mathcal{O}] = \mathbb{R} \mathbb{O}$ or $\mathbb{R} = \mathbb{O}$. This is only possible if \mathbb{R} has the following structure with three free parameters a_1, a_2 and a_3 :




FIG. 2: A diabatic speed of sound c_s m easured using the time dependent density-density correlations for =2a = 0.05. Densities are obtained at the supercell level and the period of oscillations in the density correlations are used to calculate the speed of sound. D ata is shown for the wave vectors k = (2 = L)(1;0) (), k = (2 = L)(0;1) () and k = (2 = L)(1;1) (M), respectively. P aram eters: L=a = 128, A + 1 and $k_B T = 1:0$.

It turns out that original SRD with a rotation angle is naturally described by a relaxation matrix of this shape and that the eigenvalues $_1$ and $_2$ are equal. In the current model, the probabilities w and w_d must be adjusted properly to maintain this isotropic behavior. Adjusting these probabilities does not neccessarily mean that all properties of the model are isotropic. This becomes very apparent at high densities or high collision frequency 1= 1 where one observes inhom ogeneuous states with cubic order. O ther practical tests for isotropy are needed such as measurements of the speed of sound and of transport coe cients for di erent directions of the wave vector $k = (k_x; k_y)$. Fig. 2 shows

the speed of sound m easured for three di erent directions of the wave vector $k = (2 = L) (n_1; n_2)$, with $(n_1; n_2) = (0; 1)$, (1; 0), and (1; 1) where L is the linear dimension of the system. No dependence on the direction was detected, even at this smallmean free path = (2a) = 0.05, = $\frac{P}{k_B T}$. A similar measurement (not shown here) revealed that the viscosity for a nite wave vector does not depend on the direction of k either.

Choosing w = 1=4 and $w_d = 1=2$ in Eq. (12) and averaging over the particle number uctuations (particles are supposed to be Poisson-distributed as in an ideal gas) gives the elective decay rate,

Both, the cross-correlation hv_x (t) v_y (t) i and the di erence between kinetic energy in x-and y-direction relax independently with this relaxation rate, i.e.




FIG. 3: Non-equilibrium relaxation of velocity moments as a function of time. (a) Large mean free path =(2a) = 1:50, (b) sm all mean free path =(2a) = 0:05.0 pen circles () and squares () show the decay of hv_x (t) v_y (t) i and hv_x^2 i hv_y^2 i correlations respectively. The solid lines are the predictions of Eqs. (14) and (15). Parameters: L=a = 32, M = 5, A ! 1 and $k_B T = 1:0$.

Fig. 3 shows the time relaxation of these moments for small and large mean free path. The initial conguration was set up far from equilibrium with a large difference between $hv_x^2 i$ and $hv_y^2 i$ and a strong correlation between the x- and y-component of the velocity. The measured decay is exponential for large mean free path = (2a) = 1.5. For smaller = (2a) = 0.05 one sees a slower decay starting after a few iterations. The reason is that the assumption of molecular chaos is invalid at small =a. This is similar to the behavior of the velocity auto-correlation function analyzed in [16].




FIG.4:D in ensionless relaxation rate e for the non-equilibrium relaxation of the velocity moments $hv_x v_y i$ and $hv_x^2 i$ $hv_y^2 i$ as a function of M, the mean particle number per cell. (a) =2a = 1.50, (b) =2a = 0.05. Bullets () show measurements and the solid line is a plot of Eq. (14). Parameters: L=a = 32, M = 5, A ! 1 and $k_B T = 1.0$.

Fig 4 shows the dimensionless decay rate e as a function of M.At = (2a) = 1.5 very good agreement is found for small and large M.At smaller the decay is slightly slower due to the mentioned correlation e ects.

C. Phase-space contraction and detailed balance

It is easy to see that the original SRD method conserves phase space and obeys detailed balance [3, 6]. The situation is more tricky for any coarse-grained, discrete-time method of hard-sphere collisions. In our model, any state in the 2dN-dimensional phase space is allowed, in contrast to a real hard-sphere system where particles cannot overlap. It is the collision rules described above which make certain states favorable than others. These rules ought to be biased to obtain a non-ideal equation of state and to build up non-ideal correlations between particle positions and their velocities. On the other hand, kinetic energy is conserved like in a real hard-sphere liquid, and we are in the microcanonical ensemble. Under these circum stances it is unavoidable that the dynamics must be phase space contracting, it has to project out certain states or at least sample them with a smaller probability. These unfavourable states correspond to the ones which are entirely forbidden in a real hard-sphere system.

A super cial analysis seems to indicate that phase space is conserved: The Jacobian of the stream ing step is always one and the Jacobian of the collision operation is either + 1 or 1. A closer look reveals, that the dependence of the collision probability on u destroyes this picture. A ssum e a N-particle state A with only one double cell and with u < 0. No collision is allowed to happen, the state remains unchanged: A (t+) = A (t) (W e leave out stream ing for the moment). Consider now a state B with identical particle positions as A but inversed velocities $v_i^{B} = v_i^{A}$. This time u > 0 and a collision happens resulting in B (t+) = A (t). Hence two dimensions are mapped onto exactly the same e state in one iteration: phase space is contracted.

As a consequence, the dynam ics is not time-reversible even in a stochastic sense: Inverting the signs of all velocities of state B (t +) = A(t +) and performing one iteration would lead to a collision going back to the time-inverted version of state B even if one would have started at A initially. In other words, there is no way to go back in time to a state which did not full l the collision criteria, namely u > 0.

The whole dynam ics presum ably still full lls detailed balance or at least sem idetailed balance, which is hard to prove since this involves not only the transition probabilities between states but also the (di cult to obtain) probability of the equilibrium states itself. Instead, we checked several therm odynam ic properties of the system such as consistency of the therm all uctuations with the pressure, [14, 15], and the speed of sound which are related by therm odynam ic expressions, and the scaling of interface uctuations for the binary version of the model [25]. No inconsistency due to the absence of tim e-reversibility or due to a possible violation of detailed balance could be observed.

Note, that also neither the consistent Boltzm ann algorithm (CBA) [17], nor the coarse-grained model by Pooley [24] nor any other method based on the Boltzm ann or Enskog equation are time-reversible, for similar reasons.

D. Additional SRD step

In order to change the viscosity independently from the equation of state, additional conventional stochastic rotations on the cell level can be performed. They will be denoted by the operator R. The stream ing step with a time step will be denoted by the operator S () and the biased collisions are called C.

To obtain a time-reversal order of operations one has to be careful once the time evolution consists of more than two non-commuting operations. Consider the set of operations :::S C R S C R :::. Inverting time, i.e. reading the sequence from the back leads to the chain :::S R C S R C ::: which is not equivalent to the previous one since C comes always after R, instead of R always following C. This set of operations can be symmetrized. One possibility would be using streaming with half the time step =2 such as :::S (=2) R S (=2) C S (=2) :::. This chain reads the same from the back, since R and C are embedded in S-operations. Another computationally more convenient choice would be random symmetrization: :::S R C R S R C R :::. Here R represents a rotation R which is only chosen with a probability 1=2. This is the symmetrization we actually used in all our simulations. These ways of approximating time evolution operators are very similiar to Trotter-Suzuki form ulaes used in modern symplectic M olecular D ynam ics and Q uantum M onte C arbo m ethods [26].

III. EQUILIBRIUM CALCULATION OF TRANSPORT COEFFICIENTS

A. Projection operator form alism

In Ref. [6] a projection operator form alism was developed to derive the linearized hydrodynam ic equations from the microscopic collision rules of Stochastic R otation D ynam ics (SRD). This technique was originally introduced by R.Zwanzig [27, 28, 29] and later adapted for lattice-gases by D uffy and E mst [30]. W ith the help of this form alism, explicit expressions for both the reversible (Euler) as well as dissipative terms of the long-time, large-length-scale hydrodynam ics equations for the coarse-grained hydrodynam ic variables were derived. In addition, G reen-K ubo (GK) relations were obtained which enable explicit calculations of the transport coe cients of the uid. The GK – relations of SRD di er from the well-known continuous versions due to the discrete time-dynam ics and the underlying lattice-structure.

In the following, we will brie y outline how this technique is extended to accome odate the new collision rule, Eq. (3), which in contrast to SRD does not conserve momentum and energy in single cells but in random ly chosen double cells instead. For more details about the form alism the reader is referred to Ref. [6].

The starting point of this theory are m icroscopic de nitions of local, hydrodynam ic variables A . These variables are the local density, m om entum, and energy density. They can be de ned on the cell level as

The hydrodynamic variables look m uch simpler and are easier to treat in Fourier-space. Their spatial Fourier transform s are given by

where j is the coordinate of the cell occupied by particle j. k = 2 n = (aL) is the wave vector, where n = 0; 1;::; (L 1); L for the spatial components.

The next step is to set up an evolution equation in discrete time which looks like a continuity equation in Fourierspace,

where t is the discrete time evolution operator, de ned as ${}_{t}A(t) = [A(t+) A(t)] = .$ However, up to this point this equation does not contain any information; the ux D is just formally de ned by ik D(t) = [A(t+) A(t)] = . The key point in making this expression meaningful is to set up a microscopic expression for the local conservation of density, momentum and energy (for SRD this expression is given by Eq. (23) in Ref. [6]). This expression is then inserted into the formal de nition of the uxes D in order to cancel divergent term s proportional to 1=k. If this can be done, the reform ulated D really is a ux and Eq. (18) is proven to be a continuity equation for the conserved quantities A .

In the current model, for every choice of double cells, the local conservation law can be expressed as

where $\frac{5}{j}$ is the coordinate of the cell occupied by particle j in the shifted system . Note, that similiar to original SRD, a random shift of cells before collisions is required to remove anomalies at small mean free path, see Ref. [1]. The vector z_{j1} is a function of the cell coordinate $\frac{5}{j}$ and has components which are either 0, 1 or 1. It is constructed such that the sum of the two exponentials in Eq. (19) is the same for two particles if and only if they are in the same double cell. The index $l_{1} l = 1;2:::6$ describes the choice of double cells in more detail than the vector j: l = 1 denotes the lower horizontal double cell, whereas l = 2 describes the top horizontal double cell in Fig. 1. Similarly,

l = 3 stands for the left vertical double cell, and l = 4 is needed if the particle j happens to be in the right vertical double cell. l = 5 is for the diagonal choice, and l = 6 for the o -diagonal choice of double cell.

In sum m ary, Eq. (19) is just another way of saying that the m can particle num ber, the m can velocity and energy in a double cell is the same before and after a collision.

For the m on ent we will assume that only one choice for the construction of double cells within a supercell is possible, i.e. liskept xed. Later, an average over l with the probabilities w and w_d will be performed. To obtain the evolution equations for the hydrodynamic variables A in k-space, the dimensional quotient tA = [A (t +) A (t)] = has to be written in a form ik D, where the ux D is of order O (k^0). (50) in part I [6]), the only dimensioned being the vector z_{j1} which describes the coupling to a neighbor cell. Hence, the entire form alism for calculating linearized hydrodynam ics and transport coe cients for an ideal SRD – uid can be applied without changes except the modi ed de nition of the ux. In particular, using Eq. (66) of [6] one easily obtains a G reen-K ubo relation for the kinem atic shear viscosity .

U sing the resum mation procedure described in [4], this GK-relation can be rewritten in a form which is easier to evaluate analytically. The resummation utilizes the exact Galilean-invariance provided by using random grid shifts and cancels all terms containing the unshifted cell positions $_{j}$. Then, the viscosity is obtained in terms of the o -diagonal part of a resummed stress tensor $_{xy}$,

A n important test for the validity of the new model and the de nition of the ux is, whether the reduced frequency matrix ! (see Eq. (48) in [6]) is symmetric. In [6] we checked that ! is symmetric for the original model. This matrix contains scalar products of the form hA \mathcal{D} i, hD \mathcal{A} i in the limit of k ! 0, i.e. averages where the ux and hence the vector z_{j1} occur only linearly. Note, that z_{j1} is uncorrelated to the velocity-variables a $_{j1}$. Furtherm ore, the probability is 1=2 that $_{j}$ is even or odd. Hence, $hz_{j1}i = 0$ for all 1, and $hz_{j1}a_{j1}i = 0$. It turns out that the additional non-ideal term in the ux does not contribute to the reduced frequency matrix; the matrix is symmetric and identical to the one of the ideal SRD – uid.




FIG.5: V iscosity as a function of time step . Filled circles (), squares () and triangles (N) show results for M = 1;3 and 5 respectively. M easurements are done thing vorticity decay proles for the smallest wave vectors and averaging over 5 dimensional ensembles. The error bars reject this averaging. The inset shows a comparison of these vorticity measurements () with the G reen-K ubo measurements () for M = 3. The solid lines are plots of the sum $_{kin} + _{coll}$ given by Eqs. (35) and (37) in both graphs. Parameters: L=a = 32, A + 1 and $k_B T = 1.0$.

B. Determ ining the viscosity

The G reen-K ubo relation given by Eq. (31) was evaluated analytically and numerically. If only the rst term in the stress tensor, Eq. (32), (which contains term s $v_{jx}v_{jy}$) is used in the evaluation of (31) one obtains the so-called kinetic viscosity $_{kin}$. Including particle number uctuations based on the Poisson-distribution, we found in the limit of large acceptance probability, A ! 1 (see Eq. (2)):

where we have neglected particle number uctuations. Since the rst term in Eq. (36) dominates at typical acceptance rates, the viscosity is proportional to the square root of temperature as in a real gas. Interestingly, in this lim it it turns out that the self-di usion constant is exactly equal to the kinetic viscosity, $D = \lim_{kin} M$ ore details about the derivation and numerical comparisons will be published elsew here.

For large m ean free path = (2a), the total viscosity is just given by the kinetic viscosity. However, at sm all m ean free path, additional contributions, denoted by _{coll} become relevant. For A ! 1 this contribution takes the form

However, the prefactor G is not known yet and m ight depend on time step f and temperature T. Exploring these details is subject of ongoing work.

Figure 5 shows m easurements of the total viscosity as function of mean free path and mean particle number per cell. For comparison, the theoretical expressions for $\frac{1}{kin} + \frac{1}{coll}$ from Eq. (35) and (37) are shown with an arbitrary constant prefactor G = 1=6. Good agreement is found for mean free paths =(2a) > 0.25. The inset in Fig. 5 compares measurements of the viscosity using two very different concepts, (i) using vorticity correlations as explained in Ref. [1], and (ii) using the GK-relation (31). The results of both methods agree within a few percent.

C. Absence of long-time tails




FIG.6: Tem poral evolution of the shear viscosity. (a) =2a = 1.50, (b) =2a = 0.05. The solid and dashed lines show the kinetic and total contributions to shear viscosity as a function of time step, respectively. The dotted lines show the prediction of Eq. (35) for $\frac{1}{kin}$. Parameters: L=a = 32, M = 5, $A \neq 1$ and $k_B T = 1.0$.

In two dimensions, the velocity-autocorrelation function R (t) = hv_{ix} (0) v_{ix} (t) i, and the stress correlation function h_{xy} (0) $_{xy}$ (t) i are expected to decay as 1=t at large times. Since the transport coe cients are related to the integrals of these correlation functions by GK-relations, one should see a logarithm ic divergence of the time-dependent viscosity. These \long-time tails" and the logarithm ic divergence have been measured in the original SRD-method [6] and found to be in quantitative agreement with general hydrodynamic theory [31, 32, 33]. However, as can be seen in Fig. 6 no such divergence could be detected in the present model. Instead, the viscosity quickly converges to a plateau and does not drift with time. The amplitudes of the expected divergent terms were calculated analytically in the 70's [31, 32] and shown to be essentially inversely proportional to the density and to the transport coe cients such as the shear viscosity and the self-di usion constant. We estimated these amplitudes and found that they are too small to be seen within our num erical resolution, since the present model is more viscous than original SRD.




FIG. 7: Normalized velocity auto-correlation function as a function of time for =2a = 0.25. The solid line is the prediction of Eq. (38). Parameters: L=a = 32, A = 1=60, M = 5 and $k_B T = 1.0$.

Fig. 7 shows the velocity auto-correlation function. For sm allA, a calculation based on the assumption of molecular chaos gives the following exponential behavior:

The m easured decay of the auto-correlation function R (t) is exponential over four decades and agrees perfectly with expression (38), i.e. there is no sign of long-tim e tails.

IV. THE EQUATION OF STATE

A. The m echanical route to pressure

In order to obtain explicit hydrodynam ic equations, the susceptibility matrix must be known. These equal time correlations do not follow from the projection operator technique and must be determined by other means. For a hard-sphere uid, the only quantity needed to obtain all necessary information is the equation of state. The other quantity, the internal energy, is already known since it is identical to that of an ideal gas. This is because we constructed our collision operations to leave the kinetic energy invariant in a double cell. Here, we follow the mechanical route to pressure, which is de ned as the average longitudinal momentum transfer across a xed interface per unit time and unit surface.

Let us assume this interface to be parallel to the y-direction, and only consider transfer of x-m omentum, i.e. the component p_{xx} of the pressure tensor is to be determined. Double cells aligned with the y-direction do not contribute, only double cells characterized by $_1$, $_3$, and $_4$ have to be considered. We will only discuss momentum transfer caused by collisions, but not the contributions from stream ing which give rise to the ideal part of the pressure.

Since the collision rules are applied in hom ogeneously shifted cells, the distance $_x$ between the left m ost corner of a double cell and the dividing line in x-direction is hom ogeneously distributed between 0 and 2a. The average am ount of m om entum transferred across the dividing line is zero for $_x = 0$ and $_x = 2a$, and increases linearly towards $_x = a$, i.e. reaches a maximum if the dividing line goes through the center of the double cell. A veraging over this position dependence leads to G tot = $\frac{1}{2}$ G m id. G tot is the averaged transferred m om entum, G m id is the transferred m om entum across a line going through the center of m ass of the double cell.

To obtain the pressure, the therm alloverage over the momentum transfer across a line is required which involves knowledge of the acceptance probability p_A (M₁; M₂; u) for a collision. One obtains

The factor 1=2 comes from the position average of the dividing line; the integral involves only positive u, because the acceptance rate is zero for u < 0. $p_G(u)$ is the probability that u_{1x} u_{2x} for the m icro-state of two cells is equal to u. w is the probability to select this double cell and will be equal to 1=4 as discussed before to ensure isotropy. 


FIG. 8: Non-ideal part of pressure times as a function of M. Data for = 0.05; 0.10; 0.20; 0.40; 0.60; 0.80; 1.00; 2.00 are collapsed. The solid line is the rst term ($k_B T$) of the theoretical prediction of Eq. (49). Parameters: L=a = 32, A = 1=60 and $k_B T = 1.0$.

The contributions to the pressure from all terms of this series can be exactly calculated but we restrict ourselves to the rst two terms. The reason is that all terms which are non-linear in are related to a therm odynam ic inconsistency and have to be kept small anyways. The size of the rst non-linear contribution will give us clues about the useful parameter range and estimations of the violation of therm odynamics.

Dening the pressure as the average momentum transfer per unit area and unit time, $p_1 = h G_x i = (a^{d 1})$ (d is the spatial dimension, which is two in our case), the pressure follows from Eqs. (41,44) as

These assumptions are only strictly true for an ideal gas, but turn out to be su ciently accurate. In principle, the corrections of this to the non-ideal equation of state and the resulting correlations of the particle numbers in adjacent cells should be calculated self-consistently.

W ith these approximations, one obtains the non-ideal part of the pressure averaged overparticle number uctuations in two dimensions:

Note, that $P_{non id}$ is quadratic in the particle density = $M = a^2$ to low est order in and for small A as one would expect from a virial expansion. Furtherm ore, the rst term in the non-ideal pressure is linear in temperature T which is also expected for a hard-sphere gas. The second term is just the rst contribution arising from the non-linearity of the hyperbolic tangent in the acceptance probability. All these terms lead to a non-linear dependency on temperature, which will be shown to be inconsistent with the internal energy of a hard-sphere gas. This means, the prefactor A has to be chosen small enough to be in the linear regime. This is equivalent to having a small acceptance rate for a collision. It turns out that acceptance rates of about 15% are su ciently small to avoid inconsistencies.

In the lim it A ! 1, the acceptance rate is 50% because u has to be positive to accept a collision. In this lim it and for large M an expression can be derived which shows a non-analytic dependence of both density and tem perature, namely $P_{non \ id}$ $P_{K_B T}$ which again is therm odynam ically inconsistent as discussed above. A nother technical di culty for this case is that the average over the particle uctuations cannot be perform ed exactly anym ore, only at large densities an asymptotic result is found. On the other hand, even for arbitrary values of A the pressure can be obtained as an in nite sum by expanding the hyperbolic tangent. A ll term s in this sum can be calculated exactly.

The o -diagonal term s of the pressure tensor can be calculated along the same lines. One $nds p_{1xy} = 0$, $p_{3xy} = p_{1xx} = p_{xy}$. Hence the total o -diagonal term P_{xy} vanishes. In the limit of A ! 1 and for large M, the equation of state has the following non-analytic form :

where a is the lattice unit of the cell, is the mean free path = $p \frac{p}{k_B T}$.

B. A m icroscopic expression for the pressure

The m icroscopic expression for the ux D was derived in Eq. (30). The components = 2;:1 + d also provide a m icroscopic expression of the stress tensor: the average of the diagonal part gives the virial expression for the pressure,

The rst term was discussed in part II of Ref. [6], $hv_{x;j} = h v_{x;j}^2$ i and gives the ideal part of the pressure, P_{ideal} . The average over the second term vanishes (see Ref. [6]); and it is the third term leading to an expression for the non-ideal part of the pressure. As seen directly from Eq. (51), this term counts the momentum transfer between the two cells in a double cell:

Consider a horizontal double cell for simplicity. Let p be the total momentum change (in x-direction) in the left cell. D ue to momentum conservation in the double cell, the total momentum change in the right cell is equal to p. Now, z_x is equal to 1 in the left cell and equal to 1 in the right cell. Hence, as a result of the multiplication by $z_x=2$ in Eq. (51) we have p(1=2) p(1=2) = p, i.e. the non-ideal part of the pressure is expressed as the sum of all the momentum is mostly positive, since only the collisions with a higher mean velocity in the left cell are allowed to happen. This explains why biased collisions are needed to obtain a non-ideal equation of state; in original SRD there is still momentum transfer due to rotations across a plane but with positive and negative contributions which cancel each other.

In the current model, due to particle number uctuations, there can be situations where the mean velocity in the left cell is higher than in the right allowing a collision, but the mean momentum $= u_1 M_1$ is smaller than in the right cell with $M_1 < M_2$. This would lead to a negative contribution to the pressure. However, these are events of small probability and are even less relevant at higher particle density. On average, unlike in original SRD, the amount of transferred momentum does not vanish, and we have indeed a non-zero pressure.

C om parison with the analytical expression, (49) shows good agreem ent, Fig. 8. There are deviations at large M because the acceptance rate gets larger with M, and at rates above 15% the term s proportional to $(k_B T)^2$ become important in the pressure, (49). These corrections were not included in the theory plotted in the gure because the m odel becomes therm odynam ically inconsistent in that range. Better agreem ent at larger M can always be obtained by decreasing the prefactor A in Eq. (2).

C. Density uctuations and therm odynam ic consistency

Therm odynam ics gives a relation between derivatives of the pressure p and the structure factor S (k;t) at zero time t = 0 and in the sm all wave number $j_{k}j! = 0$ lim it,




FIG.9: Static structure factor S (k;t = 0) as a function of (a) for M = 3, (b) M for = 1.0. The open () circles show measurements from taking the numerical derivative of the pressure. The led () circles show direct measurements of the density uctuations. The solid line shows the theoretical prediction based on Eqs. (49) and (52). k denotes the lowest possible wave vector, k = (2 = L) (1;0). Parameters: L=a = 32, A = 1=60 and $k_B T = 1:0$.

On the other hand S (k;t = 0) is given by the equal time correlations of the density uctuations in Fourier space, $h_k(0)_k(0)i$. Hence, a numerical consistency check can be performed: The density uctuations are measured, and the derivative of the measured pressure is taken numerically and inserted into Eq. (52). Both routes should lead to the same S (k;t = 0) which can also be calculated analytically using the equation of state, (49). As shown in Fig. 9, this works nicely for small prefactors A and both large and small time steps . For small (< 5) good agreement is achieved. For larger M, one comes closer to the limit of A ! 1, where the acceptance probability is independent of particle densities; this limit is therm odynamically inconsistent as we will discuss below. Of course, if agreement for M > 4 is required, all one has to do is to reduce A, i.e. decrease the acceptance probability.

As mentioned before, at large acceptance probability, where the non-linear term s in A in the equation of state are not negligible, the model is not therm odynam ically consistent. The reason is that these terms contain non-linear functions of temperature $k_B T$. This leads to the following problem : let us assume a term in the equation of state of the form T^{2-n} , where $n \in 1$. The pressure is related to the free energy density f by the relation

which gives in our case:

F in ally, we obtain the part of the internal energy density related to the pressure term T^2 as

The rst term is linear in , the second one is nonlinear in . Hence it is in possible to have u = 0 at all densities even for an arbitrary function C (T). This is a contradiction, because we have a model with collision rules which exactly conserve kinetic energy. Hence, the internal energy should be the same as for an ideal gas, i.e., there should be a kinetic term only and the additional contribution related to the non-ideal part of the pressure should be zero at any tem perature and density. The fact that there are additional contributions to the internal energy probably means that the therm odynam ic tem perature does not agree with the kinetic one (de ned via the square of the particle velocities) and m ight be the cause of the observed inconsistencies in the density uctuations at large A (de ned in Eq. (2)). This seem s to be supported by another contradiction we observed at large A : The measured tem perature uctuations seem to be consistent with the speci c heat $c_V = dk_B = 2$ of an ideal gas, but the theoretical prediction for c_V based on a free energy density with non-linear tem perature dependence di ers from $dk_B = 2$.




FIG.10: Ordering at small . Initial con guration is 23 23 clouds. Observed con guration is 23 23. Parameters: L=a=32, A=1=60, M'=4:69, =0:0005 and $k_B T=1:0$.

V. CAGING AND ORDER/DISORDER TRANSITION




FIG.11: Pair-correlation function for the con guration shown in Fig. 10.

W hen the non-idealpart of the pressure is signi cantly larger than the idealpart, ordering e ects can be expected. As in a real hard-sphere gas, both parts scale with tem perature in the same way (for sm all A). Hence, as in a real system which does not have an energy scale, we can assume that changing the tem perature alone will not lead to an order/disorder transition | unless of course tem perature becomes so large that the nonlinear terms in the pressure become relevant. On the other hand, the two pressure terms have different dependencies on time step and density.

can be interpreted as a parameter describing the e ciency of a collision; lowering would have a similar e ect as making the spheres larger in a real system, resulting in a higher collision frequency. Therefore, we expect caging and ordering e ects if either is increased or is decreased. This is indeed the case. For < 0:0016 and M 5, an ordered cubic state is observed, as shown in Fig. 10. In Fig. 11, the pair-correlation for this state is plotted. Unlike in a real system, clouds of several particles are concentrated at locations $r_{nm} = na_x + ma_y$, where a_x , a_y are the periodicity in x and y-direction, respectively. The average num ber of particles in these clouds will be called the cloud num ber. We found that there is usually at least four particles per cloud. These ordered structures are similar to the low-tem perature phase of particles with a strong repulsion at interm ediate distances, but a soft repulsion at short distances.




FIG.12: O rdered state with defect. Initial ordered con guration is 16 16 clouds. O bserved con guration is 20 19 20. Param eters: L=a=32, A=1=60, M ' 4:69, = 0:0005 and $k_B T = 1:0$.

One of the surprising features of this crystal-like state is, that x-y symmetry can be broken, i.e. ax is not always equal to ay. Furtherm ore, there is the possibility of having several possible m etastable crystalline states corresponding to slightly di erent lattice constants and cloud num ber. For instance, Fig. 10 and Fig. 12, were created for the same param eters but di erent initial conditions. W hile there is 23 23 clouds in the rst gure, there is 20 19 20 in the other. This means also that in the latter picture a_x and a_y di er slightly. Both states are relatively stable over long times. However, in Fig. 12 we see a lattice defect (circled for better visibility) and there is still activity in the lower middle part of the sam ple where particles seem to migrate from one cloud to another. As expected, the lattice constants a_x ; a_y 1:6 are slightly sm aller than the super cell spacing 2a which sets the range of the multi-particle interaction. In this state the di usion coe cient becom es very sm all, particles are caged and can barely leave their location. As shown in Fig. 14, we measured the coe cient of self-di usion D as a function of time step in the long-time limit, i.e. after an eventual transition to an ordered state. Above a critical $_{
m C}$ 0:0016 (at M = 5) the m easured value of D agrees perfectly with the theoretical prediction:




FIG.13: Pair-correlation function for the con guration shown in Fig. 12.




FIG.14: Self-di usion coe cient D as a function of time step \cdot . The solid line is the prediction of Eq. (58). Parameters: L=a = 64, A = 1=60, M = 5 and k_B T = 1:0.




FIG.15: Pair-connelation function below and above freezing. The lled () and open () circles show m easurements for = 0.0014 and = 0.0018, respectively. Parameters: L=a=32, A=1=60, M=5 and $k_B T=1.0$.

(A is small and particle number uctuations were neglected here). However, D dram atically drops below $_{\rm C}$ which is exactly the value of below which we clearly see an ordered state. This pronounced e ect allows us to be the transition point quantitatively. Another way to describe the transition is by determining the pair-correlation function g(r). Fig. 15 shows that the behavior of g(r) is very different slightly above and below $_{\rm C}$. Below $_{\rm C}$ we see oscillations due to a cubic structure with long-range order with lattice constant 1:6a. To describe the transition in more detail one could plot the amplitude of the Fourier-mode for the oscillation in g(r) (not shown here).

How can we understand the stability of the ordered state? W ithout collisional interaction, particle clouds will broaden due to stream ing, which will happen the faster the higher tem perature is. Due to the grid shift, particles at the perim eter of the clouds will more offen undergo collisions with neighboring clouds. These collisions provide back-scattering, particles are forced to y back towards the center of their cloud. Thus, a correlation between distance from cloud center and speed is built up leading to stable cloud form ation.

VI. GENERALIZATION TO A BINARY MIXTURE

The collision model can be easily generalized to multi-component mixtures. Consider a binary system with two types of particles, A and B. In order to obtain phase separation we introduce a repulsive interaction between di erent kind of the particles, but no repulsion among particles of the same kind. This is done in the following way: Suppose a double cell is selected for a possible collision. A -particles in cell 1 can now undergo a collision with B particles from cell 2. Furthermore, B particles from cell 1 are checked for possible collision with A particles in cell 1. The rules and probabilities for these collisions are exactly the same as in the one-component situation. Since in a phase separated situation there is hardly any collision away from the phase boundary, additional regular SRD -rotations on the cell

level are incorporated to m ix particle m om enta.

A phase separation into an A and B rich phase is observed above a critical prefactor A of about $A_c = 0.36$ for $M_A = M_B = 5$, $M_{A,B}$ being the average number of A and B particles in a cell, respectively. The phase diagram does not depend on temperature as expected since similiar to a hard-sphere gas there is no energy scale in the present m odel. The spectrum of the interface uctuations of droplets well above A_c was analyzed, and it was found that they scale with wave number k as $1=k^2$ as expected. Q uantities like pressure, chem ical potentials, surface tension and transport coe cients were also obtained analytically and will be published elsewhere [25].

VII. CONCLUSION

In this paper we analyzed a particle-based model for uid dynamics with e ective excluded volum e interactions which was introduced in Ref. [14]. These interactions are modeled by means of stochastic multiparticle collisions which are biased and depend on local velocities and densities, but exactly conservem on entum and energy locally. The motivation for such a model and the collision rules were explained in detail. The relaxation to thermal equilibrium was investigated analytically and num erically, and it was shown how this relaxation was used as a guide to make the model as isotropic as possible on a cubic grid. A brief sum mary of how to calculate the pressure was already given in Ref. [14]; here we give a more detailed description of the calculation. We also show how a microscopic form ula for the pressure can be derived, which allows local measurem ents of the pressure.

In addition, we outlined how a discrete-time projection operator technique developed for original SRD [6] can be generalized to the current model, and how G reen-K ubo relations can be obtained for the transport coe cients. Num ericalm easurem ents of the velocity and stress auto-correlation functions did not show long-time tails even though all the simulations were done in two dimensions. We think that this is mainly due to the large viscosity of the model, leading to am plitudes of the tails much sm aller than the num erical resolution.

In the lim it of very large collision frequency, i.e. at large particle density and/or small time step we found an ordered cubic phase. The four-fold symmetry of this state is a numerical artifact due to the underlying cubic grid, but the crystallization itself resembles caging in a real gas and is a generic feature of models with soft repulsion at short distances. This order/disorder transition was quantitatively located by measuring the self-di usion coe cient D. At the transition we saw a pronounced change of the behavior of the di usion coe cient: D is about one to two orders of magnitude lower in the ordered phase than it would be in a hom ogeneous system.

The ordered state consists of particle clouds containing at least four particles. These clouds form m etastable cubic phases with long-range order. The lattice constant of these phases could slightly vary in x- and y-direction for the sam e set of parameters. This is due to the additional degree of freedom of how many particles on average can live in a cloud. Lattice defects were observed leading to a slow evolution from less favourable states where the lattice constant was below or above the optimum range. This range seems to be centered around 1:6a.

The current model was extended to multi-component mixtures such as binary mixtures and microemulsions, and the critical behavior was investigated. These studies will be published elsewhere.

APPENDIX A:AVERAGES OF u

A verages of u, the mean velocity di erence between two cells, show up in the calculation of the acceptance rate for a collision. They can be measured as a test of the correct in plementation of the code. We restrict ourselves to horizontal cells, where only the x-component of velocities are needed. In this case u is de ned as

where p_G is given in Eq. (42). The particle mass is set to one as before, and is dened as in Eq. (44).

The average over the particle uctuations, which we again assume to be Poisson-distributed, and uncorrelated on the cell level cannot be done analytically. Let us rst consider $h(u)^2 i$ which does not have the complication of a square root, p^{-} . It involves the following averages

The double bracket denotes the average over the particle num ber in a cell, while the single bracket is for averages over velocity distributions. The rhs. of Eq. (A 3) can be expressed in integral form :

Hence, the behavior of hj u ji= $p \frac{p}{k_B} T_p$ is proportional to M $p \frac{p}{2}$ M 2 (4 $p \frac{p}{2}$) = $p \frac{p}{2}$ at sm all M, reaches a m axim um around M = 1 and behaves as 1 = M at very large M. This non-m onotonic behavior suggests that functions of

should not occur in the equation of state but should be cancelled by an appropriate collision probability. W ithout the cancellation there m ight be unphysical phase transitions at densities around M = 1.
