# A c-theorem for the entanglem ent entropy

#### Abstract

The combination of the Lorentz symmetry and the strong subadditive property of the entropy leads to a c-theorem for the entanglem ent entropy in $1+1$ dim ensions. W e present a sim ple derivation of th is theorem and com pare the associated c-functions w th the Zam olodchikov's ones for the case of free elds. W e discuss the various di culties which obstacle the naive generalizations of the entropic c-theorem to higher dim ensions.


## 1. Entanglem ent entropy

Suppose we are interested in the physics of events localized in a region A of the space. The H ibert space of states can be decom posed accordingly as a tensor product $H=H_{A} \quad H_{A}$ where $H_{A}$ and $H_{A}$ are the spaces of states localized in $A$ and in the com plem entary region A respectively. Take the vacuum (the fundam ental state) as a global state $j$ i of the system with density matrix $0=j$ ih $j$. The state $A$ relevant to the algebra of operators acting on $\mathrm{H}_{\mathrm{A}}$ follows from the partial trace of 0 over the H illbert space H A. That is, we obtain the local reduced density m atrix

The global state 0 is generally entangled in the bipartite system $H_{A} \quad H_{A}$ and in consequence this $m$ atrix is a $m$ ixed (non pure) state for the local region. The corresponding entropy

is usually called entanglem ent or geom etric entropy.
The entanglem ent entropy is one of the $m$ ost prom inent candidates to explain the intriguing entropy of the black holes [l]. H ow ever, in this proposal the role of quantum gravity is fundam ental to produce a nite entropy, and the whole sub ject is still controversial. In a series of recent papers a de nite conjecture for the meaning of the entanglem ent entropy in the context of the A dS-CFT duality has been given [2].

This and other $m$ easures of entanglem ent have also been extensively studied in condensed $m$ atter and low dim ensional system $s$, partially motivated by advances in quantum inform ation theory and the density $m$ atrix renorm alization group $m$ ethod. As a result it was uncovered that a variety of phenom ena have an interesting correlation
$w$ th the entanglem ent properties of fundam ental states. This includes quantum phase transitions [3], topological order [4], and, as will be reviewed in this paper, the renorm alization group irreversibility in two dim ensions [5, 6].

## 2. Entanglem ent entropy and quantum eld theory

From the point of view of quantum eld theory (QFT) the entanglem ent entropy $S$ (A) can be considered as a non local variable which is de nable for any theory disregarding the eld content. In this sense it can be identi ed as a natural tool to investigate general properties of Q FT. In fact, the entanglem ent entropy satis es very rem arkable non perturbative relations (see for exam ple (7])

The rst one follows from the purity of the vacuum state, while the second, called strong subadditivity (SSA), is a general and very im portant property of the entropy for $\mathrm{m} u$ ltipartite system s .

From a technical point of view, the entanglem ent entropy $S(A)$ is proportional to the variation of the Euclidean free energy w ith respect to the introduction of a sm all conical singularity at the boundary of A [8, [9]. Explicitly we have

where $Z(A ;)$ is the Euclidean partition function of the theory on a space w ith conical singularity of angle 2 at the boundary of A.

The entanglem ent entropy in the continuum theory is ultraviolet divergent. H ow ever, it has a nice geom etrical structure of divergences. In $d$ spatial dim ensions we have [10]

where $S_{0}(V)$ is a nite part, is a short distance cuto, and the $g_{i}$ are local and extensive functions on the boundary $@ V$, which are hom ogeneous of degree i. The leading divergent term coe cient $g_{d}[@ V]$ is then proportional to the ( $d$ 1) power of the size of $V$, and this is usually referred to as the area law for the entanglem ent entropy [11]. H ow ever, $g_{i}$ for $i>0$ depends on the regularization procedure and $g_{d} 1$ is not proportional to the area if this later is not rotational invariant. These term s are not physicalw ithin QFT since they are not related to continuum quantities.

Universal quantities are present in $S(A)$ however. In particular the mutual inform ation

between two non-intersecting regions is universal since the boundary terms get subtracted aw ay [5]. In fact, a general theorem based on the strong subadditive property
and the Lorentz covariance [7] establishes that if the entanglem ent entropy is nite, the m utualinform ation is identically zero for a relativistic Q FT.T he presence of a non zero m utualinform ation im plies that the entropy cannot bem ade nite through contributions com ing from the physics at the high energy sectors (w ithin QFT).

## 3. The c-theorem

The statem ent of the ctheorem in $1+1$ dim ensions [12] can be expressed in two equivalent w ays:
(a) There is a universal dim ensionless function of the couplings $C$ ( $f{ }_{i} g$ ) in the theories space in $1+1$ dimensions which is non-increasing along the renom alization group trajectories and stationary at the xed points, where it takes a nite value proportional to the V irasoro central charge $\mathrm{C}_{\mathrm{V}}$.
(b) For any theory in $1+1$ dim ensions there is a universal dim ensionless function of a distance $C(r)$ which is non-increasing under dilatations and takes a nite value proportional to $C_{V}$ at the xed points.

An interesting interpretation which follows from the form ulation (a) is that the cfunction $m$ easures som e kind of entropy related to the inform ation which is lost during the renorm alization group transform ations. H ow ever, if we take this too literally, we could conclude that the theorem should also be valid outside the dom ain of unitary and relativistic theories, where it actually does not hold. In contrast, the form ulation (b) does not refer to the renorm alization group and show the ctheorem as a property of the continuum theory, disregarding the procedure used to de ne it.

T he Zam olodchikov's proofofthe ctheorem is given in the Euclidean form ulation of the two dim ensionalQ FT, and involves the covariance of the energy $m$ om entum tensor correlators plus the re exion positivity property. H ere we show a very sim ple altemative proof based on the strong subadditive property of the entanglem ent entropy and the Lorentz invariance in a realspace-tim e form ulation [5].

C onsider tw o intervals of lengths.b and c relatively boosted to each other and located as shown in gure 1. The causaldom ain ofdependence ofthese intervals (causalshadow) have intersection and causalunion given by the ones corresponding to the tw o intervals of length $a$ and $d$. These sets appear in the $s m$ all side of the relativistic version of the strong subadditive inequally betw een b and c [7]. T hen, we havez

T he relativistic geom etry gives the sim ple relation

z To be explicit, this relation is just the standard SSA inequality on the (non tim e-like) surface $c_{1}$ [ $a\left[b_{1}\right.$ (see gure 1), which gives $S\left(c_{1}[a)+S\left(a\left[b_{1}\right) \quad S(a)+S\left(c_{1}\left[a\left[b_{1}\right)\right.\right.\right.\right.$, followed by the identi cation of $S\left(c_{1}[a)=S(c), S\left(a\left[b_{1}\right)=S(b)\right.\right.$, and $S\left(c_{1}\left[a\left[b_{1}\right)=S(d)\right.\right.$, which is a consequence of the unitarity of the causalevolution.

which can be rew ritten as

$$

Therefore (8) gives

$$

S(b) \quad S(a) \quad S(b) \quad S(a): \tag{11}

Thism eans that the di erence of the entropies $S(b) S(a)$, with $b \quad a$ is non-increasing under dilatations. It is also dim ensionless and universal since according to (6) in two dim ensions the divergent term for an interval is a constant (independent of the interval size) proportionalto $\log ()$. At the conform al xed points the entropy can be explicitly evaluated [9], and is given by

Thus, at the xed points $S(b) \quad S(a)=\left(C_{V}=3\right) \log (b=a) \quad 0$. We conclude that $S$ (b) $\quad S(a)$ is a c-fiunction for any $b>a$.

An entropic c-fiunction depending on a single param eter (and containing all the inform ation in $S$ (b) $S(a))$ can be de ned by

which is dim ensionless, universal, positive, and according to (11) satis es

$$
\begin{equation*}
c^{0}(r)=r S^{\infty}(r)+S^{0}(r) \quad 0: \tag{14}

W e have com puted the entropic c-fiunctions for free ferm ions and bosons num erically in a lattice and found analytically short and long distance expansions using (5) (13]. The analytic results involve sine-G ordon $m$ odel correlators of exponential operators which are given in term s of $P$ ainleve $V$ di erential equations. A s shown in gure 2 these are

quite di erent from the Zam olodchikov's ones. The leading short and long distance term s read

where $t=m r, m$ is the eld $m$ ass, and $c_{D}(t)$ and $c_{S}(t)$ are the entropic c-finctions corresponding to a free D irac and a real scalar eld respectively.
4. Is there an entropic c-theorem in $m$ ore dim ensions?

Though several authors have $m$ ade $m u c h$ progress in the direction of extending the c-theorem to higher dim ensions using correlators of the energy m om entum tensor, no de nitive result has been obtained so far [14]. Thus, it is tempting to try the present $m$ ethod in $m$ ore dim ensions, exploiting the Lorentz sym $m$ etry and the strong subadditive inequality on the geom etric entropy. H ow ever, one has to bear in $m$ ind that no com pelling physical principle guarantees that a version of the theorem has to hold in d 2 15]. W e have essayed di erent possibilities w ithout success, since several obstacles show up in higher dim ensions. W hat follow s is a list of som e of them. They $m$ ay be avoided in de Sitter space but at the expense of introducing a dim ensionfull param eter (the space-tim e radius) which im pedes the proof of the theorem. a-. The shape problem : a generalization of the construction on gure 1 requires to select a speci c shape for the set replacing the interval in two dim ensions. T he rst obstacle is then that in d 2 the intersections and unions of sets with a given shape are in general of a di erent shape. A lso, the SSA relation betw een them in general contains divergent term s on each side which do not cancel due to the new surface features contained in the intersection and the union. This put di culties in the gain of useful inform ation from the SSA relation.
b-. The commutativity problem : there are certain shapes for which the previous problem does not appear, for exam ple two rectangles form ed by moving one of them along one of its sides. H ow ever, if the rectangles are boosted to each other (this is essential in (11)) there are pieces of the boundary of one of the rectangles whidh are at a tim elike distance from the other: technically they do not com $m$ ute in the algebra of causal sets, and the SSA relation cannot be used [7]. W e can avoid this problem by using the lim it of rectangles w ith one large side. H ow ever, in this case we have to consider intensive quantities $w$ ith respect to the large side, the corresponding $c$ functions are dim ensionfull, and cannot be used to prove the theorem.
c-. The order of the divergences: this is perhaps the deepest problem encountered. Because of its nature, the SSA relation when used betw een in nitesim ally displaced sets, allow us to obtain inequalities involving only second order derivatives of the entropy. H ow ever, in d spatial dim ensions we have general divergent term sw ith d 1 dim ensions. $T$ hus, the localSSA relation cannot give inequalities for universal quantities ifd 2. $d-$. Logarithm ic term $s$ : the $m$ utual inform ation $I(A ; B)$ is universal, dim ensionless and increasing w ith the size of $A$ and $B$. Thus, $I(A ; B)$ is decreasing under dilatations for star-shaped non-intersecting sets A and B. H ow ever I (A;B) diverges logarithm ically at critical points due to the logarithm ic term s induced by the vertioes [10].
