H igh energy scales in electronic self-energy im aged by optics

We use a new technique to directly extract an estimate of the quasiparticle self-energy from the optical conductivity which can be easily related to both theory and angle-resolved photoem ission spectroscopy (ARPES) experiments. In the high T_c cuprate B i-2212 we nd evidence for a new high energy scale at 900 m eV in addition to the two previously well known ones at roughly 50 and 400 m eV. The intermediate scale at 400 m eV has been recently seen in ARPES as a large kink which optics nds to be weaker and shifted. In YBCO, the three energy scales are shifted to lower energy relative to B i-2212 and we observe the emergence of a possible fourth high energy feature at 600 m eV.

One of the most beautiful aspects of studying condensed matter systems is that a large number of very di erent types of experim ents are available to probe the many-body state, and in the quest for microscopic understanding all of the various probes must concur about the features observed. This provides a stringent test of theories and further allows for the perfection of experim ental technique and analysis. Consequently, if there is an opportunity to bring two di erent techniques closer together for the purpose of com parison, both theory and experiment will be ne t and there will be a great enhancem ent of the ability to identify potentially fundam ental and robust signatures of the underlying physics. Two powerful techniques which have been brought to bear on the problem of high T_c superconductivity are angleresolved photoem ission spectroscopy (ARPES) [1, 2] and far-infrared optical spectroscopy [3]. These techniques have blossom ed with the dem ands of this area of study resulting in unprecedented resolution and new m ethods for extraction and analysis of information, such as through inversion techniques.[4, 5, 6, 7, 8, 9]

Applying inversion techniques to the optical conductivity has resulted in the identi cation of a coupling of the charge carriers to a resonance mode at about 50 m eV and a spin uctuation background extending beyond 400 m eV .[8, 9, 10, 11] A R P E S, on the other hand, has mainly con m ed the low energy scale as, until recently, they were limited to presenting data for the quasiparticle dispersion curve up to about 200-300 m eV in energy.[12, 13, 14, 15, 16, 17, 18, 19, 20] How ever, new advances have extended this range to greater than 1 eV and several works[21, 22, 23, 24, 25] are reporting features at high energy at about 400 m eV and 800 m eV, which are speculated to arise from exotic physics. C on-

m ing the existence of these new energy scales and investigating a wide range of materials is essential to the development of these or other new ideas.

In this letter, we present com plem entary results ob-

tained from optical data and dem onstrate, at the same time, a new technique which allows for the direct, although approximate, extraction of the quasiparticle selfenergy from the optical conductivity, which can be com pared most easily with the ARPES via a dispersion-type curve. This is in portant because optics is a bulk probe as opposed to ARPES which is only sensitive to the surface. In addition, optical spectroscopy m easures the selfenergy due to correlations directly while ARPES nds, instead, the renorm alized energy and the self-energy follows only once the bare dispersion is known. Using our new technique to analyze the data on Bi-2212 sam ples of varying doping, we can show that optics also sees features at high energy and supports som e of the observations seen in ARPES, but not all. M oreover, as optical experiments are more exible in the type of materials which can be studied, our work goes beyond Bi-2212 to exam ine the high energy scales in YBCO.

We begin by discussing the theoretical basis for the new analysis of optics which allows for the extraction of the quasiparticle self-energy. W ithin the experimental community, it has become common to analyze the complex optical conductivity (!) for the correlated charge carriers in terms of the optical self-energy, $^{op} = {}_{1}^{op}$ (!) + i ${}_{2}^{op}$ (!), using an extended D rude m odel of the form :[3, 10]

where $!_p$ is the plasm a frequency. ^{op} can be written in term s of the optical scattering rate 1= ^{op} (!) and the opticalm ass renorm alization 1 + op (!) by

and it is routine to present quantities such as 1= ^{op} or ^{op}. Despite the suggestive structure of this form, ^{op} is not the quasiparticle self-energy ^{qp} and 1= ^{op} is not the quasiparticle scattering rate. However, these quantities do encode such inform ation and within a set of reasonable approximations, a surprisingly simple procedure can be applied to extract ^{qp} from ^{op}.

If we can assume, for the sake of argument, that the renormalization and scattering of charge carriers is due to some sort of frequency-dependent interaction with a bosonic spectrum which we will call 2 F (!) in analogy to the conventional electron-phonon spectral function, then we can show that [26, 27, 28, 29]

where the electronic density of states N (!) can be energy-dependent and we have ignored the di erence between the transport and quasiparticle spectral densities, $_{tr}^2$ F and 2 F, respectively. The approximations behind these form ulas and their range of validity may be found in the work of A llen [30], Shulga et al.[31], and Sharapov and C arbotte [32]. For convenience, these equations are stated here for T = 0 and for no in purity scattering. In the cuprates, we can assume the clean limit. Finite tem – peratures e ects are easily incorporated when needed. If we de ne a new quantity, following the work of C arbotte et al.[33], which we will call the optically-derived quasiparticle self-energy,

then from Eqs. (5) and (6), the derivative in Eq. (7) gives exactly $^{\rm qp}$.




FIG.1: (color online) Theoretical illustration based on the model described in the text which demonstrates that the quasiparticle dispersion curve can be extracted from optics (op-qp) via our new procedure. It agrees well in magnitude and detailed structure with the exact theoretical curve (qp). If the optical self-energy is used, the resulting dispersion curve (op) is structureless and does not agree with the exact result. The inset illustrates for a realm aterial B i-2212 the di erence between the dispersion curve derived from the optical self-energy and that from the new procedure which gives rise to detailed structure and speci c energy scales.

To illustrate the e ectiveness of Eq. (7) to determ ine the exact quasiparticle self-energy, we show a model calculation in Fig. 1, where an ${}^{2}F$ (!) spectrum consisting of three delta functions has been used to calculate both the exact ${}^{\rm qp}$ from many-body theory and the optical conductivity in the usual K ubo approximation.[26, 27] The optical conductivity is then processed via Eqs. (3)-(4) and (7) to obtain ${}^{\rm op}{}^{\rm qp}$. In the gure, we have

chosen to plot the real part of in terms of a renorm alized dispersion curve where $E_k = k$ ₁ (E_k) [34] as we wish eventually to make comparison with ARPES in the same form at. The dispersion curve for ^{qp} shows very clearly three structures due to the three -function peaks in the ${}^{2}F$ at 0.04, 0.09, and 0.19 eV [27]. However, the curve form ed from op is fairly featureless and does not capture any of the underlying structure of the spectral function. In addition, this calculation has included a nite band density of states [26, 27, 28] which causes the renorm alized dispersion curve to cross the bare dispersion curve (a fact that is not well-known, but is a signature of nite bands) and once again the curve from op has not crossed the bare dispersion at the same energy and indeed the crossing is higher in energy by a factor of roughly two. On the other hand, the optically-derived quasiparticle self-energy op q gives a dispersion curve in excellent agreem ent with the exact one and it reproduces all of the structures at the correct energies and with the proper magnitude. A side from a small overshoot of the curve between about 0.3 and 0.4 eV due to the derivative technique which is known to produce such characteristics just after the end of the boson spectrum,




FIG.2: (color online) (a) D ispersion curve derived from optics for optim ally-doped Bi-2212, for T = 100 K, in a color m ap showing the relative height and width of A (k;w), as is done in ARPES. (b) D ispersion curve from (a) repeated (op-qp) and com pared with the result reported by ARPES and with the theoretical LDA curve from Ref. [36]. The grey shading gives the width of the optically-derived quasiparticle curve based on the in aginary part of the self-energy.

the op-qp curve also crosses the bare dispersion at the sam e point as the qp curve. The agreem ent is rem arkable and sim ilar agreem ent is found in the detailed com parison of the real and in aginary parts of ^{qp} and ^{op qp} (not shown). The grey shading shows the broadening of the dispersion curve which occurs with 2 and is indicated by j_{2}^{qp} j. The inset of this gure shows the procedure of Eq. (7) applied to experim ental optical data for optim ally-doped Bi-2212 at T = 100K [10, 35]. Again, ^{op} gives a featureless dispersion curve, but ^{op qp} restores structures in the curve (such as the kink at 50 meV) which can now be compared to ARPES. Fig. 1 em phasizes that it is ^{op qp} which must be used for this purpose. A point that must be made before continuing to such a comparison is that optics is a transport property and it does not contain m om entum -dependent information. Consequently, along with the assumption that ${}_{tr}^2 F = {}^2 F$, we stress that the \dispersion curves" presented here are to be viewed as m om entum -averaged curves in term s of the self-energy and the only rem aining m om entum -dependence enters through the bare dispersion k which is taken from LDA calculations.

Having established the technique, we now present our new results on high energy scales in B i-2212 and YBCO as imaged by optics. In Fig. 2, we present the analysis of the optical data for optimally-doped B i-2212 at 100 K. The derivative needed in Eq. (7) to extract $^{\rm op}$ $^{\rm op}$ can introduce noise and we have applied smoothing techniques as is reasonable since we are interested mainly in capturing global features. For comparison with ARPES, we have presented the $^{\rm op}$ $^{\rm op}$ in the form




FIG. 3: (color online) Upper frame: The real part of the optically-derived quasiparticle self-energy for three Bi-2212 sam ples, overdoped, optim ally-doped and underdoped, and one underdoped YBCO in the orthoII phase [38], all at T = 100 K. Lower frame: The imaginary part of the optically-derived quasiparticle self-energy. Various energy scales are indicated on the curves and discussed in the text. The inset gives the 2 F (!) obtained in the optim ally doped Bi-2212 from inversion of optical data. [11]

of a dispersion curve using an LDA calculation [36] for the bare dispersion k. W ith this information, we can form a color map of the quasiparticle spectral function $\binom{\text{op qp}}{1}^{2} + (\binom{\text{op qp}}{2})^{2}$] $A(k;!) = \frac{1}{2}j_{2}^{op qp} \neq [(!)$ k to connect to the raw data as presented by ARPES. In Fig. 2b, we com pare our data with that of G rafet al.[21] from ARPES in the nodal direction on a similar optimally doped sample. In the ARPES, they identify three energy scales with these data at $E_0 = 50 \text{ m eV}$, E_1 0:4 eV , and E_2 0:8 eV. In our data, we can con m a structure at 0:9 eV and a much stronger kink at E₀ 50 m eV, E_2 however, we do not nd evidence for a very strong feature at 0.4 eV, although the $\frac{\text{op qp}}{1}$ does show a local maximum around 0.25 eV. The broadening that we nd is within the range that is found by ARPES. Thus, we conclude that overall, we nd agreement with ARPES using our analysis as shown in Fig. 2b, however, there rem ain som e discrepancies which we will now address.

Inversion [8, 9] of optical data to recover the electronboson spectral density of Eqs. (5) and (6) shows that the kink at 50 m eV may be attributed to a peak in ${}^{2}F$ (!) which is followed by a broad spin uctuation background extending beyond 0.4 eV (see inset of Fig. 3). This spectrum accounts for the deviations, extending up to 0.6 eV, of the op-qp data from the LDA curve seen in Fig. 2b. The renormalization found in the ARPES data, while larger than that found in the op-qp curve around 0.4 eV, is smaller below the 50 m eV kink. The lack of quantitative agreem ent between the optics and ARPES in these two regions may re ect (i) the di erences between the quasiparticle and transport spectral densities, not included in this work, (ii) the di erences in k-dependence between optical data (averaged over the Ferm isurface) and that of ARPES (m om entum speci c), and (iii) that form ally the self-energy (k;!) can depend on the magnitude of k as well as direction, but this goes beyond the theory used here. It is clear that renorm alizations are present in both experim ents on a broad energy scale up to the end of the spin uctuation spectrum (0.4 eV) which we take here to be the E_1 scale rather than the position of the peak in the self-energy. Furtherm ore, we associate the higher energy scale around 0.8-0.9 eV with the commencement of a new higher energy band (see discussion below). One of the results, strongly highlighted in some of the ARPES work [23, 24, 25] is the vertical dispersion seen in the data from E_1 to E_2 . The question arises as to whether this is due to some sort of ordering [21, 24] or if it is a renorm alization effect. Indeed a vertical dispersion can be obtained within standard electron-boson m odels [28, 37] with appropriate choice of param eters and in this instance, the high energy scale of this feature points to a spin-uctuation spectrum rather than a low energy boson spectrum. Thus,

ization rather than som ething more exotic, as was also concluded by Valla et al.[23]. In the upper fram e of Fig. 3, we show $\int_{1}^{0} dP$ for three Bi-2212 m aterials: underdoped (UD 69), optim ally-doped (OPT96) and overdoped (OD60), and one underdoped YBCO material (UD 59) [38], all at T = 100 K in the norm al state. For the Bi-2212 samples we have indicated possible features that would correlate with the E_{0} , E_1 , and E_2 seen in ARPES providing possible con mation of three sim ilar energy scales seen universally across members of Bi-2212 family. For the YBCO sample, we also can suggest the existence of the three energy scales. W hile E_0 remains the same, the E_1 and E_2 scales are now shifted to lower energy relative to Bi-2212 and are labelled E_1^0 (not shown) and E_2^0 . In addition, there is a 0:6 eV. In the lower frame, possible fourth scale E_3^0 $\frac{p}{2}$ op $\frac{qp}{p}$ for the four samples. This quantity we show

we would conclude that the large kink is due to renorm al-

is positive de nite and shows some of the characteristic energy scales more unambiguously. In particular, we see the emergence of a new band at larger energy. In the case of a nite band, we expect the scattering rate to drop [26, 27, 28] beyond the end of the boson spectrum.

In sum m ary, we have demonstrated a new analysis to extract the quasiparticle self-energy directly from the optical conductivity data, which will facilitate future com parisons with both ARPES and theory. In applying this method to Bi-2212 for various dopings, we nd good agreem ent with the ARPES data in comparison with the optically-derived quasiparticle dispersion curve. W hile the optics data show features at both low and high en-0:9 eV) as in ARPES, ergies (E₀ 50 m eV and E_2 the prole of the intermediate scale E_1 0:4 eV, which has been identied as the background spin uctuation scale, is very di erent in optics. Notwithstanding the lack of m om entum resolution, optics provides a com plementary technique to ARPES in this case because it is a bulk probe, has enhanced energy resolution, and is able to exam ine a wider range of materials such as the YBCO fam ily. Indeed, we nd with the YBCO data shown here that we can identify up to four energy scales, which range from low to high energies, but that overall they appear to be shifted to lower energy relative to Bi-2212. The theoretical understanding of these features remains to be more fully elucidated, but con mation of these scales by more than one technique gives impetus to such an endeavour.
