M esoscopic m agnetism in dielectric photonic crystal m eta m aterials: topology and inhom ogeneous broadening

We consider m eta m aterials m ade from a two-dimensional dielectric rod-type photonic crystal. The m agnetic response is studied within the recently developed hom ogenization theory and we in particular study the elects of topology and inhom ogeneous broadening. W hile topology itself m ainly a lects the M is resonance frequency we indicate the dispersion in the topological radius R of the dielectric rods m ay lead to signi cant inhomogeneous broadening and suppression of the negative-phenomina for $R = R_0$ $m^0 = m^0$, with $m = m^0 + im^0$ being the relative dielectric function of the rods.

1 Introduction

The developm ent of m eta m aterials has led to renewed interest in the original work by Veselago on negative refraction [1] and the eld of m eta m aterials is in rapid grow th. For m ore details we refer to recent reviews $[2\{4\}$ as well as to recent special issues [5,6]. In this work we consider a photonic crystal com posed of high-index dielectric rods arranged in a two-dim ensional lattice, see Fig. 1 (A). For tem poral harm onic m odes the H eld is governed by [7,8]

where " is the relative dielectric perm ittivity, is the relative m agnetic perm eability, c is the speed of light in vacuum, and ! = ck is the angular frequency with k = 2 = beingthe free-space wave vector. For N ature's own dielectric m aterials we locally have, alm ost by de nition, that (r) 1 so that everywhere in space B (r) = (r)H (r) H (r) [8]. How ever, for articial composite dielectric structures in the meta material limit, where the free-space wavelength is much longer than the characteristic length scale (periodicity) d of the underlying (quasi) periodic structure, one may for the slow ly varying hom ogenized elds (envelopes) have an elective permeability $_{\rm e}$ which is constant in space and which at certain frequencies deviates remarkably from the microscopic permeability, i.e. $_{\rm e}$ 6 and in particular it may become negative. The same apparent paradox is also possible for the dielectric response. As an example Fig. 2 shows a plane-wave simulation [9] of Eq. (1) for the structure in Fig. 1A with " = 200 and = 1 for the rods and " = = 1 for the background air region. For these inverse photonic crystal structures, the band structure and the photonic band-gap form ation can be understood in term s of M ie resonances [10,11]. Clearly, the band structure reveals a strong hybridization at the frequency corresponding to the rst M ie resonance of the rods as indicated by the dashed line. It is this resonance behaviour which make the rods behave as arti cial magnetic atom s with the possibility for a negative- response.

In this work we extract the e ective permeability by applying the recently derived m esoscopic hom ogenization theory for p-polarized elds by Felbacq and Bouchitte [12{14]. We in detail study the e ective permeability $_{\rm e}$ and the e ect of the topology of the rods as well as the in uence of spatial disorder/random ness and dispersion in the rod topology, com pare panels (B) and (C) in Fig. 1. For rods with a more arbitrary cross section we de ne a topological radius R by

where A is the area of and P is the perimeter of its surface (0, see Fig. 1(B)). It is easily veried that a circular cross section of radius R gives R = R. M ore generally, the topological radius R captures the qualitative resonance behaviour of the elective permeability as we shall see in the following.

Our results for more arbitrary topologies rely on approximative results for the spectral problem of the Helm holtz equation as employed recently by one of us in the context of di usion dynamics, uid ow, and ion transport in micro uidic problems [15{17].

2 Multi-scale expansion theory




Figure 1: (A) Photonic crystal consisting of parallel high-index dielectric rods. We consider the p-polarized case with the magnetic eld parallel to the rods. (B) Top view of the photonic crystal with rods arranged in a periodic lattice with pitch d. (C) Top view of weakly disordered/random photonic crystal.

We consider the problem of p-polarized elds corresponding to a magnetic eld aligned parallel to the rods, see Fig. 1(A). In the limit where d the problem posed by Maxwell's equations can be treated by a multi-scale expansion approach leading to an e ective magnetic permeability given by [13]

Above, we have used the D irac bra-ket notation and inner products are de ned as

where h(r) and g(r) are functions on . Similarly, m, or m(r), in Eqs. (3) and (4) corresponds to the magnetic eld component along the rods and 1 denotes the unity function.

In the following we assume a quadratic unit cell with area d^2 , see Fig. 1(B), so that f = 1 A = d^2 . As in Refs. [12{14] we solve the problem in a complete basis de ned by the Helm holtz eigenvalue equation

with the basis functions being orthonormal, i.e. $m = nm \cdot 0$ by iously, the Ansatz

ful lls the boundary condition and the expansion coe cients are readily determ ined by standard bra-ket m anipulations. In this way we arrive at the following general expression for the elective permeability [12]

The strength of this result is obviously the connection of $_{\rm e}$ to the spectrum and eigenstates of the Helm holtz equation which have been studied in great detail in various contexts of physics, including m embrane dynamics, the acoustics of drum s, the single-particle eigenstates of 2D quantum dots, not to forget quantized conductance of quantum wires. Finally, the results of course in turn provides the direct link between $_{\rm e}$ and the Mie resonances.

3 A pproxim ate properties of the spectral problem

In the following we utilize approximate results for the spectral problem and its dependence on geometry. We start by introducing the elective area $A_n = 1_n^2$ so that Eq. (8)

where we in the second line have truncated the rapidly converging sum making the approximation valid in the vicinity of the main resonance.

In Table 1 we have listed the rst eigenvalue $_1$ and the corresponding e ective area A $_1$ for a number of di erent geometries. For the numerical results we have employed a nite-element method with an adaptive mesh algorithm (C om solmultiphysics) ensuring fast convergence of both eigenvalues and eigenstates. Inspecting the column for the eigenvalue $_1^2$ in Table 1 we note that the numbers do not in general change much from geometry to geometry, despite the variation in topology. The small spread originates in the normalization by the topological radius R, see Eq. (2). For the elective area A $_1$ we likewise observe a modest variation. It is worthwhile emphasizing the results for a circular cross section which become good approximations for also other relatively compact topologies. In the following we thus use the approximation that $_1 = _{00}^{0}$ R and A $_1$ =A = $_{00}^{2}$ where $_{00}$ ' 2:405 is the rst zero of the Bessel function, i.e. J₀($_{00}$) = 0. W ith these approximations we nally arrive at

where all the dependence on geometry is captured by the topological radius R .

W e m ay now estimate the resonance wavelength. Suppose that " = " 0 + i" 0 , then for weakly absorbing materials, " 0 " 0 , we have the resonance around

As expected the line width re ects the damping due to $"^0$ in the high-index material. Furthermore, we may also estimate the magnitude of the elective magnetic response. Just below the resonance the real part is bounded by

The above results illustrate how ", f, and R in uence the magnetic response. Obviously, a negative permeability requires that " 0 ". On the other hand, some absorption is of course needed to have a nite line width instead of a delta-function-like response which would su er trem endously from the inevitable elects of inhom ogeneous broadening. We shall return to this in Sec. 5.

4 C om parison to num erical results




Figure 2: Plane-wave simulations of photonic band structure for a d d square lattice of rods of circular cross section with " = 200, see Fig. 1(B). The air-lling fraction f' 80:37% corresponding to a rod of radius R = R = d=4. The dashed line shows the fundam ental M is resonance of an isolated dielectric rod, Eq. (11).




Figure 3: E ective permeability $_{e}$ versus normalized wavelength =d for a rod with " = 200 + 5i in a quadratic d d unit cell with an air-lling fraction f ' 80:37% corresponding to a rod of radius R = R = d=4. The inset illustrates the unit cell as well as the function m at a wavelength above resonance. The solid lines are num erical exact solutions based on a nite-element (adaptive m esh) solution of Eq. (4) while the dashed lines show the approximate result in Eq. (10).




Figure 4: E ective permeability $_{\rm e}$ versus normalized wavelength =d for a rod with " = 200 + 5i in a quadratic d d unit cell with an air-lling fraction f ' 80:37%. The inset illustrates the unit cell as well as the function m at a wavelength above resonance. The highly non-circular cross section has a topological radius of R ' 0:151 d. The solid lines are numerical exact solutions based on a nite-element (adaptive mesh) solution of Eq. (4) while the dashed lines show the approximate result in Eq. (10). The horizontal dashed lines show the limits in Eqs. (13) and (14).

The validity of the assumptions underlying Eq. (3) has been tested in Refs. [12{14] by com paring simulated transmission spectra of the real photonic crystal to spectra based on the corresponding hom ogenized m eta m aterial. In this work we thus assume Eq. (3) valid and focus on checking the quality of the approxim ate result in Eq. (10). We do this by comparing the outcom e of Eq. (10) to num erical solutions of the original problem posed by Eq. (3). We use a nite-element method with an adaptive mesh algorithm (Com sol multiphysics) for this purpose. For the dielectric function we use " = 200 + 5i as in Ref. [12{14]. Fig. 2 illustrates the corresponding photonic band structure. C learly, there is a strong hybridization at the frequency corresponding to the isolated M ie resonance of the rod, see Eq. (11). It is this avoided crossing which causes strong resonance in the e ective permeability that is observed in Fig. 3. The approximate result in Eq. (10) works excellently near the main resonance for rods with circular cross section as seen in Fig. 3 while the approxim ation of course doesn't capture high-orderm odes due to the truncation of the summation in Eq. (9). In the following we go a step further and test the result for highly non-circular geometries. Fig. 4 illustrates results for one such example. As seen there is a good qualitative agreem ent and since the geom etry is highly non-circular, see inset, the quantitative agreement is perhaps better than expected. Note how the change in topological radius R scales the resonance wavelength and the line width compared to the circular case, Fig. 3, in accordance with Eq. (11) while the conservation of the air-lling fraction f leads to the same magnitude of the response in accordance with Eqs. (13) and (14) which depend only on f, but not on R.

5 Inhom ogeneous broadening

The present results suggest that shape plays only a minor role and mainly a ects the particular value of the resonance frequency (which is proportional to the topological radius R) while the air-lling fraction f and the dielectric function $" = "^0+ i"^0$ tend to govern the magnitude of the e ective magnetic response. This suggests that hom ogenized materials will not be strongly in uenced by spatial disorder/random ness conserving the average air-

lling fraction while shape dispersion (dispersion in the topological radius, possibly also in uencing the average air-lling fraction) will give rise to a smearing of the resonance phenomena. Suppose that for a particular topological radius R $_0$ the resonance wavelength

is $_{0} = R_{0}$, see Eq. (11), and that the width of the resonance is $_{0}$. A ssum ing a G aussian distribution of R, #

and neglecting the dependence of the intrinsic line width $_0$ on R we get an inhom ogeneous suppression of the resonance magnitude by a factor ,

and an inhom ogeneous broadening of the resonance by a factor $^{-1}$,

Thus, inhom ogeneous broadening will be negligible if $\frac{R}{R}$ 1 corresponding to




Figure 5: Inhom ogeneous broadening of the elective permeability $_{\rm e}$ for rods with a circular cross section in a quadratic d d unit cell with an average air-lling fraction f_0 ' 80:37% corresponding to rods with an average radius $R_0 = R_0 = d=4$. The dashed curves show the intrinsic line width corresponding to the results in Fig. 3.

Fig. 5 illustrates these results in the case of rods of circular cross section as in Fig. 3. The results are obtained from a numerical evaluation of ${R_1 \atop 0} dR_e$ (R)P(R) with e given by Eq. (10). As also suggest by Eq. (18) a size dispersion with a relative variation comparable to " ${}^{(0)}_{=}$ " preserves the negative phenom enawhile larger variations will result in a positive e.

6 Conclusion

W e have studied the magnetic response of rod-type dielectric meta materials within the recently developed hom ogenization theory [12] and we have in particular investigated the elects of topology and inhom ogeneous broadening. We predict that topology itselfmainly a ects the M is resonance frequency while the resonance shape mainly depends on the air-

lling fraction and the ratio " 0 ="" with " = " 0 + i"" being the relative dielectric function of the rods. Furtherm ore, we argue that random ness/disorder conserving the air-lling fraction will have a limited in uence on the negative- phenom ena while dispersion in the topological radius R of the rods m ay lead to signi cant inhom ogeneous broadening and suppression of the phenom ena.
