# M esoscopic m agnetism in dielectric photonic crystalm eta m aterials: topology and inhom ogeneous broadening

#### Abstract

$W$ e consider $m$ eta $m$ aterials $m$ ade from a two-dim ensional dielectric rod-type photonic crystal. The m agnetic response is studied w thin the recently developed hom ogenization theory and we in particular study the e ects of topology and inhom ogeneous broadening. While topology itself $m$ ainly a ects the $M$ ie resonance frequency we nd that the dispersion in the topological radius $R$ of the dielectric rods $m$ ay lead to signi cant inho$m$ ogeneous broadening and suppression of the negative- phenom ena for $R=R_{0} \quad{ }^{n}=N^{0}$, $w$ ith $"="^{0}+i^{\infty}$ being the relative dielectric function of the rods.

## 1 Introduction

The developm ent of $m$ eta $m$ aterials has led to renewed interest in the original work by Veselago on negative refraction [1] and the eld ofm eta $m$ aterials is in rapid grow th. For $m$ ore details we refer to recent reviews [2\{4] as well as to recent special issues [5,6]. In this work we consider a photonic crystal com posed of high-index dielectric rods arranged in a two-dim ensional lattioe, see Fig. [1 (A ). For tem poral harm onic modes the H eld is govemed by $[7,8]$

where " is the relative dielectric perm ittivity, is the relative $m$ agnetic perm eability, $c$ is the speed of light in vacuum, and ! = ck is the angular frequency w ith $\mathrm{k}=2=$ being the free-space wave vector. For N ature's ow n dielectric m aterials we locally have, alm ost by de nition, that (r) 1 so that everyw here in space $B(r)=(r) H(r) \quad H$ (r) [8]. H ow ever, for arti cialcom posite dielectric structures in them eta $m$ aterial lim it, where the
free-space wavelength is m uch longer than the characteristic length scale (periodicity) d of the underlying (quasi) periodic structure, one $m$ ay for the slow ly varying hom ogenized elds (envelopes) have an e ective perm eability e which is constant in space and which at certain frequencies deviates rem arkably from them icroscopic perm eability, i.e. e and in particular it $m$ ay becom e negative. The sam e apparent paradox is also possible for the dielectric response. As an example Fig. 2 shows a planewave sim ulation [9] of Eq. (1) for the structure in Fig . 1 A w ith $"=200$ and $=1$ for the rods and $"=$
$=1$ for the background air region. For these inverse photonic crystal structures, the band structure and the photonic band-gap form ation can be understood in term sofM ie resonanœes $[10,11]$. C learly, the band structure reveals a strong hybridization at the frequency corresponding to the rst $M$ ie resonance of the rods as indicated by the dashed line. It is this resonance behaviour which $m$ ake the rods behave as arti cialm agnetic atom sw th the possibility for a negative- response.

In this work we extract the e ective perm eability by applying the recently derived m esoscopic hom ogenization theory forp-polarized elds by Felbacq and B ouchitte [12\{14]. We in detail study the e ective perm eability e and the e ect of the topology of the rods as well as the in uence of spatial disorder/random ness and dispersion in the rod topology, com pare panels (B) and (C) in Fig. [1]. For rods w ith a m ore arbitrary cross section we de ne a topological radius $R$ by

where $A$ is the area of and $P$ is the perim eter of its surface @ , see $F$ ig. [1(B). It is easily veri ed that a circular cross section of radius $R$ gives $R=R$. M ore generally, the topological radius R captures the qualitative resonance behaviour of the e ective perm eability as we shall see in the follow ing.

O ur results for m ore arbitrary topologies rely on approxim ative results for the spectral problem of the H elm holtz equation as em ployed recently by one of us in the context of di usion dynam ics, uid ow, and ion transport in $m$ icro uidic problem s [15\{17].

## 2 M ulti-scale expansion theory

W e consider the problem of p-polarized elds corresponding to a m agnetic eld aligned parallel to the rods, see Fig. [1 (A). In the lim it where $d$ the problem posed by M axwell's equations can be treated by a multi-scale expansion approach leading to an e ective $m$ agnetic perm eability given by [13]

A bove, we have used the D irac bra-ket notation and inner products are de ned as Z
h $g=d r h g ;$
where $h(r)$ and $g(r)$ are functions on . Sim ilarly, $m$, or $m(r)$, in Eqs. (3) and (4) corresponds to the $m$ agnetic eld com ponent along the rods and 1 denotes the unity function.

In the follow ing we assum e a quadratic unit cell with area $d^{2}$, see $F$ ig. $]_{1}(B)$, so that $f=1 \quad A=d^{\}}$. A $s$ in Refs. [12\{14] we solve the problem in a com plete basis de ned by the $H$ elm holtz eigenvalue equation

fiul lls the boundary condition and the expansion coe cients are readily determ ined by standard bra-ket $m$ anipulations. In this w ay we arrive at the follow ing general expression for the e ective perm eability [12]

The strength of this result is obviously the connection of e to the spectrum and eigenstates of the H elm holtz equation which have been studied in great detail in various contexts ofphysics, including $m$ em brane dynam ics, the acoustics ofdnum $s$, the single-particle eigenstates of 2D quantum dots, not to forget quantized conductance of quantum wires. $F$ inally, the results of course in tum provides the direct link between $e$ and the $M$ ie resonances.

## 3 A pproxim ate properties of the sp ectral problem

In the follow ing we utilize approxim ate results for the spectralproblem and its dependence on geom etry. W e start by introducing the e ective area $A_{n}=1 n{ }^{2}$ so that Eq. (8)
is rew rilten as

where we in the second line have truncated the rapidly converging sum $m$ aking the approxim ation valid in the vicinity of the $m$ ain resonance.

In Table 1 we have listed the rst eigenvalue 1 and the corresponding e ective area $A_{1}$ for a num ber of di erent geom etries. For the num erical results we have em ployed a nite-elem ent $m$ ethod with an adaptive mesh algorithm ( $C$ om solmultiphysics) ensuring fast convergence of both eigenvalues and eigenstates. Inspecting the colum $n$ for the eigenvalue ${ }_{1}^{2}$ in Table 1 we note that the num bers do not in general change $m$ uch from geom etry to geom etry, despite the variation in topology. T he sm all spread originates in the norm alization by the topological radius R, see Eq. (2) . For the e ective area $A_{1}$ we likew ise observe a m odest variation. It is w orthw hile em phasizing the results for a circular cross section which becom e good approxim ations for also other relatively com pact topologies. In the follow ing we thus use the approxim ation that $1 \quad 00=R$ and $A_{1}=A \quad 4=\frac{2}{00}$ where 00 ' 2:405 is the rst zero of the Bessel function, i.e. $J_{0}\left(0_{00}\right)=0$. W ith these approxim ations we nally arrive at

where all the dependence on geom etry is captured by the topological radius R .
W e m ay now estim ate the resonance wavelength. Suppose that " $="^{0}+i^{\infty}{ }^{\infty}$, then for weakly absorbing $m$ aterials, " ${ }^{\infty} \quad{ }^{0}$, we have the resonance around
w ith a line width of the order

A s expected the line width re ects the dam ping due to " $\infty$ in the high-index material. Furtherm ore, we $m$ ay also estim ate the $m$ agnitude of the e ective $m$ agnetic response. Just below the resonance the real part is bounded by

The above results illustrate how ", $f$, and $R$ in uence the $m$ agnetic response. 0 bviously, a negative perm eability requires that " ${ }^{0} "^{\infty}$. On the other hand, som e absonption is of course needed to have a nite line width instead of a delta-function-like response which would su er trem endously from the inevitable e ects of inhom ogeneous broadening. W e shall retum to this in Sec.5.

## 4 C om parison to num erical results

The validity of the assum ptions underlying Eq. (3) has been tested in Refs. [12\{14] by com paring sim ulated transm ission spectra of the realphotonic crystal to spectra based on the corresponding hom ogenized $m$ eta $m$ aterial. In this work we thus assum e Eq. (3) valid and focus on checking the quality of the approxim ate result in Eq. (10). W e do this by com paring the outcom e of Eq. (10) to num erical solutions of the original problem posed by Eq. (3). W e use a nite-elem ent $m$ ethod $w$ ith an adaptive $m$ esh algorithm (C om sol multiphysics) for this punpose. For the dielectric function we use " = 200 $+5 i$ as in Ref. [12\{14]. F ig. [2] ilhustrates the corresponding photonic band structure. C learly, there is a strong hybridization at the frequency corresponding to the isolated $M$ ie resonance of the rod, see Eq. [11). It is this avoided crossing which causes strong resonance in the e ective perm eability that is observed in F ig. [3. The approxim ate result in Eq. (10) w orks excellently near the $m$ ain resonance for rods $w$ ith circular cross section as seen in $F$ ig. 3 while the approxim ation of course doesn't capture high-orderm odes due to the truncation of the summ ation in Eq. (9). In the follow ing we go a step further and test the result for highly non-circular geom etries. Fig. ilhustrates results for one such exam ple. As seen there is a good qualitative agreem ent and since the geom etry is highly non-circular, see inset, the quantitative agreem ent is perhaps better than expected. N ote how the change in topological radius $R$ scales the resonance $w$ avelength and the line width com pared to the circular case, F ig. 3 , in accordance w ith Eq. (11) while the conservation of the air- lling fraction $f$ leads to the sam e $m$ agnitude of the response in accordance w ith Eqs. (13) and (14) which depend only on $f$, but not on $R$.

## 5 Inhom ogeneous broaden ing

The present results suggest that shape plays only a m inor role and $m$ ainly a ects the particular value of the resonance frequency (w hich is proportional to the topologicalradius $R$ ) while the air- lling fraction $f$ and the dielectric function " $="^{0}+i^{\infty}$ tend to govem the $m$ agnitude of the e ective $m$ agnetic response. This suggests that hom ogenized $m$ aterials w ill not be strongly in uenced by spatialdisorder/random ness conserving the average air-
lling fraction while shape dispersion (dispersion in the topological radius, possibly also in uencing the average air-lling fraction) will give rise to a sm earing of the resonance phenom ena. Suppose that for a particular topological radius R o the resonance w avelength
is $0=R_{0}$, see Eq. (11), and that thew idth ofthe resonance is 0 . A ssum ing a $G$ aussian distribution of R ,

and neglecting the dependence of the intrinsic line width 0 on $R$ we get an inhom ogeneous suppression of the resonance $m$ agnitude by a factor ,

and an inhom ogeneous broadening of the resonance by a factor

Thus, inhom ogeneous broadening w ill.be negligible if $\quad \frac{R}{0} \quad 1$ corresponding to

Fig. 5 ilhustrates these results in the case of rods of circular cross section as in $F$ ig. ${ }^{3}$. The results are obtained from a num erical evaluation of $\mathrm{R}_{1} d R$ e(R)P(R)withe given by Eq. (10) . A s also suggest by Eq. (18) a size dispersion $w$ ith a relative variation com parable to $"^{(1)}="^{0}$ preserves the negative- phenom ena while larger variations w ill result in a positive e.

## 6 C onclusion

W e have studied the $m$ agnetic response of rod-type dielectric $m$ eta $m$ aterials $w$ ithin the recently developed hom ogenization theory [12] and we have in particular investigated the e ects of topology and inhom ogeneous.broadening. W e predict that topology itselfm ainly a ects the $M$ ie resonance frequency while the resonance shape $m$ ainly depends on the air-
lling fraction and the ratio $"="^{\infty}$ w ith $"="^{0}+i^{(10}$ being the relative dielectric function of the rods. Furthem ore, we argue that random ness/disorder conserving the air- ling fraction w illhave a lim ited in uence on the negative- phenom ena while dispersion in the topological radius $R$ of the rods $m$ ay lead to signi cant inhom ogeneous broadening and suppression of the phenom ena.
