Sem iclassical Approach to Chaotic Quantum Transport

W e describe a sem iclassical m ethod to calculate universal transport properties of chaotic cavities. W hile the energy-averaged conductance turns out governed by pairs of entrance-to-exit trajectories, the conductance variance, shot noise and other related quantities require trajectory quadruplets; sim ple diagram m atic rules allow to nd the contributions of these pairs and quadruplets. B oth pure sym m etry classes and the crossover due to an external m agnetic eld are considered.

I. IN TRODUCTION

M esoscopic cavities show universal transport properties { such as conductance, conductance uctuations, or shot noise { provided the classical dynam ics inside the cavity is fully chaotic. Here chaos may be due to either im planted im purities or bum py boundaries. A phenom enological description of these universal features is available through random -m atrix theory (RMT) by averaging over ensem bles of system s (whose H am iltonians are represented by m atrices) [1]. For system s with im purities, one can alternatively average over di erent disorder potentials. How ever, experiments show that even individual cavities show universal behavior faithful to these averages.

In the present paper we want to show why this is the case. To do so we propose a sem iclassical explanation of universal transport through individual chaotic cavities, based on the interfering contributions of close classical trajectories. This approach generalizes earlier work in [2, 3, 4, 5] and is inspired by recent progress for universal spectral statistics [6, 7, 8, 9]. Our sem iclassical procedure often turns out to be technically easier than RMT; transport properties are evaluated through very sim ple diagram matic rules.

We consider a two-dimensional cavity accommodating chaotic classical motion. Two (or more) straight leads are attached to the cavity and carry currents. We shall mostly consider electronic currents, but most of the following ideas apply to transport of light or sound as well, minor modi cations apart.

The leads support wave modes (\channels") $e^{ikx_1 \cos i} \sin (ky_i \sin j_i)$; the subscripts i = 1;2 refer to the ingoing and outgoing lead, respectively, x_i and y_i with $0 < y_i < w_i$ are coordinates along and transversal to the lead. Here, w_i is the width of the lead, k the wave number, and i the angle enclosed between the wave vector and the direction of the lead. D inichlet boundary conditions inside the lead in pose the restriction $kw_i \sin j_i j = a_i$ with the channel index a_i running from 1 to N_i, the largest integer below $\frac{kw_i}{2}$. C lassically, the a_i -th channel can be associated with trajectories inside the lead that enclose an angle i with the lead direction, regardless of their location in con guration space. The sign of the enclosed angle changes after each rejection at the boundaries of the cavity, and angles of both signs are associated to the same channel.

We shall determ ine, e.g., the mean and the variance of the conductance as power series in the inverse of the number of channels N = N₁ + N₂. In contrast to much of the previous literature, we will go to all orders in $\frac{1}{N}$. We shall be interested both in dynamics with time reversal invariance (\orthogonal case") and without that symmetry (\unitary case"). For electronic motion time reversal invariance may be broken by an external magnetic edd. For that latter case, we shall also interpolate between both pure symmetry classes by account for a weak magnetic eld producing magnetic actions of the order of h.

W e will always work in the sem iclassical limit, and thus require the linear dimension L of the cavity to be large compared to the (Ferm i) wavelength . W hen taking the limit $\frac{1}{L}$! 0, the number of channels N / $\frac{W}{W}$ (w w₁ w₂) will be increased only slow ly. The width of the openings thus becomes small compared to L. For this particular sem iclassical limit, the dwell time of trajectories inside the cavity, T_D / $\frac{L}{W}$ grows faster than the so-called Ehrenfest time T_E / $\ln \frac{L}{L}$ / $\ln h$. Interesting e ects arising for $T_E = T_D$ of order unity [11, 12, 13] are thus discarded.

Following Landauer and Buttiker [14, 15], we view transport as scattering between leads and deal with am plitudes $t_{a_1a_2}$ for transitions between channels a_1 and a_2 . These am plitudes form an $N_1 = N_2$ matrix $t = ft_{a_1a_2}g$. Each $t_{a_1a_2}$ can be approximated semiclassically, by the van V leck approximation for the propagator, as a sum over trajectories connecting the channels a_1 and a_2 [16],

The channels exactly determ ine the absolute values of the initial and nalangles of incidence 1; 2 of the contributing trajectories; again both positive and negative angles are possible. In (1), T_H denotes the so-called Heisenberg time, i.e., the quantum time scale 2 h⁻ associated to the mean level density $\overline{}$. The Heisenberg time diverges in the sem iclassical limit like $T_H = 2$ h⁻ $\frac{1}{(2 \text{ h})^{f-1}}$ with the volume of the energy shell and f the number of degrees of freedom; we shall mostly consider f = 2. The \stability am plitude" A (which includes the so-called M aslov index) can be found in Richter's review [16]. Finally, the phase in (1) depends on the classical action S = p dq. W ithin the framework just delineated, we will evaluate, for individual fully chaotic cavities,

the mean conductance tr(tt^y) (A ctually, the conductance is given by $\frac{e^2}{h}$ tr(tt^y), taking into account two possible spin orientations; we prefer to express the result in units of $\frac{e^2}{h}$),

the conductance variance $(\operatorname{tr} \operatorname{tt}^y)^2 = \operatorname{tr}(\operatorname{tt}^y)^2$,

the mean shot noise power tr(tt^y $t^y t^y$), in units of $\frac{2e^3 y}{b}$,

for a cavity with three leads, correlations between the currents owing from lead 1 to lead 2 and from lead 1 to lead 3 depending on the corresponding transition matrices $t^{(1!\ 2)}$; $t^{(1!\ 3)}$ as $tr(t^{(1!\ 2)}t^{(1!\ 2)}t^{(1!\ 3)}t^{(1!\ 3)})$,

the conductance covariance at two di erent energies which characterizes the so-called Ericson uctuations.

Here the angular brackets signify an average over an energy interval su cient to sm ooth out the uctuations of the respective physical property. We will see that after such an averaging each of these quantities takes a universal form in agreement with random -m atrix theory, without any need for an ensemble average. To show this, we shall express the transition amplitudes as sums over trajectories as in (1). The above observables then turn into averaged sum s over pairs or quadruplets of trajectories, which will be evaluated according to simple and universal diagram m atric rules. We shall rst derive and exploit these rules for the orthogonal and unitary cases and then generalize to the interpolating case (weak magnetic eld).

Due to the unitarity of the time evolution, we could equivalently express transport properties through re ection amplitudes and trajectories starting and ending at the same lead. For the average conductance we have checked explicitly that the same result is obtained, meaning that our approach preserves unitarity.

II. MEAN CONDUCTANCE

We is consider the mean conductance and propose to show that individual chaotic systems are faithful to the random -matrix prediction [1, 10]

In the sem iclassical approximation (1), the average conductance becomes a double sum over trajectories; connecting the same channels a_1 and a_2 ,

Due to the phase factor $e^{i(S - S)=h}$, the contributions of m ost trajectory pairs oscillate rapidly in the limit h ! 0, and vanish after averaging over the energy. System atic contributions can only arise from pairs with action di erences S = S - S of the order of h.

A. D iagonal contribution

The simplest such pairs involve identical trajectories =, with a vanishing action di erence [6, 17]. These \diagonal" pairs contribute




FIG.1: Scheme of a Richter/Sieber pair. The trajectories (full line) and (dashed line) connect the same channels a_1 and a_2 , and dieronly inside a 2-encounter (in the box). A Poincare section P intersects the encounter stretches at the points x_{P1} and x_{P2} in phase space whose con guration-space location is highlighted by two dots. P divides the encounter in two parts with durations $t_s = \frac{1}{2} \ln \frac{c}{j_{Pj}}$ and $t_u = \frac{1}{2} \ln \frac{c}{j_{Pj}}$. The relevant trajectories are in reality much longer than depicted here; in the absence of a potential they consist of a huge number of straight segments rejected at the boundary.

The foregoing single-trajectory sum may be evaluated using the following rule established by Richter and Sieber [2]: Summation over trajectories connecting xed channels is equivalent to integration over the dwell time T as

Here, the integrand $e^{\frac{N}{T_{H}}T}$ can be understood as the survival probability, i.e., the probability for the trajectory to remain inside the cavity up to the time T. The factor $\frac{N}{T_{H}} = \frac{2p(w_1 + w_2)}{w_1 + w_2}$ is the classical escape rate. Due to / L², that rate is proportional to $\frac{w}{L}$ if p is scaled according to p / L; inversion yields the typical dwell time $T_D = \frac{T_H}{N} / \frac{L}{w}$ mentioned in the introduction.

F in ally sum m ing over all N $_1$ possible choices for a_1 and over the N $_2$ possibilities for a_2 , one nds [2, 17]

Eq. (6) reproduces the RMT result for the unitary case, and gives the leading term in the orthogonal case.

B. Richter/Sieber pairs

For the orthogonal case, R ichter and Sieber attributed the next-to-leading order to another family of trajectory pairs. In the following, we shall describe these pairs in a language adapted to an extension to higher orders in $\frac{1}{N}$. In each R ichter/Sieber pair (see Fig. 1), the trajectory contains a \2-encounter" wherein two stretches are almost mutually time-reversed; in con guration space it boks like either a small-angle self-crossing or a narrow avoided crossing. We dem and that these two stretches come su ciently close such that their motion is mutually linearizable. A long , the two stretches are separated from each other and from the leads by three \links" ¹. The partner trajectory

¹ In our previous papers [9, 25, 38] we used the term \loop" to refer to the com paratively long orbit pieces connecting encounter stretches to one another or to the openings. We decided to replace this expression by \link" which is more appropriate since the beginning and

is distinguished from only by di erently connecting these links inside the 2-encounter. A long the links, how ever,

is practically indistinguishable from ; in particular, the entrance and exit angles of and (de ned by the in-and out-channels) coincide ². The initial and nallinks are traversed in the same sense of motion by and , while for the middle link the velocities are opposite. O by iously, such R ichter/Sieber pairs ; can exist only in time-reversal invariant system s. The two trajectories in a R ichter/Sieber pair indeed have nearly the same action, with the action di erence originating mostly from the encounter region.

We stress that inside a Richter/Sieber pair, the encounter stretches and the leads must be separated by links of positive durations $t_1;t_2;t_3 > 0$. For the \inner" loop with duration t_2 the reasons were worked out in previous publications dealing with periodic orbits ([18, 19], and [9, 20] for more complicated encounters): Essentially, is obtained from by switching connections between four points where the encounter stretches begin and end; to have four such points the stretches must be separated by a non-vanishing link. The fact that the duration of the initial and nal links is non-negative (the encounter stretches are alm ost antiparallela trajectory with an encounter \sticking out" would enter and exits the cavity through the same opening and thus be irrelevant for the conductance.

Encounters have an important e ect on the survival probability [4]. The trajectory is exposed to the \danger" of getting lost from the cavity only during the three links and on the rst stretch of the encounter. If the rst stretch remains inside the cavity, the second stretch, being close to the rst one (up to time reversal) must remain inside as well. If we denote the duration of one encounter stretch by t_{enc} , the total \exposure time" is thus given by $T_{exp} = t_1 + t_2 + t_3 + t_{enc}$; it is shorter than the dwell time T which includes a second sum m and t_{enc} representing the second encounter stretch. Consequently, the survival probability $e^{-\frac{N}{T_{H}}T_{exp}}$ exceeds the naive estimate $e^{-\frac{N}{T_{H}}T}$. In brief, encounters hinder the loss of a trajectory to the leads.

To describe the phase-space geometry of a 2-encounter, we consider a Poincare section P orthogonal to the rst encounter stretch in an arbitrary phase-space point x_{P1} . This section must also intersect the second stretch in a phase-space point x_{P2} almost time-reversed with respect to x_{P1} . In Fig. 1 the con guration-space locations of x_{P1} and x_{P2} are highlighted by two dots. For a hyperbolic, quasi two-dimensional³ system, the small phase space separation between the time-reversed T x_{P2} of x_{P2} and x_{P1} can be decomposed as [21, 22, 23]

where $e^s(x_{P1})$ and $e^u(x_{P1})$ are the so-called stable and unstable directions at x_{P1} . If P m oves along the trajectory, following the time evolution of x_{P1} , the unstable component u will grow exponentially while the stable component s shrinks exponentially. For times large compared with the ballistic time (L=v with v the velocity) the rate of grow th (or shrinking) is given by the Lyapunov exponent (not to be confused with the wavelength also denoted by),

By our de nition of a 2-encounter, the stable and unstable components are conned to ranges c < s < c, c < u < c, with c as mall phase-space separation. The exact value of c will be irrelevant, except that the transverse size of the encounter in conguration space, c = m with m the m ass, m ust be small compared with the opening diameters. It should also be smallenough to allow m utual linearization of m otion along the encounter stretches. As a consequence, the time between P and the end of the encounter is $t_u = \frac{1}{m} \ln \frac{c}{j_{uj}}$, i.e., the time the unstable component needs to grow from u to c. Likewise the time between the beginning of the encounter and P reads $t_s = \frac{1}{m} \ln \frac{c}{j_{uj}}$. Both times sum up to the encounter duration

A glance at F ig. 1 shows that the times t_{P1} ; t_{P2} of the piercing points x_{P1} , x_{P2} (measured from the beginning of the trajectory) are now given by

the end of such a piece may be far removed from each other (in the case of the initial and nallink and of links between di erent encounters).

² Following Richter and Sieber we die dem iclassical estimate for a conductance component $h_{\hat{f}_{n_1 a_2}}$ fibetween two given in- and out-channels and dem and therefore that all contributing trajectories have the same in- and out-angles. An alternative [12] is to replace sum mation over channels in the formula for the transport property by integration; then the channel numbers of the contributing trajectories found through an additional saddle point approximation will not be integer.

F inally, the stable and unstable coordinates determ ine the action di erence as [22, 23] (see also [9, 18])

The encounters relevant for the transport phenom ena have action di erences of order h and thus durations t_{enc} $\frac{1}{\ln \frac{c^2}{i \cdot S \cdot i}}$ of the order of the Ehrenfest time $T_E = \frac{1}{\ln \frac{c^2}{h}}$.

W ith this input, we can determ ine the average number of 2-encounters inside trajectories of a given dwell time T. In ergodic systems, the probability for a trajectory to pierce through a xed Poincare section P in a time interval $(t_{P_2}; t_{P_2} + dt_{P_2})$ with stable and unstable separations from x_{P_1} inside (s; s + ds) (u; u + du) is uniform, and given by the Liouville measure $\frac{1}{2} dt_{P_2} dsdu$. To count all 2-encounters inside , we have to integrate this density over t_{P_2} (to get all piercings x_{P_2} through a given P) and over t_{P_1} (to get all possible x_{P_1} and thus all possible sections P). W hen integrating over t_{P_1} , we weigh the contribution of each encounter with the corresponding duration t_{enc} , since the section P m ay be placed at any point within the encounter; therefore we must subsequently divide by t_{enc} . The integration over the piercing times t_{P_1}, t_{P_2} may be replaced by integration over the link durations $t_1; t_2$, which as we stressed, must be positive; in addition $t_3 = T$ t_2 t_2 t_{enc} must also be positive. A largether, we obtain the follow ing density of stable and unstable coordinates,

This density is normalized such that integration over all s; u belonging to a given interval of S = su yields the number of 2-encounters of giving rise to action di erences within that interval.

To nd what Richter/Sieber pairs contribute to the conductance (3), we replace the sum over by a sum over 2-encounters inside or, equivalently, an integral over w (s;u). The additional approximation 4 A yields

Next, we employ the Richter/Sieber rule to do the sum over by integrating over the dwelltime T, with the integrand involving the (m odi ed) survival probability e $\frac{N}{T_{H}}T_{exp} = e^{\frac{N}{T_{H}}(t_1 + t_2 + t_3 + t_{enc})}$. The integral over T m ay be transformed into an integral over the duration of the nallink. Moreover, sum mation over all channels $a_1 = 1 ::: N_1, a_2 = 1 ::: N_2$ yields a factor $N_1 N_2$. We are thus led to

This integral factors into three independent integrals over the link durations,

and an integral over the stable and unstable separations within the encounter,

The encounter integral I can be evaluated if we expand the exponential as $e^{\frac{N}{T_{H}}t_{enc}(s;u)} = 1$ $\frac{N}{T_{H}}t_{enc}(s;u) + :::.$ As shown in [9], the constant term yields $dsdu \frac{1}{t_{enc}(s;u)}e^{isu=h} = \frac{2h}{h}sin\frac{c^{2}}{h}$ which oscillates rapidly as h ! 0 and therefore vanishes after averaging. In the sem iclassical limit, the value of I is solely determ ined by the linear term for which the denom inator $t_{enc}(s;u)$ cancels out,

⁴ For long trajectories, the derivative $\frac{d \#_2}{d y_1}$ in A [16] is proportional to the so-called stretching factor , i.e., the factor by which an initial separation along the unstable direction grows until the end of the trajectory . This factor can be written as a product of the (tim e-reversal invariant) stretching factors of the individual links and encounter stretches. Since contains practically the same links and stretches, we have . All other factors alm ost coincide as well (see [18, 20, 23] for the M aslov index), entailing A A .




FIG.2: Fam ilies of trajectory pairs (;) di ering in one 2-encounter (a), two 2-encounters (b-f) or in one 3-encounter (g-j). In contrast to Fig.1 the cavity is not depicted, and the initial and nalpoints of the trajectories are joined together (junction symbolized by two dots and intervening bar, j). One orbit pairm ay result from joining beginning and end of di erent trajectory pairs (like cd, ef, and hij). A rrows indicate the directions of motion inside the encounters, and highlight those links which are traversed by and with opposite sense of motion. Note that all families apart from b) and g) involve alm ost mutually tim e-reversed encounter stretches and thus require tim e-reversal invariance (TRI). Together with the diagonal pairs, the ones show n here reproduce the mean conductance up to order N₁N₂=N³.

where we use dsdue^{isu=h} ! 2 h and $T_H = \frac{1}{2h}$; all further terms vanish compared to the linear one like $\frac{N t_{enc}}{T_H}$ $\frac{T_E}{T_D}$ and m ay thus be neglected, given our previous de nition of the sem iclassical limit. Since all occurrences of T_H in Eqs. (14), (15) and (17) mutually cancel, we can formulate the following \diagram matic rule": Each link yields a factor $\frac{1}{N}$ and each encounter a factor N. The result still has to be multiplied with the number of channel combinations N $_1N_2$. A logether, the contribution of Richter/Sieber pairs to the average conductance is hence determined as

O urpresent treatment diers from Richter's and Sieber's original paper [2] in two points: First, one has to exclude encounters which stick out of the opening. (In [2], encounters were described through self-crossings in con guration space, and only that crossing, approximately in the center of the encounter, had to be located inside the cavity.) Second, one must take into account that encounters hinder the escape into the leads. While these two corrections mutually cancel for Richter/Sieber pairs they will presently turn out of crucial in portance for higher-order contributions to the mean conductance, as well as for other observables like shot noise.

C. Diagram m atic rules for all orders in $\frac{1}{N}$

To proceed to all orders in $\frac{1}{N}$, we must consider pairs of trajectories di ering by their connections inside arbitrarily many encounters. Each of these encounters may involve arbitrarily many stretches. We shall speak of an 1-encounter




FIG. 3: Reconnections inside a 3-encounter leading to one trajectory (dashed) and one periodic orbit (dotted), rather than a single connected partner trajectory.

whenever 1 stretches of a trajectory com e close in phase space. In time-reversal invariant system s we must also allow for encounters whose stretches are alm ost mutually time-reversed. As a consequence, the resulting conductance will depend on the symmetry class: We shall see all higher-order contributions to mutually cancel in the unitary case but to yield the 1=N expansion of the RMT result (2) in the orthogonal case.

A list of examples is displayed in Fig. 2, where for later convenience we did not draw the cavity and form ally joined the initial and nalpoints of the trajectories together. These examples illustrate the simplest among in nitely many topologically di erent families of trajectory pairs.

The individual families are characterized (i) by the numbers v_1 of l-encounters in which the two partners di er. These numbers can be assembled into a \vector" $v = (v_2; v_3; v_4; :::)$, and determ ine the overall number of encounters $V(v) = \begin{bmatrix} 1 & 2 \\ 1 & 2 \end{bmatrix} v_1$ and the total number of encounter stretches $L(v) = \begin{bmatrix} 1 & 2 \\ 1 & 2 \end{bmatrix} v_1$. The number of links exceeds the number of stretches by one and reads L(v) + 1. Further characteristics of our families of trajectory pairs are (ii) the order in which the encounters are traversed by the trajectory , (iii) the mutual orientation of the encounter stretches (i.e., $= v_3$. =, or $= v_3$. =), and (iv) the reconnections leading to the partner trajectory and one periodic orbit as in Fig. 3 must be excluded.

All families of trajectory pairs contribute to the conductance according to the same rules as do Richter/Sieber pairs: Each link yields a factor $\frac{1}{N}$, each encounter gives a factor N, and we have to multiply with the number of channel combinations N₁N₂. To prove this assertion, we place a Poincare section P (with = 1:::V) across each of the V encounters. Similar as for Richter/Sieber pairs, we characterize each l-encounter by l 1 stable coordinates s_j (with = 1:::V and j = 1:::l 1), and by l 1 unstable coordinates u_j [9], measuring the phase-space separations between the points where the lencounter stretches pierce through P .

A gain, the trajectory may get lost from the cavity only during the links and on the rst stretch of each encounter. If it survives on that rst stretch, it cannot escape on the remaining stretches of the same encounter, since these are close to the rst. The exposure time T_{exp} is thus obtained as the sum of all link and encounter durations $T_{exp} = \frac{P}{\sum_{i=1}^{L+1} t_i} + \frac{P}{\sum_{i=1}^{V} t_i} t_{enc}$. The survival probability $e^{\frac{N}{T_H}T_{exp}}$ results, again larger than the naive estimate $e^{\frac{N}{T_H}T}$.

We proceed to investigating the statistics of encounters for a given family of trajectory pairs. Generalizing the treatment of Subsection IIB we rst keep all V Poincare sections P xed: each P is placed orthogonal to at a phase-space point traversed at a xed time. The further L V piercings through these sections may be considered statistically independent; the probability density for their occurrence at given times and with given stable and unstable coordinates thus reads $\frac{1}{L_V}$. To account for all encounters, we must integrate $\frac{1}{L_V}$ over all times for the L V later piercings. M oreover, to include all possible P , we must integrate over the times of the V phase-space points chosen as the origin of a section P . Since all sets of piercings within the duration t_{enc} belong to the same encounter,

the latter integral weighs each encounter with a factor t_{enc} . Exactly as for Richter/Sieber pairs, this factor must subsequently be divided out. To simplify our calculation, we replace the integral over altogether L times of piercings by an integral over the durations $t_1; t_2; \ldots; t_L$ of all links except the nalone. This replacement is permissible because all piercing times may be written as functions of $t_1; t_2; \ldots; t_L$, with the Jacobian of the transformation equal to unity. Here, the duration t_{L+1} of the nallink does not show up, since that link does not precede any encounter stretch or piercing point. The integral goes over positive t_i , by the same reasoning as for 2-encounters ⁵; moreover, the cum ulative duration of the rst L links and all encounter stretches must be smaller than the dwell time T, to allow for a non-vanishing nallink. We thus obtain the following density of stable and unstable coordinates

The weight w(s; u) is normalized similarly as in Subsection IIB: Integration over $s_j; u_j$ corresponding to a given interval of $S = \frac{1}{j} s_j u_j$ leads to the number of partner trajectories of a given , with action difference inside that interval, and with the pair (;) belonging to the family considered.

We can now evaluate the contribution of an arbitrary family of trajectory pairs to the average conductance (3). We again approximate A A, and write the sum over as an integral over w (s;u),

As before, the sum over $a_1;a_2$ leads to a multiplication with the number of channel combinations N₁N₂. The sum over can be done using the (modi ed) Richter/Sieber sum rule, and leads to integration over the duration t_{L+1} of the nallink, with an integrand involving the survival probability $e^{\frac{N}{T_H}T_{exp}} = e^{\frac{N}{T_H}(\frac{p}{1+1}t_L + \frac{p}{1+1}t_{exp})}$. Together with the integrals over the remaining L link durations in w (s;u), Eq. (20), all links are now treated equally, and we obtain

Just like in (14) the integral factorizes into several integrals, one for each link and each encounter: Each link gives $\frac{T_{H}}{N}$, and the encounter integral is determined by the linear term in the series expansion of the exponential $e^{-\frac{N}{T_{H}}-t_{enc}(s;u)}$. The encounter integral is slightly changed because the piercing probability $\frac{1}{2}$, and the simple integral disdue^{isu=h}! 2 h now both appear in the (1 1)-fold power. Each encounter thus yields $\frac{N}{T_{H}} = \frac{2}{T_{H}} + 1 = \frac{N}{T_{H}^{-1}}$. Again, all powers of T_{H} mutually cancel. We thus not the same diagram matic rules as above with a factor $\frac{1}{N}$ from each of the L + 1 links, a factor N from each of the V encounters, and a factor $N_{1}N_{2}$ representing the possible channel combinations. (We note that these rules have a nice analogy to our previous work on spectral statistics, see Appendix D). The contribution of each family is therefore given by

To obtain the overall conductance, we must sum over all fam ilies. If we let N (v) denote the number of fam ilies associated to v, Eqs. (6) and (23) in ply

⁵ Note that the initial and nal links must have positive duration also in case they lead to stretches of a parallel encounter. O therw ise all parallel stretches of that encounter would enter or leave the cavity through the same lead. This is im possible, since the trajectories cannot enter or leave the cavity several times.

O ur task has thus been reduced to counting fam ilies of trajectory pairs and evaluating c_m .

For the bwest orders m, the counting is easily done. We have already seen that for time-reversal invariant systems the next-to-leading contribution to conductance originates from the Richter/Sieber family of trajectory pairs di ering in one 2-encounter, see Fig. 1 or 2a. This family has L = 2, V = 1 thus m = 1. Hence, it gives rise to a coe cient $c_1 = -1$ in the orthogonal case. In the unitary case the absence of such trajectory pairs in plies q = 0.

The following coe cient c_2 is determined by pairs of trajectories which either di er in two 2-encounters (i.e., L = 4, V = 2) and thus contribute with a positive sign, or di er in one 3-encounter (i.e., L = 3, V = 1) and contribute with a negative sign. The relevant families are sketched in Fig. 2. In the unitary case, there is only one family of the rst type (Fig. 2b), and one family of the second type (Fig. 2g). Both contributions mutually cancel, i.e., $c_2 = 0$. In the orthogonal case, we must allow for encounters with mutually time-reversed stretches. We then not ve families contributing with a positive sign (Fig. 2b-f) and four families contributing with a negative sign (Fig. 2g-j). All contributions sum up to $c_2 = 1$.

The higher coe cients c m require m ore involved combinatorial methods to which we now turn.

D. Combinatorics

In [9], we found a system atic way for sum m ing contributions of fam ilies of trajectory pairs that di er in arbitrarily m any encounters. In particular, we obtained a recursion for the num bers N (*). Since the treatm ent of [9] was geared towards spectral statistics of closed system s, it was form ulated for pairs of periodic orbits rather than pairs of open trajectories. It can, however, be easily adapted to open trajectories. We just have to turn trajectory pairs into orbit pairs by joining the initial and nalpoints as in Fig. 2, or cut orbits in order to form trajectories.

The topology of orbit pairs (A;B) was described by \structures". To de ne these structures, we numbered the encounter stretches of A in their order of traversal, starting from an arbitrary reference stretch; the links of A were numbered as well, with the rst link preceding the rst encounter stretch. Then, each structure is characterized by (i) a vector \mathbf{v} as above, (ii) a way of distributing the numbered stretches among the encounters, (iii) xing the mutual orientation of stretches inside each encounter, and (iv) shifting connections to form a partner orbit B.

W ith this de nition, each fam ily of trajectory pairs corresponds to one structure of orbit pairs. We only have to glue together the initial and nalpoints of the trajectories as in Fig. 2, and keep the rst stretch of (the one following the initial point) as the rst stretch of A. Thus, each of the pictures in Fig. 2 represents one structure of orbit pairs, and the numbers of orbit pair structures and of trajectory pair families both equal N (*).

To illustrate this relation, we consider the two fam illes of trajectory pairs depicted in Fig. 2e and f. If we join the initial and nal points for any of these fam illes, we obtain orbit pairs of one and the same topology. But still the resulting structures are di erent, because in Fig. 2e the rst encounter stretch (the one following the initial point of the trajectory) precedes a stretch of the same encounter, i.e., the two antiparallel encounters respectively involve the stretches (1;2) and (3;4). A di erent choice of the initial stretch as in Fig. 2fm eans that the two encounters com prise the stretches (1;4) and (2;3). Indeed, structures of orbit pairs and fam illes of trajectory pairs are one-to-one.

For later convenience, we refer to the structure involving one antiparallel encounter (F ig. 2a) as the Sieber/R ichter structure (it was proposed by these authors in [8], see also [24]), to the structure involving two parallel 2-encounters (F ig. 2b) as ppi, to the two structures involving a parallel and an antiparallel 2-encounter (F ig. 2c and d) as api, and to the structures involving two antiparallel encounters (F ig. 2e and f) as asa [25]. The structure involving one parallel 3-encounter (F ig. 2g) will be called pc, and the three structures of the type \equiv (F ig. 2h-) ac.

To form ulate our recursion for N (v), we now denote by N (v; 1) the num ber of structures of orbit pairs (or fam ilies of trajectory pairs) related to v, for which the structures belongs to an 1-encounter. We had established the identity

which has the following intuitive interpretation (not to be confused with the proof in [9]): The probability that the rst stretch forms part of an 1-encounter is given by the overall number lv_1 of stretches belonging to 1-encounters, divided by the overall number L (*) of stretches in all encounters; to obtain N (*;1), we have to multiply N (*) with that probability. Incidentally, the denition of N (*;1) in plies $l_2 N$ (*;1) = N (*).

The relevant recursion relation reads [9]⁶

with = 2 and = 1 respectively referring to the unitary and orthogonal case. The symbol $\mathbf{v}^{[k;2! k+1]}$ denotes the vector obtained from \mathbf{v} if we reduce v_k and v_2 by one, and increase v_{k+1} by one; likewise $\mathbf{v}^{[2!]}$ is obtained from \mathbf{v} if we reduce v_2 by one. In general, the list on the left-hand side of the arrow contains the sizes of \rem oved" encounters, whereas the right-hand side contains the sizes of \added" encounters.

To turn (27) into a recursion for the coe cients c_m , we multiply with $(1)^{V(v)}$ and sum over all v with xed m = M(v) L(v) V(v),

In each of the foregoing sum s we can replace the sum mation variable v by $v^0 = v^{[k;2! k+1]}$ or $v^0 = v^{[2!]}$. Given that trajectory pairs associated with v^0 have one encounter and one encounter stretch less than those of v, we then have to sum over v^0 with $M(v^0) = L(v^0) = V(v^0) = (L(v) = 1)$ (V(v) = m. By denition, we should restrict ourselves to v^0 with $v^0_{k+1} > 0$; how ever, that restriction may be dropped since v^0 with $v^0_{k+1} = 0$ have N (v^0 ; k+1) = 0. In contrast, trajectory pairs associated to v^0 have one encounter and two stretches less than those associated to v. The pertinent sum runs over v^0 with $M(v^0) = L(v^0) = V(v^0) = U(v^0)$. Using $(1^{V})^{(v)} = (1^{V})^{(v^0)} = (1^{V})^{(v^0)}$ we can rewrite (28) as

For the unitary case we conclude that all o -diagonal contributions to the average conductance mutually cancel; the remaining diagonal term, $\frac{N_1N_2}{N}$ reproduces the random -matrix result. For the orthogonal case an initial condition is provided by the coe cient $c_1 = 1$, originating from R ichter/Sieber pairs; hence $q_n = (1)^n$. The anticipated m ean conductance (2) is recovered through (24) as the geometric series

We have thus shown for both symmetry classes that the energy-averaged conductance of individual chaotic cavities takes the universal form predicted by random -matrix theory as an ensemble average.

III. CONDUCTANCE VARIANCE

Experiments with chaotic cavities also reveal universal conductance uctuations. In particular, the conductance variance agrees with the random -m atrix prediction [1]

⁶ Eq. (27) is a special case of Eqs. (42) and (54) in [9], with 1 = 2. To understand the equivalence, note that in [9] we allowed for \vectors" v^0 including a non-vanishing component v_1^0 , which may form ally be interpreted as a number of \1-encounters". We moreover showed that N (v^0 ;1) = N ($v^{0[1!}$) (see the paragraph preceding Eq. (58) of [9]). Applying this relation to $v^0 = v^{[2! 1]}$, one sees that the N ($v^{[2! 1]}$;1) appearing in Eq. (54) of [9] coincides with N ($v^{[2! 1]}$).

Once more, the sem iclassical limit oers itself for an explanation of such universality. With the van V leck approximation for the transition amplitudes (1), the mean squared conductance turns into a sum over quadruplets of trajectories,

Here $a_1; c_1 = 1:::N_1$ and $a_2; c_2 = 1:::N_2$ are channel indices. The trajectories and lead from the same ingoing channel a_1 to the same outgoing channel a_2 , whereas and connect the ingoing channel c_1 to the outgoing channel c_2 . We can expect system atic contributions to the quadruple sum over trajectories only from quadruplets with action di erences S S S + S S of the order of h.

A. Diagonal contributions

The leading contribution to (33) originates from \diagonal" quadruplets with pairwise coinciding trajectories either as (=, =), or as (=, =); both scenarios in ply vanishing action di erences. The rst scenario = , = obviously leads to connecting the same channels as , and connecting the same channels as , as required in (33); this holds regardless of the channel indices $a_1;c_1;a_2;c_2$. The second scenario (=, =) brings about adm issible quadruplets on ly if all trajectories connect the same channels, i.e., both the ingoing channels $a_1 = c_1$ and the outgoing channels $a_2 = c_2$ coincide. The contribution of these diagonal quadruplets to (33) m ay thus be written as the following double sum over trajectories and

The sum over channels just yields the num ber of possible channel combinations as a factor, namely $N_1^2 N_2^2$ for the rst scenario and $N_1 N_2$ for the second one. Doing the sum s over and with the Richter/Sieber rule (5) we get

The larger one of the two sum m ands, $\frac{N_1^2N_2^2}{N^2}$, is cancelled by the squared diagonal contribution to the m ean conductance.

In recent works on Ehrenfest-time corrections [12, 13] (which are vanishingly small in our limit $T_E = T_D$) the diagonal approximation was extended to include trajectories which slightly dier close to the openings. The relation of the methods used in these papers to our present approach is not fully settled yet; further investigation about this relation is desirable.

B. Trajectory quadruplets di ering in encounters




FIG. 4: (a) Schem atic graph of d-quadruplets, with the hatched area a \black box" containing any num ber of encounters; one of the dashed partner trajectories shares initial and nalpoints with ; the second partner trajectory similarly related to . (b)-(h) d-quadruplets responsible for the leading-order contribution to the conductance variance. The diagram s (b), (f)-(h) containing encounters with antiparallel stretches exist only in the orthogonal case. A diagram m ay have a \tw in" obtained by re ection in a horizontal line; the num ber of sym m etric versions of each diagram is indicated by a multiplier underneath. (i) Schem atic graph of x-quadruplets, encounters suppressed: one of the partners shares initial link with and nallink with nallink of . (j) An x-quadruplet involving one 2-encounter.

O -diagonal contributions arise from quadruplets of trajectories di ering in encounters; see Fig. 4 for examples. Each trajectory pair (;) typically contains a huge number of encounters, where stretches of and/or come close to each other (up to time reversal). Partner trajectories , can be obtained by switching connections within some encounters. Together, and go through the same links as and , and traverse each l-encounter exactly l times, just like the pair (;). Consequently, the cum ulative action of (;) is close to the one of (;), with a small action di erence S = (S + S) (S + S) originating from the intra-encounter reconnections.

D i erent quadruplet fam ilies are distinguished by the number of L-encounters, the mutual orientation of encounter stretches, their distribution among and , and the reconnections leading to and . Sim ilar as the diagonal quadruplets, some fam ilies of quadruplets involve one partner trajectory whose initial and nal links practically coincide with those of and the other one whose initial and nal links coincide with those of . When these fam ilies are depicted schem atically with encounters suppressed they all look the same and in fact like diagonal quadruplets (see Fig. 4a), for which reason we shall refer to them as \d-fam ilies"; examples are depicted in Figs. 4b-h. In analogy to the diagonal quadruplets, d-quadruplets contribute with altogether N $_1^2$ N $_2^2$ + N $_1$ N $_2$ channel com binations. O f these, N $_1^2$ N $_2^2$ arise when and start and end alike since then the four channel indices involved are unrestricted; when and start and end alike, N $_1$ N $_2$ com binations arise since the channels are restricted as $a_1 = c_1$; $a_2 = c_2$.

A second type of quadruplet fam ilies is drawn schem atically in Fig. 4i: here one partner trajectory practically coincides at its beginning with and at its end with ; the other trajectory coincides at its beginning with and

at its end with . The simplest example of such an x-fam ily" involves just one 2-encounter, see Fig. 4j β , 5]; not surprisingly, our schematic sketch strongly resembles that picture. Since quadruplets contribute to the conductance variance only if they connect channels as ; :a₁ ! a₂ and ; :c₁ ! c₂, x-fam iles arise only if either the ingoing channels or the outgoing channels coincide. If the ingoing channels coincide, a₁ = c₁, the trajectory coinciding initially with and nally with has the form a₁ = c₁ ! a₂ and may be chosen as ; the trajectory coinciding initially with and nally with is of the form a₁ = c₁ ! c₂ and may be chosen as . If a₂ = c₂, sim ilar arguments hold, with and interchanged. Thus, x-fam ilies arise for N₁N₂ channel combinations with a₁ = c₁, and for N₁²N₂ combinations with a₂ = c₂, altogether for N N₁N₂ possibilities.

We shall presently nd that quadruplet families contribute to the conductance variance according to the same rules as do pairs to the mean conductance: Each link yields a factor $\frac{1}{N}$, each encounter a factor N; moreover, we have to multiply with the number of channel combinations, i.e. $N_1^2 N_2^2 + N_1 N_2$ for d-families and N N₁N₂ for x-families.

To justify these rules we consider a family with numbers of l-encounters given by $\mathbf{v} = (v_2; v_3; v_4; :::)$. Again, \mathbf{v} determ ines the total number of encounters V (\mathbf{v}) and the number of encounter stretches L (\mathbf{v}). The overall number of links is now given by L (\mathbf{v}) + 2, since there is one link preceding each of the L (\mathbf{v}) encounter stretches, and the two nallinks of and which do not precede any encounter stretch. Similarly as for trajectory pairs, we can determ ine a density w (s; u) of stable and unstable separations; this density w ill be norm alized such that integration over all s; u belonging to an interval (S; S + d S) of action di erences S yields the number of pairs; di erence is inside that interval

; such that the quadruplet (;;;) belongs to a given family and the action di erence is inside that interval. Using the same arguments as in Subsection IIC, one nds w (s;u) as an integral over $f = t_{enc} (s;u)g^{-1}$, with the integration running over the durations of all links, except the nallinks of and . The integration range must be restricted such that all links (including the nalones) have positive durations. To evaluate the contribution of one family to the quadruple sum in (33), we may now replace the sum mation over and by integration over w (s;u),

The coe cients d_m ; x_m are obtained by counting families of quadruplets. That counting is an elementary task for smallm. The coe cient d_1 accounts for families of d-quadruplets di ering in one 2-encounter (L = 2, V = 1, m = 1). In the unitary case there are no such families, i.e., $d_1 = 0$. In the orthogonal case, we must consider quadruplets with one partner trajectory di ering from in a 2-encounter, and one partner trajectory identical to , see Fig. 4b; the quadruplet thus contains one R ichter/Sieber pair and one diagonal pair. A similar family of quadruplets involves one partner trajectory identical to , and one partner trajectory di ering from in a 2-encounter trajectory di ering from 2.

The following coe cient d_2 is determined by d-quadruplets differing in two 2-encounters or in one 3-encounter, the latter quadruplets contributing with a negative sign. Some of these quadruplets fall into two pairs contributing to the average conductance. Quadruplets consisting of one diagonal pair and one pair contributing to the coe cient c_2 of the average conductance (see Fig. 2) yield a contribution $2c_2$ to d_2 (i.e., 0 in the unitary case and 2 in the orthogonal case); the factor 2 arises because either or m ay belong to the diagonal pair. In the orthogonal case, there is one further family of quadruplets consisting of two R ichter/Sieber pairs. Finally, we must reckon with quadruplets that do not fall into two pairs contributing to the mean conductance, as depicted in Figs. 4c-e, for the unitary case. Two further families are obtained by \re ection", i.e., interchanging and in Figs. 4d and 4e. Taking into account the negative sign for Fig. 4e and its re ected versions of Fig. 4g and h yield a further sum m and 1. A ltogether, we thus nd $d_2 = 1$ in the unitary case and $d_2 = 2 + 1 + 1 + 1 = 5$ in the orthogonal case.

The most important family of x-quadruplets, see Fig.4; involves a parallel encounter between one stretch of and one stretch of . This family, discovered in [3] for quantum graphs, gives rise to a coe cient $x_1 = 1$ for systems with or without time-reversal invariance.

W ith the coe cients $d_1; d_2; x_1$, the conductance variance (38) can be evaluated up to corrections of order O $(\frac{1}{N})$. The result⁷

coincides with the random -m atrix prediction (32). We note that Eq. (39) could ultimately be attributed only to the quadruplets shown in Fig. 4c-h, since all other contributions mutually cancel. (In particular, the contributions proportional to $N_1^2 N_2^2$ from all d-quadruplets that consist of two pairs contributing to the conductance are cancelled by the squared average conductance. The term proportional to $N_1 N_2$ in the diagonal approximation is compensated by the contribution of x-quadruplets as in Fig. 4j.)

To go beyond Eq. (39) (and to show that no term swere m issed in Eq. (39)), we must system atically count fam ilies of d- and x-quadruplets with arbitrarily many encounters. Sim ilar to the case of conductance this can be done by establishing relations between fam ilies of trajectory quadruplets and structures of periodic orbit pairs. For details see Appendix A; the results di er for the two universality classes.

IV. SHOT NOISE

O ur reasoning can be extended to a huge class of observables which are quartic in the transm ission am plitudes and thus determ ined by d-and x-quadruplets as well. For a rst example, we consider shot noise: D ue to the discreteness of the elementary charge, the current owing through a mesoscopic cavity uctuates in time as $I(t) = \overline{I} + I(t)$ where \overline{I} denotes the average current. These current uctuations, the so-called shot noise, remain in place even at zero tem perature. They are usually characterized through the power [1]

U sing our sem iclassical techniques, we proceed to show ing that for chaotic cavities, the energy-averaged power of shot noise takes a universal form. A gain, our treatment applies to individual cavities and yields an expansion to all orders in the inverse number of channels. That expansion turns out convergent and sum m able to a sim ple expression which subsequently to our prediction was checked to agree with random -m atrix theory by Savin and Som m ers [28].

Following Buttiker [15], we express the power of shot noise through the transition matrices t

here, P is averaged over the energy and measured in units $\frac{2e^3 y}{h}j$ depending on the voltage V. W hile the average conductance htr(tt^y) i was already evaluated in Section II, the quartic term turns into a quadruple sum over trajectories similar to the conductance variance

the trajectories , , , must now connect the ingoing channels a $_1;c_1$ to the outgoing channels $a_2;c_2$ as indicated in the summation prescription.

As a consequence, the possible channel combinations for d- and x-fam ilies of quadruplets are changed relative to the conductance variance. In the present case, d-quadruplets, with one partner trajectory coinciding at its beginning and end with , and the other partner trajectory doing the sam e with , contribute only if either the ingoing or the outgoing channels coincide. If the ingoing channels coincide, the partner trajectory connecting the sam e points as is of the type $a_1 = c_1 ! a_2$ and may be taken as , whereas the trajectory connecting the sam e points as has the form $a_1 = c_1 ! c_2$ and may be chosen as . If the outgoing channels coincide, sim ilar arguments apply, with and interchanged. Thus, d-quadruplets contribute only for $N_1 N_2^2 + N_1^2 N_2 = N N_1 N_2$ channel combinations. In this sense, they take the role played by x-quadruplets in case of the conductance variance.

In turn, x-quadruplets now contribute for all channel combinations. Moreover, if both the ingoing and the outgoing channels coincide, either of the two partner trajectories may be chosen as or , meaning that the corresponding channel combinations have to be counted for a second time. Thus, x-quadruplets now contribute for altogether $N_1^2N_2^2 + N_1N_2$ channel combinations, like d-quadruplets in case of the conductance variance.

W e can simply interchange the multiplicity factors in our form ula for $h(tr(tt^{y}))^{2}$ i, Eq. (38), to get




FIG.5: Fam illes of x-quadrup lets with m = L V = 2, contributing to the next-to-leading order of shot noise for time-reversal invariant system s.

to all orders in $\frac{1}{N}$, for individual chaotic cavities. We can, moreover, give an intuitive interpretation for the terms s in (51). The diagonal contributions to htr(tt^y)i and htr(tt^ytt^y)i both read $\frac{N_1N_2}{N}$ and therefore mutually cancel. The leading contribution, $\frac{N_1^2N_2^2}{N^3}$, arises from d-quadruplets di ering in a single 2-encounter (see Fig. 4). In the unitary case, there are no terms of order 1, since all related families require time-reversal invariance. In the orthogonal case, R ichter/Sieber pairs yield a contribution $\frac{N_1N_2}{N^2}$ to htr(tt^y)i, from which we have to subtract two contributions to htr(tt^ytt^y)i, the term $\frac{2N_1N_2}{N^2}$ accounting for d-quadruplets di ering in a single antiparallel2-encounter (see Fig. 4b), and a term $\frac{4N_1^2N_2^2}{N^4}$ arising from x-quadruplets contributing to $x_2 = 4$. The latter x-quadruplets may di er in two 2-encounters, as in Figs. 5a and 5b, or in one 3-encounter, as in Fig. 5c. From the examples in Fig. 5, further families are obtained by interchanging and , interchanging the two leads (for Figs. 5a and 5c), or interchanging the pairs (;) and (;) (for Fig. 5b). Each of the Figs. 5a-c therefore represents altogether four families, whose




FIG.6: A cavity with three leads. If a voltage V is applied between lead 1 and leads 2 and 3, one observes currents $I^{(1! 2)}$ and $I^{(1! 3)}$. As explained in the text, correlations between these currents are again determined by families of d-and x-quadruplets of trajectories.

contributions indeed sum up to $x_2 = 4(1)^2 + 4(1)^2 + 4(1) = 4$. Together with the contributions mentioned before, they combine to (51).⁹

V. CURRENT CORRELATIONS IN CAVITIES W ITH THREE LEADS

A nother interesting experimental setting involves a chaotic cavity with three leads, respectively supporting N₁, N₂ and N₃ channels; see F ig. 6. The second and the third lead are kept at the same potential, and a voltage is applied between these leads and the rst one. Consequently, currents $I^{(1! 2)}$, $I^{(1! 3)}$ ow from the rst lead to the second and third one. We shall be interested in the uctuations $I^{(1! 2)}$, $I^{(1! 3)}$ of these currents around the corresponding averages values, and study correlations between $I^{(1! 2)}$ and $I^{(1! 3)}$ [29, 30].

This setting is similar to the fam ous Hanbury Brown-Twiss experiment [31] in quantum optics: there, light from some source (corresponding to the rst lead) was detected by two photom ultipliers (corresponding to the second and third lead). Similar work on Fermions began somewhat later [29, 30] but the precise from of the correlation function is as yet unknown.

O ur sem iclassical reasoning can easily be extended to llthis gap. The two currents depend on the matrices $t^{(1!\ 3)}$, $t^{(1!\ 3)}$ containing the transition amplitudes between channels of the rst and the second and third lead; these matrices have the sizes N₁ N₂ and N₁ N₃. As shown in [29, 30], correlations between I^(1!\ 2) and I^(1!\ 3) are determined by the transition amplitudes as

The contribution of each family of trajectory quadruplets can be evaluated similarly to the conductance variance or shot noise. Since a particle can have the cavity through any of the three leads, the escape rate depends on the overall number of channels $N = N_1 + N_2 + N_3$. Again, integration brings about factors $\frac{1}{N}$ and N for each link and each encounter. Only the numbers of channel combinations are changed. x-quadruplets as in Fig. 6a contribute for all $N_1^2N_2N_3$ possible choices of a_1 , c_1 , a_2 , c_3 . For any of these choices, partner trajectories connecting the initial point of

 $(c_1 \ c_3)$ to the nalpoint of $(a_1 \ a_2)$, and the initial point of to the nalpoint of are of the form $c_1 \ a_2$ and $a_1 \ c_3$ and can be chosen as and , respectively. In contrast, d-quadruplets as in Fig. 6b contribute only for the N₁N₂N₃ combinations with coinciding ingoing channels $a_1 = c_1$. For these combinations the partner trajectory coinciding at its ends with is of the type $a_1 = c_1 \ a_2$ and can be taken as whereas the partner trajectory coinciding at its ends with has the form $a_1 = c_1 \ c_3$ and can be chosen as . With these numbers of channel combinations, the current correlations in a 3-lead geometry are obtained as

VI. ERICSON FLUCTUATIONS

A nother interesting quantum signature of chaos are so-called Ericson uctuations, which have rst been discovered experimentally in nuclear physics. In compound-nucleus reactions with strongly overlapping resonances, universal uctuations in the correlation of two scattering cross sections at di erent energies have been observed. A rst interpretation in terms of random -m atrix theory was provided by Ericson [32] and further theoretical investigations have been reported in [33], [34].

Later on, the relation between classical chaotic scattering and Ericson uctuations in single-particle quantum mechanics has been discussed [35]. Theoretical work shows that, e.g. the photoionization cross section of Rydberg atom s in external elds show universal correlations once the underlying classical dynam ics is chaotic [36].

C haotic transport through a ballistic cavity displays E ricson uctuations in the covariance of the conductance at two di erent energies,

Here, the di erence between the two energies was made dimensionless by referral to the energy scale $\frac{N}{2}$ = proportional to the number of channels and to the mean level spacing. Similarly as for the conductance variance, the sem iclassical approximation (1) for t(E);t(E⁰) where E⁰ = E + $\frac{N}{2}$ leads to a quadruple sum over trajectories,

For each d-family we have to keep into account N $_{1}^{2}N_{2}^{2}$ channel combinations with coinciding at its ends with ; all these \ -type" combinations give rise to the same f $_{i}$; g and to the same link and encounter factors. In addition, we must consider N $_{1}N_{2}$ combinations of the \ -type" with coinciding at its ends with , and a di erent set of f $_{i}$; g.

For each x-fam ily we would, in principle, have to distinguish between $N_1N_2^2$ combinations with coinciding ingoing channels, and coinciding at its beginning with and at its end with , and $N_1^2N_2$ combinations with coinciding outgoing channels, and coinciding at its beginning with and at its end with . Such caution is, how ever, unnecessary for reasons of symmetry. Each x-fam ily is accompanied by another one which is topologically m irror-symmetrical, with left and right in Fig. 4 interchanged. In this fam ily, initial points turn into nalones, and vice versa, im plying that and are interchanged. Since both fam iles are taken into account simultaneously, \m istakes" like always choosing to connect the initial point of to the nalpoint of , are automatically compensated.

W e can thus write the conductance covariance as

Here the coe cients x_m (); $d_m^{()}$ (); $d_m^{()}$ () are the sum m ary contributions of the x-quadruplets and the two m entioned groups of d-quadruplets, with m = L (*) V (*) 2 (and thus m = 0 for the diagonal quadruplets) and the denom inator N^m² dropped. The squared averaged conductance is -independent and is determined by Eq. (2).

The leading contribution to the conductance covariance corresponds to dropping in (61) all coe cients but $x_1; d_0^{()}; d_1^{()}; d_2^{()}; d_2^{()}$. For the conductance variance, we had seen that the contributions of d-quadruplets that fall into pairs (,) and (,) contributing to conductance cancel with the squared average conductance. The




FIG. 7: Families of trajectory quadruplets contributing to the covariance of conductance (coinciding with Fig. 4c-h,j). The trajectories and are highlighted through dashing and dotting, assuming that connects the same points as . The picture also indicates all non-vanishing num bers $_{\rm i}$ and (the latter in bold font).

same remains valid here, since for these pairs and traverse the same links and encounters, and all $_{\rm i}$ and vanish. Again, the contributions of diagonal quadruplets =, = and x-quadruplets as in Fig. 4j (see also Fig. 7g) m utually com pensate; com pared to the variance both kinds of quadruplets receive the sam e additional factors due to one link with i = 1 (the trajectory = and the lower left link in Fig. 7g) and one link with i = 1 (the trajectory = and the upper left link in Fig. 7q).

Like for the conductance variance, the leading contribution to the covariance thus originates from the d-families in Fig. 4c-h which contain encounters between and and thus do not fall into pairs relevant for conductance. These fam ilies are redrawn in Fig. 7a-f, together with all non-vanishing numbers i and . The trajectories and are highlighted through dashing and dotting, assuming that connects the same points as ; channel combinations with connecting the same points as only contribute to higher orders in $\frac{1}{N}$. The family of Fig. 7a involves a link with

1 (the upper central one) and a link with i = 1 (in mediately below), and thus yields $\frac{N_1^2 N_2^2 (N)^2}{N^6 (1+i)(1-i)} = \frac{N_1^2 N_2^2}{N^4 (1+2)}$. i = The same holds for the family in Fig. 7d, which requires time-reversal invariance. In contrast, the contributions of Fig. 7b, c,e, and frem ain independent of , since additional factors from links with i = 1 and encounters with 1 mutually compensate; the same applies for the families represented by $\ 2"$ in Fig.7, with (,) and (,) interchanged and the signs of $_{\rm i}$ and ipped. As for the variance of conductance, the contributions of Fig. 7b, c,e,f thus mutually cancel, both in the orthogonal case and in the unitary case (where only Figs. 7b, c may

Higher orders in $\frac{1}{10}$, not known from random matrix theory, can be accessed by straightforward computer-assisted counting of fam ilies of quadruples di ering in a larger num ber of encounters, or in encounters with m ore stretches. To do so, we generated permutations which describe possible structures of orbit pairs (see Appendix B and [9]). We then \cut" through these pairs as described in Appendices A and B to obtain quadruplets of trajectories and determined the corresponding i, . The nalresult can be written as

In the unitary case the x-type contribution cancels in all orders with the d (-)-contribution; for that reason the overall result is proportional to N $_1^2$ N $_2^2$.

VII. QUANTUM TRANSPORT IN THE PRESENCE OF A WEAK MAGNETIC FIELD

A. Changed diagram m atic rules

Our methods can also be applied to the case of a weak magnetic eld, with a magnetic action of the order of h. The necessary modi cations were introduced in [37] for the spectral form factor; see also [38]. As in [37], we will obtain results interpolating between the orthogonal case (without a magnetic eld) and the unitary case, where the magnetic eld is strong enough to fully break time-reversal invariance. We shall assume that the eld is too weak to in uence the classical motion, meaning that we have to deal with the same families of trajectory pairs as in the orthogonal case. However, the action of each trajectory is increased by an amount proportional to the integral of the vector potential A along that trajectory, e.g., by

for the trajectory . When we evaluate the average conductance, the action di erence inside each pair of trajectories and is thus increased by . This additional term may be neglected for pairs of trajectories where all encounters are parallel. For these pairs, all links and stretches of are close in phase space to links and stretches of , and therefore receive alm ost the sam e m agnetic action.

The situation is dierent for pairs where and traverse links or stretches with opposite sense of motion. Since the magnetic action changes sign under time reversal, such orbit pairs have signicant magnetic action dierences

. These di erences can be split into contributions from the individual links and encounters. Let us rst consider links. If contains the time-reversed of the i-th link of , it must obtain the negative of the corresponding magnetic action $_{i}$. The di erence then receives a contribution 2 $_{i}$. Therefore we may write the contribution of each link as 2 $_{i}$ $_{i}$ with $_{i} = 1$ if the link changes direction on and $_{i} = 0$ otherwise.

Consider now the contribution of encounters. We assume that in the original trajectory the encounter had stretches traversed in some direction (arbitrarily chosen as\positive") meaning that the remaining 1 stretches were traversed in the opposite, \negative" direction; in the trajectory partner these numbers will generally change to 0 ; 1 0 correspondingly. Denoting the magnetic action accumulated on a single stretch traversed in a positive direction by we see that the encounter yields 2 to the magnetic action di erence, with = 0 . The overall magnetic contribution to the action di erence now reads

where we again distinguish between links and encounters only through Latin vs. G reek subscripts.

To handle this additional phase factor, we show that for fully chaotic (in particular, ergodic and m ixing) dynam ics, the magnetic action may electively be seen as a random variable [37]. For fully chaotic systems, any point on any trajectory can be located everywhere on the energy shell, with a uniform probability given by the Liouville measure. Moreover, phase-space points following each other after times larger than a certain classical \equilibration" time t_{c1} can be seen as uncorrelated. We will therefore split each link or encounter stretch into pieces of duration t_{c1}. These pieces have dimensions to the magnetic actions. Let us consider the probability density for these actions. Since positive and negative contributions to the magnetic action are equally likely, the expectation value for the action of an orbit piece must be equal to zero. The width W (i.e., the square root of the variance W²) must be proportional to the vector potential and therefore to the magnetic edd B. Since the magnetic actions of the individual pieces are uncorrelated, the central limit theorem then in plies that the magnetic actions of links with K $\frac{t_{\rm i}}{t_{\rm c1}}$ 1 pieces obey a G aussian probability distribution with the width $\stackrel{\rm P}{\rm K}$ W, i.e.,

Links and stretches traversed in opposite directions by and thus lead to exponential suppression factors in the contributions of trajectory pairs.

These factors have to be taken into account when evaluating the average conductance, starting from (22). The link integrals are changed into

Since the T_H 's again mutually cancel, our diagram matic rules are changed to give a factor $\frac{1}{N(1+1)}$ for each link and a factor N (1 + 2) for each encounter; the arising product has to be multiplied with the number of channel combinations, i.e., N_1N_2 for the average conductance.

The same rules carry over to the conductance variance, shot noise, and correlations in a three-lead geometry. In these cases, i is equal to 1 if the i-th link of the pair (,) is reverted in (,), and counts the stretches of the -th encounter of (,) which are reverted in (,); the sign of is xed as above.

B. M ean conductance

For the average conductance, the diagonal contribution, $\frac{N_1N_2}{N}$, remains una ected by the magnetic eld. The contribution of R ichter/Sieber pairs, $\frac{N_1N_2}{N^2}$, obtains an additional factor $\frac{1}{1+}$, since one of the three links of in Fig. 1 or 2a is traversed by in opposite sense. The next order originates from trajectory pairs as in Fig. 2b-jwhere arrows indicate the direction of motion inside the encounters and highlight those links which are traversed by and with opposite sense of motion. The contributions of the families in Fig. 2b, c, d, g, i, jrem ain unchanged: In Fig. 2b, g no links or encounter stretches are reverted; for Fig. 2c, d, i, j the num ber of links with i = 1 and encounters with 2 = 1 coincide, m eaning that the -dependent factors m utually compensate. The six above families cancel m utually due to the negative sign for Fig. 2g, i, j. The contributions of Fig. 2e, f, h obtain a factor $\frac{1}{(1+)^2}$ from two reverted links; due to the negative sign of Fig. 2h, they sum up to $\frac{N_1N_2}{N_3(1+1)^2}$. We thus nd

Counting further families of trajectory pairs with the help of a computer program one is able to proceed to rather high orders in $\frac{1}{N}$. We then nd

As expected, (70) and (71) interpolate between the results for the orthogonal case, reached for B ! 0 and thus ! 0, and the unitary case, form ally reached for B ! 1 and thus ! 1. The convergence to the unitary result is non-trivial: The contributions of the families in Fig. $2c_{i}d_{i}$ are not a ected by a magnetic eld, because all dependent factors cancel. These contributions thus survive in the limit ! 1 (i.e., when the magnetic action becomes much larger than h, but the trajectory deform ations due to Lorentz force can still be disregarded), but vanish in the unitary case (i.e., when the magnetic eld is strong enough to considerably deform the trajectories). The agreem ent between the limit ! 1 and the unitary result in plies that the contributions of all such families must sum to zero, for all orders in $\frac{1}{N}$. O rder by order, (71) coincides with the results of [39], where the individual coe cients were given as (rather involved) random -m atrix integrals.

C . C onductance variance, shot noise and three-lead correlations

For observables determ ined by families of trajectory quadruplets, it is convenient to rst evaluate the overall contributions of d- and x-families per channel combination. These contributions, denoted by D and X, now depend on the parameter . The contribution of d-families reads

generalizing our previous results (41) and (44) for the unitary and orthogonal cases. The leading term, originating from diagonal quadruplets, remains una ected by the magnetic eld. The second term is due to quadruplets as in Fig. 4b. Since in these quadruplets, one link of (,) is time-reversed in (,), the corresponding contribution is proportional to $\frac{1}{1+}$. It is easy to check that the third term correctly accounts for d-quadruplets di ering in two 2-encounters, or in one 3-encounter; com pare Subsection IIIB and Fig. 4. The higher-order term swere again generated by a computer program.

In the overall contribution of x-fam ilies,

the term $\frac{1}{N^3}$ accounts for x-quadruplets di ering in a parallel 2-encounter, Fig. 4j. These quadruplets are not a ected by the magnetic eld. All families responsible for the second term, Fig. 5a-c, display a Lorentzian eld dependence $\frac{1}{1+}$: W hile Figs. 5a and 5c contain one time-reversed link and only encounters with = 0, Fig. 5b involves two time-reversed links and one encounter with $^2 = 1$. The remaining term swere again found with the help of a computer.

W ith these values of D and X, we obtain, writing out only term sup to 0 (N $^{-1}$),

At least the higher orders in $\frac{1}{N}$ are new results. In particular, for the power of shot noise, we do not only obtain the previously known cancellation of the second term at $N_1 = N_2 = \frac{N}{2}$, but also a new eld dependence due to the third term,

D. Ericson uctuations

W hen studying Ericson uctuations in a weak magnetic eld, we have to deal with two parameters (apart from the channel num bers): the scaled energy di erence and the parameter proportional to the squared magnetic eld. Our

diagram m atic rules are then changed in a straightforward way. Each link yields a factor $\frac{1}{N(1+i)}$, whereas each encounter gives N (1 + i), to be multiplied with the number of channel combinations.

As in the orthogonal and unitary cases, the leading contribution can be attributed to the quadruplets in Figs. 7a and 7d; all other contributions of the same or lower order, including the remaining families in Fig. 7, mutually cancel. Quadruplets as in Fig. 7a do not feel the magnetic eld, and thus yield $\frac{N_1^2 N_2^2}{N^4 (1+2)}$ as shown in Section VI; here we dropped lower-order corrections due to the case of coinciding channels. For the family of quadruplets depicted in Fig. 7d, the two links with i = 1 connecting the two encounters are reversed inside (,) and thus have i = 1.W e obtain factors $\frac{1}{N(1+i)}$ and $\frac{1}{N(1+i)}$ from these two links, $\frac{1}{N}$ from each of the four remaining link, and N from the encounter. Multiplication with the number of channel combination yields a contribution $\frac{N_1^2 N_2^2}{N^4 ((1+j)^2+j)}$. Ericson uctuations in a weak magnetic eld are therefore determined as

VIII. CONCLUSIONS

A sem iclassical approach to transport through chaotic cavities is established. We calculate mean and variance of the conductance, the power of shot noise, current uctuations in cavities with three leads, and the covariance of the conductance at two di erent energies. These observables are dealt with for system swith and without a magnetic eld breaking time-reversal invariance, as well as in the crossover between these scenarios caused by a weak magnetic eld leading to a magnetic action of the order of h. In contrast to random -matrix theory, our results apply to individual chaotic cavities, and do not require any averaging over ensembles of system s. Moreover, we go to all orders in the inverse number of channels.

Transport properties are expressed as sum s over pairs or quadruplets of classical trajectories. These sum s draw system atic contributions from pairs and quadruplets whose members di er by their connections in close encounters, and almost coincide in the intervening links. The contributions arising from the topologically di erent fam ilies of quadruplets or pairs are evaluated using simple and general diagram matic rules, sum marized in Tab. I. (These rules rem ain in place even for observables involving higher powers of the transition matrix, as shown in Appendix C). O ur work shows that, under a set of conditions, individual chaotic system s dem onstrate transport properties devoid of any system -speci c features and coinciding with the RM T predictions. An obvious next stage would be investigation of the system -speci c deviations from RM T observed when these conditions are not met. P revious work [2, 4, 5] has already motivated an extension to the regime where the average dwell time T_D is of the order of the E hren fest time T_E , i.e. the duration of the relevant encounters. Here, the sem iclassical approach helped to settle questions controversial in the random -matrix literature [11]. As shown in [12, 13], the leading contributions to the average conductance and the power of shot noise become proportional to powers of e $T_E = T_D$, ultimately arising from the exponential decay of the survival probability. On the other hand, the conductance variance turned out to be independent of T_E [12].

The door is open for a sem iclassical treatment of many more transport phenomena, such as quantum decay [40], weak antilocalization [41], parametric correlations [38, 42], the full counting statistics of two-port cavities, and cavities with more leads. Extensions to the symplectic symmetry class, along the lines of [9, 43], and to the seven new symmetry classes [44] (relevant e.g. for norm al-metal/superconductor heterostructures or quantum chromodynamics) should be within reach. A generalization to quasi one-dimensional wires would nally lead to a sem iclassical understanding of dynamical localization.

APPENDIX A: TRAJECTORY QUADRUPLETS VS ORBIT PAIRS

In this Appendix we will establish a combinatorial method for counting families of trajectory quadruplets appearing in the theory of conductance variance and shot noise. We will see that trajectory quadruplets can be glued together to form orbit pairs, and orbit pairs can be cut into quadruplets of trajectories. In contrast to the case of trajectory pairs, see Fig. 2, we shall now need two cuts.

O ur approach will be purely topological; e.g., an orbit pair (A;B) is regarded just as a pair of directed closed lines with links coinciding in A and B but di erently connected in the encounters. Similarly, within each quadruplet (;;;) we can assume that the links of; exactly coincide with those of; . Mostly, we can even think of the quadruplets as black boxes with two left ports $a_1;c_1$ and and two right ports $a_2;c_2$. Regardless of the actual num ber of encounters inside, an x-quadruplet can then be treated like a \dressed" 2-encounter: connections $a_1 | a_2, c_1 | c_2$ in one of the trajectory pairs are replaced by $a_1 | c_2, c_1 | a_2$ in the partner pair, exactly as if a single 2-encounter existed between the trajectories; of the quadruplet. On the other hand, no change in the connections occurs between the ports in a d-quadruplet, hence it is topologically equivalent to a pair of dressed links.

W e shall consider both the unitary and the orthogonal case. In each case, we will use two slightly di erent m ethods to relate trajectory quadruplets and orbit pairs. This will allow us to express the quantities x_m and d_m de ned in (37) through the auxiliary sum s

where N (v) and N (v;2) are numbers of structures of orbit pairs (see Subsection IID) and we have M (v) L (v) V (v); these auxiliary sum s will be determined recursively in Subsection A 3 below.

1. Unitary case




FIG.8: Left-hand side: Schem atic picture of a d-quadruplet of trajectories; (full lines), , (dashed lines). Right-hand side: Outside the \bubble", we added connection lines joining (;) and (;) into periodic orbits A and B with the initial link indicated by "1.". The additional lines of A and B coincide.

To illustrate method I, let us consider a d-quadruplet (;;;), as on the left-hand side of Fig. 8, and merge and into one \orbit" A. We connect the nalpoint of to the initial point of and the nalpoint of to the




FIG.9: Left-hand side: Schem atic picture of an x-quadruplet of trajectories ; (full lines), , (dashed lines). Right-hand side: Outside the \bubble", we added connection lines joining (;) and (;) into periodic orbits A and B. The additional lines of A and B di er from each other, and can be viewed as an additional 2-encounter.

initial point of , as shown on the right-hand side. Likewise, and can be glued together to an $orbit" B.^{10}$ The connection lines added are the same for (;) and for (;): one connection line joins the coinciding nallinks of and with the coinciding initial links of and , whereas the second one joins the nallinks of and with the initial links of and B di er in the same encounters as (;) and (;). To x one structure for the orbit pair A; B, we have to single out one link as the $\$ rst" and choose as such the link of A created by merging the nallink of with the initial link of (indicated by "1." in Fig. 8).

We can revert the above procedure, to obtain families of d-quadruplets from structures of orbit pairs. We rest have to cut both orbits inside the \initial" link. This leads to a trajectory pair with L (*) + 1 rather than L (*) links. We then have L (*) + 1 choices for placing a second cut in any of these links. In each case, we end up with a trajectory quadruplet. Within this quadruplet, the trajectories following the rest cut through A and B are labelled by and ; the remaining ones are called and . In this way, each of the N (*) structures of orbit pairs related to a given v gives rise to L (*) + 1 families of d-quadruplets with the sam e v. The quantities N d (*) and d_m characterizing the d-families in (37) thus become accessible as

Let us discuss a few examples. A coording to (A 3) the coe cient d_1 is determined by orbit pairs with m = 1 (i.e., only one 2-encounter). Since in the unitary case there are no such orbit pairs, we have $d_1 = 0$. The following coe cient d_2 is determined by orbit pairs with m = 2. In the unitary case there are only two such structures, ppi and pc (Fig. 2b and g). All quadruplets responsible for the coe cient d_2 can be obtained by making two cuts through these orbit pairs, one through the initial link which may be chosen arbitrarily. The second cut can go through any link; in particular, there are two possibilities for the second cut in the initial link, before and after the rst cut. That m eans L + 1 = 5 possible positions of the second cut for ppi. These lead to the quadruplets as in Fig. 4c and d, the re ected version of Fig. 4d, and quadruplets where either or contain two 2-encounters and the other trajectory




FIG.10: Sketches of orbit pairs (A;B). Inside the bubbles: quadruplets of trajectories obtained by cutting (A;B) in the initial link (indicated by "1."), and in one further link. In (a) both links are traversed by A and B with the same sense of motion, and the trajectory quadruplet is of type d. In (b), the second cut is placed in a link traversed with opposite senses of motion, and the resulting quadruplet is of type x.

contains none. For pc there are four possible positions for the second cut, corresponding to Fig. 4e, its re-ected version, and quadruplets where either or contain the full 3-encounter. All quadruplet fam ilies related to a given structure m ake the same contributions (1)^V to the coe cient d₂, i.e., 1 for those obtained from ppi and -1 for those obtained from pc; we again see that d₂ = 5 4 = 1.

To explain method II, let us now consider x-quadruplets as on the left-hand side in Fig. 9.0 n the right-hand side, and are again merged into a periodic orbit A, and and are once more merged into B, by connection lines leading from the end of one trajectory to the beginning of the other one. In contrast to the rst scenario, the pair (A;B) has one further 2-encounter between these lines, with di erent connections for the two partner orbits. To x one structure for the latter orbit pair, we take the initial link of as the $\$ rst" link of the orbit pair. This link is preceded by a $\$ nal" stretch, which m ust belong to the added 2-encounter. W e m ust therefore reckon with orbit pairs associated to the vector $\mathbf{v}^{[! 2]}$ and whose nal stretches belong to a 2-encounter. In the notation of Subsection IID, the num ber of structures of such orbit pairs is given by N ($\mathbf{v}^{[! 2]}$;2).

Each of these structures can be turned back into one fam ily of x-quadruplets, by cutting out the added 2-encounter. Consequently, there is a one-to-one relation between x-fam ilies and the structures of orbit pairs considered. The number of x-fam ilies related to v and the coe cients x_m de ned in (37) are given by

For instance, the coe cient x_1 is determined by orbit pairs with L (*) V (*) = 2.0 nly one such structure (ppi) contains 2-encounters and yields a contribution 1, whereas pc involves only one 3-encounter. We thus nd $x_1 = 1$, as already seen previously.

Taken together, Eqs. (A 3), (A 6), and (26) indeed relate the conductance variance to structures of orbit pairs.

2. Orthogonal case

For tim e-reversal invariant system s, we must now consider pairs of orbits A, B di ering in encounters whose stretches are either close or almost mutually tim e-reversed. The sense of traversal of an orbit now being arbitrary we x the direction of B such that B traverses the \initial" link of A in the same direction.

We start with method I, i.e., we cut an orbit pair (A;B) inside links, rst inside the initial link and afterwards in an arbitrary link. We have to distinguish two cases, respectively leading to d- and x-quadruplets. First assume that the second cut is placed in a link traversed by A and B with the same sense of motion; see Fig. 8 or 10a. As in the unitary case we then obtain a d-quadruplet of trajectories; this quadruplet is highlighted by a grey \bubble" in Fig. 8




FIG.11: Sketches of orbit pairs (A; B) with one 2-encounter singled out. This 2-encounter contains the $\$ nal" encounter stretch, and is either (a) parallel in both A and B, (b) parallel in A and antiparallel in B, (c) antiparallel in A and parallel in B, or (d) antiparallel in both A and B.

and 10a, without depicting the encounters. Inside this quadruplet, is de ned as the trajectory following the cut through the initial link (marked by "1." in Fig. 8-11).

Now assume that the second cut is placed in a link traversed by A and B with opposite senses of motion. The resulting quadruplet, shown in the grey bubble in Fig. 10b, resembles an x-quadruplet, apart from the directions of motion. To obtain a true x-quadruplet, one has to revert the directions of motion of two trajectories in Fig. 10b, such that all trajectories point in the same direction as (i.e., the trajectory following the cut inside the initial link).

W e hence obtain the follow ing relation between orbit pairs and trajectory quadruplets: By cutting inside links, each of the N (*) structures of orbit pairs related to * can be turned into a fam ily of trajectory quadruplets in L (*) + 1 possible ways. Through such cuts, all N_d (*) d-fam ilies and all N_x (*) x-fam ilies are obtained exactly once, since each d- or x-fam ily could be inserted inside the bubble in Fig. 10a or 10b, respectively. We thus have

We now turn to method II (cutting inside 2-encounters). We consider orbit pairs A; B containing one more 2encounter compared with the quadruplets in question, assuming that the nalencounter stretch of the orbits belongs to the \added" 2-encounter; the number of these structures is N ($v^{[! 2]}$; 2). Cutting out the added 2-encounter will create all possible quadruplets associated to v, some of them, as we shall see, in several copies.

The added 2-encounter can be either parallel or antiparallel in the orbit A as well as in its partner B. This leads to four di erent possibilities, depicted by arrows on white background in Fig. 11a-d. First suppose that the encounter in question is antiparallel in both A and B, as in Fig. 11d. This is possible only if the ports of this encounter are connected in the same way in A and B, up to time reversal; one can easily check that all other connections would lead to either A or B decomposing into several disjoint orbits. The connections outside the encounter, as depicted in the bubble in Fig. 11d, thus resemble d-quadruplets and can be turned into true d-quadruplets if we revert the sense of m otion on some trajectories.¹¹ Any d-fam ily could be substituted for the bubble in Fig. 11d. Thus, cutting through 2-encounters of the kind in Fig. 11d produces all possible fam ilies of d-quadruplets.

¹¹ R ather than reverting directions of m otion, we could also identify the initial points of all trajectories inside the bubble with ingoing leads, and the nalpoints with outgoing leads, loosing the identi cation of the two sides of our bubble with the two openings of the cavity. This would entail a di erent m apping between orbit pairs and trajectory quadruplets, but not a ect the following results.

In the three other cases, F ig. 11a-c, the remaining connections have to be of type x, up to the sense of motion on some trajectories, since connections of type d would lead to decom posing orbits. To better understand these cases, it is helpful to view the corresponding x-quadruplets as a \dressed" 2-encounters. Then, the orbit pairs of F ig. 11a-c are topologically equivalent to the simple diagram s in F ig. 2. The orbit pair in F ig. 11a is of the type ppi whereas the pairs in F ig. 11b and c are both of the type api. (In F ig. 11b the initially parallel encounter is identi ed with the added encounter, and the initially antiparallel encounter is identi ed with the x-quadruplet, whereas the situation is opposite in F ig. 11c.) A ny fam ily of type x could be substituted for the bubbles in each of the F igs. 11a-c, and can therefore be obtained by cutting three di erent structures of orbit pairs.

We have thus seen that by cutting through 2-encounters of the N ($x^{[! 2]}$;2) structures of orbit pairs considered, we obtain each fam ily ofd-quadruplet once and once only, whereas each x-fam ily is produced by three di erent structures. We therefore have

In our approach transport properties phenom ena are related to trajectory pairs or quadruplets di ering in encounters; we showed that all topologically di erent fam ilies of pairs or quadruplets can be found using the corresponding structures of orbit pairs considered in the theory of spectral uctuations [9]. The number of structures to be considered grows exponentially with the order of approximation, and in absence of an analytic formula (in particular, for Ericson uctuations or crossover in a magnetic eld) can be evaluated only with the help of a computer. Here we describe an algorithm for the system atic generation of orbit pairs.

A sum e tim e-reversal invariant dynam ics, and let A be a periodic orbit and B its partner obtained by reconnections in a set of encounters associated to the vector $\mathbf{v} = (v_2; v_3; v_4; :::)$. Let us then number all the L = L (w) encounter stretches in A in order of traversal. Each encounter has two sides which can be arbitrarily named left and right such that the two ends of the i-th encounter stretch can be called its left. (i₁) and right (i_r) ports. The direction of traversal of the encounter stretches in A will be denoted by another vector ! = (1 2 ::: L). Here i is equal to 1 if the i-th stretch is traversed from the left to the right such that i₁ and i_r are its entrance and exit ports respectively, and equal to -1 in the opposite case. There can be 2^{L} di erent ~. How ever, only relative direction of motion within encounters is physically meaningful: we can, e.g., assume that the rst stretch of each of the V (w) encounters is passed from the left to the right. This leaves 2^{L} V physically di erent ~. Each orbit link connects the exit port of an encounter stretch of A with the entrance port of the follow ing stretch. Both of these ports can be left or right which makes four com binations possible, i_r ! (i+1)₁; i_r ! (i+1)_r; i₁ ! (i+1)₁; i₁ ! (i+1)₁, the sense of the link traversal in A being in all cases i ! i+1. These choices are uniquely xed by the vector ~.

In the partner orbit B the left port i_1 will be connected by an encounter stretch not with the right port i_r but with some other right port f (i)_r. The set of reconnections of all ports can be written as a permutation

in which the upper and lower lines refer to the left and right encounter ports, correspondingly. Since reconnections are possible only within encounters, P_{enc} must consist of as many independent cyclic permutations (cycles) as there are encounters in the orbit A, with each cycle of lelements corresponding to an l-encounter. The links of the orbit B are unchanged compared to A, but may be passed with the opposite sense. The orbit B may exist in two time reversed versions; we shall choose the one in which the encounter stretch with the port 1_1 at its left is passed from the left to the right. This choice made, the sequence of visits of all ports and the direction of traversal of all encounter stretches and links in B become uniquely xed by the permutation P_{enc} and the the vector ~. Indeed, let us start from 1_1 , move along the encounter stretch arriving at the right port f $(1)_r$ and then traverse the link attached. W here we move next in B depends on the ports connected by this link in the original orbit A:

- 1. $f(1)_r ! [f(1) + 1]_1$. The sense of traversal of the link in B is the same as in A. The next encounter stretch is traversed from the left to the right leading from the port $p_2^0 = [f(1) + 1]_1$ to $[f(p_2^0)]_r$.
- 2. $f(1)_r ! [f(1) + 1]_r$: The sense of traversal of the link in B is the same as in A. The next encounter stretch is traversed from the right to the left leading from $p_2^0 = [f(1) + 1]_r$ to $f^{-1}(p_2^0)_{-1}$, i.e., to the element of the upper row in P_{enc} corresponding to f(1) + 1 in the lower row.
- 3. [f(1) 1] ! f(1)_r : The link is traversed in B in the direction opposite to A leading from $f(1)_r$ to $p_2^0 = [f(1) 1]$. The next encounter stretch leads from the left port p_2^0 to the right port $[f(p_2^0)]_r$:
- 4. [f(1) 1] ! f(1)_r: The link is traversed in B in the direction opposite to A leading from $f(1)_r$ to $p_2^0 = [f(1) 1]$. The next encounter stretch leads from the right port p_2^0 to the left port $f^{-1}(p_2^0)_1$.

C ontinuing our way we eventually return to the starting port 1_1 . If that return occurs before all 2L encounter ports are visited the combination P_{enc} ; ~ has to be discarded since it leads to a partner consisting of several disjoint orbits, a so called pseudo-orbit. O there is we have found a structure of the periodic orbit pair (A;B) with the encounter set v and established the port sequence in B as well as the sense of traversal of all its links and encounter stretches. Running through all $L \models \begin{bmatrix} 1 & 2 \\ 1 & 2 \end{bmatrix} V_1 v_1!$ permutations associated to v and through all $2^L = V$ essentially di erent ~ we nd all N (v) structures of the orbit pairs.

Suitable cuts yield all trajectory doublets and quadruplets relevant for quantum transport. E.g., if we cut A and B in the initial link (i.e. in the link preceding the port 1_1) we obtain a trajectory pair contributing to the conductance; the numbers i_i ; needed for calculating conductance in a magnetic eld are obtained by counting the number of links and encounter stretches changing their direction in B compared with A.

The trajectory quadruplets contributing to the conductance covariance and other properties are obtained, in accordance with our method I (see Appendix A), by cutting the pair (A;B) twice, in the initial link and in any of the L orbit links producing thus L + 1 quadruplets per orbit pair. If the second cut goes through a link preserving its sense of traversal the result is a d-quadruplet, otherwise it is an x-quadruplet. (We remind the reader that in the last case the sense of traversal of the trajectories ; is changed to the opposite compared with the periodic orbits; this has to be taken into account in calculation of the transport properties in the magnetic eld.) Method II of producing quadruplets consists of cutting a 2-encounter out of the orbit pair (A;B) which is possible only if the encounter set v contains at least one 2-encounter, i.e. $v_2 > 0$; the resulting quadruplet will be characterized by the encounter set $v^0 = v^{[2!]}$.

The relatively trivial case when time reversal is absent can be treated by choosing i = +1; i = 1;:::;L (all encounter stretches are traversed from the left to the right, and all links are attached to the ports like $i_r !$ (i + 1)₁):

APPEND IX C:DIAGRAM MATIC RULES FOR ARBITRARY MULTIPLETS OF TRAJECTORIES

O ur sem iclassical techniques can be expanded to a huge class of transport problem s, for cavities with arbitrary numbers of leads, and observables involving arbitrary powers of transition matrices. We then have to evaluate (sum s of) general products of the type

Using the sem iclassical transition amplitudes (1), we express hZ i as a sum over multiplets of trajectories $_k$; $_k$ connecting channels as $_m$ $a_1^{(m)}$! $a_2^{(m)}$, $_m$ $a_1^{(m)}$! $a_2^{((m))}$,

Contributions to (C2) arise from multiplets of trajectories where $_1$;:::; $_M$ either coincide with $_1$;:::; $_M$, or dier from the latter trajectories only inside close encounters in phase space. hZ i thus turns into a sum over families of multiplets characterized by a vector v.

Proceeding as in Subsections IIC and IIIB, we represent the contribution of each family as a sum over the trajectories $_1$;:::; $_{M}$ and an integral over the density of stable and unstable coordinates,

here, w (s;u) is obtained by integrating f^L $V = V_{i=1}^{2} t_{enc}(s;u)g^{-1}$ over the durations of all links except the nallink of each of the M trajectories. Doing the sum over k with the Richter/Sieber rule, we not the same link and encounter integrals as before, and thus a contributions $\frac{1}{N}$ from each link and a contribution N from each encounter.

The same nule applies for products slightly dierent from (C1). First, if some of the channels $a_1^{(1)}$; :::; $a_1^{(M)}$ or some of the channels $a_2^{(1)}$; :::; $a_2^{(M)}$ coincide (as in many examples studied in the main part) some of the subscripts in (C1) will appear not twice but 4;6;8;:::times. We then have to consider all possible ways to pair these subscripts. In the spirit of W ick's theorem, each of these possibilities contributes separately. (Note that, if a subscript appears an odd number of times, the corresponding product cannot be related to multiplets of trajectories, and may be expected to vanish after averaging over the energy). Second, in the orthogonal case the two subscripts of one t or t in (C1) may be interchanged without a ecting the nal result; the corresponding trajectory is then reverted in time.

W ith these rules, one can evaluate a huge class of observables relevant for quantum transport. For each single application, only the counting of fam ilies remains to be mastered.

APPENDIX D:SPECTRAL STATISTICS REVISITED

We here want to reform ulate our previous results on spectral statistics [9] in the present language of diagram matic rules. In contrast to [9], we start from the level staircase N (E), de ned as the num ber of energy eigenvalues below E. N (E) can be split into a smooth local average \overline{N} (E) and an uctuating part N _{osc} (E) describing uctuations around that average. We want to study the two-point correlation function of N _{osc} (E)

To check on the last member of the foregoing chain of equations one must write the average h i inD(1) as an integral over the center energy E, take its second derivative by and integrate by parts the term s containing N ^{0}N in the integrand.

In the sem iclassical limit, G utzw iller's trace form ula determ ines N_{osc} (E) as a sum over periodic orbits A of arbitrary period T_A (E), N_{osc} (E) = $\frac{1}{2}$ Im $_{A}$ F_A e^{iS_A} (E); here, F_A depends on the stability matrix M_A and the M aslov index $_{A}$ of A as F_A = $\frac{p_{1}}{\frac{1}{\text{jdet}(M_{A}-1)j}}e^{i_{A}\cdot\overline{2}}$, and S_A (E) is the classical action of A at energy E. The correlation function C () turns into a double sum over periodic orbits A and B,

To evaluate the contribution to (D 2) resulting from a given structure of orbit pairs di ering in encounters (see Subsection IIC), we replace the sum over B by an integral over a density w (s;u) of phase-space separations inside A. Sim ilarly as for transport w (s;u) is de ned as the integral of $\frac{1}{L-v \cdot Q \cdot Q}$ over all piercing times; integration over the rst piercing time leads to multiplication with the orbit period, whereas the remaining integrals can be transformed into integrals over all link durations but one. Approximating $F_B = F_A$ and $T_B = T_A$, we nd

The multiplication with the orbit period is thus replaced by integration over the period or, equivalently, over the duration of the remaining link. Writing $T_A = \prod_{i=1}^{P} t_i + \prod_{i=1}^{V} t_i + \prod_{i=1}^{V$

We have thus rederived one of the main results of [9] in the elegant fashion suggested by the present work on transport.
