D oping-dependent evolution of low -energy excitations and quantum phase transitions within e ective model for H igh-T_c copper oxides

In this paper a m ean- eld theory for the spin-liquid param agnetic non-superconducting phase of the p-and n-type H igh-T_c cuprates is developed. This theory applied to the elective t t⁰ t⁰⁰ J m odel with the ab initio calculated param eters and with the three-site correlated hoppings. The static spin-spin and kinem atic correlation functions beyond H ubbard-I approxim ation are calculated self-consistently. The evolution of the Ferm i surface and band dispersion is obtained for the wide range of doping concentrations x. For p-type system s the three di erent types of behavior are found and the transitions between these types are accompanied by the changes in the Ferm i surface topology. Thus a quantum phase transitions take place at x = 0.15 and at x = 0.23. Due to the di erent Ferm i surface topology we found for n-type cuprates only one quantum critical concentration, x = 0.2. The calculated doping dependence of the nodal Ferm i velocity and the elective m ass are in good agreement with the experimental data.

I. IN TRODUCTION

D is covered alm ost 20 years ago, H igh-T_c copper oxides still rem ain a challenge of the m odern condensed m atter physics. It is not only due to unconventional superconducting state w ith a highest superconducting transition tem perature T_c ever observed. A lso they reveal evolution from an undoped antiferrom agnetic (AFM) insulator to an alm ost conventional, though highly correlated¹, Ferm i liquid system at the overdoped side of the phase diagram . B etw een these two regimes the system exhibits strongly correlated, or so-called \pseudogap" m etallic behavior up to an optim al doping concentration x_{opt} 0:16.

Recent signi cant improvements of experimental techniques, especially of the Angle-Resolved Photoemission Spectroscopy (ARPES) and the Scanning Tunneling Microscopy (STM), revealed many exciting features of this doping dependent evolution. First of all, the Fermi surface (FS) at low doping concentrations x has been measured². Together with the previous measurements on optimally and overdoped samples (see e.g. review³ and references therein), these observations provide a uni-

ed picture of the doping dependent FS, which changes from the \Fermi arcs"⁴ in the underdoped compounds to the \large" Ferm i surface in the overdoped system s. Though this change is smooth, it occurs around the optimal doping concentration. Also, the observed evolution is consistent with the Hallcoe cient R_H m easurem ents⁵.

The pseudogap behavior observed in ARPES is also tracked in the transport measurements. In particular, the resistivity curvature mapping over T \times phase diagram clearly demonstrates crossover between underdoped and overdoped regimes⁶. And the in-plane resistivity _{ab} shows T -linear dependence only around x_{opt}.

The drastic change of the quasiparticle dynamics around the optimal doping was found by the timeresolved measurements of the photoinduced change in re ectivity for $B_{2}Sr_{2}Ca_{1}$ y $Dy_{y}Cu_{2}O_{8+}$ (BSCCO)⁷. N am ely, the spectral weight shifts expected for a BCS superconductor can account for the photoinduced response in overdoped, but not underdoped BSCCO. This agrees with the observed di erence of the low-frequency spectral weight transfer in norm aland superconducting states on under- and over-doped sam ples^{8,9}.

M eanwhile, the integral characteristics of the system demonstrate more smooth behavior upon increase of the doping x. The dependence of the chem ical potential shift on x shows pinning at $x < x_{opt}$, and evolves sm oothly at higher doping concentrations¹⁰. The measured nodal Ferm i velocity v_F is almost dopingindependent within experimental error of 20% 11,12. The experiments involving combination of dc transport and infrared spectroscopy revealed an almost constant effective electron mass m = m = 3:8 2 in the underdoped and slightly overdoped La2 x SrxCuO4 (LSCO) and $YBa_2Cu_6O_v$ (YBCO)¹³. Low -x e ective mass dependence contradicts predictions of the Brinkm an-R ice metal-insulator transition theory¹⁴, predicting divergence of the m at the point of transition. One of the m ain drawbacks in this theory is that the magnetic correlations were neglected. Thus the discrepancy with the experim ent em phasizes the im portance of these correlations in High-T_c copper oxides.

From the theoretical point of view, the description of the crossover between alm ost localized picture and the Ferm i liquid regime is very di cult. Starting from the Ferm i liquid approach one m ay discuss the overdoped and, partly, optim ally doped region, while for underdoped and undoped sam ples this approach is not applicable. The strong-coupling G utzw iller approxim ation¹⁵ for the Hubbard m odel provides a good description for the correlated m etallic system. This approximation is equivalent^{16,17} to the mean-eld saddle-point solution within a slave-boson approach¹⁸. At the same time, as shown within 1=d expansion¹⁶, with d being the dim ensionality of the lattice, the Gutzwiller approximation is equivalent to the case of d = 1 . O by iously, for the quasitwo-dimensional systems such as H igh-T_c copper oxides this is not a proper limit. The same applies to the Dynamical Mean-Field Theory (DMFT)^{19,20}, which is exact only for d = 1 . In this limit the short-range magnetic uctuations are excluded. It is not a good starting point

for the system with long-range AFM order at low x and short-range AFM correlations in the underdoped region. To describe the doping dependent evolution of the low -

energy excitations we develop a strong-coupling meaneld theory for the param agnetic non-superconductive phase of High-T_c copper oxides starting from the local lim it. To go beyond the usual Hubbard-I approxim ation a self-consistently calculated static spin-spin and kinematic correlation functions are taken into account. W ithin this approximation in the framework of the e ective t $t^0 t^{00} J$ model with ab initio calculated param eters we obtain a doping-dependent evolution of the FS, e ective mass and nodal Ferm i velocity. The analysis of the low-energy excitations behavior for p-type cuprates yields two quantum phase transitions associated with the change of the FS topology. For n-type cuprates we observe only single quantum critical concentration. The key aspect in these ndings is an adequate description of the electron scattering by the short range magnetic uctuations accompanied by the three-site correlated hoppings.

The paper is organized as follows. In Section II the e ective model and the approximations are described. The results of the calculations for p-type cuprates are presented in Section III. A lso, the critical comparison of the t t^0 t^0 J and t t^0 t^0 J models is made, and the role of short range magnetic order is discussed. Section IV contains results for n-type cuprates. The last Section sum marize this study, and the main points are discussed.

II. MODELAND APPROXIMATIONS

High-T_c cuprates belong to a class of strongly correlated system s where the standard local density approximation (LDA) schemes and the weak-coupling perturbation theories yield an inappropriate results. To overcom e this di culty recently we have developed an LDA+GTB method²¹. In this method the ab initio LDA calculation is used to construct the W annier functions and to obtain the single electron and Coulomb parameters of the multiband Hubbard-type model. W ithin this model the electronic structure in the strong correlation regime is calculated by the Generalized Tight-Binding (GTB) m ethod^{22,23}. The latter com bines the exact diagonalization of the model H am iltonian for a sm all cluster (unit cell) with perturbative treatment of the intercluster hopping and interactions. For undoped and weakly doped LSCO and Nd_{2 x} Ce_xCuO₄ (NCCO) this scheme results in a charge transfer insulator with a correct value of the

gap and the dispersion of bands in agreement with the experimental ARPES data (see $Ref.^{21}$ for details).

Then this multiband Hubbard-type Ham iltonian was mapped onto an e ective low energy model1. Param eters of this e ective model were obtained directly from the ab initio parameters of the multiband model. The low-energy model appears to be the t t^0 t⁰⁰ J model (t t⁰ t⁰⁰ J model with the three-site correlated hoppings) for n-type cuprates and the singlet-triplet t t^0 t^{00} J model for p-type system s. How ever, for x < 0.7 in a phase without a long-range magnetic order the role of the triplet state and the singlet-triplet hybridization is negligible 24 . Therefore, the triplet state could be om itted and in the present paper we will describe the low-energy excitations in the single-layer pand n-type cuprates within the t t^0 t^{00} J m odel.

To write down the model H am iltonian we use the H ubbard X -operators²⁵: X_f \$ X_f^{n,n⁰} jnihn⁰j. Here index \$ (n;n⁰) enumerates quasiparticle with energy ! = "_n (N + 1) "_{n⁰} (N), where "_n is the n-th energy level of the N -electron system. The commutation relations between X -operators are quite complicated, i.e. two operators commute on another operator, not a c-number. N evertheless, depending on the di erence of the number of ferm ions in states n and n⁰ it is possible to de ne quasi-Ferm i and quasi-Bose type operators in terms of obeyed statistics. In this notations the H am iltonian of the t t⁰ t⁰ J m odel in the hole representation have the form :

In the notations of Ref.²¹ the hopping matrix elements t_{fg} corresponds to t_{fg}^{SS} and t_{fg}^{00} for p-and n-type cuprates, respectively, and $t_{fg} = t_{fg}^{0S}$. Ham iltonian H₃ contains the three-site interaction term s:

There is a simple correspondence between X -operators and single-electron annihilation operators: $a_f =$ ()X_f, where the coe cients () determines

the partial weight of the quasiparticle with spin and orbital index . These coe cients are calculated straightforwardly within the GTB scheme. In the considered case there is only one quasi-Ferm i-type quasiparticle, = (0;), w ith () = 1, and the Ham iltonian in the generalized form in momentum representation is given by:

The Fourier transform of the two-time retarded G reen function in the energy representation, G ($\tilde{\kappa}$;E) = $a_{\kappa} a_{\kappa}^{Y}$, can be rewritten in terms of the ma h i DD EEtrix G reen function $\hat{D}(\tilde{\kappa};E) = X_{\kappa} X_{\kappa}^{Y} E$:

The diagram technique for Hubbard X-operators has been developed^{26,27} and the generalized Dyson equation²⁸ in the param agnetic phase (hX₀' i = X₀') reads:

Here, \hat{G}_0^{-1} (E) is the exact local Green function, G_0 (E) = = [E ($"_n ~"_n \circ$)], \hat{K} ; E) and \hat{P} (K; E) are the self-energy and the strength operators, respectively. The presence of the strength operator is due to the redistribution of the spectral weight between the H ubbard subbands, that is an intrinsic feature of the strongly correlated electron system s. It also should be stressed that \hat{K} ; E) in Eq. (5) is the self-energy in X -operators representation and therefore it di ers from the self-energy entering D yson equation for the weak coupling perturbation theory for G (K; E).

W ithin Hubbard-I approximation²⁹ the self-energy (k;E) is equal to zero and the strength operator P(k;E) is replaced by P(k;E)! P = F, where $F_{(n;n^0)} = X_f^{n;n} + X_f^{n^0;n^0}$ is the occupation factor. Taking into account that in the considered param agnetic phase $X_f' = \frac{1 \times 2}{2}$, $X_f^{0;0} = x$, with x being the doping concentration, after all substitutions and treating all k-independent terms as the chem ical potential renorm alization, the generalized D yson equation for the Ham iltonian (1) becomes:

To go beyond the Hubbard-I approximation we have to calculate $(\tilde{\kappa}; E)$. For this purpose we use an equations of motion method for the X -operators³⁰. The exact equation of motion for X_k is:

Here N is the number of vectors in momentum space.

Until now we have made two major approximations. First, we neglected irreducible part of the self-energy, $\Gamma_{\kappa}^{(irr)}$, thus allowing quasiparticles to have in nite lifetime. Second, and this is not so obvious, in Eq. (6) for the strength operator $\hat{P}(K;E)$ we drop out corrections beyond Hubbard-I approximation. These dropped corrections also lead to the nite quasiparticle lifetime. The consequence of these approximations will be discussed later.

K inem atic correlation functions (12) are calculated straightforwardly with the help of G reen function (6). The spin-spin correlation functions for the t J m odel with three-site correlated hoppings H₃ were calculated in Ref.³¹. In this paper the equations for the spin-spin G reen function $X_f X_g$ were decoupled in the rotationally invariant quantum spin liquid phase, sim ilar to Refs.^{32,33}. The results of this approach for a static magnetic susceptibility for the t J m odel are sim ilar to those obtained by other m ethods^{34,35}. Higher-order correlation functions appearing due to the H₃ term are decoupled in the follow ing way:

Thus, higher-order kinematic and spin-spin scattering channels are decoupled.

A fler the term sproportional to x $2t_{01}=E_{ct}^{2}$ being neglected, the expression for Fourier transform of the spinspin G reen function becomes:

and m agnetic excitations spectrum $!_q$ represented by the Eq. (26) of paper³¹.

The following results were obtained by self-consistent calculation of the chemical potential, the spin-spin correlation functions (11) using G reen function (14), and the kinematic correlation functions (12) using G reen function (6) with the self-energy (13).




FIG.1: (color online) The quasiparticle dispersion (on the left) and the density of states (DOS, on the right) in the param agnetic phase of p-type cuprate with x = 0.16. The position of the chem ical potential is denoted by the horizontal (green) line. Results within the H ubbard-I approxim ation are shown by dashed (red) and dash-dotted (cyan) curves for the m odel with (t t ⁰ t ⁰⁰ J m odel) and without (t t ⁰ t ⁰⁰ J m odel) three-site correlated hoppings, respectively. Bold solid (blue) curves represent the results for the t ⁰ t ⁰⁰ J m odel with the short range m agnetic order.

III. RESULTS FOR p-TYPE CUPRATES

For LSCO the LDA+GTB calculated parameters are (in eV): t = 0.93; $t^0 = 0.12$; $t^{00} = 0.15$; J = 0.295; $J^0 = 0.003$; $J^{00} = 0.007$. All gures below are in electron representation.

First of all we would like to stress the important e ects caused by the three-site correlated hoppings H $_3$ and the renorm alizations due to the short range m agnetic order. P reviously, the importance of the three-site correlated hoppings in the norm aland superconducting phases has been dem onstrated in Refs.^{31,36,37}. In Fig. 1 we present our results for 16% hole doping within di erent approximations. Evidently, introduction of three-site interaction term s results in the change of the position of the top of the valence band. Therefore, this will become important at small x. In AFM phase of the t J model there is a symmetry around (=2; =2) point. In the paramagnetic phase this symmetry is absent. Due to the scattering on the short range magnetic uctuations with AFM wave vector Q = (;) the states near the (;) point are pushed below the Ferm i level (see Fig.1), thus totally changing the shape of the FS. In other words, the short range m agnetic order \tries" to restore the sym metry around (=2;=2) point. In our calculations the short range m agnetic uctuations are taken into account




FIG.2: (color online) D oping dependent evolution of the kinematic (a) and spin-spin (b) correlation functions within the t t 0 t 0 J model for p-type cuprates. Index n enumerates real space vectors connecting neighboring sites: n = 1 for nearest-neighbors, n = 2 for the next nearest neighbors, and so on. In (c) and (d) the doping dependence of the nodal Ferm i velocity (in units of eV a with a being a lattice constant) and the e ective mass are shown.

via the spin-spin correlation functions (11).

Our results for the doping dependence of the kinem atic and spin-spin correlation functions are shown in Fig. 2. Note, the kinematic correlation functions K_n possess a very nontrivial doping dependence. For low concentrations, x < 0.15, due to the strong magnetic correlations the hoppings to the nearest and to the next-nearest neighbors are suppressed leading to the small values of K_1 and K_2 , while K_3 is not suppressed. Upon increase of the doping concentration above x 0:15, m agnetic correlations decrease considerably and nearest-neighbor kinem atic correlation function K $_1$ increase. Next m a jor 0:23 when the system possesses alchange sets at x m ost Ferm i liquid behavior: K₁ becom es largest of all K $_{n}$'s, while the magnetic correlation functions C $_{n}$ and the kinem atic correlation function K₃ are strongly suppresæd.




FIG.3: (color online) Band structure (on the left), density of states (in the middle), and Fermi surface (on the right) evolution with doping concentration x within thett $^{\circ}$ t $^{\odot}$ J m odel for p-type cuprates.

So, we can clearly de ne two points of the crossover, 0:23. The system behavior is namely x 0**:**15 and x quite di erent on the di erent sides of these points, although there is no phase transition with sym m etry breaking occurs. To understand the nature of these crossovers we consider the FS evolution with doping concentration, presented in Fig.3. At low x the FS has the form of the hole pockets centered around (=2; =2) point. Then these pockets enlarge and at x = 0.15 all of them m erge together, form ing the two FS contours. Up to x = 0.23the FS topologically equivalent to the two concentric circles with the central one shrinking toward (0;0) point. For x = 0.23 the central FS contour shrinks to the single point and vanishes, leaving one large hole-type FS.

A pparently, the topology of the FS changes drastically

upon doping. In particular, it happens at x = 0.15 and at x = 0.23. For the string time the velectronic transition" accompanying the change in the FS topology, or the socalled Lifshitz transition, was described in Ref.³⁸. Now such transitions referred as a quantum phase transitions with a co-dimension= 1 (see e.g. paper³⁹). Note, when the FS topology changes at quantum critical concentrations $x_1 = 0.15$ and at $x_2 = 0.23$ the density of states at the Ferm i level also exhibit signin cant modin cations. This results in the dimension functions on the dimensity of states at the Ferm i level will also result in the significant changes of such observable physical quantities as the resistivity and the specin cheat.

A lso, from the obtained quasiparticle dispersion we calculated the doping dependence of the nodal Ferm ivelocity v_F and the elective mass m = m (see Fig. 2 (c) and (d)). Nodal Ferm ivelocity does not show steep variations with increase of the doping concentration in agreement with the ARPES experiments^{11,12}. Elective mass m increase with decreasing x and reveals tendency to the localization in the vicinity of the metal-insulator transition. But this increase is not very large and overall m = m doping dependence agrees quite well with the experimentally observed one¹³. Note, the non-monotonic doping dependence of both these quantities relects the presence of the critical concentrations x_1 and x_2 .




FIG.4: (color online) The same as in Fig2, but within the model for p-type cuprates without three-site correlated hoppings (t t $^{\circ}$ t $^{\circ}$ J model).




FIG.5: (color online) The same as in Fig.3, but within the model for p-type cuprates without three-site correlated hoppings (t t $^{\circ}$ t $^{\circ}$ J model).

To analyze the e ect of the three-site hopping term H_3 we also calculated the doping dependence of the band structure and FS within the t t^0 t^0 J model. The behavior of the kinem atic and the spin-spin correlation functions, presented in Fig. 4, is quite di erent from that of the t t^0 t^0 J model. There is only one quantum critical point at x 0.08 and the e ective m ass becomes very large for x approaching zero. For x > 0.1 the evolution of the FS and density of states near the Ferm i level is smooth, without signi cant changes (see Fig.5). Most part of the di erence to the t t^0 t^{00} J model stem s from the role of H₃ in the energy of states near the (;) point, thus determ ining the topology of the FS and the physics at low doping concentrations (see Fig.1).




FIG.6: (color online) The same as in Fig.2, but within the t t $^{\circ}$ t $^{\circ}$ J model for n-type cuprates.




FIG.7: (color online) The same as in Fig.3, but within the t t $^{\circ}$ t $^{\circ}$ J model for n-type cuprates.

IV. RESULTS FOR n-TYPE CUPRATES

Now let us consider n-type cuprates within the t t^0 t^0 J model. For NCCO the LDA+GTB calculated parameters are (in eV):t = 0:50; t^0 = 0:02; t^0 = 0:07;J = 0:195;J^0 = 0:001;J^0 = 0:004.

The obtained doping dependence of the kinematic and magnetic correlation functions presented in Fig. 6. There is only one crossover point at x = 0.2. Also, in contrast

to the p-type results, the most important kinem atic correlation function on the left of this point is K₂, rather than K₃. For x > 0.2 the system demonstrates Ferm i liquid-like behavior with magnitude of kinem atic correlation function decreasing with the distance, and sm all values of the magnetic correlations.

The role of the short range m agnetic order and threesite hopping term s in n-type cuprates is similar to that of p-type. In particular, due to the scattering on the m agnetic excitations the states near the (;) point pushed above the Ferm i level, and the local symmetry around the (=2; =2) points is restored, reminding of the shortrange AFM uctuations (see Fig. 7).

Instead of hole pockets around the (=2;=2) point in p-type, here at low x the electron pockets around ;0) and (0;) points are present. Upon increase (of the doping concentration these pockets become larger and m erge together at x = 0.2. For higher concentrations the FS appear to be a large hole-like one, shrinking toward (;) point. Therefore, no other changes in the FS topology other than at x = 0.2 are present. Referring to the same argum ents as in previous section, we claim that in our approach there is only one quantum critical point at $x_n = 0.2$ in the n-type cuprates. Th non-monotonic change of the e ective mass and the nodal Ferm i velocity is also present at this concentration, as evident from Fig. 6(c) and (d).

V. DISCUSSION AND SUMMARY

To summarize, we have investigated the dopingdependent evolution of the low-energy excitations for pand n-type H igh-T_c cuprates in the regime of strong electron correlations within the sequentially derived e ective model with the ab initio parameters. We show that due to the changes of the Ferm i surface topology with doping the system exhibits drastic change of the low -energy physics. N am ely, for p-type cuprates there exist two critical concentrations, x_1 0:15 and x_2 0:23. A long the di erent sides of these concentrations the behavior of the density of states near the Ferm i level, of the kinem atic and m agnetic correlation functions, of the e ective m ass and the nodal Ferm i velocity, is drastically di erent. This let us speak about crossover, or, taking into account the accompanying FS topology changes, about quantum phase transitions at these quantum critical concentrations.

For n-type cuprates due to the speci $c\,F\,S$ topology we obtain only one quantum critical concentration, $x_n \qquad 0.2$.

F irst of all, we would like to comment on the approximations made in this work. Since we use the perturbation theory with hopping t and exchange J as small parameters, appropriate for the strongly correlated regime, the real part of the corrections to the results obtained will be small to the extent of smallness of the higher powers of t= E_{ct} and J= E_{ct} . This will result in the small changes of the band dispersion and in the medetails of the FS,

not changing anything qualitatively.

M ore concerns give the in aginary part of the neglected corrections to the strength operator $\hat{P}(\tilde{K}; E)$ and to the self-energy ^ (k;E) through $\Gamma_{\kappa}^{(irr)}$. Application of the equation of motion decoupling method to the Hubbard model with nite quasiparticle lifetim d^0 reveals that the results of the mean- eld-like approximation is qualitatively correct. Quantitatively, at low doping the imaginary part of the self-energy leads to the hiding of the FS portions above the antiferrom agnetic Brillouin zone ((;0) (0;) line). This results in Fermi arc rather than hole pockets at $x < x_{opt}$ (see Fig. 3). A lso, we can com pare our results to the num erical m ethods, nam ely, to the exact diagonalization studies⁴¹. The quasiparticle dispersion of the t t^0 J m odel in R ef.⁴¹ can be considered as consisting of two bands. For p-type cuprates intensities of the spectral peaks corresponding to the band situated mostly above the Ferm i level (in electron representation) are very low. This band is often called a \shadow " band and appears due to the scattering on the short range AFM uctuations. Notably, our band dispersion from Figs. 3 and 7 reproduce very well the shape of the other, \non-shadow ", band. It is this band where the most part of the spectral weight is residing, thus determ ining most of the low-energy properties, except for such subtle e ects as a so-called \kink " in dispersion¹¹.

A lso, all renorm alizations not included in consideration will change the values of the critical concentrations x_1 , x_2 , and x_n . Comparing with the results of a more rigorous theory in paper⁴⁰, we expect these values to decrease.

Thus we conclude that our theory captures the most im portant part of the low -energy physics within the considered (and justi ed for cuprates) model. This claim is supported by the qualitative agreem ent with the critical concentrations of crossover observed in the transport experim ents^{5,6} and in the optical experim $ent^{7,8,9}$, and even quantitative agreem ent of the doping dependence of the nodal Ferm i velocity and of the e ective mass^{11,12,13}. Although we use a simple mean-eld theory, though strong-coupled, the agreem ent with the experim ents is not surprising since we included all necessary for High-T_c copper oxides ingredients. Namely, the short range m agnetic order and three-site correlated hoppings. Form er is the intrinsic property of the cuprates exhibiting long range AFM order at low x, while latter results from the sequential derivation of the low -energy e ective m odel.
