H om ogenization of m em brane and pillar photonic crystals

Abstract

W e study wave propagation and di raction in a bidim ensional photonic crystal with nite height, in case where the wavelength is large with respect to the period of the structure. The device is made of materials with an isotropic permittivity and permeability tensors. We derive rigorously the hom ogenized system, using the concept of two-scale convergence. The elective permittivity and permeability tensors turn out to be that of a two-dimensional photonic crystal with in nite height.

Photonic crystals, i.e. dielectric or metallic arti cial periodic structures, are generally thought of as strongly scattering devices, authorizing the existence of photonic band gaps. However, their actual electrom agnetic behavior when the wevelength is large with respect to the period is also interesting, because it can produce strongly anisotropic behaviors, plasm on frequencies, or even left-handed materials [1, 2]. The study of the properties of these structures in this asymptotic regime comes under the theory of hom ogenization [3]. A bt of results are by now very well-known both for 2D and 3D structures. In this paper, we consider a photonic crystal made of a collection of parallel nite-size bers embedded in a matrix. This covers the case of structures made out of a layer of bulk materials in which holes are m ade periodically (m em brane photonic crystal) but also the case of structures m ade out of nanopillars (pillar photonic crystal [4, 5, 6, 7, 8, 9]), or more generally, structures composed of bers with nite length embedded in a matrix. Our point is to derive the e ective permittivity and permeability tensors of this structure when the ratio between the period of the structure and the wavelength of the incident eld is very small. We show, using the two-scale convergence method, that the e ective, or hom ogenized, permittivity and permeability tensors of these structures are the same as that of in nitely long bers, for which we had already derived rigorous results [10]. For in nitely long bers, explicit form ulas can be derived in som e cases [3, 11, 12, 13]. Let us note that our results hold for dispersive and lossy materials.

The set of bers is contained in a dom ain = 0 [L;L] of R³ (cf. g.l). The space coordinates are denoted: $x = (x_1;x_2;x_3)$ and we also denote $x_7 = (x_1;x_2)$. The period of the lattice is denoted by (see g. 2). We denote by Y the basic two-dimensional cell of the lattice. The obstacle in Y is denoted by P. We consider time harm onic elds, the time dependence is chosen to be exp (i!t). For a given monochromatic incident eld (Eⁱ;Hⁱ), we denote by (E;H) the total electrom agnetic eld. Our aim is to pass to the limit ! 0 and determ ine the limit of the couple (E;H). In our methodology, we get at the limit a true electrom agnetic scattering problem, for a given wavelength and a bounded obstacle characterized by som e permittivity and permeability tensors. This situation is quite di erent from other hom ogenization techniques, making use of periodization conditions, in which the frequency tends to zero, thus not leading to a di raction problem but rather to an electrostatic one [14]. Such an approach can som etim es give useful explicit form ulas but generally leads to com plicated form ulations. M oreover, it does not handle the boundary e ects which in some cases may lead to some m is comprehensions [15]. The relative permittivity tensor " (x) and relative permeability tensor (x) are described by : 8

where $y ! "^{0}(y) = "^{0}_{ij}(y)$ and $y ! ^{0}(y) = ^{0}_{ij}(y)$ are Y-periodic 3 3 matrix functions. The domain is periodically led with contracted cells Y [L;L] (see g. 2).

The total electrom agnetic eld (E ; H) satis es

and (E Eⁱ; H Hⁱ) satis es Silver-Muller radiation conditions.

In order to describe this problem, we will rely on a two-scale expansion of the elds. That way, the physical problem is described by two variables: a macroscopic one x and a microscopic one y representing the rapid variations of the material at the scale of one basic cell, measured by , that is, at the scale of Y. By noticing that there are no rapid variations in the vertical direction x_3 , the microscopic variable is set to be: $y = x_2 = .$ D i erential operators with respect to variable y are denoted with a subscript y. The elds are periodic with respect to that microscopic variable (this corresponds to the neighborhood of the point in the rst B rillouin zone). The limit problem obtained by letting tend to 0, will then depend on them acroscopic, physical, variable x but also on them icroscopic, hidden, variable y. The total limit elds will read E⁰ (x; y) and H⁰ (x; y) and the observable, physical, elds will be given by the mean value over the hidden variable y: E (x) = $jt j_{x}^{1} = 0$ (x; y) dy and H (x) = $jt j_{x}^{1} = 0$ (x; y) dy, where jt j is the measure area of Y. In order to lighten the notations, we denote by brackets the averaging over Y, hence H (x) = hH⁰ i and E (x) = hE⁰ i.

The main mathematical tool that we use is a mathematically clean version of the multiscale expansion, widely used in various areas of physics. More precisely, for a vector eld F in $(L^2())^3$, we say, by de nition, that F two-scale converges towards F^0 if for every su ciently regular function (x;y), Y-periodic with respect to y, we have:

as tends to 0.

The limit eld F^0 is square integrable with respect to both variables x and y and is Y-periodic in the y variable (it belongs to L^2 ; $L^2_{\#}$ (Y)³). A complete analysis of this new mathematical tool can be found in [16].

W e m ake the physically reasonable assumption that the electrom agnetic energy remains bounded when tends to 0, which is equivalent to assume that (E ;H) are both locally square integrable. Then it is known [16] that (E ;H) two-scale converges towards lim it elds (E 0 ;H 0). This physical assumption could be justiled m athematically, however it seems quite obvious, from the point of view of physics, that the lim it elds exist. The point is then to give the system of equations that is satisfied by these elds and to derive the elds ective permittivity and permeability tensors.

First of all, we have to determ ine the set of equations that are m icroscopically satis ed, that is, satis ed with respect to the hidden variable y, for that will give the constitutive relations of the hom ogenized m edium. Multiplying M axwell+Faraday equation by a regular test function $x; \frac{x_2}{x_1}$, and integrating over , we obtain:

Multiplying by and letting tend to 0, we get using (3): ZZ

which is nothing else but the variational form for: $\operatorname{curl}_{y} E^{0} = 0$. In a very similar way, but using now Maxwell-Ampere equation, we get the equation: $\operatorname{curl}_{y} H^{0} = 0$. On the other hand, since "E is divergence free, we have, for every test function (x;y), R " (x)E (x): $r_{x} + \frac{1}{r}r_{y}$ dx = 0. Multiplying by and letting tend to 0, we get: ZZ " (y)E⁰ (x;y) r_{y} dxdy = 0; (7)

this can be written as (notice that the div, operator acts only on the transverse components):

Similarly, since the magnetic eld is divergence free, we derive:

Sum m ing up, we have the follow ing m icroscopic equations, holding inside the basic cell Y :

The system s in (10) are respectively of electrostatic and m agnetostatic types. This means that, with respect to the hidden variable y, the electric eld and m agnetic eld satisfy the static M axwell system. This property is true only at that scale and not at the m acroscopic scale. However, it is these static equations that determ ine the electric eld. From the curl relation, we get r $_{y}E_{3}^{0} = 0$, and so $E_{3}^{0}(x;y) = E_{3}(x)$. Besides, the basic cell having the geometry of a torus, we get the existence of a regular periodic function $w_{E}(y)$ such that:

The function w_E is the electrostatic potential associated with the m icroscopic electrostatic problem. Inserting (11) in equation (8) and projecting on the two horizontal axis, we obtain:

By linearity, denoting $E_2 = (E_1; E_2)$, we derive that the potential w_E is given by $w_E = E_1 w_{E_1;1} + E_2 w_{E_2;2}$, where $w_{E_2;1}$ are the periodic solutions of (12). Thus by (11):

The magnetic eld H⁰ can be handled in the same way since it satisfies exactly the same kind of equations as H⁰ (see (10)). In particular, we may represent its tranversal component in the form : H⁰₂ = H₂ + r₂ w_H, where w_H is a periodic magnetic potential (the possibility

of this representation is due to the curl-free condition which means that no microscopic current is present). Analogously as in (13,14), we nd:

The above results show that, at them icroscopic scale, the limit elds (E^{0} ; H^{0}) are completely determined by the physical elds (E; H). Now that the microscopic behavior is precised, we are able to determine the macroscopic system satis ed by (E; H). To that aim, let us choose a regular test function (x) independent of variable y. From M axwell equations we get

Recalling that $hE^{0}i = E$ and that $hH^{0}i = H$, we get:

which, taking into account (13,15), brings to the lim it system :

The hom openized permeability and permittivity tensors are thus respectively h 0 M i and $h^{\mu 0}$ Ei. It appears here that the hom ogenization process is purely local, and that the niteness of the bers does not play any role in the hom ogeneous properties of the medium : the e ective tensors coincide with that obtained in the polarized cases [3, 10, 17]. This surprising property is easily foreseen by ourm ethodology. An approach relying on explicit calculations, for instance using B loch-waves theory or Fourier-Bessel expansions, cannot work here, due the lack of an explicit representation of the elds in case of nite size bers. It should also be noted that the case of materials with losses is handled by our result. This result can be straightforwardly applied to the study of mem brane photonic crystal in the long wavelength range where phenomena of birefringence and dichroism are obtained [18]. However, we en phasize that the locality pointed out, that is, the fact the elective constitutive relations are local ones, is lost if we change the scale of the permittivity coe cients in the obstacles. In particular, the results obtained in the case of in nite conductivities in the polarized case [10] cannot be transposed to the case of bers with nite length, due to the emergence of surprising non local e ects which are studied in [21, 22]. We also remark that the situation that we handle here is di erent from that studied in [20] where the small parameter is the depth over wavelength, while the period over wavelength ratio is not small, contrarily to our situation. In that case, a dependence on the depth is found. In our hom ogenization result, it is clear that the main num erical problem is the solving of the annex problem s (12,17)for they give the e ective matrices E and M . In certain simple cases, for instance that of circular isotropic non magnetic rods and a permittivity constant in each connected region, it is possible to nd an explicit expression for the e ective permittivity (it is in fact a very old problem). However, form ore complicated geom etries, there is a general num erical procedure based on ctitious sources, that allows to solve both annex problem s at a low num erical cost [23].

- (b) Bidim ensional basic cell Y with 2D obstacle P.




