Theory of quasiparticle spectra for Fe, Co, and N i: bulk and surface

The correlated electronic structure of iron, cobalt and nickel is investigated within the dynam ical m ean-eld theory form alism, using the new ly developed full-potential LM TO-based LDA+DM FT code. Detailed analysis of the calculated electron self-energy, density of states and the spectral density are presented for these m etals. It has been found that all these elements show strong correlation e ects form a prity spin electrons, such as strong dam ping of quasiparticles and form ation of a density of states satellite at about 7 eV below the Ferm i level. The LDA+DM FT data for fcc nickel and cobalt (111) surfaces and bcc iron (001) surface is also presented. The electron self energy is found to depend strongly on the number of nearest neighbors, and it practically reaches the bulk value already in the second layer from the surface. The dependence of correlation e ects on the dimensionality of the problem is also discussed.

Introduction

The late 3d m etals iron, cobalt, and nickel and their com pounds are vital for nearly all elds of technology. The E arth core is believed to be com posed predom inantly of iron. It is ironic that in the early 21-st century we still lack a com plete understanding of these m etals. P roperties of \normal" (weakly correlated) solids are described quantitatively by density functional theory $(D FT)^{1,2}$ in the local density (LDA) or generalized gradient (GGA) approxim ations. Not only DFT provides the ground state properties, but in m any cases it also gives a rather good description of excitation spectra in terms of K ohn-Sham quasiparticles. The concept of quasiparticles originates from Landau's Fermi liquid theory and for weakly correlated solids the quasiparticles (electrons and holes) are well de ned in a wide energy range.

Fe, Co and Ni, how ever, are more correlated system s. They have partially led shells of fairly localized 3d electrons. These electrons form a narrow d-band, and their behavior shows signs of both atom ic-like and freeelectron-like behavior^{3,4} . In strongly correlated system s the quasiparticle picture breaks down, except in a close vicinity of the Ferm i surface. Quasiparticles often have short lifetim es and therefore are not well de ned, and in m any cases incoherent features such as Hubbard bands and satellites appear in excitation spectra^{5,6}. LDA and GGA typically fails for this class of systems and their theoretical description remains a great fundam ental challenge. In particular, LDA and GGA give rather good m agnetic m om ents for Fe, Co, and Ni, but failto describe their electronic structure adequately. In particular, photoem ission experiments for these metals 7,8,9 demonstrate that LDA/GGA calculations give too wide majority spin 3d band, overestim ate the spin splitting and fail to reproduce the 6 eV satellite in nickel, an essentially incoherent feature. Som e other theoretical m ethods are needed to

properly describe the electronic structure of Fe, C $\rm o$ and N i.

One of the successful schemes for correlated electron system s is the Dynam ical Mean-Field Theory (DMFT), which replaces the lattice problem with a problem of a single correlated site in a self-consistent bath (impurity problem). It has been originally developed for the Hubbard $m \operatorname{odel}^{5,10,11}$. Being W the bandwidth and U the Coulomb interaction, the DMFT catches the main features of weakly (W U), interm ediate (W U) and strongly (W U) correlated regim es, and becom es exact in the lim it of in nite dimensions. The crucial point of the DMFT is in the solution of the self-consistent im purity problem. The choice of the DMFT \solver" for a given system is always a comprom ise between generality, accuracy and e ciency. There exist both num erically exact solvers (quantum M onte-C arb, exact diagonalization) which can in principle be applied to all system s, and approxim ate solvers with lim ited area of applicability but high e ciency, such as the Spin Polarized T -m atrix Fluctuation exchange (SPTF) solver 12 for the case W . U .

Although DMFT was designed originally for the Hubbard model, it can be combined with LDA to describe realistic m aterials with a local electron correlation. This approach, known as LDA+DMFT^{6,13,14} is at present the most universal practical technique for calculating the electronic structure of strongly correlated solids. LDA + DMFT has been successfully applied to various in portant problem s, including, e.g., the electronic structure of manganese¹⁵, $-Pu^{16,17}$, the { transition in cerium¹⁸ and the m etal-insulator transition in $V_2 O_3^{19}$. D espite all success stories of LDA + DM FT, the method is still less than a decade old and at a stage of active developm ent. M ost available in plem entations apply som e drastic sim pli cations to the LDA + DMFT form alism . In particular, m any LDA + DMFT codes are based on atom ic sphere approximation (ASA)-based LDA codes (LMTO-ASA¹³ or




FIG.1: (Color online) Im aginary part of the self energy Im (+ i0) for bcc iron, majority spin for orthogonalized LM TO (ORT) and mu n-tin-only (MT) correlated subspaces. Two di erent temperatures are considered: T = 400 K and T = 1500 K.

KKR-ASA²⁰). These schemes might work well for closepacked crystal structures, but they are insu cient for open structures and low-dimensional geometries. However, until recently, the only all-electron full-potential LDA+DMFT in plementation has been the one based on the full-potential LMTO code LMTART of Savrasov¹⁶.

The goal of this paper is to investigate the correlated electronic structure of bulk and surface of iron, cobalt and nickel using the new full-potential LDA+DMFT code BRIANNA. Although iron and nickel have been previously investigated using ASA-based LDA+DMFT codes4,12,21, no full-potential results have been published. The LDA + DMFT spectral density of nickel has never been published, while for cobalt only three-body scattering approximation²² data are available, but no LDA+DMFT results. Further, and most importantly, LDA + DMFT methods have not been previously applied to transition metal surfaces. Now, with the present full-potential LDA + DMFT scheme available, we want to check how the correlation e ects depend on the dimensionality of the problem . We address for nickel and cobalt (111) surfaces and iron (001) surface in this paper, as exam ples.

This paper is organized as follows. In chapter I we present the LDA+DMFT formalism in its most general form following a discussion of the basis set problem in Refs23,24. Chapter II introduces our full-potential LDA+DMFT in plementation BRIANNA.Results of our calculations are presented in chapter III, which is followed by the conclusion.




FIG. 2: (Color online) Im aginary part of the self energy for bcc iron, m inority spin for two di erent correlated subspace (M T and ORT orbitals) and two di erent tem peratures (T = 400 K and T = 1500 K).




FIG .3: Realpart of the self energy for bcc iron (M T orbitals, T = 1500 K).

I. LDA + DM FT M ETHOD

A. Correlated subspace

The LDA+DM FT m ethod de nes a "correlated subspace" f \Re ; ig of the strongly correlated orbitals \Re ; i, where R stands for the B ravais lattice site and the quantum number speci es the correlated orbitals within the unit cell. W ithin this subspace the m any-body problem is solved in a non-perturbative m anner using DM FT. All remaining states of the crystal are assumed weakly correlated and treated within LDA. For sim plicity, we can always choose correlated orbitals to be orthogonal and norm alized hR 1; $1\Re_2$; $2i = R_1; R_2 = 1; 2$.

Results of a LDA+DMFT calculation depend on the choice of the correlated orbitals. The correct form of \Re ; i is dictated by physical considerations for each par-




FIG. 4: (Color online) Density of states of bcc iron (LDA+DMFT with MT correlated orbitals at T = 400 K vsLDA).

ticular problem 23,24,25 . U sually the correlated orbitals are derived from d or f atom ic states. In this case stands for site (within unit cell) and atom ic quantum numbers l;m; . In early LDA+DMFT in plementations \Re ; i's were taken as orthogonalized m u n tin orbitals (M TO's). A part from the technical sim plicity, how ever, there is no reason for making such a choice. In particular, orthogonalized M TO's are poorly localized in real space (due to orthogonalization) and they don't have pure lm character (due to tail cancellation and orthogonalization). Besides, such choice of f \Re ; ig de facto restricts the LDA part of the LDA+DMFT code to m u n-tin based m ethods (LM TO, NM TO, KKR) with a mini-

m albasis set. Now adays other choices, such as W annierlike orbitals 23,25 are investigated. Apart from atom ic states, the correlated orbitals \Re ; i can be chosen as hybridized orbitals (possibly describing covalent bonds) if dictated so by the physical problem . Som etim es the LDA Ham iltonian is downfolded in order to include only correlated degrees of freedom (such as d-states or even t_{2q} or e_q states). This results in a very time e cient DMFT im plem entation, how ever this approach cannot be used to study the hybridization between sp-electrons and the correlated ones, which is important, e.g., for the superexchange interaction. In this section, we present the LDA+DMFT formalism in a more general form, without making any restrictions on the choice of the correlated subspace f R; ig or the basis set used by the LDA part of the code. We are going to return, however, to the question of choosing the correlated subspace in the section describing our im plem entation.

In LDA a solid is described by the one-particle K ohn-Sham equation

where the LDA H am iltonian H $_{\rm LDA}$ has one-electron form

with h_{LDA} acting in the Hilbert space of one-electron states in a periodic crystal, and the index i numbering all electrons in the crystal. The LDA+U Ham iltonian adds explicit Coulomb term for the correlated orbitals \Re ; i to the LDA Ham iltonian

It has a form of a multiband Hubbard Ham iltonian with the LDA Ham iltonian used as "hopping". The Coulom b param eters U $_{1;2;3;4}$ are screened C oulom b integrals for the states $f \Re$; ig. They are to be found empirically or calculated from rst principles, and they, in general, depend on the choice of the correlated subspace $f_{\mathcal{R}}$; ig. Note that H $_{LDA}$ is not a kinetic energy and the H ubbard-U term is not a "raw" C oulom b interaction. R ather, the LDA+U Ham iltonian is an e ective Hubbard Ham iltonian for the correlated orbitals, and the rest of the states (e.g. sp states) is described within LDA. The justi cation of this approach²⁴ is not a trivial matter, and the main practical reason why it is widely used is the local nature of the screened Coulom b interaction. Note that we have included the explicit Coulomb term in the Hamiltonian, although m any static e ects of the C oulom b interaction

are already included in the LDA H am iltonian. N am ely, LDA includes a Hartree term, an exchange term, and som e correlation e ects (including a good description of the screening). However, the many-body treatment of the Hubbard-U part of the H am iltonian will also give the Hartree-Fock term and various correlation term s. Therefore, a double-counting correction scheme is necessary

where (z) is the local self energy of the DMFT problem. For treating m etals within LDA + DMFT the most common choice of the double-counting correction is the static part of the self-energy:




FIG.5: (Color online) Spectral density of bcc iron along high simmetry directions of the Brillouin zone from LDA+DMFT with MT correlated orbitals at T = 400 K.

The multiband Hubbard Ham iltonian, such as Eq. 3 cannot be solved exactly, therefore various approxim ations are applied. Unlike the static LDA+U method²⁶, LDA+DMFT takes into account dynam ical corelation effects through the frequency-dependent self energy (z).

B. LDA + DM FT equations

Spectral density functional theory^{6,24,27} uses the local G reen function $G_R(z)$ as the main observable quantity, much like the particle density (r) in DFT or the one-electron G reen function G(z) in Baym-K adano theory. Namely, for sensible de nitions of $G_R(z)$, a functional $G_R(z)$, and the local selfenergy R(z) plays the role similar to the K ohn-Sham potential in DFT. In the present paper we de ne $G_R(z)$ as the projection of the total one-electron GF to the correlated states R; i of a given site R

is the projection operator to the correlated subspace belonging to site R . The one-electron G F G (z) can in turn be expressed via the one-electron self energy (z) as

where is the chemical potential, and h_{LDA} plays the role of the unperturbed Ham iltonian ("hopping").

P recisely like in DFT or Baym-Kadano theory, the exact expression for the functional $[G_R]$ is not known. The most widely used approximation is the dynamical mean eld theory (DMFT). The approximation behind DMFT is that the total one-electron self energy (z) is taken as the sum of the local self energies of all lattice sites (with double-counting correction when appropriate)

This self energy is local, i.e. it does not have matrix elements between di erent sites

W ith this form of (z), the local self-energy $_{\rm R}$ (z) can be obtained from the inpurity problem, with the rest of the lattice replaced by the bath GF (or "dynam icalm ean eld") G₀⁻¹ (R;z) de ned by

In a periodic solid all atoms are equivalent, therefore the local quantities such as $(_R)_{1;2}$, $(G_R)_{1;2}$ and G_0^1 (R;z) _______ do not depend on the site R. Moreover, if there are several sites within unit cell, and the Hubbard-U term does not have matrix elements between di erent sites, $(_R)_{1;2}$ takes a block diagonal form with a block for each site.

The system of one correlated site in the self-consistent bath does not have a H am iltonian, but can be described by an e ective action. Here and in the following we use the M atsubara form alism for a nite temperature T. The GF's and self energies are de ned at the M atsubara frequencies

This problem still cannot be solved exactly, how ever, com pared to the original many-body problem it has only a few degrees of freedom, so it can be solved by the DMFT solver, which can be for example Quantum M onte Carlo (QMC), exact diagonalization, or a num ber of approxim ate m ethods, such as SPTF¹². The DM FT solver is the central part of the LDA + DM FT scheme. It uses the bath GF (G_0) (z) and produces the new self energy 1; 2(z). The equations (4), (6), (8), (9), (11) and (13) constitute the DMFT cycle which is solved selfconsistently until the convergence is reached. The num ber of electrons is given by

This equation is used to determ ine the LDA+DMFT chem ical potential (Ferm i energy), which must produce the correct num ber of electrons. In the following subsection we show how the DMFT equations can be presented in a given LDA basis set.

C. DMFT equations for a given LDA basis set

The Kohn-Sham eigenfunctions belong to the Hilbert space of one-electron states in a solid. The choice of the basis set in this space is dictated by the method (LM TO, LAPW, ...), and we can use a basis either in the realspace or in the reciprocal-space. The real space basis set $f_{\mathbb{R}}$; ig is de ned by the wavefunction

W e use the following de nition for the matrix elements of an operator

The LDA k-space basis set f_{k} ; ig should be used in order to calculate the local GF (6), since we know the LDA H am iltonian m atrix h_{LDA} (k) and the overlap m a-trix S (k) in this basis set. On the other hand, the DM FT impurity problem is form ulated for the correlated sub-

where (k;z) is the selfenergy matrix in the LDA basis fk; ig. This expression would be exact only if the basis set fk; ig was complete. It would also be exact if the correlated orbitals R; i belonged to the space spanned by the basis functions k; i, like for the orthogonalized M TO's, since it would mean that fk; ig is complete within the space of interest. In realistic full-potential calculations the completeness of fk; ig is a reasonable approximation. The local self energy transform ed into the LDA basis is in turn given by

The spectral density generalizes the concept of quasiparticle band structure by allowing quasiparticles to decay, thus introducing sm earing of bands. In the abænce of self energy it reduces to the usualK ohn-Sham band structure

As we already mentioned, typical spectral density has coherent (quasiparticles) features and also possibly noncoherent (dispersionless) ones: Hubbard band satellites. N ote that DM FT gives G reen function at M atsubara frequencies i!_n, while DOS and the spectral density are de ned via GF at the + i0 contour. The num erical analytical continuation can be done, for example, using the P ade approxim ation.

II. IM PLEM ENTATION

In this paper we introduce the code BRIANNA, a new LDA + DM FT in plem entation based on the full-potential

space with a real-space basis set f \Re ; ig. Transforming back and forth between the local GF's and the self energies is thus necessary at each DMFT iteration. Using Eqs. (22) { (28), it is easy to show that Eq. (6) becomes




FIG.6: (Color online) Im aginary part of the self energy for iron, cobalt and nickel, m a jority spin (M T correlated orbitals at T = 400 K).

linear mu n tin orbital (FP-LM TO) code developed in Ref28. As we already mentioned, FP-LM TO gives an accurate description of solids within LDA, and the full-potential treatment is especially in portant for open structures and surfaces. On the other hand, FP-LM TO uses a relatively small basis set, which is convenient for calculating G reen functions, since it involves inverting a matrix in the LDA basis set for each M atsubara frequency and k-point. The typical basis set is \doubleminim al", i.e. it contains two basis functions per each site and l;m; , with di erent \tail energies". It is still much smaller than the basis set in the plane wave and augmented plane wave based codes.




FIG.7: (Color online) Im aginary part of the self energy for iron, cobalt and nickel, m inority spin (M T correlated orbitals at T = 400 K).




FIG. 8: (Color online) Density of states of fcc nickel (LDA+DMFT with MT correlated orbitals at T = 400 K vsLDA).

There are a few other technical issues worth m entioning here. A DMFT solver typically needs about 1000 or m ore M atsubara frequencies (above the real axis). Instead of perform ing matrix inversion in Eq. (29) for every frequency (and every k-point), it is a standard technique now adays to use a smaller (usually logarithm ic) mesh in Eq. (29) and, after having calculated the localGF, transform it to the M atsubara mesh using cubic splines. Inverse transform ation is applied to the self energy in order to plug it into Eq. (29). All calculations of the present paper use 1024 M atsubara frequencies in the DMFT solver, but only 80 points in Eq. (29). The rst 16 of them coincide with the rst M atsubara frequencies, while the rest form s a logarithm ic mesh. Another issue involves num erical analytical continuation in (31) and (32). Analytical continuation using the Pade approximation can introduce serious num erical errors. In the present im plem entation we do not apply the Pade

;

approximation to the G reen functions. Instead, we use it only for the self energy (z), while the GF is calculated directly at the + i0 contour using Eq. (8).

W e have already m entioned the very im portant question of choosing the orbitals spanning the correlated subspace. In this paper we use two di erent de nitions, both of them atom ic-like and derived from transition metald states. The rst, more traditional, uses orthogonalized d-type basis functions of the FP-LM TO method, transform ed to the real space via (19). W e call this de nition orthogonalized LMTO (ORT) correlated subspace. We rem ind the reader that it is poorly localized, and also that the orbitals \Re ; i do not have pure l;m character. Such kind of approach requires minimal LDA basis set for the d-type electrons. This FP-LM TO code²⁸ allows to use a double-m in in al basis set (two or even more energy tails) for sp-electrons and a m in im alone (single tail) for d electrons. The latter have less dispersion than sp electrons, and use of the single-tail basis set for them does not lead to any severe errors within LDA.

O ur second choice is som ewhat opposite, since it deals with extrem ely localized correlated orbitals. We call it mu n-tin only (MT) correlated subspace. \Re ; i is chosen as

R R + r is the site where the orbital \Re ; i is located and R_{MT}; is the mun-tin radius for this site. The puremun-tin radial function 1(r) is the solution of the radial Schrodinger equation in the spherically averaged K ohn-Sham potential²⁸, inside the mun-tin only, for a certain energy E .

The correlated orbital in Eq. (33) is zero outside a given mu n-tin, and is thus ultim ately local. The correlated orbitals have pure angularm on entum character, but, at the same time, they are orthogonal by de nition (since they do not overlap). Note that the correlated orbitals obviously do not form a complete basis set within the H ilbert space of one-electron wafefunctions (since the interstitial region is not included at all). This is not a problem, since they are only used to de ne the H ubbard-U term in the H am iltonian (3), while the "hopping" term is the LDA H am iltonian de ned using the FP-LM TO basis set, which we assume to be su ciently complete.

III. RESULTS

A. Iron

The LDA+DMFT self energies of bcc iron have been calculated for U = 2.3 eV, J = 0.9 eV. We used both mu n-tin only (MT) and the orthogonalized LMTO (ORT) sets of correlated orbitals, and also perform ed calculations for di erent tem peratures. In Figures 1 and 2 we present the imaginary part of the self energies,




FIG.9: (Color online) Spectral density of fcc nickel from LDA+DMFT with MT correlated orbitals at T = 400 K.




FIG. 10: (Color online) Density of states of hop cobalt (LDA+DMFT with MT correlated orbitals at T = 400 K vs LDA)

Im (+i0), form a prity and m inority spins respectively, while in Figure 3 we show the realpart of (only for the M T basis and for T = 1500 K). In quasiparticle language the matrix elements Re (E + i0); describe the shift of the quasiparticle bands, while Im (+i0); has the physical meaning of quasiparticle band sm earing , which is the inverse of the quasiparticle decay time = 1=. The band structure is only well de ned if jIm; j W, where W is the bandwidth. For metals this is always true in the vicinity of the Ferm i level, since Im (+i0) = 0. The self energies presented here are averaged over the orbital indices m, nam ely

The crystal eld splitting of is rather small and we are not going to discuss it in details. Figure 4 shows the total density of states (DOS) of bcc iron (LDA+DMFT vs LDA), while the spectral density (k-resolved DOS) is presented in Figure 5 for several high-symmetry directions. We remaind the reader that the spectral density is the generalization of the band structure with nite quasiparticles lifetime taken into account. Both gures use the M T basis set and T = 400 K.

The three curves in Figs. 1 and 2 are qualitatively similar, proving that both M T and O RT correlated orbitals (corresponding to well-localized and poorly localized d-states, respectively) can be used to adequately describe iron within LDA + DM FT. However, the exact am plitude of the peaks in is sensitive to the choice of the correlated subspace. We are going to use the muntin only (MT) correlated orbitals for the rest of this paper. Note also that is practically tem perature-independent for a wide range of tem peratures.

The majority spin Im (+ i0) in Fig. 1 has the main peak at ' 7 eV, by reaching the value 3:4 eV. This gives rather strong dam ping of quasiparticles, as we can observe in Fig. 5. There is also a shoulder or sm allm ini-2 eV. The correlation e ects are more promum at ' nounced for the majority spin electrons, which is common for late transition m etals (see R ef. 22 for an interesting discussion). The LDA + DM FT density of states (Fig. 4) shows the narrowing of the majority-spin d-band com pared to the LDA DOS and also a satellite at ' 7 eV. This is the e ect of Re (+ i0). The positive region of Re for the majority electrons between -6 eV and the Ferm i level in Fig. 3 leads to the narrowing of the band, while the sharp negative peak at -8 eV "draws" the electrons down in energy, leading to the form ation of the DOS satellite. Naturally, the sm earing of the quasi-




FIG.11: (Color online) Spectral density of hep cobalt from LDA + DMFT with MT correlated orbitals at T = 400 K.




FIG. 12: (Color online) Im aginary part of the self energy for nickel 5-layer (111) slab, 3-layer (111) slab and bulk for nickel, majority spin (from LDA + DMFT with MT correlated orbitals at T = 400 K). In the legend "1 of 5" indicates the surface atom of the 5-layer slab, "2 of 5" the sub-surface atom and "3 of 5" the quasi-bulk atom . Sim ilarly "1 of 3" indicates the surface atom of the 3-layer slab and "2 of 3" the quasi-bulk atom .

particle bands, given by Im , leads to the sm earing of the sharp peaks of the LDA DOS.Note that our selfenergies and DOS dier som ewhat from the ones in Ref. 21. In particular, we clearly observe a DOS satellite at

' 7 eV, which was not observed in the earlier calculation for U = 2:3 eV and J = 0:9 eV, but only form uch larger values of U. The reason, we believe, is that Ref. 21 used a simpli ed version of the SPTF solver, while in the present paper the full in plem entation of the SPTF¹²




FIG.13: (Coloronline) Im aginary part of the self energy for nickel 5-layer and 3-layer (111) slabs and bulk, m inority spin (from LDA+DMFT with MT correlated orbitals at T = 400 K). In the legend "1 of 5" indicates the surface atom of the 5-layer slab, "2 of 5" the sub-surface atom and "3 of 5" the quasi-bulk atom. Sim ilarly "1 of 3" indicates the surface atom of the 3-layer slab and "2 of 3" the quasi-bulk atom.

is used. To the best of our know ledge this is the rst calculation that shows the existence of such a satellite, and this could open a new scientic problem, since it has never been reported in any experiment.

B. Cobalt and nickel

The LDA+DMFT self energies for foc nickel, hop cobalt and foc cobalt are presented in Figs. 6 and 7,




FIG.14: (Color online) Spectral density of nickel (111) surface modelled by the 5-layer slab (from LDA+DMFT with MT correlated orbitals at T = 400 K).




FIG. 15: (Color online) Im aginary part of the self energy for fcc cobalt 5-layer (111) slab, majority spin (from LDA+DMFT with MT correlated orbitals at T = 400K K). In the legend "1 of 5" indicates the surface atom of the slab, "2 of 5" the sub-surface atom and "3 of 5" the quasi-bulk atom.

and the bcc iron self energy is also shown for comparison. The values of H ubbard parameters were U = 2:3 eV, J = 0:9 eV for cobalt and U = 3 eV, J = 1 eV for nickel. Strictly speaking the parameters U and J are somewhat arbitrary (since they apply to a modelLDA + U H am iltonian) and their values depend on the choice of the correlated orbitals. We make a rather traditional choice of U and $J^{21,22}$ in the present paper, how ever^{4,12,21,22}.

The general structure of the self energy is similar for Fe, C o and N i. The correlation e ects for majority spin




FIG. 16: (Color online) Im aginary part of the self energy for fcc cobalt 5-layer (111) slab, minority spin (from LDA+DMFT with MT correlated orbitals at T = 400K K). In the legend "1 of 5" indicates the surface atom of the slab, "2 of 5" the sub-surface atom and "3 of 5" the quasi-bulk atom.

electrons are strongest for nickel and weakest for iron, at least for the values of U and J used here. The shoulder at 2 eV is most pronounced for iron and practically disappears for nickel. The self energy curves for foc cobalt and hop cobalt are almost identical. The correlation for m inority spin electrons (Fig. 7) are by far strongest in nickel, which has the lowest magnetic moment of the three elements, therefore the di erence between majority and m inority spin behavior is less profound in nickel com pared to iron and cobalt.




FIG.17: (Coloronline) Spectral density of fcc cobalt (111) surface modelled by the 5-layer slab (from LDA+DMFT with MT correlated orbitals at T = 400 K).




FIG.18: (Coloronline) Im aginary part of the selfenergy for bcc iron (001) surface modelled by the 5-layer slab, m a jority spin (from LDA+DMFT with MT correlated orbitals at T = 400 K). In the legend "1 of 5" indicates the surface atom of the slab, "2 of 5" the sub-surface atom and "3 of 5" the quasi-bulk atom .

Figures 8 and 10 present density of states of fcc nickel and hcp cobalt respectively, while Figures 9 and 11 show the spectral density for these materials. The density of states for nickel is in a good agreement with previous LDA + DMFT calculations¹². Note that the SPTF solver places the majority-spin satellite at about 7:5 eV, while in experiment it is observed at 6 eV. The spectral density of fcc nickel is, to the best of our know ledge, pre-

sented here for the rst time. Since bcc iron, fcc cobalt

and foc nickel have di erent crystal structure, their band




FIG.19: (Color online) Im aginary part of the self energy for bcc iron (001) surface, m odelled by the 5-layer slab, m inority spin (from LDA+DMFT with MT correlated orbitals at T = 400 K). In the legend "1 of 5" indicates the surface atom of the slab, "2 of 5" the sub-surface atom and "3 of 5" the quasi-bulk atom .

structures naturally bok di erent. However, Fe, Co and N i all have strong sm earing of majority-spin bands at about 7 eV dictated by the peak in the selfenergy (Fig. 6), and show a DOS satellite at about 7.5 eV.

The LDA+DMFT values of the spin magnetic moments are substantially equal to the LDA values (e.g. for boc Fe we have = 223 _B per atom from the DMFT calculation which should be compared to = 222 _B per atom from LSDA, and for hcp Cowe obtain = 1.54 _B per atom from the DMFT calculation which should be




FIG.20: (Color online) Spectral density of bcc iron (001) surface modelled by the 5-layer slab (from LDA+DMFT with MT correlated orbitals at T = 400 K).




FIG.21: (Color online) Real part of the self energy for boc iron (001) surface m odelled by the 5-layer slab. Both m a prity and m inority spins for the surface atom (labelled "1 of 5") are reported and com pared to the bulk values (from LDA + DM FT with MT correlated orbitals at T = 400 K).

com pared to = 1.57 _B from LSDA). Indeed the problem of the e ect of the correlations on the spin and orbital m agnetic m om ents is very interesting and will be the subject of further investigations in the near future.

C. Surfaces

W e model the nickel (111) surface with slabs having di erent number of close-packed atom ic layers. Such slabs form a superlattice with a 30 A thick layer of vacuum separating them, with each slab having two (111) surfaces. The calculations have been done for 5-layer slabs; how ever just form ethodical aim s, to show the sensitivity to the computational details the results for 3-layer slabs are also presented on som e gures. In Figs. 12 and 13 we present the LDA + DMFT self energies (im aginary part) for nickel slabs for majority and minority spin respectively. D ata for each layer of the 3-layer and 5-layer slabs and for the bulk fcc nickel (for com parison) are presented. Notice that the self energy of a nickel atom at the surface is obviously quite di erent from the self energies for the rest of the atom s in the slab. The most noticeable e ect is that the positions of the peaks are shifted and that the correlation e ects for majority spin electrons seem to be more enhanced at the surface com pared to bulk. We will encounter sim ilar e ects for the other surfaces studied here (see below). This shows that the e ect of the correlations is di erent for the topm ost surface layer, com pared to the rest of the surface layers, and that the sub-surface layer already seems really bulklike. This nding is an observation that is worthy experim ental attention. The reasons of such a di erence are rather obvious: due to the reduced coordination num ber of the surface atom s the bands becom e narrower, which m akes correlation e ectsm ore im portant. In addition the screening of the electron-electron interaction is less e ective for the surface atom s, and this increases the value of the Hubbard U.Although the basic mechanisms are easily identied for why correlation e ects are more im portant at the surface, we provide here a quantitative measure of this e ect.

The spectral density of the nickel 5-layer slab is presented in Fig. 14 along high-sym metry directions of the two-dimensional Brillouin zone. For well-de ned quasi-




FIG.22: (Color online) Spectral density of bcc iron (001) surface modelled by the 5-layer slab and with di erent values of U for atom s belonging to di erent layers of the slab (from LDA + DM FT with MT correlated orbitals at T = 400 K).




FIG.23: (Color online) Real part of the self energy for boc iron (001) surface modelled by the 5-layer slab and with different values of U for atom s belonging to di erent layers of the slab. Both majority and minority spins for the surface atom (labelled "1 of 5") are reported and compared to the values calculated in the simulation with constant U (from LDA + DM FT with MT correlated orbitals at T = 400 K).

particles, each band of the bulk nickel splits into ve bands for the 5-layer slab. Som e of the bands are surface states, while the rest joins into the bulk continuum when the number of atom ic layers go to in nity. In Fig. 14, it is already possible to observe the surface states (isolated bands) and the hint of the bulk continuum form ation (several bands that are very close to each other).

Sim ilar results are obtained for the foc cobalt (111) surface and for boc iron (001) surface, whose self ener-




FIG.24: (Color online) Real part of the self energy for boc iron (001) surface modelled by the 5-layer slab and with different values of U for atom s belonging to di erent layers of the slab. Both majority and minority spins for the surface atom (labelled "1 of 5") are reported and compared to the values calculated in the simulation with constant U (from LDA+DMFT with MT correlated orbitals at T = 400 K).

gies are respectively shown in Figs. 15-16 and in Figs. 18-19. We can notice twom aim di erences with respect to the results for the nickel: for the majority spin the shift of the peak and the increase of its depth for the atom s on the surface are stronger, while for the minority spin the correlation e ects are, som ewhat surprisingly, decreased (slightly for C o and strongly for Fe). In Fig. 21 we can observe the realpart of the self energies for the atom s on the iron surface, com pared to the bulk values. It is especially interesting that for the surface layer the selfenergy of m inority spin states is considerably suppressed, which leads to the fact that the satellite at 7.5 eV is almost totally polarized and possesses majority spin charachter. In Figs. 17 and 20 we show the spectral densities for the surfaces of C o and Fe, and the elects of the change of the imaginary parts of with respect to the bulk are clearly evident in the dilerence of the densition of the quasi-particle bands for majority and minority spins.

Finally we have to notice that the choice of the values of U, already non trivial for the bulk m aterials, becomes m ore problem atic for the surfaces, where the screening is m uch sm aller. To analyze this problem, we have tried to m odel the bcc Fe (001) surface with di erent values of U for atom s belonging to di erent layers, namely U = 2.3 for the inner layer, U = 2.4 for the intermediate one and U = 3.0 for the external one. In Figs. 23 and 24 we respectively show the real and the imaginary part of the self energy for the external atom s. In comparison to the previous calculation we do not observe any drastic e ect, but mainly a reasonable increasing of the peaks and a sm all shift of the 7:5 eV satellite. This makes the satellite m ore pronounced in the density of states. The spectral densities are reported in Fig. 22.

IV. CONCLUSION

In this paper we have introduced the new full-potential LDA + DM FT code BR IANNA and we have applied it to the correlated electronic structure of bulk Fe, Co, Ni, and the fcc Co and Ni (111) surface, and the bcc Fe (001) surface. The calculated self energies, DOS and the spectral densities are presented. The spectral density plots show the correlated electronic structure in the most clear way, as the k-resolved DOS (or, equivalently, as the

sm eared band structure). The main correlation e ects in iron, cobalt and nickel are observed for the majority spin electrons and they include strong quasiparticle dam ping for at about 7 eV, narrow ing of the d-band (com pared to LDA/GGA) and the appearance of a DOS satellite at about 75 eV, which is a non-quasiparticle feature.

The calculations for N i and Co (111) surfaces and for Fe (001) surface show that the electron self energy depends mostly on the local coordination number, with the atom s in the second layer from the surface already being similar to the bulk. Hence our calculations suggest that the e ect of correlations should be dierent for the surfaces of these elements, compared to the bulk. In addition, the spectral density of the N i (111) surface show both bulk and surface states. The question \How do the correlation e ects depend on the dimensionality of the problem ?" still needs further investigation, how ever, and the the LDA + DM FT studies of slabs of di erent thickness and nanow ires are the subject of the future research.
