## Tem perature and M agnetic Field D ependencies of C ondon D om ain P hase in Lifschitz-K osevich-Shoenberg A pproxim ation

The tem perature and m agnetic eld behavior of non-uniform diam agnetic phase of strongly correlated electron gas at the conditions of dH vA e ect is analyzed. It is shown, that in the fram ework of Lifschitz-K osevich-Shoenberg approximation the magnetic induction splitting, as well as the range of existence of C ondon dom ains, are characterized by strong dependencies on tem perature, m agnetic eld and im purities of the sam ple.

I. INTRODUCTION

O scillations of the therm odynam ic quantities of electron gas in magnetic eld are the result of the oscillations of the density of states when successive Landau levels sweep through the Ferm i level [1]. At high magnetic eld and low temperature the instability of strongly correlated electron gas due to magnetic interaction between electrons results in diamagnetic phase transition (DPT) [2] with form ation of C ondon dom ain (CD) structure, which is extensively studied, both theoretically and experim entally [3]-[16]. Magnetic interaction of strongly correlated electron gas results in non-linear dependence of local diamagnetic moments on external magnetic eld and temperature [9] and gives rise such an exotic phenom enon as diamagnetic hysteresis [11], [14].

Recent progress in experiments on observation of CD structure in Ag [5] and Be [11] provides a natural stimulus towards a more detailed understanding of the properties of strongly correlated electron gas in the conditions of dHvA e ect.

A lthough the theoretical aspects of the CD form ation have been recently reviewed [8], some important questions concerning the DPT and non-uniform phase of strongly correlated electron gas are still open. In particular, the detailed theoretical investigation of the in uence of the temperature T, magnetic eld  $_0H$  and impurities of the sample on such important characteristics of the non-uniform diam agnetic phase, as the range of existence of the CD structure and m agnetic induction splitting, is still lacking.

W e present the theoretical investigation of the tem – perature and magnetic eld behavior of the CD phase in the fram ework of Lifshitz-K osevich-Shoenberg (LKS) approximation [1], [2] and compare our results with available data on investigation of CDs in Ag [4], [5]. II. MODEL

The oscillator part of the therm odynam ic potential density in the LKS approximation [2] can be written in reduced form with taking into account the shape sample e ects:

where  $b = k (B_{0}H) = k [h_{ex} + 4 (1 n)M] = x + (1 n)y$ ,  $_{0}H$  is the magnetic eld inside the material  $k = 2 F = (_{0}H)^{2}$ , F is the fundamental oscillation frequency),  $h_{ex} = H_{ex}$  H is the small increment of the magnetic eld H and the external magnetic eld  $H_{ex}$ , n is the demagnetization factor. The validity of therm odynamic potential density (1) is restricted by applicability to hom ogeneous phase only, where the conception of demagnetization coe cient n is justi ed  $\mathfrak{P}$ ]. In the conditions of strong magnetic interaction, when

a state of lower therm odynam ic potential is achieved over part of dH vA oscillation cycle by the form ation of CD structure. The usually observed diam agnetic dom ain structure is of stripe-dom ain type [2],[5]. In the dom ain state, when the reduced am plitude of dH vA oscillations satis es to the condition 2, the dem agnetization factor n is replaced by the coe cient [9], which depends on m agnetic eld, tem perature, in purities and geom etry of the sam ple.

The equation a( $_0H$ ;T;T<sub>D</sub>) = 1 de nes the critical surface in three dimensions  $_0H$  T T<sub>D</sub>. Above this surface the uniform diam agnetic phase exists, but below it, the CD phase appears in the part of the period of dHvA oscillations.

In the non-uniform phase, when the condition (2) is full led, the metastable states, form ed by magnetic eld

h, are determ ined by

identifying two local m inim a of the therm odynam ic potential (1). The diam agnetic m om ents y corresponding to these m inim a, being the functions of m agnetic eld increment x and reduced am plitude of the dH vA oscillations  $a = a (_0H;T;T_D)$  [9], are characterized by the strong dependence on m agnetic eld, tem perature and in purity of the sam ple and contribute to the m agnetic induction splitting  $b = y_+$  y between two adjacent dom ains. The average m agnetic induction splitting can be de ned as the m agnetic induction splitting at the center of the period of dH vA oscillations:

In this case the magnetic induction splitting b is calculated due to

In limit a !  $1 + 0^+$ , e.g. in the nearest vicinity of the point of DPT, from the Eq. (5) one can obtain the expression form agnetization  $y = \frac{P}{[6(1 \ 1=a)]}$  [8]. A c-cording to Eq. (5) m agnetic induction splitting b = b(a) has strong dependencies on magnetic eld  $_0$ H, tem perature T and D ingle tem perature  $T_D$  through the reduced am plitude of dHvA oscillations a = a( $_0$ H;T;T<sub>D</sub>).




FIG.1: The magnetic induction splitting b as a function of the range of existence of non-uniform phase . Closed circles show the dilerent values of reduced amplitude of dH vA oscillations a: 1 - a = 1, 2 - a = 1:3, 3 - a = 2:6, 4 - a = 3:9,5 - a = 4:6, 2 - a ! 1. Both variables 0 b 2 and 0 2 are restricted by the period of the oscillations (2 in reduced units), which is shown by dash lines. The straight line between points 5 and 6 corresponds to slow increase of induction splitting b with increase of a in the interval a 2 [4:6;1 ), when has reached its maximum value = 2. The open circle corresponds to the data [4].

The range of existence of the CD structure in every period of dH vA oscillations can be estimated by consideration of the instability points, or in ection points, where the next two conditions must simultaneously hold

U sing the Eqs. (6) one can obtain

From Eq. (7) it follows that the range of existence of the CD structure is also dependent on magnetic  $eld_0H$ , tem perature T and D ingle tem perature  $T_D$ .

For proper calculation of the reduced am plitude of the dH vA oscillations a and investigation of the tem perature and m agnetic eld characteristics of CD phase, the correct topology of Ferm i surface has to be taken into account.

In case of ellipsoidal Ferm i surface, the tem perature and eld dependence of the reduced am plitude of dH vA oscillations a is de ned by 2], [8]

m<sub>c</sub> is the cyclotron m ass,  $k_B$  is the Boltzm ann constant, e is the absolute value of the electron charge, c is the light velocity, ~ is the P lanck constant, and  $T_D = -2 k_B$  is the D ingle tem perature, which is inversely proportional to the scattering lifetime of the conduction electrons. The limiting am plitude

is the combination of temperature-independent factors in the Lifschitz-Kosevich formula [1], and

is the limiting eld §] above which DPT does not occur at any temperature T,  $_{\rm F}$  is Ferm i energy in eV, = m  $_{\rm c}$ =m and m electron mass. The validity of the LKS approximation and, consequently, the expression for reduced am plitude of the dHvA oscillations a (8) is restricted by the application to the spherical (or alm ost spherical) Ferm i surface sheets, which is the case of noble m etals [2]. The recent experimental data on observation




FIG.2: M agnetic eld dependence of the reduced range of existence of non-uniform phase (a) and corresponding m easured range  $_{CD}$  (a) in silver for  $T_D = 0.1K$  and four di erent tem peratures: 1 - T = 1K, 2 - T = 1.5K, 3 - T = 1.75K, 4 - T = 2K. The straight horizontal line at (a) corresponds to the maximum value of = 2. This line transforms into second power of magnetic eld dependence of  $_{CD} = =k$  at the same interval of magnetic eld (b). At  $T = 1K _{CD}$  reaches its maximum value at  $_{0}H$  15T.

of CD structure in Ag [11], [15] by measurement of the amplitude of the third harm onic of the ac susceptibility reveals the possibility to construct the phase diagram. As it was expected, the measured phase diagrams for Ag [15] are in a good agreement with the calculated in the framework of LKS form alism phase diagrams, justifying the applicability of the Eq. (8) for belly oscillations in Ag.

## III. RESULTS AND DISCUSSIONS

W hen the condition (2) is fulled, the sample is divided into domains with up and down magnetization. Both the magnetic induction splitting de ned in explicit form by the Eq. (5) and the range of existence of CDs Eq. (7) are the functions of reduced amplitude of the dHvA oscillations and cannot be considered as independent functions at wide range of applied magnetic eld and temperature. Mathematically, the Eqs. (2),(5) deno the function h=h(x) is paymentic form with the

ne the function b = b( ) in parametric form with the

parameter a 2 [1; 4:6] (Fig. 1). At a = 4:6 the reduced range of existence of CD structure spreads through all period of the dHvA oscillations and remains constant at further increase of a.

The results of numerical calculations (Fig. 1) show rapid increase of magnetic induction b with increase of reduced am plitude a in the vicinity of the point of DPT with slowing down of this increase at a 2 [2; 4:6]. Contrary to it, the range of existence of the CD structure

is characterized by slow increase near the DPT point and rapid increase at the biggest values of a till its full value = 2 at a = 4:6. Thus, b = 2:43 >> = 0.27 at a = 1:3. At the interval a 2 [4:6;1] the function b increases slow by with increase of a, while the range of existence of CD s remains constant = 2. In fam ous experiment on observation of CD structure in Ag by NM R [4] the value of a was found to be about 2:6, which is consistent with the value of a, calculated from Eq. (8) at the conditions of the experiment:  $_0H = 9T, T = 1:4K$  and




FIG.3: Magnetic eld dependence of the reduced range of existence of non-uniform phase (a) and corresponding measured range  $_{\rm C\,D}$  (a) in silver for T = 1.2K and four di erent D ingle temperatures:  $1-T_{\rm D}$  = 0.1K,  $2-T_{\rm D}$  = 0.25K,  $3-T_{\rm D}$  = 0.4K,  $4-T_{\rm D}$  = 0.55K. Sim ilar to the Fig.2 the straight horizontal line at (a) corresponds to the maximum value of = 2. This line transforms sinto second power of magnetic eld dependence of  $_{\rm C\,D}$  = =k at the same intervalofm agnetic eld in (b).  $_{\rm C\,D}$  reaches its maximum value at  $_{0}{\rm H}$  20T.

Due to the bell-like shape of the diam agnetic phase diagram s T = T ( $_0$ H;T<sub>D</sub>) (see, e. g. [8]) there is one critical temperature T<sub>c</sub> at given magnetic eld and two critical values of magnetic eld H (H < H<sub>+</sub>) at given temperature. Another possibility for realization of the DPT is related to the concentration of in purities in the sample, which in uence on the amplitude of the dHvA oscillations through the scattering of conduction electron.

Near the point of DPT a !  $1 + 0^+$  (T !  $T_c + 0$ , or H ! H + 0, or  $T_D$  !  $T_D_{;c} + 0$ ) the tem perature and m agnetic eld dependencies of m agnetic induction b can be represented as follow s:

Here,  $_{c} = (_{0}H ; T_{c}), _{D,c} = (_{0}H ; T_{D,c}), = (_{0}H ; T), ^{(D)} = (_{0}H ; T_{D}).$  It can be shown that near the point of D P T the range of existence of C D structure is related to the magnetic induction splitting b according to

It follows from Eqs. (12) and (14) that the parameters of the CD phase are characterized by the critical behavior near the DPT. The tem perature and magnetic eld dependencies of the order parameter b (12) can result in existence of soft mode. The possibility of softening of the orbital magnon mode was studied in [16].

In general case the temperature and magnetic eld characteristics of CD structure can be calculated from Eqs. (4) and (7) with taking into account the Eq. (8) for reduced amplitude of the oscillations. To illustrate the behavior of the non-uniform diamagnetic phase, we calculated the temperature and magnetic eld dependencies of the range of existence of CDs and magnetic induction splitting b for Ag, where the domains were observed




FIG. 4: (a) Temperature dependence of the range of existence of CD phase for six di erent D ingle temperatures:  $1 - T_D = 0.1K$ ,  $2 - T_D = 0.25K$ ,  $3 - T_D = 0.4K$ ,  $4 - T_D = 0.55K$ ,  $5 - T_D = 0.7K$  and  $6 - T_D = 0.85K$ . (b) Temperature dependence of the magnetic induction splitting due to CDs for four di erent D ingle temperatures:  $1^0 - T_D = 0.1K$ ,  $2^0 - T_D = 0.5K$ ,  $3^0 - T_D = 0.9K$  and  $4^0 - T_D = 1.3K$ . The strait horizontal line at (a) corresponds to the maximum value of = 2.

[5] and the DPT diagram swere con med experimentally [15].

The m easured, or absolute, values of the range of existence of CD structure  $_{CD}$  and m agnetic induction splitting B are de ned as follows

The results of numerical calculation of the temperature and magnetic eld dependencies of the parameters of the CD structure, Eq. (7) and bEq. (5), are illustrated in Figs. 2-6.

Fig. 2 shows the magnetic eld dependencies of the range of existence of CD structure in A g at constant D ingle temperature  $T_D = 0.1 K$  and several temperatures: T = 1 K, T = 1.5 K, T = 1.75 K, and T = 2 K. The straight horizontal line in the graphical representation of the function  $= (\ _0 H$ ) at  $T_D = 0.1 K$  (Fig. 2 (a), curve 1) corresponds to the full value of reduced range

= 2 with the amplitude of oscillations a 4:6 (com - pare with the straight line 5-6, Fig. 1). Corresponding

m easured, or absolute, range of non-uniform phase existence  $_{CD}$  (15) is characterized by the second power eld behavior at the sam e applied eld interval (Fig.2). The function  $_{CD}$  has maximum s at the middle range of applied eld  $_{0}$ H 2 (15; 25T) and decreases with increase of the impurity of the sam ple.

In Fig. 3 the range of existence on CD s is shown as a function of magnetic eld for  $T=1.2 \rm K$  and four different Dingle tem peratures:  $T_D=0.1 \rm K$ ,  $T_D=0.25 \rm K$ ,  $T_D=0.4 \rm K$ , and  $T=0.55 \rm K$ . The growth of Dingle tem perature results in decrease of the range of the non-uniform phase. Similar to Fig. 2, the straight horizontal line in Fig. 3 (a) corresponds to the maximum of reduced range , which results in quadratic increase of the absolute range of CD existence  $_{\rm CD}$  (15).

The tem perature dependencies of the range of existence of CDs (7) ( $_{CD}$  (15)) and magnetic induction splitting b (5) (B (16)) at  $_{0}H = 10T$  and di erent D ingle tem peratures  $T_D$  are illustrated in Fig. 4. At the tem perature intervalT 0 1:5K for  $T_D = 0$ :1K (curve 1 (a)) the range of CD existence spreads over all period of dH vA oscillations, reaching its maximum possible value. Near the point of diam agnetic phase transition, when a ! 1 + 0<sup>+</sup> the parameter of the order bexhibits critical behavior in accordance with Eq. (12). It results in softening of orbitalm ode. The last circum stance is in portant for experim ental observation of the DPT point and constructing the phase diagram s  $_{0}$ H T T<sub>D</sub> by m easuring the tem perature dependence of param eter of order B = B (T). The increase of the D ingle tem perature  $T_D$  results in decrease of the range (Fig. 4(a))and splitting b (Fig. 4(b)).




FIG.5: Magnetic eld dependence of the reduced induction splitting b (a), caused by two adjacent dom ains, and corresponding measured value B (b) in silver for  $T_D = 0.1K$  and ve di erent tem peratures: 1 - T = 1K, 2 - T = 1.5K, 3 - T = 1.75K, 4 - T = 2K, and 5 - T = 3K. The second power law dependence of the period of the dH vA oscillations on the applied m agnetic eld shifts the maximum values of measured characteristics to the high-eld range.




FIG. 6: Magnetic eld dependence of the reduced induction splitting b (a), caused by two adjacent domains, and corresponding measured value B (b) in silver for T = 1:3K and four di erent D ingle tem peratures:  $1 - T_D = 0:1K$ ,  $2 - T_D = 0:5K$ ,  $3 - T_D = 0:9K$ , and  $4 - T_D = 1:3K$ . Sim ilar to Fig. (5), the second power law dependence of the period of the dH vA oscillations on the applied magnetic eld shifts the maximum values of measured characteristics to the high-eld range.

The magnetic eld dependencies of induction splitting b(B) are shown in Fig. (5) for ve di erent temperatures and in Fig. 6 for four di erent D ingle temperatures. The maximum values of absolute induction splitting (B) are shifted into high-eld range  $_0H$  25 40T.

The magnetic induction splitting due to CD structure changes the distribution of magnetic eld in vacuum above the surface of the sample. The possibility of detection of these changes by means of H all probe spectroscopy and mapping of CD structure is discussed in [12], [13] and realized in [5], [15]. It was found [12], [13] for the plate-like sample in applied magnetic eld along the norm alto the surface H k Z with periodic domain structure along the Y-axis, that the norm al component of magnetic eld H<sub>n</sub> is described by the following periodic function of Y with the period 2D equal to the period of CD structure :

The measured value by method of Hall probes is the maximum splitting of the normal components of nonuniform magnetic eld above two neighboring domains  $H_n$ , e.g. the maximum di erence between two values,  $H_n^{"}$  and  $H_n^{\#}$ , of normal component of magnetic eld

Eq. (17) caused by magnetic induction splitting B inside the sample

The function (18) is of rapid decrease of Z. Thus, the magnetic eld splitting above the sam ple Eq. 16) at the distance of one-third of the period of CD structure is about 0.15 B =  $_0$ . It follows from Eq. (18) that the measurement of the magnetic eld splitting H<sub>n</sub> at given distance Z = d above the surface of the sam ple can give information about magnetic induction splitting B inside the sam ple due to CD structure with given period 2D.

The Hallprobes m easurements of magnetic eld distribution above the sample surface [5], [15] were performed on a high quality single crystal of A g 2.4 1.6 1.0 mm<sup>3</sup>. The D ingle temperature was estimated to be  $T_D = 0.2K$ . At the conditions of the experiment,  $_0H = 10T$  and T = 1.3K [5], the magnetic induction splitting, calculated in LKS approximation with a Eq. (8), gives

B (1:3K) =  $_0$  = 16:7G. These estimations are in agreement with the earlier famous NMR measurements in Ag [4], where at the slightly less favorable conditions for observation of CD structure, e.g.  $_0H = 9T$ , T = 1:4K and  $T_D = 0:3K$ , the smaller value of induction splitting in the sample  $B = _0$  12G was reported. At the conditions of the experiment [4], the Eq. (16) with taking into account Eq. (8) gives the value of B (1:4K) =  $_0 = 11:7G$  close to the reported one, justifying the applicability of the LKS approximation [2] for belly oscillations in Ag.

C orrect treatm ent of the experim ental results on m easuring of distribution of m agnetic eld by Hall probe technic [5] can be done with know ledge of the ratio of the distance between the set of Hall probes and the surface of the sam pled to the period of the dom ain structure 2D (see, e.g. Eq. (18)). Unfortunately, the distance between Hall probes and sam ple surface was not reported in [5], and there are no accurate data about the characteristic m agnetic sizes of the non-uniform phase, except of the statem ent, that the dom ain period was not




FIG. 7: Comparison between theory and experiment. (a) Applied magnetic eld dependence (a) and temperature dependence (b) of the magnetic eld splitting H above the surface of the sample, caused by the induction splitting B of CD structure. The solid lines correspond to the magnetic eld distribution, calculated from Eq. (16) in the fram ework of LKS approximation at the conditions of the experiment [5]:  $_0H = 10T$  and  $T_D = 0.2K$ . The circles are referred from [5]. In calculation of the theoretical curves the thing parameter d=2D = 0.1 is used.

sm aller than 150 m . The more com plex m easurem ents of the magnetic eld distribution at di erent xed positions in the direction perpendicular to the surface of the sample would provide the lacking information about the period of the CD structure. To compare the theory with the available experimental results [5] we use the tting param eter d=2D 0:1, which gives reasonable value of d 15 m for 2D = 150 m within accuracy of the experiment [19]. Atd 50 m which is the reasonable value for the average distance between unpolished surface and Hall probes, the calculated magnetic eld splitting H Eq. (18) is about 2:5G, which is at the edge of accuracy of the experim ent [5]. It explains the absence of the signal from Hall probes for rough surface [5]. The results of comparison of the tem perature and magnetic

eld dependencies of the measured magnetic eld distribution above the surface of the sample [5] with the value of H<sub>n</sub>, calculated from Eq. (18) in LKS approximation (8) are present in Fig. (7). The reported critical tem perature  $T_{\rm c}$   $\,$  3K at  $_0H$  = 10T, de ned from the tem perature dependence of the m easured splitting, is in accordance with the predicted value  $T_{\rm c}$  = 2:9K, calculated in LKS approximation for  $T_D$  = 0.2K at the same value of  $_0H$  = 10T.

## IV. CONCLUSIONS

We investigated theoretically the temperature and m agnetic eld characteristics of the CD structure in LKS approximation [1], [2]. We show that the magnetic induction splitting in non-uniform diamagnetic phase, caused by the arising instability of strongly correlated electron gas in high magnetic eld and low temperature, and the range of the existence of this phase depend on temperature, magnetic eld and impurity of the sample. We show that the magnetic induction splitting, e.g. the order parameter of the DPT, and the range of the exis-
