Quantitative Evaluation of the E ects of Positional versus Orientational D isorder on the Scattering of A coustic Phonons in

# D isordered M atter

## Abstract

The phonon scattering processes on the three solid phases of ethanol are investigated by m eans of them al conductivity, light and neutron scattering m easurem ents as well as m olecular dynam ics sin ulations on single-crystalline m odels for the two crystalline m odi cations (fully ordered m onoclinic and orientationally disordered bcc phases). The orientationally disordered crystal is found to exhibit a tem perature dependence of the therm al conductivity that is rem arkably close to that found for the structurally am orphous solid, specially at low tem peratures. The results, together w ith m easurem ents of the B rillouin linew idths as derived from light scattering m easurem ents em – phasize the role of orientational disorder on phonon scattering. The experimental results obtained on polycrystal sam ples are then discussed with the aid of com puter simulations on single-crystalline m odels of both bcc and m onoclinic crystals. O ur notings are in good agreem ent with the wealth of them odynam ic and dynam ic data available so far [1], but are in stark contrast with inferences m ade from the analysis of inelastic X -ray data on polycrystalline sam ples [2], where a comm on nature for the excitations in all phases is postulated.

#### I. IN TRODUCTION

The present understanding of the m echanism s governing heat transport in disordered m edia rests upon concepts grounded on heat-pulse experiments showing that acoustic phonons, specially those having transverse polarization are the main heat carriers [3]. The lifetime and therefore the mean-free path of such excitations is known to be severy limited due to the action of several scattering mechanisms which are additional to those mainly dealing with the kinematics of the phonon gas, that are well established for fully ordered crystals.

One of the most striking notings revealed from work carried out over the last couple of decades, concerns the quantitative sim ilarities exhibited by the thermal conductivity of bulk am orphous materials [4] between say 0.1 K and 10 K, independent of them ical composition. In fact, from the collected dataset, which now includes a good number of disordered crystals, including a quasicrystal [4, 5], it is found that the ratio of the wavelength of the acoustic wave to the mean free path lof all these solids ranges within 10<sup>2</sup> -10<sup>3</sup>, which suggests the presence of "universal" behavior of some sort. On such grounds, it is becoming increasingly clear that the presence of "glassy dynamics" cannot be attributed in full to the absence of static translational long-range order (LRO).

W ithin the disordered crystals referred to above, som em olecular or ionic materials where the constituent particles have random static orientations while their centers of mass sit at the nodes of a three dimensional crystalline lattice are also known to exhibit glass-like excitations. W ithin those, solid ethyl alcohol is perhaps the most convenient benchmark to carry out a quantitative comparison of the e ects brought forward by the complete lack of LRO [1] on the most sensitive property to explore the propagation of excitations in condensed matter, such is the thermal conductivity. The material, apart from the well known P c monoclinic crystalline (fully ordered, Z = 2, FOC) modic cation, can be prepared in three long-lived (although metastable) phases, that are an am orphous solid or glass, an orientationally-disordered crystal, ODC (or orientational glass) showing static orientational disorder but having translational LRO since the molecules sit at the nodes of a bcc lattice, and a crystal with dynam ic orientational disorder (rotator-phase crystal or RPC) which retains LRO as a bcc lattice still exists. Two calorin etric glass-transitions [1] take place about the same range of temperatures and centered about 97 K and correspond to the canonical glass ! supercooled liquid and a rotational freezing transition ODC ! RPC [1], that is well understood as a purely dynam ic phenom enon (see M Jim enez-Ruiz et al. in Ref. [1]).

Here we report on measurements of the thermal conductivity of ethylakohol for all the solid phases as well as on measurements of the acoustic phonon lifetimes as determined by means of optical Brillouin scattering. Our aim in pursuing such a route is twofold. First and forem ost, as stated in a recent review [4] the m easurem ents will provide additional tests on claims of quantitative "universality" on the properties of heat propagation at low and interm ediate tem peratures on disordered m atter brought forward by a class of m aterials for which no data were available in Ref.[4]. On a more fundamental vein, our study also aim s to verify recent claim s concerning high-frequency (i.e. THz) acoustic excitations sampled in disordered m atter by m eans of inelastic X -ray (IX S) or neutron scattering (IN S) [6, 7]. M ore speci cally, our results m ay contribute to clarify whether the spectral feature characteristic of the INS or Ram an spectra of most glasses usually referred to as the "Boson peak" can be taken as a signature of a high-frequency lim it beyond which acoustic excitations become bcalized as proposed by som e authors [6, 7], or contrary to that, phonons m ay propagate down to m icroscopic scales without having their lifetim es limited by strong scattering processes, as known to be the case for excitations up to GHz frequencies. In this respect, here we will particularly focus onto som e details concerning the nature of the spectral response observed by means of IXS on polycrystals of the same material [2], for which two rather di erent interpretations have been proposed [2, 7]. To the ends just delineated, we com plem ent the experim ental study with calculations of the phonon frequencies and linew idths for both the FOC and ODC carried out by means of Molecular Dynam ics simulations on single-crystalline m odels of both m aterials using for the purpose well contrasted interm olecular potentials [10]. In doing this we will follow the evolution of the coherent dynam ic structure factor S (Q ; E ) accross the st Brilloin zone deriving unambiguous estimates for the phonon frequencies and inverse lifetimes, an exercise which cannot be pursued in polycrystalline samples as known since long [11]. Such calculations are complementary to previous harm onic Lattice D ynam ics results on the P cm onoclinic phase carried out for a sem i-rigid m odel which incorporates the lower lying molecular modes and has been tested against therm odynamic (i.e. speci c heat data up to 30 K) and spectroscopic data such as the frequency distributions as derived from neutron scattering as well as R am an spectral data. For m ore details in this particular aspect the interested reader is referred to Ref.[12].

#### II. EXPERIMENTS AND COMPUTATIONAL DETAILS

Them al conductivity m easurem ents which are detailed in Ref.[8] were carried out under equilibrium vapor pressure at 2-159 K by the steady-state potention etric m ethod using a special setup [9]. The preparation of the glass, disordered crystal or fully ordered m onoclinic phase was carried out following previously described procedures [1]

B rillouin light-scattering m easurem ents were carried out using a multipass tandem Fabry-Perot interferom eter from about 5 K up to 160 K on backscattering geometry on both glass/liquid and ODC/RPC phases. M easurem ents on the monoclinic modi cation were ham pered by the strong speckle patterns arising from the sample.

Neutron inelastic scattering experiments were performed using the MARI spectrometer at ISIS (Rutherford Appleton Laboratory), using an incident energy of 15 meV and a tem – perature of 10 K on fully deuterated samples. The dierent sample states were prepared in situ, the transformation between themmonitored by means of dieraction measurements. Additional measurements on the Boson peak were carried out using teh IN14 triple axis spectrometer at the Institut Laue Langevin.

M olecular D ynam ics simulations were carried out using a sem i- exible representation of the m olecules and its predictive capabilities are described in Refs.[10].

#### III. RESULTS

A sum mary of the measurements of the thermal conductivity of FOC, ODC and RPC phases is shown in the Figl. A glance to such a gure shows

that the conductivity of the FOC phase exhibits a shape much alike that of most crystalline solids explored so far. From melting ( $T_m = 159$  K) down to some 27 K, the therm al conductivity follows the exponential relation (T) / exp (E=T) with E = 38.3 0.9 K. The maximum is located at T = 12 K and below 4.5 K it then decreases following the well established (T) / T<sup>2</sup> behavior. Notice the abrupt decrease in therm al conductivity by 42% in a narrow temperature interval.

Both ODC and glass exhibit a temperature dependence of (I) rather similar to that of most am orphous solids [4]. The therm al conductivity increases with temperature with the largest grow th registered within the region below 4 K.A sm eared out "plateau" is then




FIG.1: The upper fram e depicts the m easured therm al conductivity for the FOC (stars), ODC (squares) and glass (circles). Solid lines are model to as described in the text. The lower fram e depicts data for the glass (circles) and ODC (squares) plotted on a linear scale.

found within 5 K - 10 K, above which (T) experiences a further increase. Such an increase lasts up T = 50 K, from where (T) for both samples shows a very mild dependence on temperature up to both glass-transitions range at T<sub>g</sub>' 97 K. The data for the ODC closely follows that of the am orphous solid. In real numbers, the therm al conductivity of the ODC is higher than that of the structural glass by about 2 per cent at 2 K, 8 per cent at 3.2 K, 16 per cent at 10 K 12 per cent at 25 K and 85 per cent above 50 K. At tem peratures beyond T<sub>g</sub> our data shows that (T) for the supercooled liquid and for the RPC are both independent of tem perature, its value being close to the therm al conductivity of liquid ethanol at the tem perature of solidi cation, T<sub>m</sub> = 159 K.

The data has been analyzed on phenom enological grounds by means of the model of soft potentials [8], where phonon scattering is pictured as caused by low energy excitations such as tunneling states, classical relaxors and soft quasiharm onic vibrations. As the m ost relevant param eters derived from thing (T) to such a model one gets estimates for the dimessionless tunneling strength C as well as the quentity W which characterizes the crossover from a regime dominated by phonon scattering by low-energy excitations (tunneling states and classical relaxors) into another dominated by scattering by soft quasiharm onic vibrations. Numerical values for both quantities yield 8.0  $10^{4}$ , 8.6  $10^{4}$  and 4.5  $10^{4}$  for the glass, ODC and FOC respectively, while those for W yield 3.6 K, 4.0 K and 14.0 K for the same three phases. Put into di erent words, both the tunnel strenght and the crossover energy yield very close values for both glass and ODC but largely di er from that found for the fully ordered crystal.

From values found for the strength parameter C a value for the ratio of the wavelength of the acoustic wave to its mean-free path the relationship given by Pohlet al. [4] a value for the ratio of the wavelength of the acoustic wave to its mean-free path is derived,

and yields gures '  $8 10^3$ , that are in quantitative agreement with data reported in Ref.[4] and thus lend further support to the claim of "universal" behavior there expounded since it is shown to be also followed by this class of materials. Notice that the estimate for the monoclinic crystal would come close to an order of magnitude larger and thus well outside charateristic limits of disordered matter.

A direct experimental route to assess the indings just referred to is provided by measurements of the phonon frequencies and linewidths by means of Brillouin light-scattering spectroscopy. Notice that for a disordered solid, it is within this limit where the concept of a phonon retains its physical meaning. This comes as a consequence of the fact that at scales where the experiments are typically performed that is wavevectors of the order of 10<sup>3</sup> A<sup>1</sup> and frequencies of som e G H z that are comparable to those sampled by thermal conductivity measurements, the solid behaves as an elastic continuum where acoustic excitations exhaust the frequency spectrum.

The experimental spectra consist on a single peak attributable to longitudinal phonons, the transverse component being too weak to be observed. The quantities of interest are here the Brillouin peak frequencies  $!_B$  as well as the peak widths  $_B$ . From such quantities we calculate the fractional frequency shift  $_B$  and the ratio of Brillouin linewidth to its




FIG.2: The upper frame depicts the measured temperature dependence of the fractional change in sound velocity for ODC/RPC (circles with a dot) and glass/liquid (crosses).

frequency Q  $^1$  as

Here, the fractional frequency shift is calculated with respect to the datum measured for T = 5 K and provides a measure of the shift with temperature of the phonon spectrum, that is an estimate of the temperature coe cient of anharm onicity. In turn, Q<sup>1</sup> provides an estimate of phonon damping in terms of a coe cient of internal friction.

The Fig.2 displays a comparison of the evolution with temperature of both  $_{\rm B}$  and Q<sup>1</sup> for both glass and ODC and temperatures covering most of the range of existence of both solids. The behaviour with temperature of  $_{\rm B}$  for both solids follow a rather mild dependence below som e 30 K - 40 K which gets largely enhanced at higher temperatures. In contrast, data for the internal friction follows nearly the same quasilinear behaviour for

both solids up to temperatures close to  $T_g$ . Both measures of the anharmonic interactions in the two solids show remarkably close values, which put into dimensions means that the phonon scattering processes operative in both kinds of disordered systems are basically the same, which is in agreement with the thermal conductivity results described above. The results contrast with the expectancy of a far less anharmonic behavior at low frequencies for the FOC. In fact macroscopic estimates of the  $_3$  G r'uneisen coencient (see H E.Fischer et al. in Ref.[1]) for low frequencies yield values of 2.9, 4.0 and 4.4 for FOC, ODC and glass respectively.




FIG. 3: Calculated phonon frequencies,  $_{Q}$  and phonon linewidths  $_{Q}$  along the (001) crystal directions. The upper fram e compares data for the orientationally disordered crystal (ODC) at low (5 K) and moderate (30 K) temperatures. This and open crosses display  $_{Q}$  and  $_{Q}$  the longitudinal phonon at T = 5 K. Full and open spares with a cross depict frequencies and damping for the transverse excitation sampled at the same temperature. Filled lozenges and open circles with a dot show dispersion frequencies and damping terms for the longitudinal phonon at 30 K. The lower frame compares data for the FOC and ODC crystals at high temperature (100 K). Longitudinal and transverse phonon frequencies for the FOC are shown by lled and open lozenges respectively. The corresponding linewidths are depicted by lled and open circles. Data for the frequencies and widths of the ODC crystal at the same temperature shown by crosses and open crosses respectively. Lines draw n through the points are approximations given in terms of simple power laws (see text).

To deepen into the origin of the di erences in behavior between the two crystals, we have carried out a number of M olecular D ynam ics simulations on m odels of both ODC and FOC single-crystals using for the purpose potentials and algorithm s already tested against experimental data [10]. The calculated dynam ic structure factors along the main (001, 010 and 100) crystal directions and tem peratures comprising 5 K - 30 K were analyzed in detail. A sample of the results is shown in Fig.3. The lowest temperature (5 K) corresponds to the upper limit of the strong rise with temperature of (T), T = 30 K is the limiting temperature where the D ebye m odel is able to account for the measured speci c heat [12], or put into di erent words, where the speci c heat can be fully accounted for in terms of acoustic excitations only. Finally, T = 100 K com es close to the stability limit of the OD C and also to the actual tem perature where IX S measurements were conducted.

The simulation data for the ODC show that for T > 5 K only the longitudinal acoustic phonon survives the strong scattering processes induced by orientational disorder. The graphs shown in the upper frame of Fig.3 for the lowest temperature depict a longitudinal branch that corresponds to a hydrodynamic sound velocity of 2639 m s<sup>1</sup> that remains as a well de ned peak all along the Brillouin zone. D amping of such excitation follows a subquadratic dependence with wavevector, the linewidth being well approximated by  $_{Q} =$  $9 \pm Q^{3=2}$  A  $^{3=2}$ . A transverse excitation also appears within the rst two Brillouin zones. Its linear dispersion corresponds to a propagation velocity of 989 m s<sup>1</sup> while its large damping is accounted by a stronger than quadratic dependence  $_{Q} = 7.9 \ Q^{5=2}$  A  $^{5=2}$ . Increasing the temperature well above the plateau in (T) has a scarce effect on the frequencies of the longitudinal phonon while its damping increases up to  $_{Q} = 13.9 \ Q^{3=2}$  A  $^{3=2}$ . The absence of a transverse acoustic branch at such temperature is here ascribed to scattering from static orientational disorder since, as shown below, such phonons are observable in the

high-tem perature crystal where low-energy librations are therm ally populated. Increasing again the tem perature up to a value consistent with that explored experimentally, that is  $0.88T_g$ , leads to a substantial broadening of the longitudinal mode frequencies for the ODC. These, as shown in the lower frame of Fig. 2 correspond to a hydrodynamic value for the sound velocity of 2349 m s<sup>1</sup>, a result in agreement with light-scattering results [1]. In

addition, the phonon remains as a well de ned entity up to wavevectors corresponding to one half of the Brillouin zone only, and the damping coe cient can be accounted for as  $_{Q} = 62.40 \ Q^{5=2}$ . Data for the monoclinic crystal also depicted in Fig.2 show a longitudinal branch with a hydrodynam ic limiting value of 3917 m s<sup>1</sup> together with a transverse mode propagating with a hydrodynam ic velocity of 1574 m s<sup>1</sup>. Damping of both modes is well accounted for by hydrodynam ic Q-dependences with coe cients of 11.98 A<sup>2</sup> m eV and 9.10 A<sup>2</sup> m eV, respectively. Our data contrast with the interpretation of IXS data on polycrystals given in Ref.[2]. The technique, as recently pointed out [7] mostly samples inhom ogeneus spectra com posed by excitations additional to those of acoustic character [12] which preempts the interpretation of maxim a and linew idths of the spectral bands in term s of physical frequencies and their damping term s.

### IV. DISCUSSION AND CONCLUSIONS




FIG.4: Experim ental interm olecular static correlation functions D(r) = 4 r[g(r) 1] derived from neutron di raction m easurem ents for all the condensed phases after subtraction of the m olecular form -factor. D ata for the m onoclinic crystal and the ODC have been m easured at 5 K.D ata for the liquid correspond to T = 180 K and those for the RPC to T = 105 K.The dotted line shows the density line 4 r, where stands for the number density. G raphs are displaced 0.2 units upwards for display purposes.

As a starting point of the discussion lets consider the signature of static correlations for all phases of ethanol as measured by means of neutron direction [1]. The Fig.4 displays a set of interm olecular static correlation functions corresponding to all the condensed phases, including the normal liquid. A glance to the gure shows, as expected, the close proximity between static correlations in liquid and glass phases as well as that existing between RPC and ODC states. Interesting enough, one notices that the main directores between the functions corresponding to the disordered crystals and those for the liquid/glass states pertain the sustained oscillations which appear having a period  $p = 2 = Q_p$ , where  $Q_p$  stands for the position in momentum transfers where the main box rejection is located. Notice however that the relative phases of such oscillations in both fully disordered and box sam ples are kept, irrespective of the presence of an underlying lattice.

In stark contrast, data pertaining the fully ordered crystal shows a far more complex pattern, which gets out-of-phase with those of the disordered crystals for distances beyond those characteristic of the st coordination sphere, that is above some 6A - 7A. For distances within such limit molecular orientational ordering arises from strong electrostatic and packing elects, which are expected to be not too di erent within the ODC and FOC states. One would then expect that excitations involving librational molecular motions would bear some resemblance in both crystals.

The lattice dynamics for the monoclinic crystal is well understood for frequencies up to about 25 m eV in terms of a semirigid molecular model [12]. The calculated frequency distributions compare favourably below such frequency threshold with those derived from neutron scattering for the fully hydrogenated or deuterated samples [12]. The lattice dynamics model gives rise to a set of 32 dispersion branches. Within those, the acoustic modes are conned below some 8 m eV, above which lies a dense mesh of mildly dispersive modes. From the analysis of the mode eigenvector components, it was found that purely acoustic modes dominate the frequency distribution below 4.2 m eV and that the inst well de ned peak appearing at some 6 m eV already has a significant optic character. The latter becomes dominant for frequencies above 9 m eV. In turn, rotational and librational motions within the bcc crsytals have been considered in detail (see C riado et al. in Ref.[1]) and found to correspond to reorientations am ongst 24 di erent basic orientations set by crystal size and molecular point symmetries. The frequency distribution of such motions covers a wide range extending up to about 20 m eV. Furtherm ore, as shown by H E.Fischer et al. in Ref.[1],




FIG. 5: Inelastic neutron scattering spectrum for fully deuterated glassy (lled symbols) ODC (open symbols) and FOC (solid line) ethanolm easured at T = 10 K.

the frequency spectra for both glass and ODC are remarkably close and show below 5 m eV the characteristic excess modes of glassy matter. In comparison, the rst van Hove singularity that corresponds to zone boundary transverse acoustic phonons is still seen at 80 K. Subsequent analysis of the spectral distributions for both glass, ODC and FOC in terms of frequency m om ents  $< !^n >$  has shown how the lower order m om ents (up to n = 1), that are related to low frequencies and are thus pertinent for glass physics, for both glassy phases di er from that for the FOC, while higher order m om ents that weigth the higher frequencies become increasingly close for all the three phases. The facts just referred to serve to understand the close similate of results for glass, ODC and FOC reported on Ref.[2]. Such similarity comes as a consequence of the closely related spectra of molecular orientational m odes in all the three phases which dom inates the frequency range explorable by the IXS technique. However the spectra for the glassy phases becomes strinkingly di erent from that of the FOC within the frequency range dom inated by the acoustic modes as the Fig.5 exempli es. In other words, and to put things explicitly, the results reported on by in Ref.[2] are to be taken as descriptive at best since the analysis there pursued where all the IXS intensities below some 22 meV are described in terms of a single physical frequency is not m eaningful.

Our nalrem ark concerns the current debate on phonon localisation due to disorder [6].




FIG.6: Inelastic neutron scattering spectrum for ODC ethanolm easured at T = 10 K as measured at several values of m on entum -transfers and frequencies covering the maximum of the Boson peak. The peak at about 7.4 m eV is a spurious instrum ental rejection.

In m one detail, the discussion here concerns whether the propagation of acoustic excitations in glassy m atter can take place beyond a spectral feature located at low frequencies known as the Boson peak. Its origin still is uncertain, but is known to be related to the hum p that appears in the speci c heat is plotted as  $C_p=T^3$ . Studies in vitreous silica [7] seem s to indicate the existence of a crossover region well within the first pseudo-Brillouin zone that is for  $Q < Q_p=2$  where the excitation linew idths equate their charateristic frequency and thus cease to propagate. Such a cross-over frequency (or wavevector) usually referred to as the Io e-Regel limit has been identified in some studies with that corresponding to the Boson peak. For the materials under discussion here we show in Fig.6 the shape of the low-frequency spectra for several values of m om entum -transfers. Such a feature appears as a well de ned peak centered at about 3 m eV which shows no clear Q-dependence on its frequency or width. Its therm odynam ic correlate is the T = 7 K hum p in the speci c heat reported in Ref.[12].

Here we address the issue just referred to by means of a comparison of the simulation data depicted in Fig.3 and the spectra showing the Boson peak displayed in Fig.6. Because of the single-crystalline nature of the simulation data, the frequencies and linewidths for the acoustic phonons cane be tracked down up to the Brillouin zone boundary. Data for the

ODC at the lowest temperature (5 K) shows no indication of a crossover in teh Io e-Reggel sense and therefore, one would expect that longitudinal acoustic phonons propagate within the Brillouin zone. In contrast, data for T = 100 K do show a crossover for the ODC at about 0.4 A <sup>1</sup>. The inference that such a comparison allows us to make tells that therm al disorder seem s a farm ore fundamental issue concerning the localization of acoustic waves than its static counterpart. The result, that went unnoticed in the current debate is how ever well known concerning the damping of acoustic phonons in cubic crystals [13], where it is kown that the phonon relaxation rate depends on the fifth power of the temperature.

In sum mary, the concurrent use of therm al conductivity measurements, light scattering experiments and molecular dynamics simulations on single crystalline models of the ODC and FOC solids has enabled us to establish the prominent role or molecular orientational disorder as the main source of acoustic phonon scattering in disordered matter. As an additional result, our study points towards the prominent role of thermal elects in the attenuation of acoustic phonons.
