W e study the angular correlation function of speckle patterns that result from multiple scattering of photons by cold atom ic clouds. We show that this correlation function becomes larger than the value given by Rayleigh law for classical scatterers. These large intensity uctuations constitute a new mesoscopic interference e ect speci c to atom -photon interactions, that could not be observed in other system s such as weakly disordered m etals. We provide a complete description of this behavior and expressions that allow for a quantitative com parison with experim ents.

A wave propagating in a random medium undergoes multiple scattering and the intensity pattern resulting from interferences of the scattered waves with each other is known as a speckle pattern. The angular and time dependent properties of these patterns have been extensively studied [1, 2, 3]. They exhibit coherent m esoscopic e ects and provide a sensitive probe to scattering properties of di usive m edia. Quasi-resonant elastic scattering ofphotons by cold atom ic gases represents in this context an important issue, since it provides a new tool to study properties of cold atom ic gases such as atom ic dynam ics. Photon propagation in atom ic gases di ers from the case of electrons in disordered m etals [4] or of electrom agnetic waves in suspensions of classical scatterers, due to the existence of atom ic internal degrees of freedom coupled to the photon polarization. Some e ects of a Zeem an degeneracy on the coherent backscattering [2, 5] have been recently investigated in the weak scattering lim it [6] in term s of phase coherence tim es [7].

The purpose of this work is to study the static angular correlation function of photons perform ing coherent multiple scattering in a cold atom ic gas. The photon intensity correlation function between angular scattering channels is de ned using the transmission coe cient Tab by



Here, position of atom s and their internal degrees of freedom (see below) and  $T_{ab}$  $T_{ab}$   $T_{ab}$ . For classical scatterers, intensity uctuations obey the Rayleigh law  $C_{abab} = 1$ . In the presence of a Zeem an degeneracy, angular correlations of speckle patterns and intensity uctuations becom e larger than one. This is a new and genuine m esoscopic e ect speci c to multiple scattering of photons by atom s and directly related to interference between am plitudes associated to di erent atom ic quantum states.

A tom s are m odeled as degenerate two-level system s denoted by j<sub>a</sub>m<sub>g</sub>i for the ground state and j<sub>e</sub>m<sub>e</sub>i for the excited state, where j is the total angularm om entum and

m is its projection on a quantization axis. The levels are degenerate with jm <sub>g</sub>j j₁and jn <sub>e</sub>j j.

W e refer to the following possible experimental setup (Fig.1). A light pulse is incident along a direction  $\$_a$ onto a dense enough atom ic gas con ned in a slab geom etry. This pulse is detected along a direction  $\$_b$  after being multiply scattered (ab channel). A time later, a second pulse that corresponds to the a<sup>0</sup>b<sup>0</sup> channel, is detected. We assume that the time is short enough so that the atom s stay at rest between the two pulses. The sam e m easurem ent is repeated after a tim e T , during which the scatterers move. The averaging over spatial disorder results from this motion. This is a Younglike experiment. Thus, although a pulse contains many photons, the transm itted intensity T<sub>ab</sub> is proportional to the probability of one \representative" photon incom ing along  $\boldsymbol{\hat{s}}_a$  , to em erge along  $\boldsymbol{\hat{s}}_b$  .



denotes a con guration average over both the IG. 1: Photons in each pair of pulses are scattered by atom s at identical positions ri but with distinct and uncorrelated quantum numbers  $(m_i; m_f)$  and  $(m_i^0; m_f^0)$ . After a time , a new measurement is performed after the atoms Т m oved to new positions  $r_i^0$ .

The average transmission coe cient  $\overline{T}_{ab}$  is obtained by sum m ing all the possible scattering am plitudes,  $A_n^{fR,mg}$ , corresponding to a given con guration fR; mg. Here fR g accounts for the spatial positions of all scatterers, and fm q is a notation for their internal Zeem an states both before and after scattering. The index n denotes one possible multiple scattering path. Squaring the sum of am plitudes we have [8]

where \_\_\_\_\_ and fm q. W hen averaging over fR q, all cross term s  $n \in n^0$  vanish because of large uctuating phase shifts, so that  $\overline{T}_{ab} = \prod_{n}^{P} \overline{A}_{n}^{fm g} f$ . This expression, known as the intensity D i uson, is the leading approximation in the weak disorder  $\lim it k_0 l = 1$ , where  $k_0$  and l are respectively the wave number and the elastic mean free path of photons. The (ab) pulse contains m any photons, and each of them may change the internal state of atoms. Therefore, if fm g (resp. fm  $^{0}$ g) is the atom ic internal con guration seen by a \representative" photon of the ab  $(resp. a^{0}b^{0})$  pulse, then we can assume that there is no correlation between fm g and fm  $^{0}$ g.

Sim ilarly to the average intensity (2), the correlation of the transmission coe cient is

since, as before, the averaging over fR g leaves only pairs of am plitudes having exactly opposite phase shifts. To leading order in the weak disorder lim it, the only non vanishing contributions involve two Di usons, i.e. two possible pairings of am plitudes, either i = j; k = l, w hich gives  $\overline{T}_{ab}\overline{T}_{a^{0}b^{0}}$ , or i = l; j = k so that

The correlation function thus appears as products of two am plitudes, that correspond to di erent internal con-

gurations fm g and fm<sup>0</sup>g, but to the sam e scattering path i (or j). Most of multiple scattering paths i and j do not share common scatterers so that we can average  $A_i^{fm \ g} A_i^{fm \ ^0g}$  and  $A_j^{fm \ ^0g} A_j^{fm \ g}$  separately, since these averages are taken upon di erent atom s, and nally,

In the theory of multiple scattering it is helpful to use a continuous description [2]. In this fram ework, one de nes two D i uson functions D (i;c) by [8]

where  $\hat{s}_{a,b} = \hat{s}_{a,b}$   $\hat{s}_{a^{0},b^{0}}$ . The intensity Di uson D<sup>(i)</sup> (r;r<sup>0</sup>) is the sum of the terms  $A_n^{\text{fm g}}(r;r^0)$ <sup>f</sup> between endpoints r and  $r^0$ . On the other hand, the correlation D i uson D  $^{(c)}$  (r;r<sup>0</sup>) is the sum of the term s denotes a con guration average, over both  $fR_{i}^{fm g}(r;r^{0})A_{i}^{fm^{0}g}(r;r^{0})$ , i.e., that involve uncorrelated con gurations fm g and  $fm^0 g$ .

> The two functions D (i;c) are obtained from the iteration of a proper elementary vertex V<sup>(i;c)</sup>, that describes the m icroscopic details of the scattering process. The iteration of the elementary vertex is written symbolically (either for D  $^{(i;c)}$ , V  $^{(i;c)}$  we shall denote by D , V) as

The term V accounts for a single scattering and DW V represents its iteration. The quantity W describes the propagation of the photon intensity between successive scattering events and it will be described later on.

The elementary vertex is obtained by the pairing of two scattering am plitudes of a photon by an atom . It is given by [9]

where the operator V  $(\mathbf{m}^0; \mathbf{m}) = \begin{bmatrix} P & & \\ m_e & \mathbf{m}^0 & d_e j j n_e i h j_e m_e j d \end{bmatrix}$ results from the dipolar interaction energy dE between atom s and photons, d being the atom ic dipole operator and E the electric eld operator. In the case of  $V^{(c)}$ , each one of the two coupled scattering am plitudes in (9) m ight belong to a distinct atom ic con guration, meaning that we must consider two distinct couples of initial  $(j_{q}m_{1}i; j_{q}m_{3}i)$  and nal  $(j_{q}m_{2}i; j_{q}m_{4}i)$  atom ic states, as well as two initial  $(n_1; n_3)$  and nal  $(n_2; n_4)$  photon polarization states. The sum m ations over the quantum numbers mi result from averaging over initial atom ic states and from non detected nalstates. Thus V(c) corresponds to the most general case regarding the miguantum num bers. In contrast, V (i) corresponds to the di erential scattering cross-section, for which we set  $m_1 = m_3$ ,  $m_2 = m_4$ ,  $m_1 = m_3$  and  $m_2 = m_4$  in (9). This is because the intensity Di uson is built out of two coupled am plitudes that must belong to the same scattering process. This distinction between V  $^{(i)}$  and V  $^{(c)}$  , and therefore between  $D^{(i)}$  and  $D^{(c)}$ , occurs only for  $j_q > 0$  and it is at the basis of the new results we obtain here for mesoscopic speckle correlations.

The iteration (8) is im plemented using the decomposition of the various term s into standard basis com ponents, thus leading to the de nition of rank four tensors such as

Likewise, the iteration equation (8) for the Di usons ac-

quires a tensorial structure, which reads

H ere W = W b, the function W describes the scalar partof the photon intensity propagator and b, de ned by

accounts for the polarization dependent part. This expression follows at once by noticing that after being scattered by an atom, the two outgoing photon amplitudes propagate with a wavevector  $\$ = k = k_0$ , random in direction but identical for both, and with two di erent polarization components. Since \$ is random, the intensity propagation is averaged h i over photon wavevec direction. The term () \$ s expresses transversality.

To proceed further, we use the W igner-E ckart theorem to rewrite the tensor V ; in term s of a sum mation of product of 3j-sym bols,

where  $a_{j_g,j_e} = (2j_e + 1)=3(2j_g + 1)$ . The two tensors b; and V; can be written in the form of a 9 9 m atrix. A coording to the spectral decomposition theorem, they can be decomposed using an orthonormal set of (generally) nine projectors T<sup>(K)</sup> [10]. Looking at (11), we wish to nd the spectral decomposition of D using the spectral decomposition of D using the spectral decomposition of V and bV. The problem is that they do not share the same projectors set in their spectral decomposition. We are thus led to de ne a new tensor U by D = UV. It obeys the iteration equation U = 1 + W UVb and it ipvolves only the spectral decomposition of V  ${}^{(i;c)}b = {}^{8}_{K=0} u_{K}^{(i;c)}T^{(K)}$ . This leads in mediately to

where q (with  $q = j_1$ ) is the Fourier variable of the di erence  $R = r^0$  r between the two endpoints of a multiple scattering sequence. The r.h.s in (15) is obtained by using the di usion approximation (i.e. ql = 1), so that  $W(q)' \frac{3}{2a_{j_qj_e}} (1 - q^2l^2=3)$ , where D = cl=3 is the photon di usion coe cient [2] and c the speed of light. We

identify the set of characteristic tim es

For V <sup>(i)</sup> (m<sub>1</sub> = m<sub>3</sub>, m<sub>2</sub> = m<sub>4</sub> in (13)), it is straightforward to check that (V <sup>(i)</sup>b) ; admits a spectral decom – position over 3 projectors T <sup>(K )</sup> only [2, 6, 12]. In contrast, for V <sup>(c)</sup> there are no constraint on the m<sub>i</sub> quantum numbers, so that the total angular momentum needs not to be conserved, and the corresponding spectral decom – position involves usually more than 3 projectors T <sup>(K )</sup>. For a non degenerate ground state level (j<sub>g</sub> = 0), angular momentum is automatically conserved and the two vertices become identical, V <sup>(c)</sup> = V <sup>(i)</sup>.

i over photon wavevectors The poles that occur in (15) correspond to di usive m odes of lifetime  $K^{(i;c)}$ . This shows up when rewriting (14), with the help of (10), in real space

and a corresponding expression for  $Y_{K}^{(i)}$  obtained by setting  $a^{0} = a, b^{0} = b$  and  $V^{(i)}$  in the previous relation. The scalar D i uson propagator D (r; r; t) obeys a di usion equation whose solution for a slab of width L is well known [2, 10] and leads for (6) and (7) to

We now analyze expressions (19) and (20), which constitute the main results of this paper. First, consider the modes of the average intensity D<sup>(i)</sup>. It is easy to check that  $_{0}^{(i)}$  is in nite as a result of the W and identity  $u_{0}^{(i)} = \frac{2}{3}a_{j_{g},j_{e}}$  (see (16)). The corresponding G oldstone mode  $U_{0}^{(i)} / 1=D q^{2}$  expresses energy conservation and long-range propagation of the average intensity. The two otherm odes  $U_{K}^{(i)}$  are exponentially dam ped with the tim es  $_{K}^{(i)}$  (see (17)). This expresses photon depolarization in multiple scattering [2, 6, 7, 11].

The spectral decomposition of D<sup>(c)</sup> gives rise to nine modes and their corresponding times  $_{\rm K}^{\rm (c)}$  . Such times are well-known to occur in quantum mesoscopic physics e.g. in conductance uctuations of disordered m etals in the presence of magnetic impurities [2, 13]. The times  $_{\kappa}^{(c)}$  describe how underlying interferences between multiply scattered waves (electrons in m etals, photons in the present case) are washed out in the presence of other degrees of freedom . The surprising and new feature of the atom -photon scattering, is the occurrence of a mode (K = 0) with a negative  ${0 \atop 0}^{(c)}$ . A coording to (17), this corresponds to an ampli ed mode that enhances the angular correlation function. This ampli ed mode is present for a degenerate atom ic transition  $(j_g; j_e > 0)$  and vanishes otherwise. Its origin can be traced out from the vertex (9) which can be written as a sum of an incoherent contribution (i.e., a sum of probabilities) present both in  $V \,^{\rm (i)}$  and  $V \,^{\rm (c)}$  , and a coherent contribution (i.e., a sum of products of quantum am plitudes associated to interferences between di erent Zeem an states). The coherent contribution enhances V <sup>(c)</sup> with respect to V <sup>(i)</sup> and its iteration gives rise to the ampli ed mode characterized by  $_{0}^{(c)}$ . Expressions (19) and (20) lead to an expres-




FIG.2: A ngular correlation function  $C_{aba}{}_{bb}{}_{0}$  plotted as a function of q =  $k_{0}$   $\$_{a}$  for an atom ic transition between non degenerate ( $j_{g}$  = 0,  $j_{e}$  = 1, dashed line) and degenerate energy levels ( $j_{g}$  = 1,  $j_{e}$  = 2, solid line). The non degenerate case describes the classical Rayleigh scattering of a polarized wave. These curves correspond to L = 71\_{e}. The inset gives the dependence of intensity uctuations C  $_{abab}$  upon the width L (the dashed line is the Rayleigh law).

sion of  $C_{aba^0b^0}$  plotted in Fig 2. This expression allows to recover the limiting case of a scalar classical wave [1] corresponding to Y<sup>(c)</sup> = Y<sup>(i)</sup> = 1 and to a single mode with in nite  $_0^{(i;c)}$ . It also provides a simple expression for angular speckle correlations of classical Rayleigh scattering of a polarized wave [10, 14]. For atom ic transitions between degenerate levels,  $C_{aba^0b^0}$  exhibits a steep decrease and large intensity uctuations (see Fig 2) as compared to the case of non degenerate atom ic levels. Intensity

uctuations m easured by  $C_{abab}$  become larger than one, unlike Rayleigh law,  $C_{abab} = 1$ , well-obeyed by classical scatterers. Large intensity uctuations result from the ampli ed mode  $_{0}^{(c)}$  which leads to a divergence of the integral in (17). This divergence is cuto by other dephasing mechanisms, such as Doppler shift, inelastic scattering or nite size of the atom ic trap. Denoting by

this upper cuto , and assuming that the dominant contributions to  $\overline{T}_{ab}$  and to  $\overline{T}_{ab}^2$  are given respectively by the G oldstone and the amplied modes, we deduce from (17) that

where  $X_q = (L = L_0^{(c)})^2$  involves the di usion length  $L_0^{(c)}$  D j<sub>0</sub><sup>(c)</sup> j and A is a constant equal to one for a non degenerate ground state. This approximate expression reproduces the main features of C<sub>abab</sub> plotted in the inset of F ig 2, namely that it can be larger than the Rayleigh term and that it is peaked at a value of L that depends on the cuto . When  $I_0^{(c)}$  and are in-

nite,  $C_{abab}$  becomes independent of L and is given by the Rayleigh law. Relative uctuations as given by (21) thus provide a direct probe of dephasing mechanisms in cold atom ic gases.
