Intensity correlations and $m$ esoscopic uctuations of di using photons in cold atom $s$

#### Abstract

W e study the angular correlation function of speckle pattems that result from $m$ ultiple scattering of photons by cold atom ic clouds. W e show that this correlation function becom es larger than the value given by R ayleigh law for classical scatterers. T hese large intensity uctuations constitute a new $m$ esoscopic interference e ect speci $c$ to atom -photon interactions, that could not be observed in other system s such as weakly disordered m etals. W e provide a com plete description of this behavior and expressions that allow for a quantitative com parison $w$ ith experim ents.

A wave propagating in a random $m$ edium undergoes multiple scattering and the intensity pattem resulting from interferences of the scattered $w$ aves $w$ th each other is known as a speckle pattem. The angular and time dependent properties of these pattems have been exten-
 e ects and provide a sensitive probe to scattering properties of di usive media. Q uasi-resonant elastic scattering ofphotons by cold atom ic gases represents in this context an im portant issue, since it provides a new tool to study properties of cold atom ic gases such as atom ic dynam ics. Photon propagation in atom ic gases di ers from the case ofelectrons in disordered $m$ etals [ [-4] or ofelectrom agnetic w aves in suspensions ofclassical scatterers, due to the existence of atom ic intemal degrees of freedom coupled to the photon polarization. Som e e ects of a Zeem an de-
 recently investigated in the weak scattering lim it [G] in term s of phase coherence tim es [iT1].

The purpose of this work is to study the static angular correlation function of photons perform ing coherent $\mathrm{m} u l t i p l e ~ s c a t t e r i n g ~ i n ~ a ~ c o l d ~ a t o m ~ i c ~ g a s . ~ T h e ~ p h o t o n ~ i n-~$ tensity correlation function between angular scattering channels is de ned using the transm ission coe cient $T_{a b}$ by

Here, - denotes a con guration average over both position of atom $s$ and their intemal degrees of freedom (see below) and $\mathrm{T}_{\mathrm{ab}} \quad \mathrm{T}_{\mathrm{ab}} \quad \overline{\mathrm{T}}_{\mathrm{ab}}$. Forclassicalscatterers, intensity uctuations obey the $R$ ayleigh law $\mathrm{C}_{\text {abab }}=1$. In the presence of a Zeem an degeneracy, angular correlations of speckle pattems and intensity uctuations becom e larger than one. $T$ his is a new and genuine $m$ esoscopic e ect speci cto multiple scattering of photons by atom $s$ and directly related to interference betw een am plitudes associated to di erent atom ic quantum states.

A tom s arem odeled as degenerate tw o-levelsystem s denoted by $\ddot{j}_{g} m g_{g} i$ for the ground state and $\ddot{j}_{e} m e^{i}$ for the excited state, where $j$ is the totalangularm om entum and
$m$ is its pro jection on a quantization axis. The levels are degenerate w ith ing ${ }^{j}$ j, and in $e^{j}$ ì .

W e refer to the follow ing possible experim ental setup ( $F$ ig.1). A light pulse is incident along a direction $S_{a}$ onto a dense enough atom ic gas con ned in a slab geom etry. This pulse is detected along a direction $\hat{s}_{\mathrm{b}}$ after being multiply scattered (ab channel). A time later, a second pulse that corresponds to the $a \% b^{0}$ channel, is detected. W e assum e that the time is short enough so that the atom s stay at rest betw een the tw o pulses. The sam e m easurem ent is repeated after a tim e $T$, during which the scatterers $m$ ove. The averaging over spatial disorder results from this motion. This is a Younglike experim ent. Thus, although a pulse contains many photons, the transm ilted intensity $\mathrm{T}_{\mathrm{ab}}$ is proportional to the probability of one \representative" photon incom ing along $s_{a}$, to em erge along $s_{b}$.

thFeTG . 1: Photons in each pair of pulses are scattered by atom $s$ at identical positions $r_{i}$ but $w$ ith distinct and uncorrelated quantum num bers $\left(m_{i} ; m_{f}\right)$ and $\left(m_{i}^{0} ; m_{f}^{0}\right)$. A fter a time $T$, a new $m$ easurem ent is perform ed after the atom $s$ m oved to new positions $r_{i}^{0}$.

The average transm ission coe cient $\bar{T}_{a b}$ is obtained by sum $m$ ing all the possible scattering am plitudes, $A_{n}^{f R, m g}$, corresponding to a given con guration $f R ; m \mathrm{~g}$. H ere fR g accounts for the spatial positions of all scatterers, and fmg is a notation for their intemal Zeem an states both before and after scattering. The index $n$ denotes one possible multiple scattering path. Squaring the sum of

W hen averaging over $f R g$, all cross term $s$ $n \in n^{0}$ vanish because of large uctuating phase shifts, so that $\bar{T}_{a b}=P{ }_{n} \overline{\left.\AA_{n}^{f m g}\right\}}$. This expression, known as the intensity D i uson, is the leading approxim ation in the weak disorder $\lim$ it $k_{0} l \quad 1$, where $k_{0}$ and $l$ are respectively the $w$ ave num ber and the elastic $m$ ean free path of photons. The (ab) pulse contains $m$ any photons, and each of them $m$ ay change the intemal state of atom $s$. Therefore, if fm $g$ (resp. $\mathrm{fm}^{\circ} \mathrm{g}$ ) is the atom ic intemal con guration seen by a \representative" photon of the ab (resp. $\mathrm{a}^{0} \mathrm{~b}^{0}$ ) pulse, then we can assum e that there is no correlation betw een fm $g$ and $f m{ }^{\circ} g$.

Sim ilarly to the average intensity (2), the correlation of the transm ission coe cient is

since, as before, the averaging over fR $g$ leaves only pairs of am plitudes having exactly opposite phase shiffs. To leading order in the weak disorder lim it, the only non vanishing contributions involve two Di usons, i.e. two possible pairings of am plitudes, either $i=j ; k=1$, which gives $\bar{T}_{a b} \bar{T}_{a^{0} b^{0} \text {, or }} i=1 ; j=k$ so that

T he correlation function thus appears as products of tw o am plitudes, that correspond to di erent intemal congurations fm g and $\mathrm{fm}^{\circ} \mathrm{g}$, but to the sam e scattering path i (or j). M ost of multiple scattering paths i and $j$ do not share com $m$ on scatterers so that we can average $A_{i}^{f m} \mathrm{~g}_{i} \mathrm{fm}^{0} \mathrm{~g}$ and $A_{j}^{f m}{ }^{0} \mathrm{~A}_{\mathrm{A}}^{\mathrm{fm}} \mathrm{g}$ separately, since these averages are taken upon di erent atom s , and nally,

The two functions $D^{(i ; c)}$ are obtained from the iteration of a proper elem entary vertex $V^{(i ; c)}$, that describes the $m$ icroscopic details of the scattering process. The iteration of the elem entary vertex is w ritten sym bolically (either for $D^{(i ; c)}, V^{(i ; c)}$ we shall denote by $\left.D, V\right)$ as

The term $V$ accounts for a single scattering and $D W V$ represents its iteration. T he quantity $W$ describes the propagation of the photon intensity betw een successive scattering events and it willbe described later on.

The elem entary vertex is obtained by the pairing of tw o scattering am plitudes of a photon by an atom. It is given by $\overline{\underline{p}} \overline{1}$

 results from the dipolar interaction energy $d E$ betw een atom $s$ and photons, $d$ being the atom ic dipole operator and $E$ the electric eld operator. In the case of $\mathrm{V}^{(\mathrm{c})}$, each one of the tw o coupled scattering am plitudes in ( $\underline{q}_{1}$ ) m ight belong to a distinct atom ic con guration, m eaning that we m ust consider tw o distinct couples of in itial
 as well as two initial ( ${ }_{1} ; \boldsymbol{m}_{3}$ ) and nal ( $\left(\begin{array}{l}m\end{array} n_{4}\right)$ photon polarization states. The sum $m$ ations over the quantum num bers $\mathrm{m}_{\mathrm{i}}$ result from averaging over initial atom ic states and from non detected nal states. T hus $\mathrm{V}^{(\mathrm{c})}$ corresponds to the $m$ ost general case regarding the $m_{i}$ quantum num bers. In contrast, $\mathrm{V}^{(\mathrm{i})}$ corresponds to the di erentialscattering cross-section, forw hich we set $m_{1}=m_{3}$, $m_{2}=m_{4}, m_{1}=m_{3}$ and $m_{2}=m_{4}$ in $\left(\underline{\underline{9}} \underline{q}_{1}\right) . T$ his is because the intensity D i uson is buitt out of tw o coupled am plitudes that $m$ ust belong to the sam e scattering process. This distinction betw een $V^{(i)}$ and $V^{(c)}$, and therefore betw een $D^{(i)}$ and $D{ }^{(c)}$, occurs only for $j_{g}>0$ and it is at the basis of the new results we obtain here form esoscopic speckle correlations.

The iteration ( $(\underline{G})$ is im plem ented using the decom position of the various term $s$ into standard basis com ponents, thus leading to the de nition of rank four tensors such as

This expression follow s at once by noticing that after being scattered by an atom, the two outgoing photon am plitudes propagate w th a w avevector $\hat{\mathrm{s}}=\mathrm{k}=\mathrm{k}_{0}$, random in direction but identical for both, and with two di erent polarization com ponents. Since $s$ is random, the intensity propagation is averaged $h \quad i$ over photon wavevecto direction. The term ( ) s is expressestransversality.

To proceed further, we use the $W$ igner $\mp$ ckart theorem to rew rite the tensor $V$; in term s of a sum $m$ ation of product of $3 j$-sym bols,

Looking at [ $\left[1 \overline{1}_{1}^{\prime}\right)$, we wish to nd the spectral decom position of $D$ using the spectral decom position of V and bV . The problem is that they do not share the sam e projectors set in their spectral decom position. W e are thus led to de ne a new tensor $U$ by $D=U V$. W e now analyze expressions $\left(\overline{1} \frac{1}{1} \bar{g}_{1}^{\prime}\right)$ and $\left(\overline{2} \overline{\mathrm{O}}_{1}^{\prime}\right)$, which constitute the m ain results of this paper. First, consider the $m$ odes of the average intensity $D^{(i)}$. It is easy to check that ${ }_{0}^{(i)}$ is in nite as a result of the $W$ ard identity $u_{0}^{(\mathrm{i})}=\frac{2}{3} a_{\mathrm{j}_{\mathrm{g}}} \mathrm{j}_{\mathrm{e}}$ (see $\left.\overline{1}_{1}^{-1} \underline{\mathrm{G}}^{-1}\right)$. . The corresponding G oldstone $m$ ode $U_{0}^{(i)} / 1=D q^{2}$ expresses energy conservation and long-range propagation of the average intensity. T he tw $o$ otherm odes $U_{K}^{(i)}$ are exponentially dam ped $w$ ith the tim es ${ }_{k}^{(i)}$ (see $\left.\left(\overline{1} \overline{Z_{1}}\right)\right)$. T his expresses photon depolariza-


The spectral decom position of $D{ }^{(c)}$ gives rise to nine m odes and their corresponding tim es ${ }_{k}^{(c)}$. Such tim es are well-known to occur in quantum $m$ esoscopic physics e.g. in conductance uctuations of disordered $m$ etals in

${ }_{K}^{(c)}$ describe how underlying interferences betw een mul tiply scattered waves (electrons in $m$ etals, photons in the present case) are washed out in the presence of other degrees of freedom. The surprising and new feature of the atom-photon scattering, is the occurrence of a m ode $(K=0)$ w th a negative ${ }_{0}^{(c)}$. A ccording to $\left(\overline{1} \overline{\eta_{1}}\right)$, this corresponds to an am pli ed mode that enhances the angular correlation function. This am pli ed $m$ ode is present for a degenerate atom ic transition ( $j_{g} ; j_{e}>0$ ) and vanishes otherw ise. Its origin can be traced out from the vertex $(\underline{\underline{g}})$ which can be w ritten as a sum of an incoherent contribution (i.e., a sum of probabilities) present both in $V^{(i)}$ and $V^{(c)}$, and a coherent contribution (i.e., a sum of products of quantum am plitudes associated to interferences betw een di erent Zeem an states). T he coherent contribution enhances $\mathrm{V}^{(\mathrm{c})}$ w ith respect to $\mathrm{V}^{(i)}$ and its iteration gives rise to the am pli ed m ode characterized by $0^{(c)}$. Expressions $\left[\overline{1}_{1}^{\left(g_{1}^{\prime}\right)}\right.$ and $\left[\mathbf{2}_{2}^{\left(O_{1}^{\prime}\right)}\right.$ lead to an expres-

It also provides a sim ple expression for angular speckle correlations of classical $R$ ayleigh scattering of a polarized w ave $\left[10_{1}^{1}, 1\right.$ tw een degenerate levels, $\mathrm{C}_{a b a}{ }^{0} b^{0}$ exhibits a steep decrease and large intensity uctuations (see Fig in) as com pared to the case of non degenerate atom ic levels. Intensity uctuations $m$ easured by $C_{a b a b}$ becom e larger than one, unlike R ayleigh law, $C_{a b a b}=1$, well-obeyed by classical scatterers. Large intensity uctuations result from the ampli ed mode ${ }_{0}^{\text {(c) }}$ which leads to a divergence of the integral in $\left[\left(\tilde{I}_{1}\right)\right.$. T his divergence is cuto by other
dephasing $m$ echanism $s$, such as D oppler shift, inelastic scattering or nite size of the atom ic trap. D enoting by
this upper cuto, and assum ing that the dom inant contributions to $\bar{T}_{a b}$ and to $\overline{\mathrm{T}_{\mathrm{ab}}^{2}}$ are given respectively by the G oldstone and the am pli ed m odes, we deduce from (17 $\left.\overline{1} \overline{1}_{1}\right)$ that

where $X_{q} \quad\left(L_{=}=L_{0}^{(c)}\right)^{2} \quad 2$ involves the di usion length $\mathrm{L}_{0}^{(\mathrm{C})} \quad \mathrm{D} j_{0}{ }^{(\mathrm{C})} \mathrm{j}$ and A is a constant equal to one for a non degenerate ground state. This approxim ate expression reproduces the $m$ ain features of $C_{\text {abab }}$ plotted in the inset of $F$ ig ", the $R$ ayleigh term and that it is peaked at a value of $L$ that depends on the cuto.$W$ hen $I_{0}^{(c)}$ and are innite, $C_{a b a b}$ becom es independent of $L$ and is given by the R ay leigh law. Relative uctuations as given by " ${ }^{-1}\left(2_{2}^{\prime}+1\right)$ thus provide a direct probe of dephasing $m$ echanism $s$ in cold atom ic gases.
